(57) **CLAIM**

I claim the ornamental design for a video camera, as shown and described.

DESCRIPTION

FIG. 1 is a top, left and front perspective view of a video camera.

FIG. 2 is a bottom, right and rear perspective of the video camera illustrated in FIG. 1

FIG. 3 is a top plan view of the video camera illustrated in FIG. 1.

FIG. 4 is a front elevation view of the video camera illustrated in FIG. 1.

FIG. 5 is a rear elevation view of the video camera illustrated in FIG. 1.

FIG. 6 is a bottom plan view of the video camera illustrated in FIG. 1.

FIG. 7 is a right side elevation view of the video camera illustrated in FIG. 1.

FIG. 8 is a left side elevation view of the video camera illustrated in FIG. 1.

FIG. 9 is a left side elevation view of the video camera illustrated in FIG. 1 with the USB plug in an extended position; and,

FIG. 10 is a front elevation view of the video camera illustrated in FIG. 1 with the USB plug in an extended position.

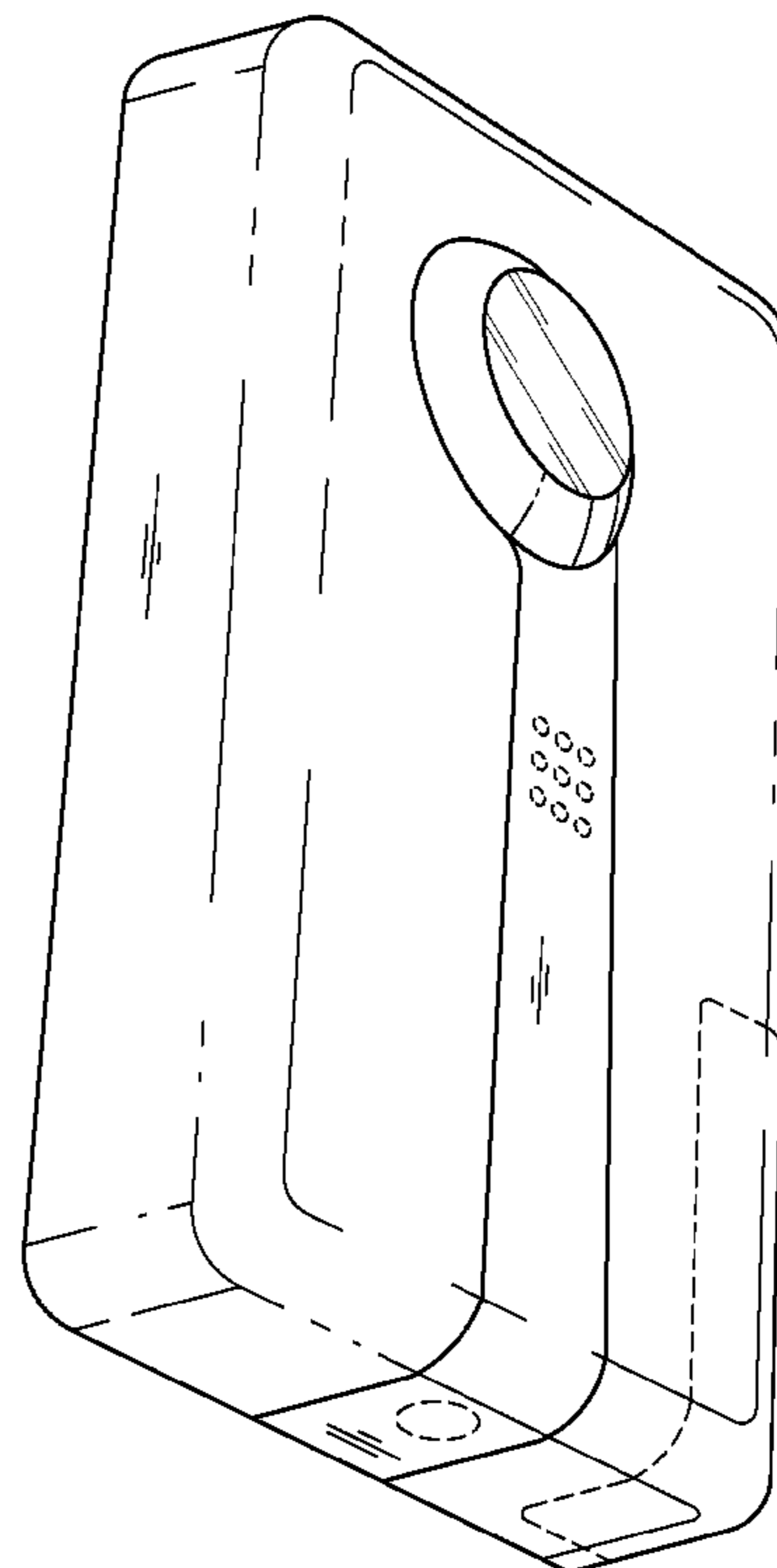
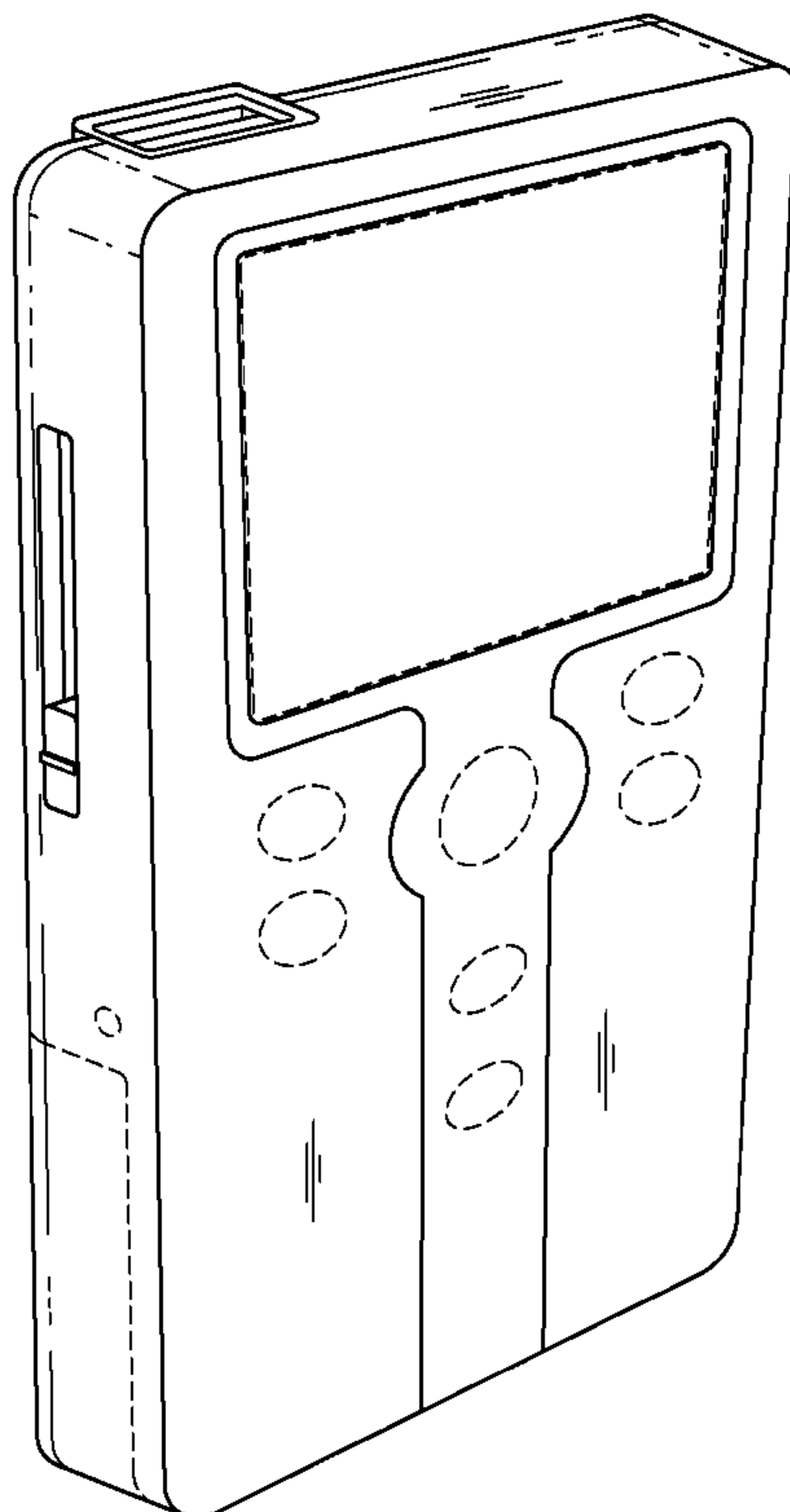

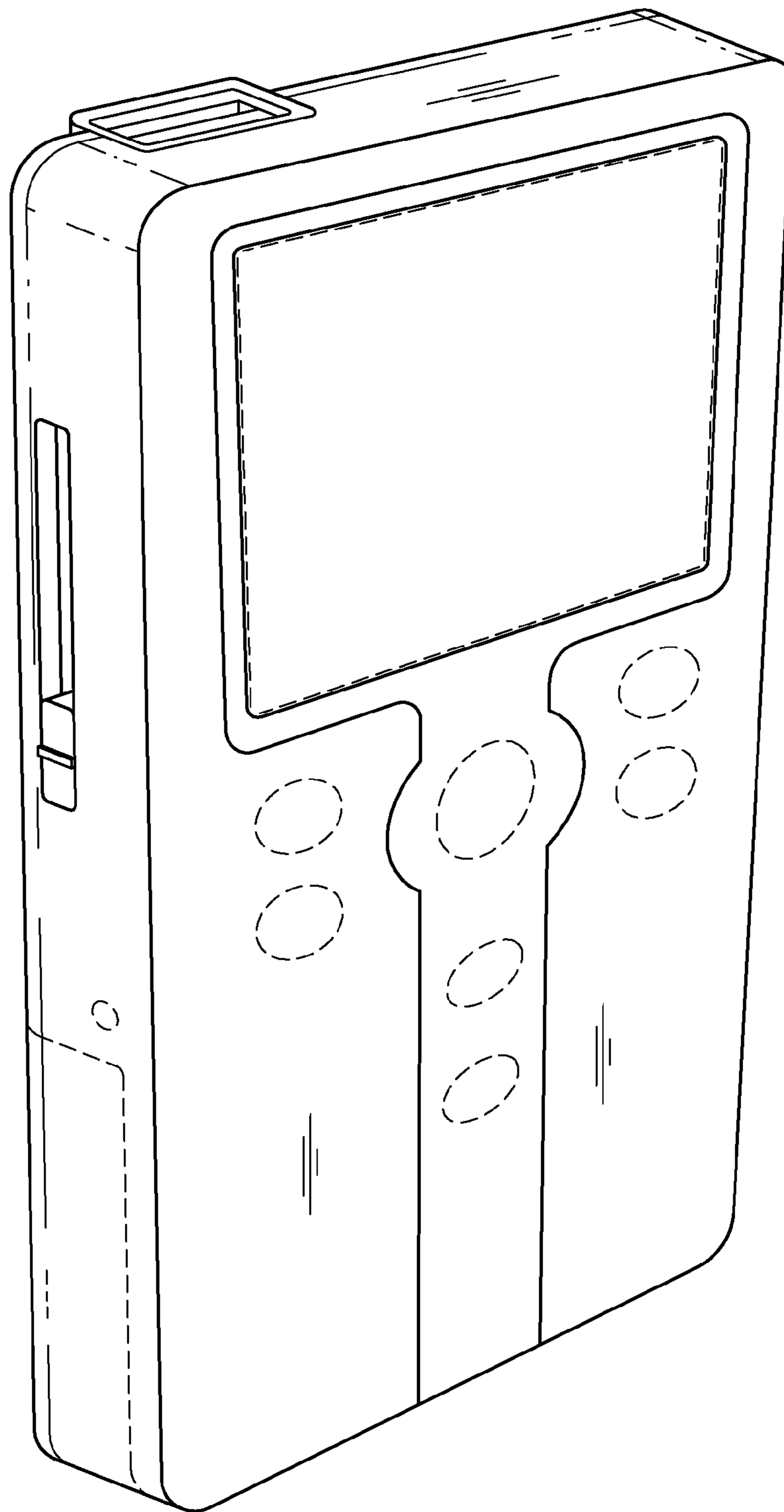

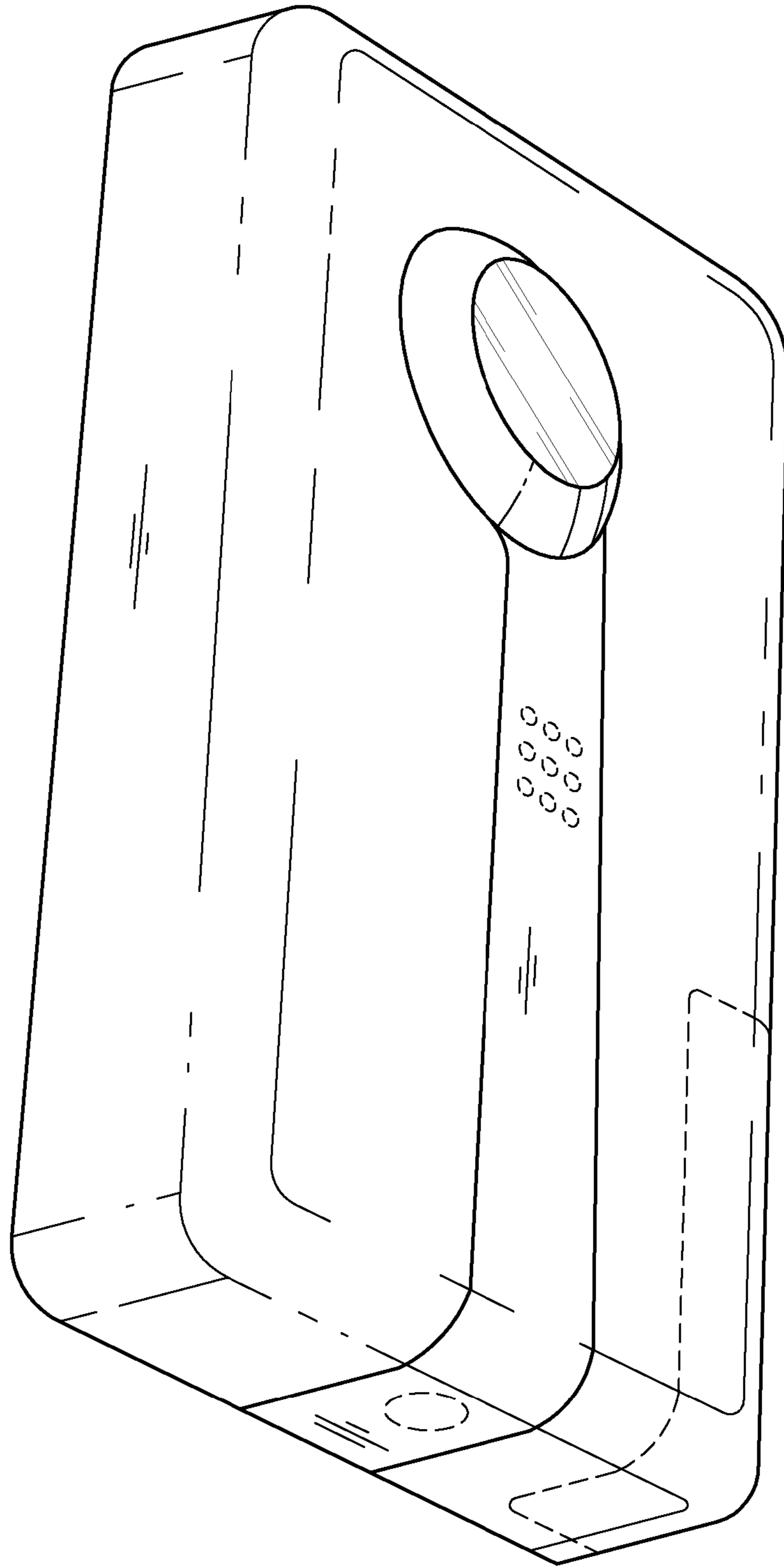

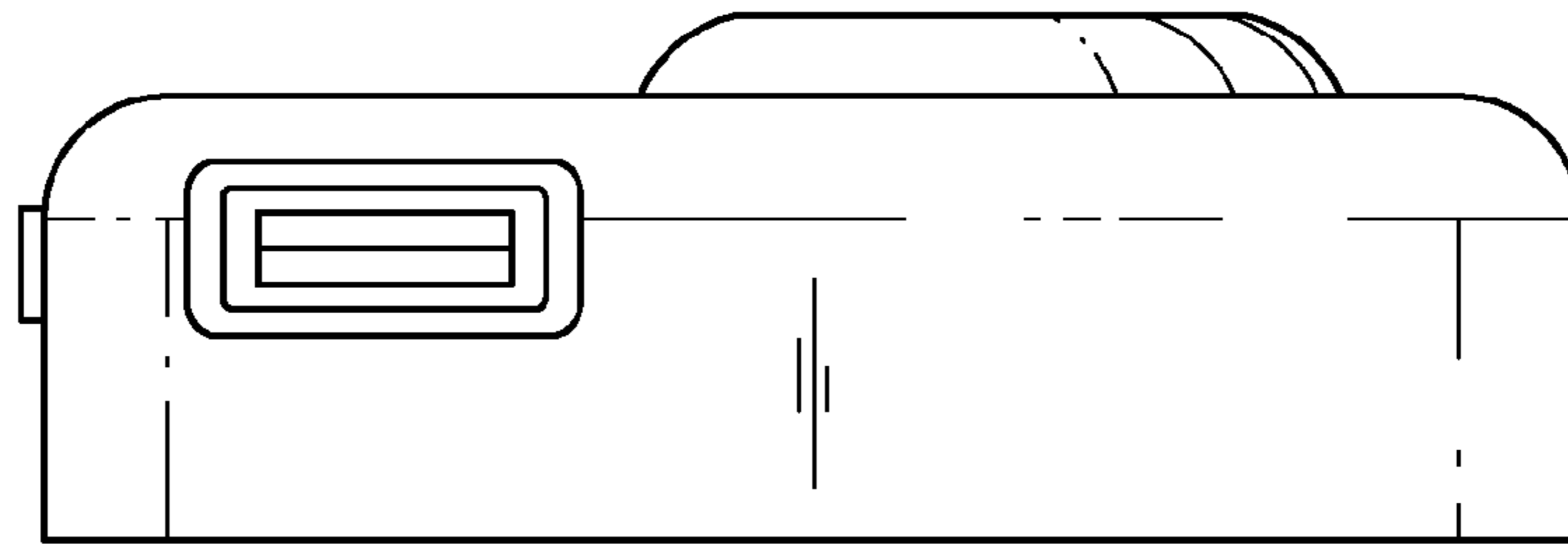

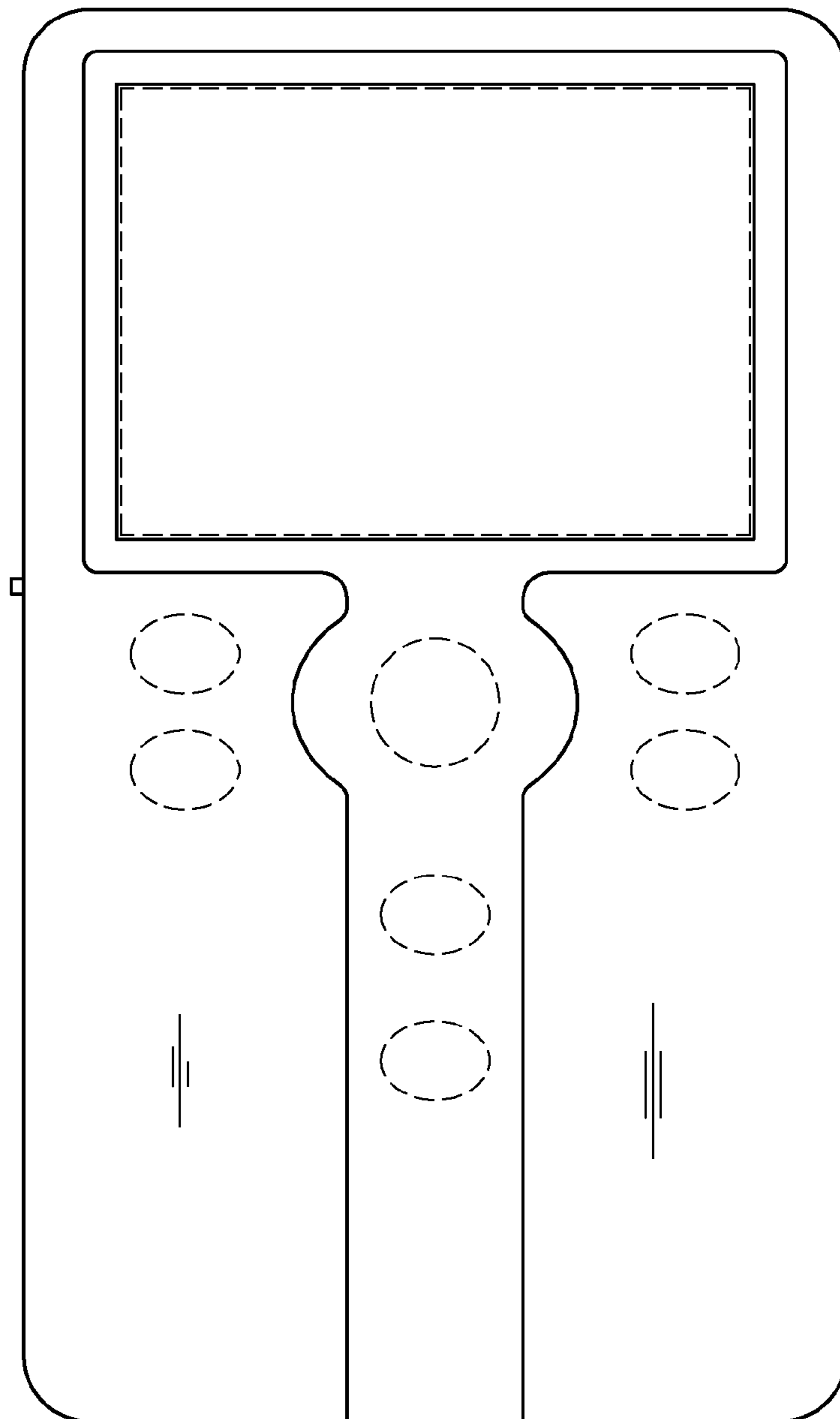

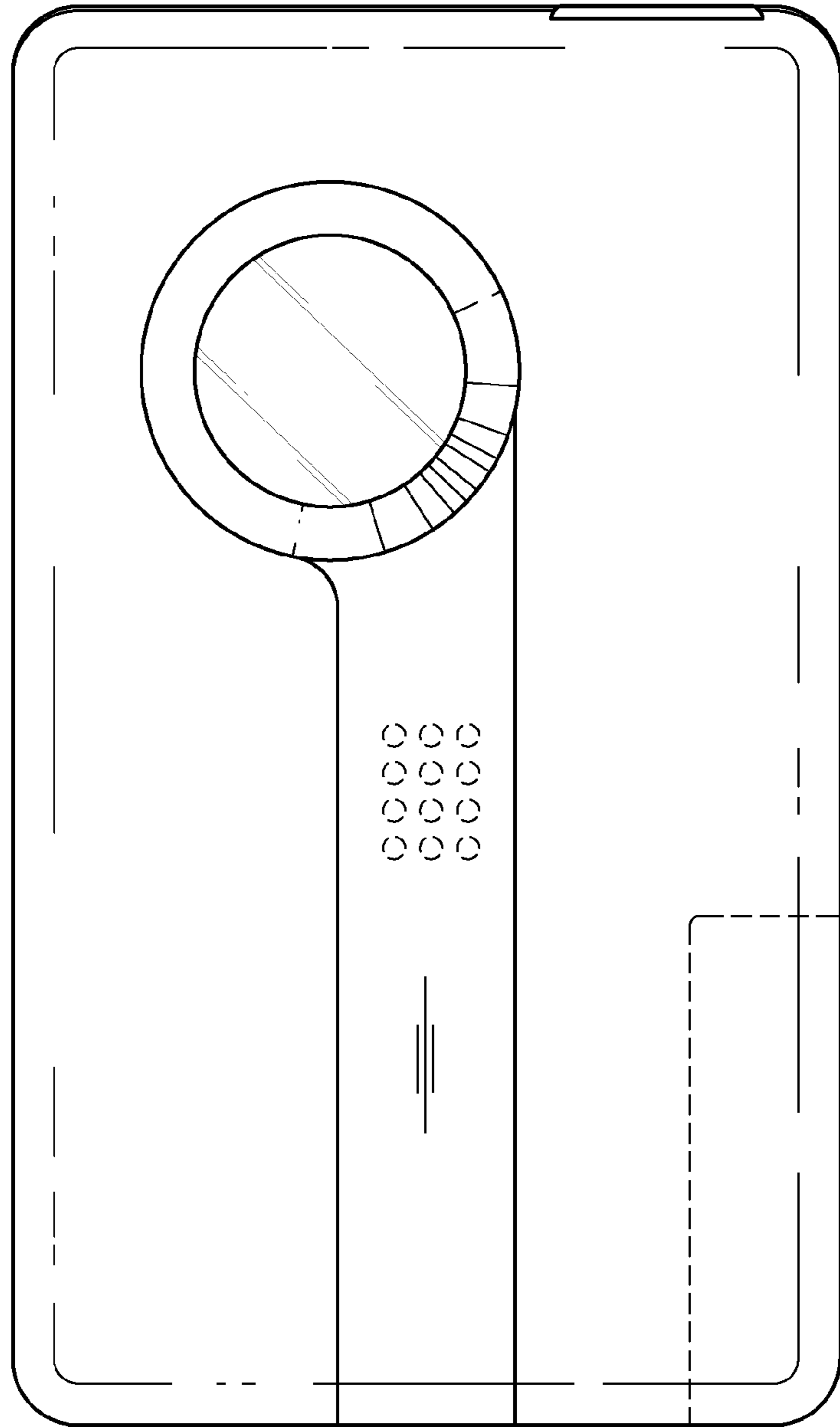

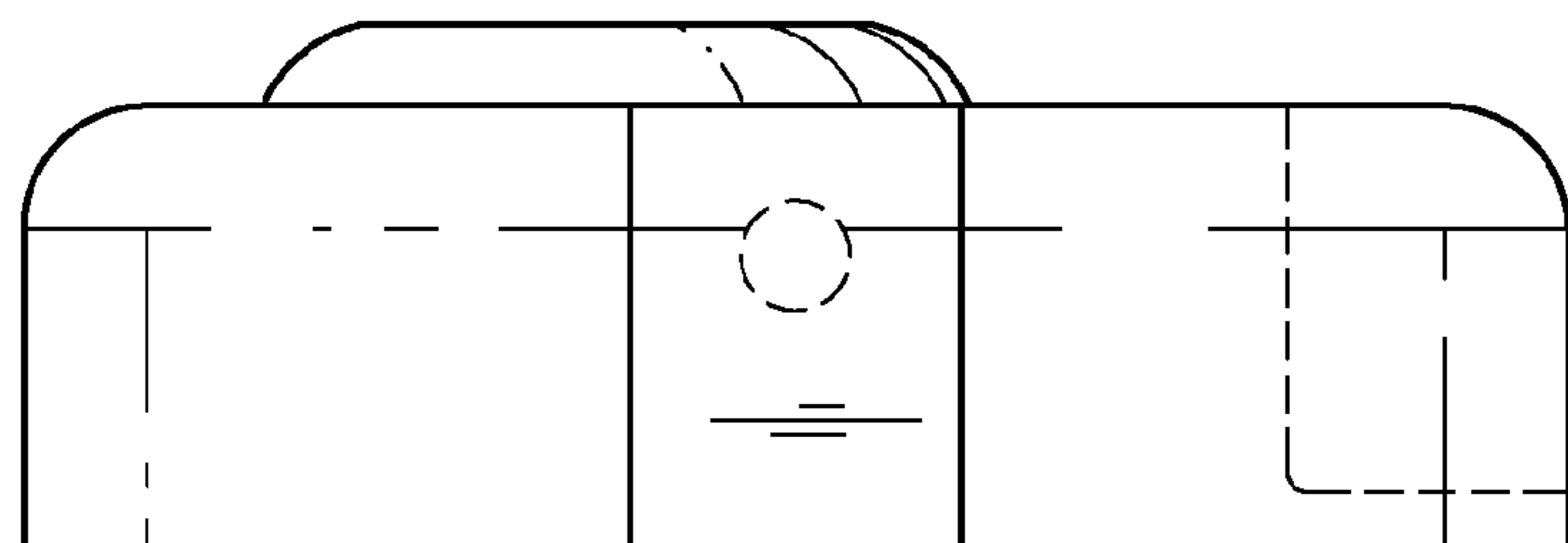

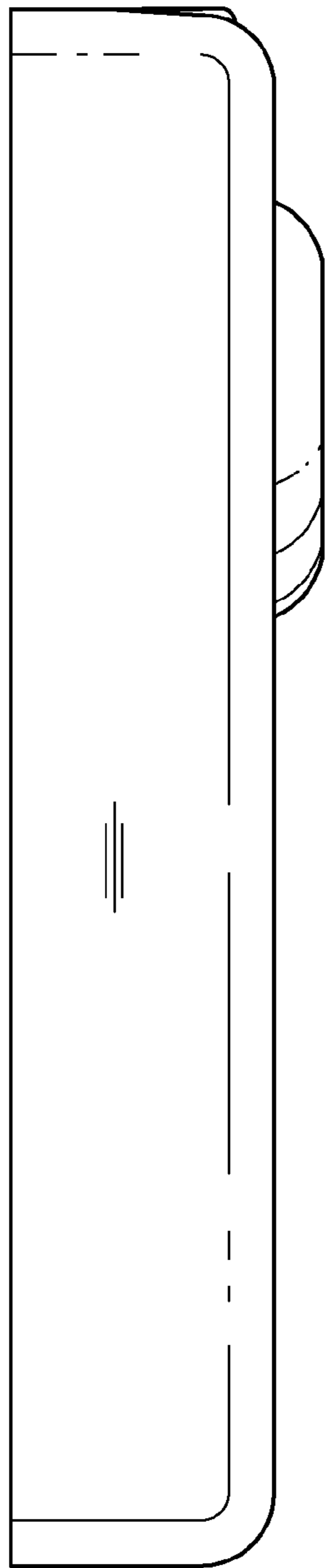

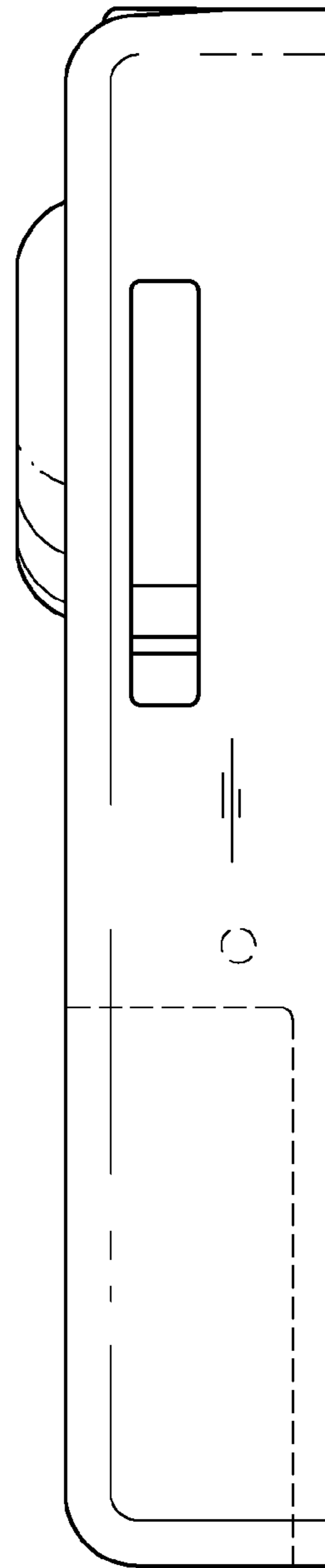

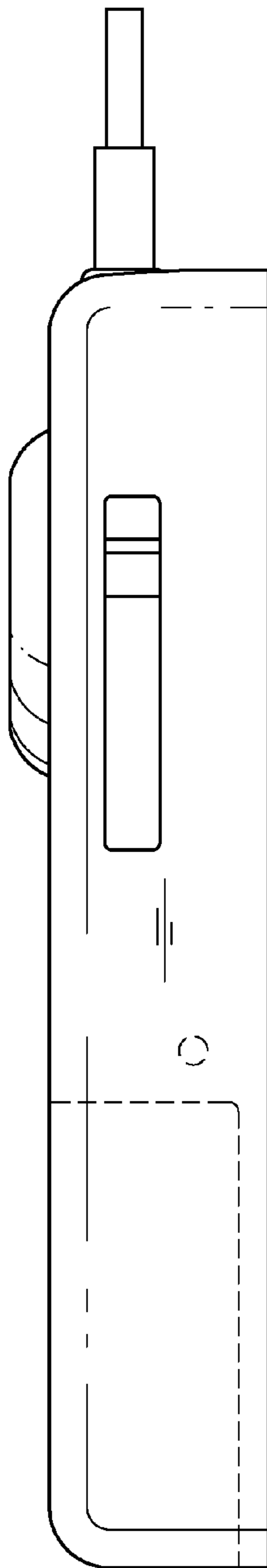
