FIG. 3 is a back elevation view of the tag shown in FIG. 1.

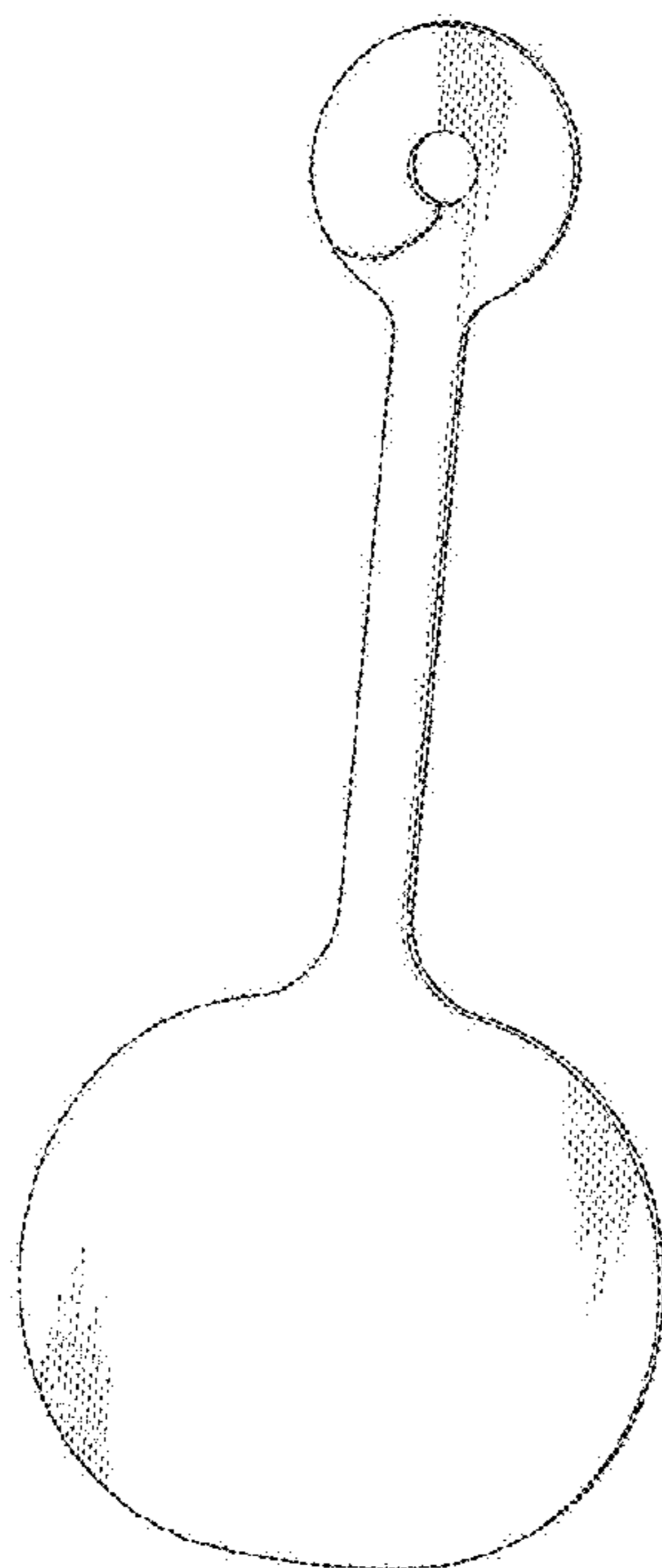
FIG. 4 is a first side elevation view of the tag shown in FIG. 1.

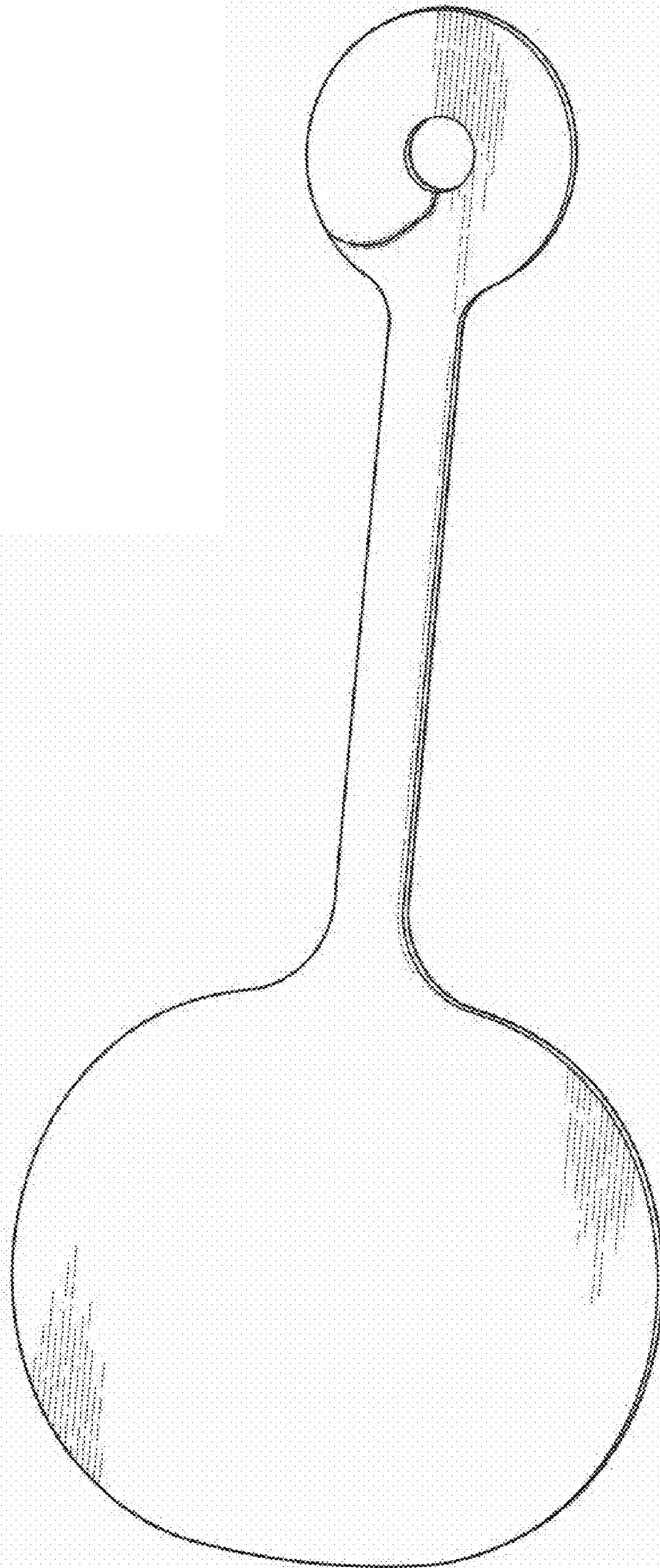

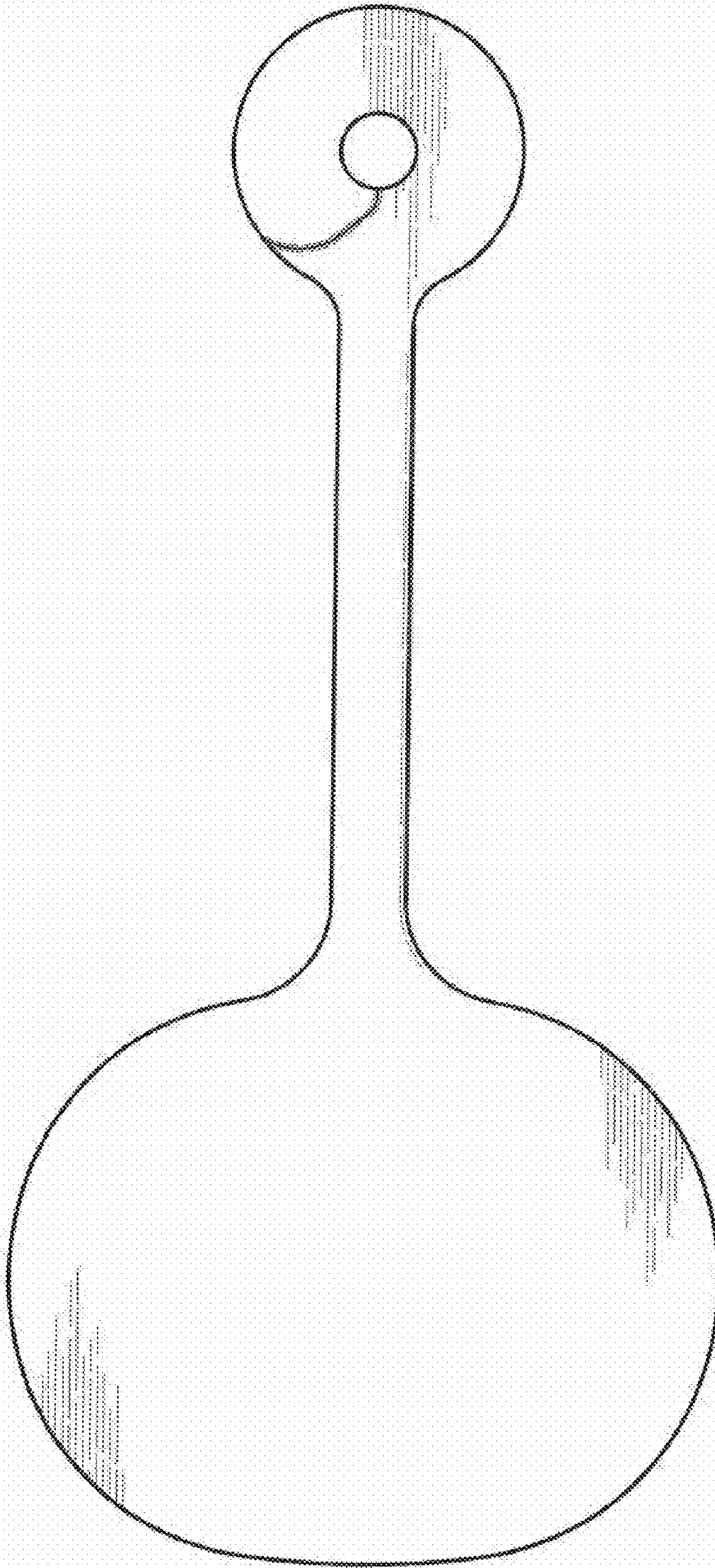

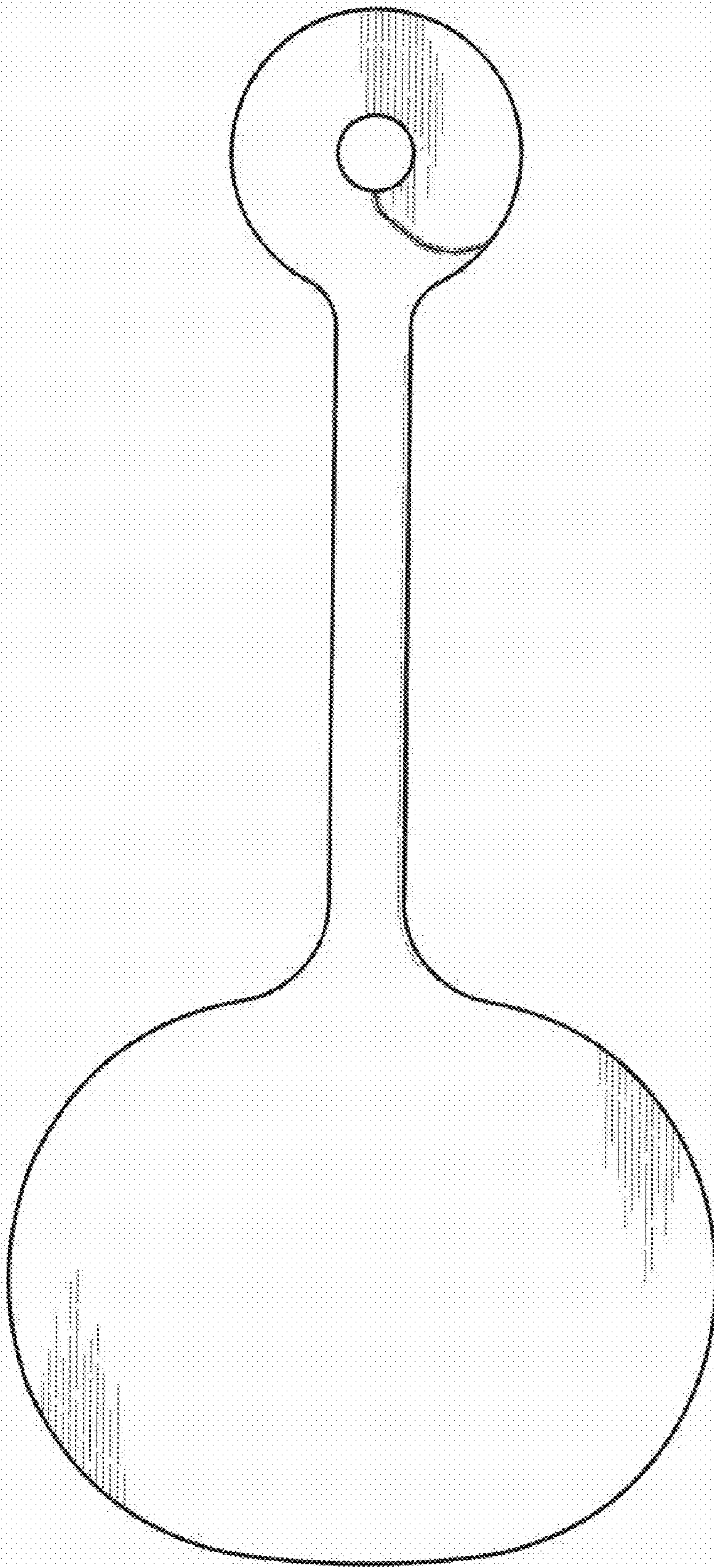

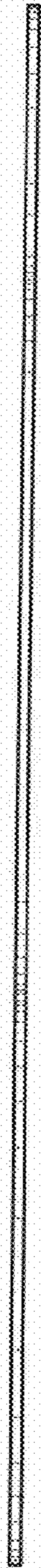

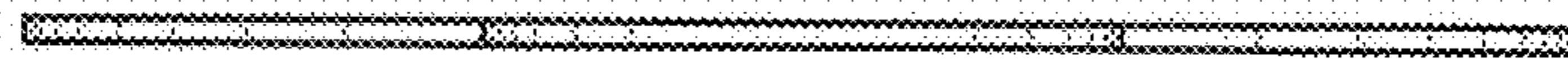

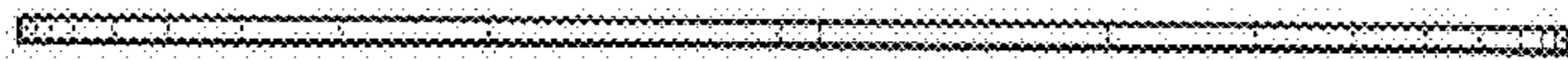
