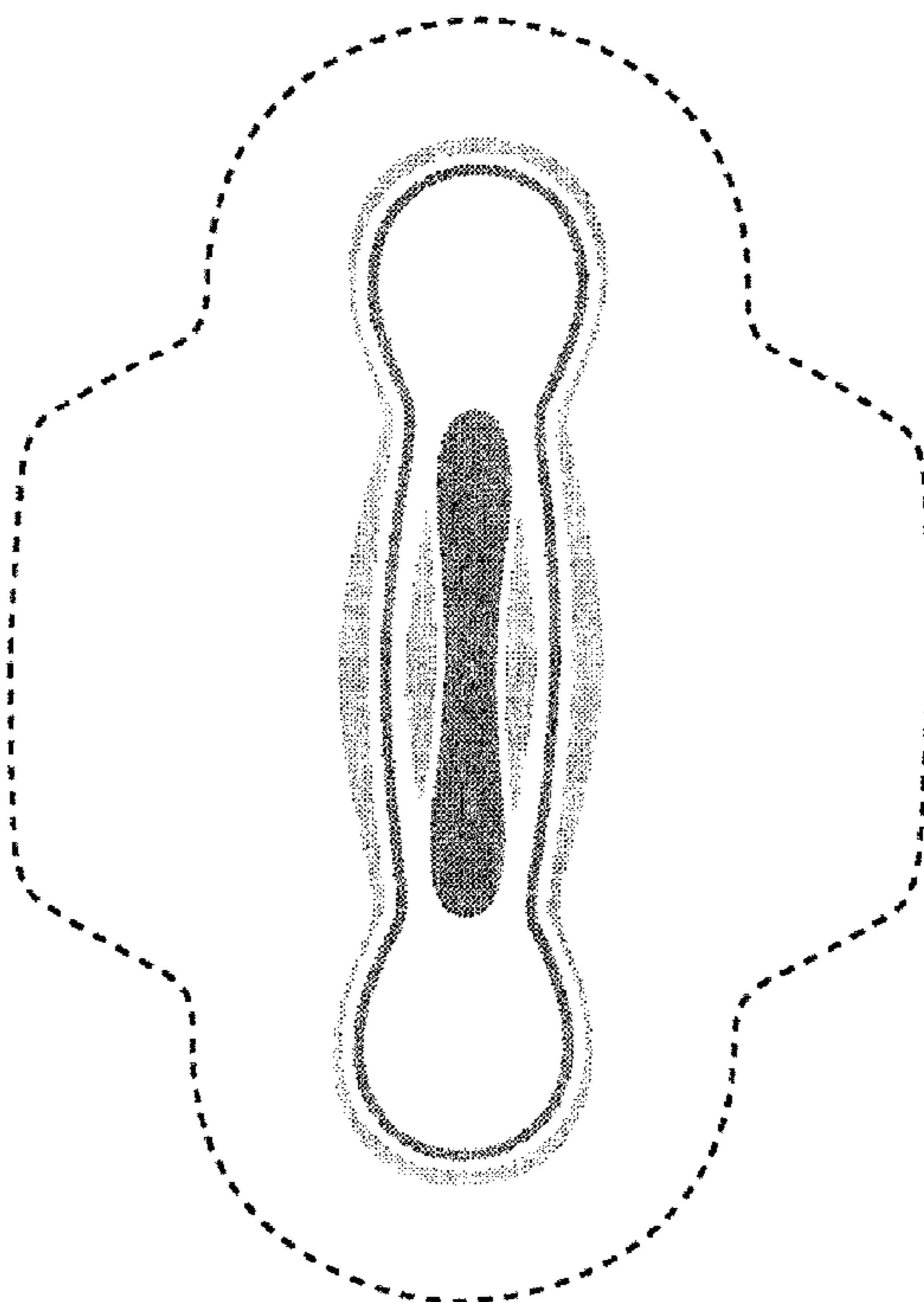

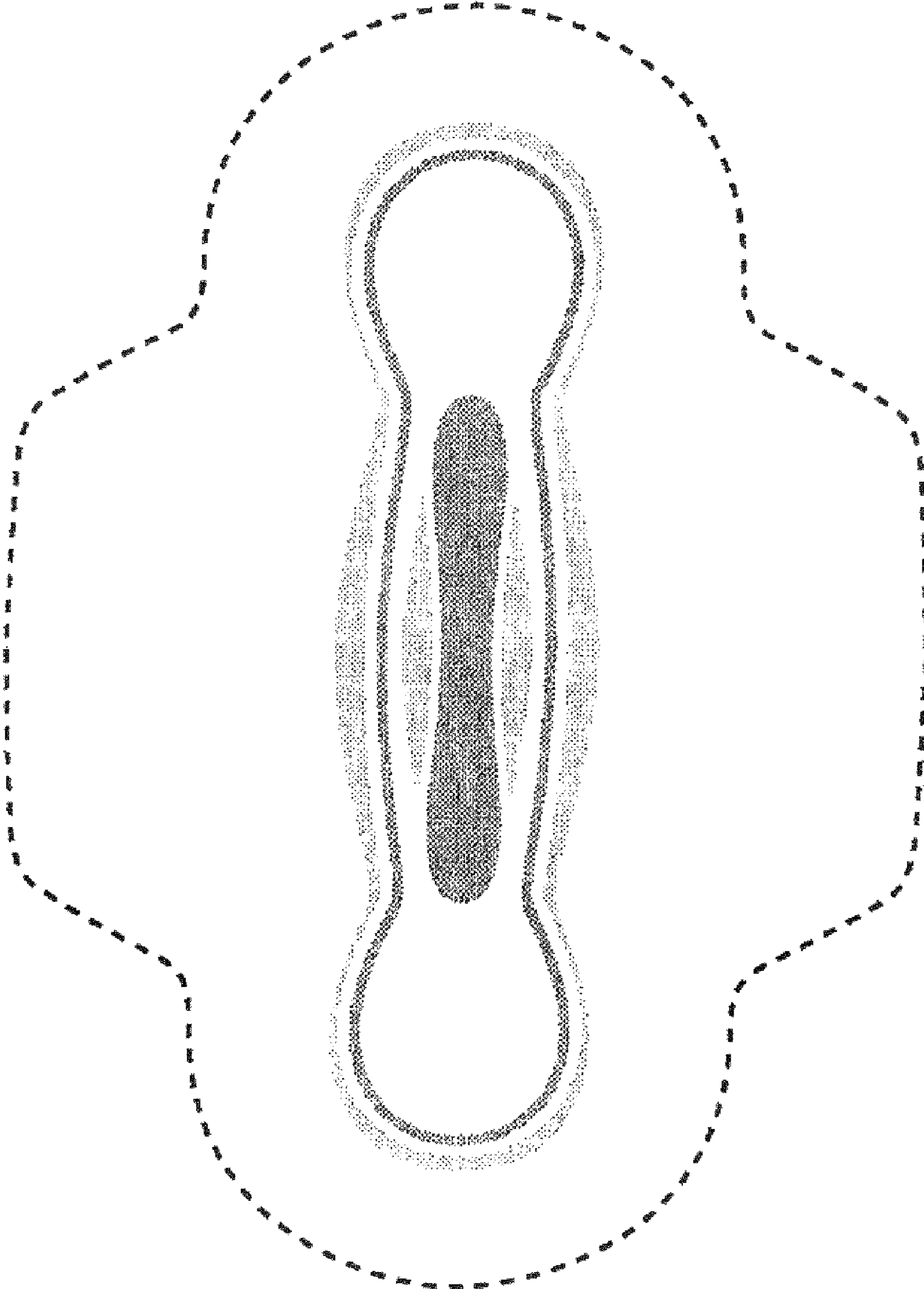
The ornamental design for a feminine hygiene pad with ornamental indicia, as shown and described.
