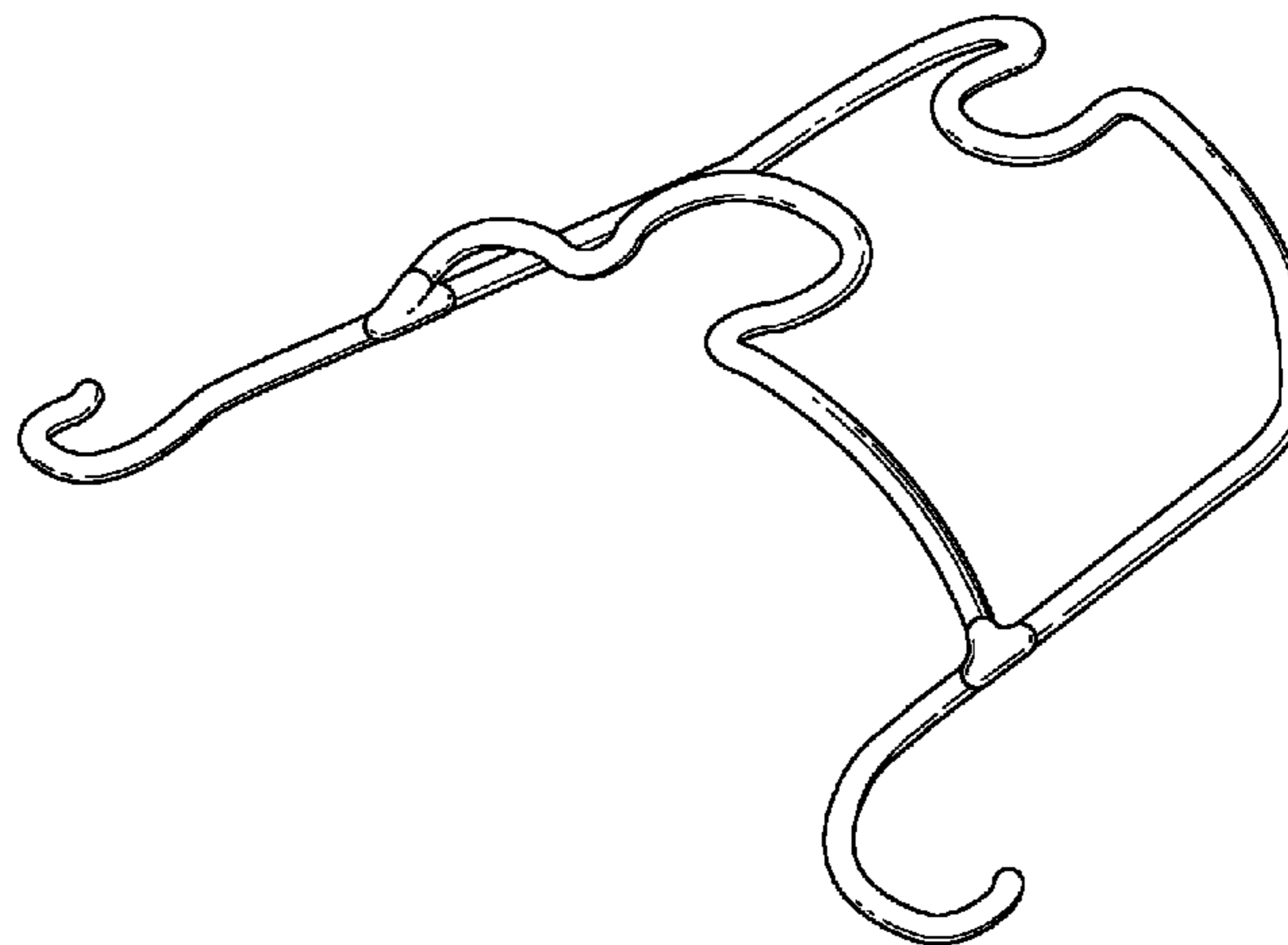
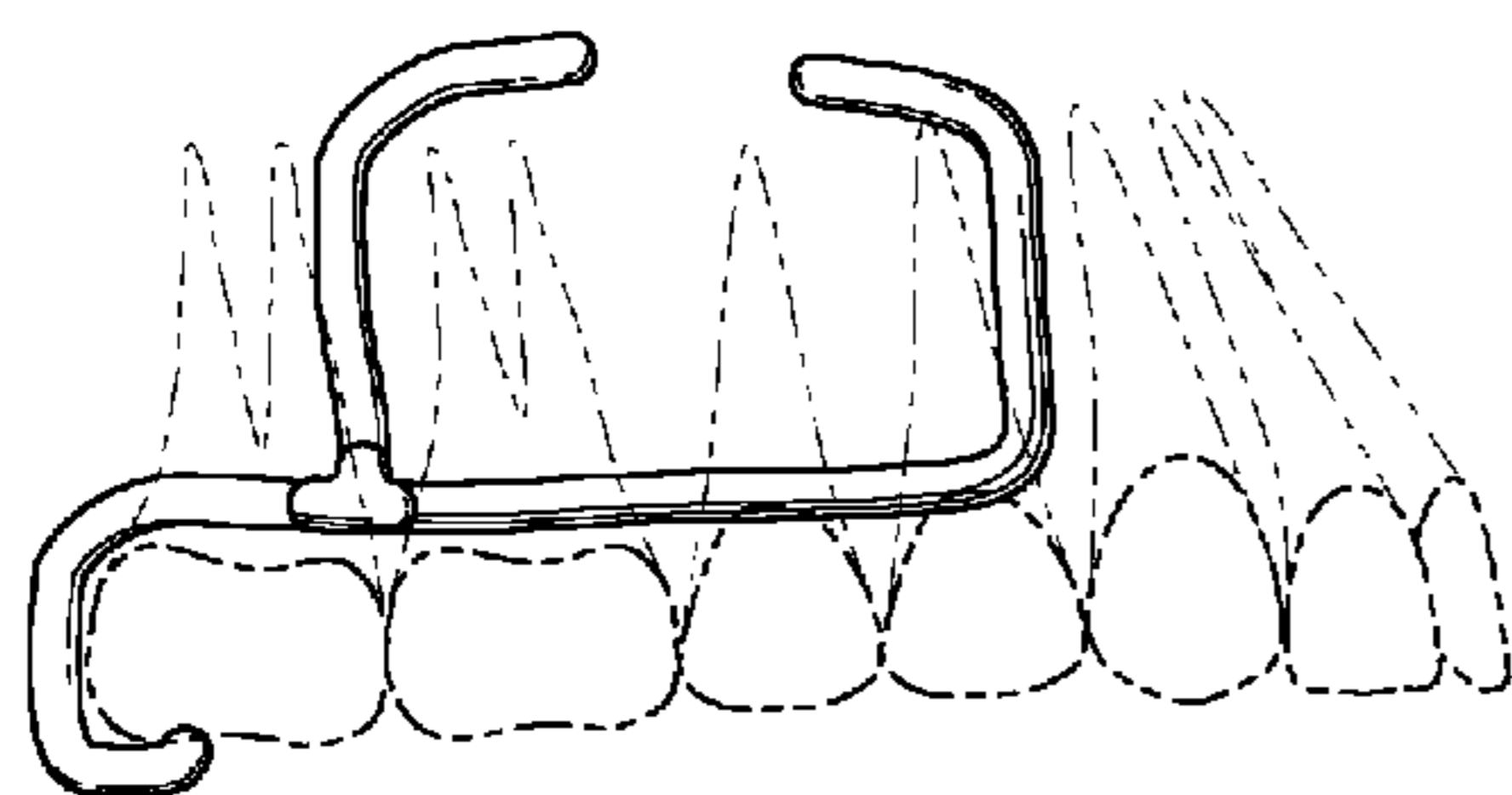
(57) **CLAIM**

The ornamental design for a spring, as shown and described.

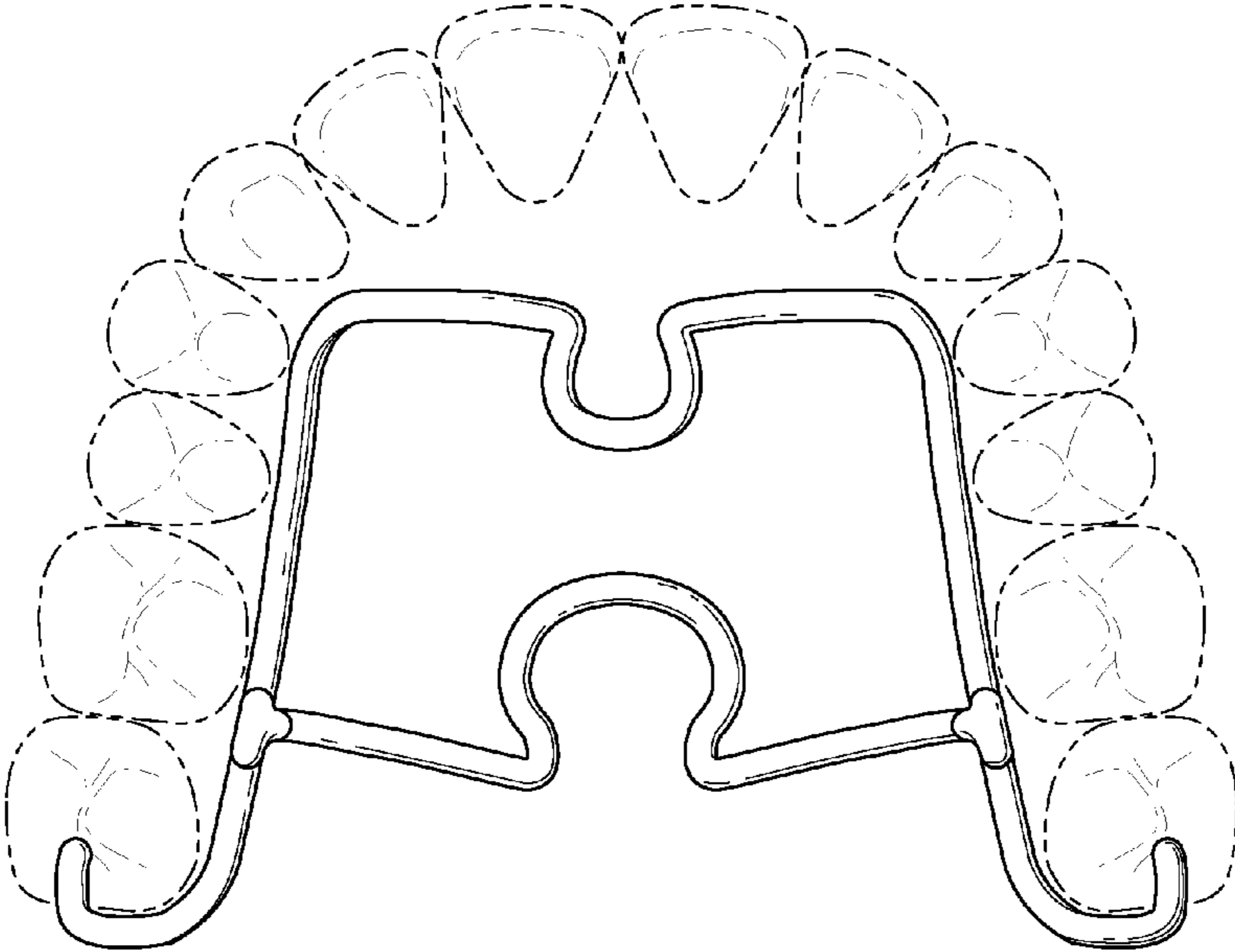
**DESCRIPTION**

FIG. 1 is a top view of a spring showing my design;  
 FIG. 2 is a reduce scale left side elevation view thereof;

 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a reduce scale right side elevation view thereof;  
 FIG. 6 is a reduce scale left side elevation view thereof;

 FIG. 9 is a rear, left-side perspective view thereof.  
 The broken lines showing the teeth in FIGS. 1 and 2 are included for illustrating environmental structure and form no part of the claimed design.

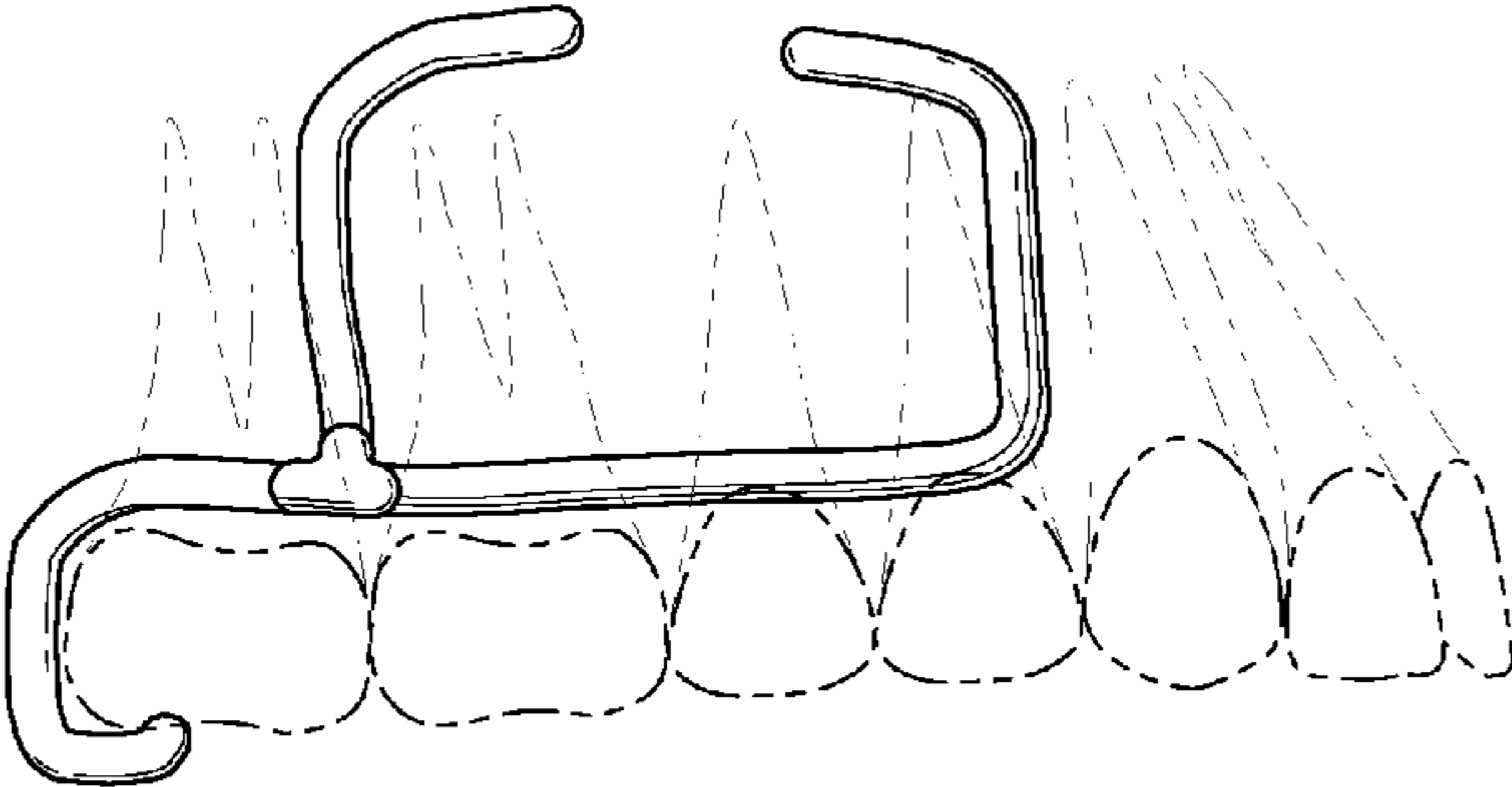

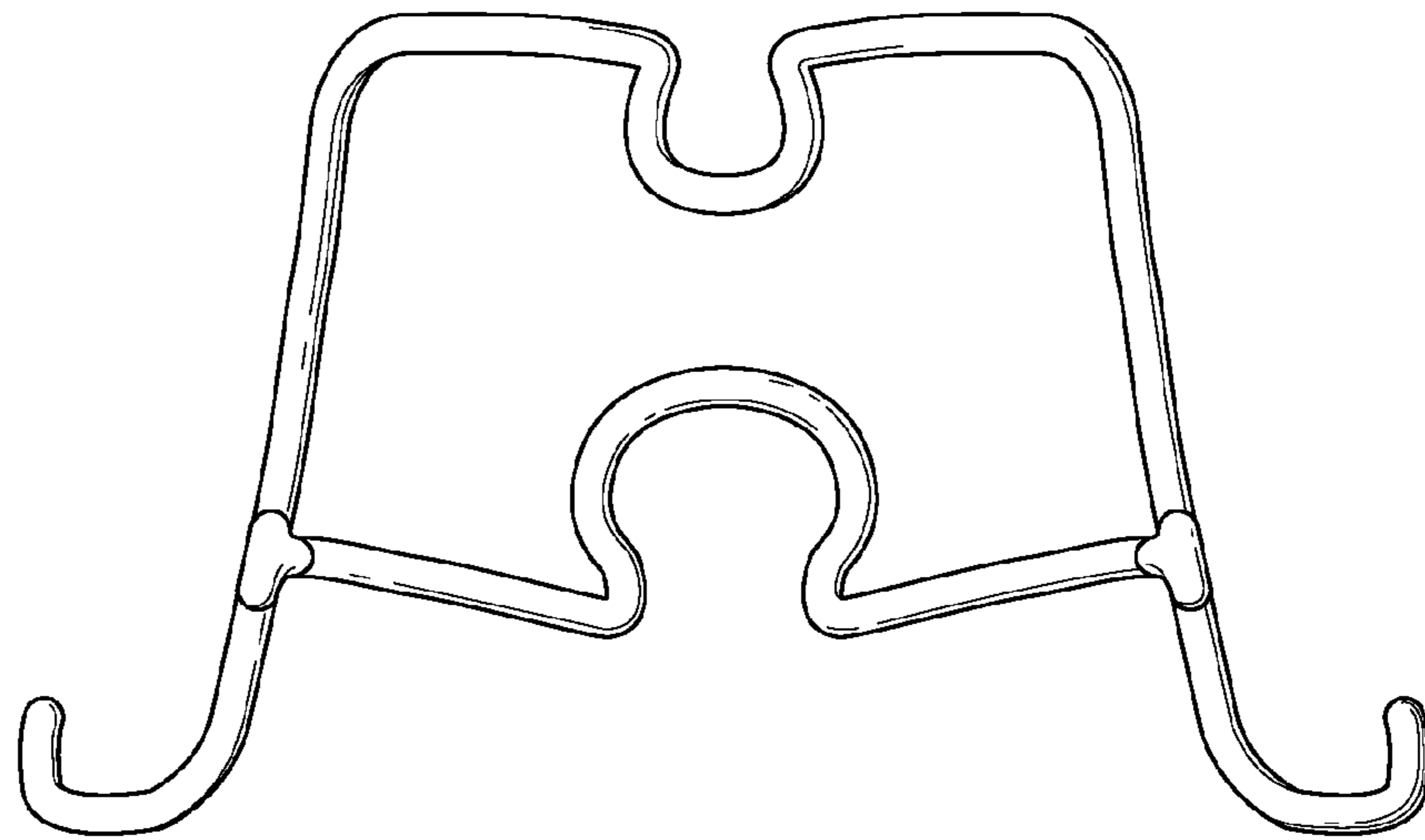

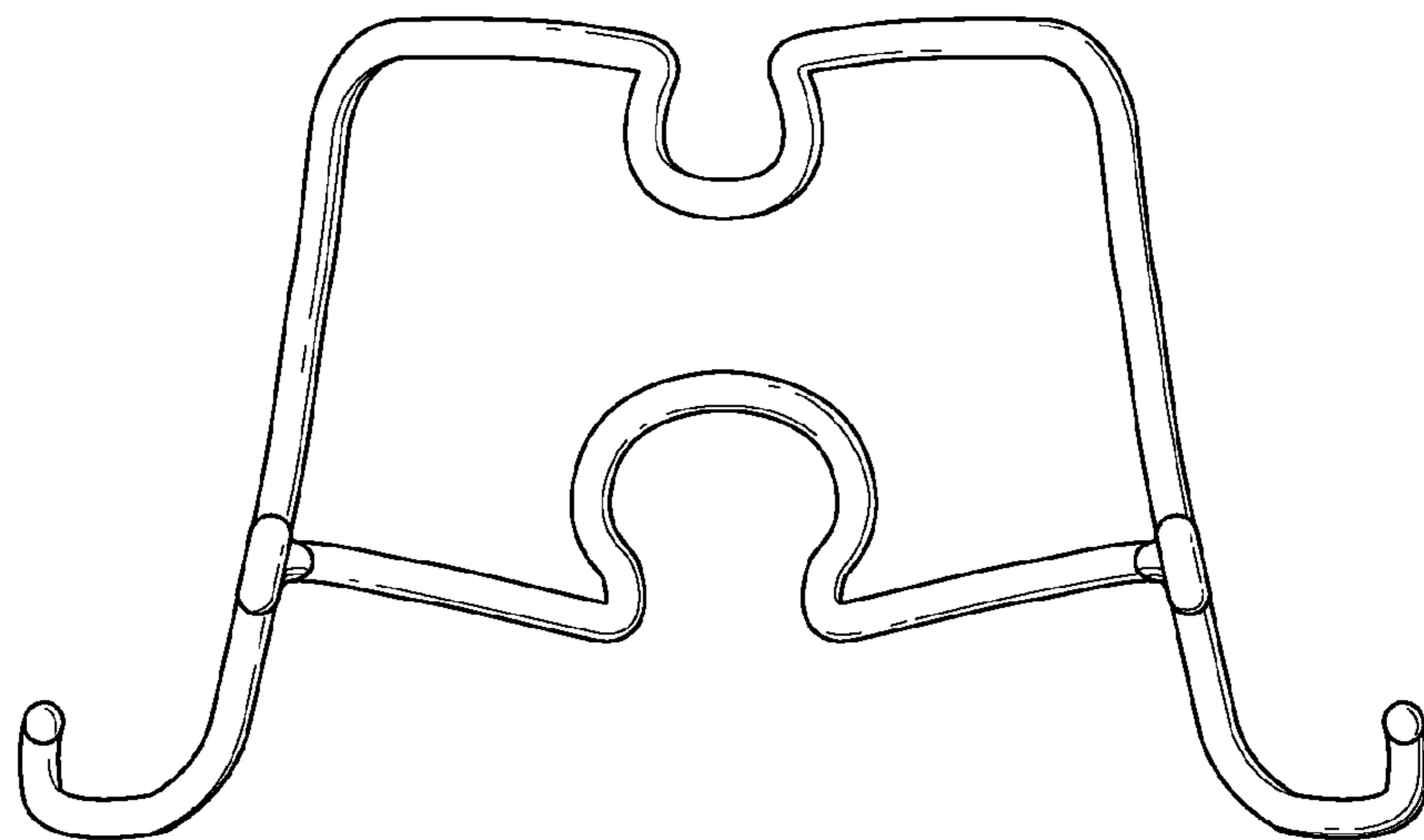

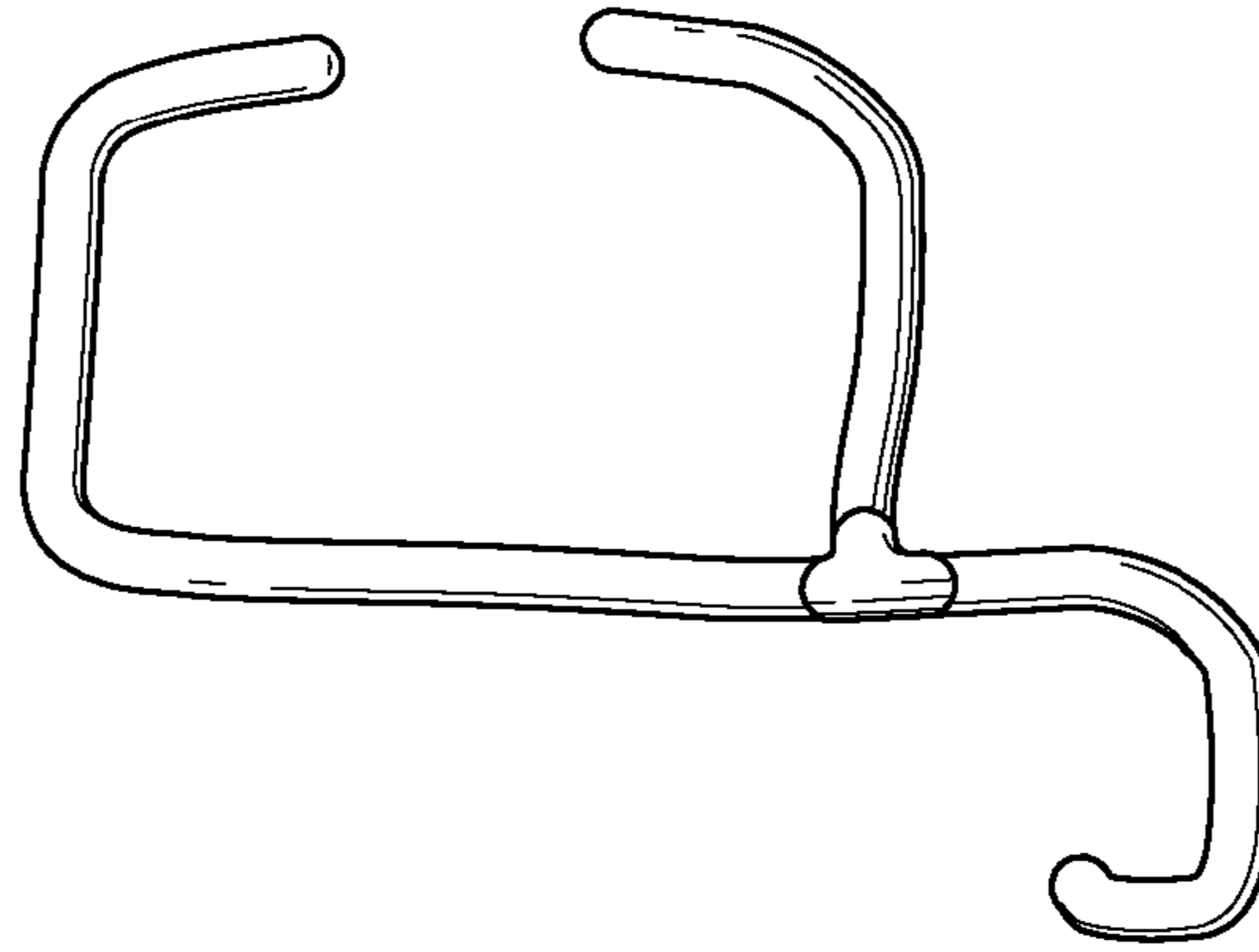

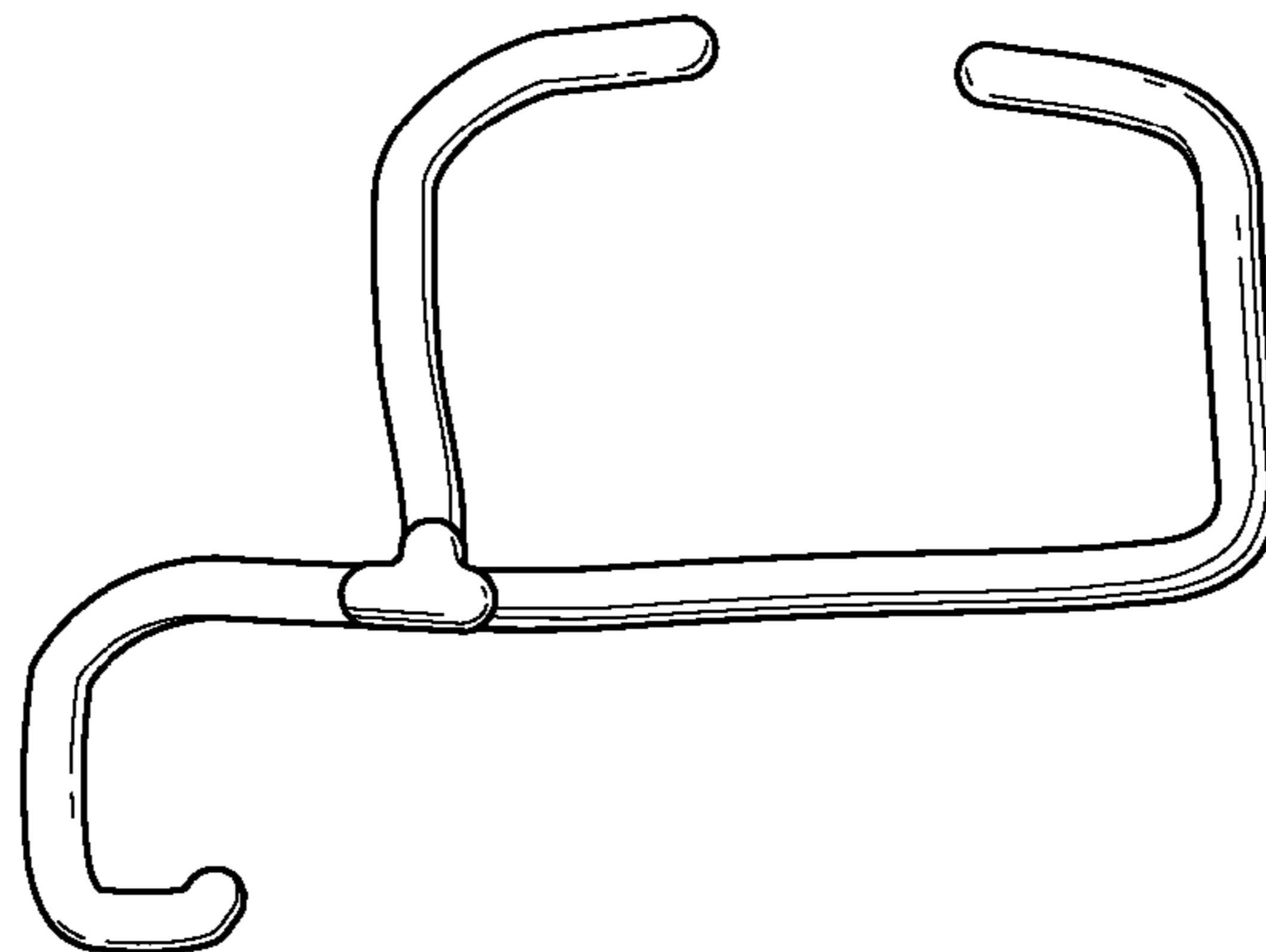

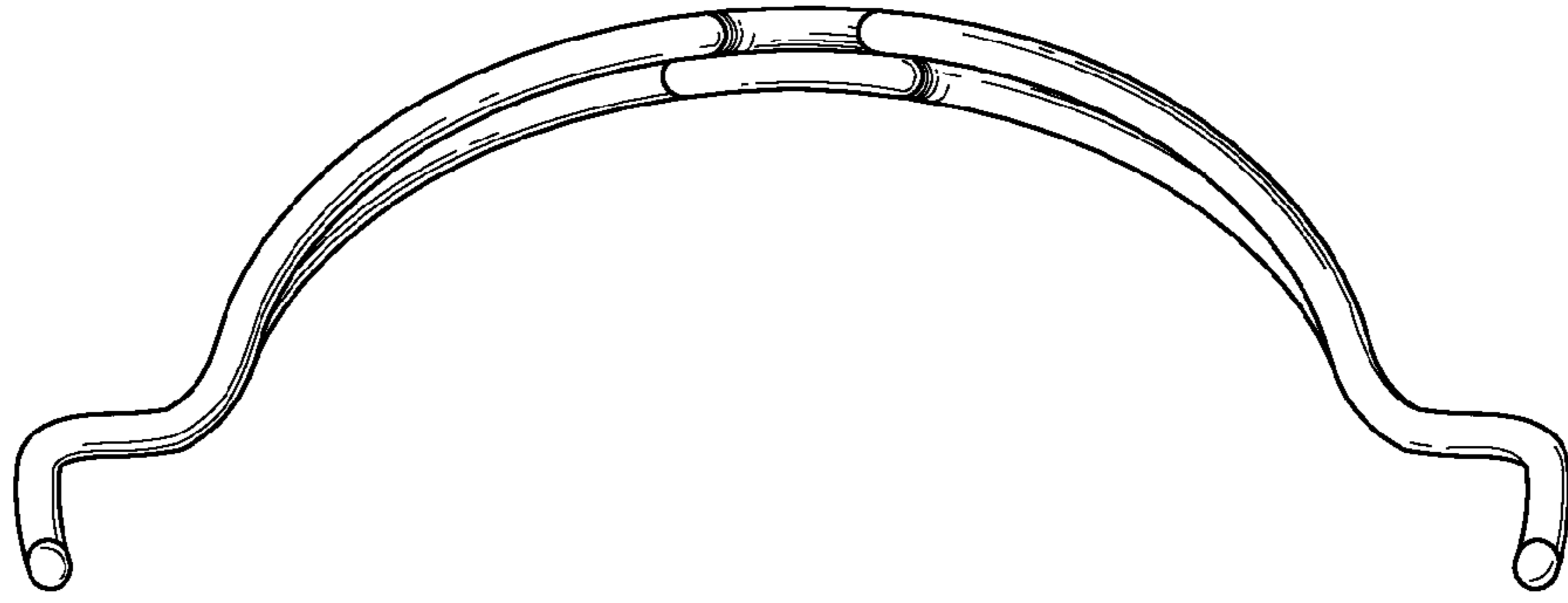

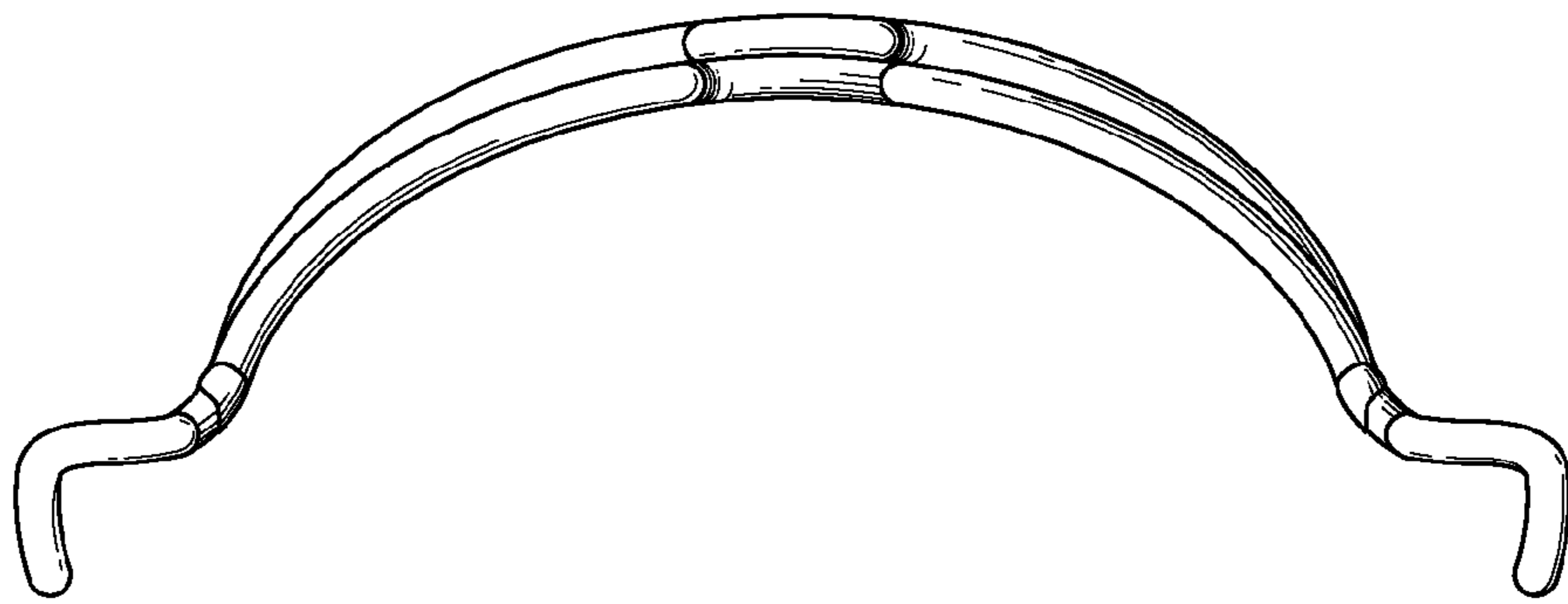
