(57) **CLAIM**

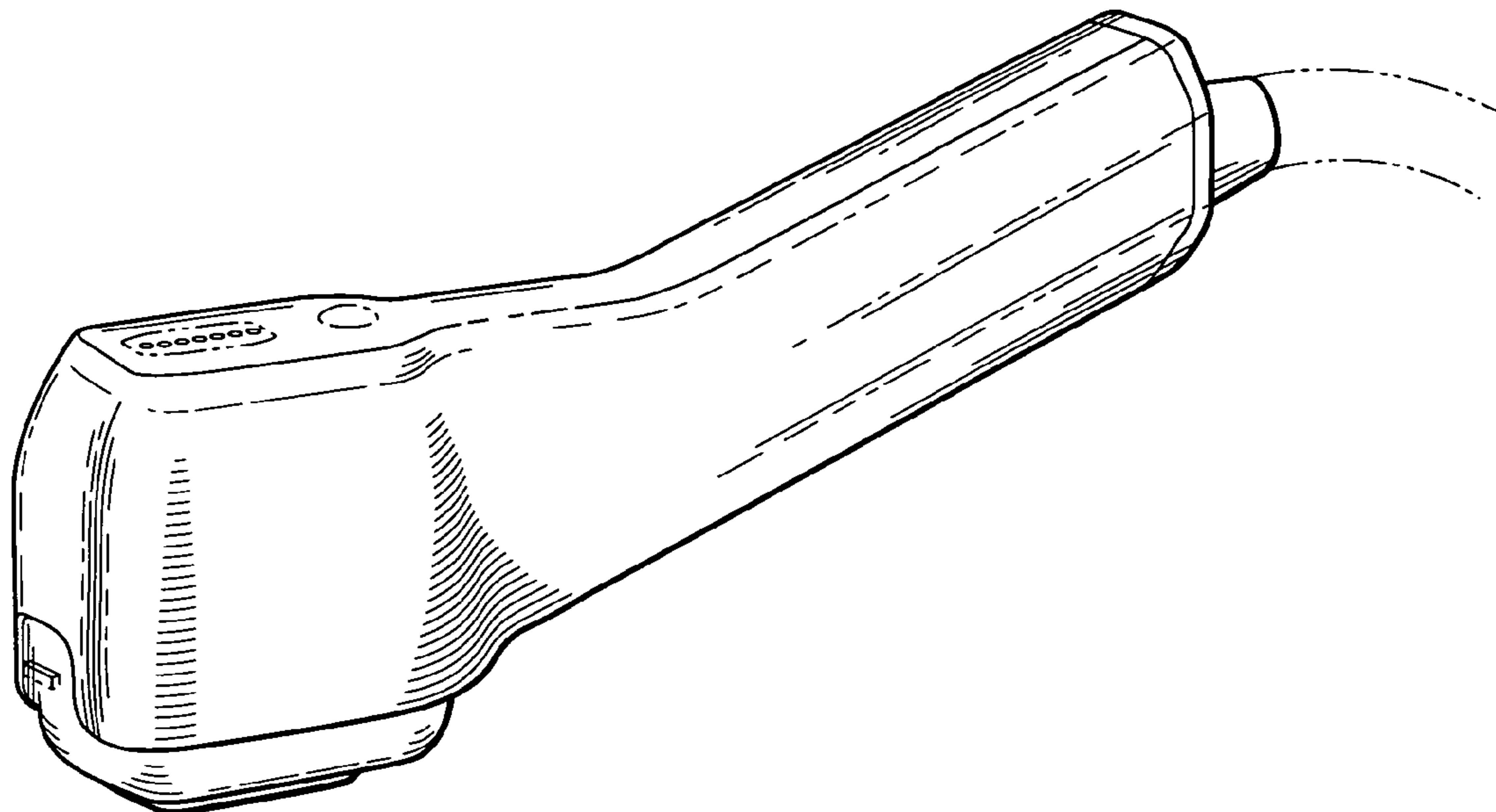
The ornamental design for a hand-held applicator for applying energy to a body tissue region, as shown and described.

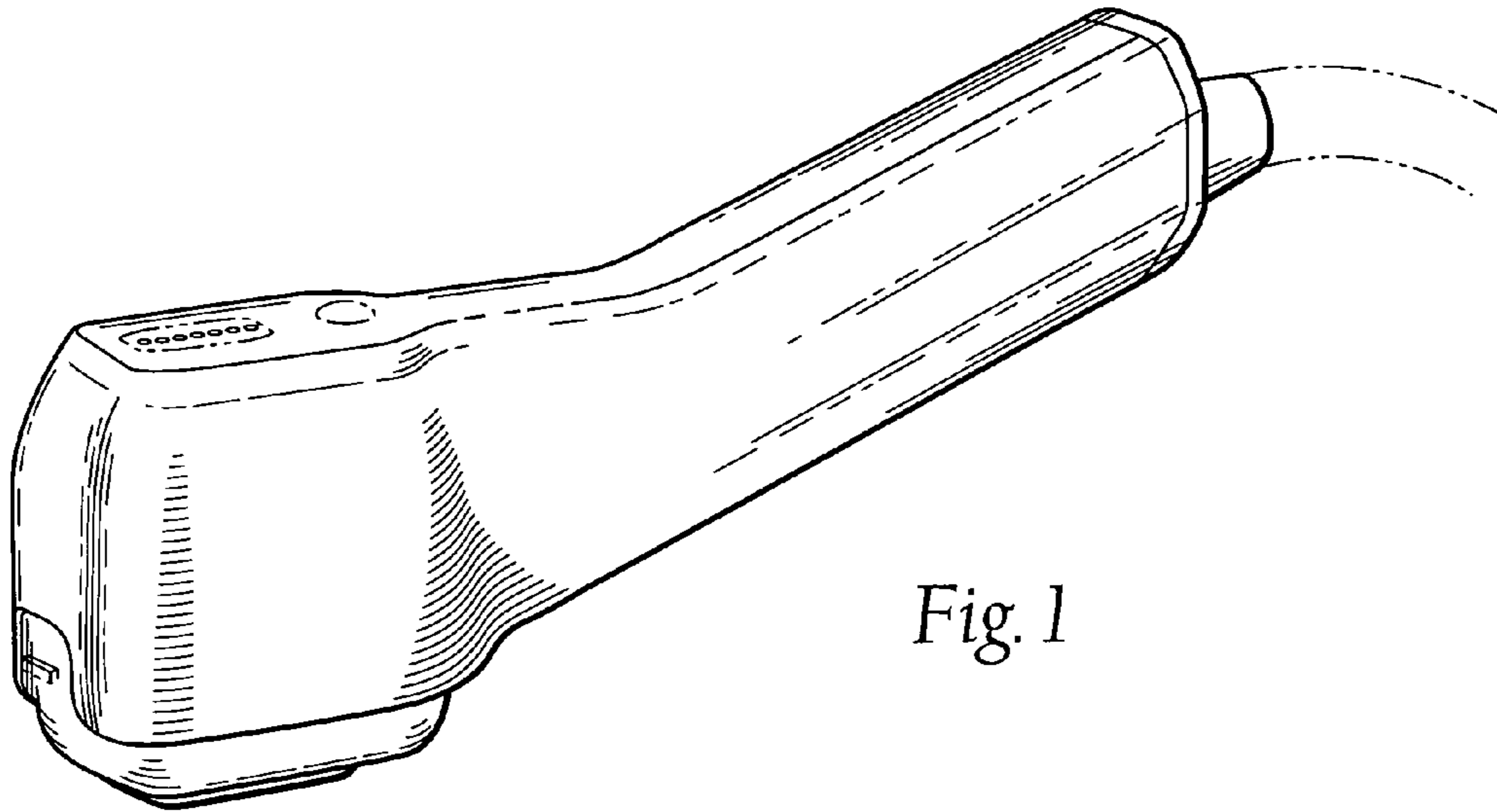

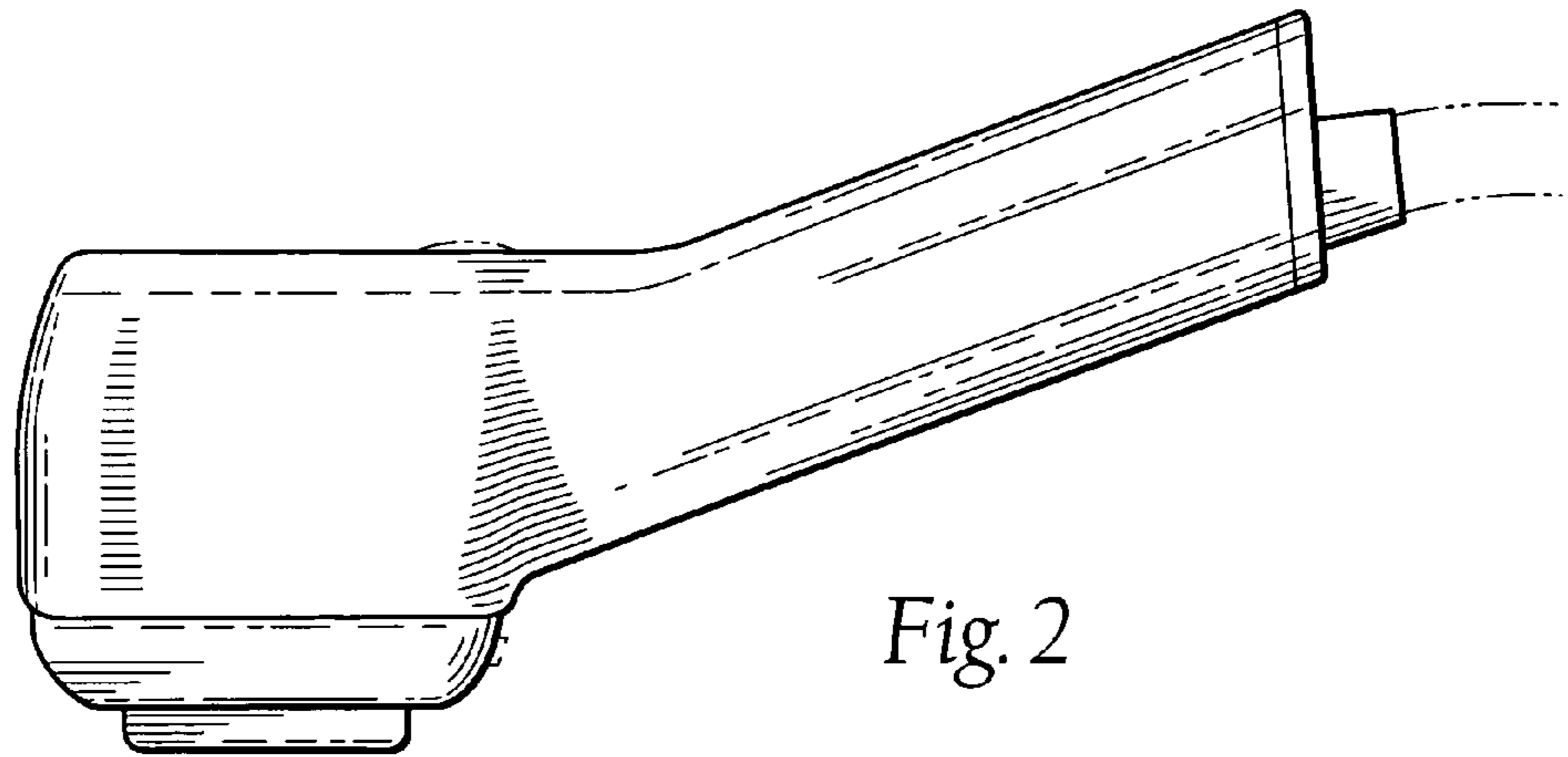

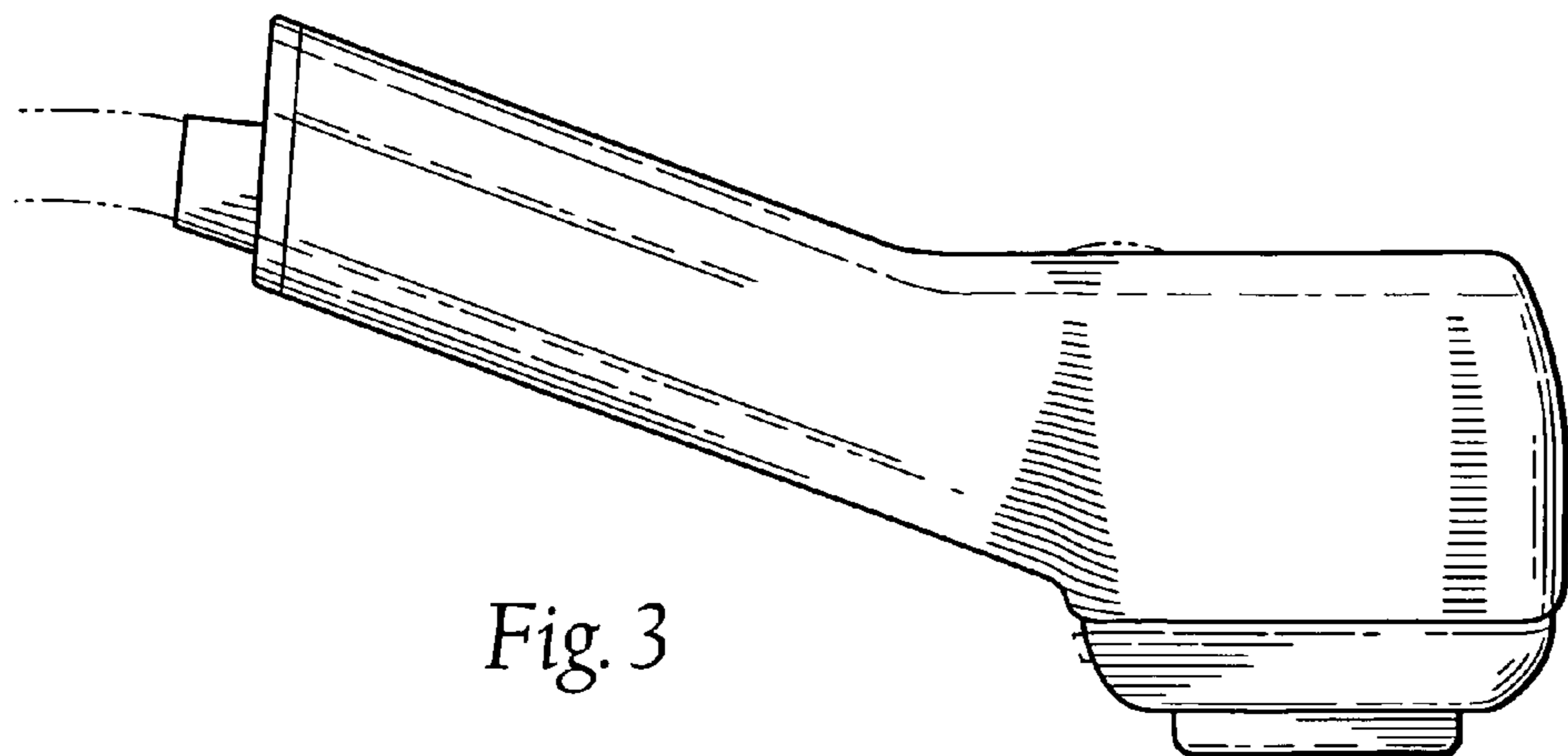

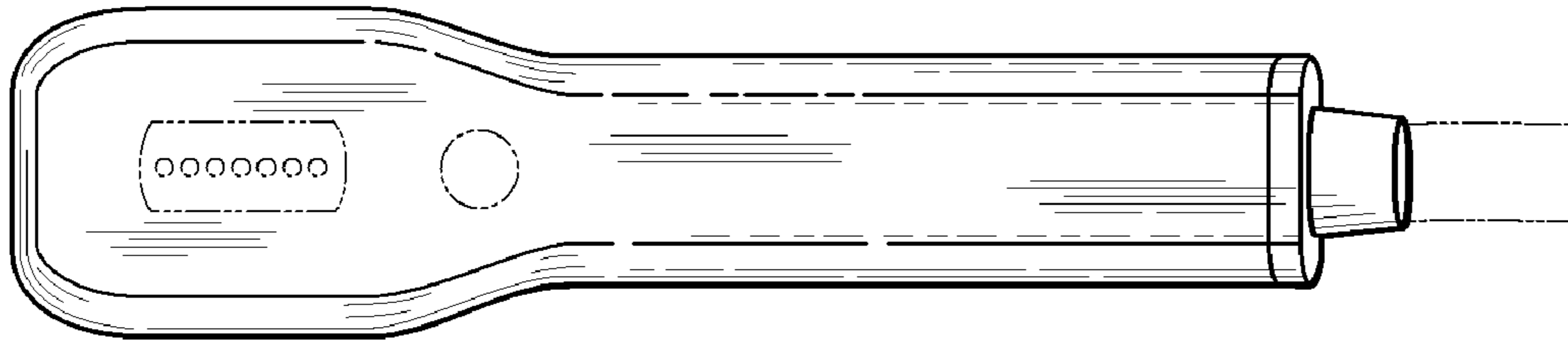

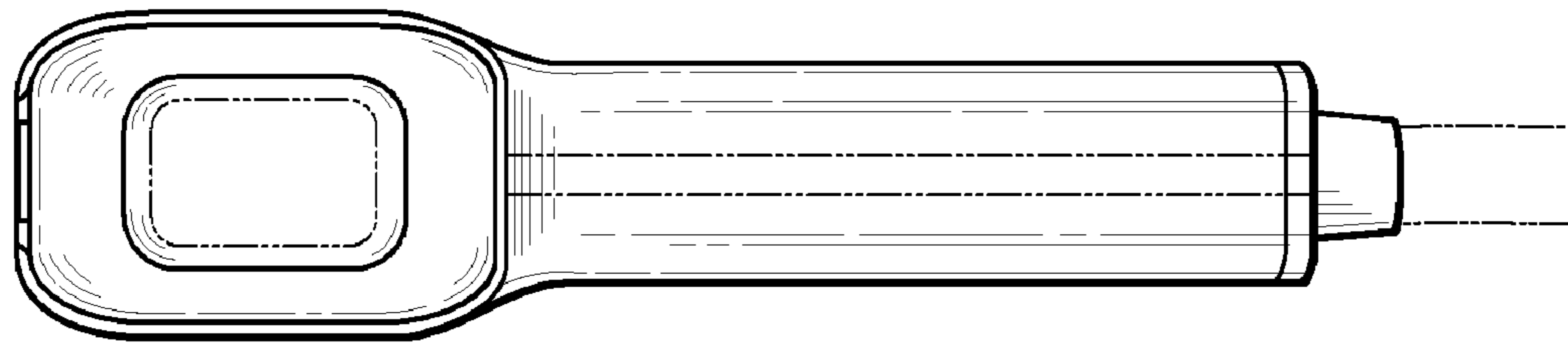

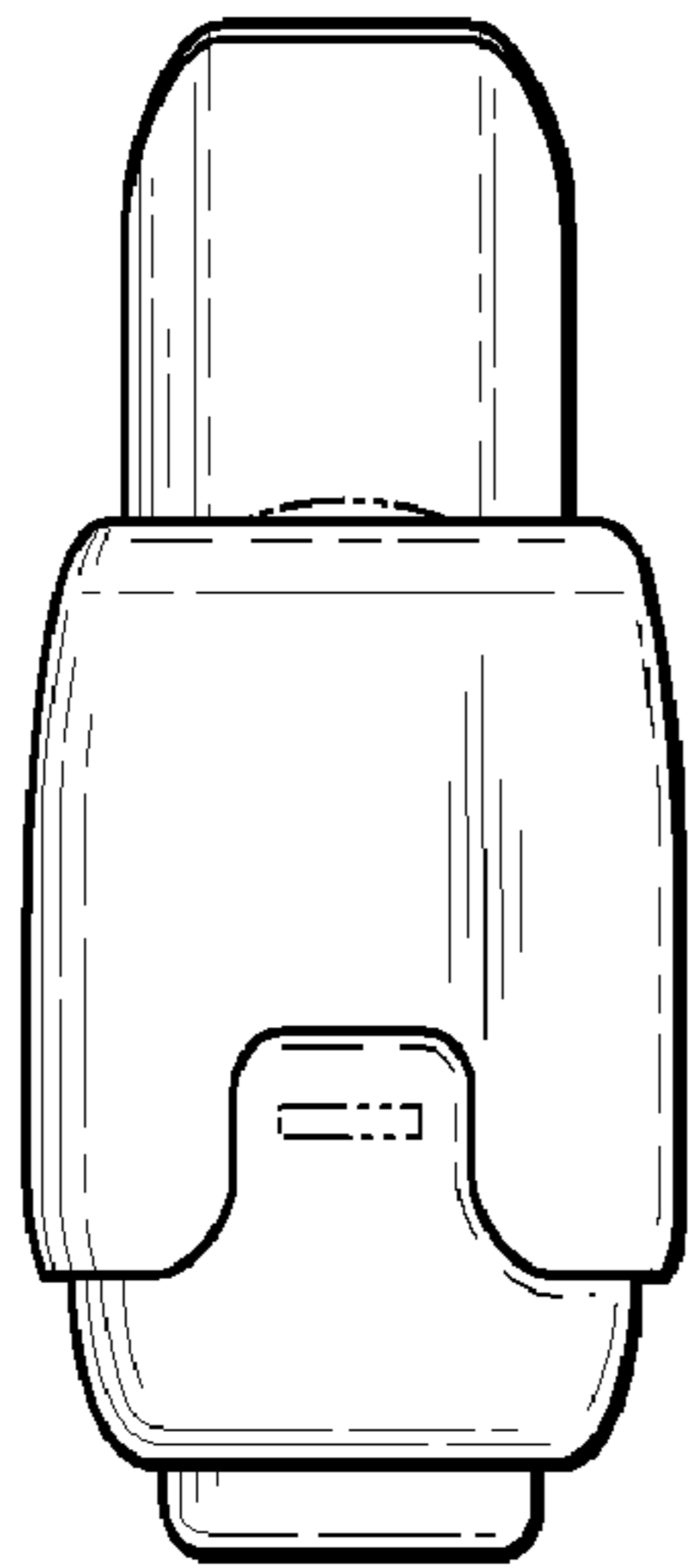

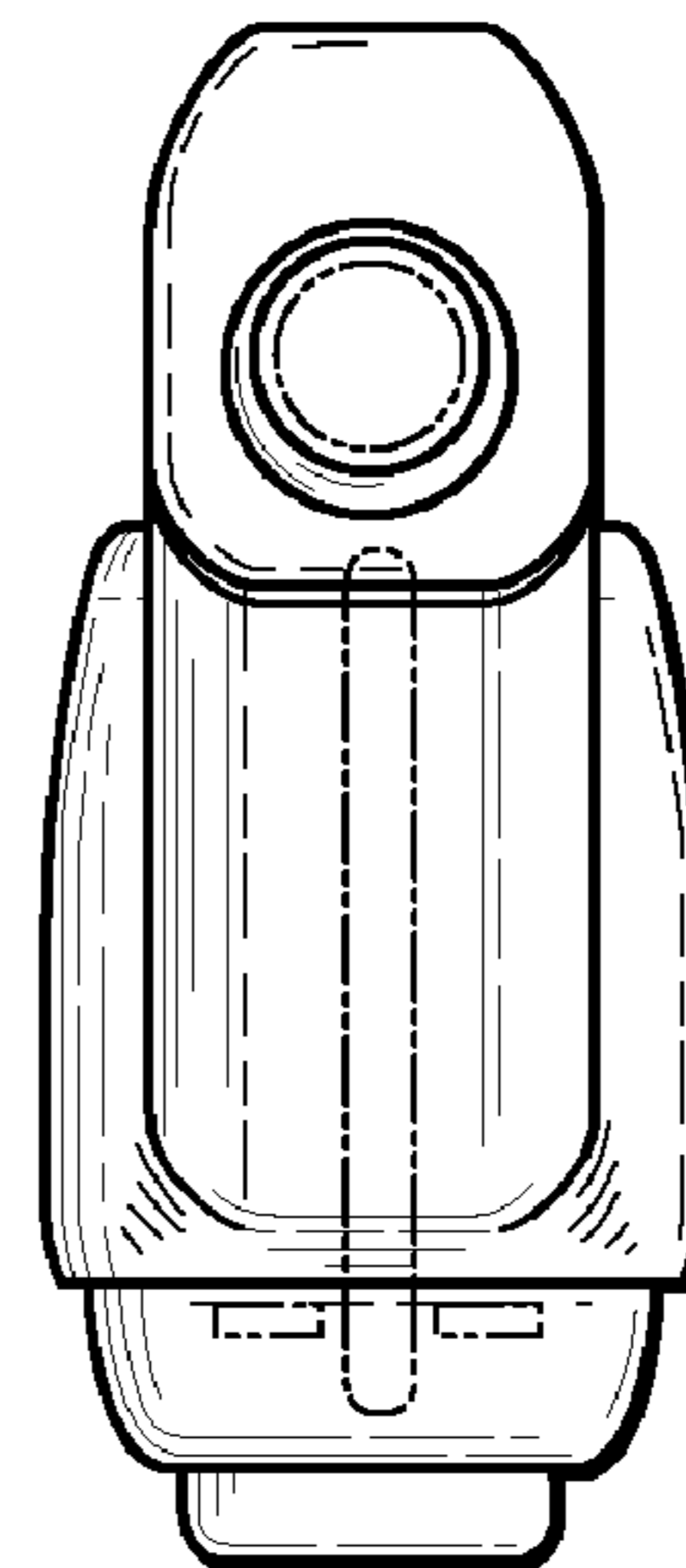
