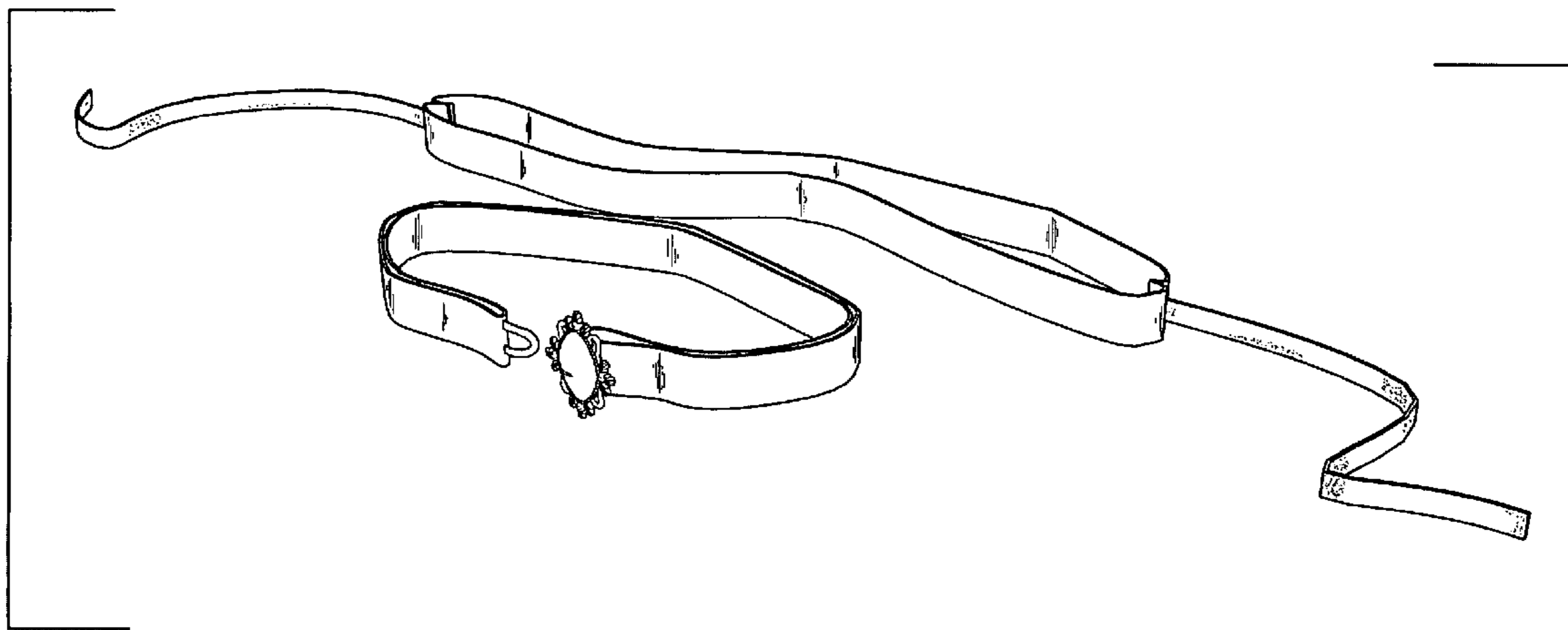
(57) **CLAIM**

The ornamental design for a set of hair styling bands, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a first portion and a second portion of a set of hair styling bands, as shown and described; FIG. 2 is a front view of said first portion of FIG. 1; FIG. 3 is a rear view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top view of said first portion of FIG. 1 with a bottom view being the mirror image thereof; FIG. 7 is a front view of said second portion of FIG. 1; FIG. 8 is a rear view thereof; FIG. 9 is a left side view thereof; FIG. 10 is a right side view thereof; FIG. 11 is a top view of said second portion of FIG. 1 with a bottom view being the mirror image thereof; and, FIG. 12 is a close-up view of a jeweled clasp of said second portion of FIG. 1.

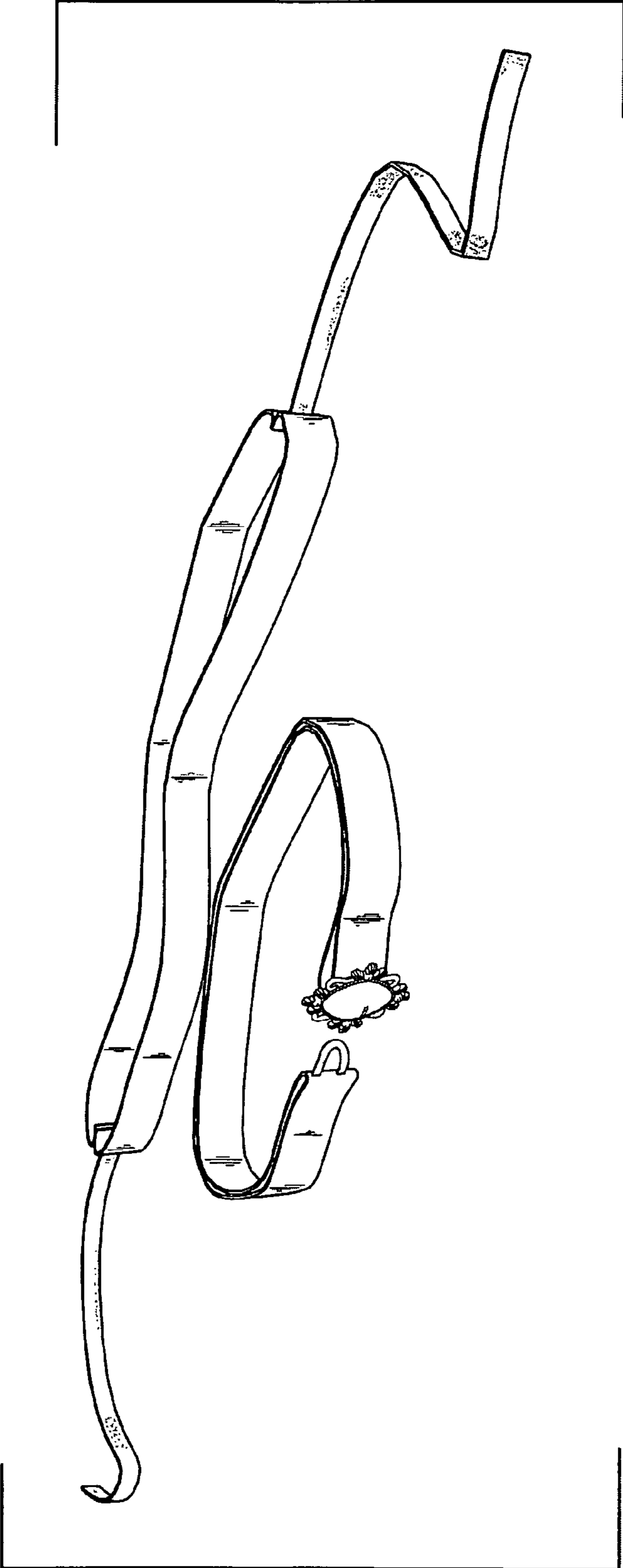

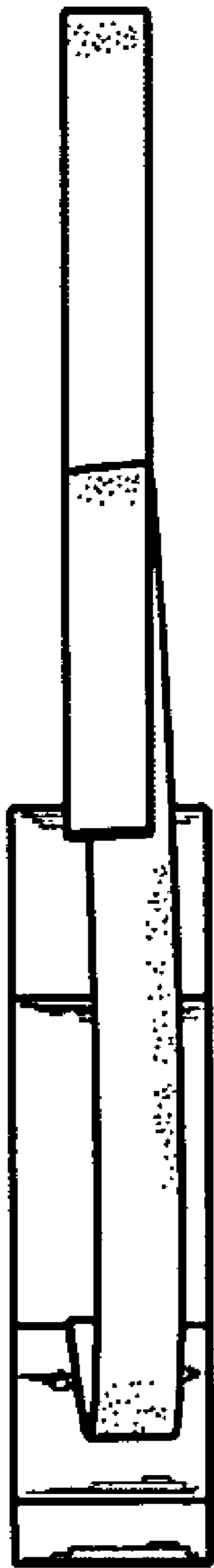

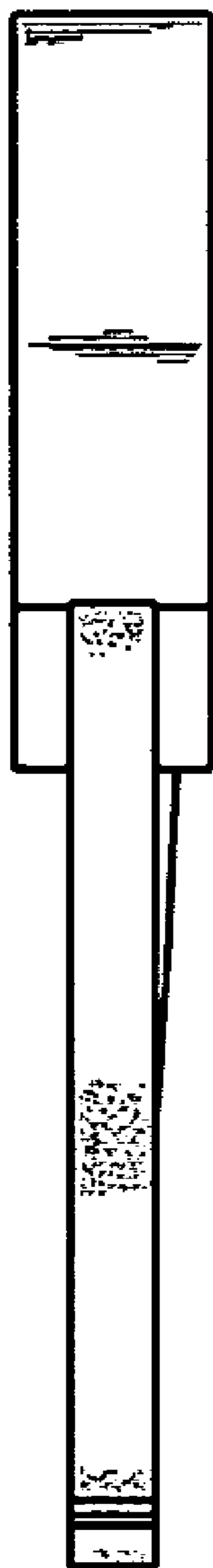

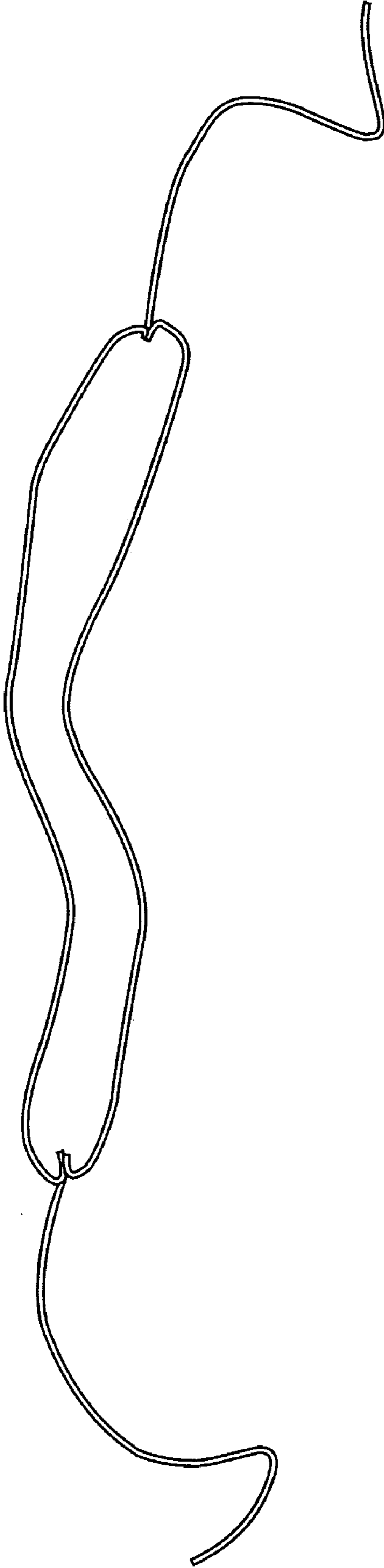

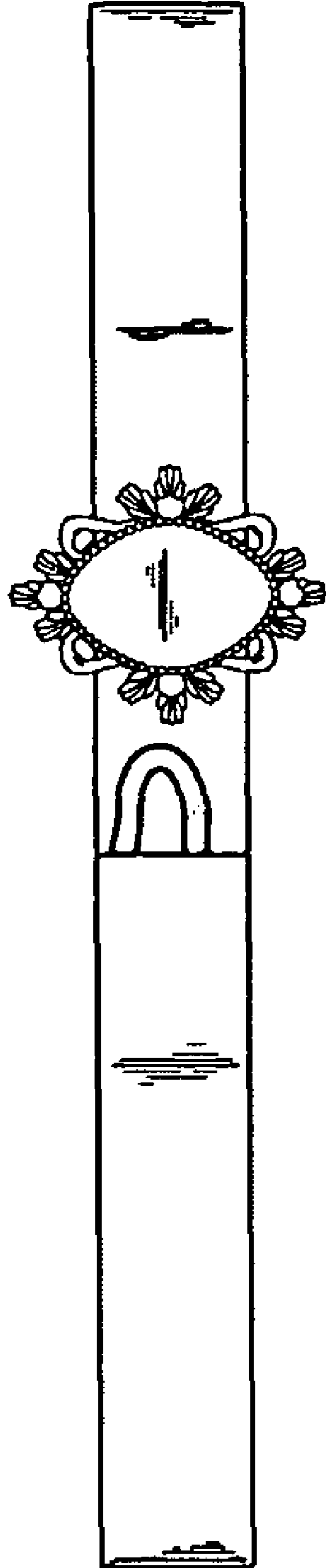

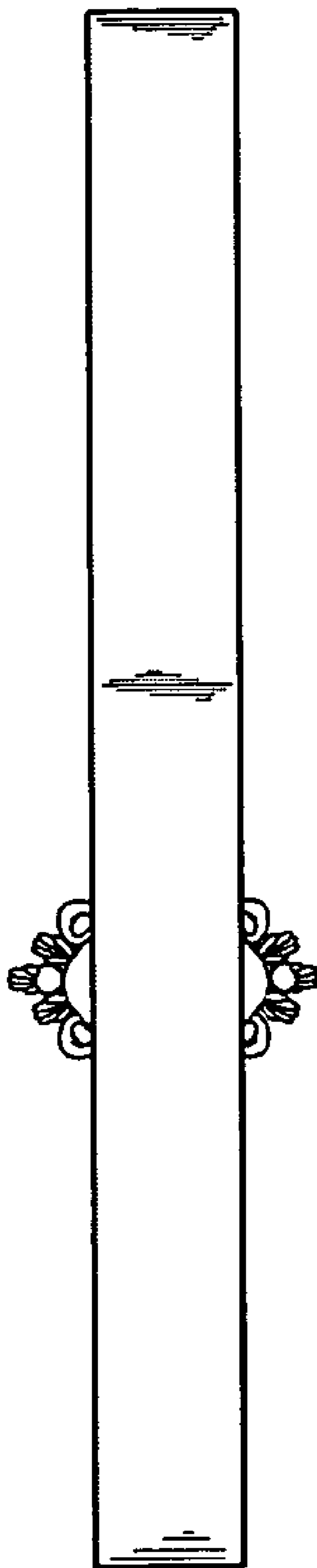

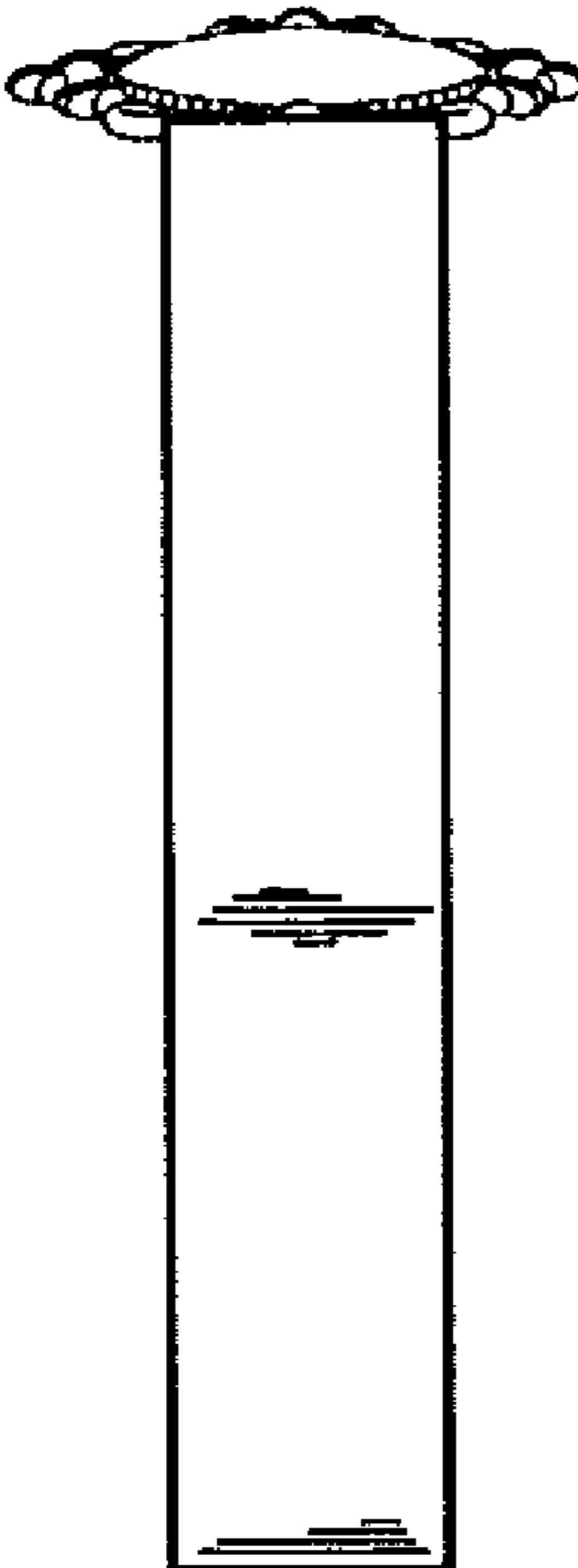

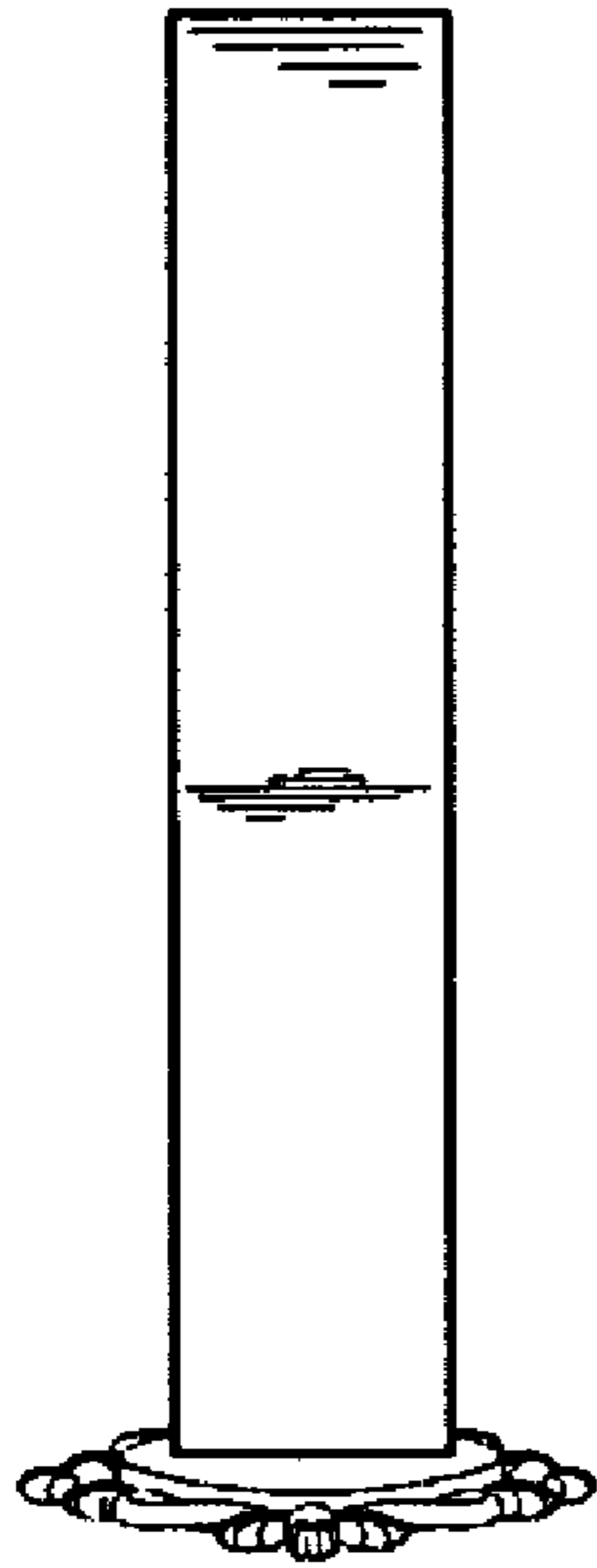

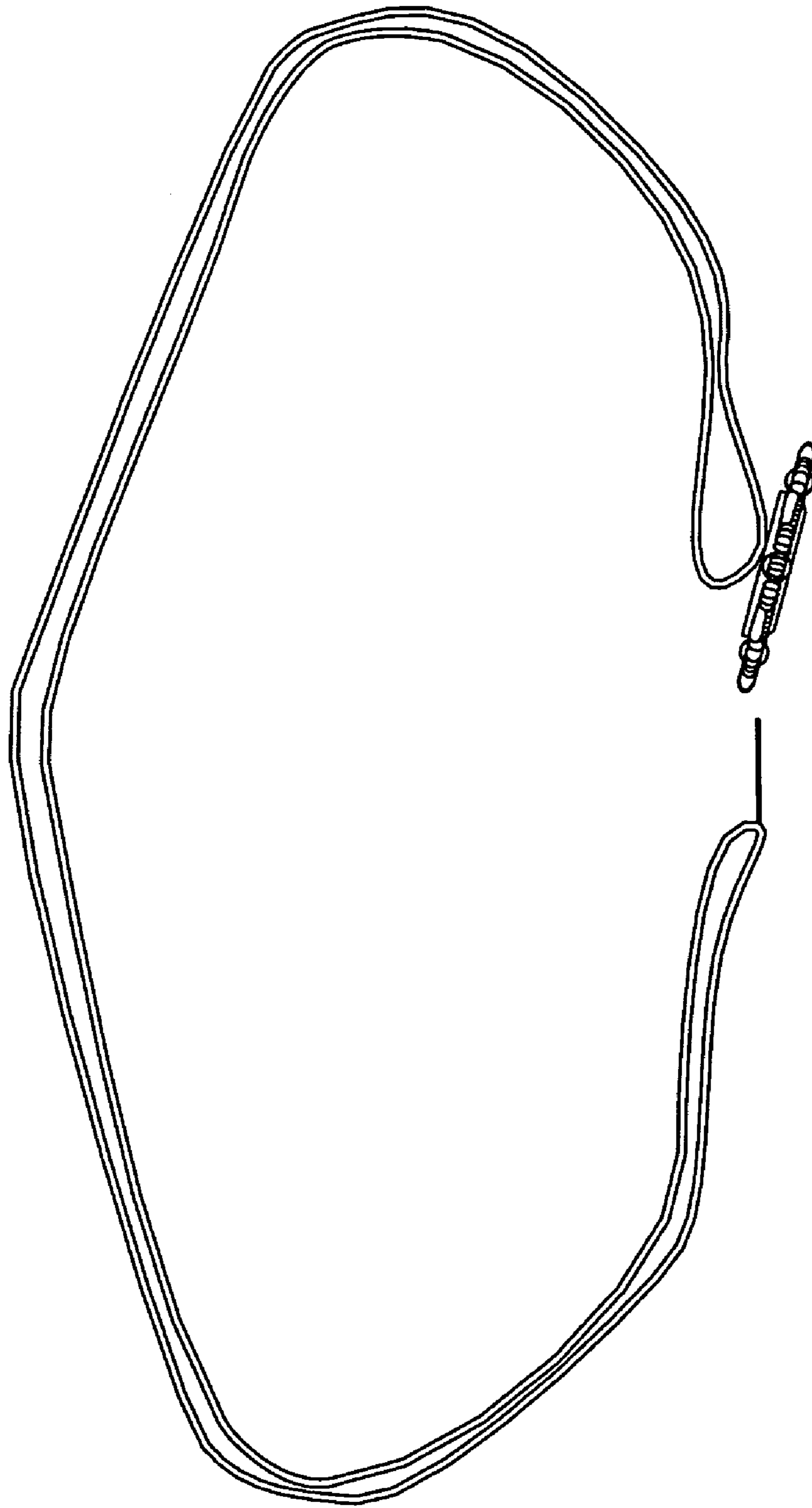

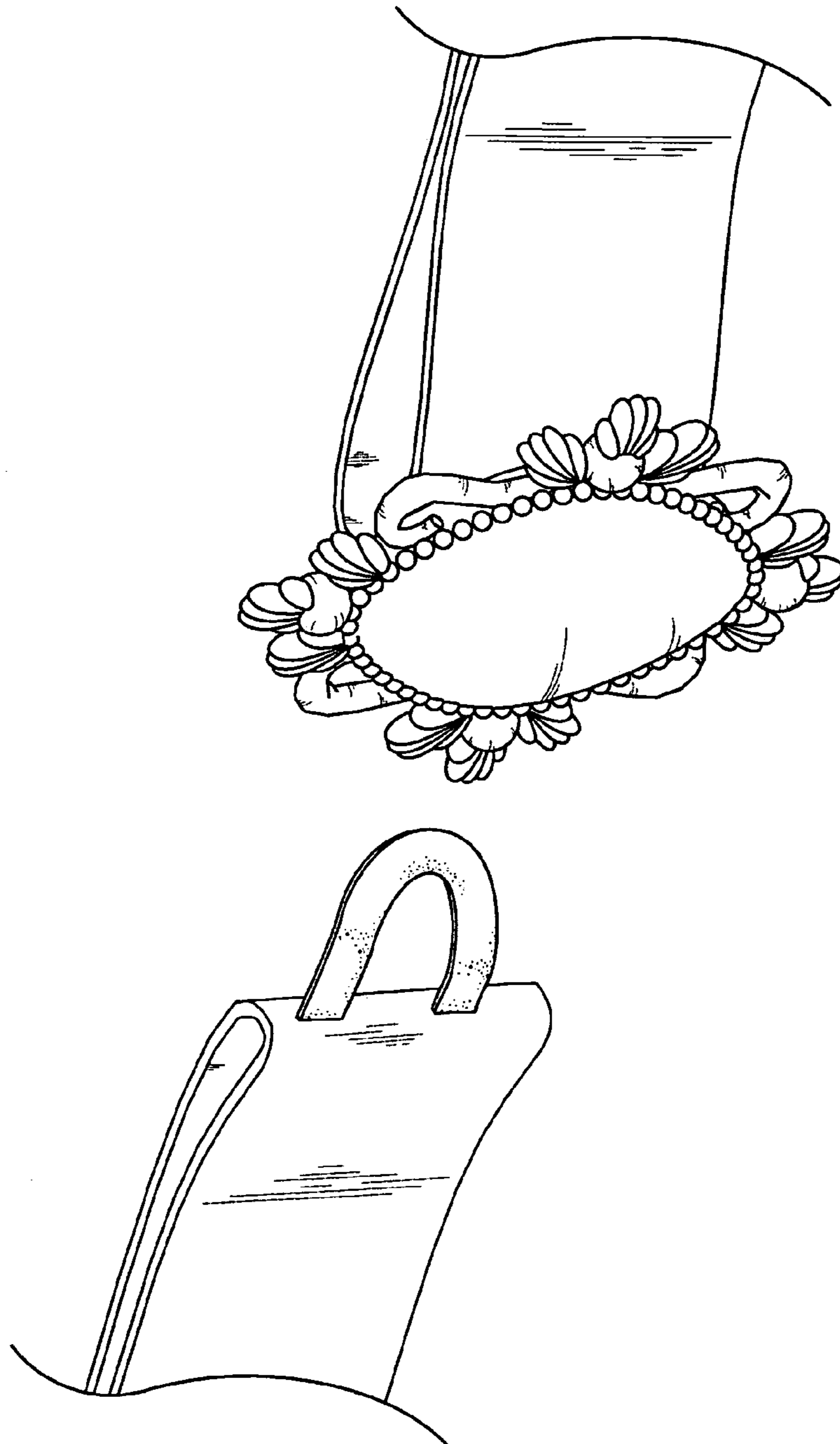
