(57) **CLAIM**

An ornamental design for a dust mask, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a dust mask showing our new design, the person shown in broken lines forms no part of the claimed design;

FIG. 2 is a front perspective view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a right side elevation view thereof;

FIG. 5 is a left side elevation view thereof;

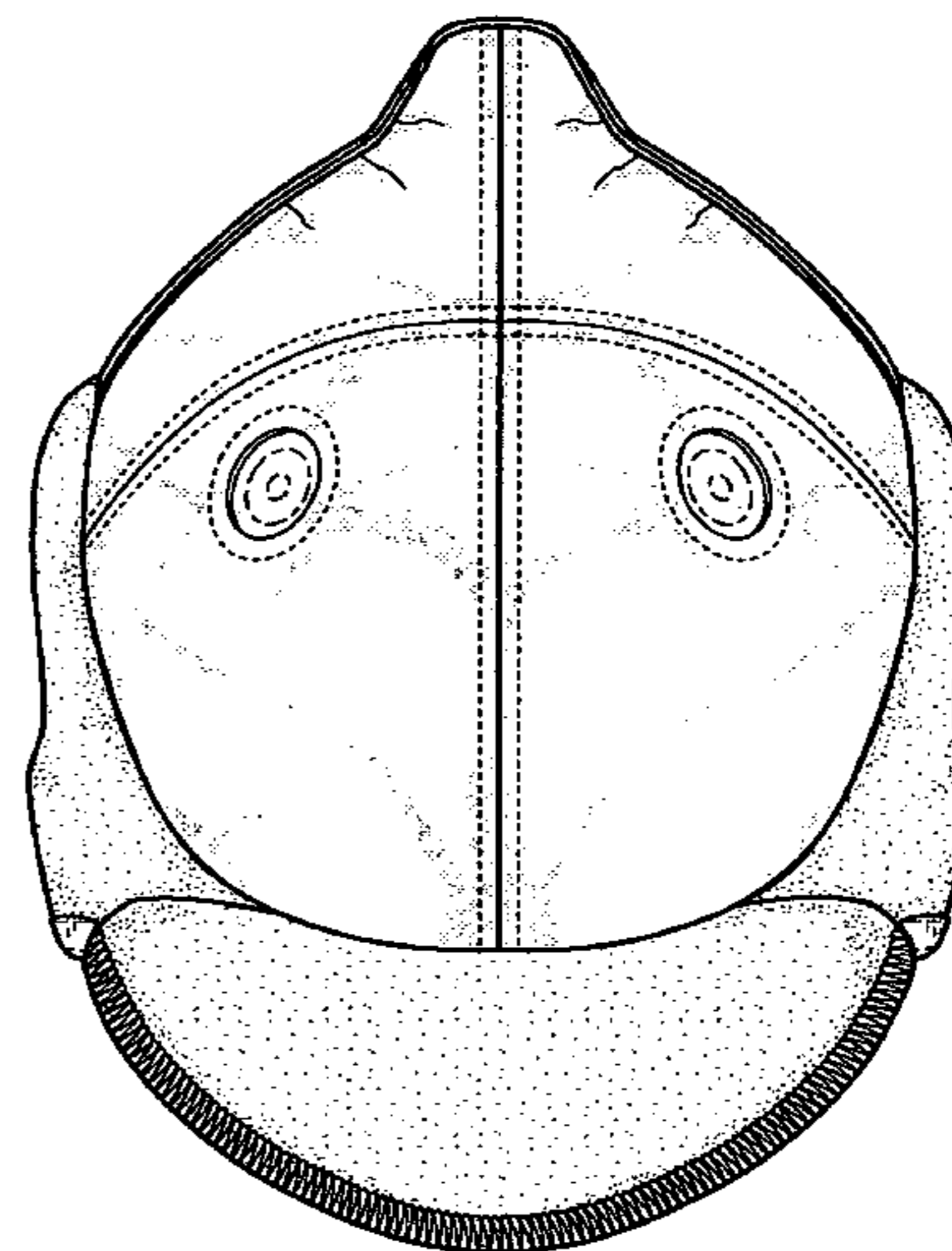
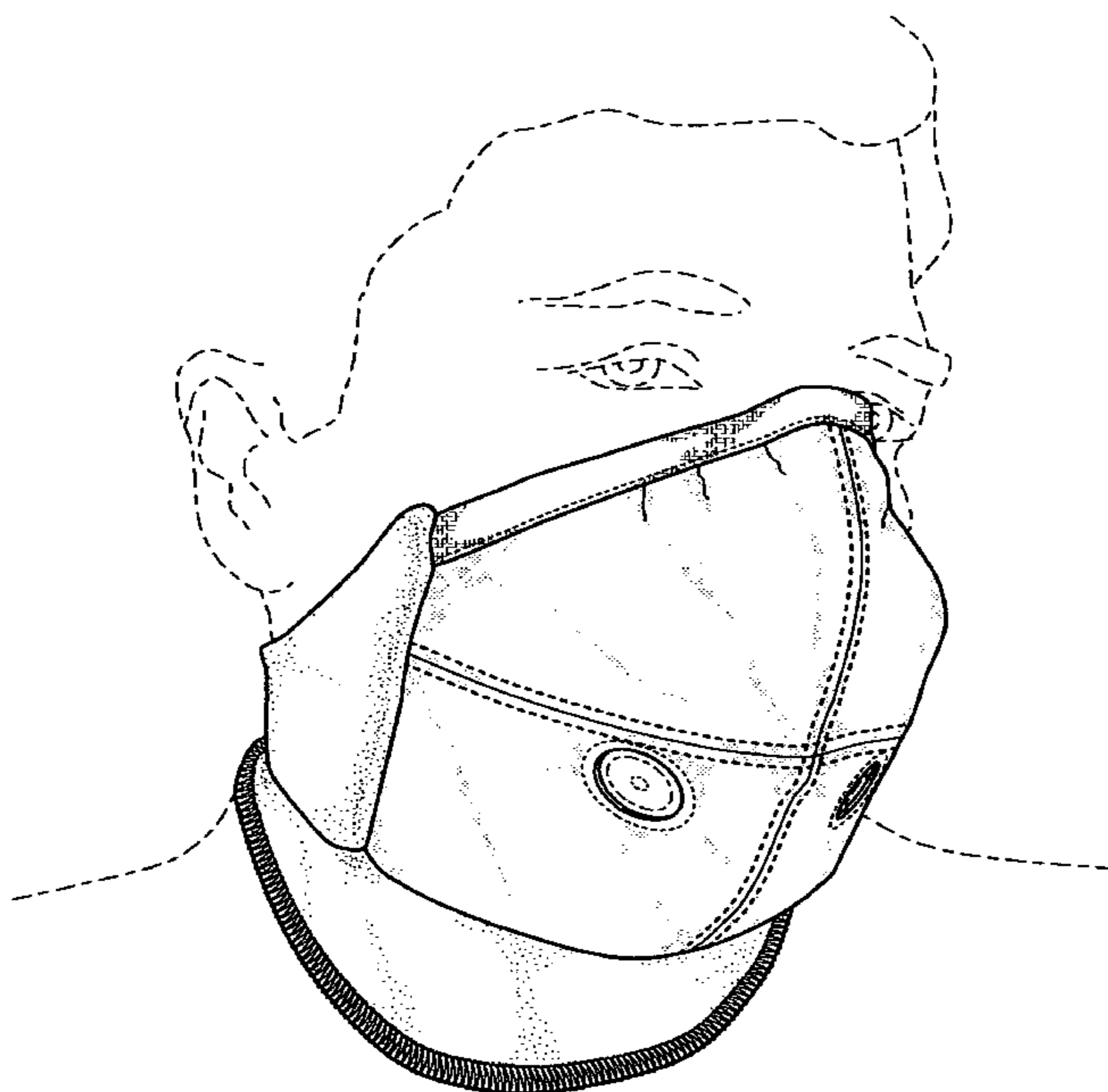
FIG. 6 is a rear elevation view thereof;

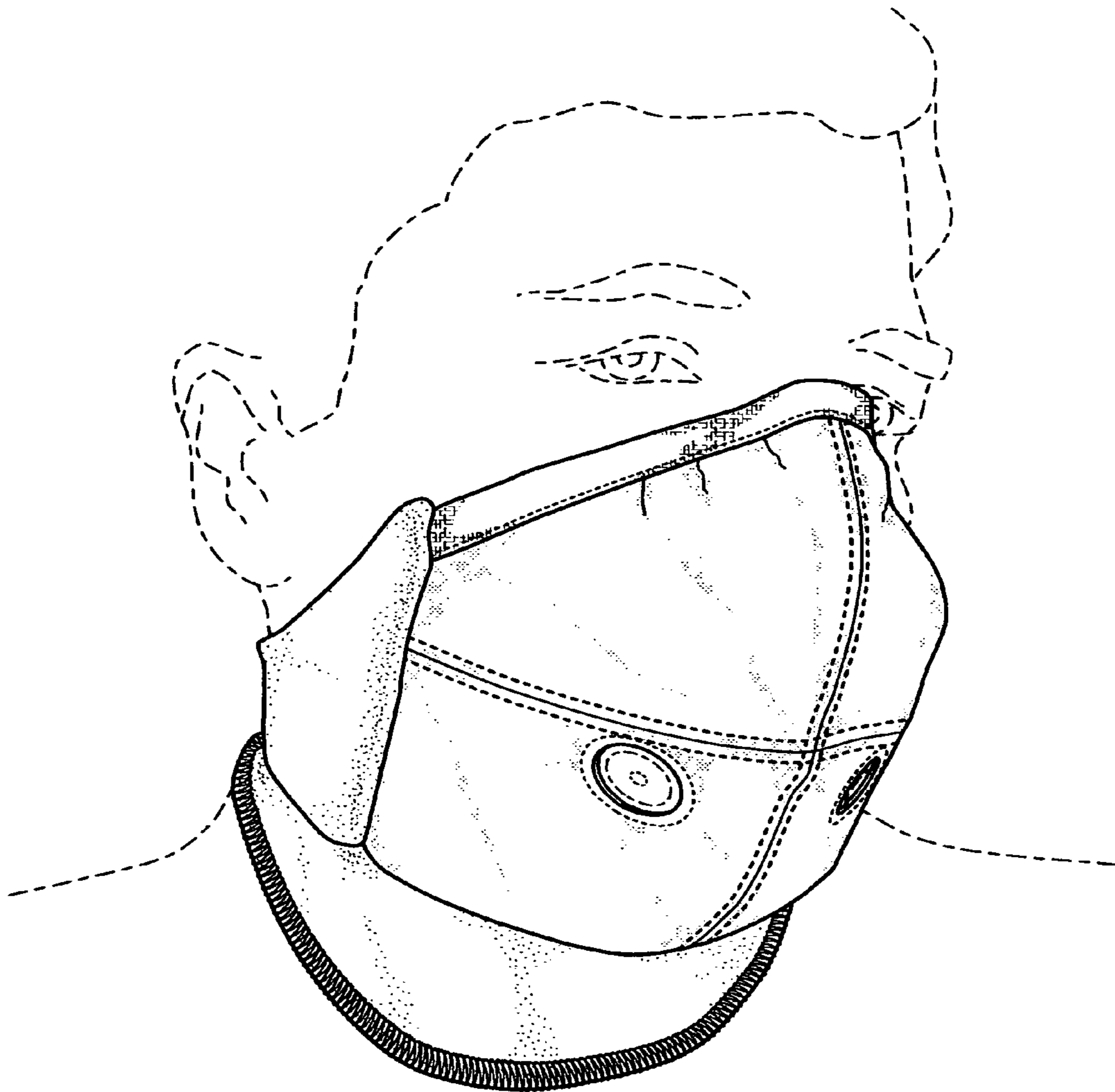

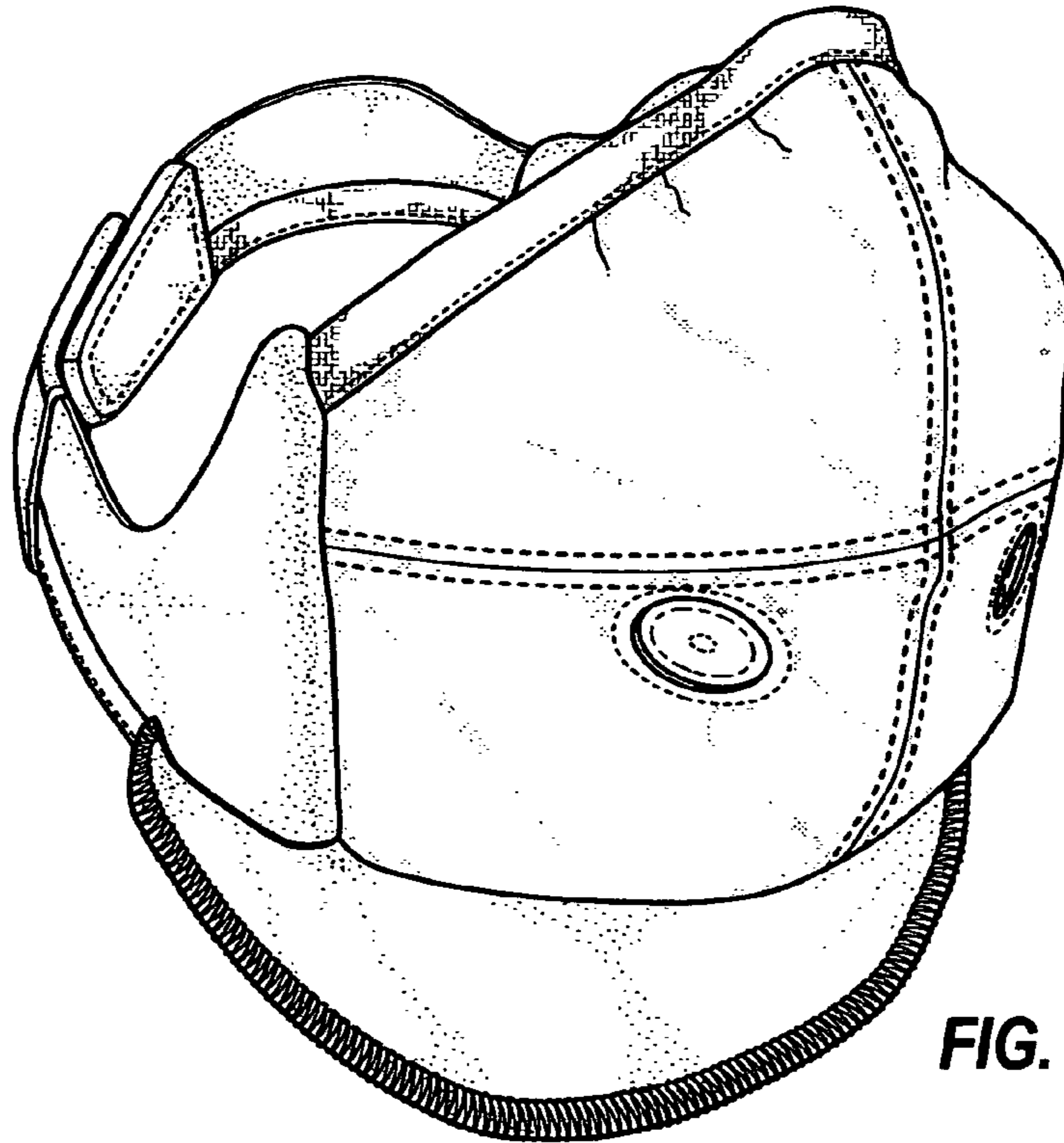

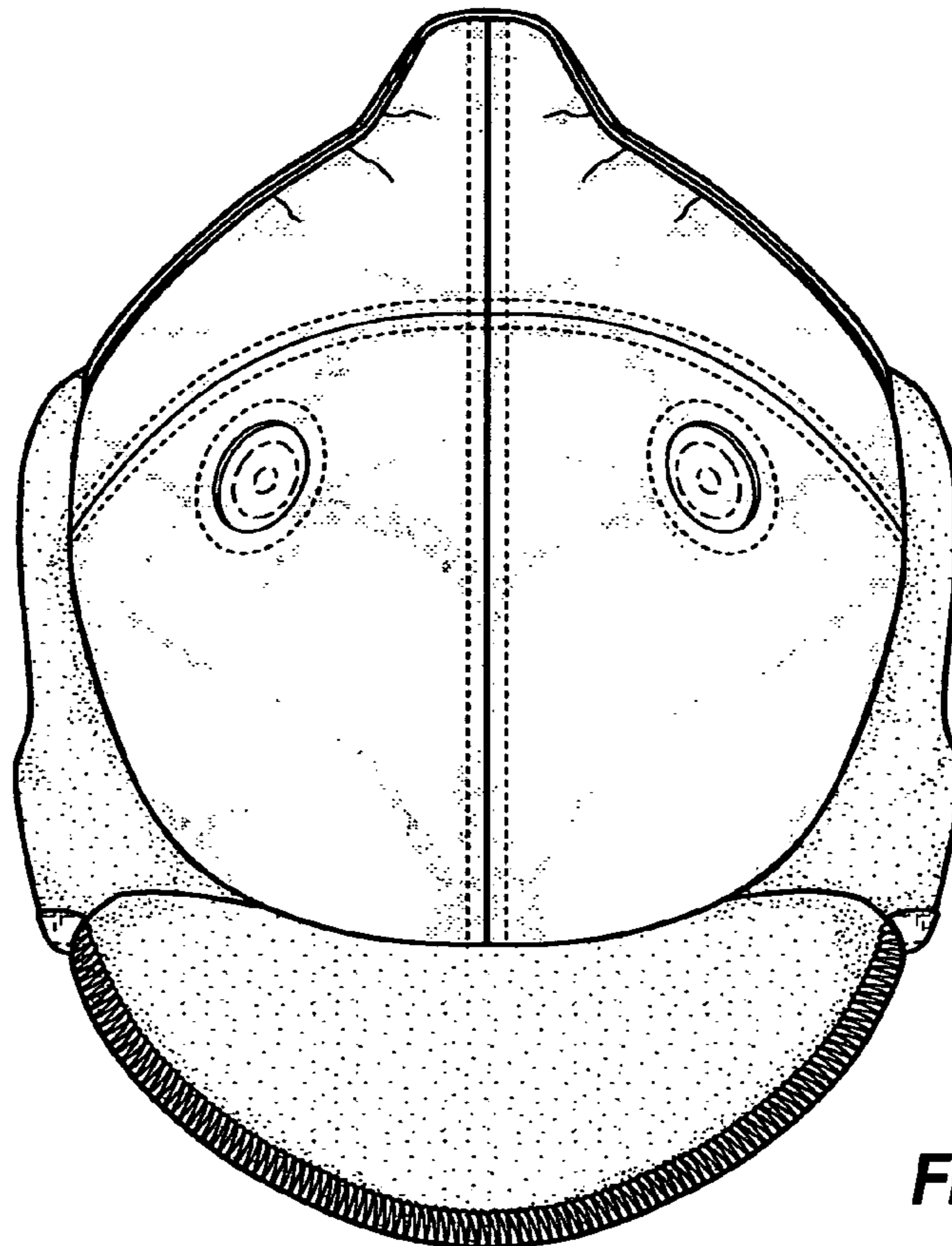

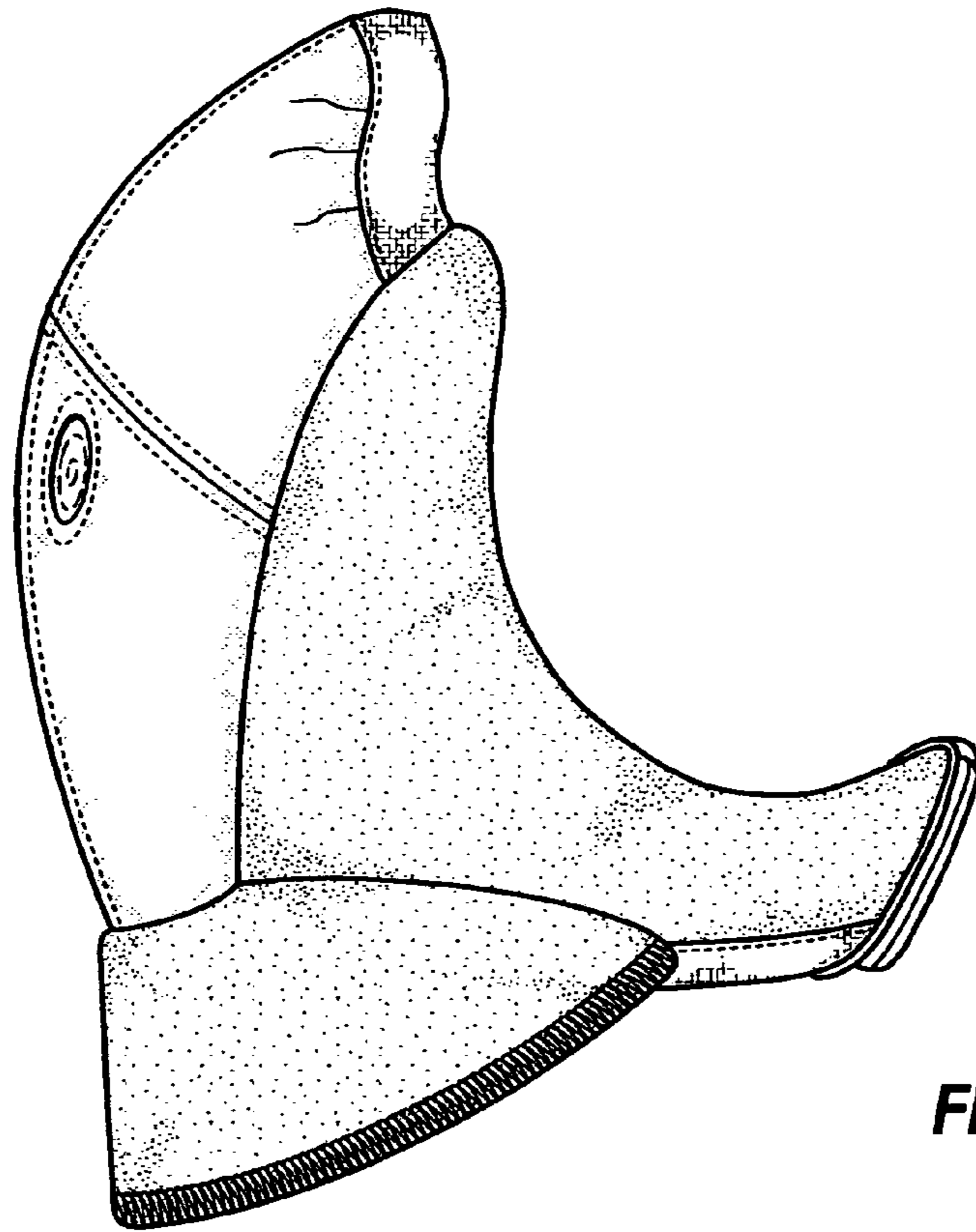

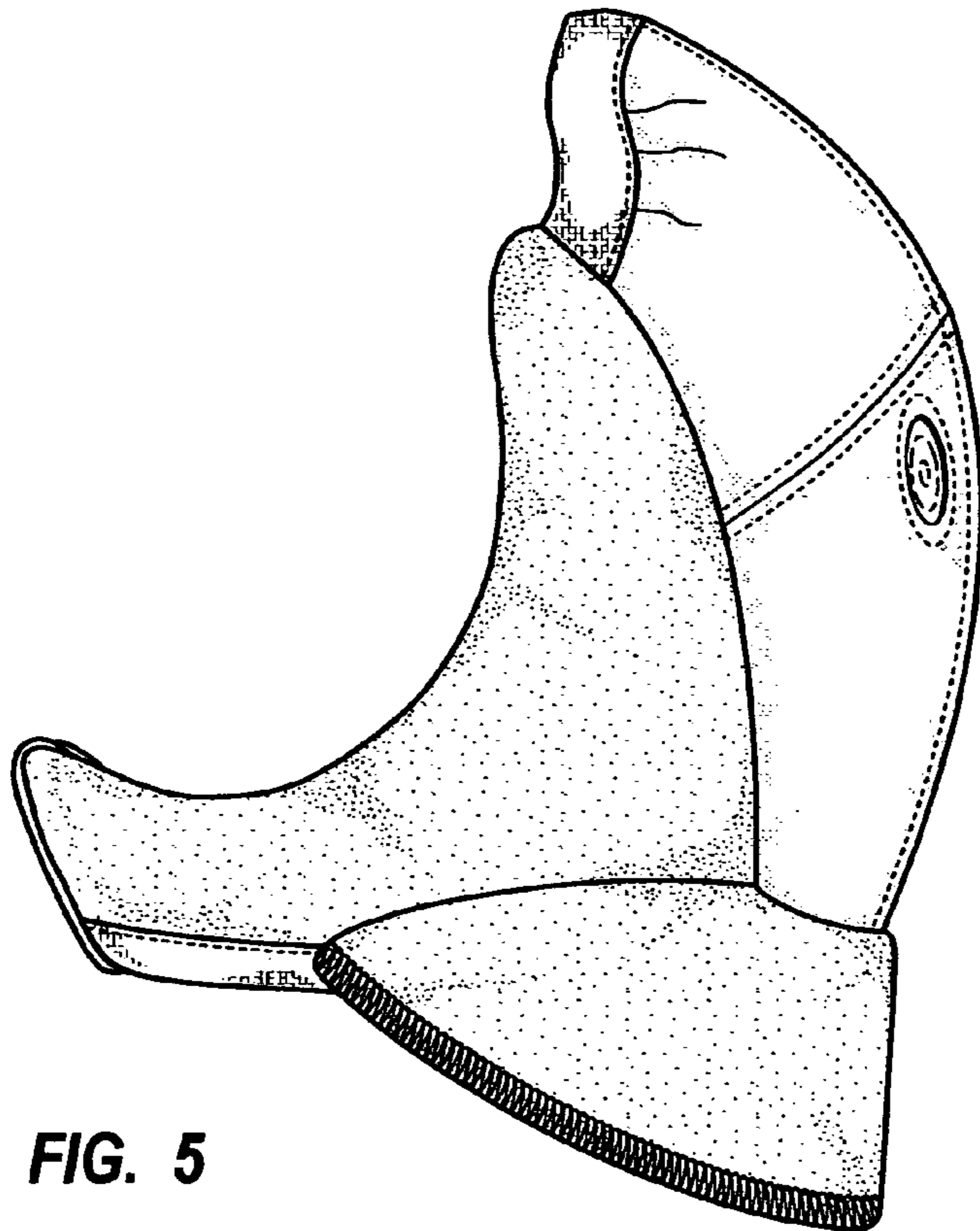

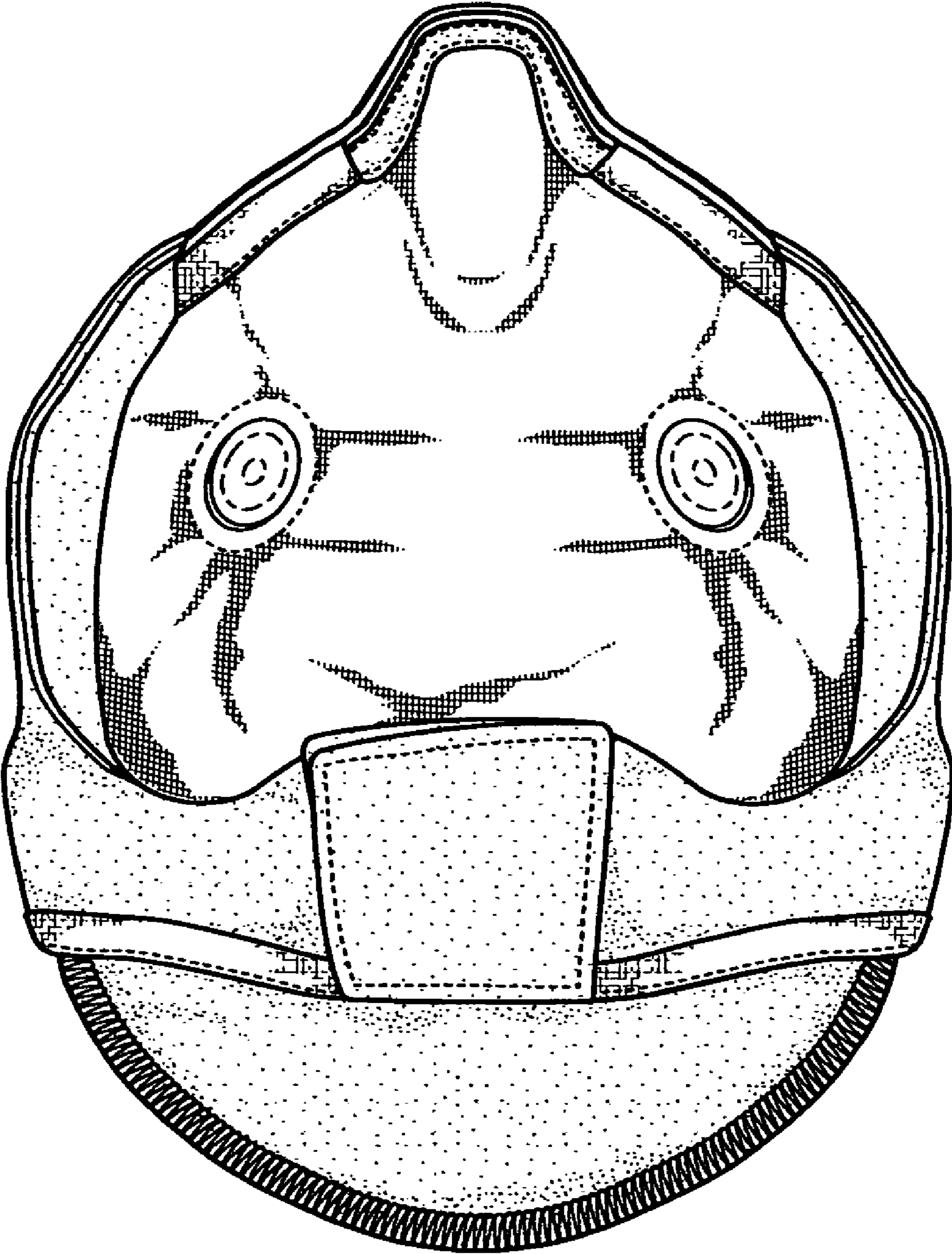

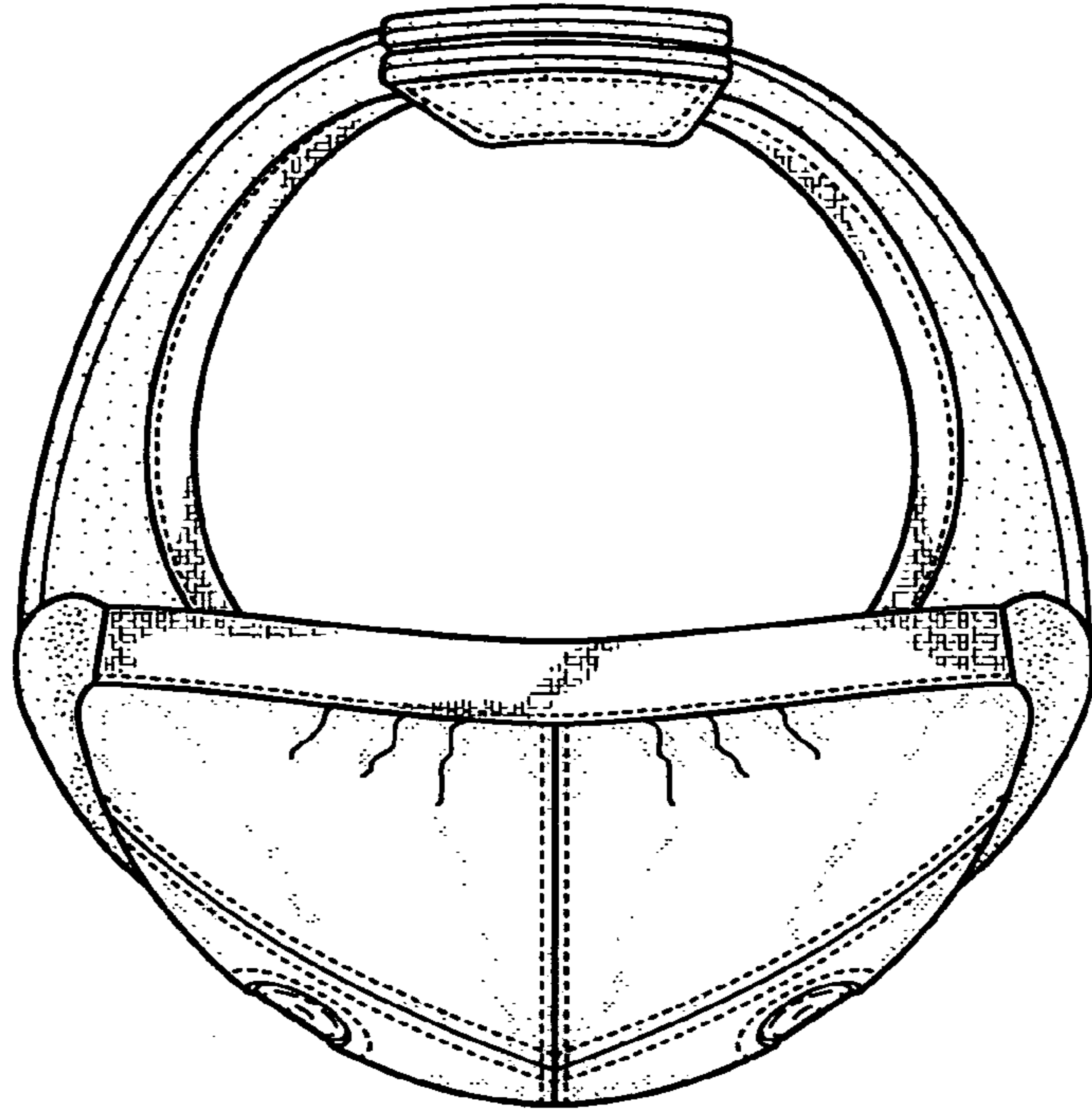

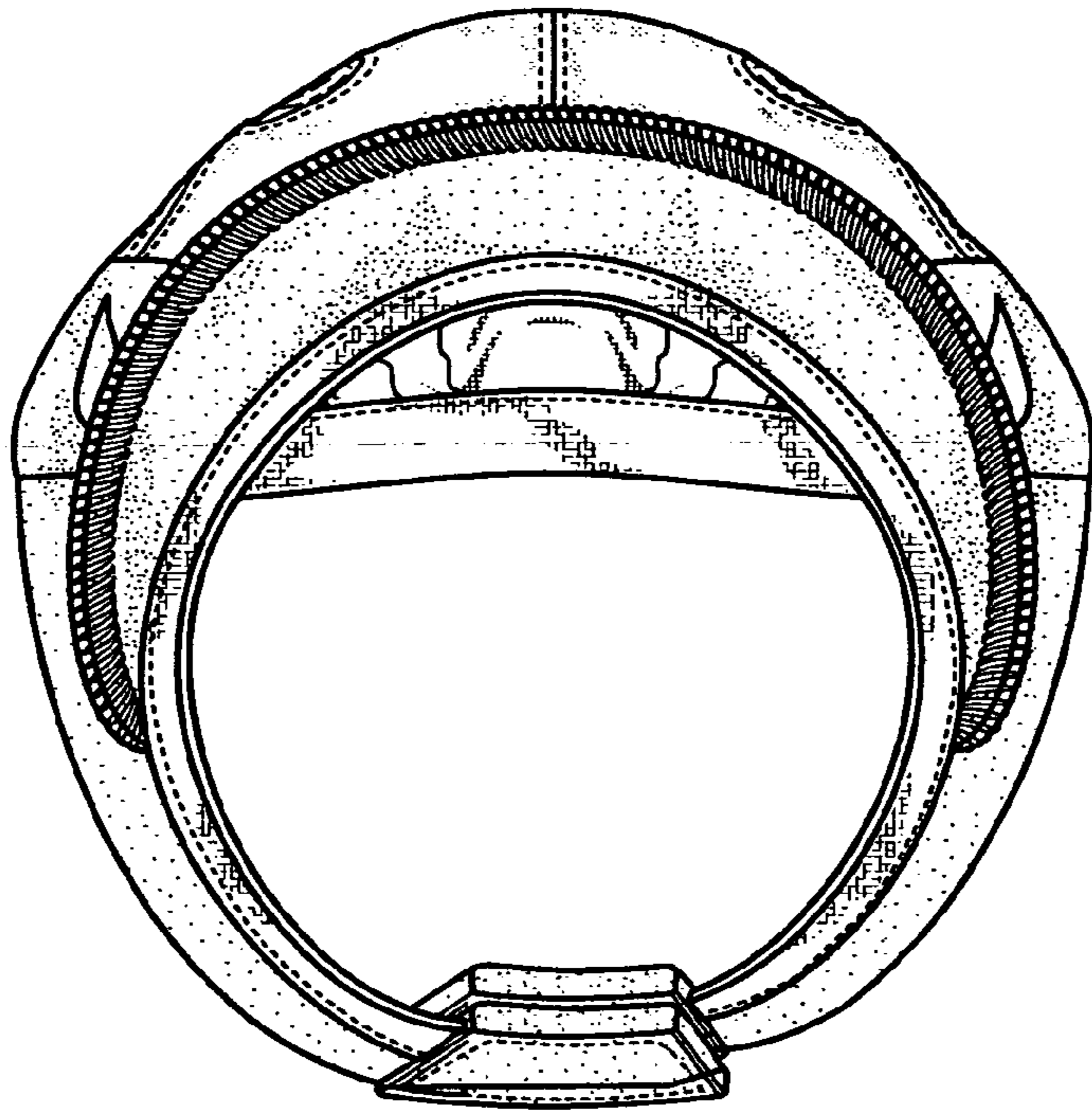
