(57) **CLAIM**

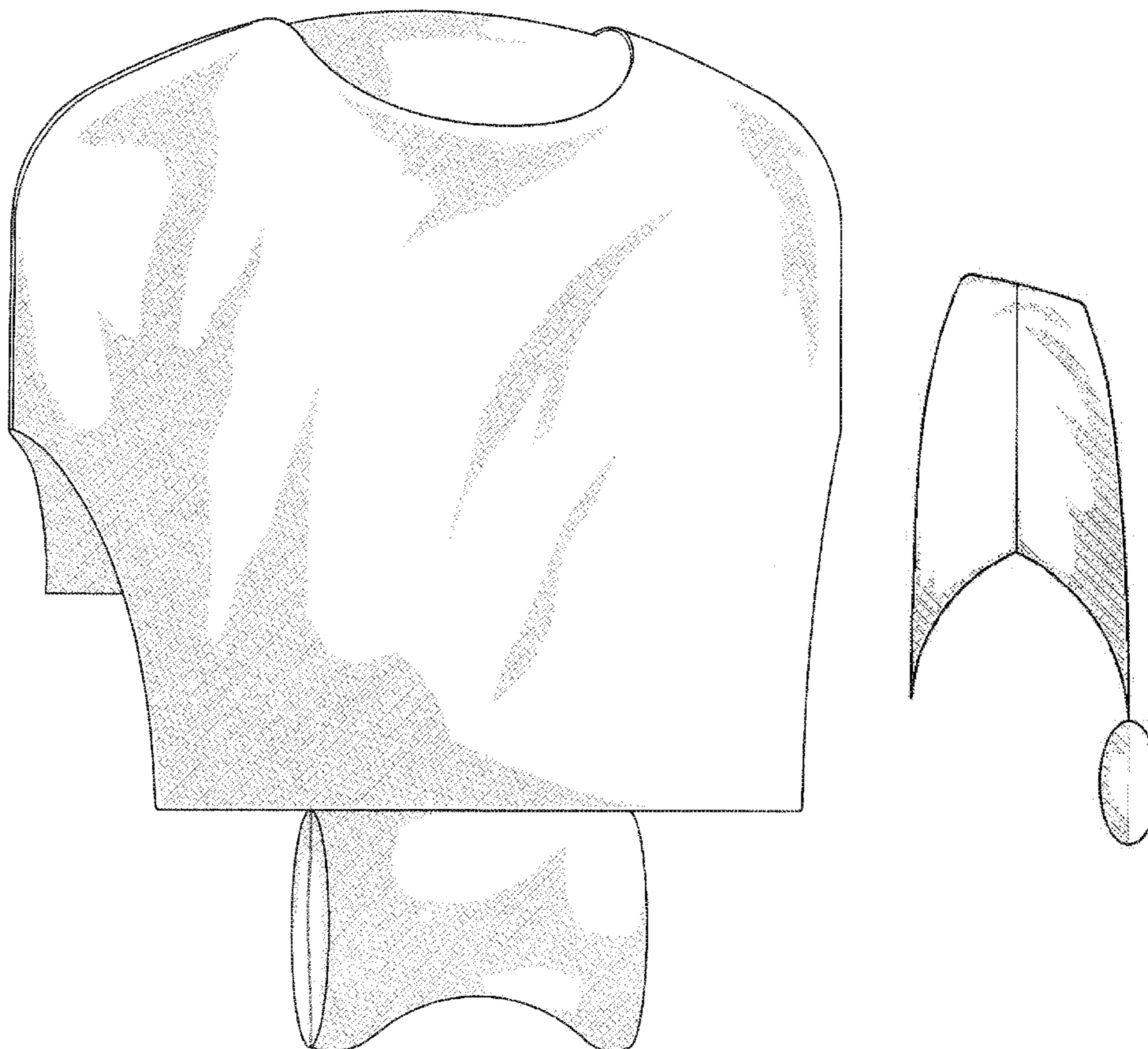
The ornamental design for a combined nursing pillow and shroud, as shown and described.

DESCRIPTION

FIG. 1 is a front, right-side perspective view of a combined nursing pillow and shroud, showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a left-side elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a front right-side perspective view thereof, showing the design in use.

The broken lines showing portions of the human form in FIG. 8, show the design in use and form no part of the claim.

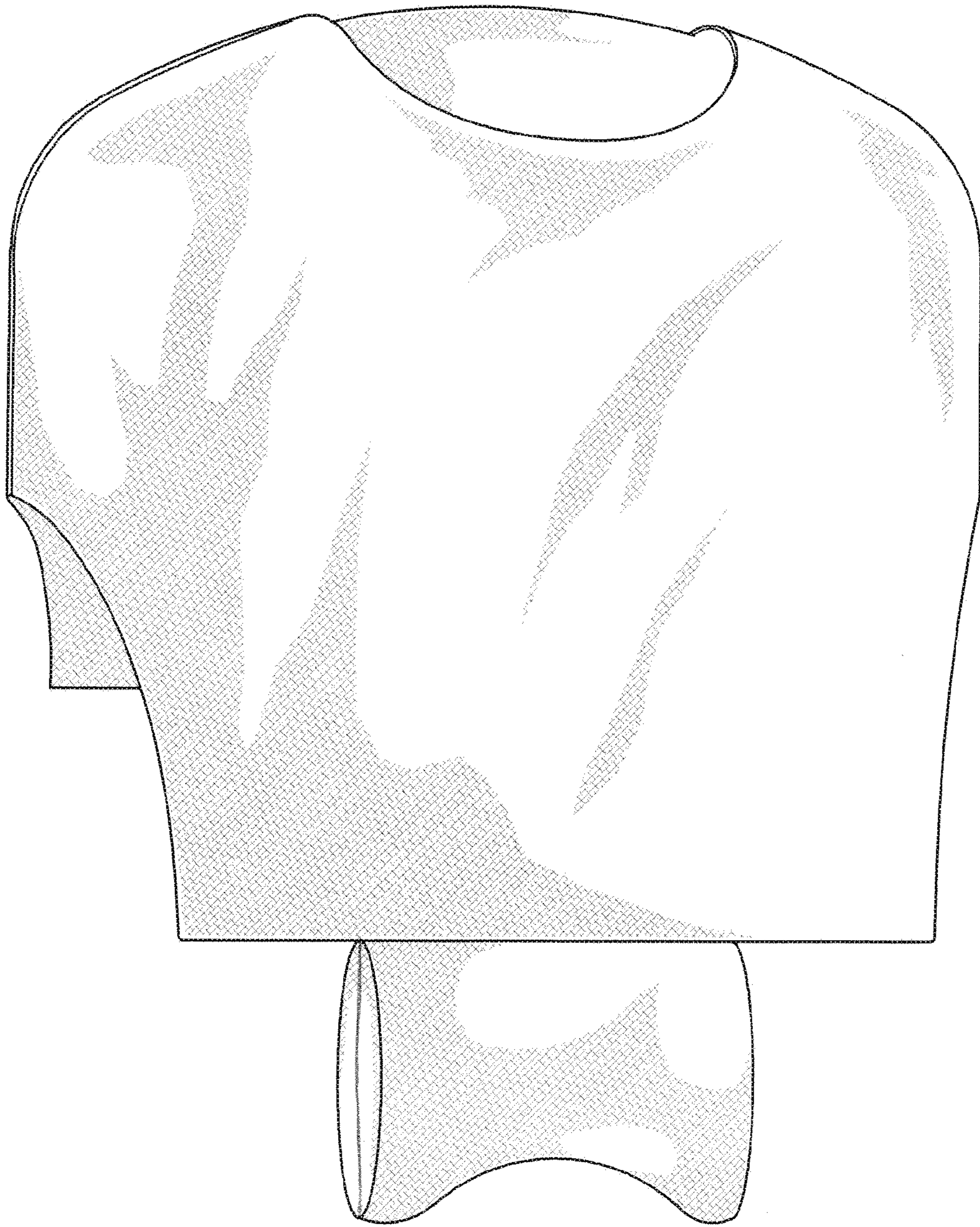

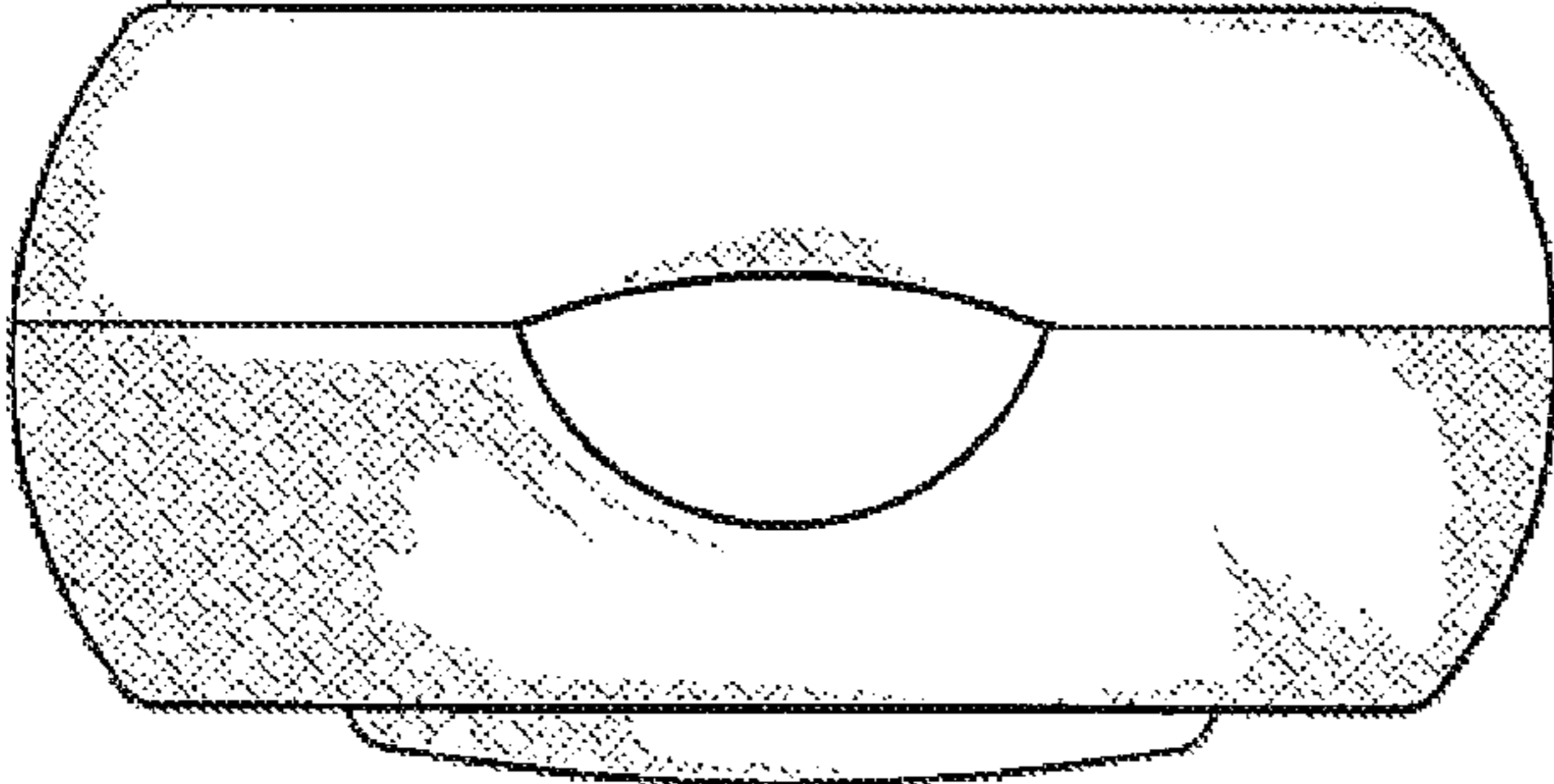

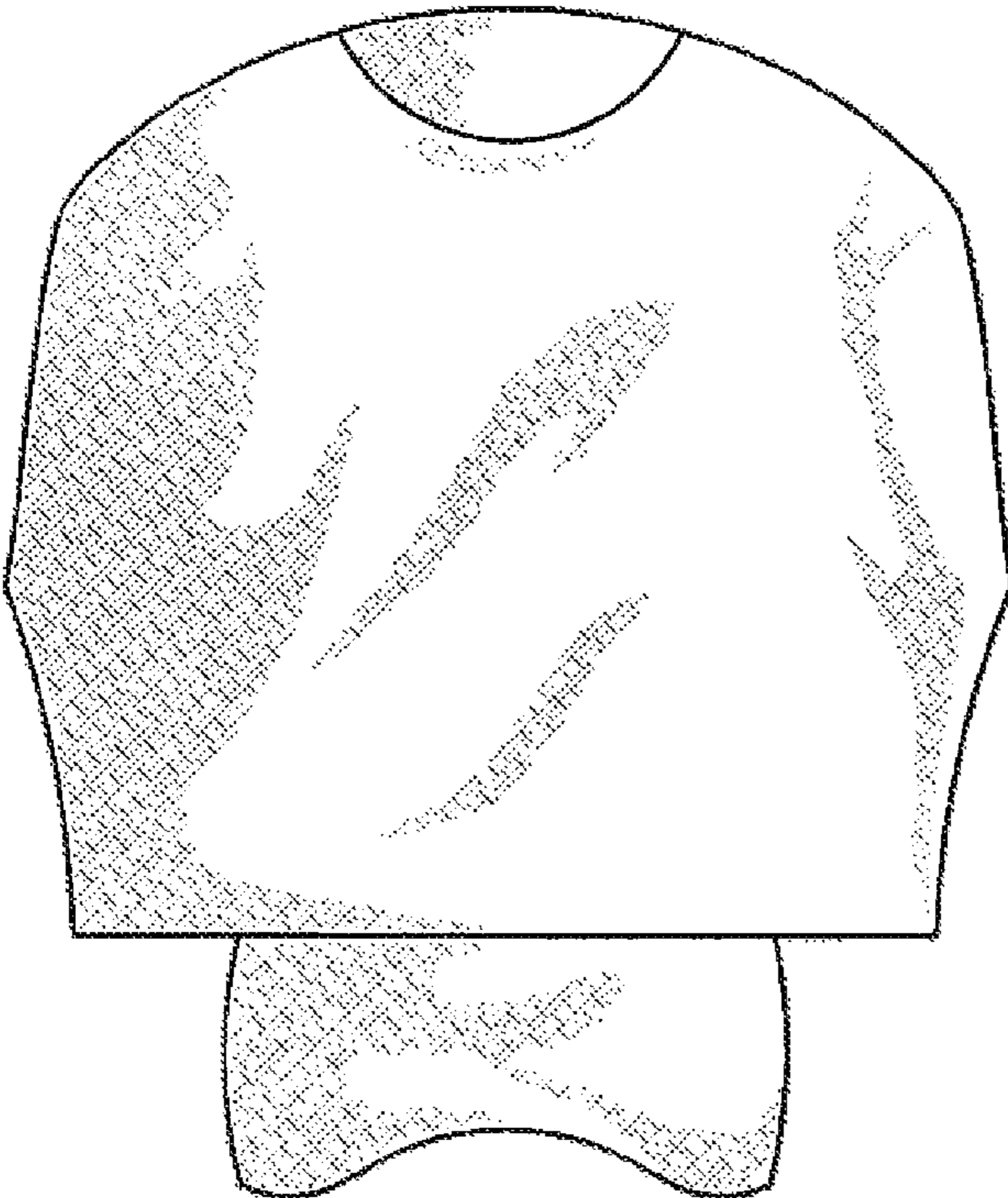

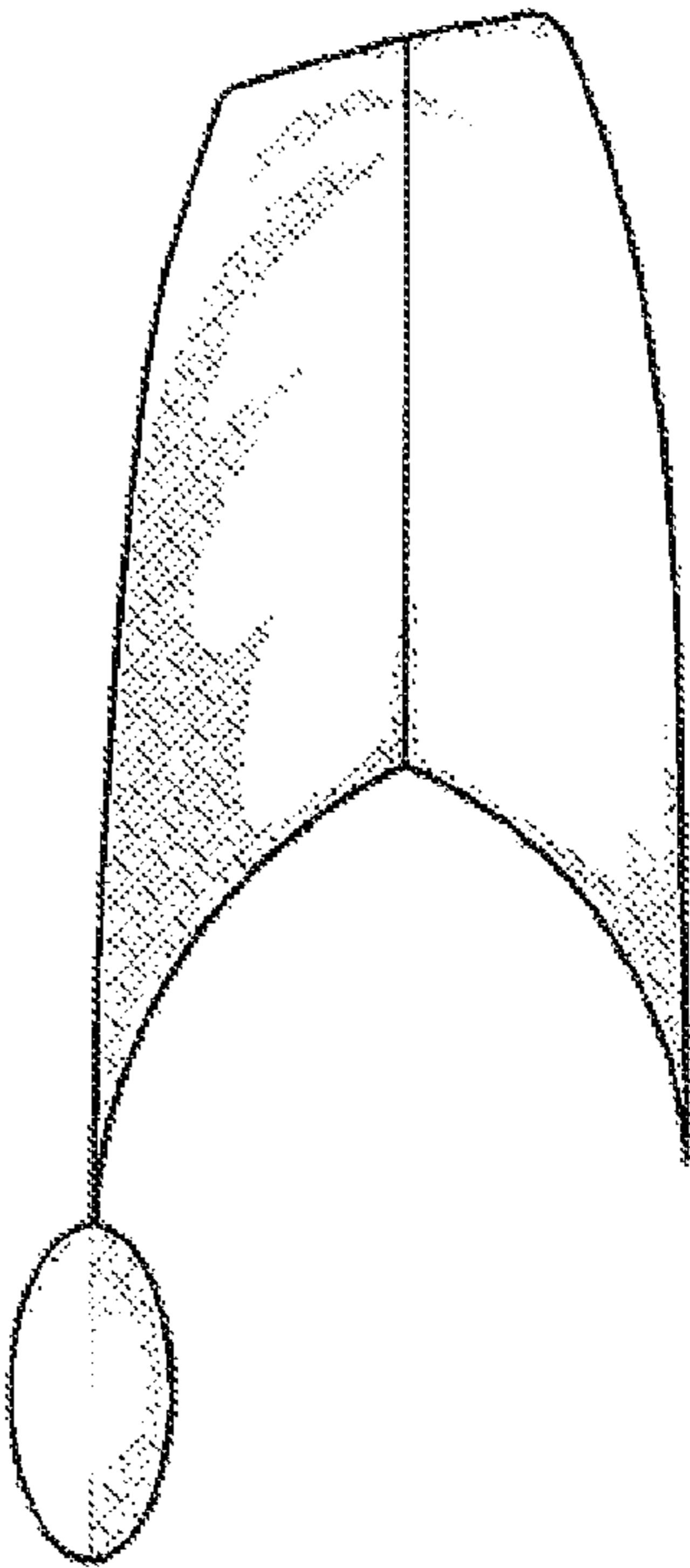

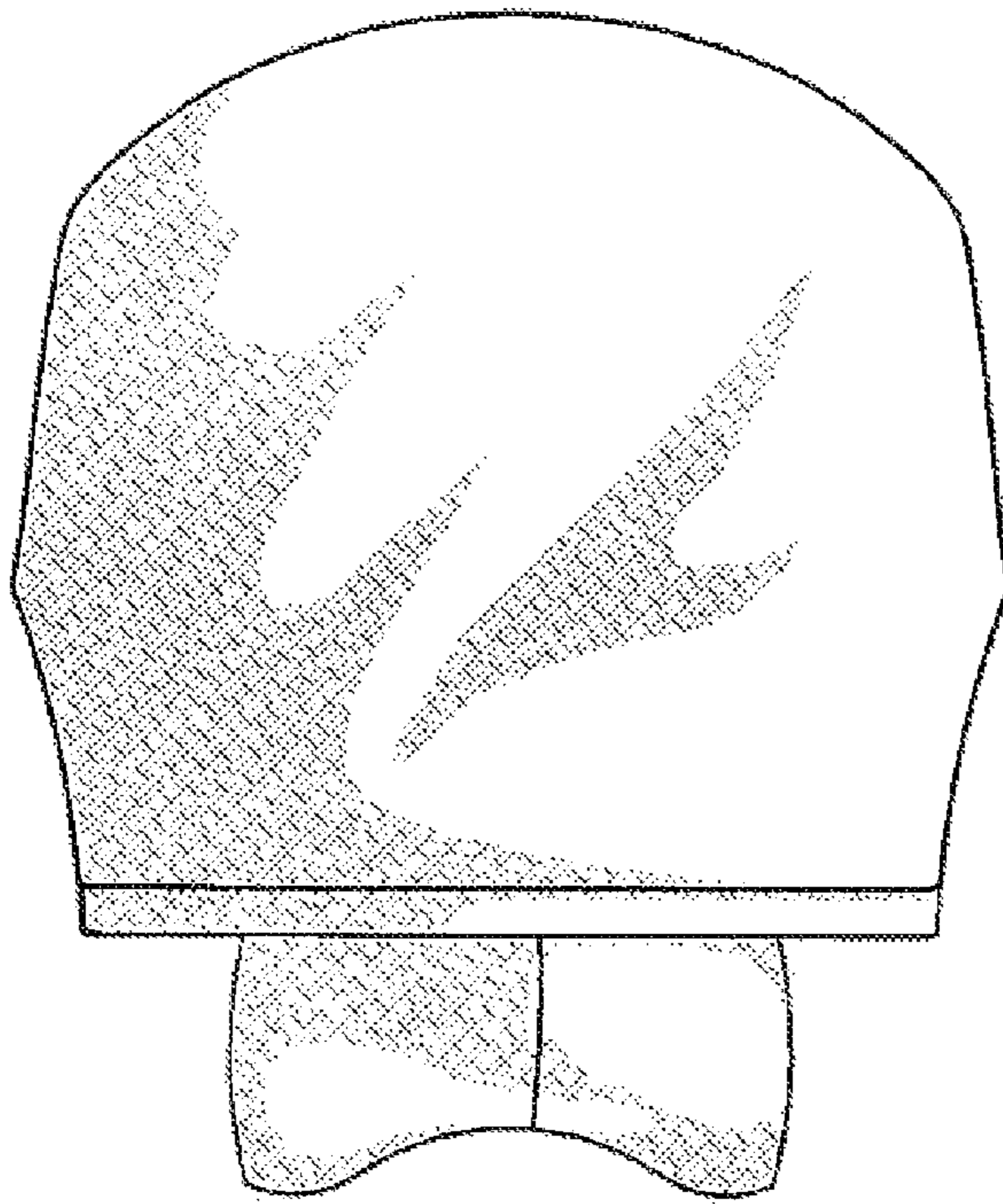

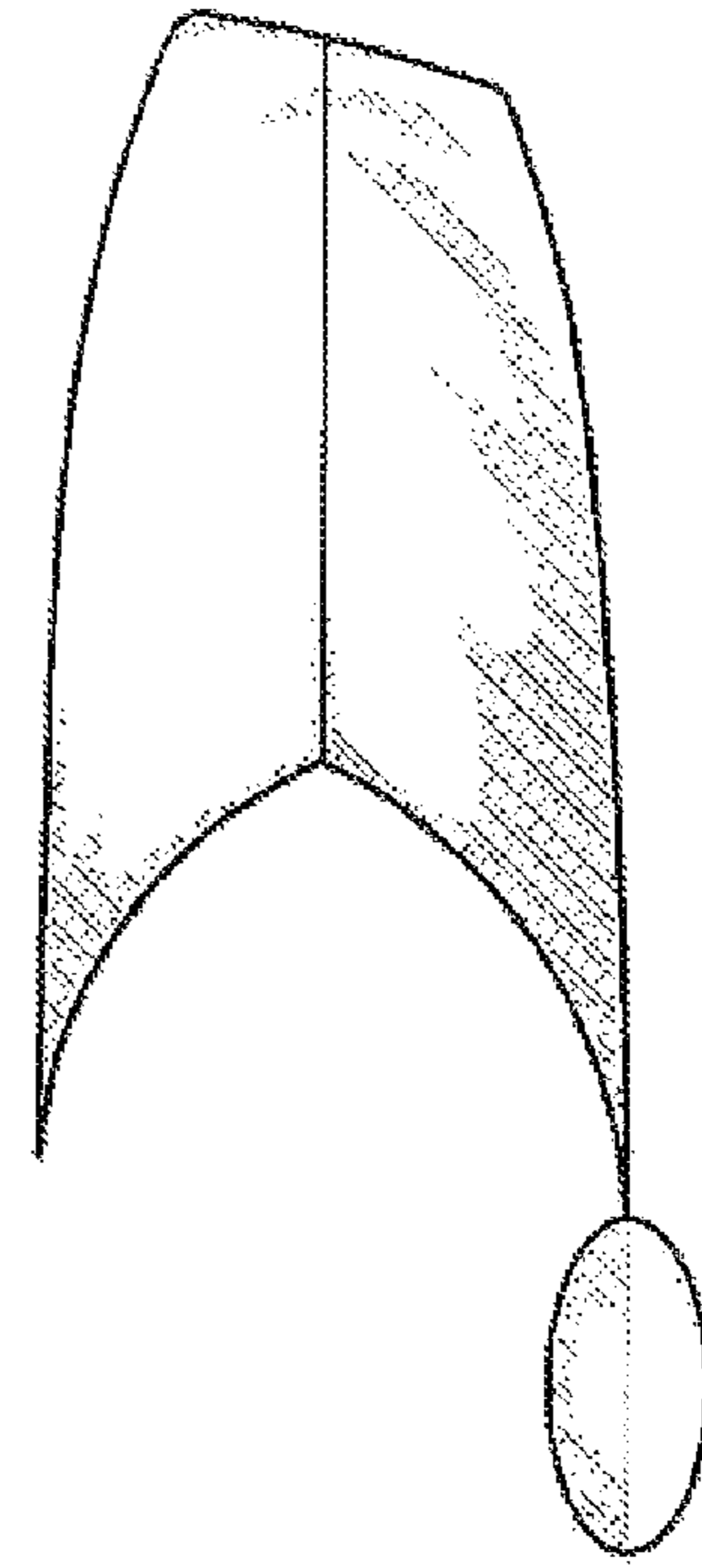

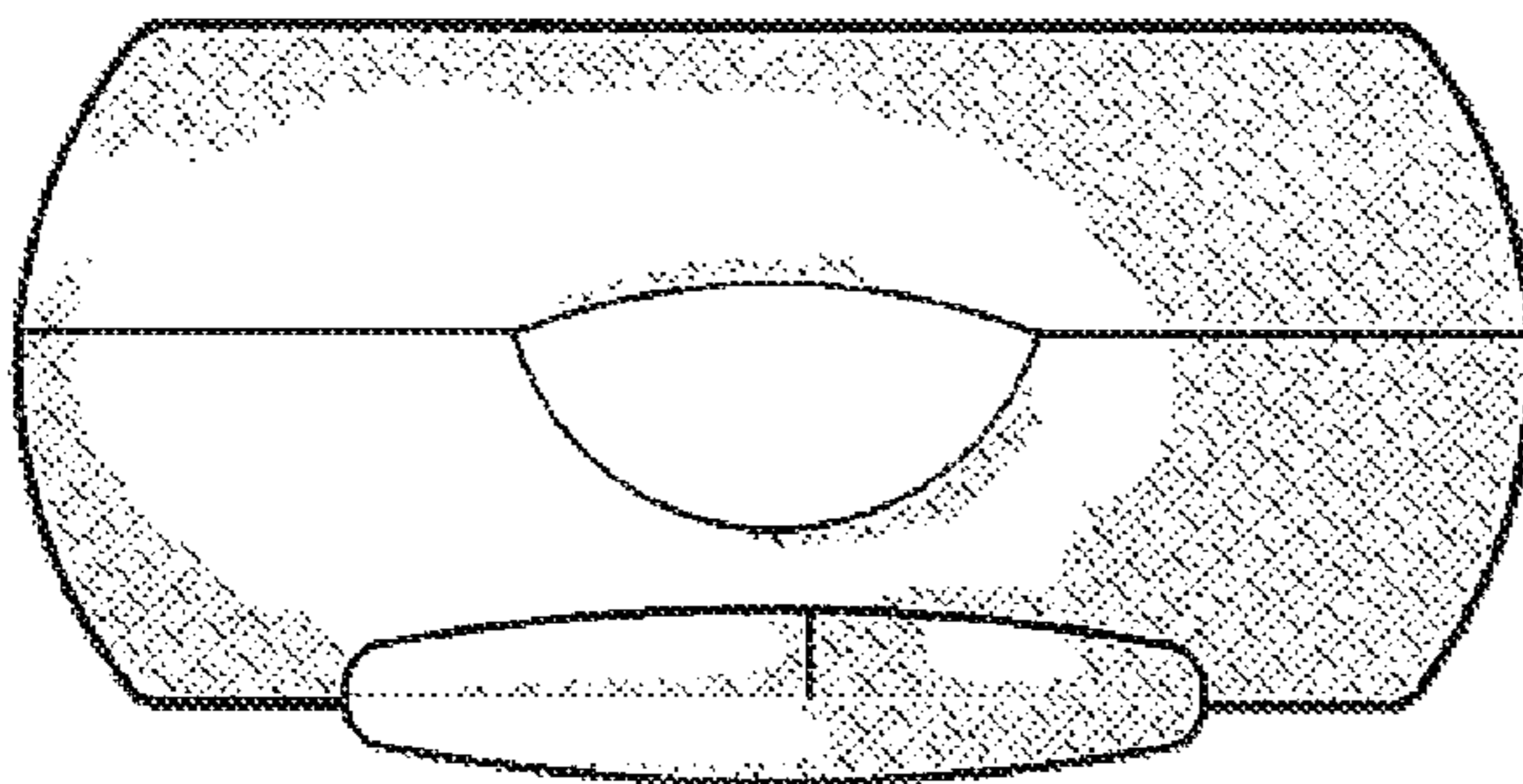

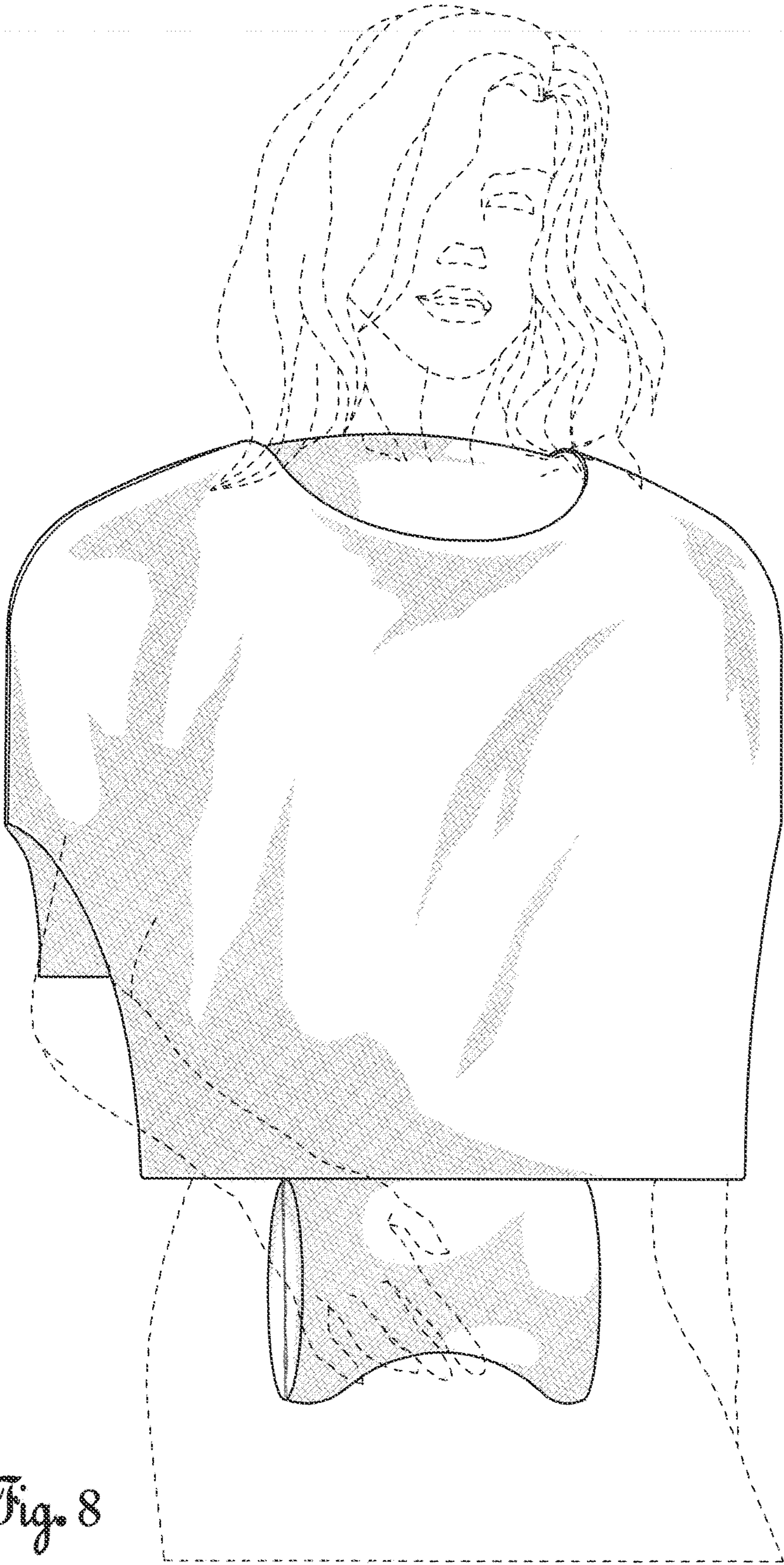
