(57) **CLAIM**

The ornamental design for a suit jacket, as shown and described.

**DESCRIPTION**

FIG. 1 is a left front perspective view of a suit jacket showing our new design;

FIG. 2 is a front elevational view of the suit jacket of FIG. 1;

FIG. 3 is a rear elevational view of the suit jacket of FIG. 1;

FIG. 4 is a left side elevational view of the suit jacket of FIG. 1

showing the lapel and collar in raised position;

FIG. 5 is a right side elevational view of the suit jacket of FIG. 1

showing the lapel and collar in raised position;

FIG. 6 is an enlarged top view of the suit jacket of FIG. 1; and,

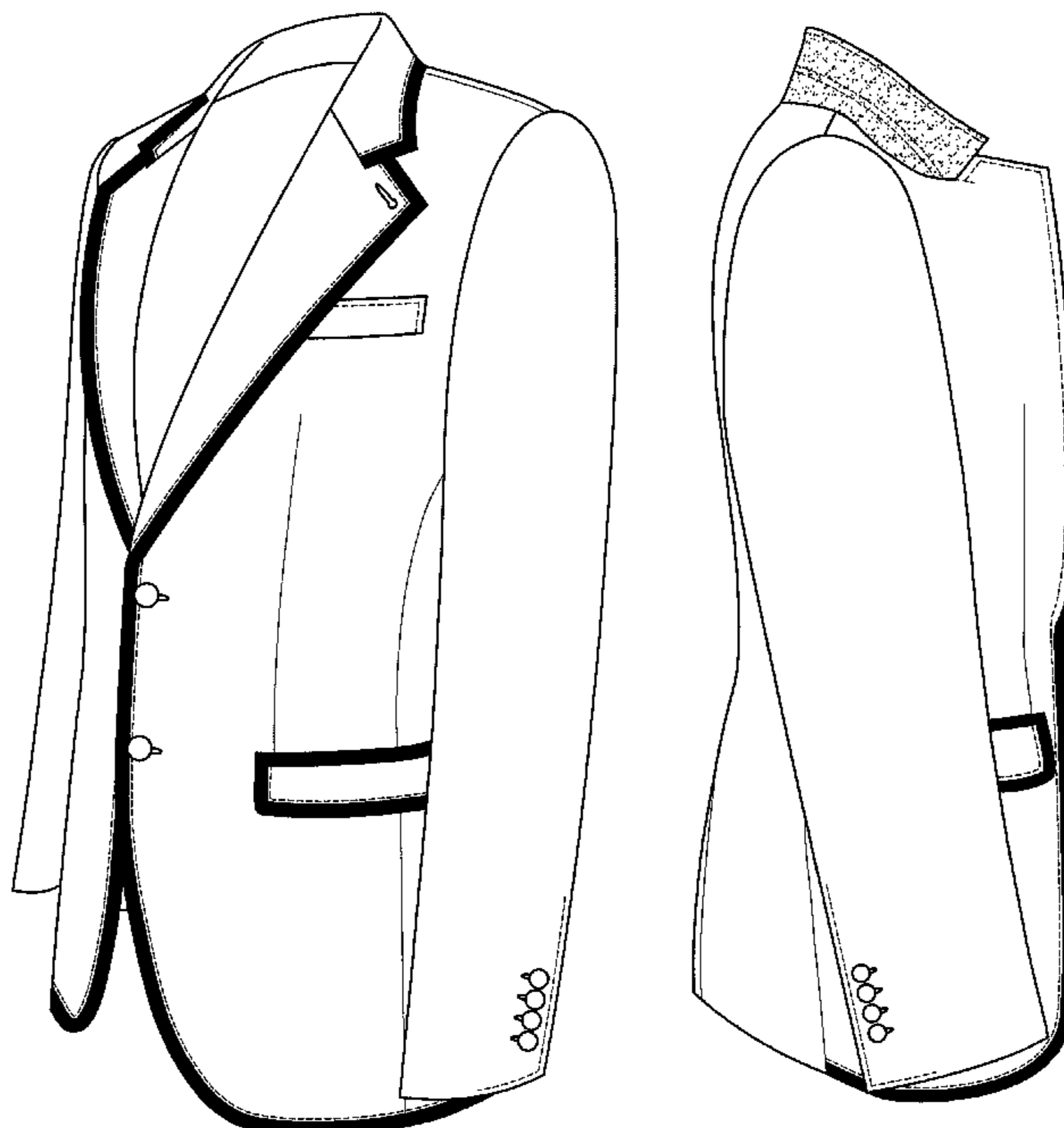
FIG. 7 is an enlarged partial view of the lapel at the area shown by 7 in FIG. 2 of the suit jacket.

The lower line is the seam line and the upper line is an object line as shown in FIGS. 1, 2, and 7.

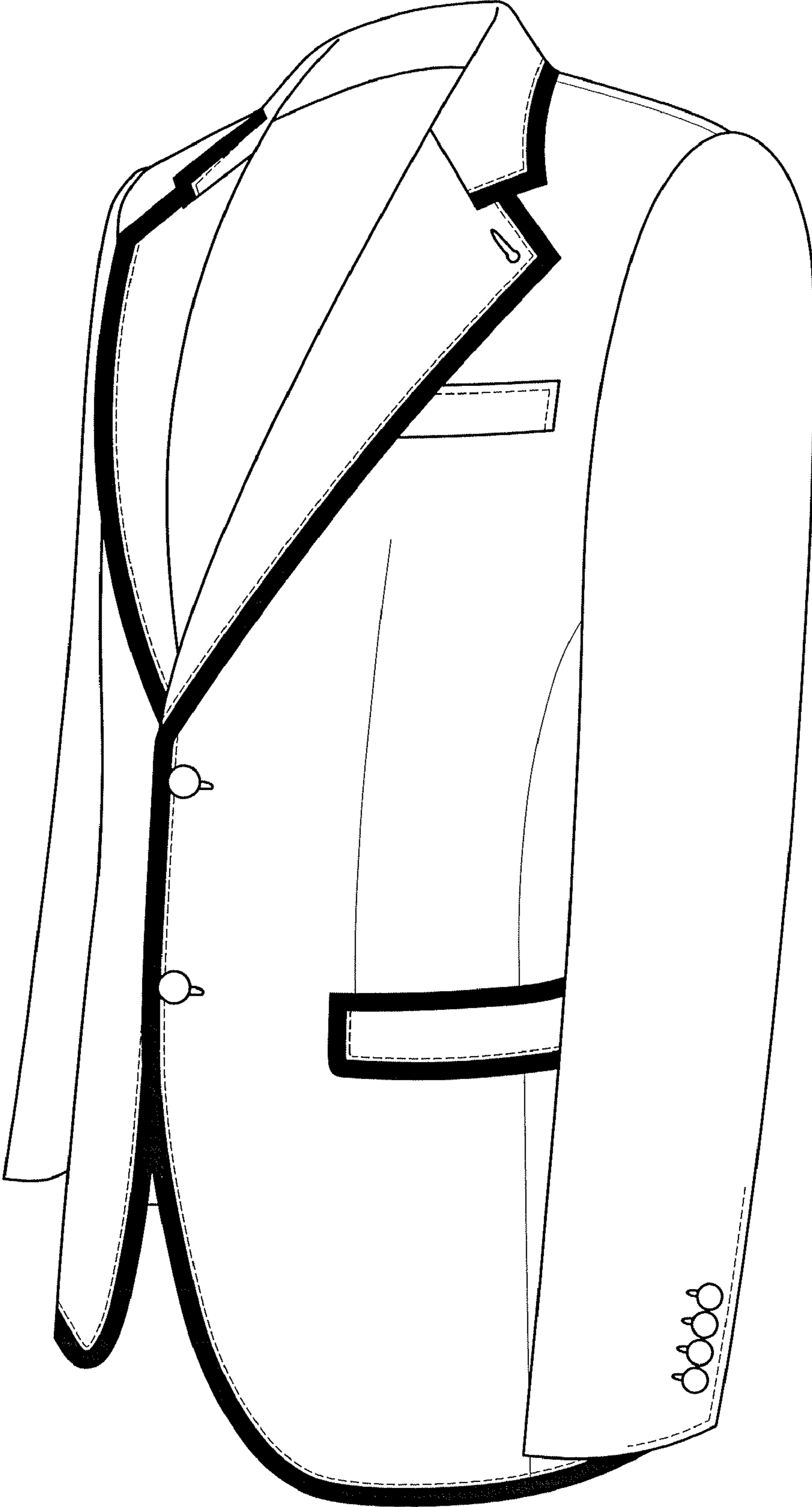

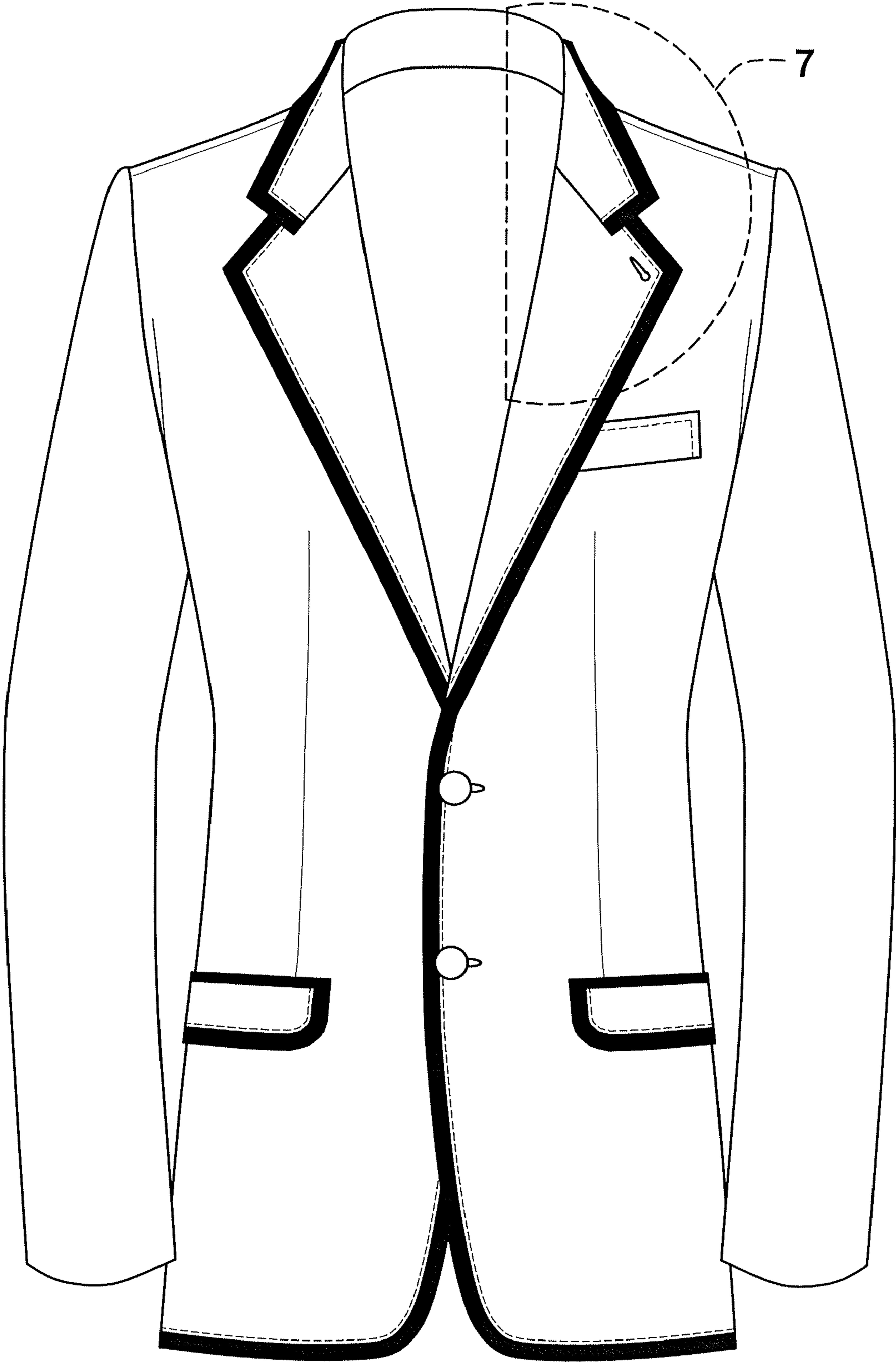

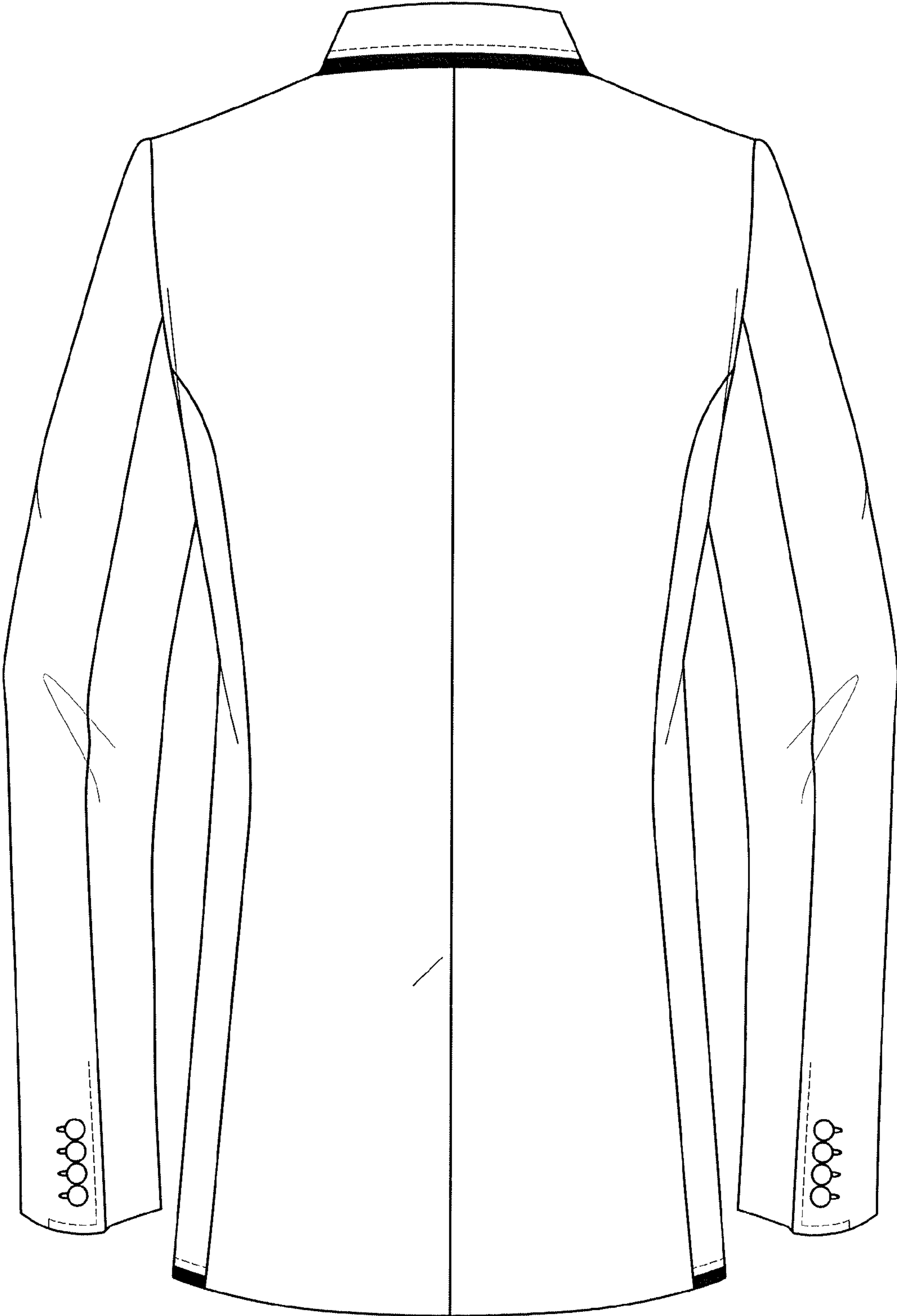

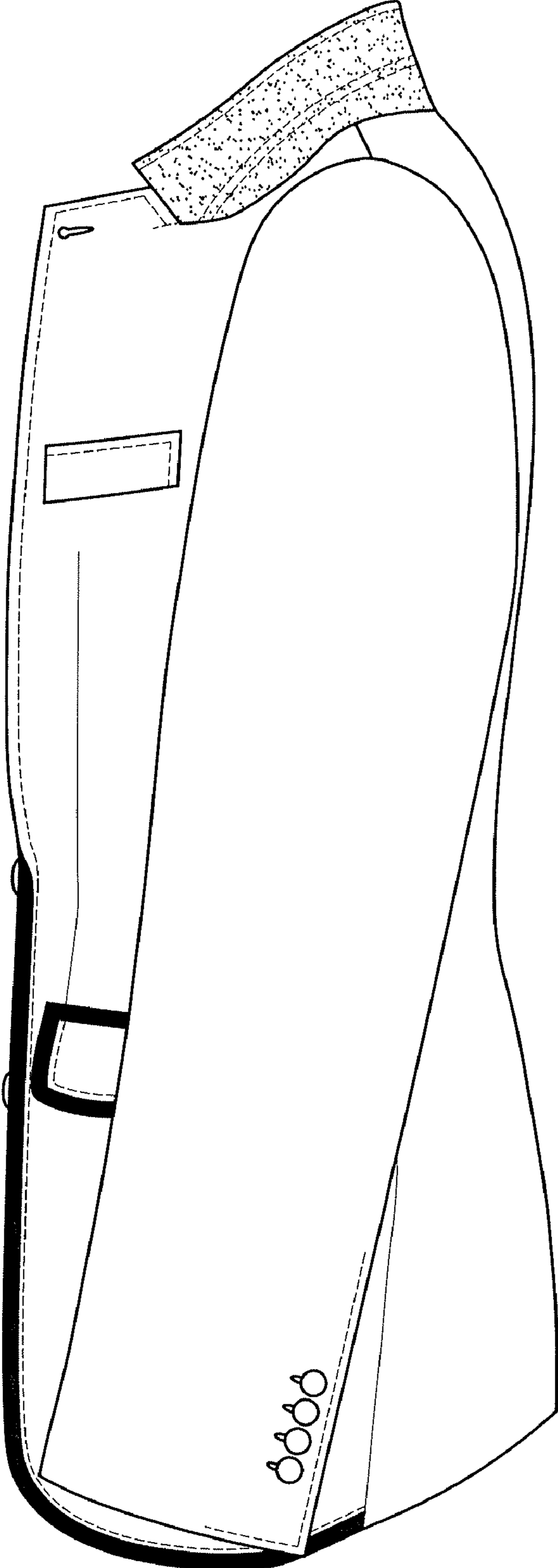

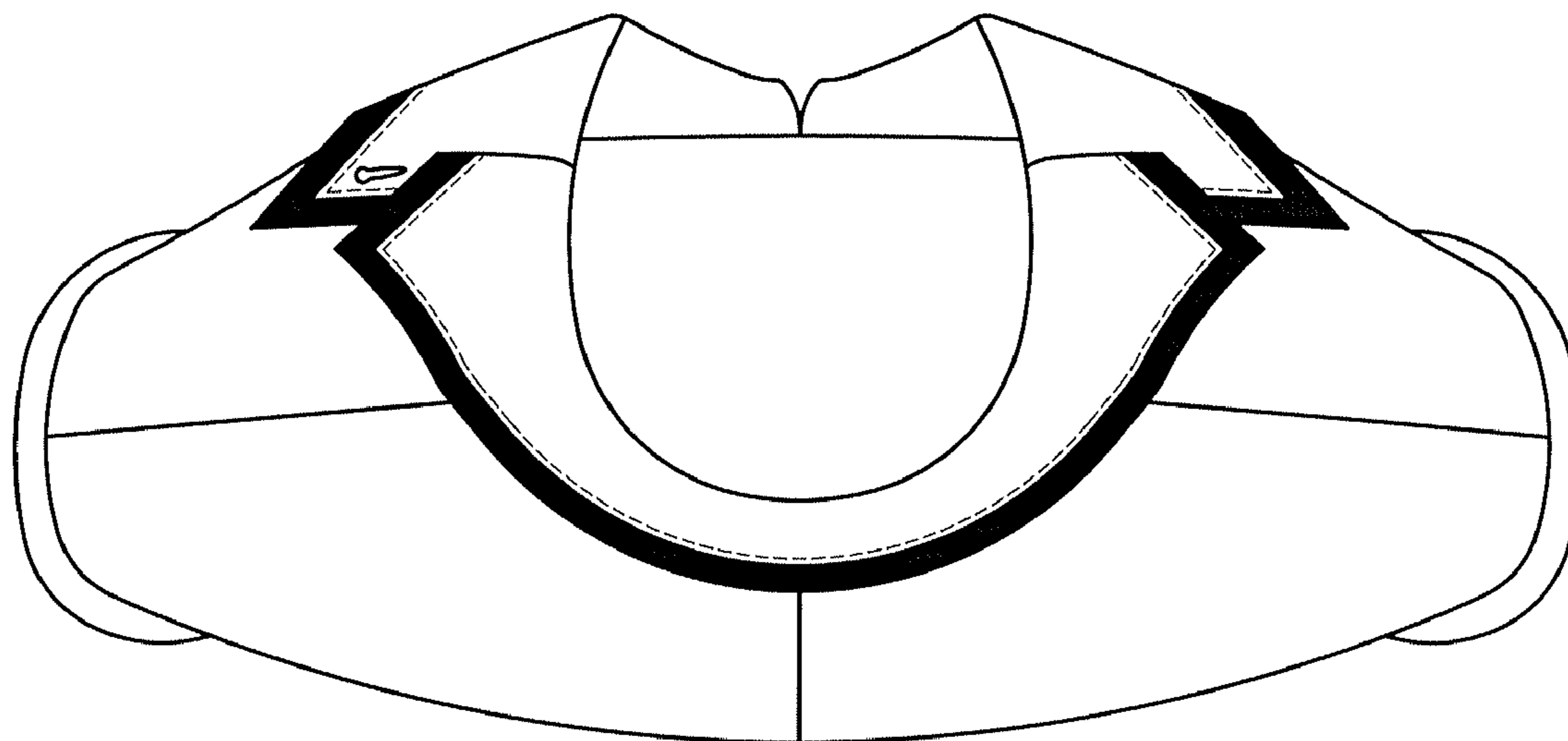

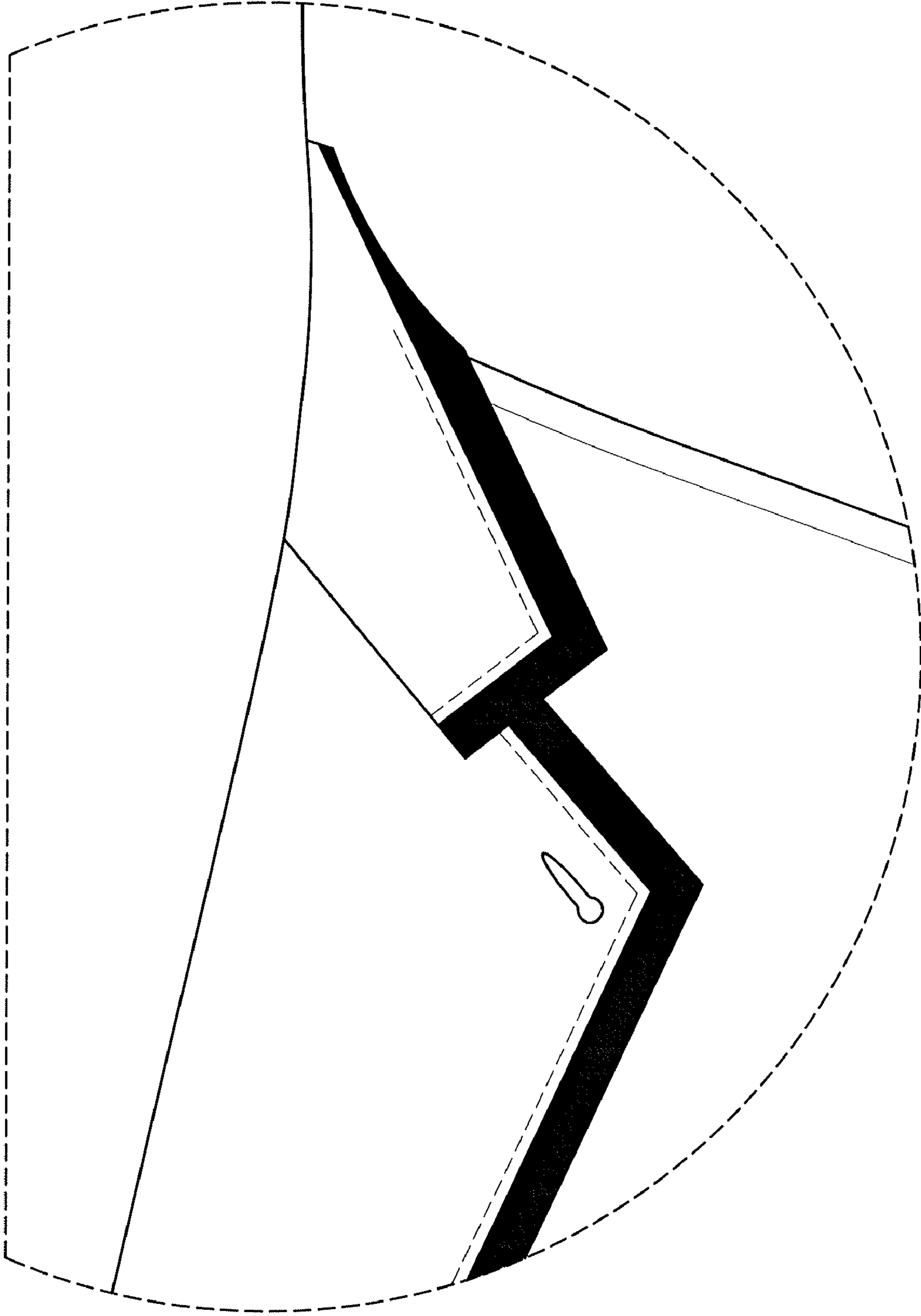
