FIG. 4 is a side view of a supplement organizer according to the present invention.

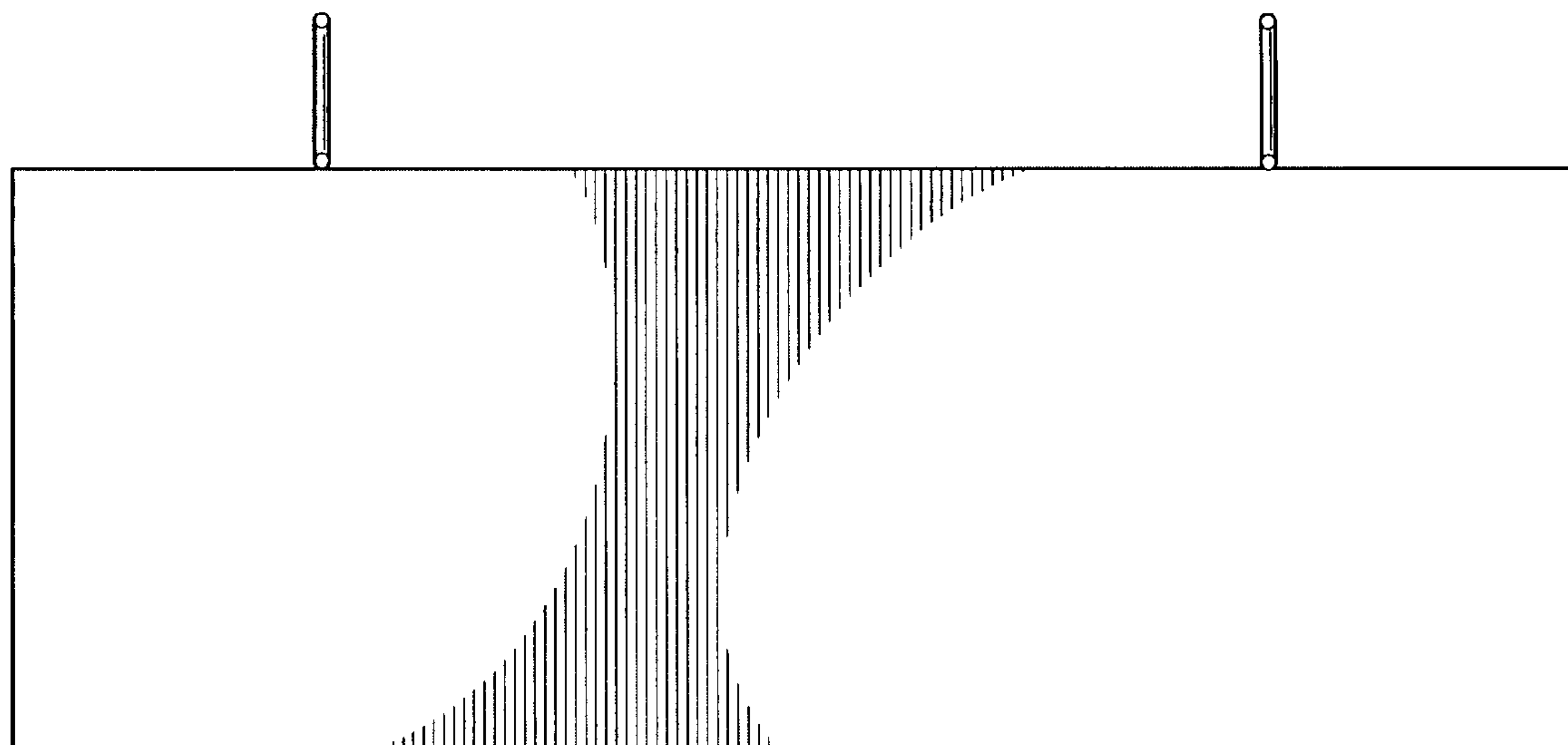
FIG. 5 is a side view of a supplement organizer according to the present invention.

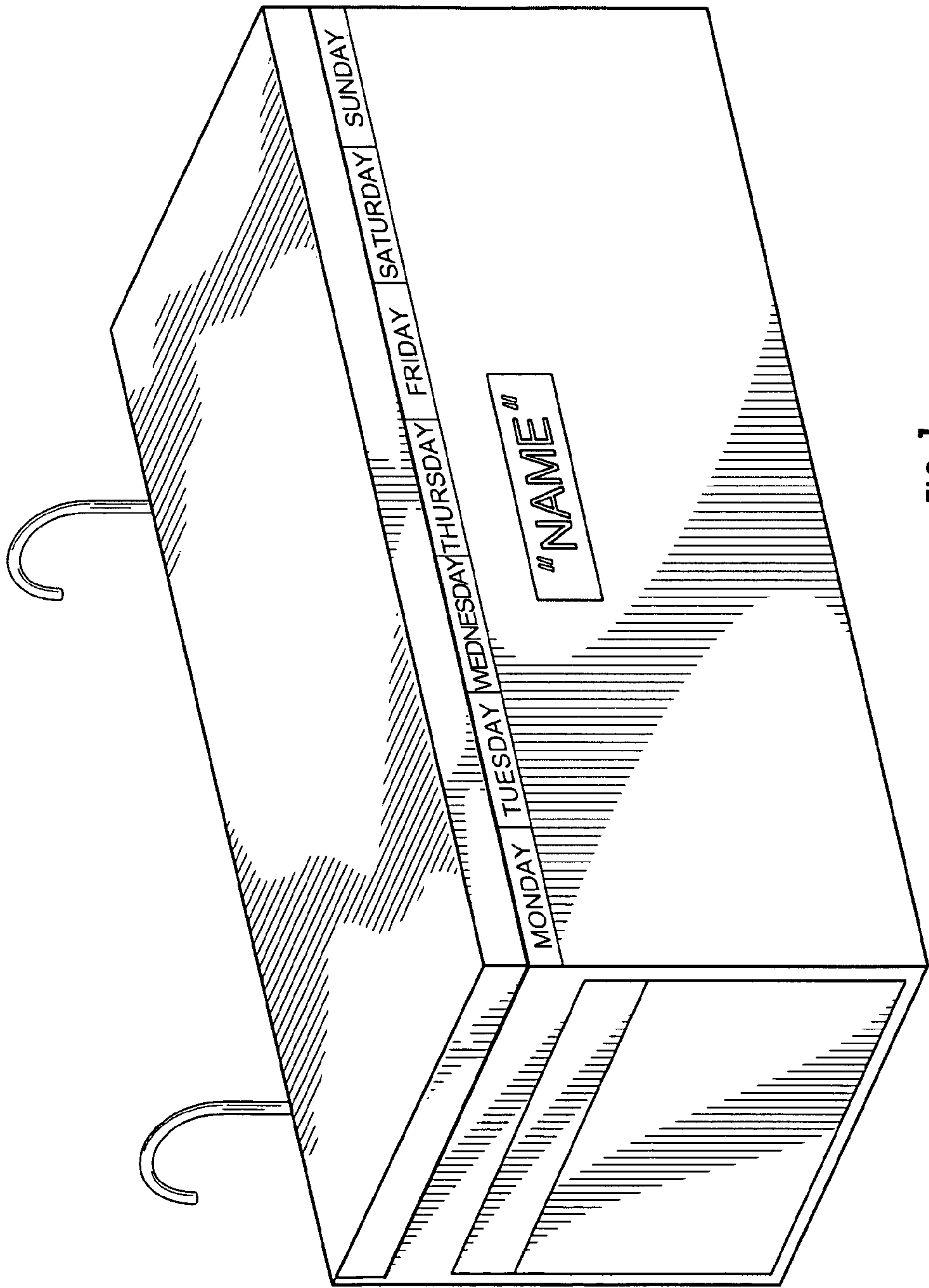

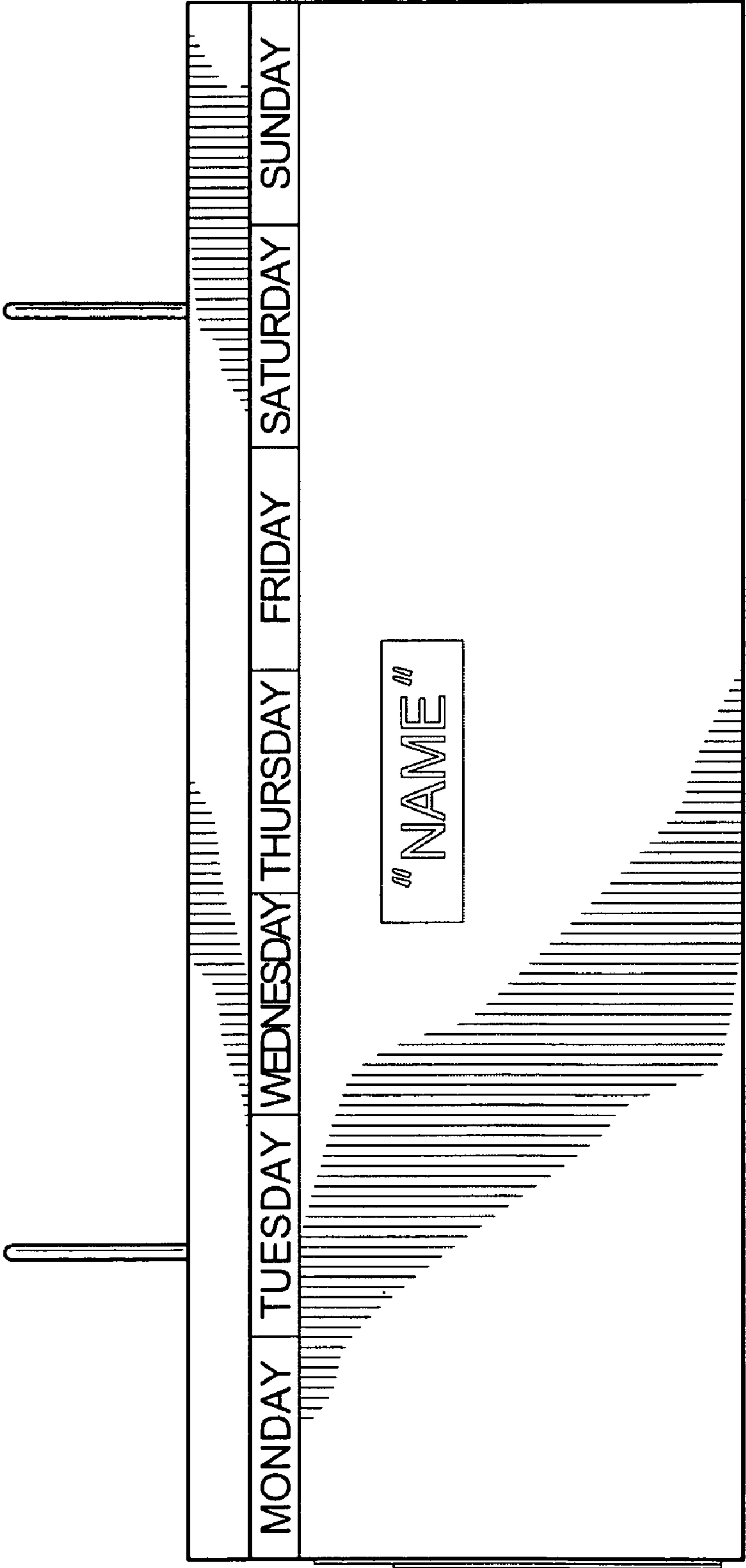

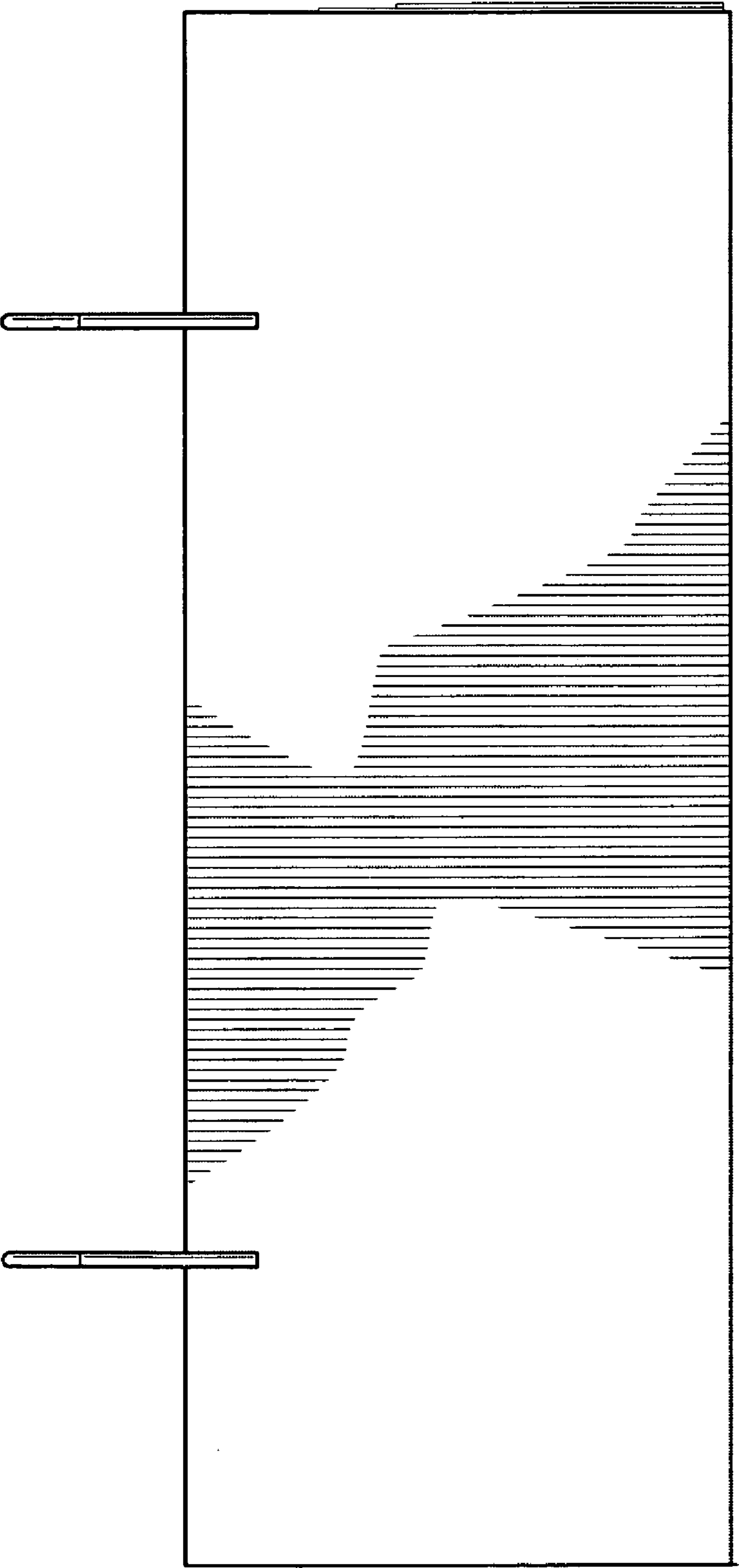

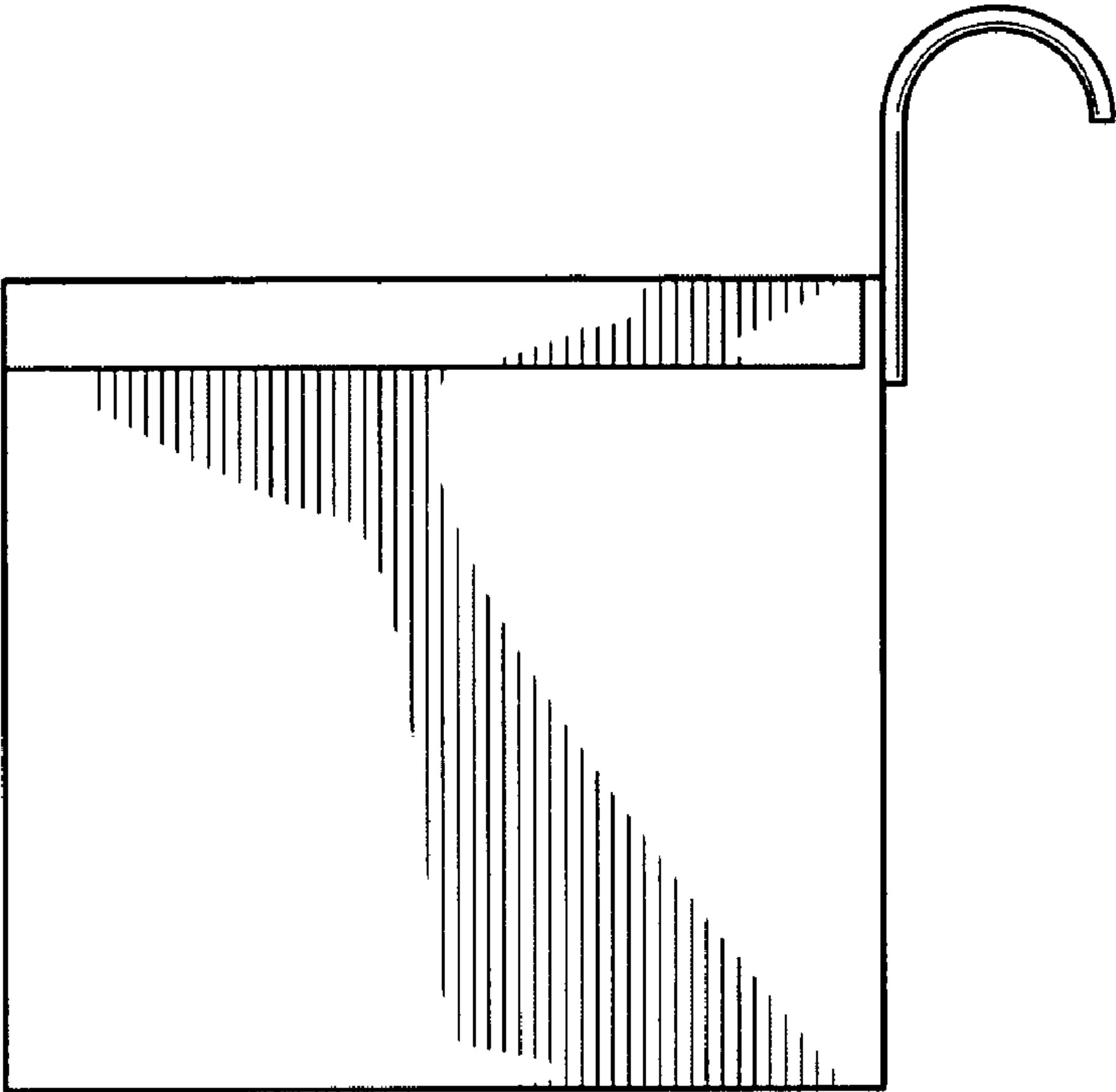

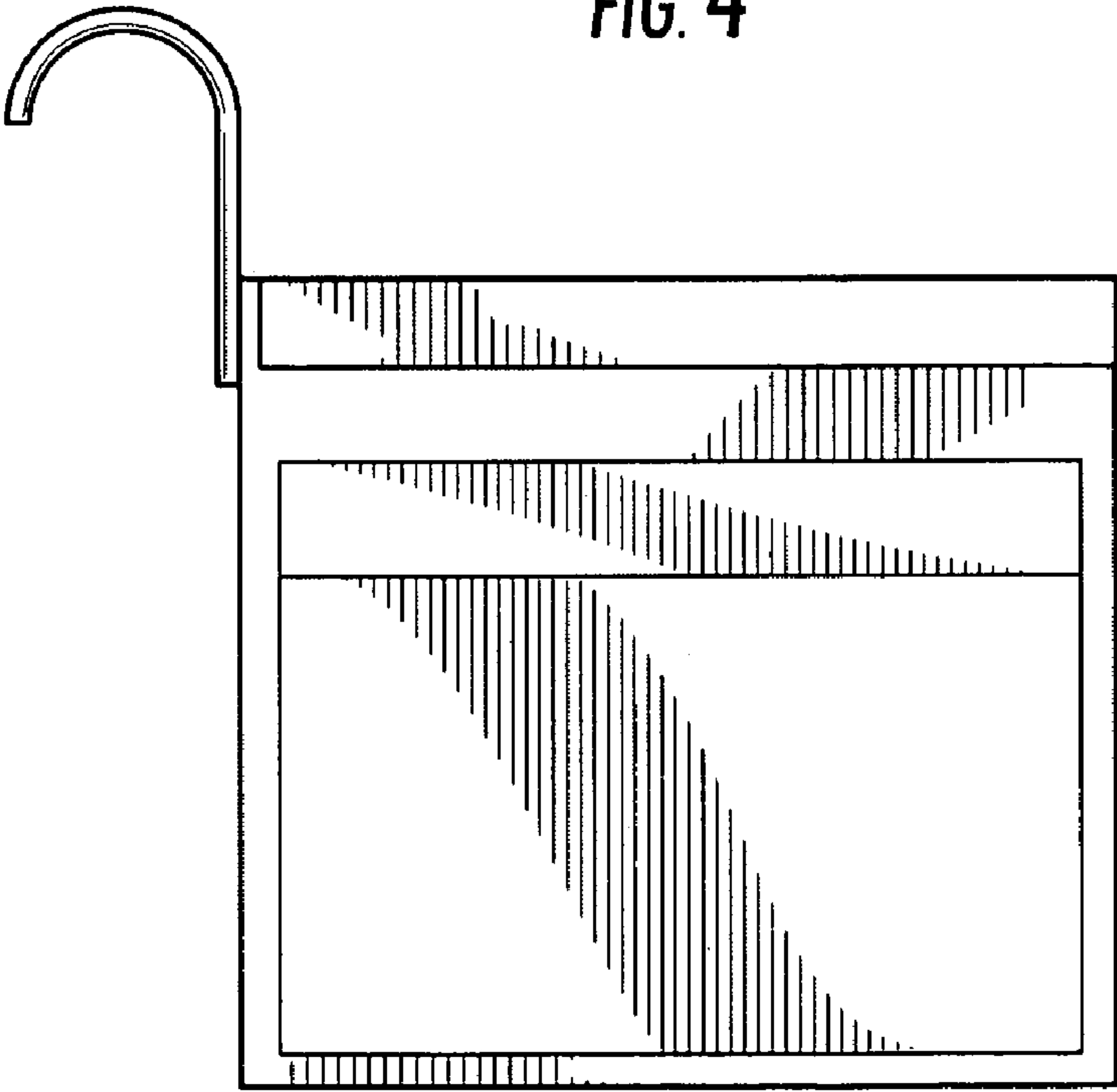

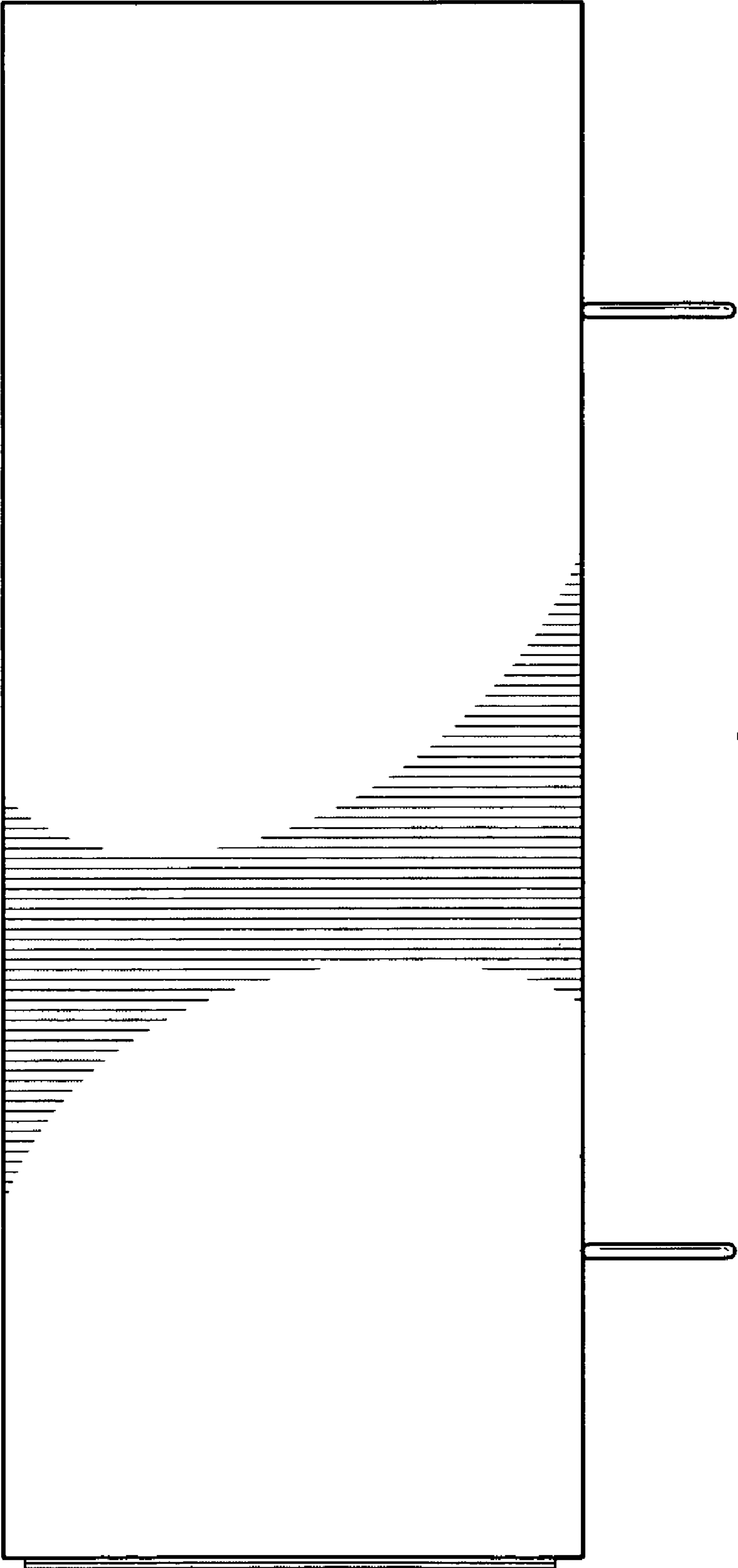

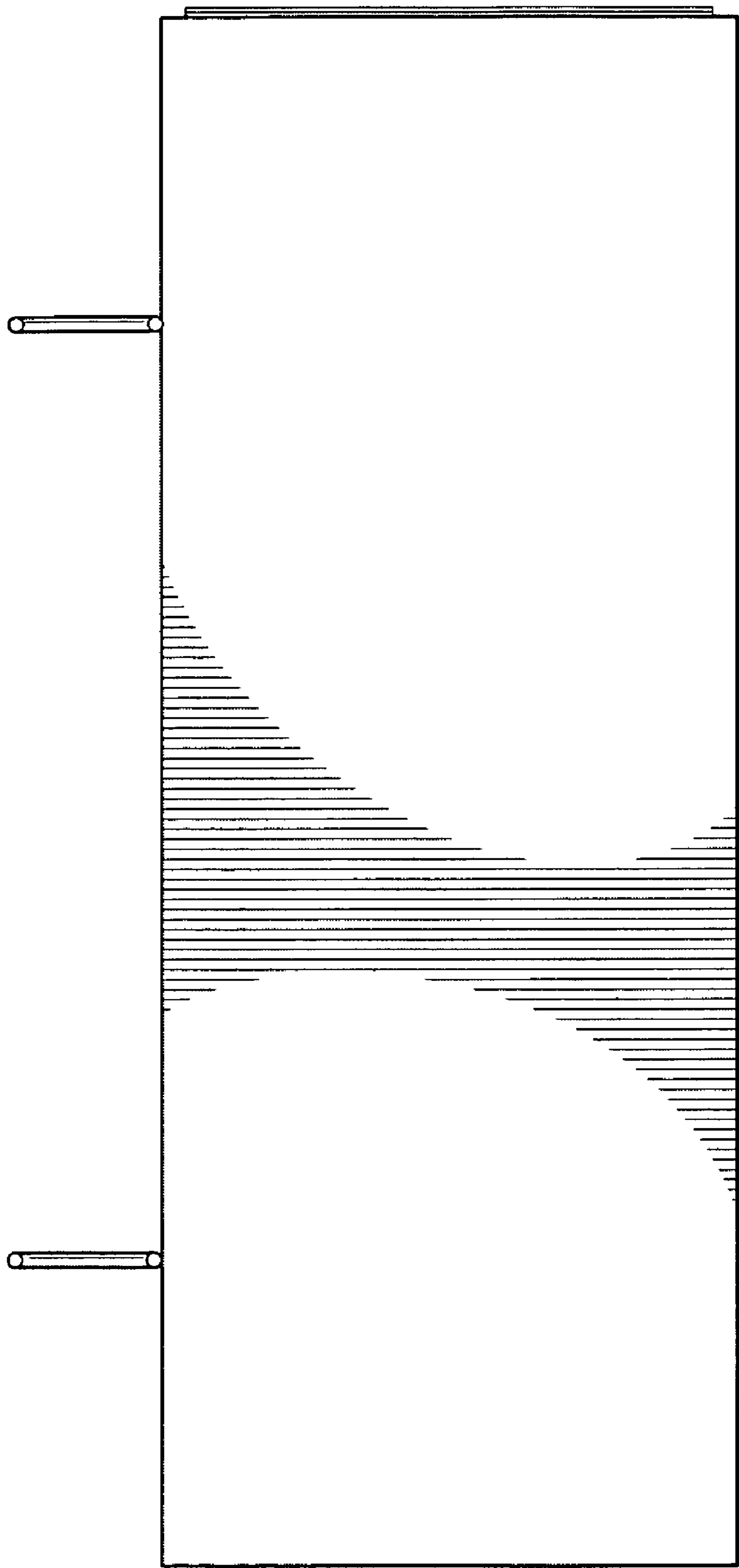
