FIG. 1 shows a perspective view of a sheet material with topographic pattern imprint.

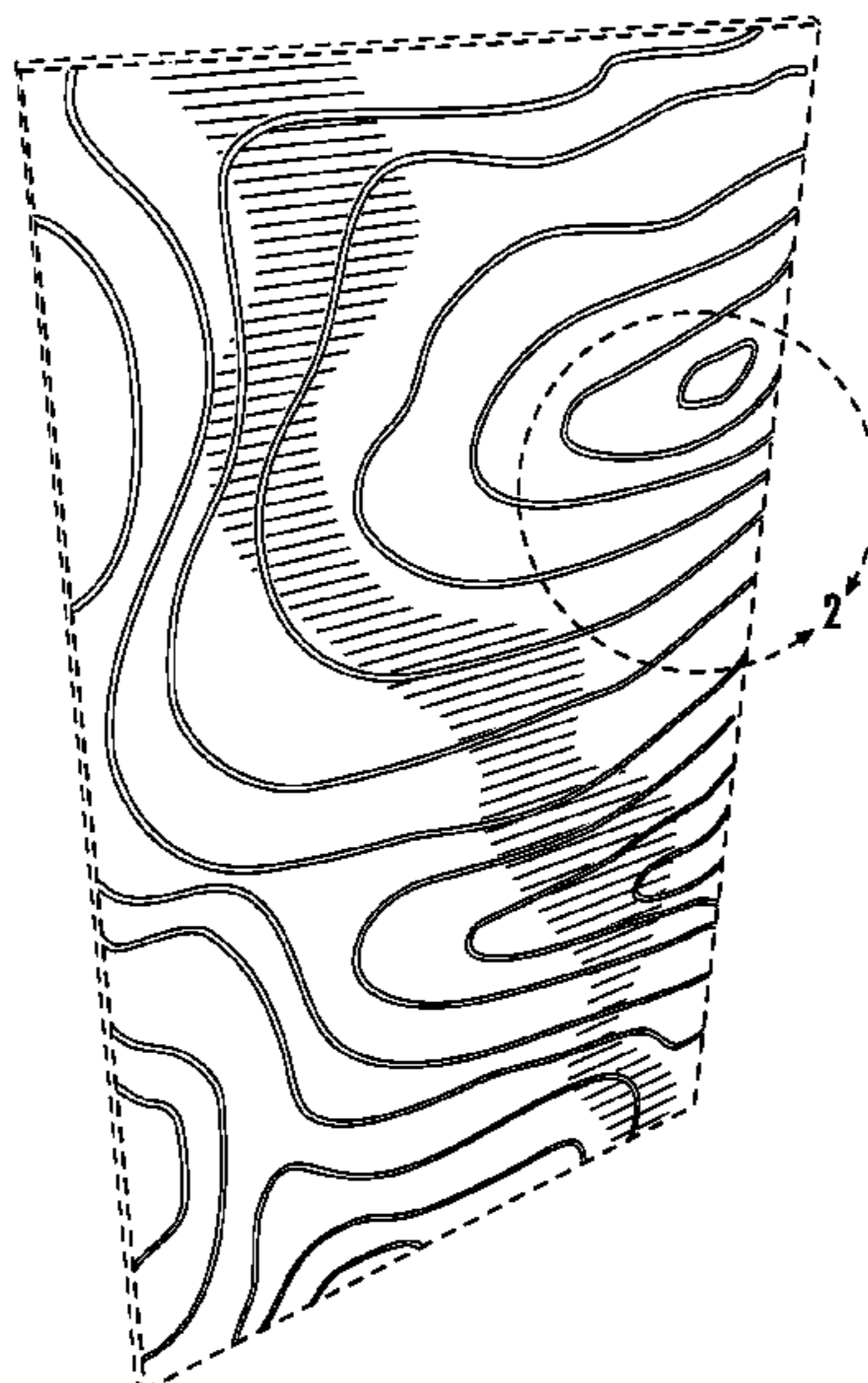
FIG. 2 shows a close-up view of the section indicated by circle 2 in FIG. 1.

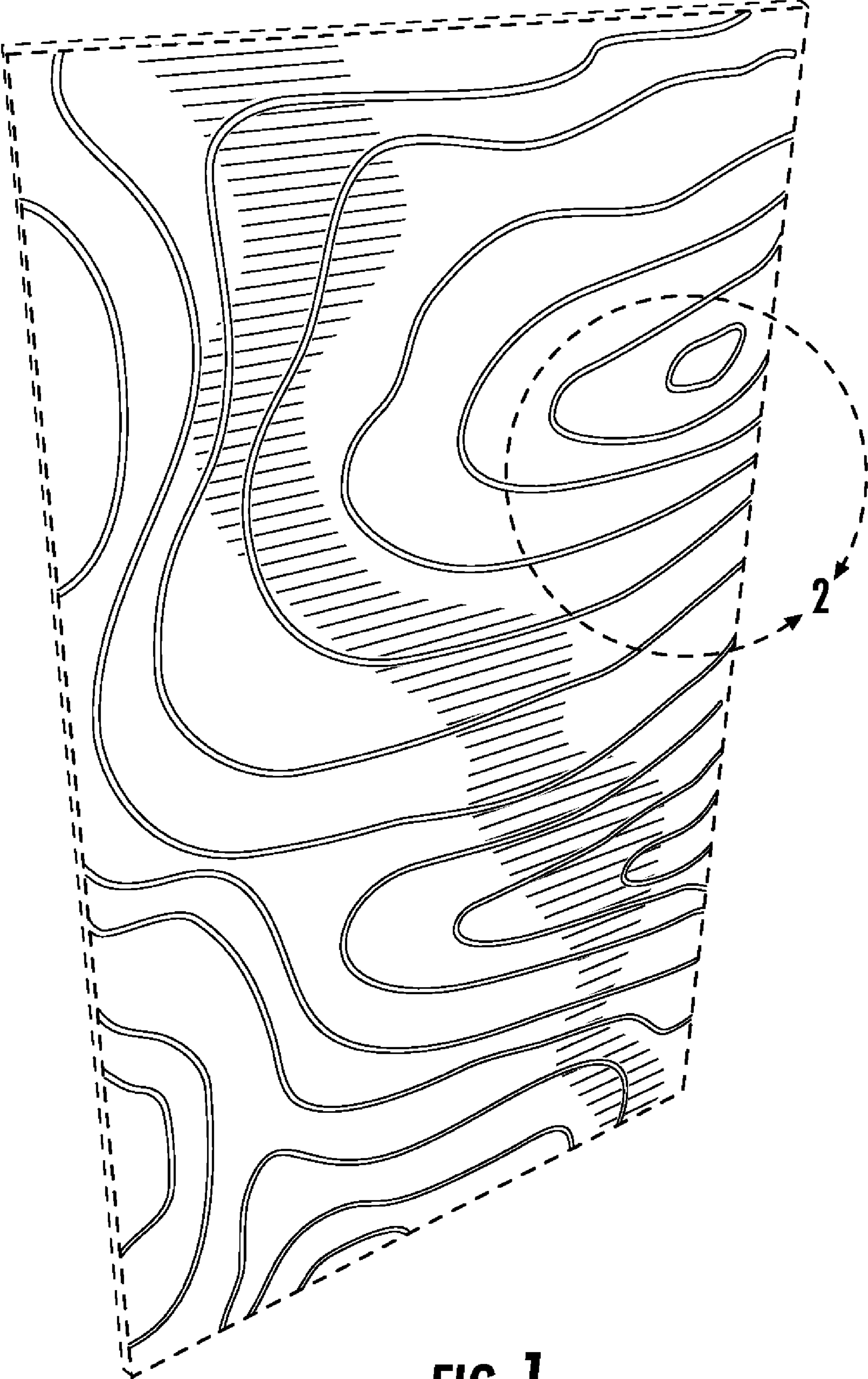

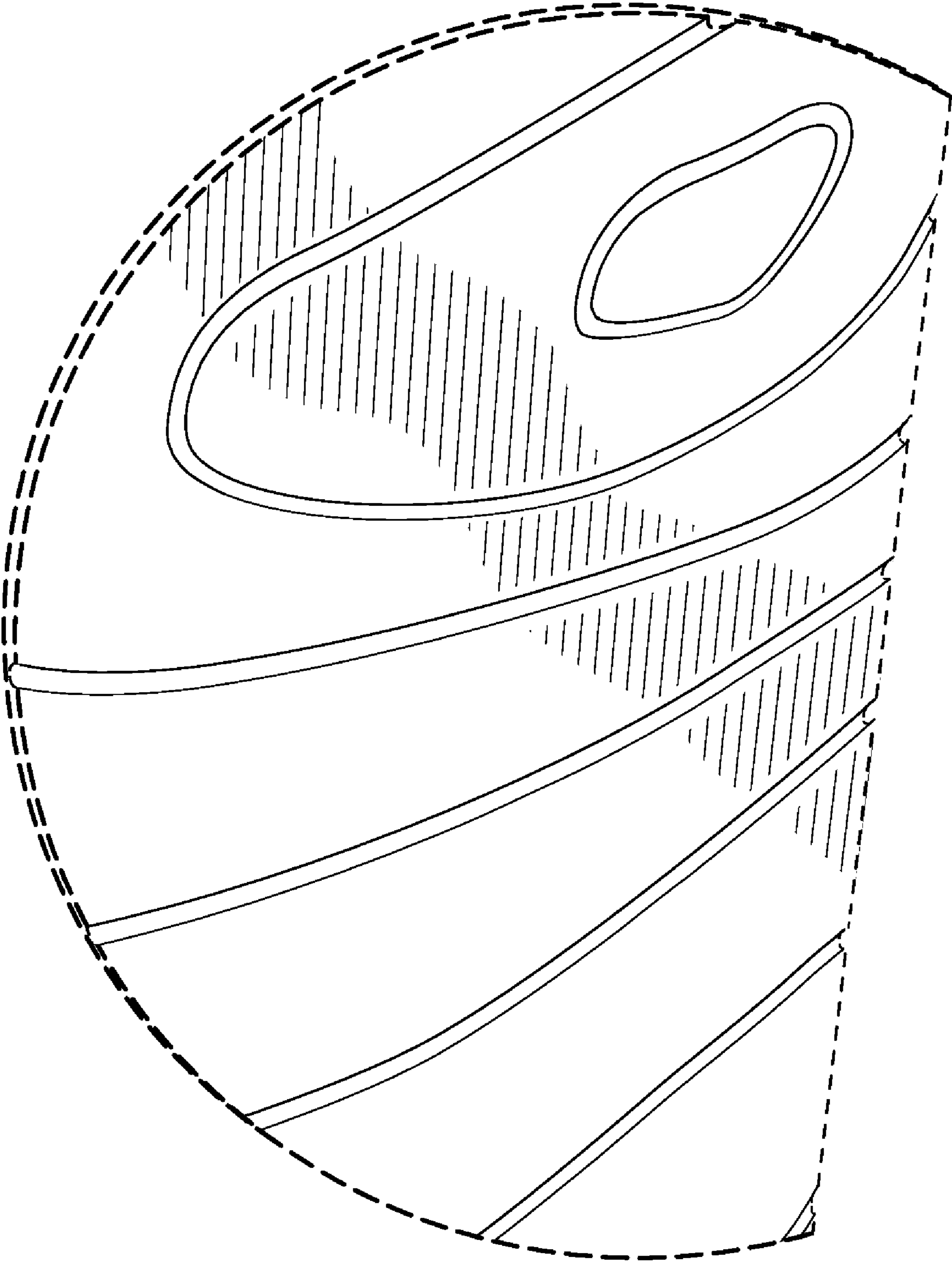

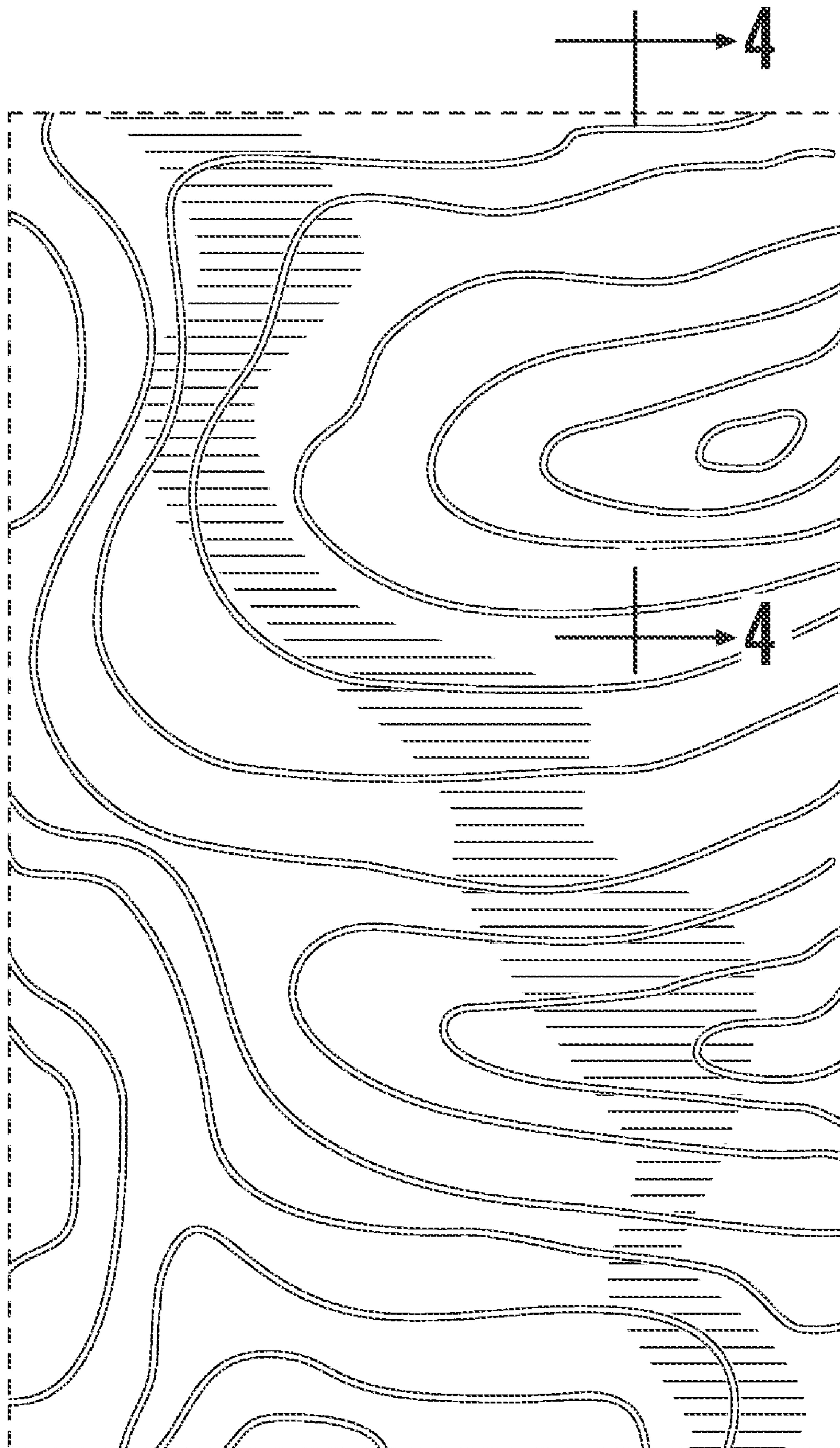
