FIG. 8 is a left side elevation view of the window covering as retracted, the right side of which is a mirror image thereof.

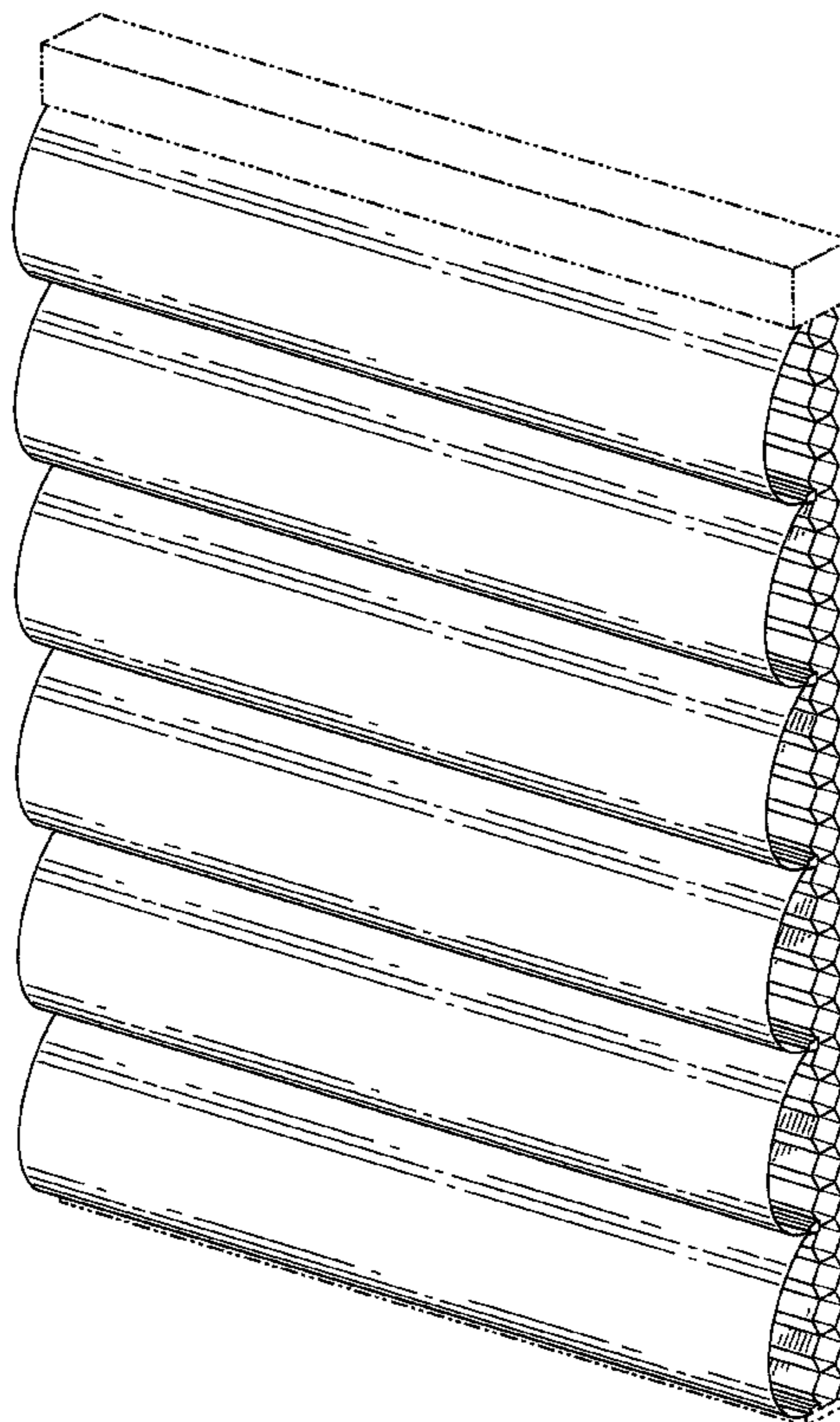

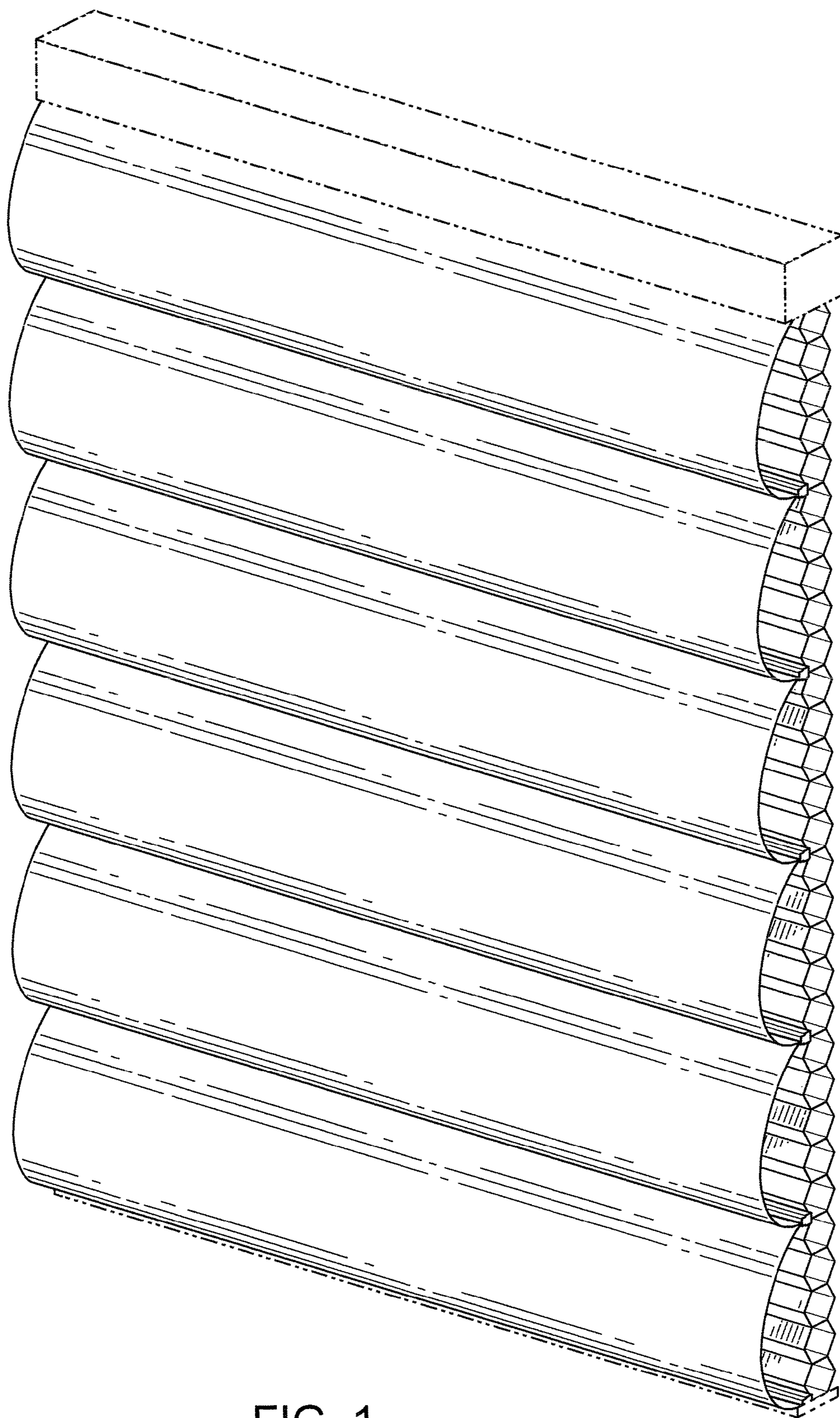

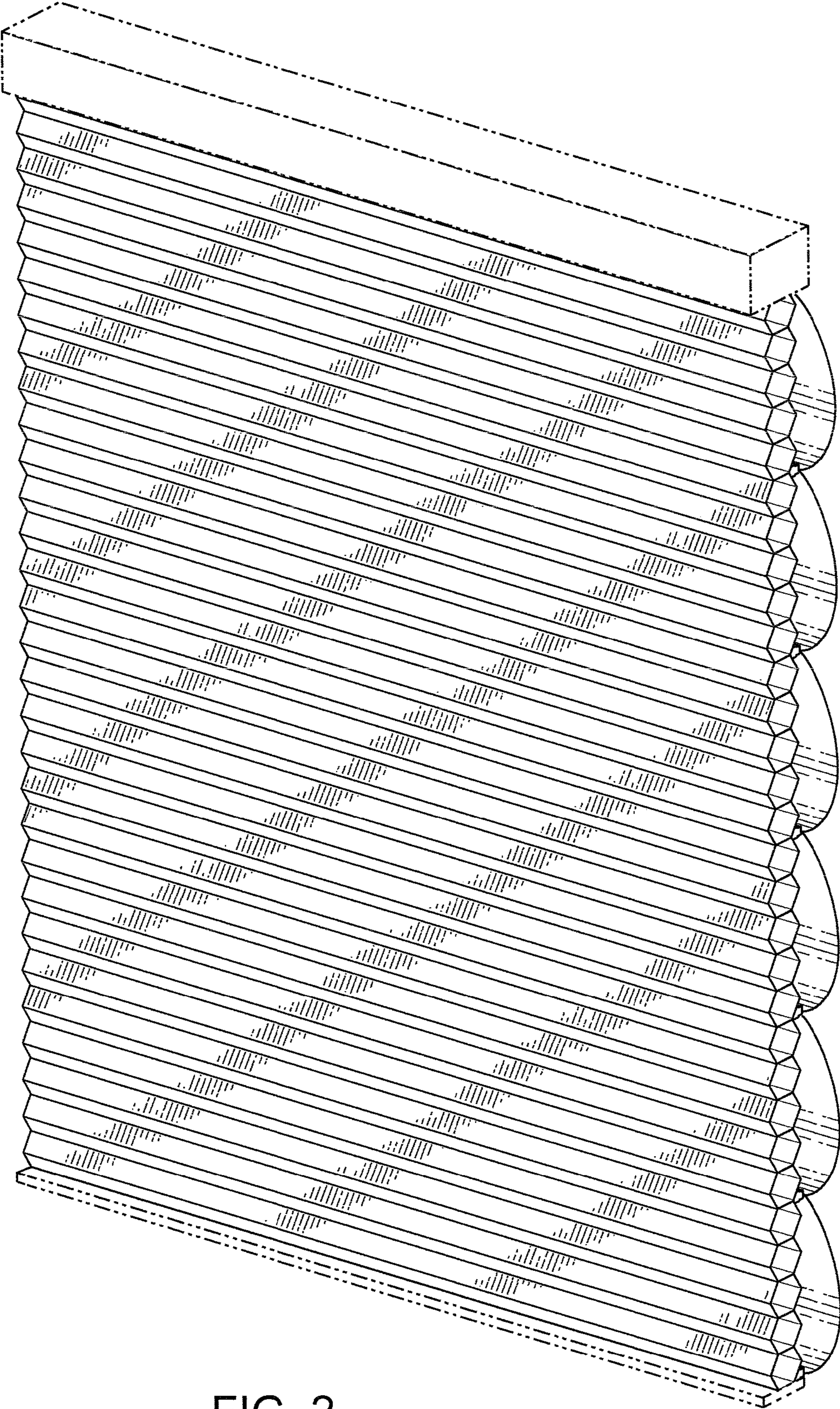

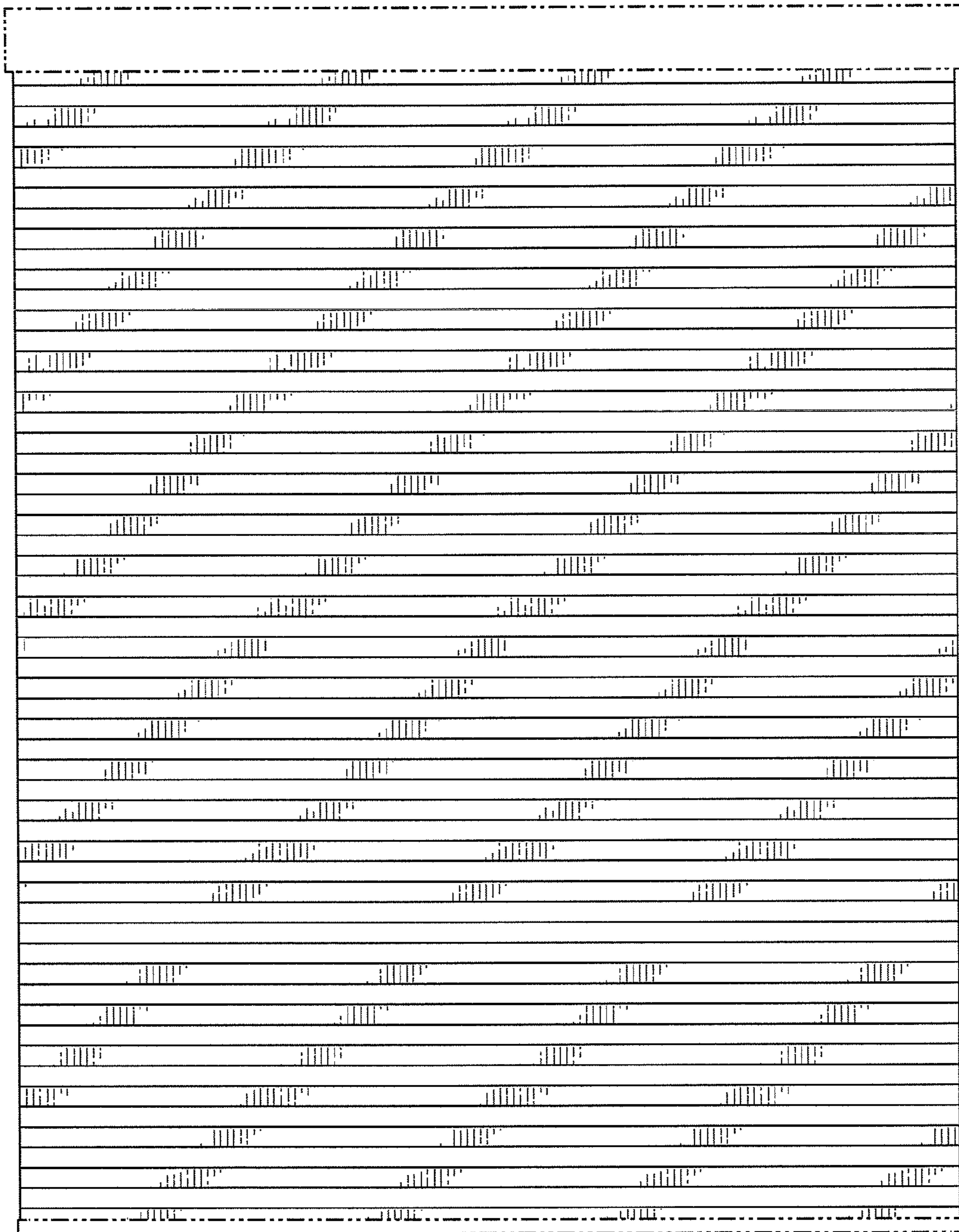

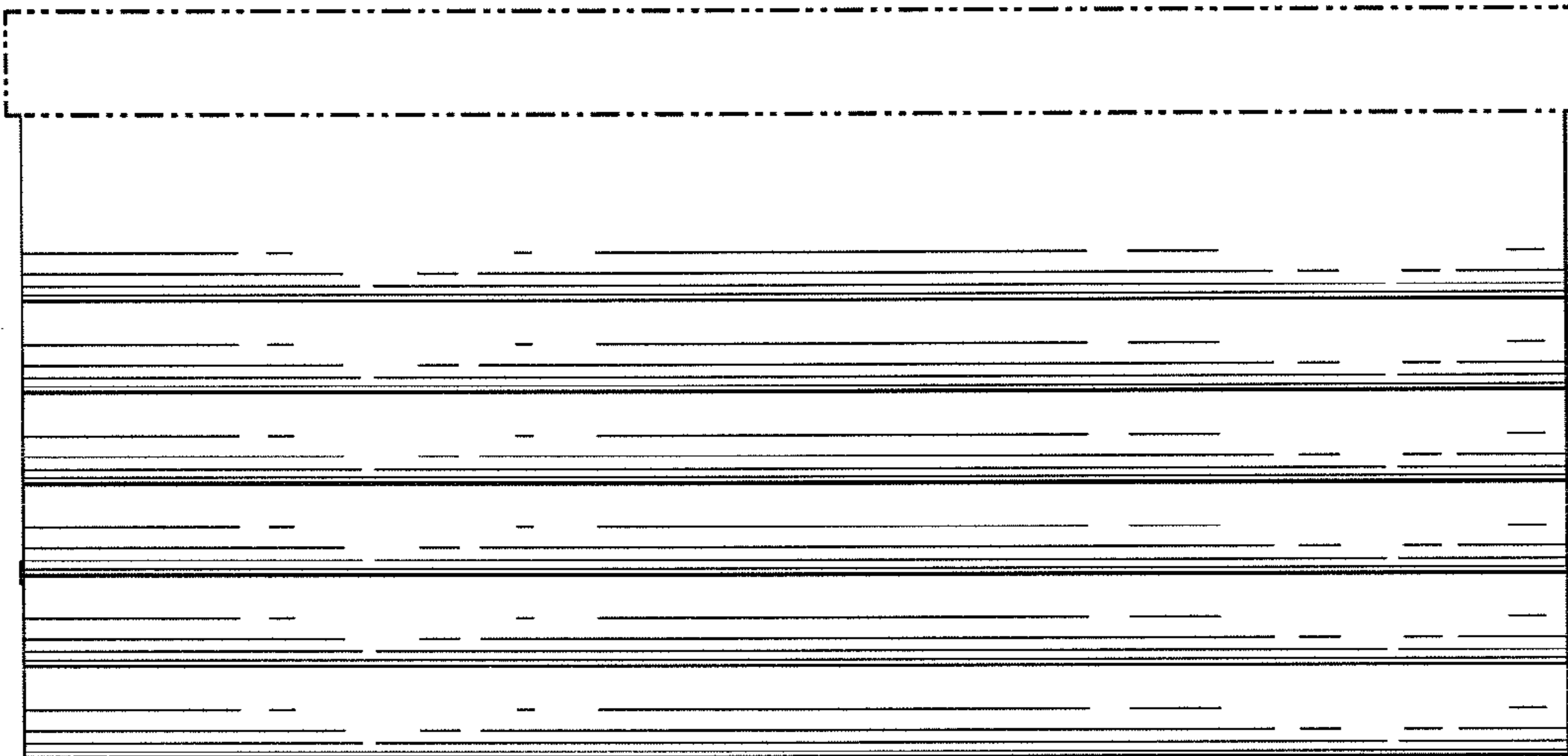

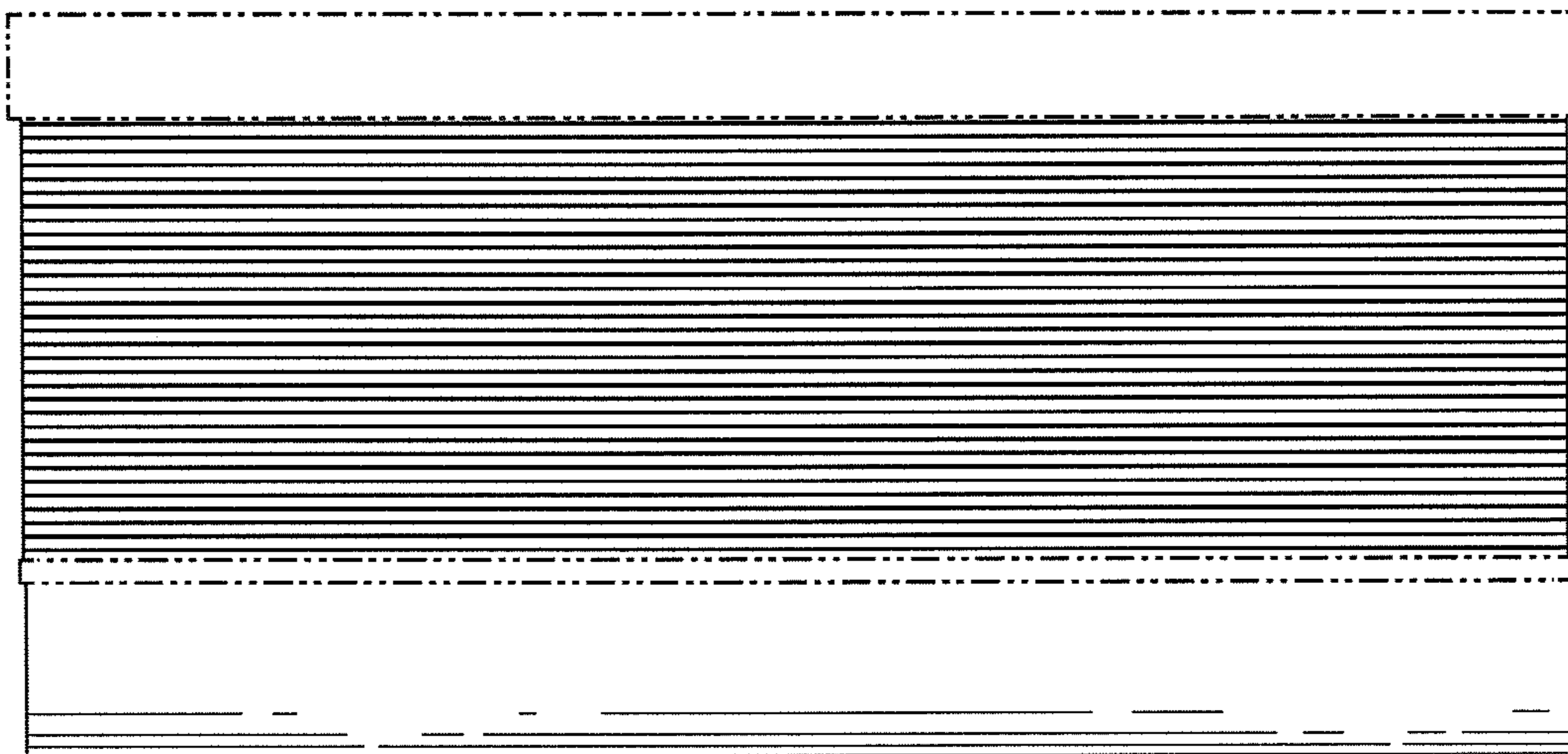

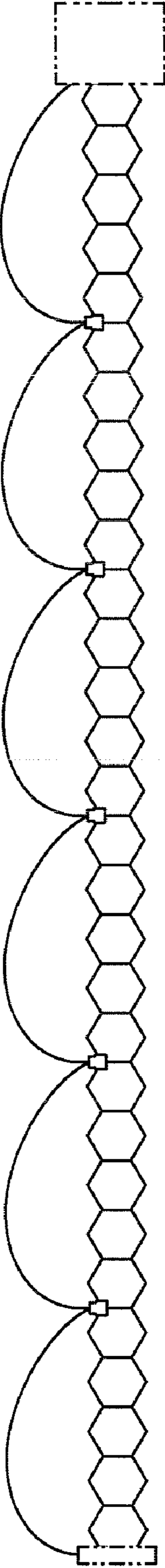

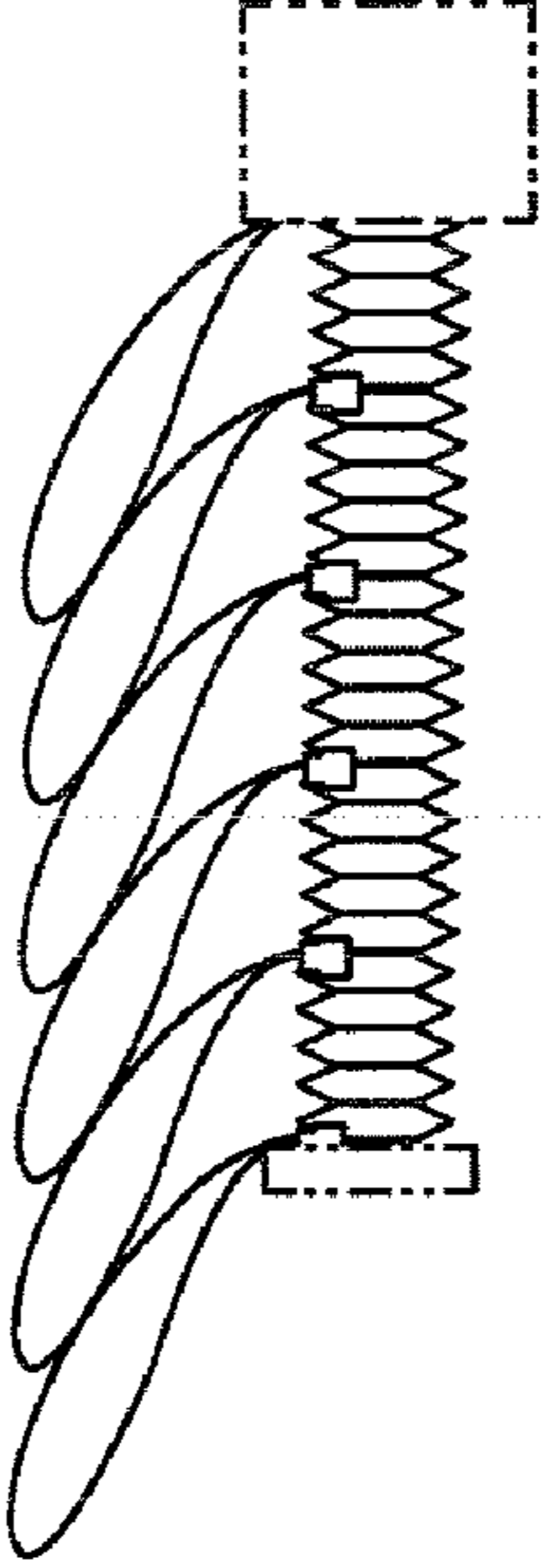
