(57) **CLAIM**

I claim the ornamental design for an decorative accessory sleeve for an automotive mirror, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a decorative accessory sleeve for an automotive mirror according to a first embodiment installed on an automotive mirror;

FIG. 2 is a front view of the embodiment of FIG. 1;

FIG. 3 is a rear view of the embodiment of FIG. 1;

FIG. 4 is a right side view of the embodiment of FIG. 1;

FIG. 5 is a left side view of the embodiment of FIG. 1;

FIG. 6 is a top view of the embodiment of FIG. 1;

FIG. 7 is a bottom view of the embodiment of FIG. 1;

FIG. 8 is a perspective view of a decorative accessory sleeve for an automotive mirror according to a second embodiment installed on an automotive mirror;

FIG. 9 is a front view of the embodiment of FIG. 8;

FIG. 10 is a rear view thereof of the embodiment of FIG. 8;

FIG. 11 is a right side view of the embodiment of FIG. 8;

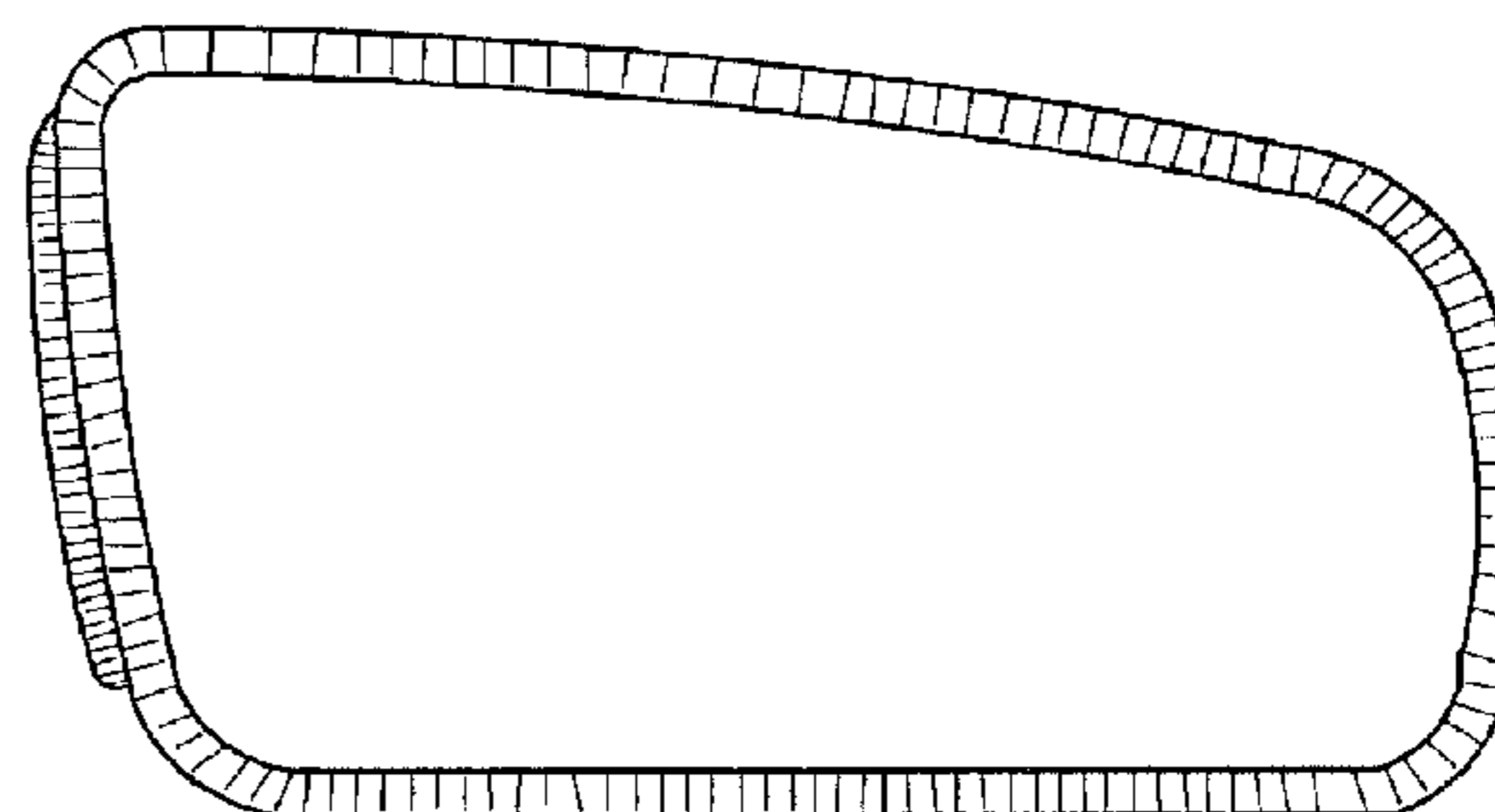
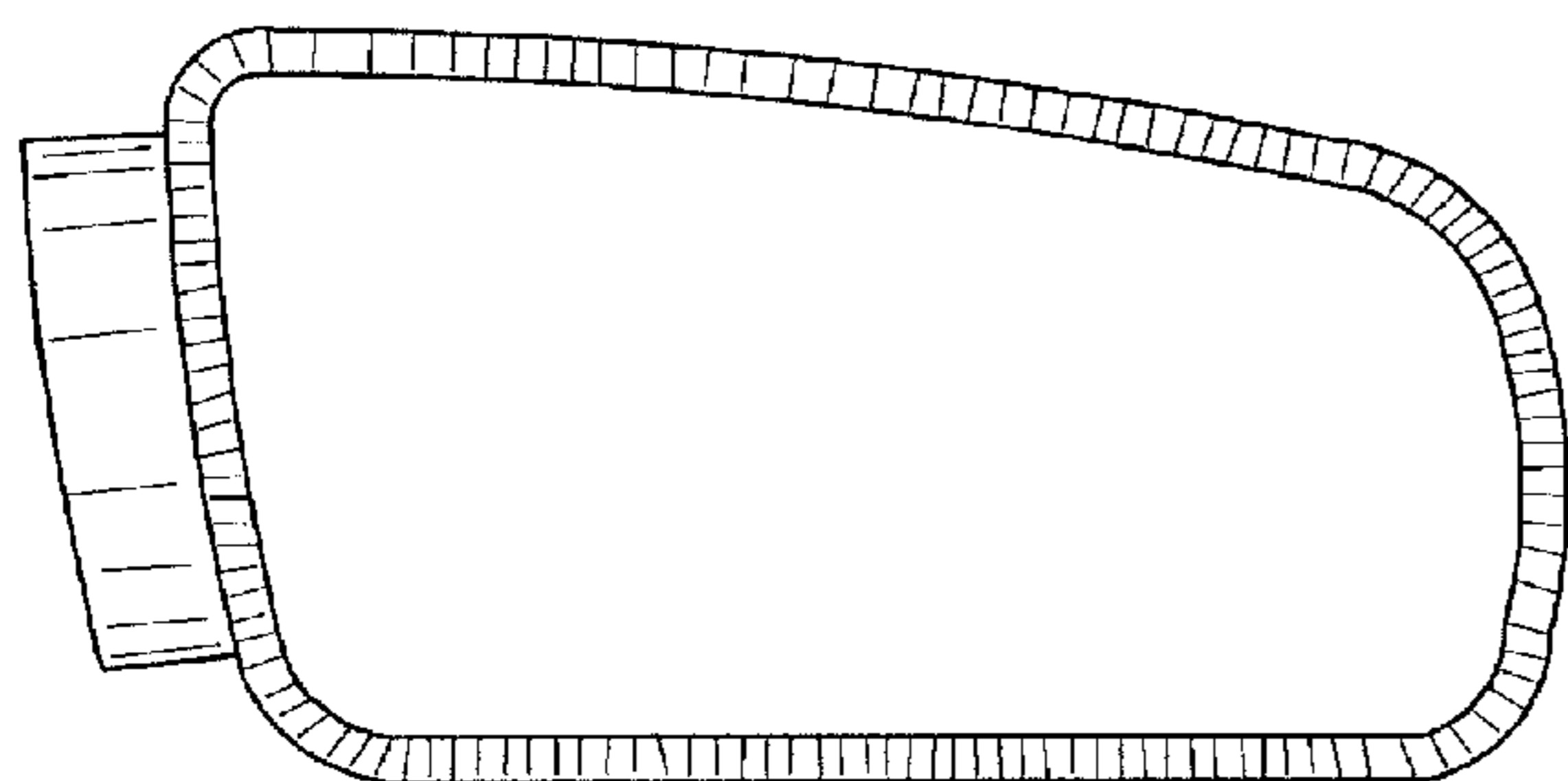
FIG. 12 is a left side view of the embodiment of FIG. 8;

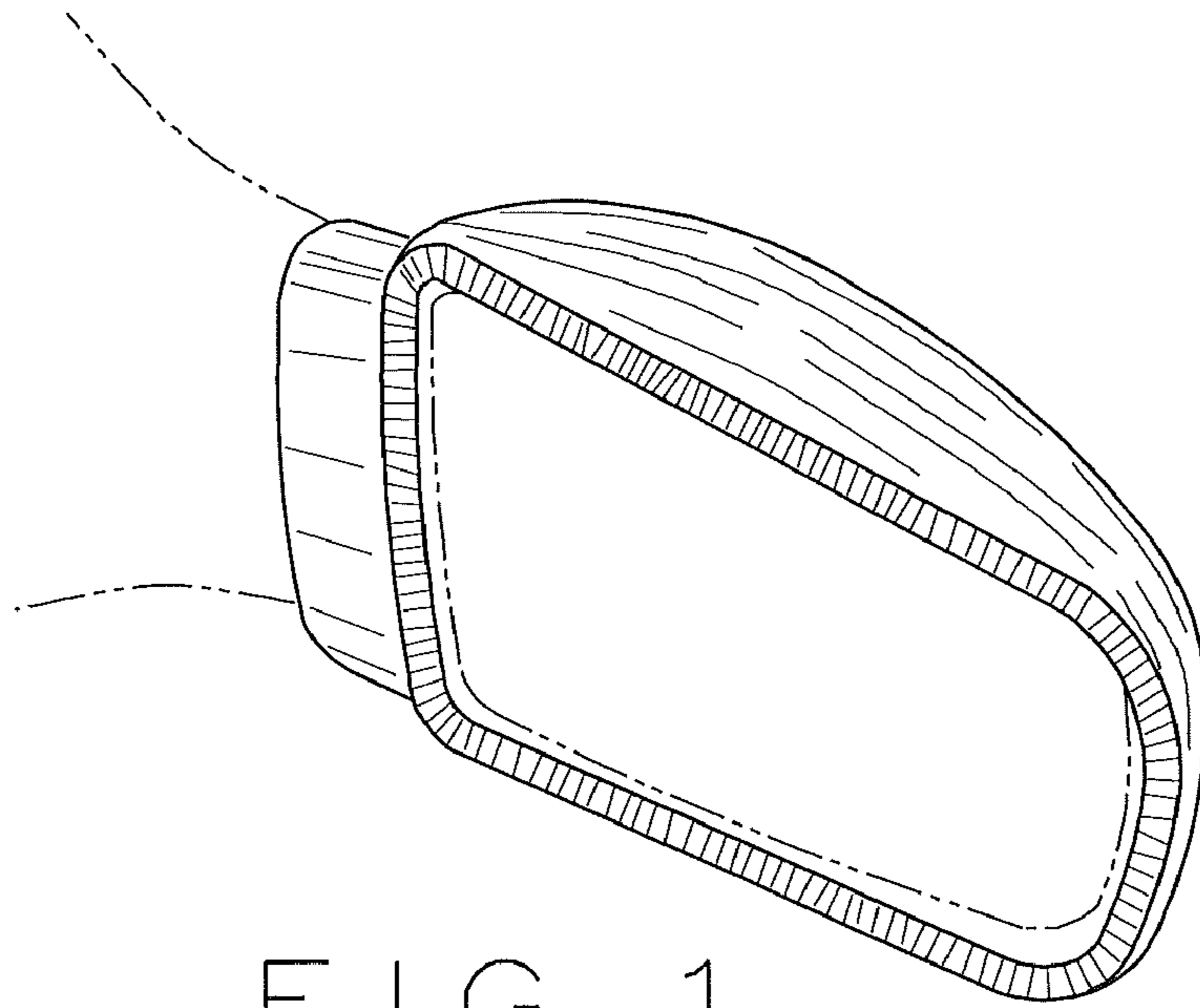

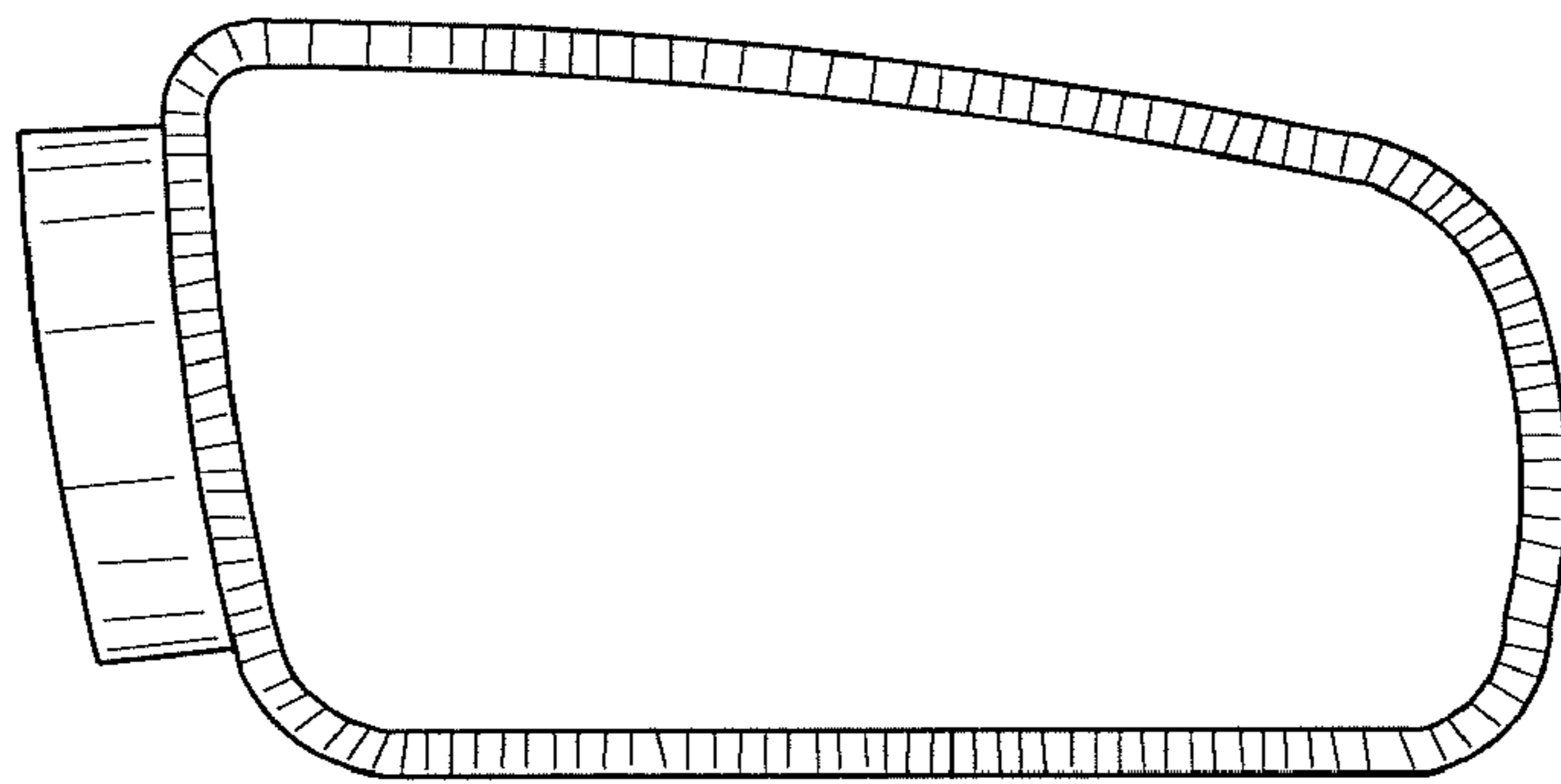

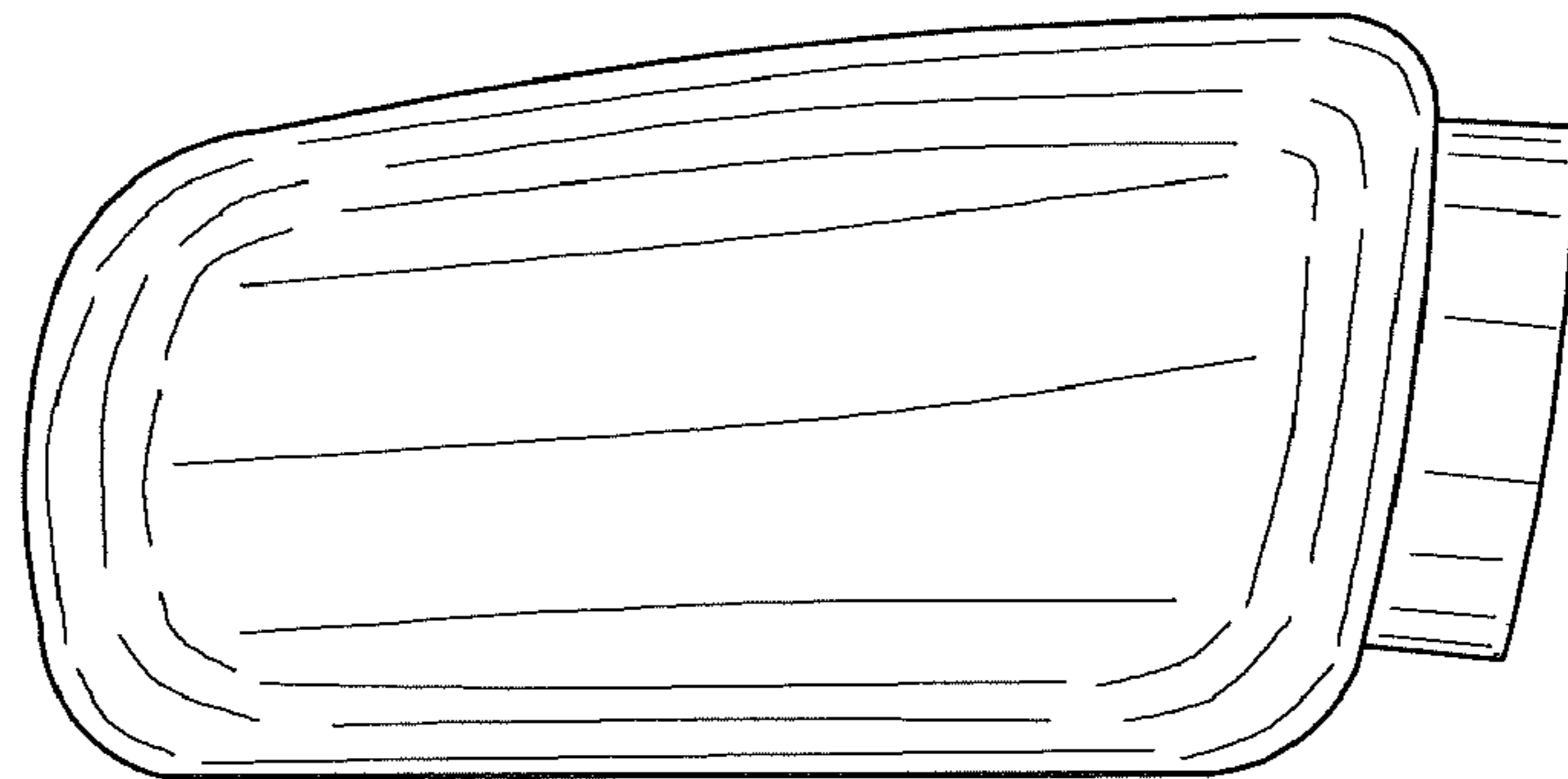

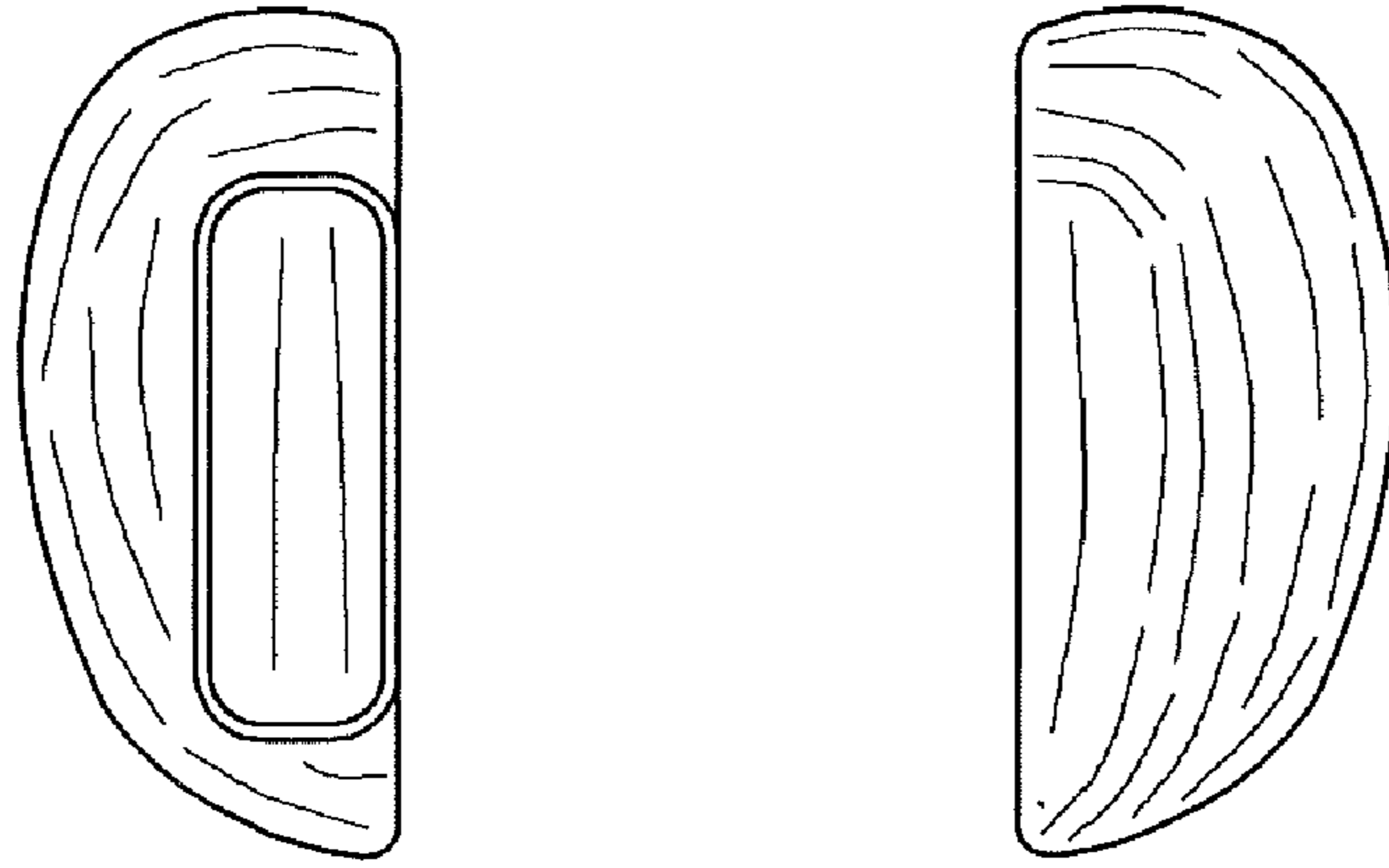

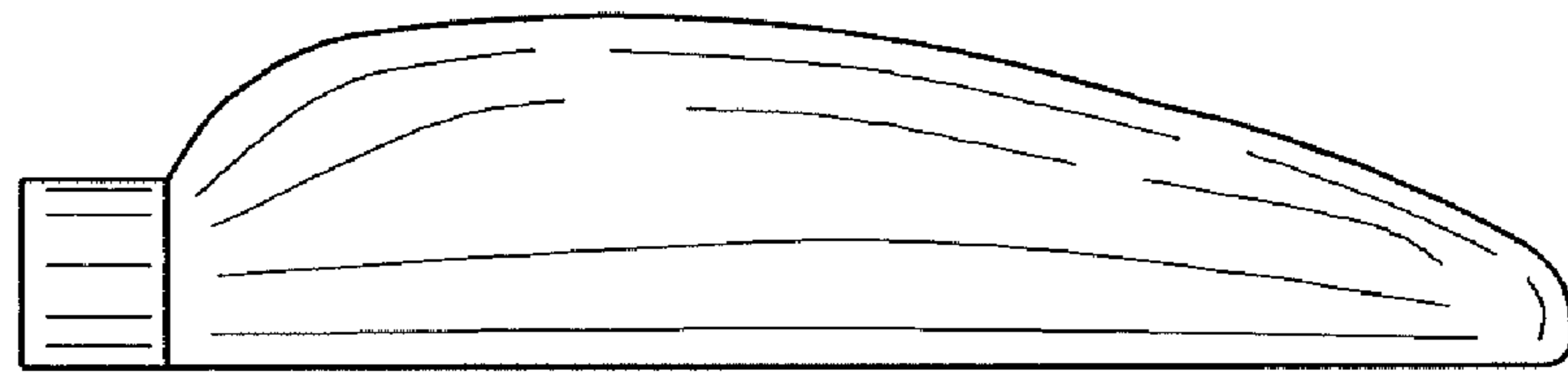

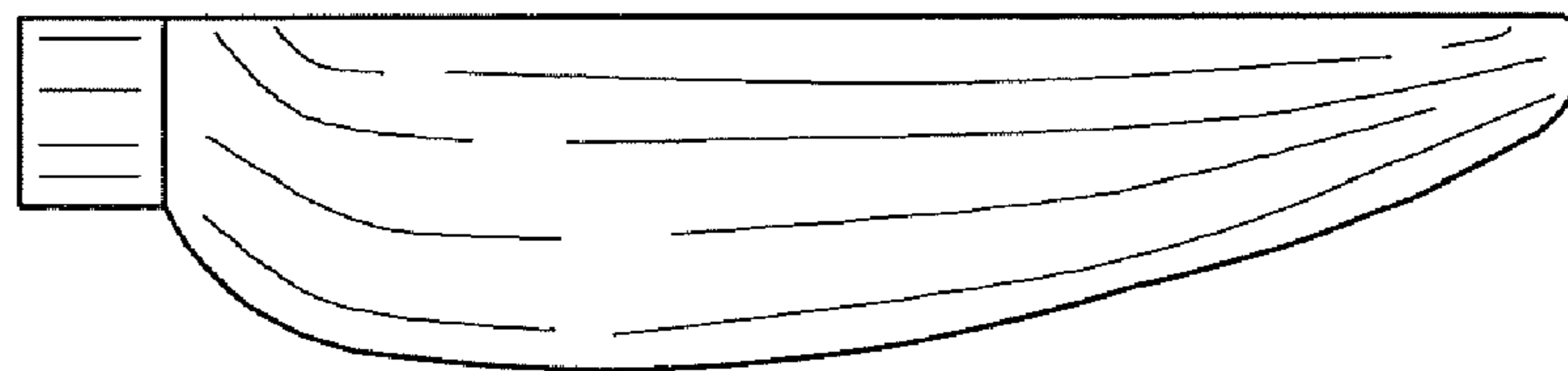

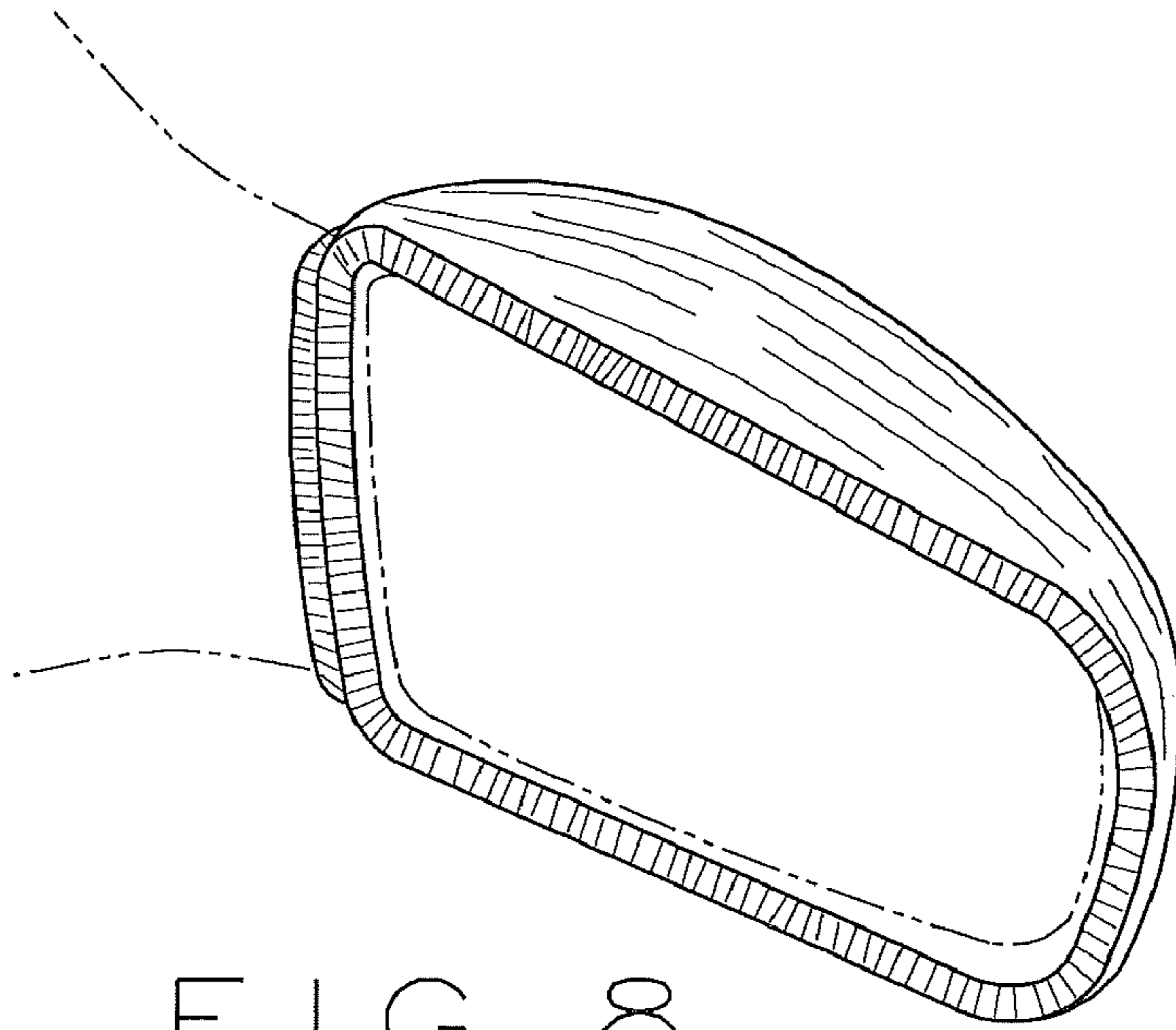

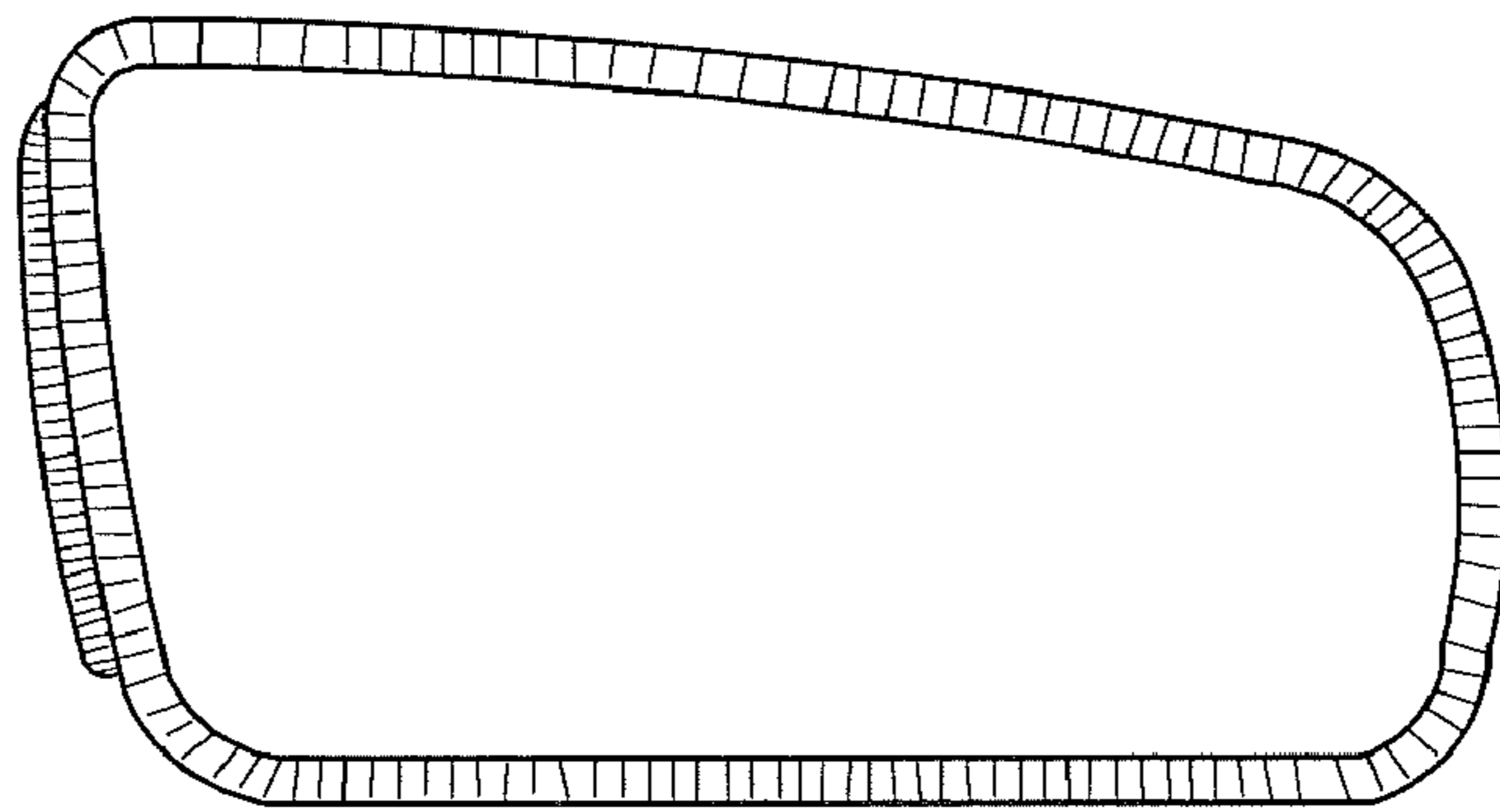

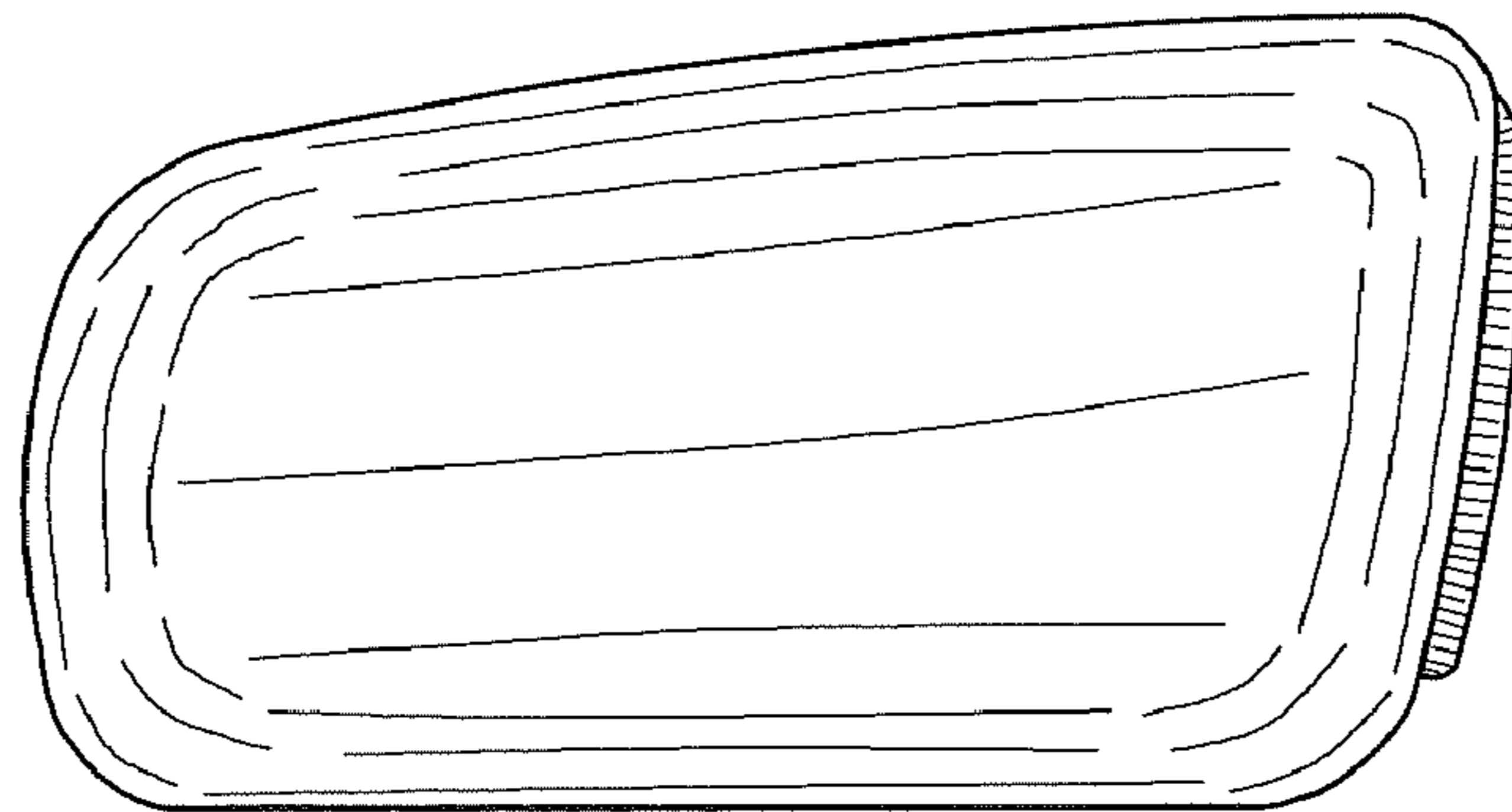

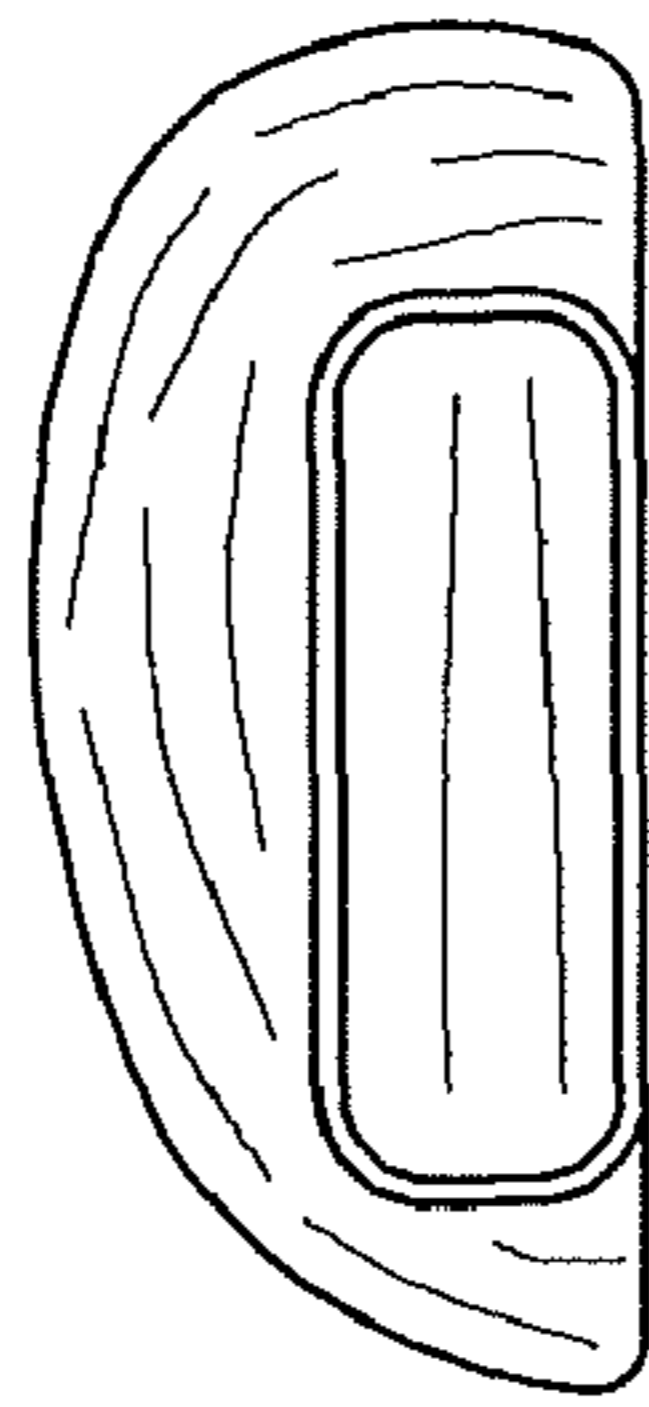

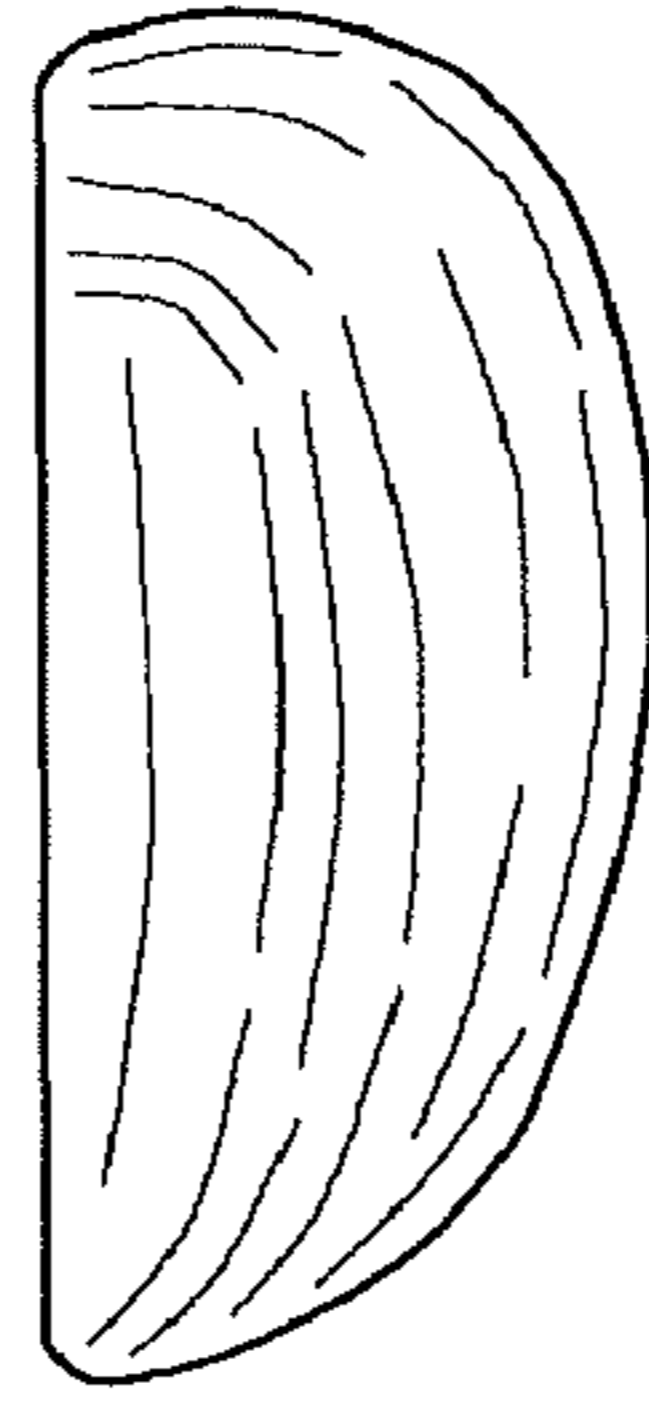

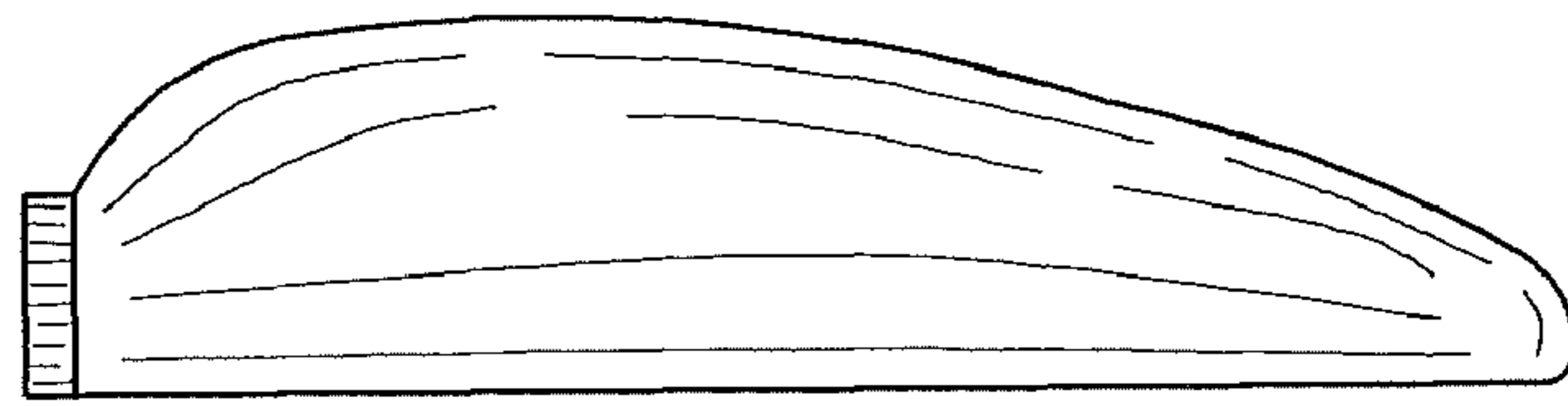

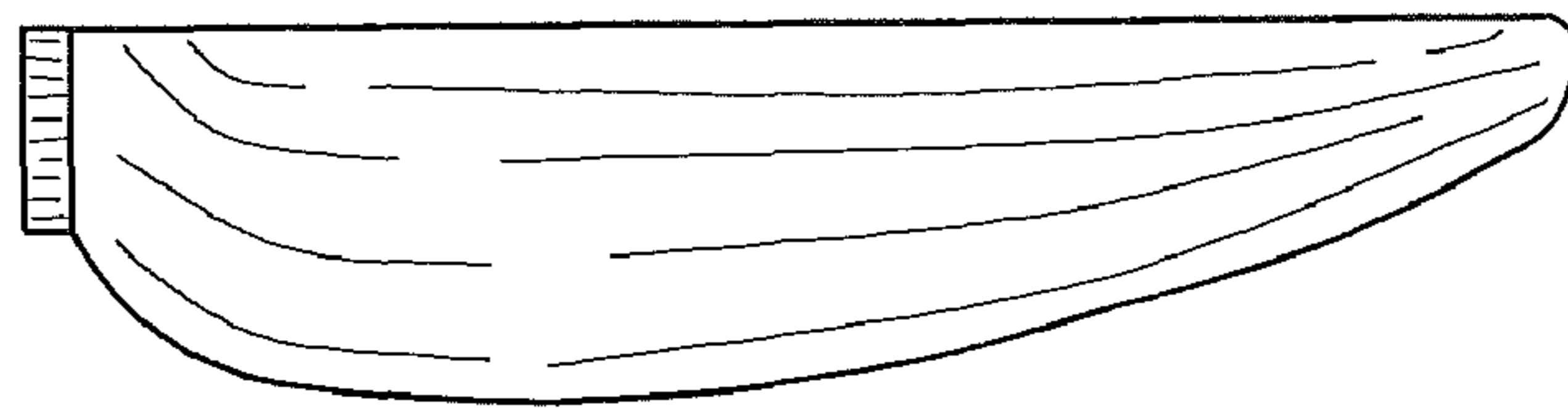
