DESCRIPTION

FIG. 1 is a bottom, front, perspective view of a cellular phone showing my new design;

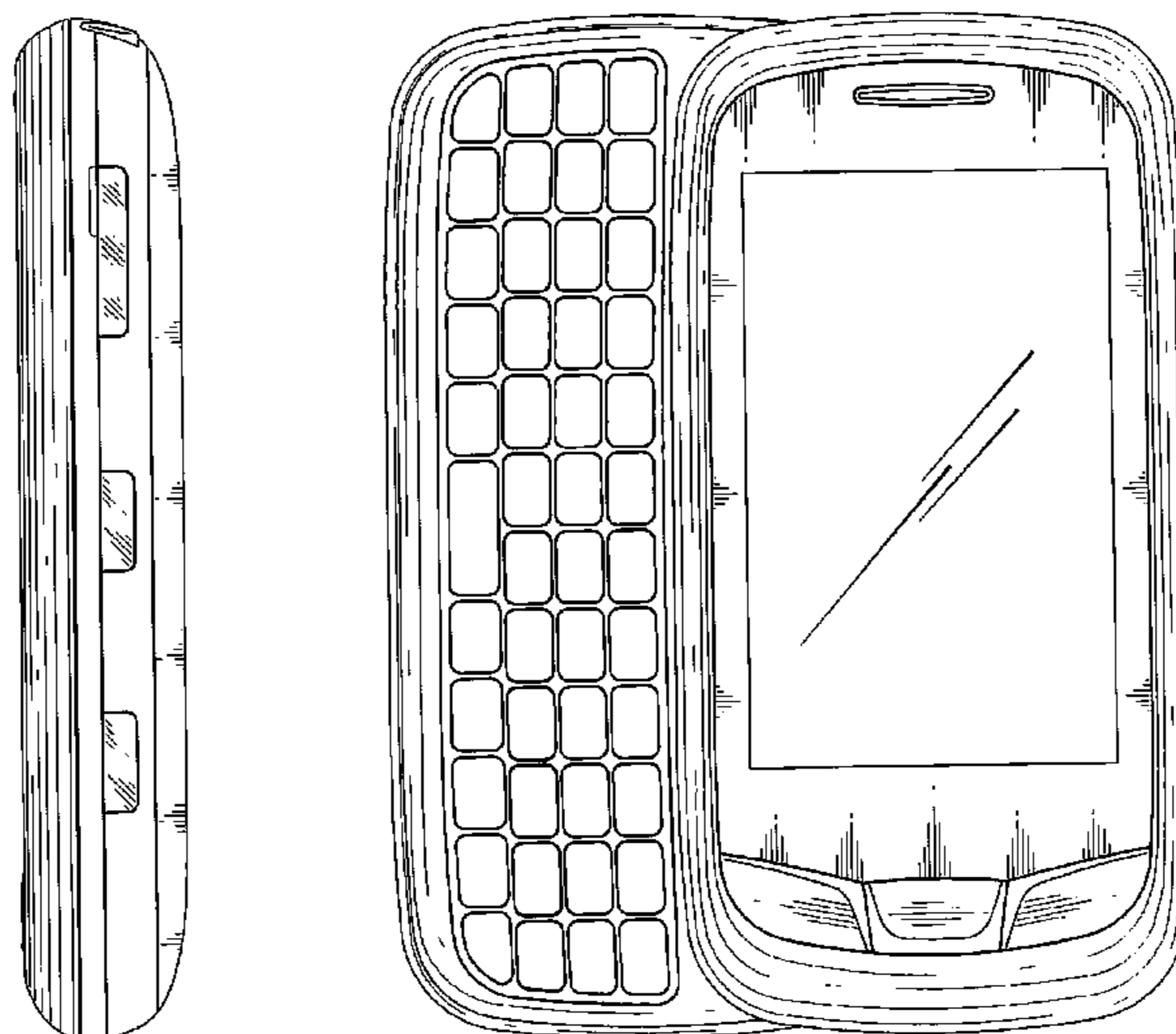

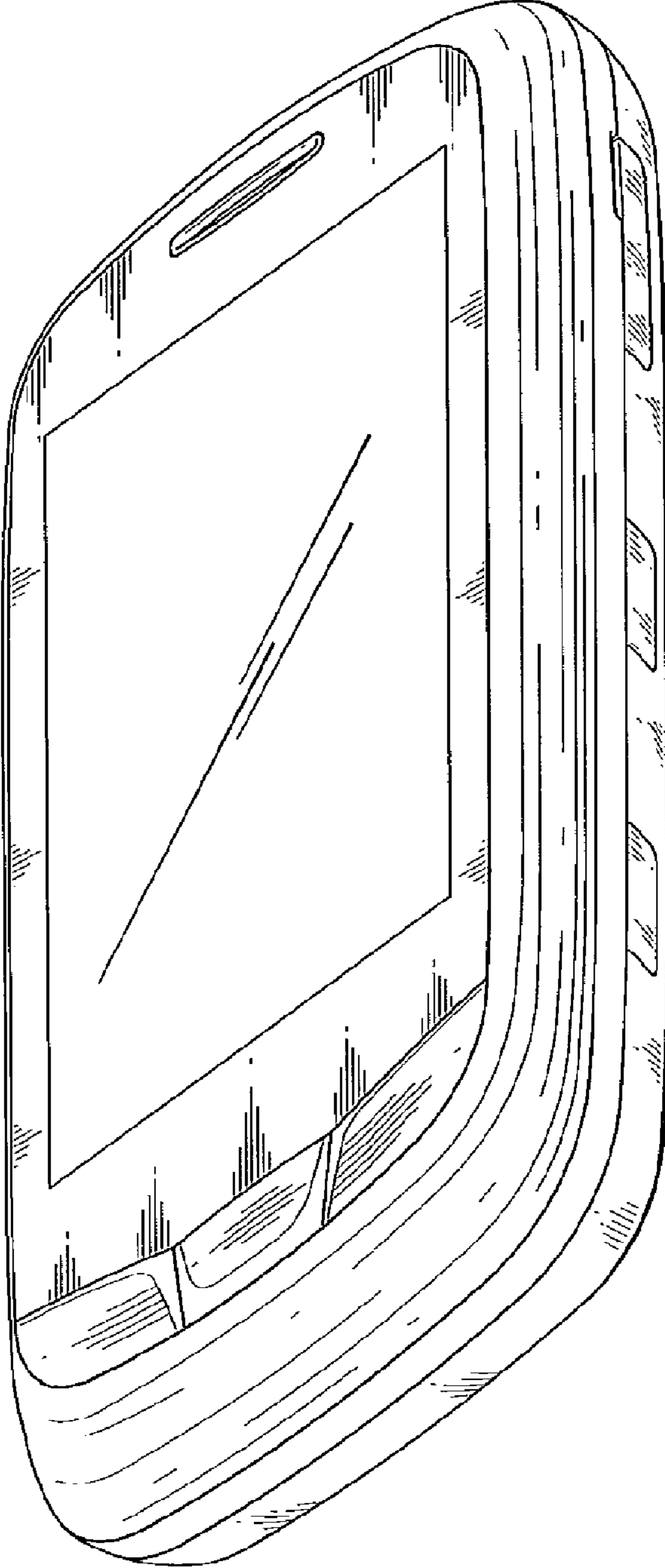

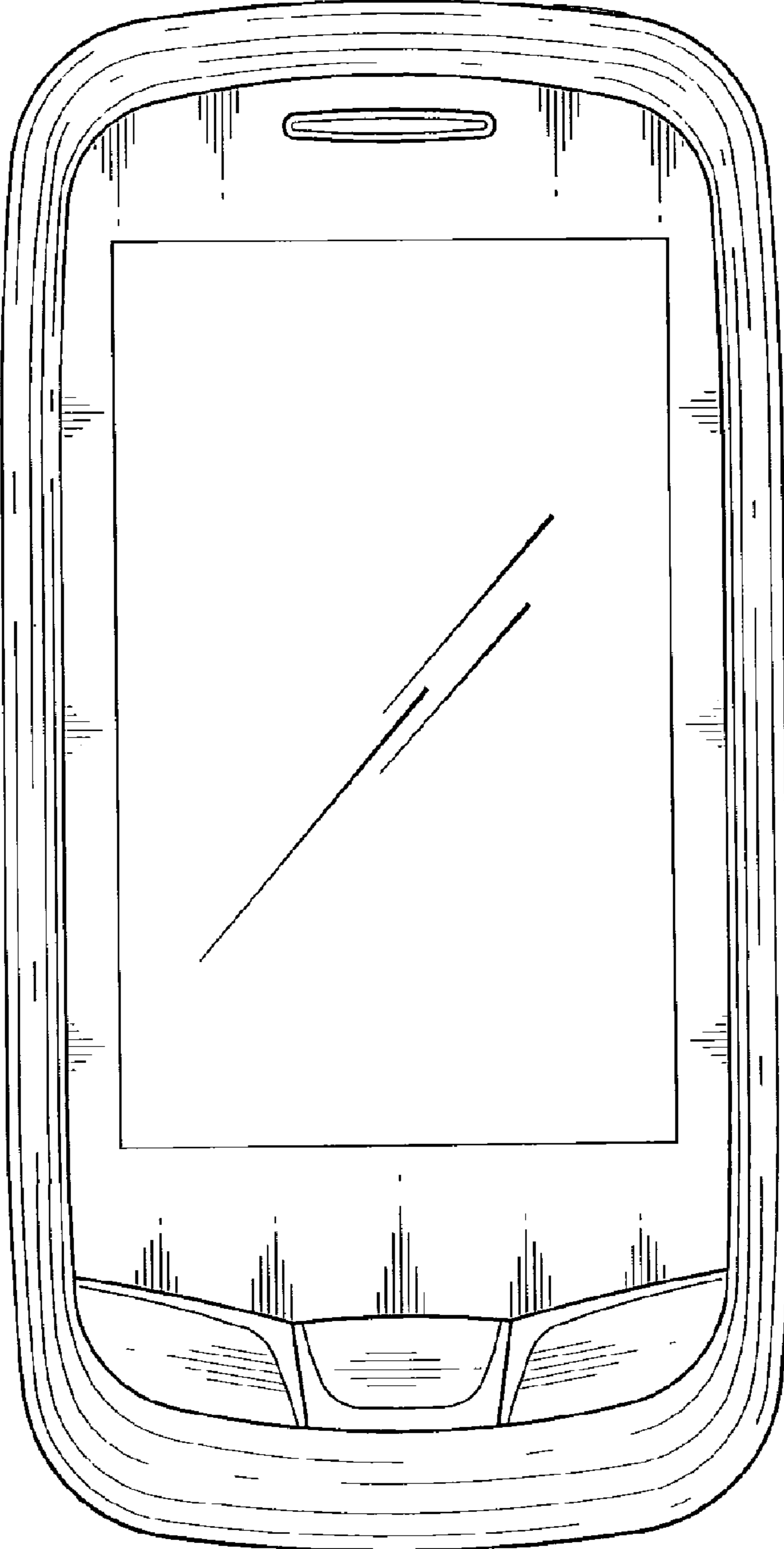

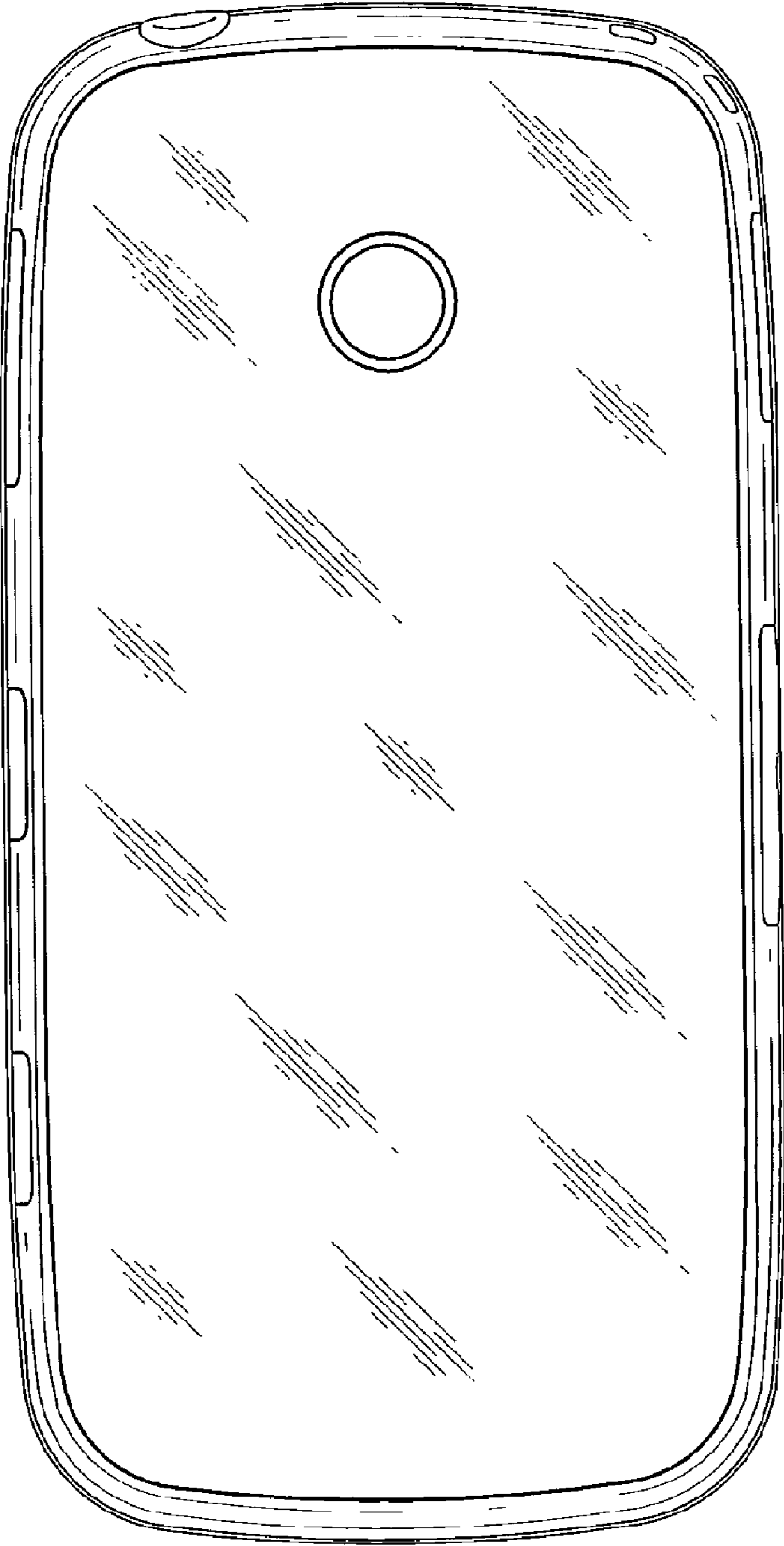

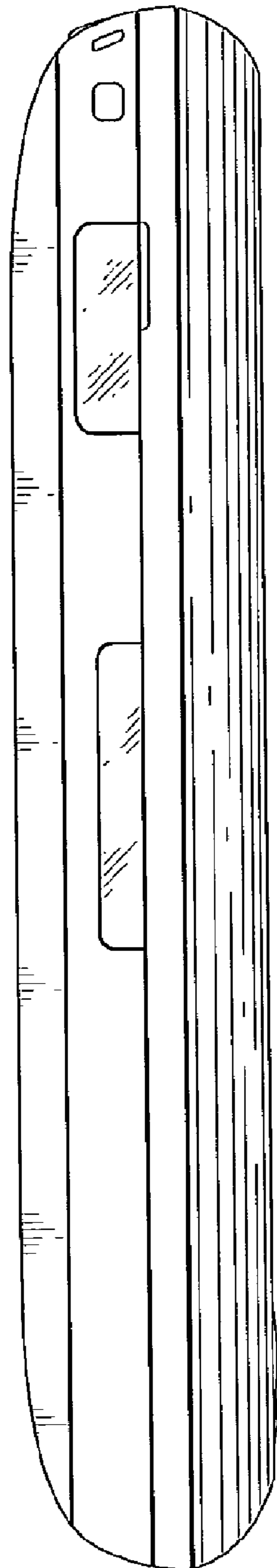

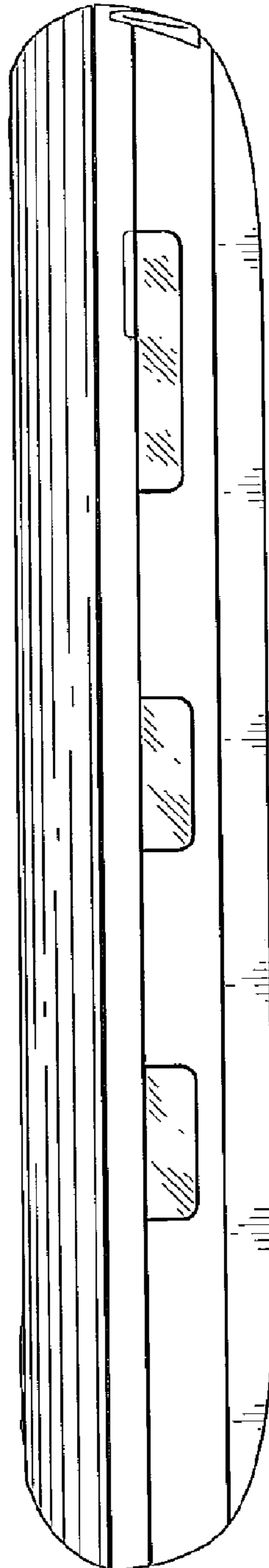

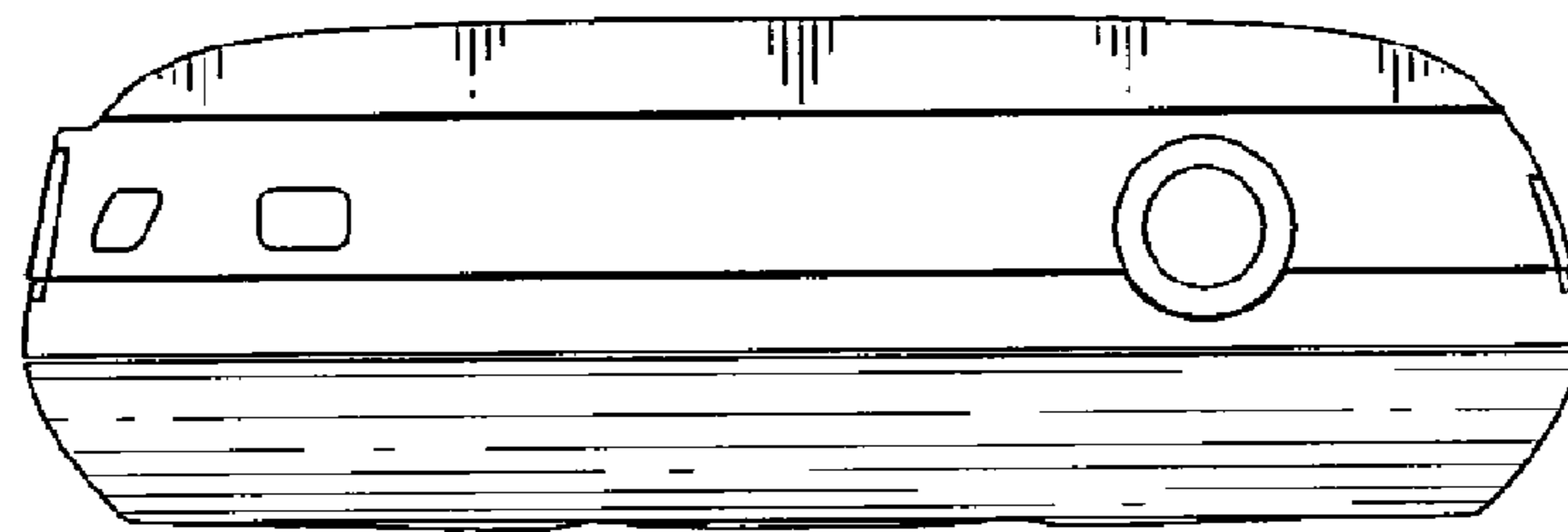

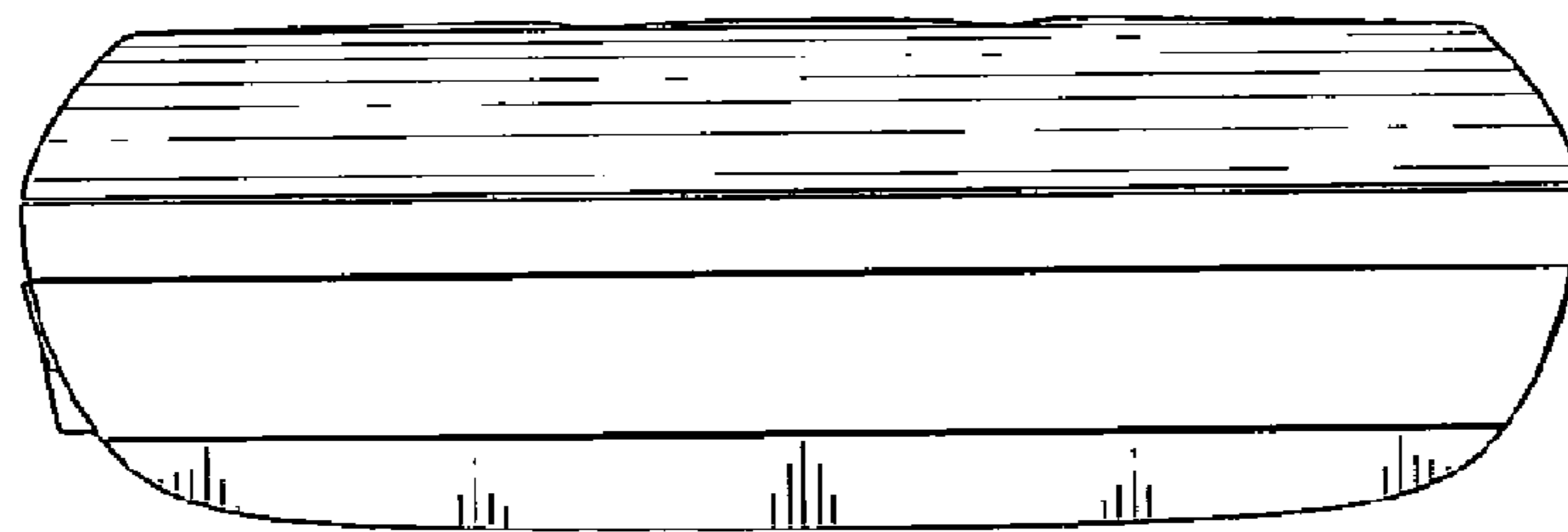
