FIG. 4 is a rear elevational view;

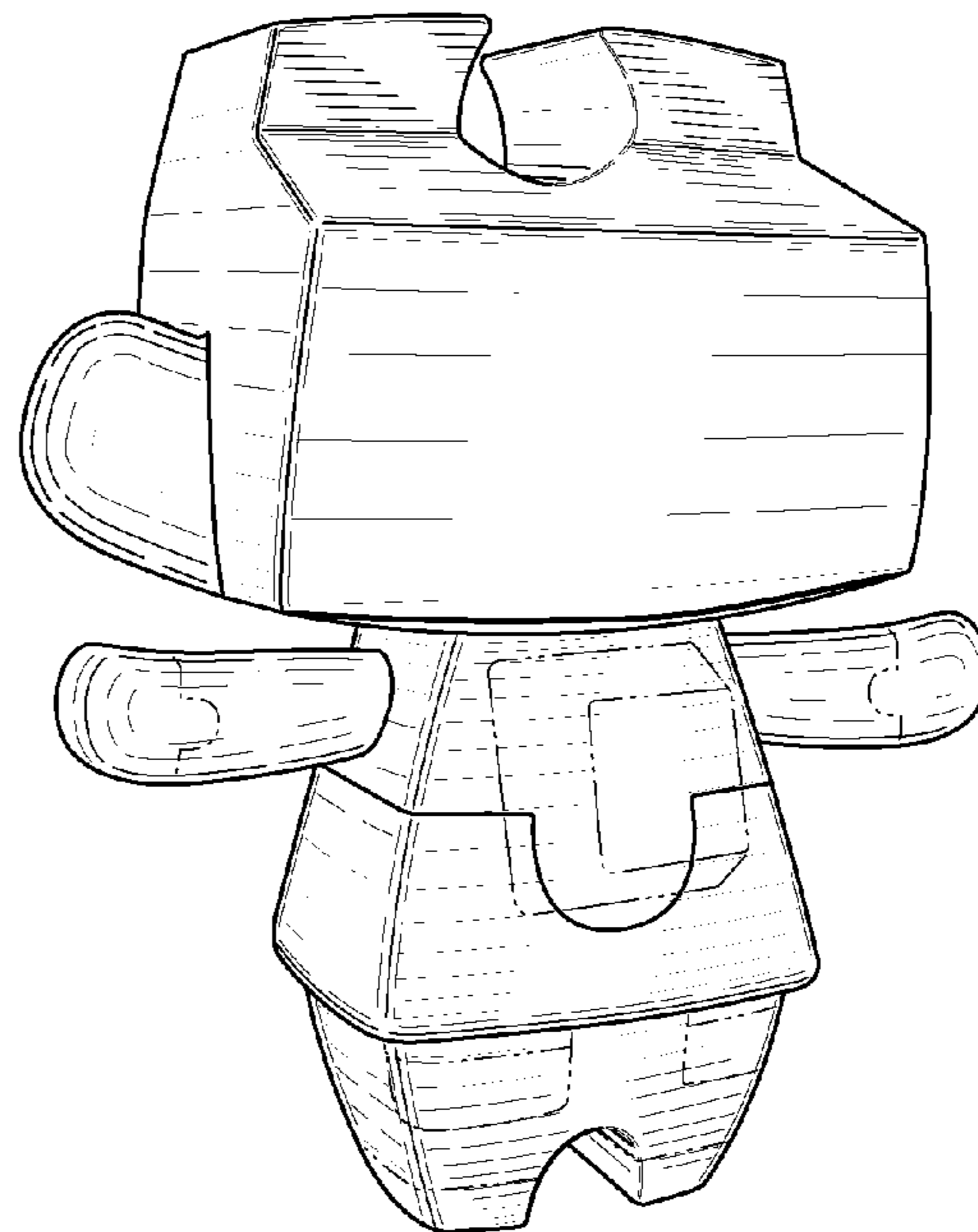
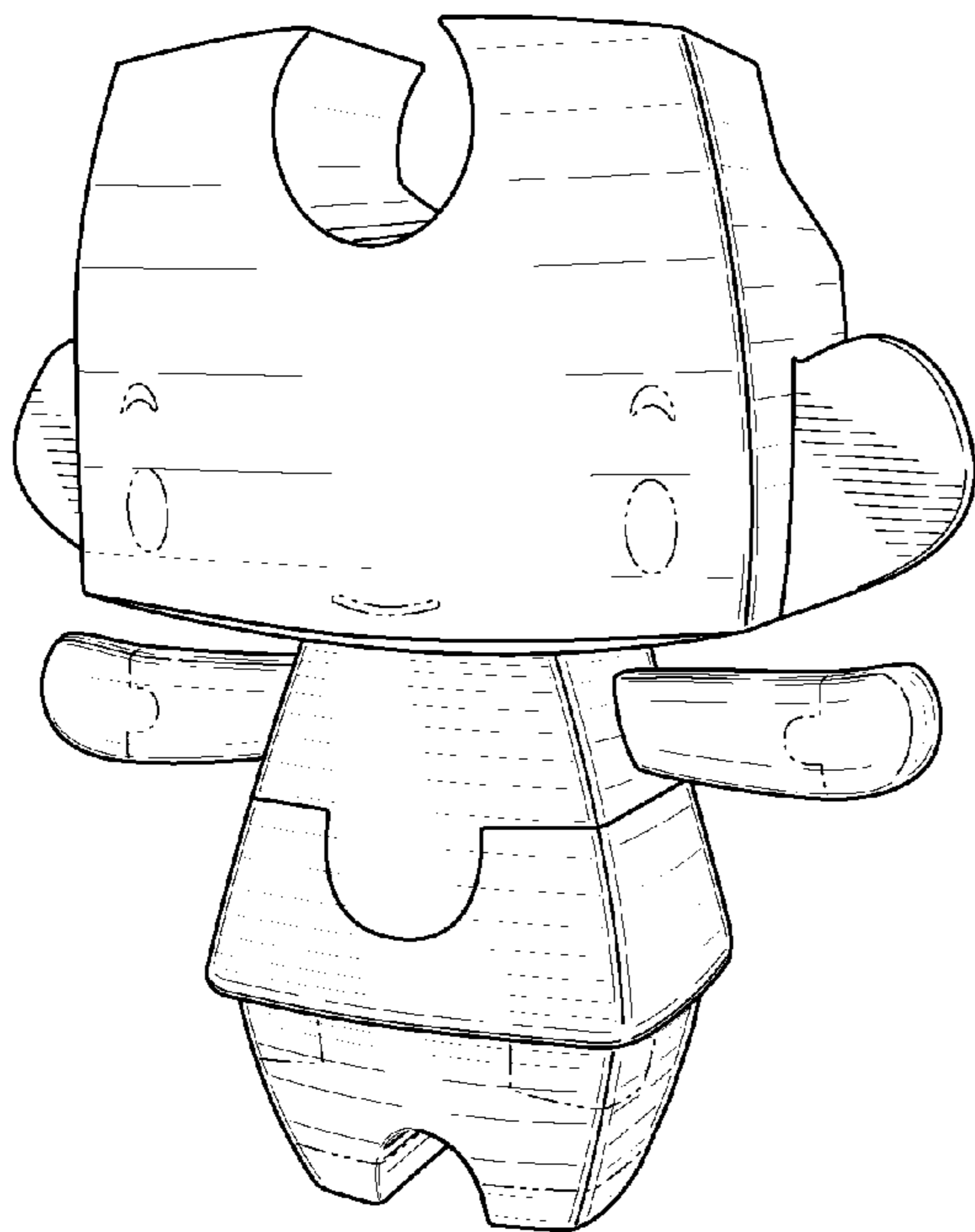
FIG. 5 is a left side elevational view (the right side being a mirror image thereof);

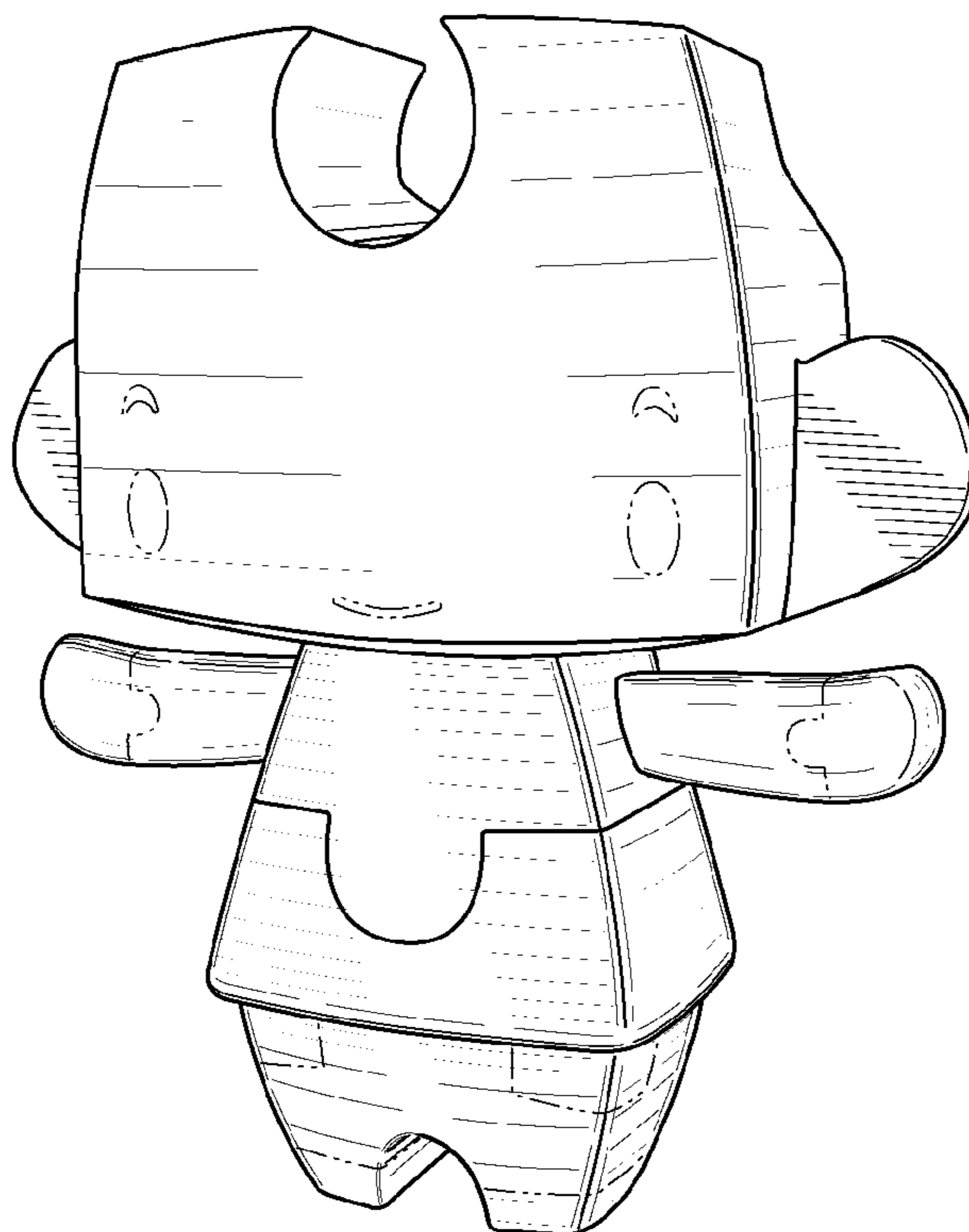

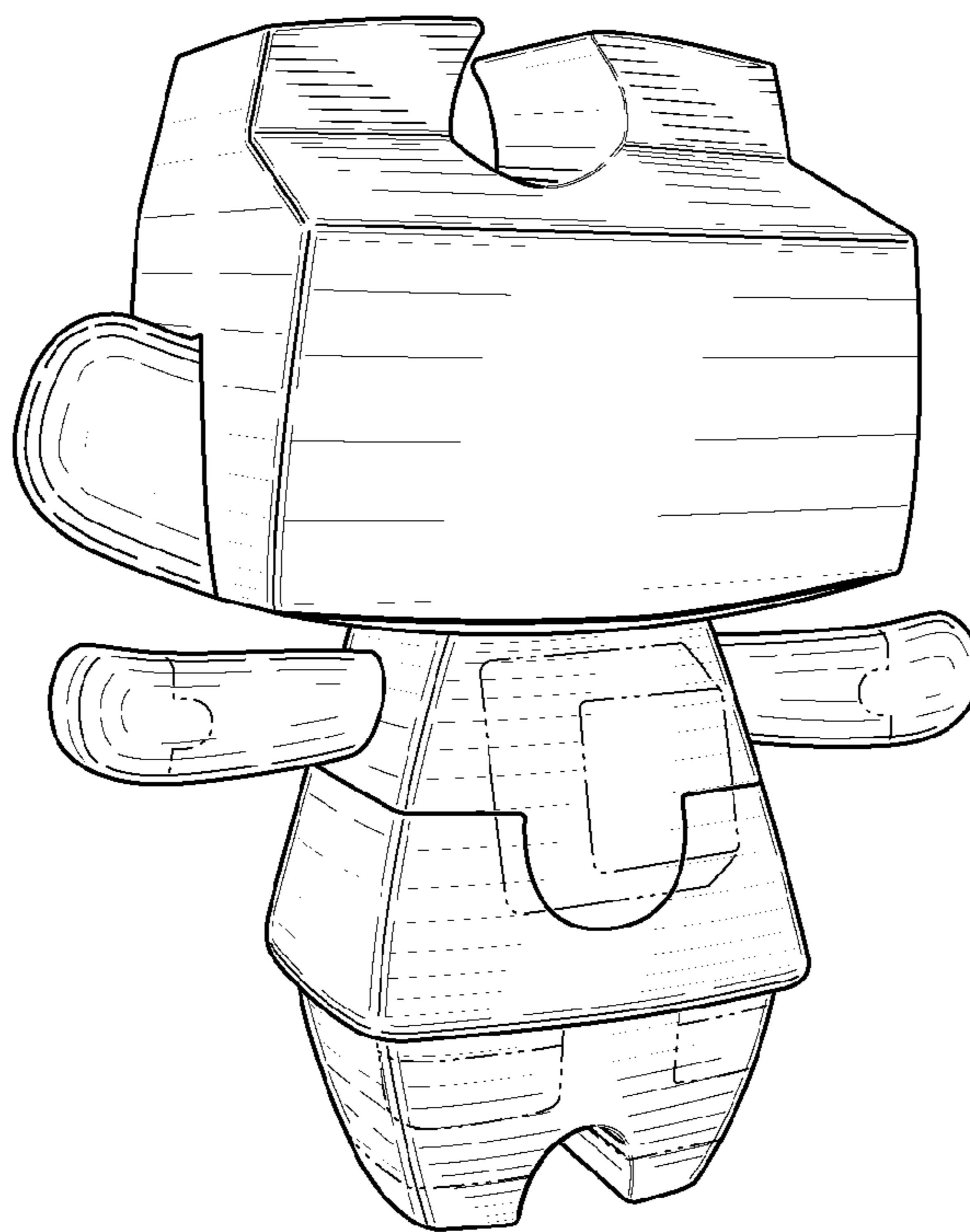

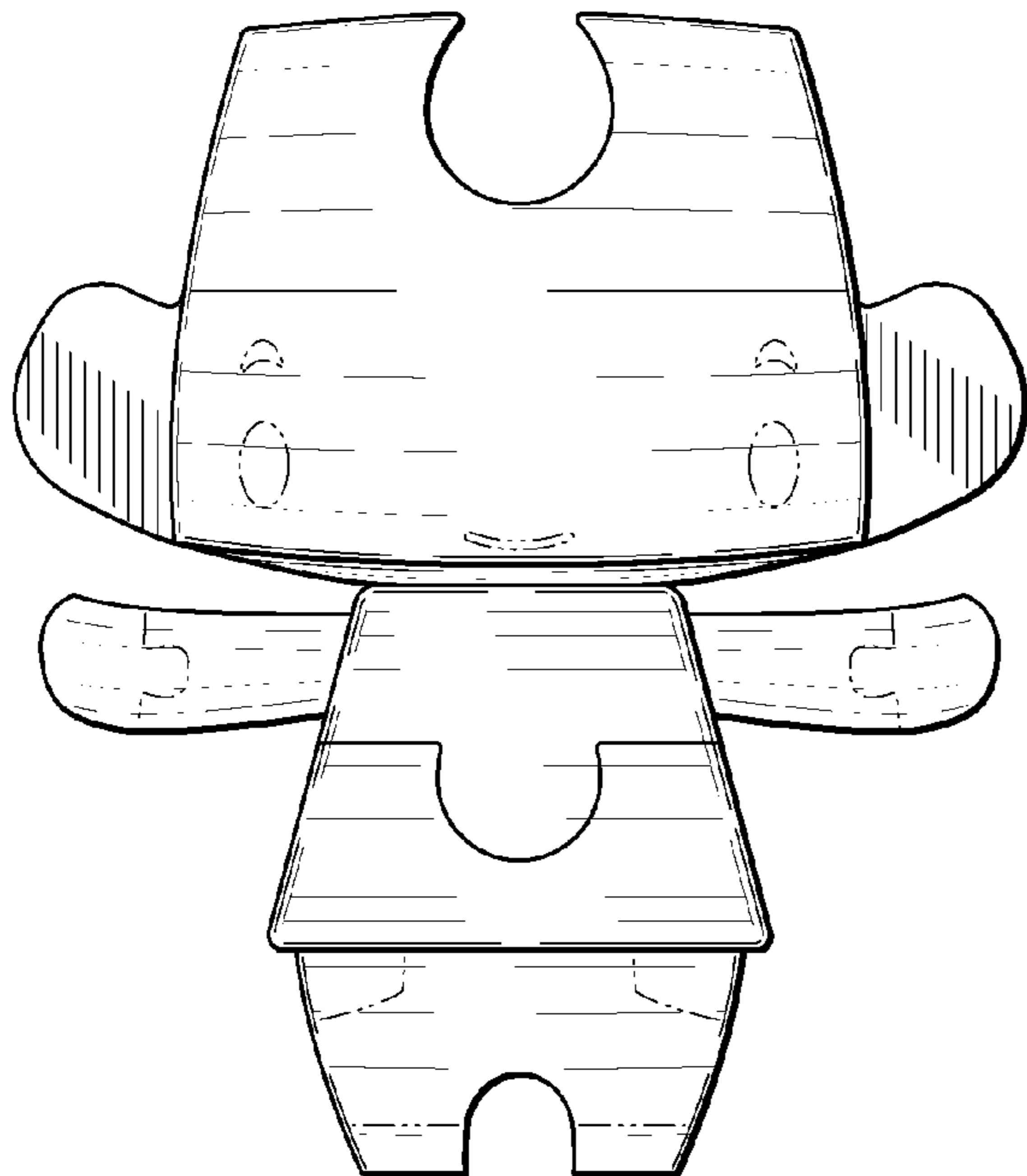

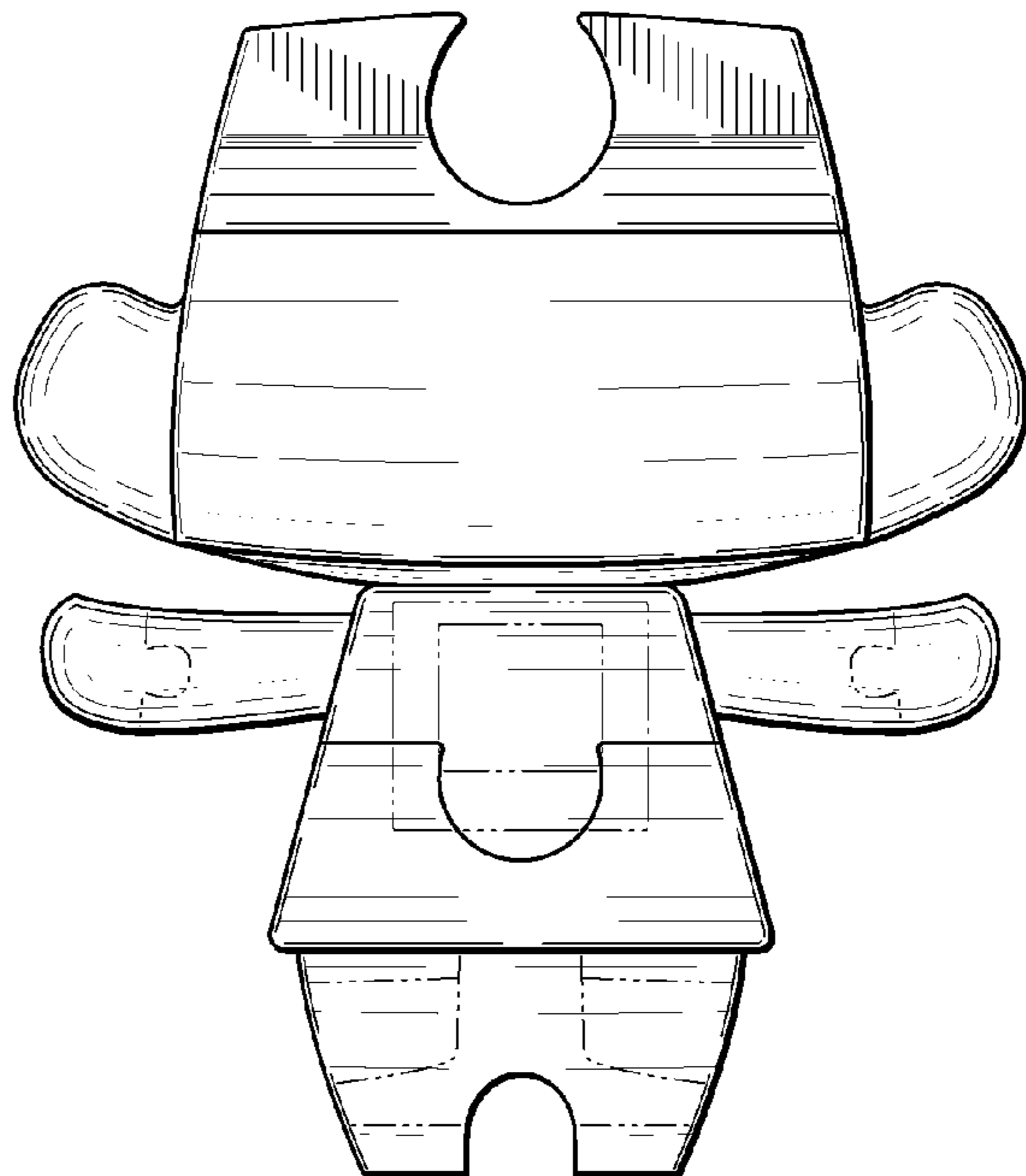

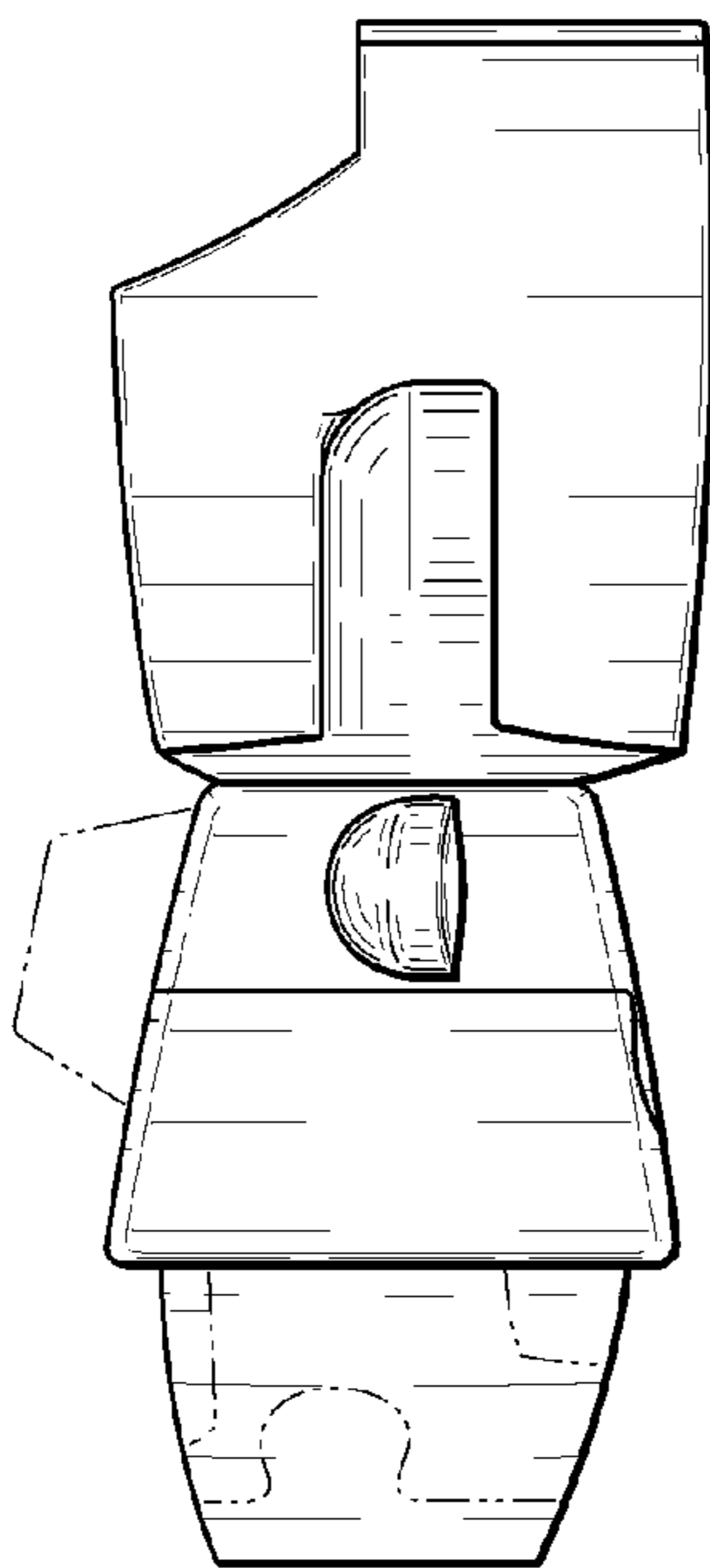

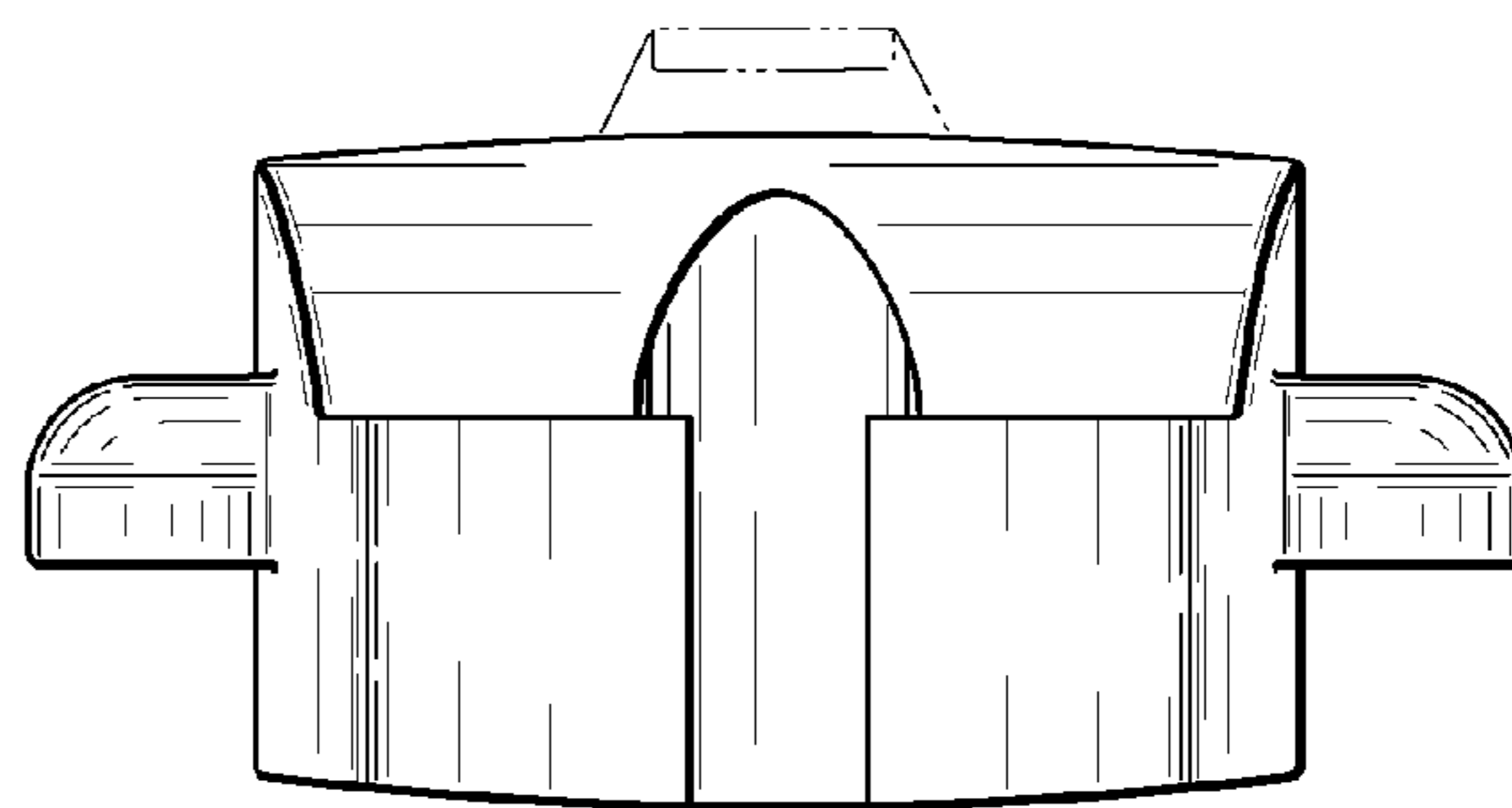

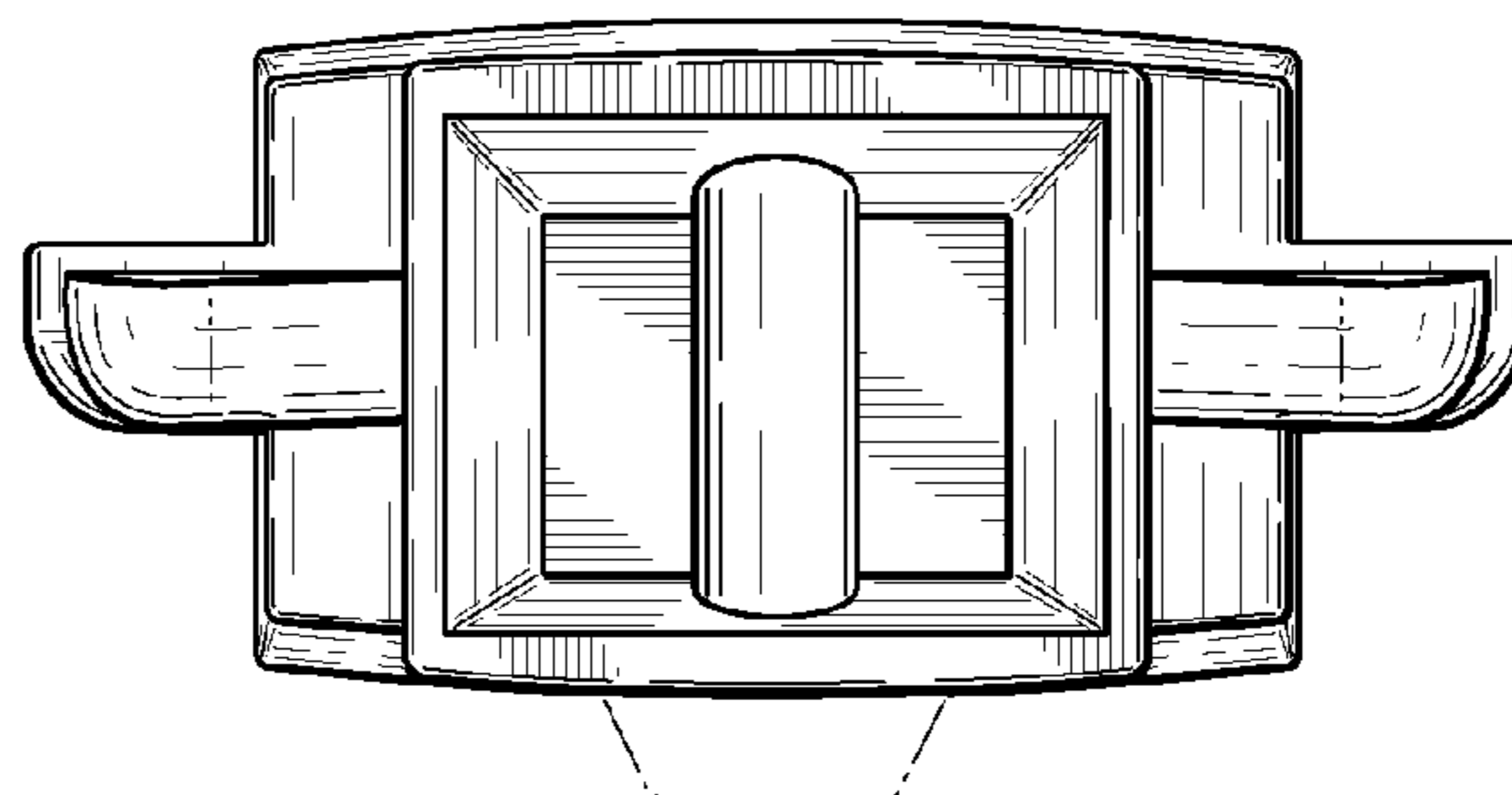
