(57) **CLAIM**

We claim the ornamental design for a pipe coupling segment,  
as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of our design for a pipe coupling  
segment;  
FIG. 2 is a front view of the design for the pipe coupling  
segment shown in FIG. 1, the rear view being identical;  
FIG. 3 is a top view of the design for the pipe coupling  
segment shown in FIG. 1;  
FIG. 4 is a bottom view of the design for the pipe coupling  
segment shown in FIG. 1; and,  
FIG. 5 is a left side view of the design for the pipe coupling  
segment shown in FIG. 1, the right side view being identical.  
The broken lines shown in FIGS. 1 through 5 are for illustra-  
tive purposes only and form no part of the claimed design.
