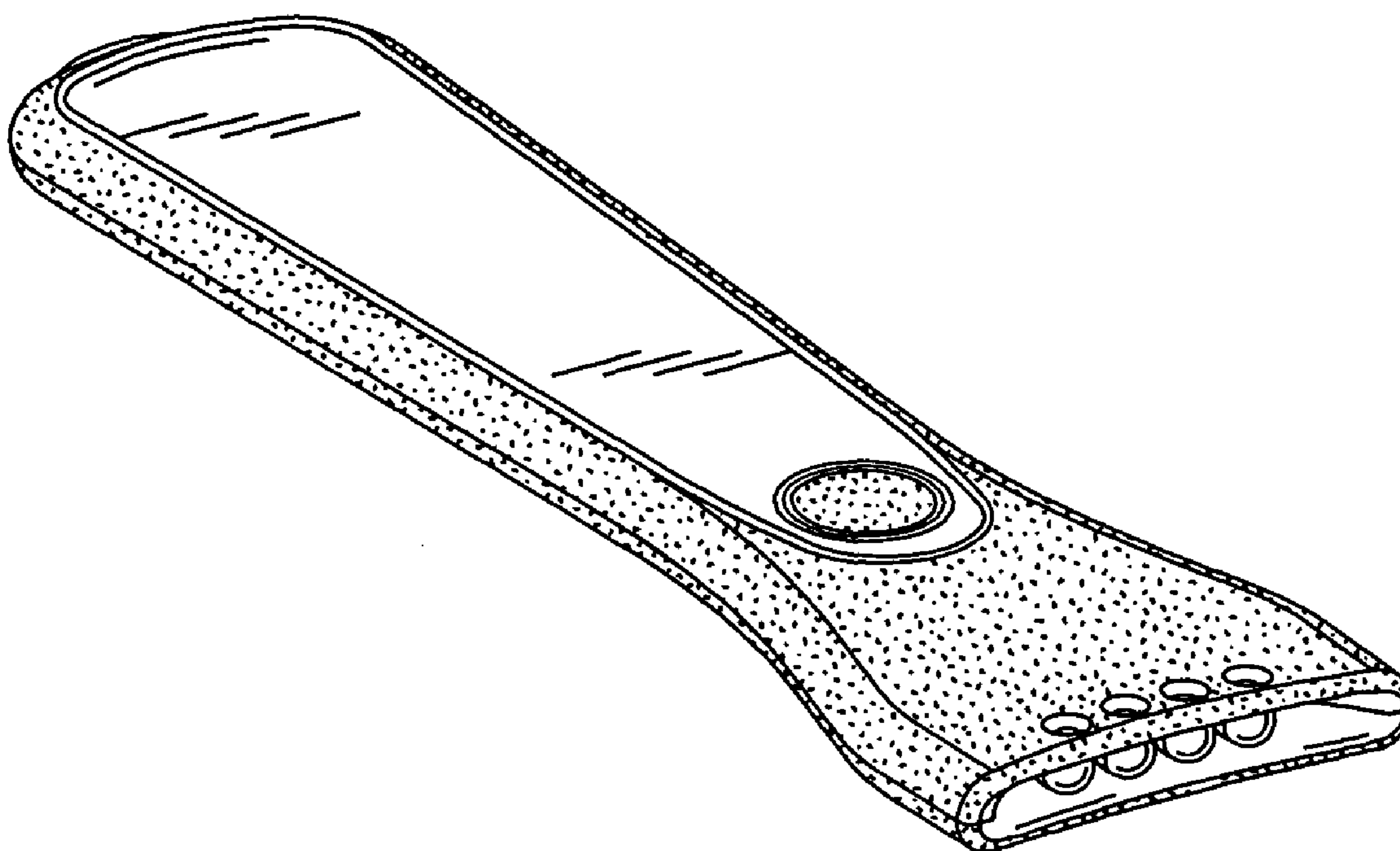
(57) **CLAIM**

The ornamental design for a flash light, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a flash light showing our new design and featuring the top, front and right sides thereof; FIG. 2 is a perspective view of the flash light of FIG. 1, and featuring the bottom, left, rear and sides thereof; FIG. 3 is an disassembled perspective view of the flash light of FIG. 1, and featuring the top, front and right sides thereof; FIG. 4 is a top view thereof; FIG. 5 is a front view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a right side view thereof; and, FIG. 9 is a left side view thereof.

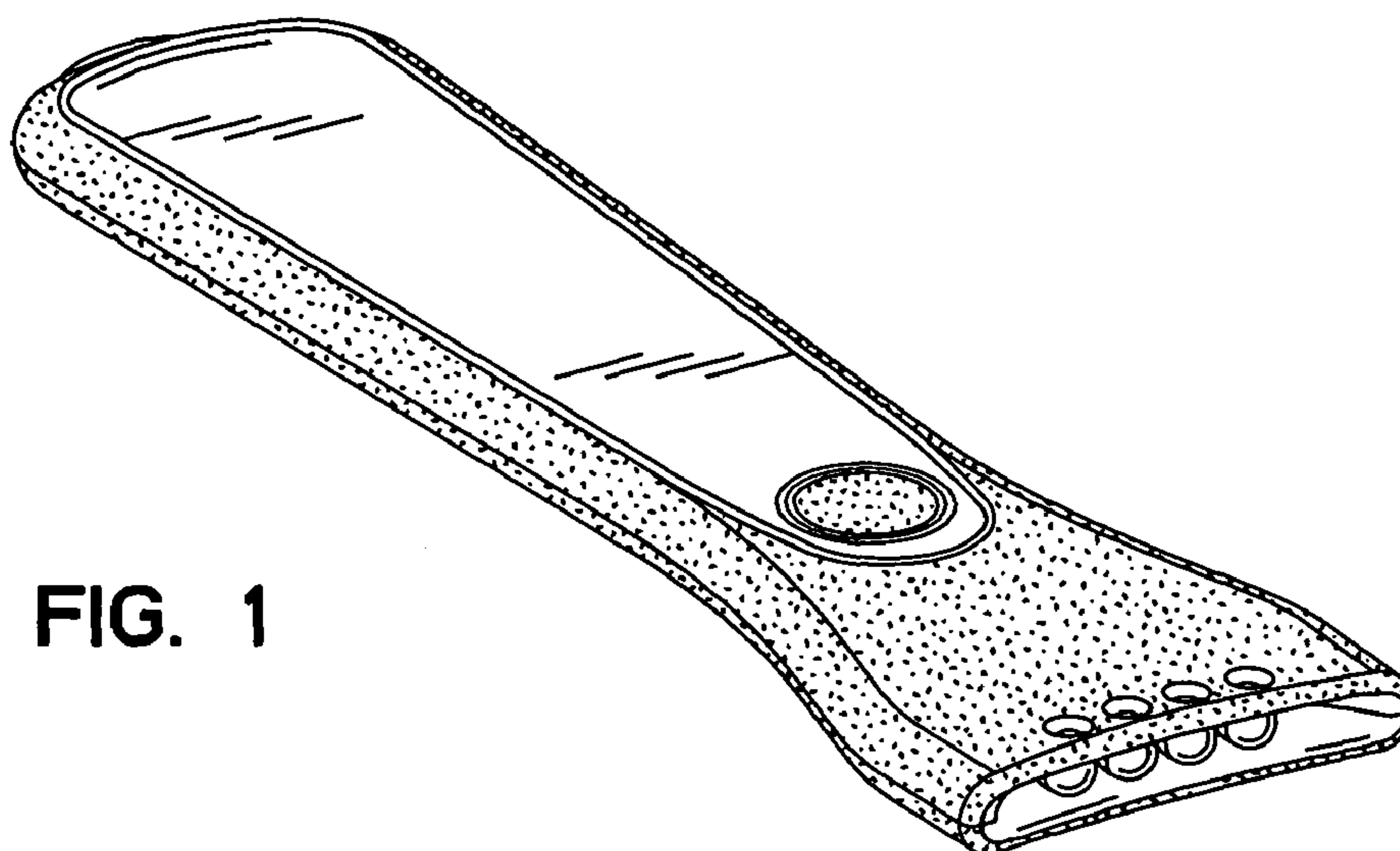

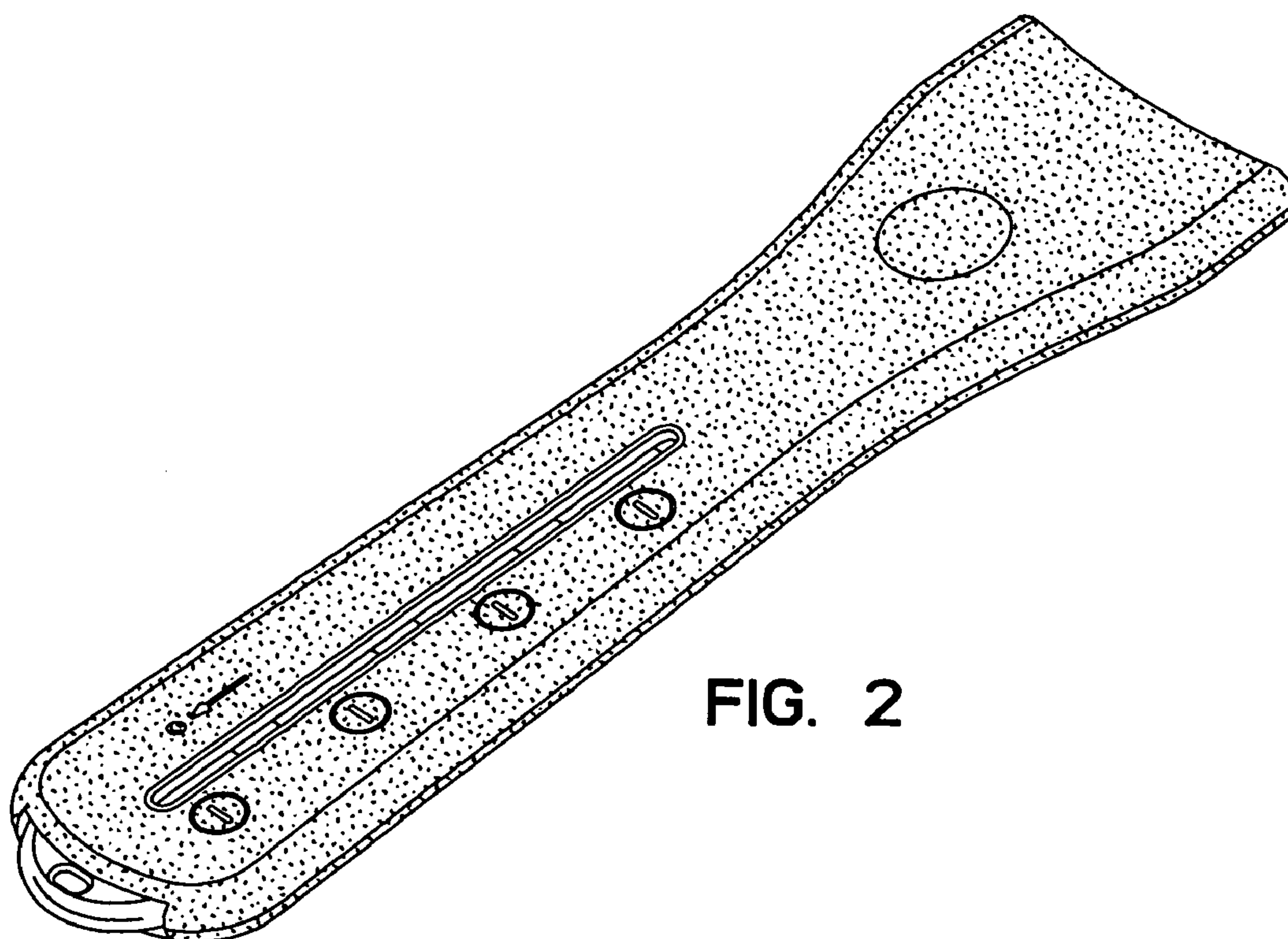

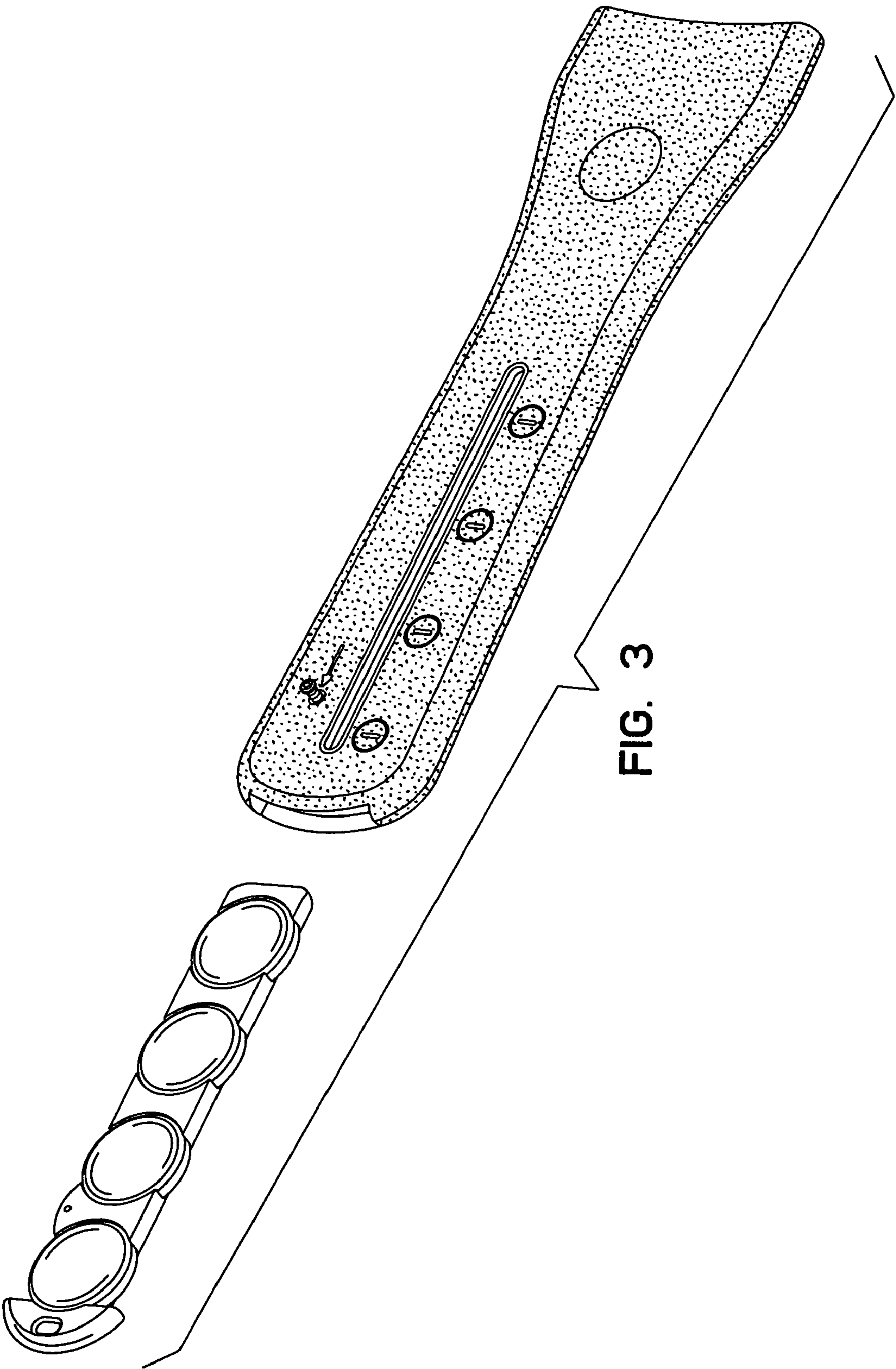

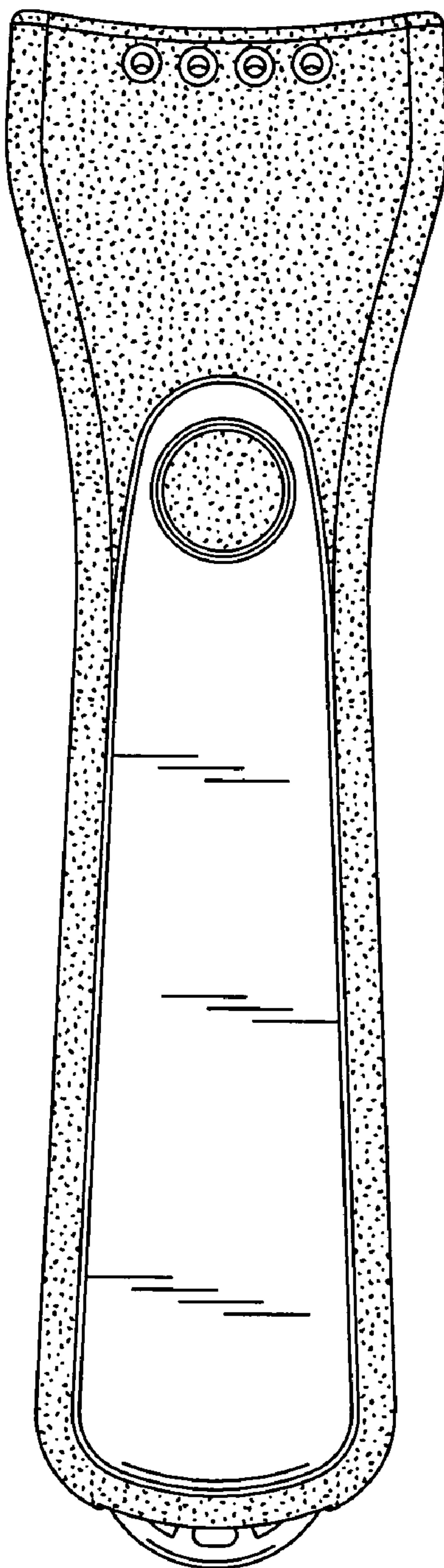

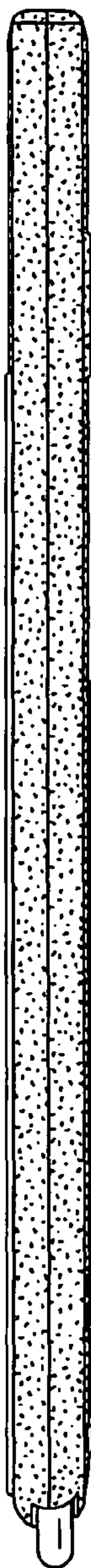

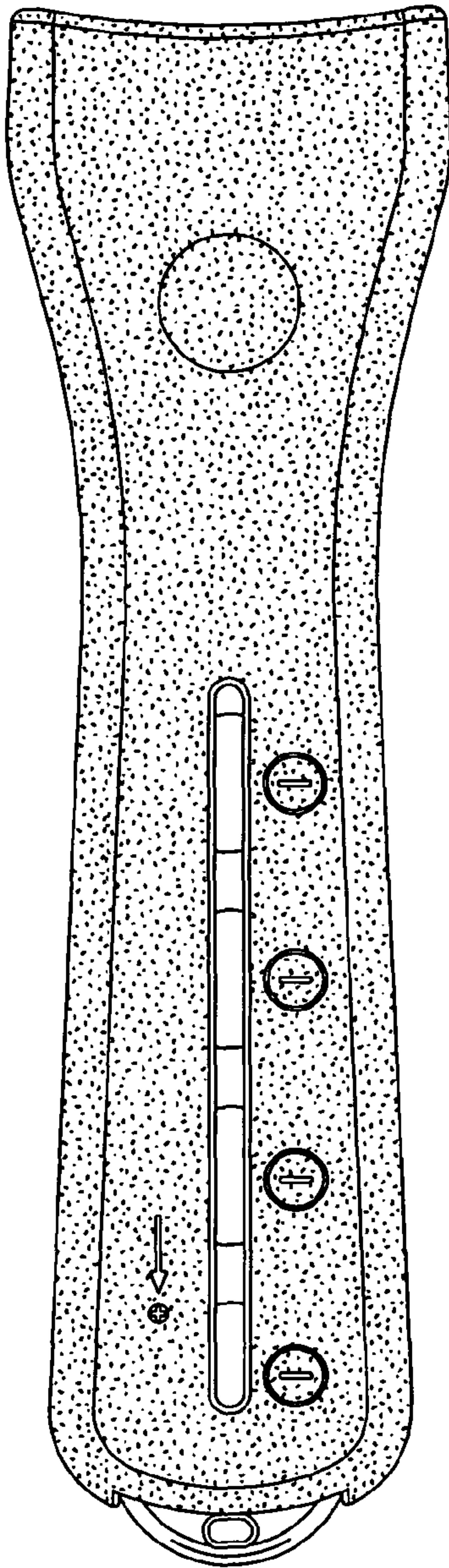

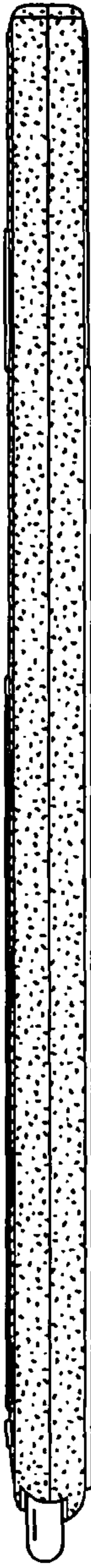
