(57) **CLAIM**

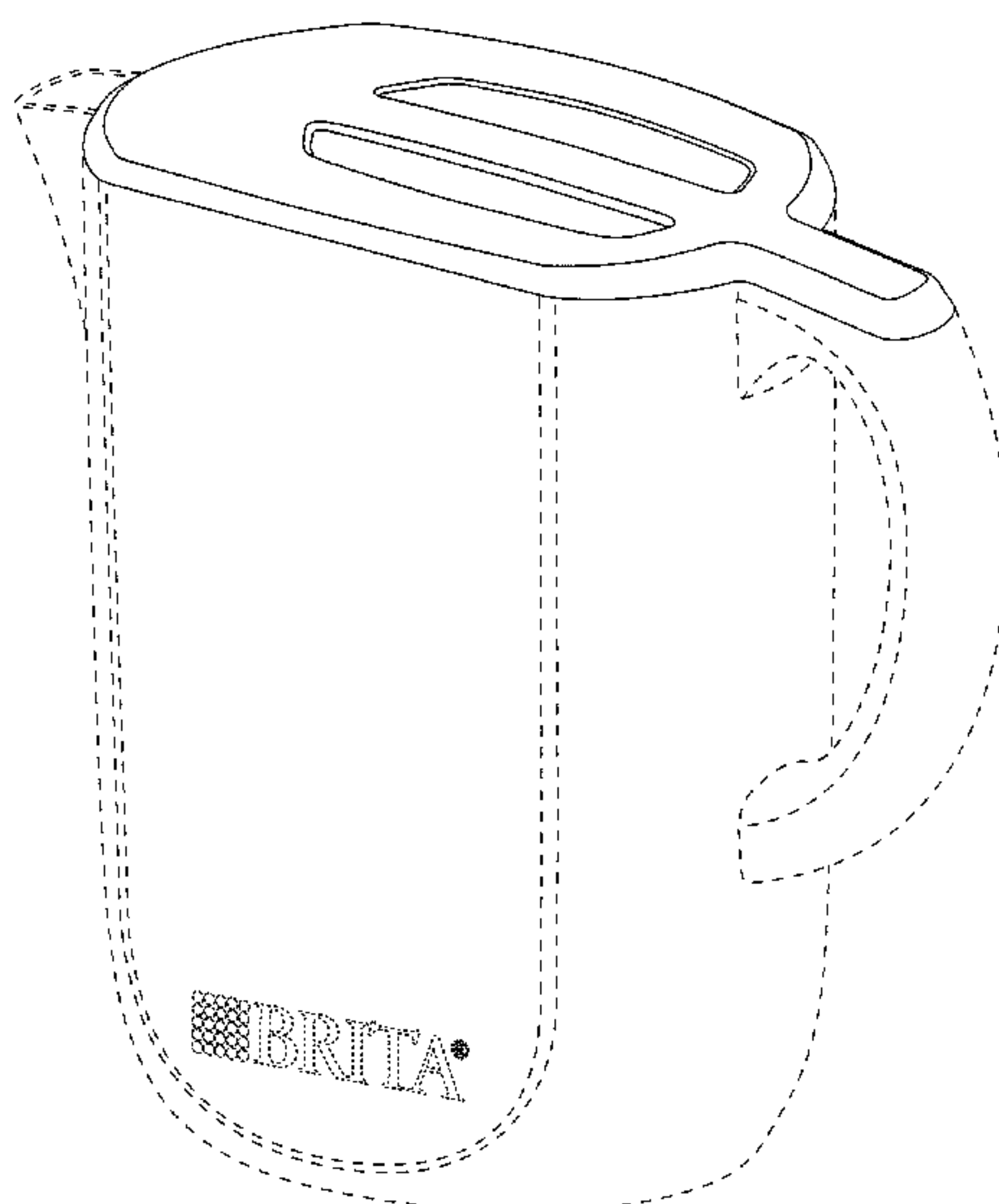
The ornamental design for a lid for a water pitcher, as shown and described.

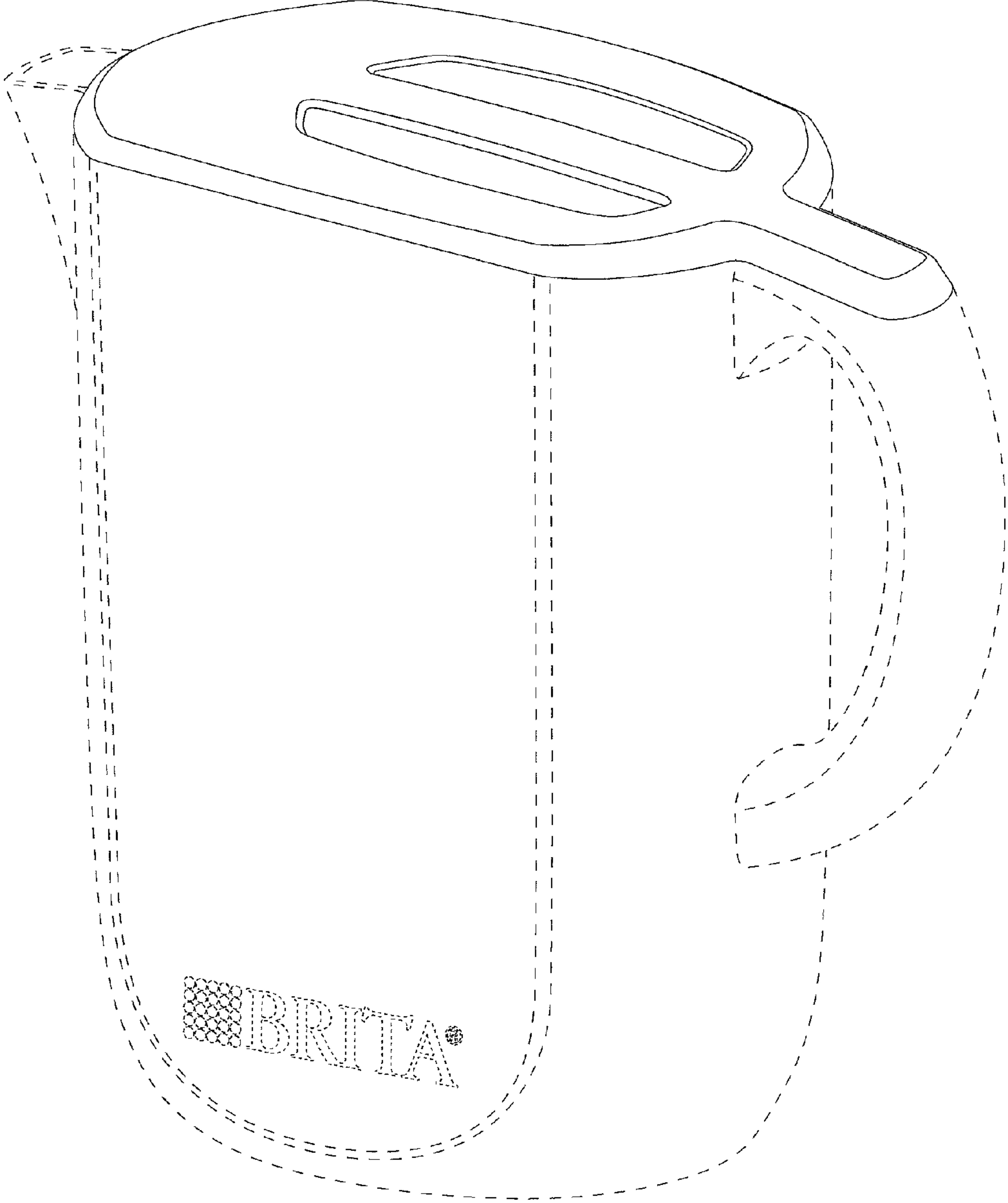

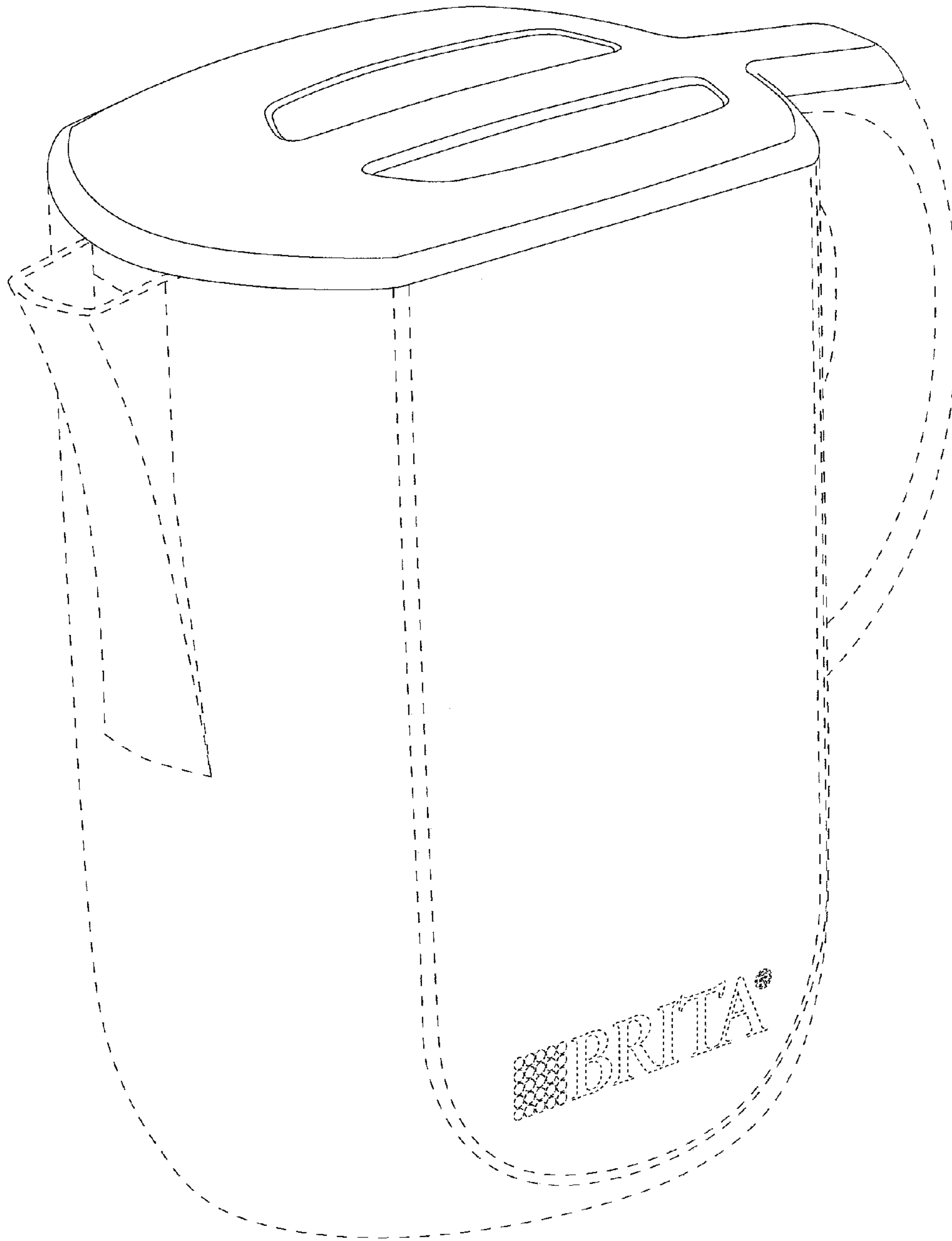

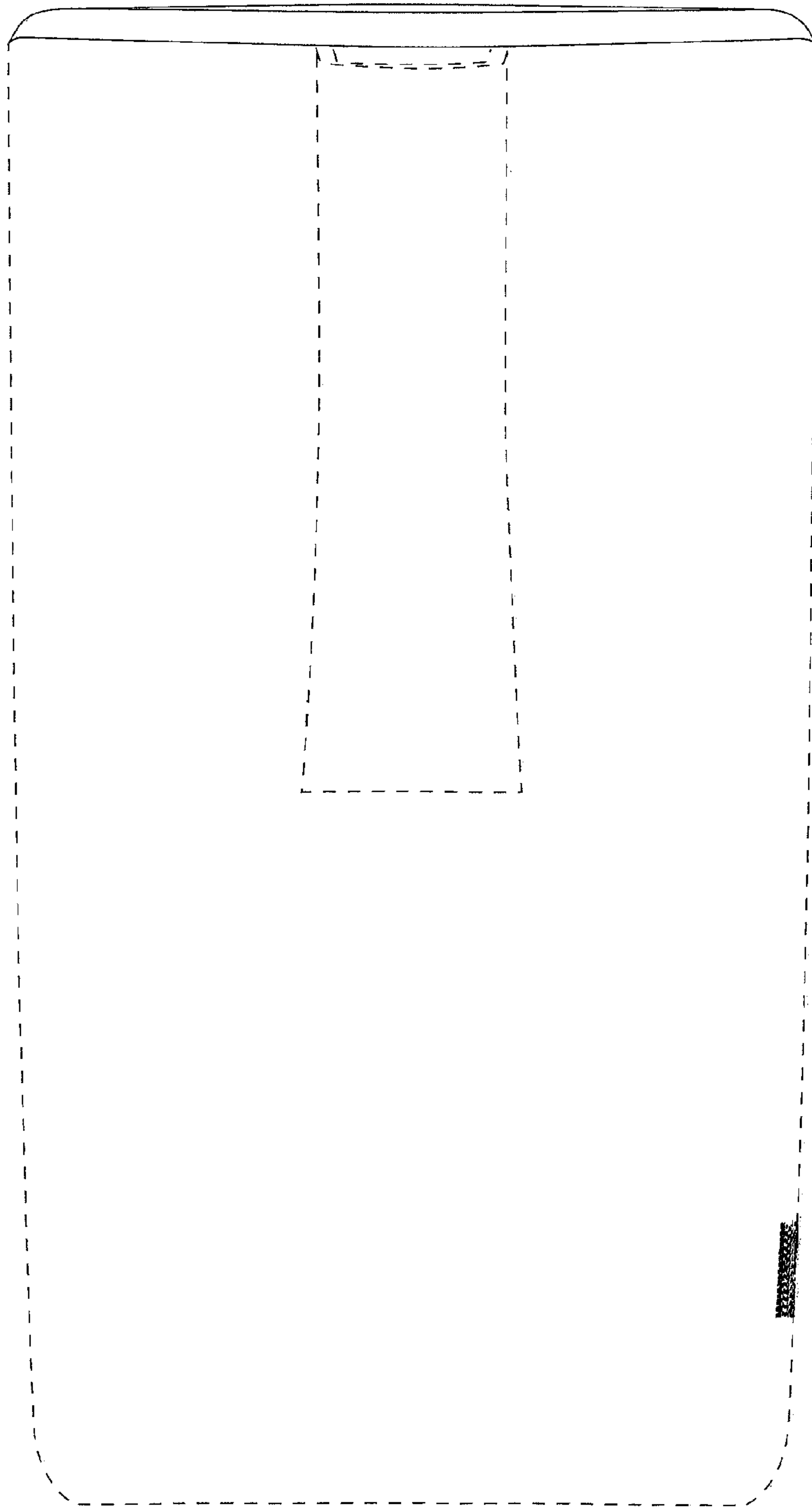

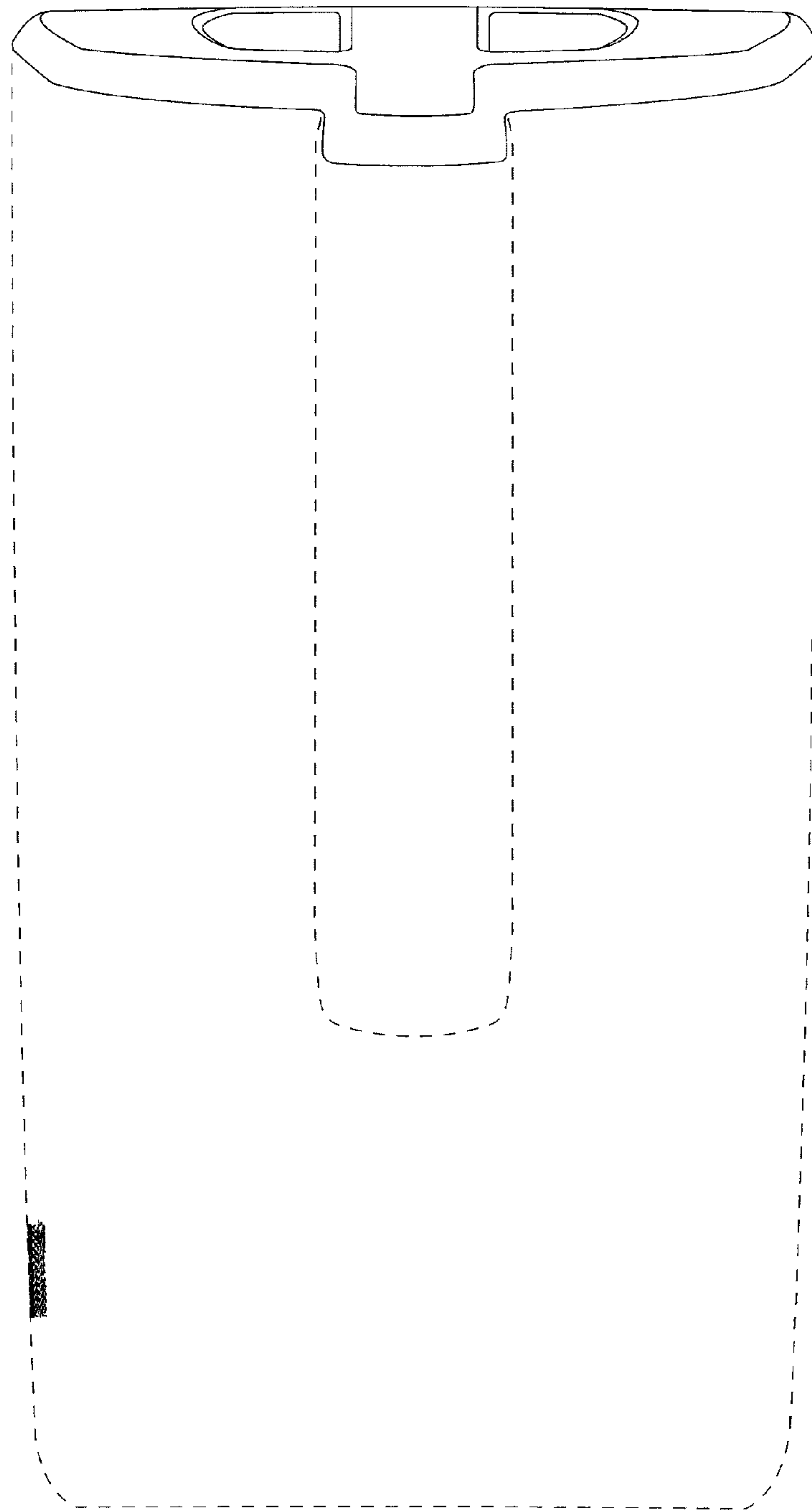

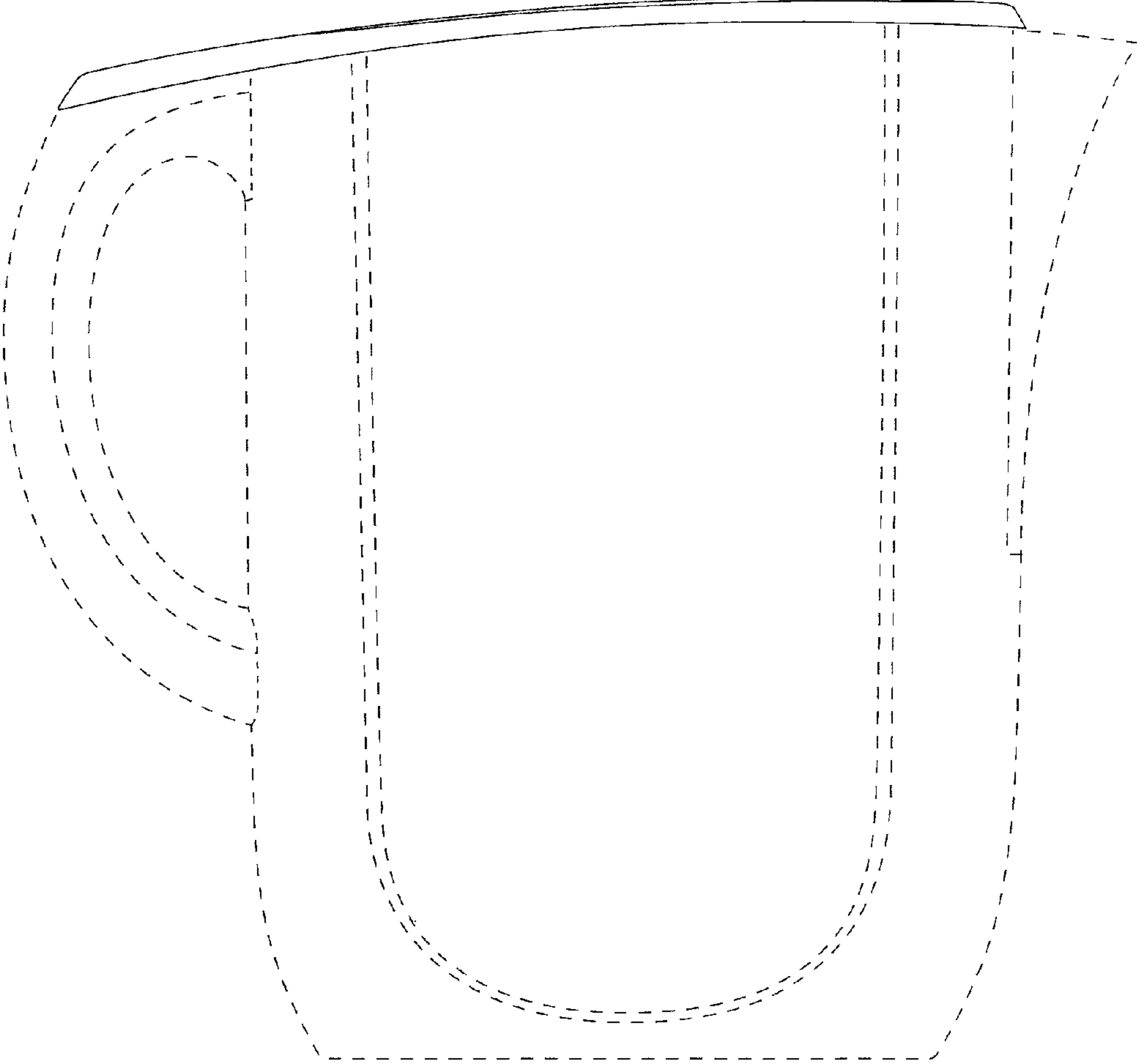

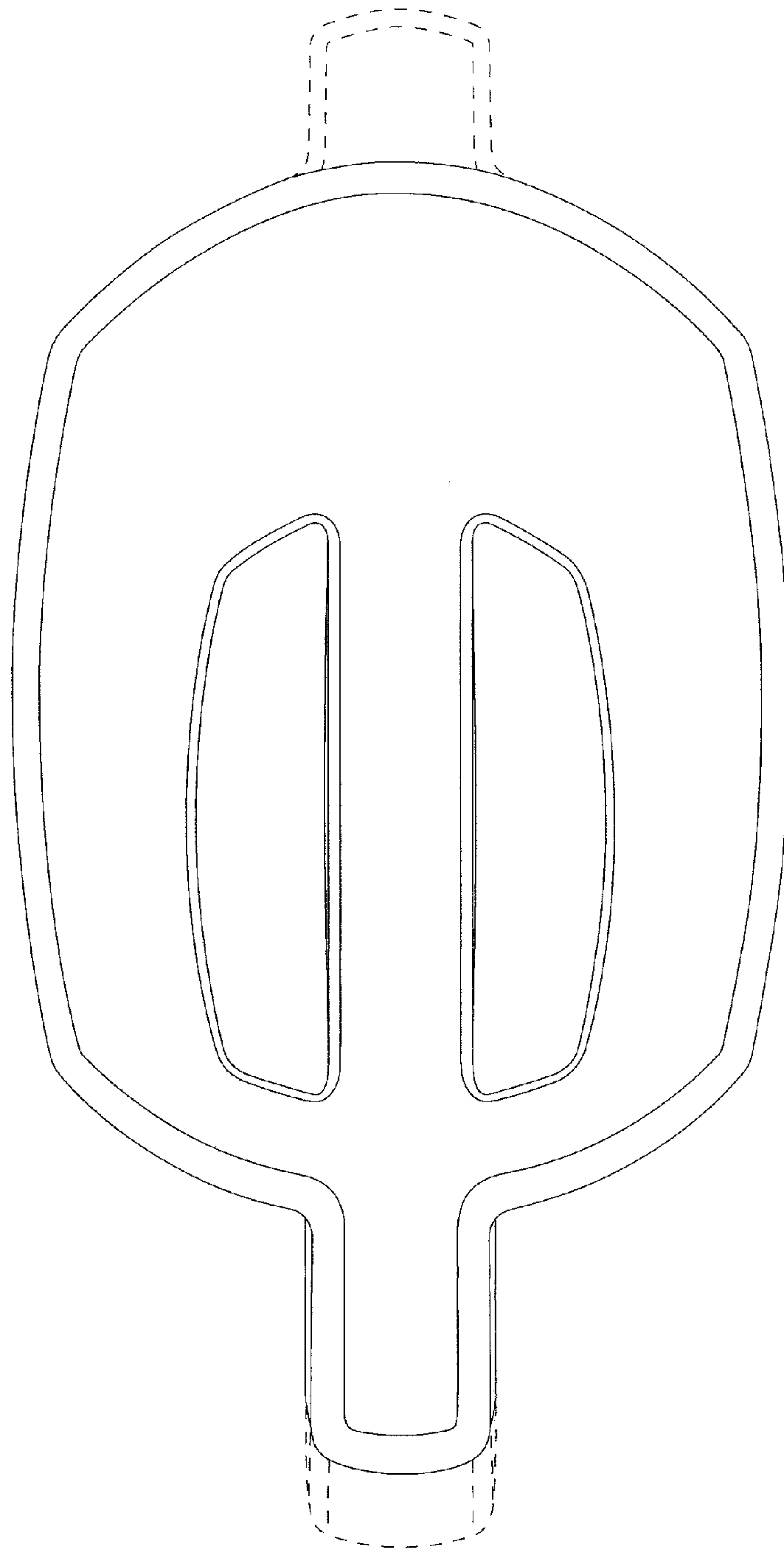

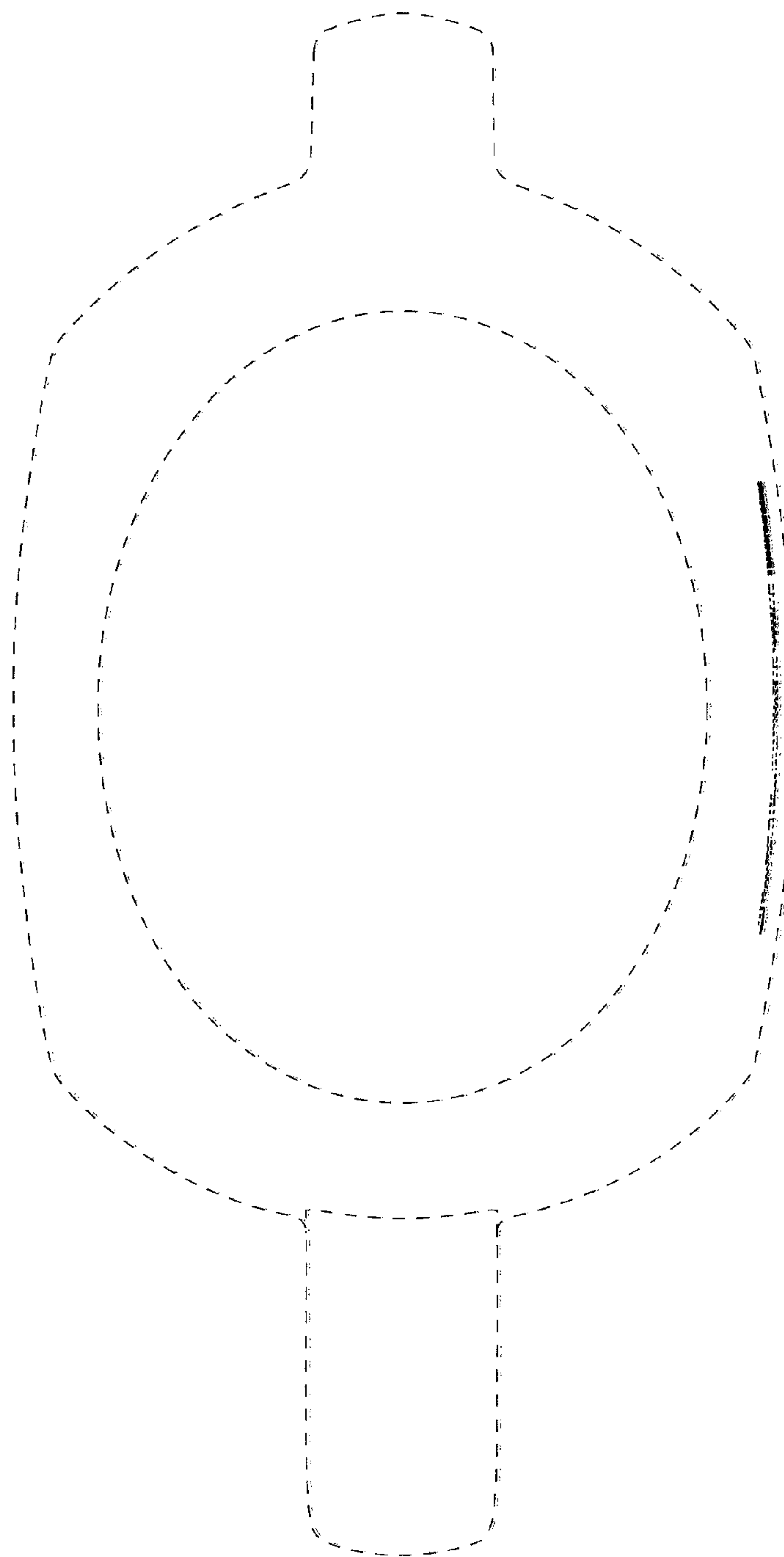
