FIG. 1 is a perspective view of the cake stand of the present invention;

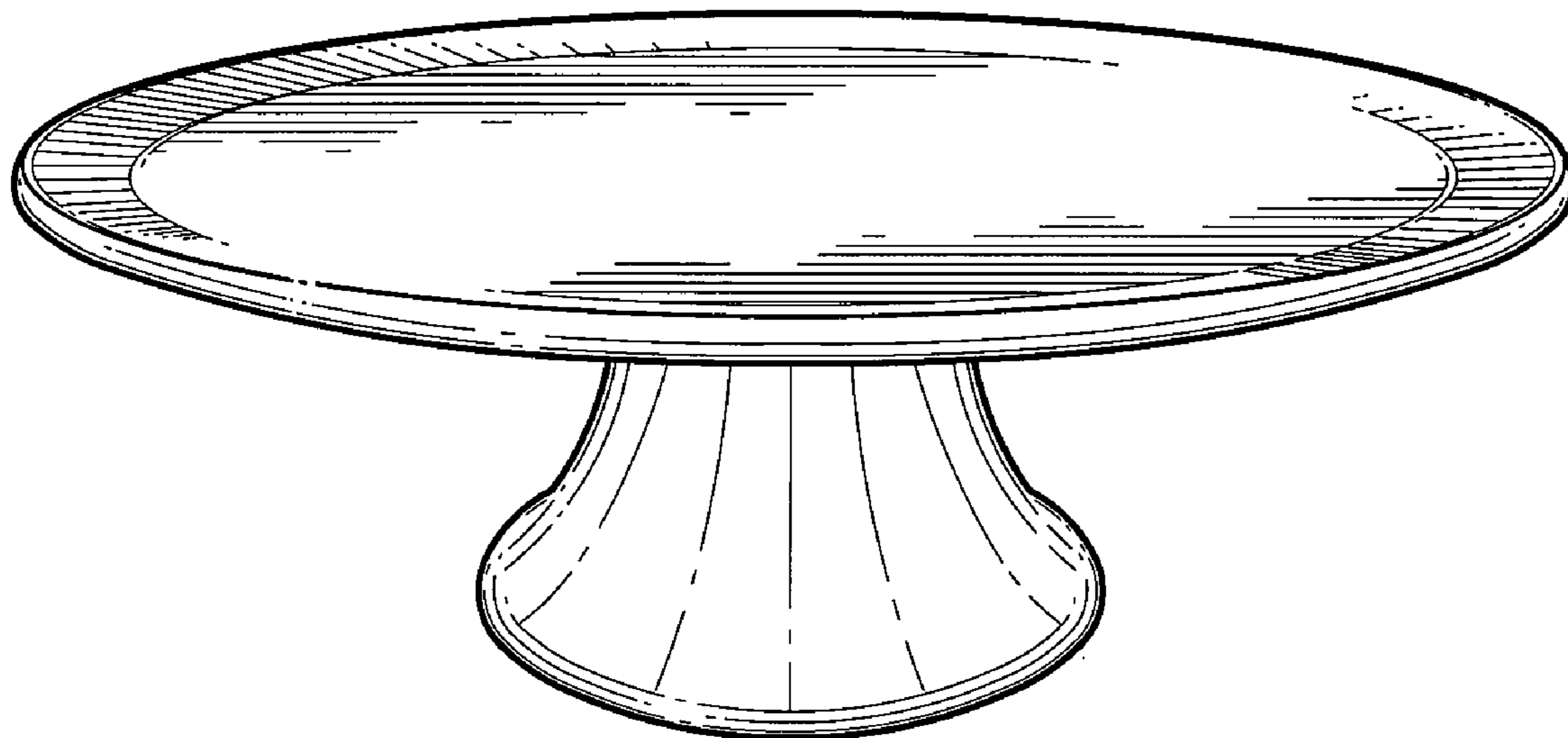
FIG. 2 is a side elevational view of the cake stand as shown in FIG. 1;

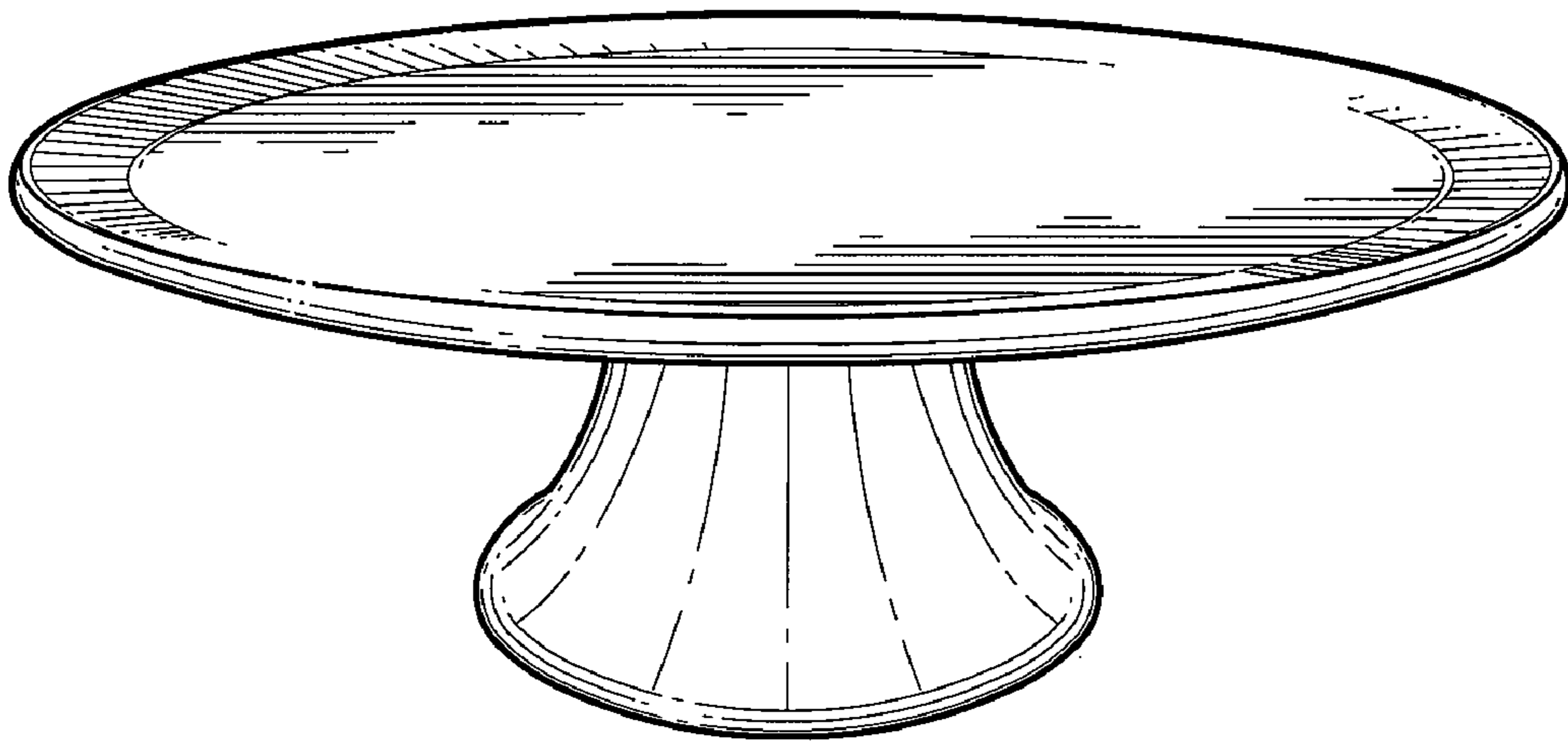

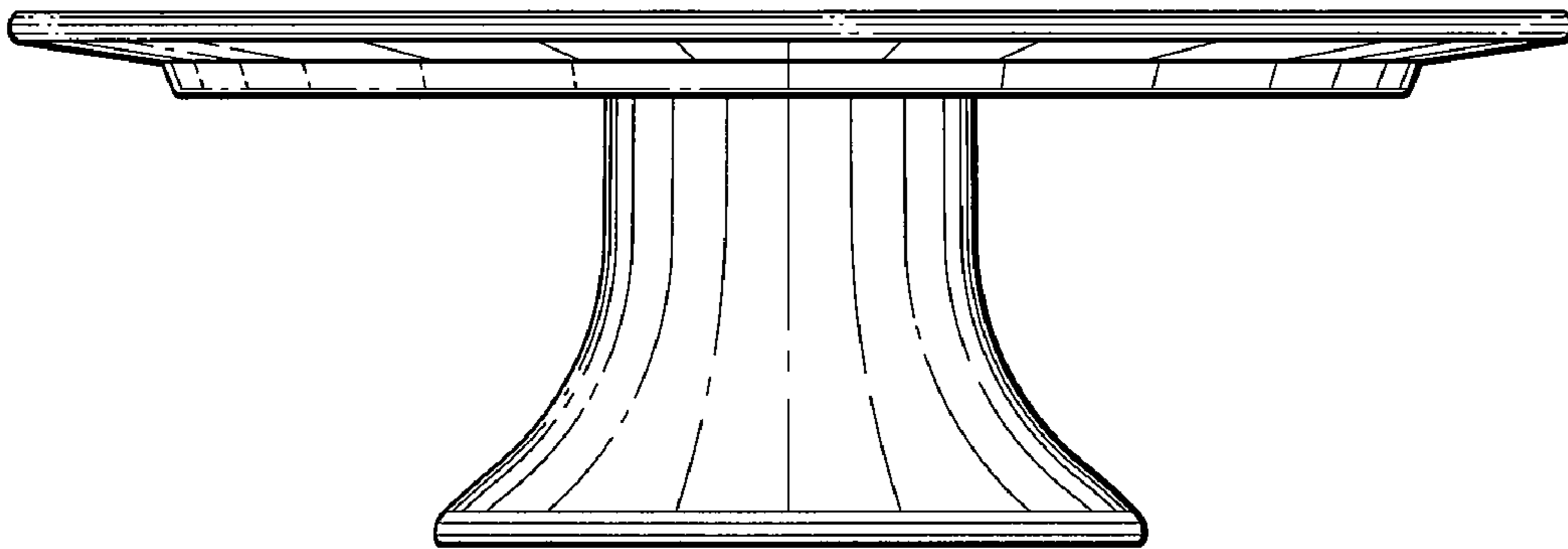

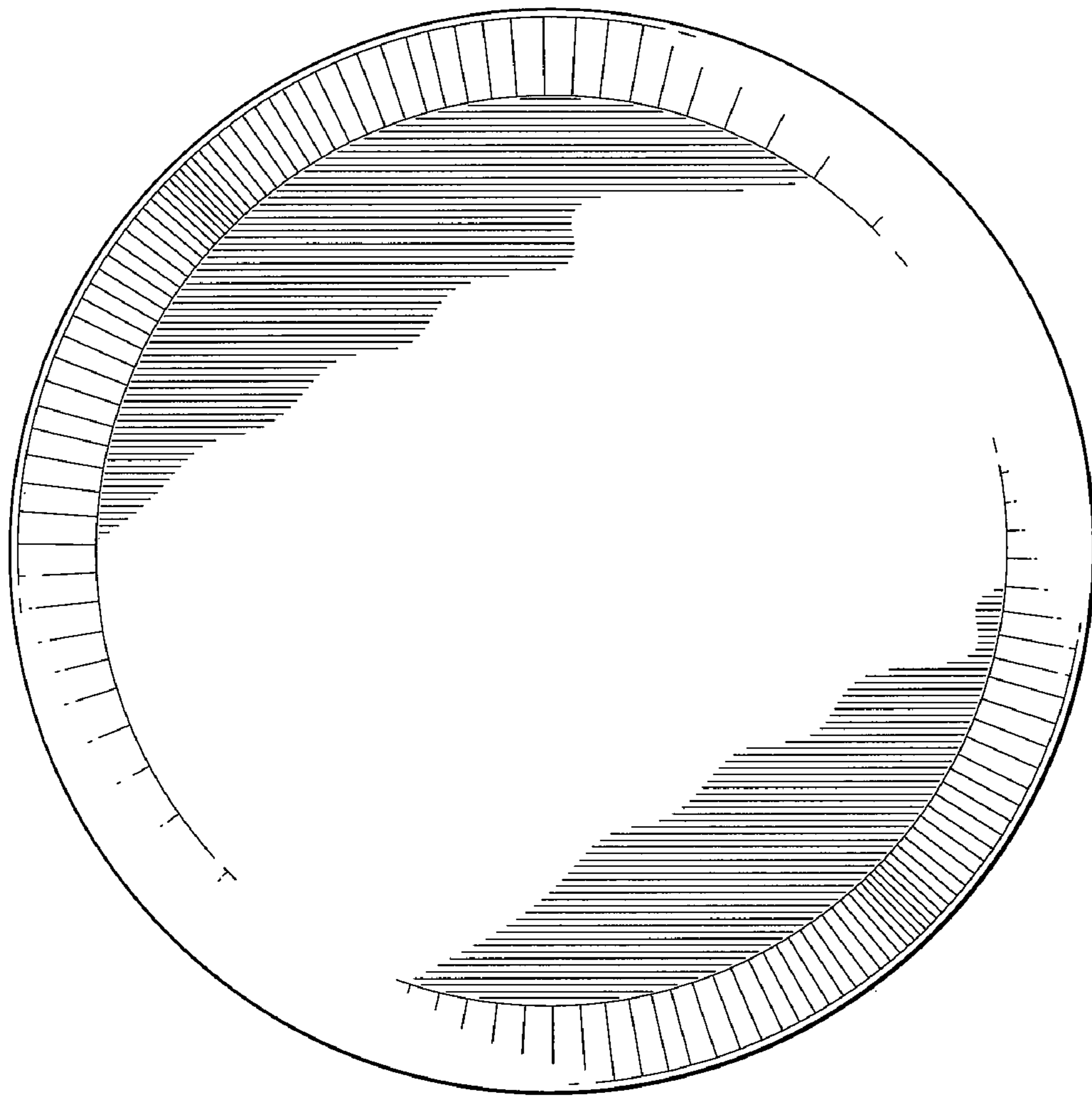

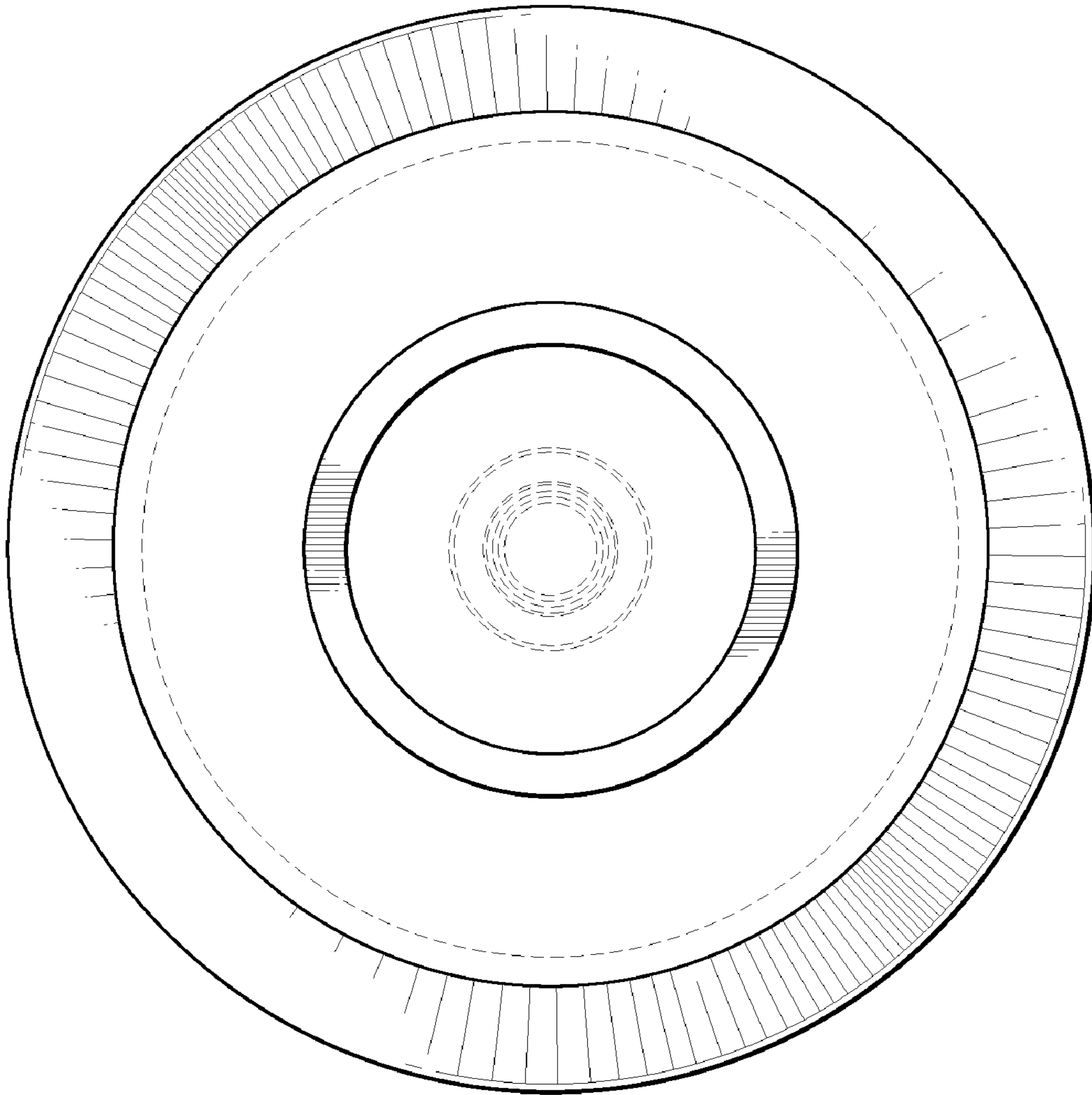
