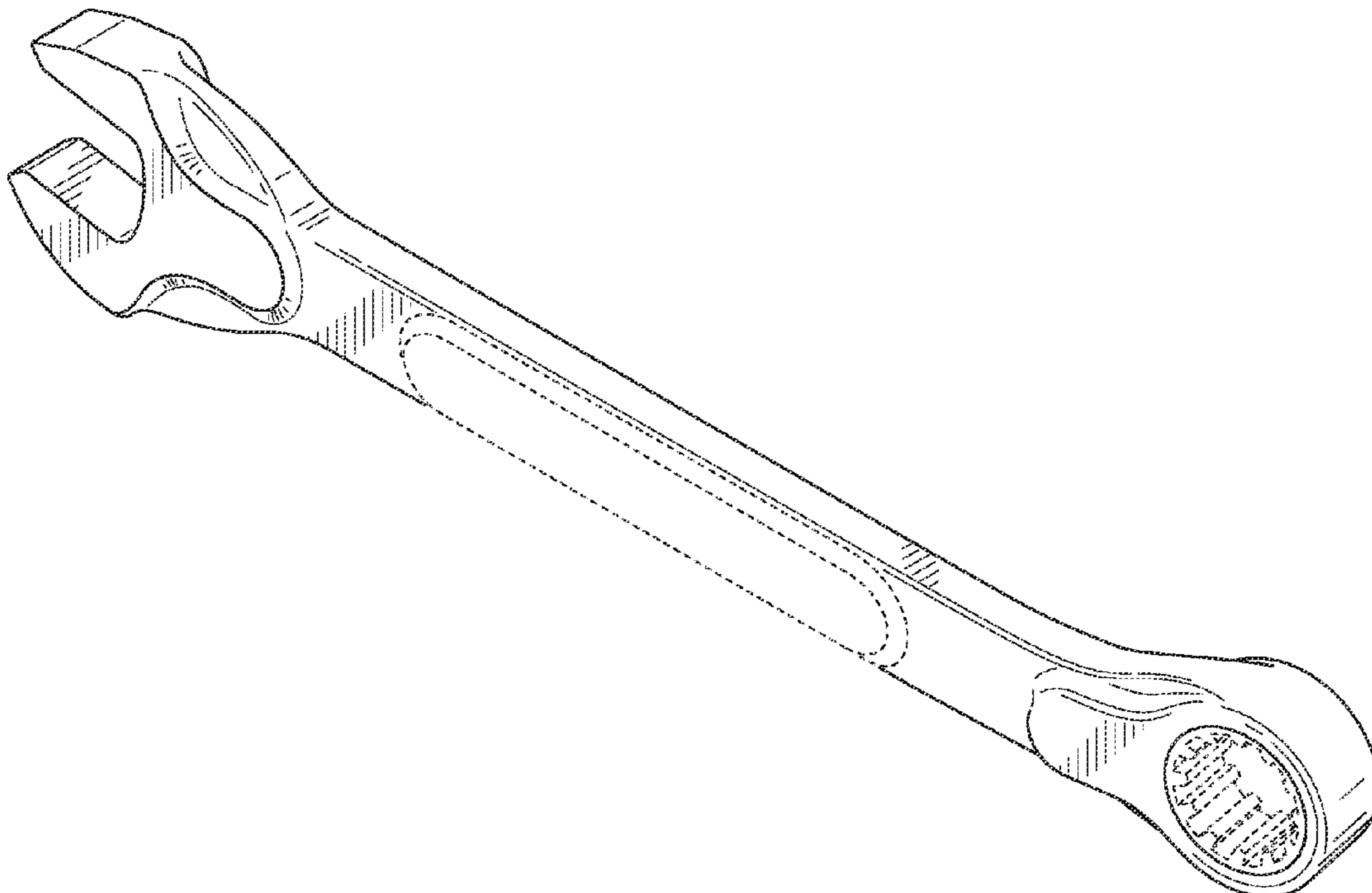
(57) **CLAIM**

The ornamental design for a wrench, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a wrench according to the invention illustrating the top and left side of the invention; FIG. 2 is a top elevation view of the wrench of FIG. 1; FIG. 3 is a bottom elevation view of the wrench of FIG. 1; FIG. 4 is a right side elevation view of the wrench of FIG. 1; FIG. 5 is a left side elevation view of the wrench of FIG. 1; FIG. 6 is a front side view of the wrench of FIG. 1; and, FIG. 7 is a back side view of the socket wrench of FIG. 1. Petitioner disclaims the shape and configuration of the features of those portions shown in broken lines.

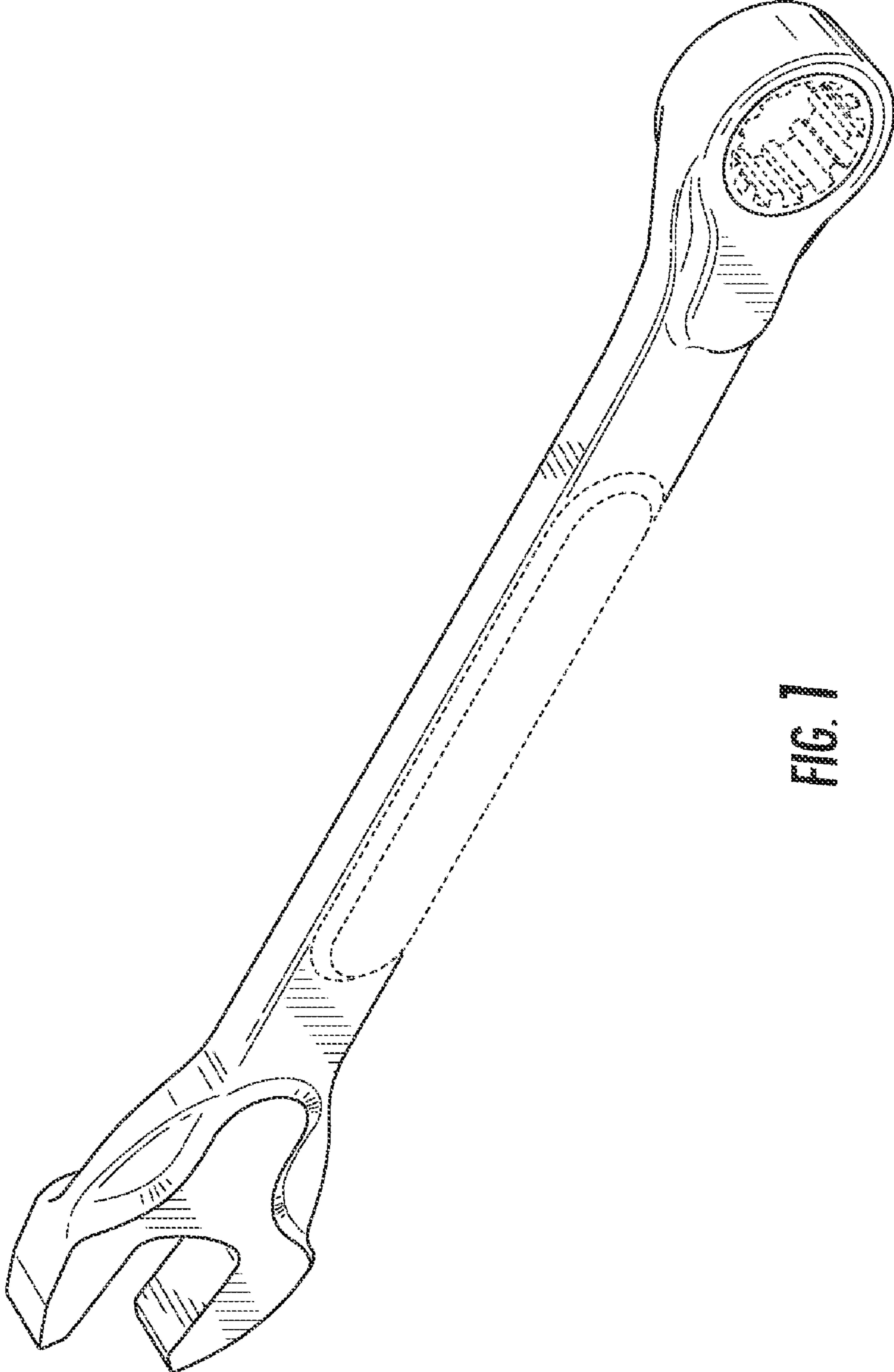

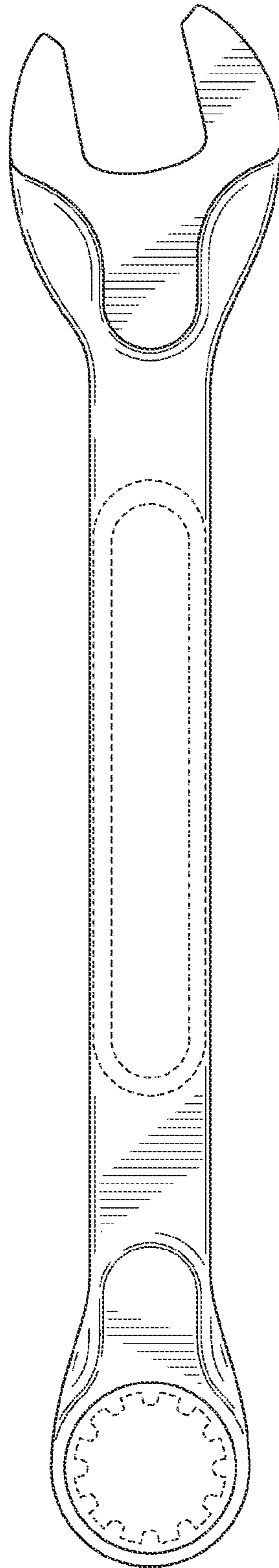

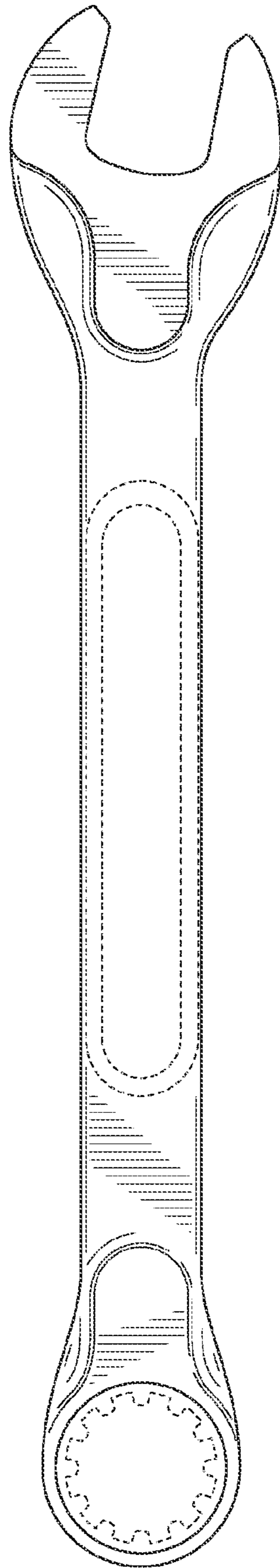
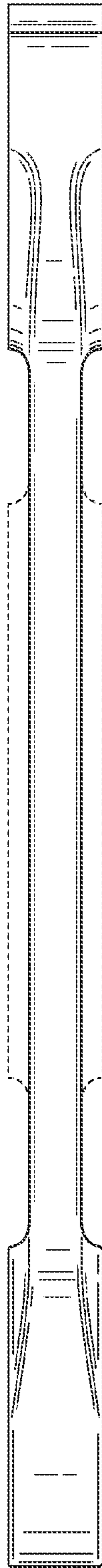
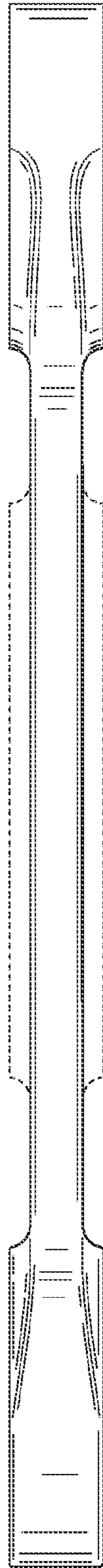

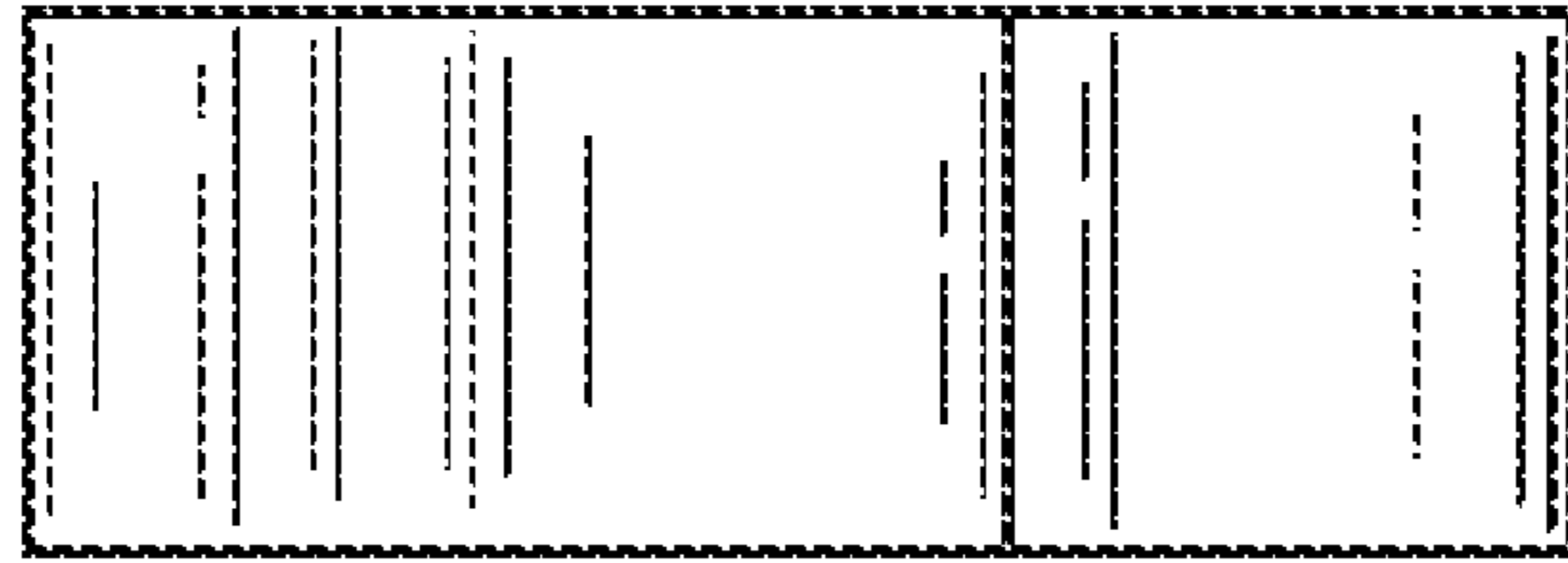

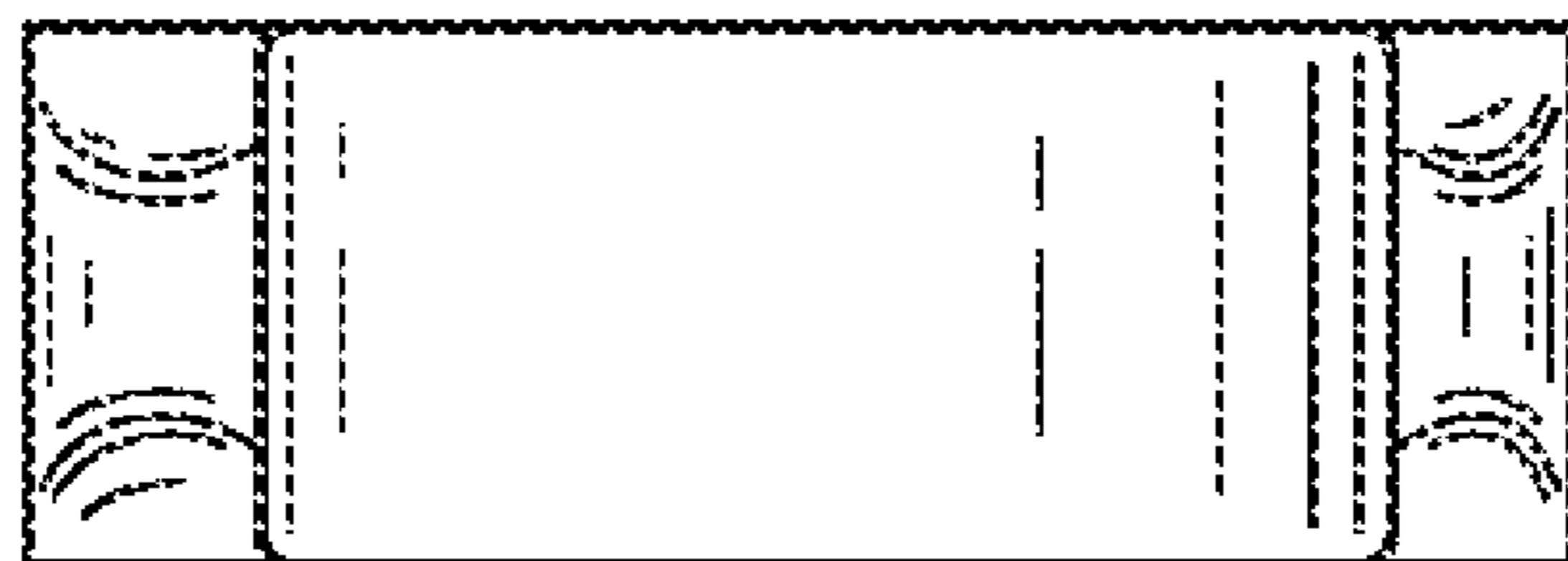
