(57) **CLAIM**

The ornamental design for an absorbent article package, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an absorbent article package showing our new design;

FIG. 2 is a front view of the absorbent article package shown in FIG. 1;

FIG. 3 is a rear side view of the absorbent article package shown in FIG. 1;

FIG. 4 is a right side view of the absorbent article package shown in FIG. 1;

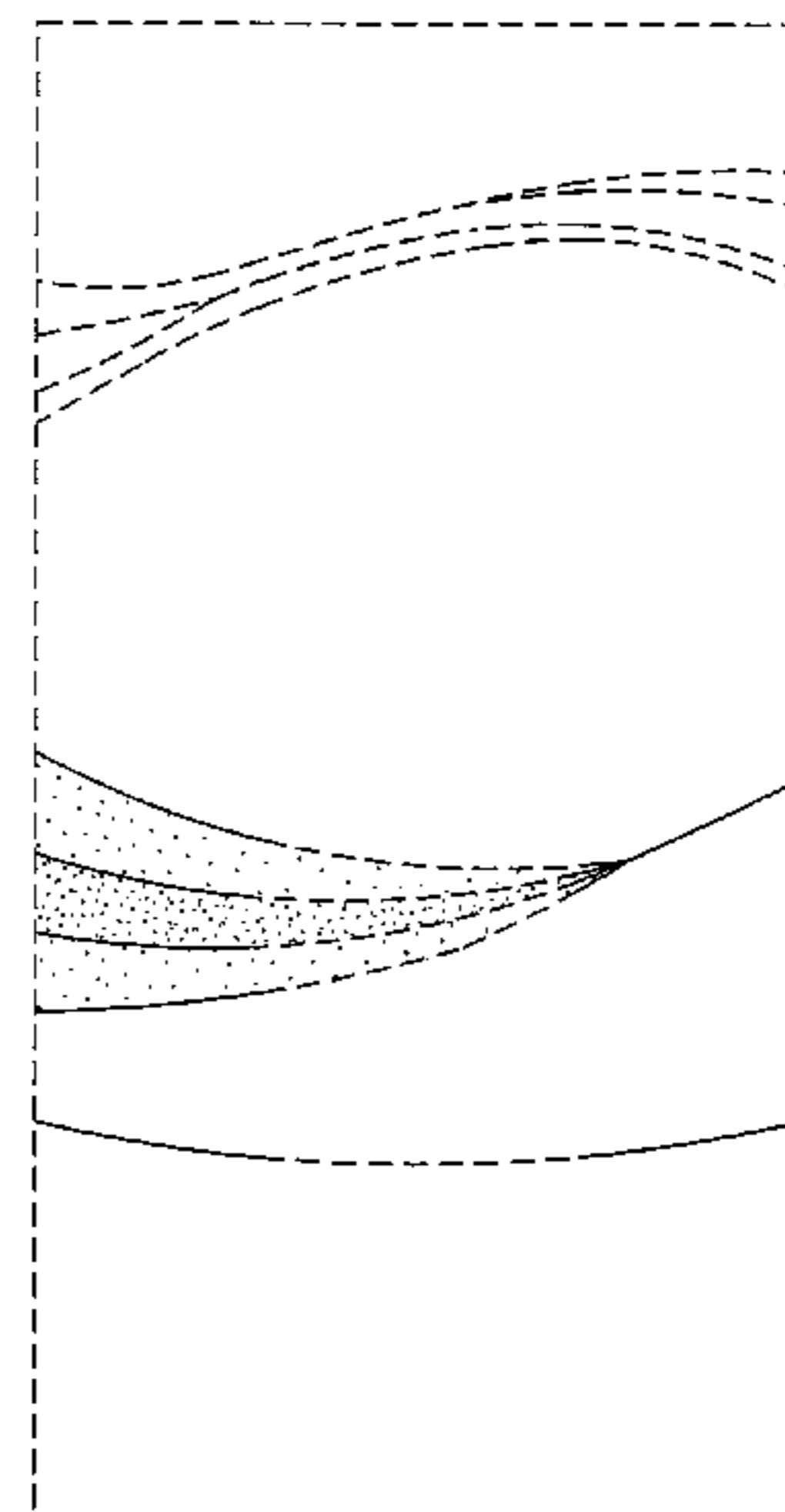
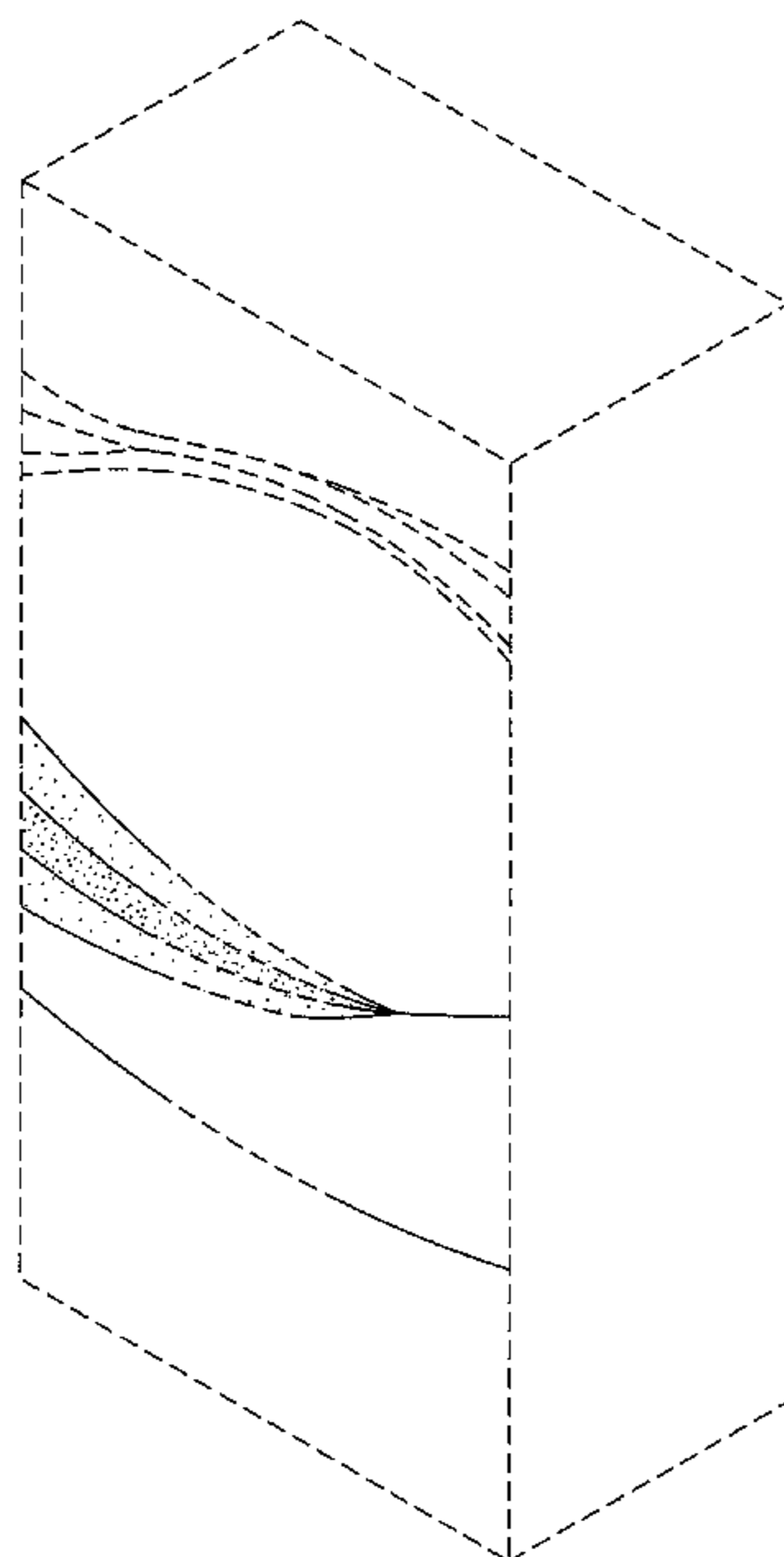
FIG. 5 is a left view of the absorbent article package shown in FIG. 1;

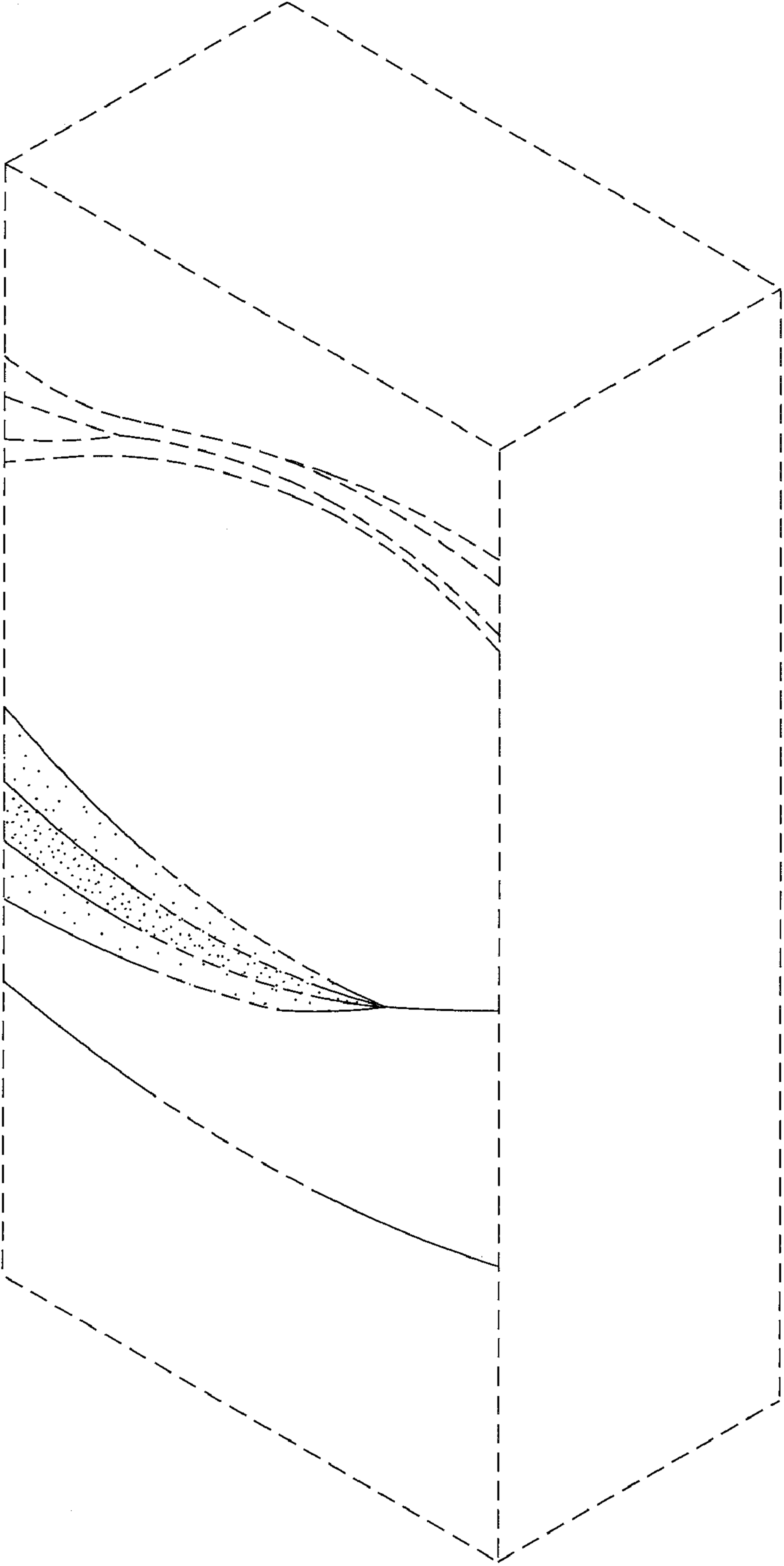

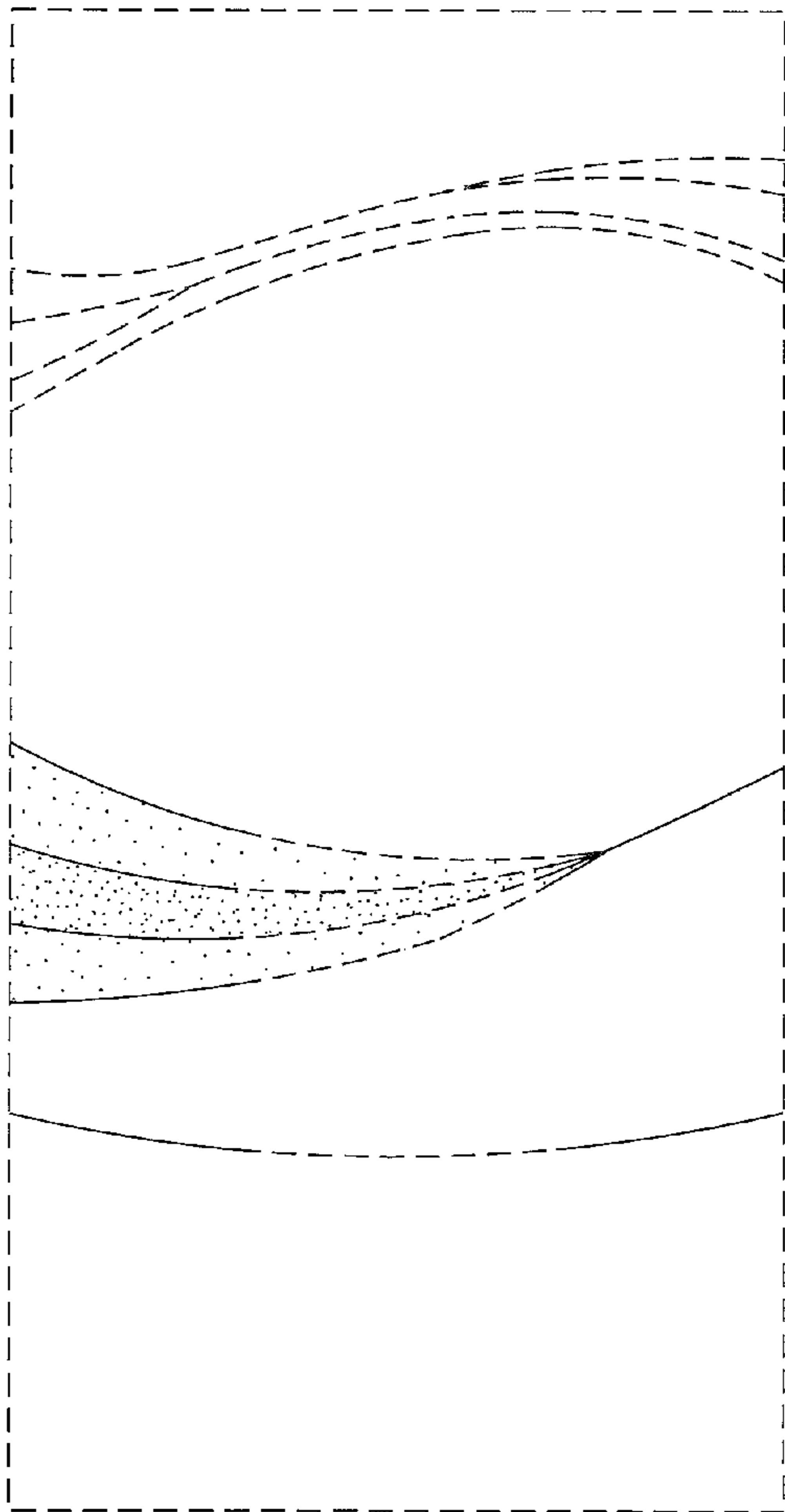

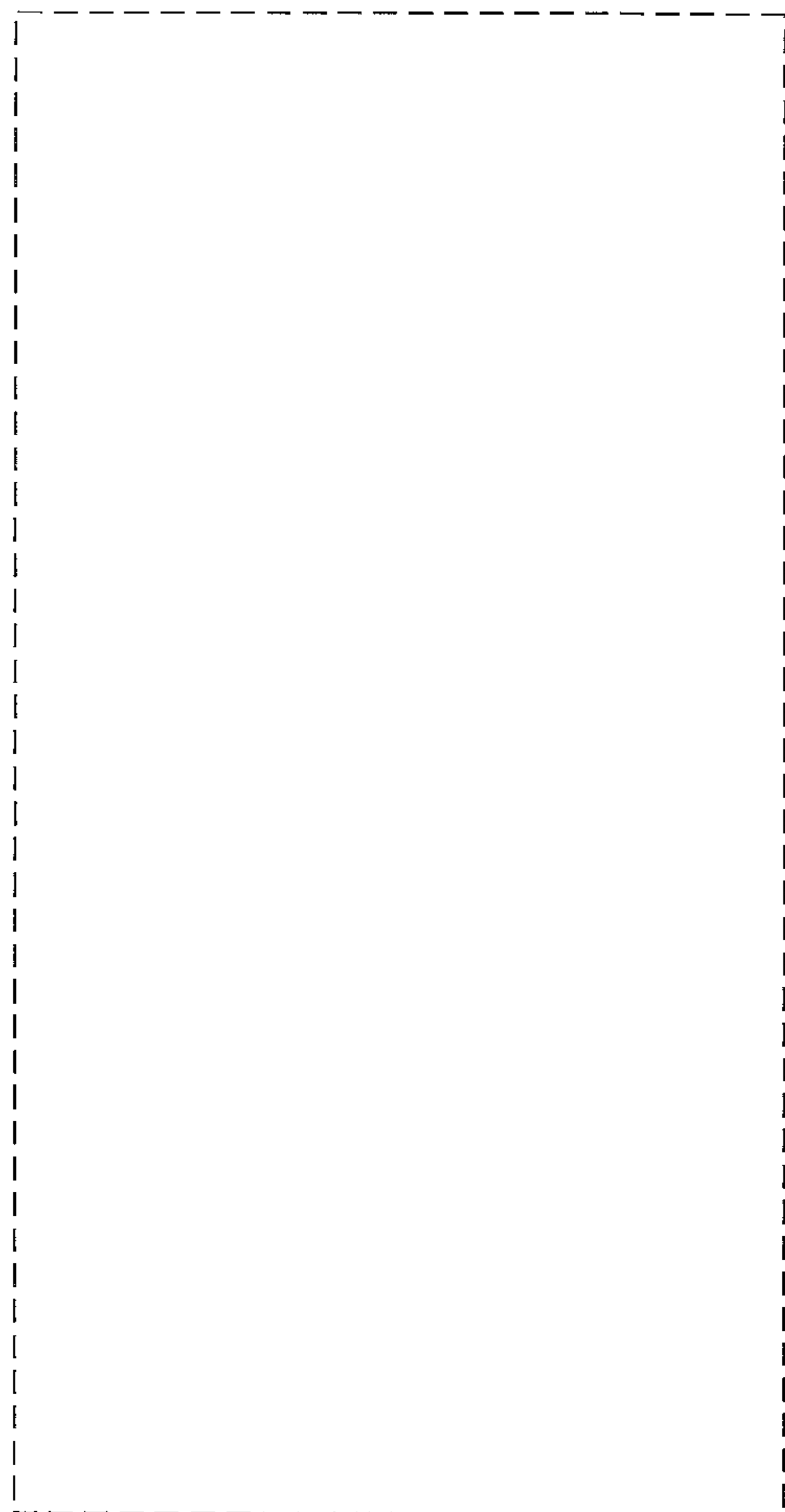

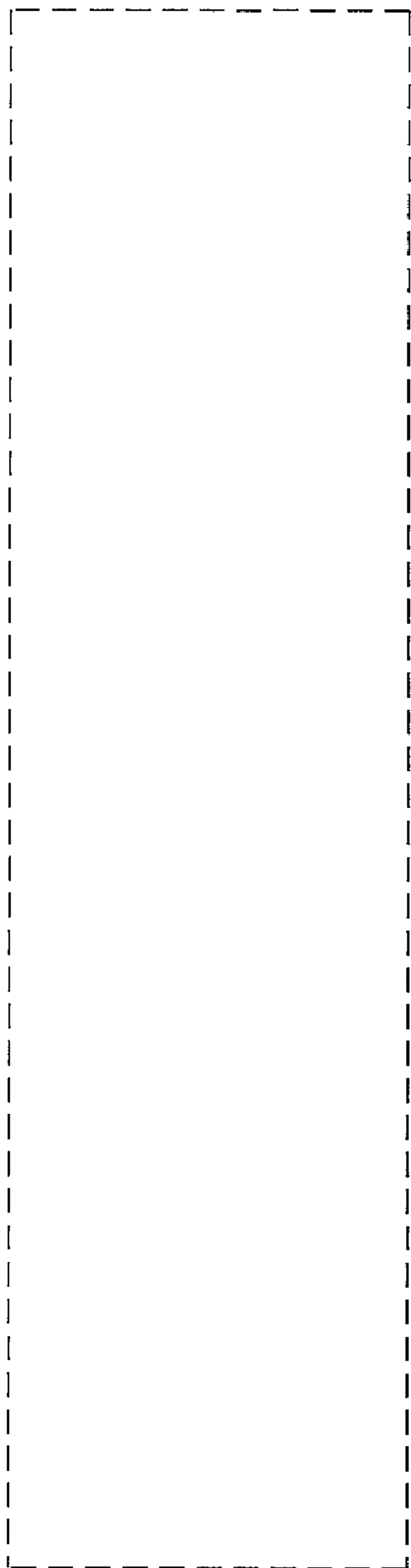

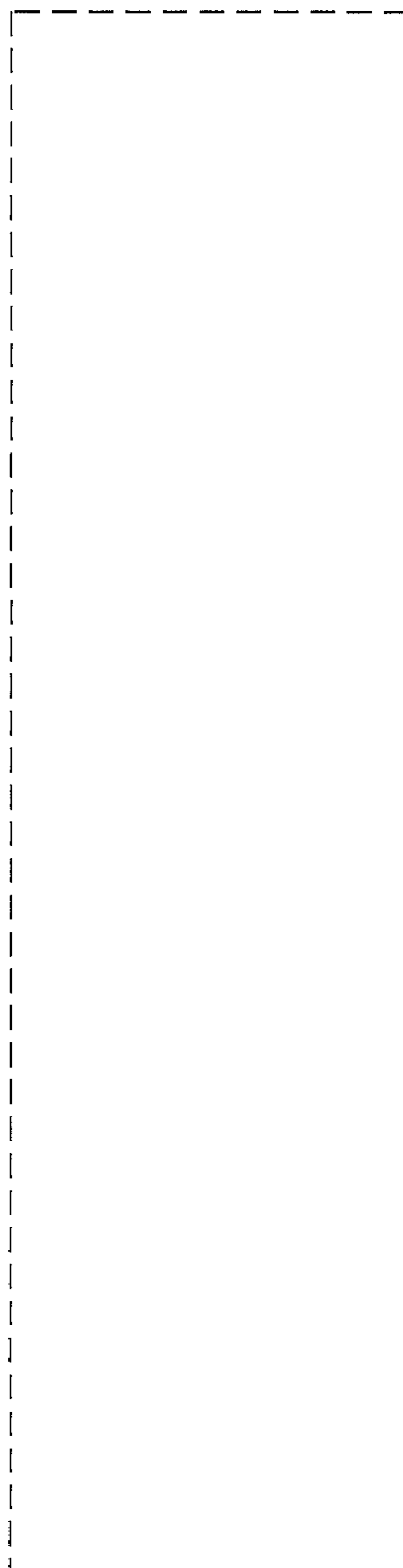

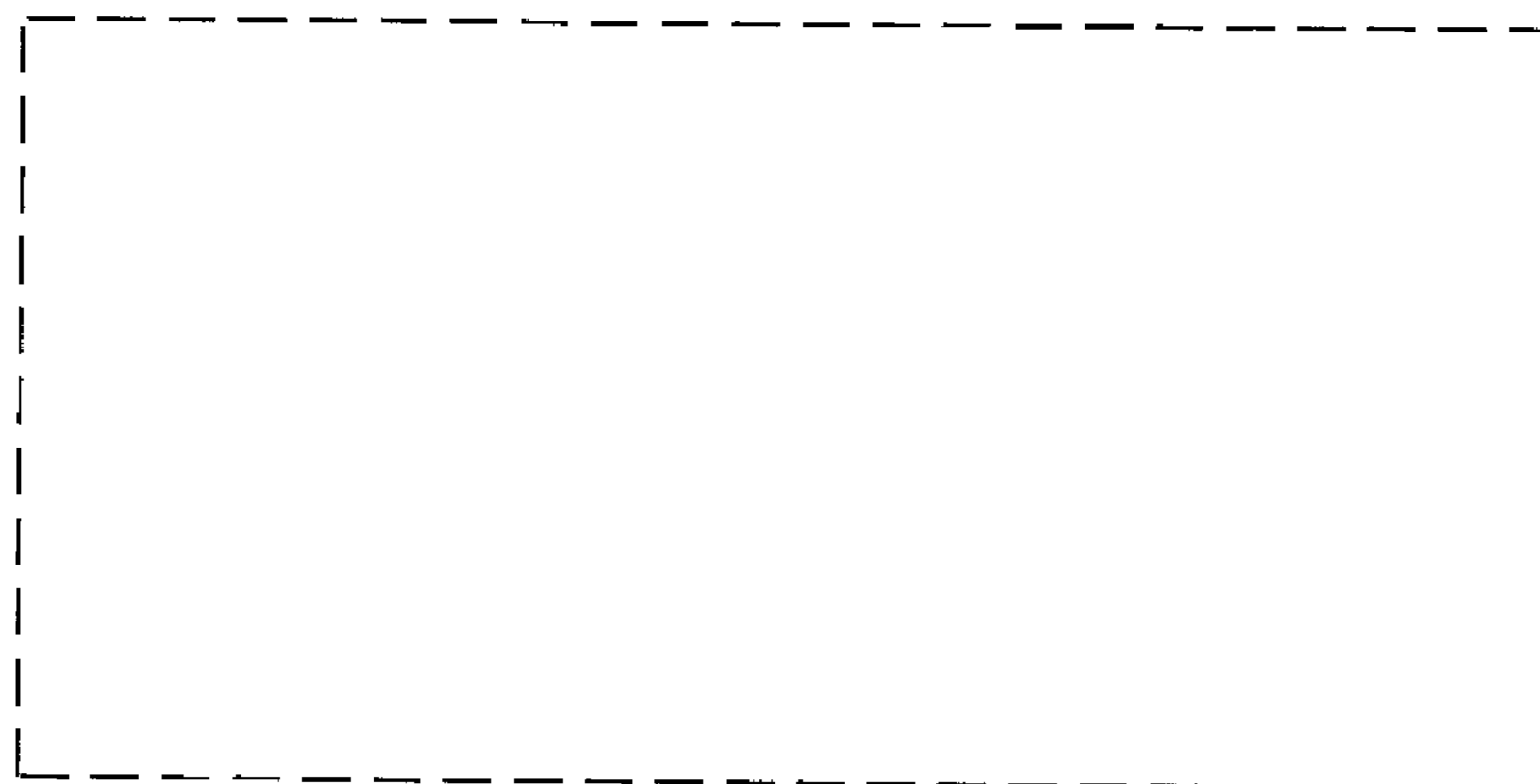

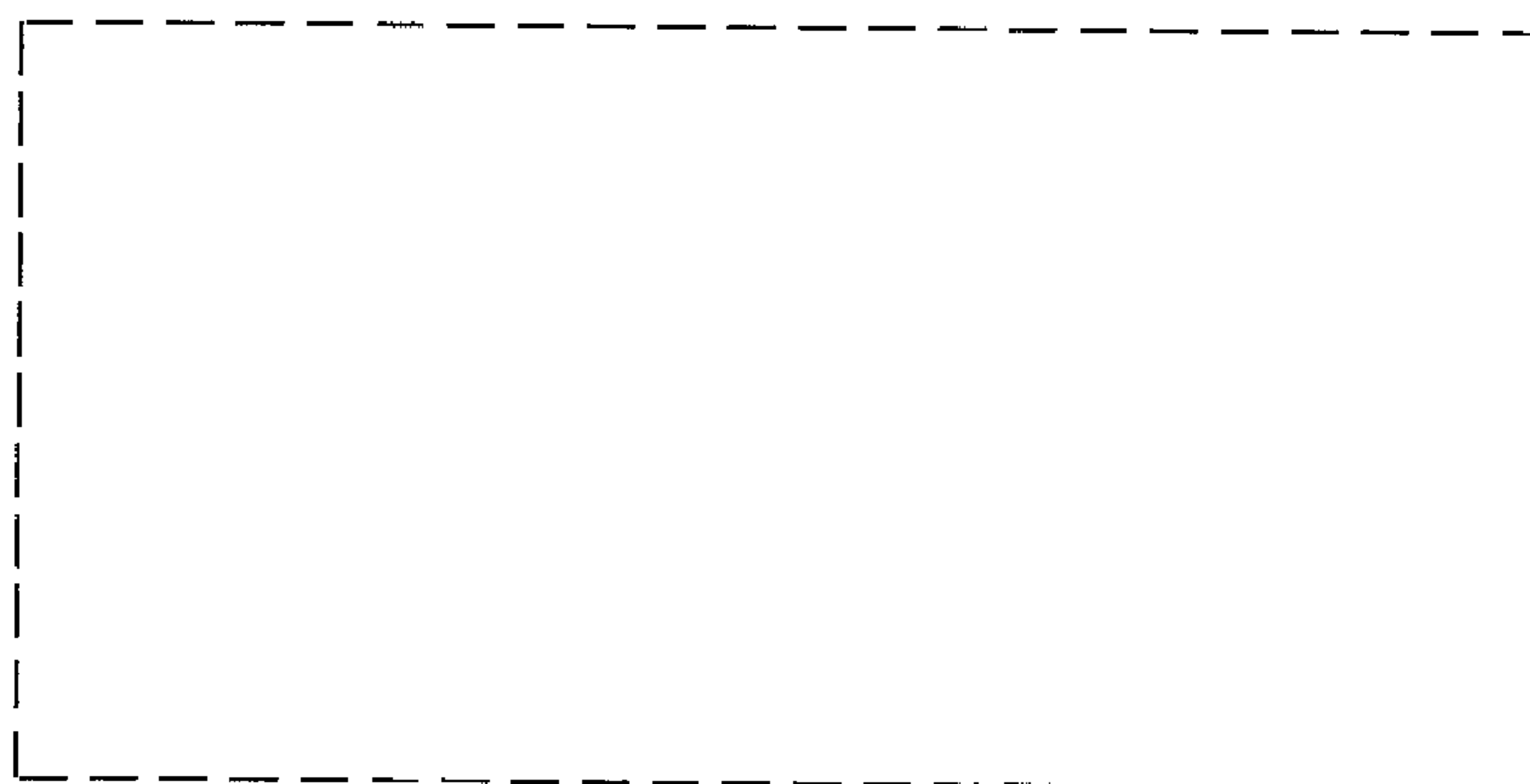
