(57) **CLAIM**

The ornamental design for a conical centrifuge bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side isometric view of our new conical centrifuge bottle, shown with unclaimed environment of a cap and measurement markings;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top, front, and left side isometric view of the conical centrifuge bottle of FIG. 1, shown with the unclaimed environment removed;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a left side elevational view thereof;

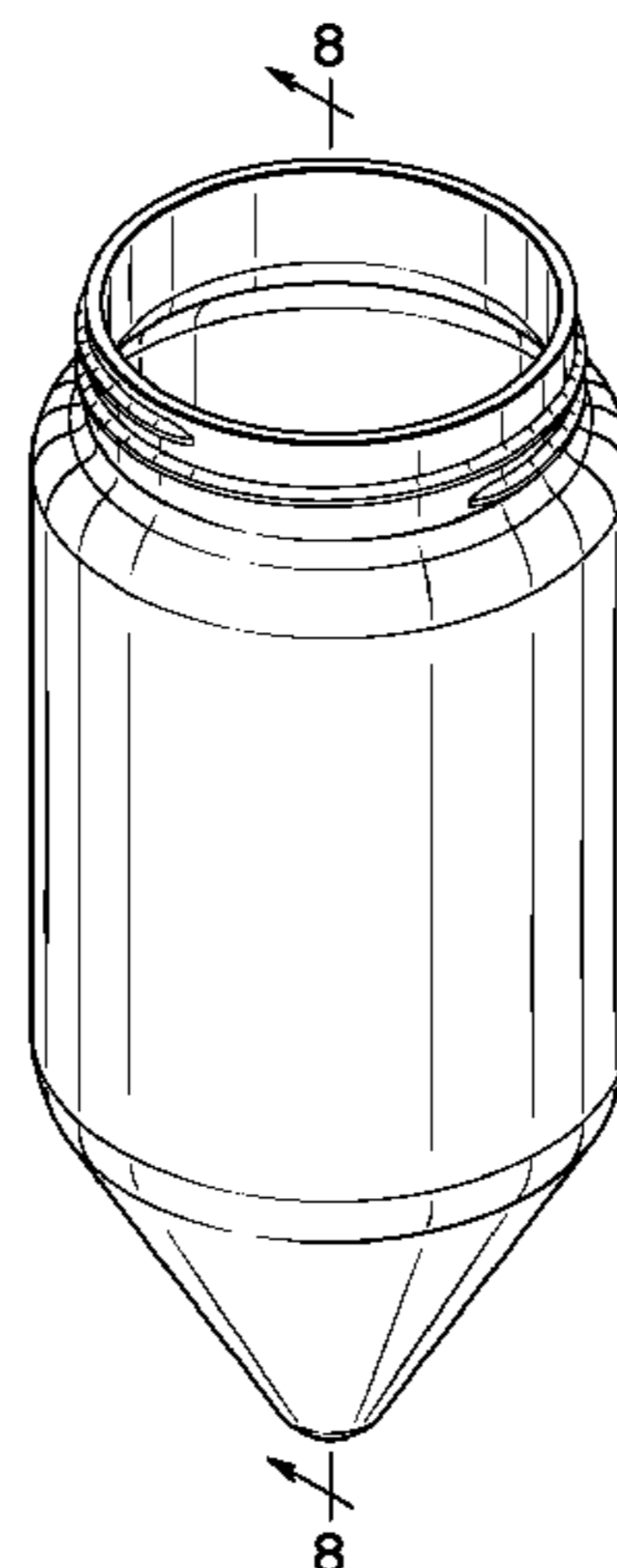
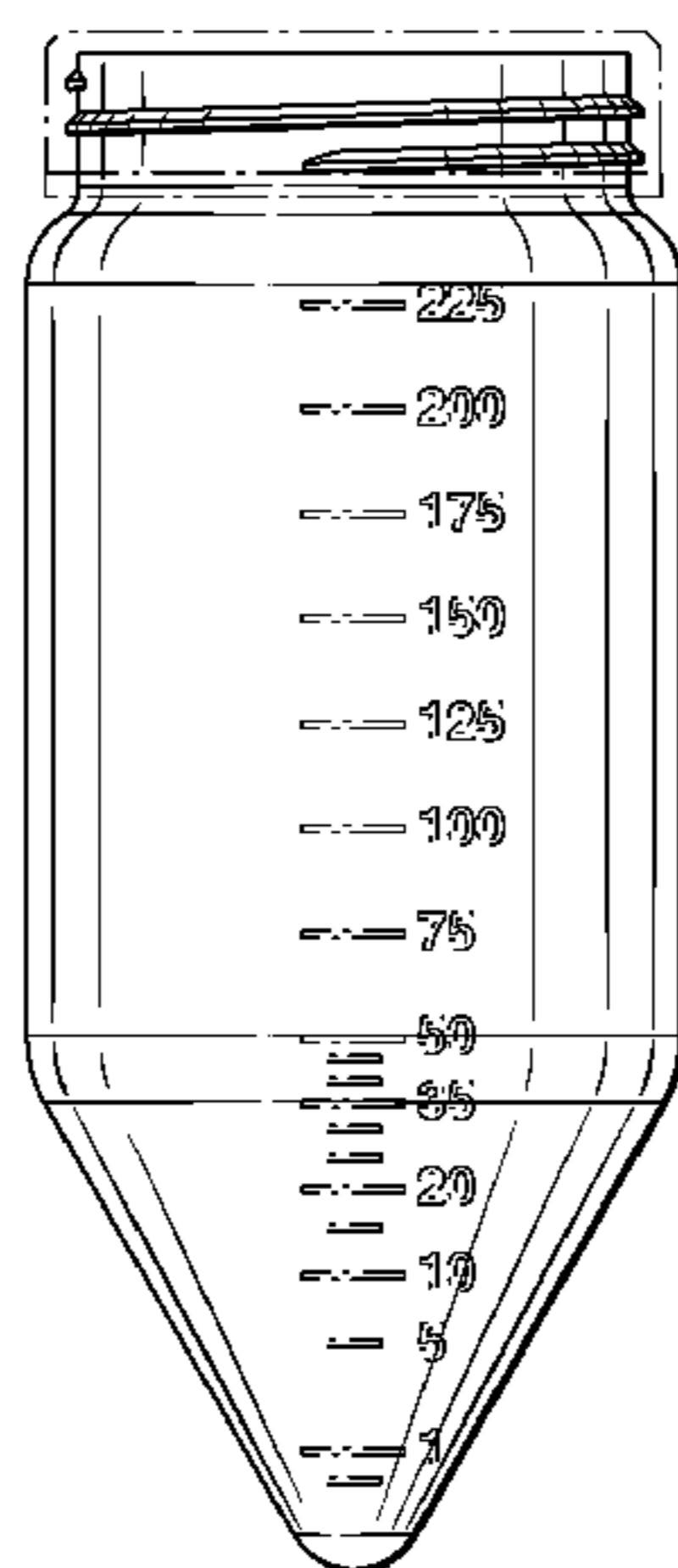
FIG. 8 is a cross-sectional view taken along section line 8—8 in FIG. 3;

FIG. 9 is a top plan view of the conical centrifuge bottle of FIG. 3; and,

FIG. 10 is a bottom plan view thereof.

The broken line showing of a cap and of measurement markings in drawing FIGS. 1 & 2 is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

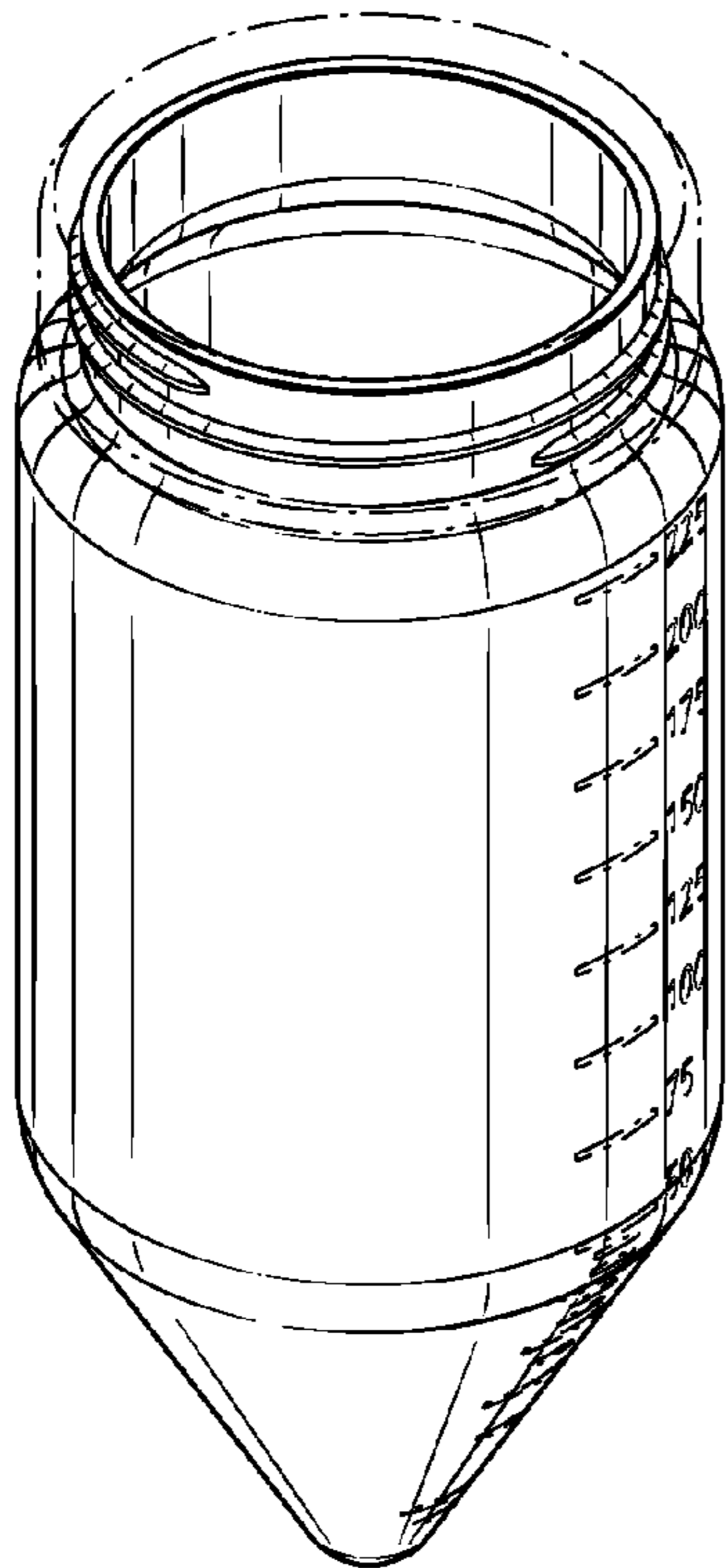

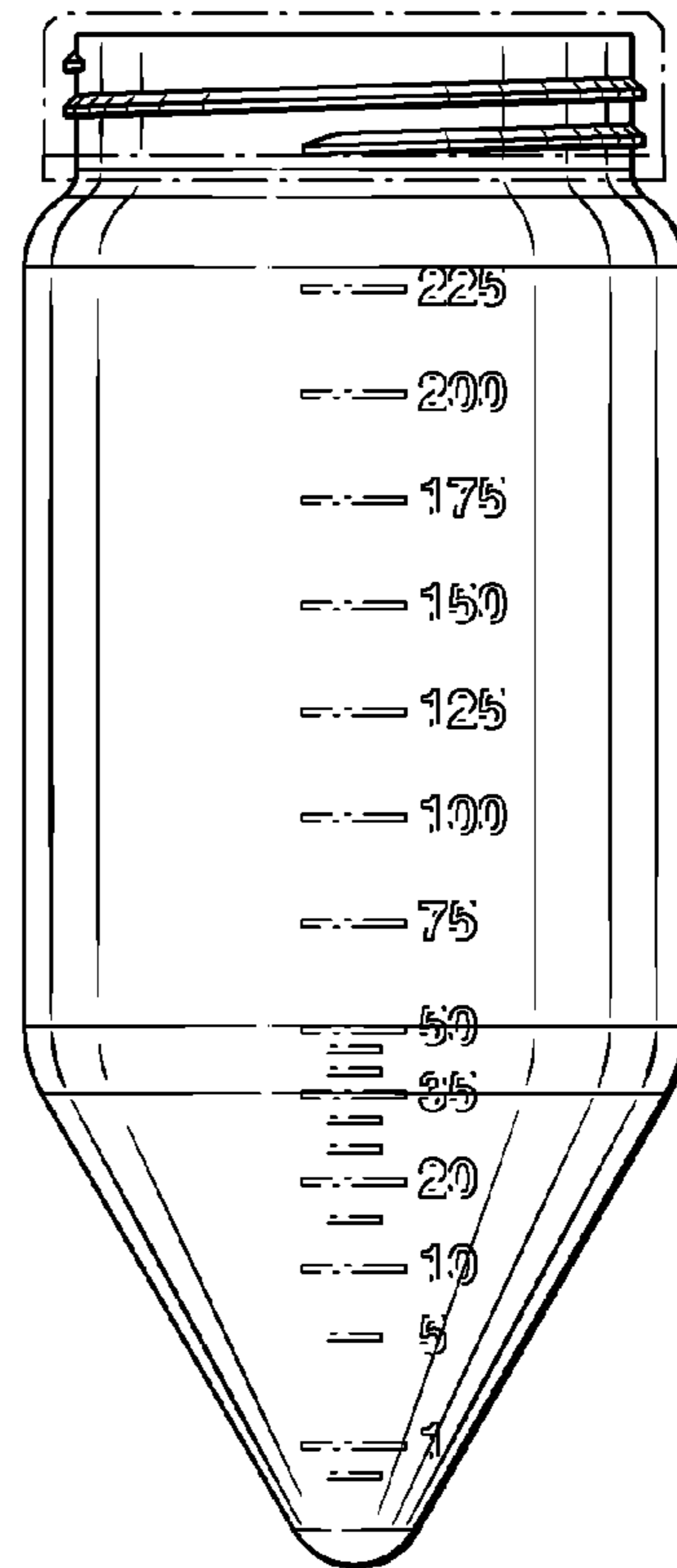

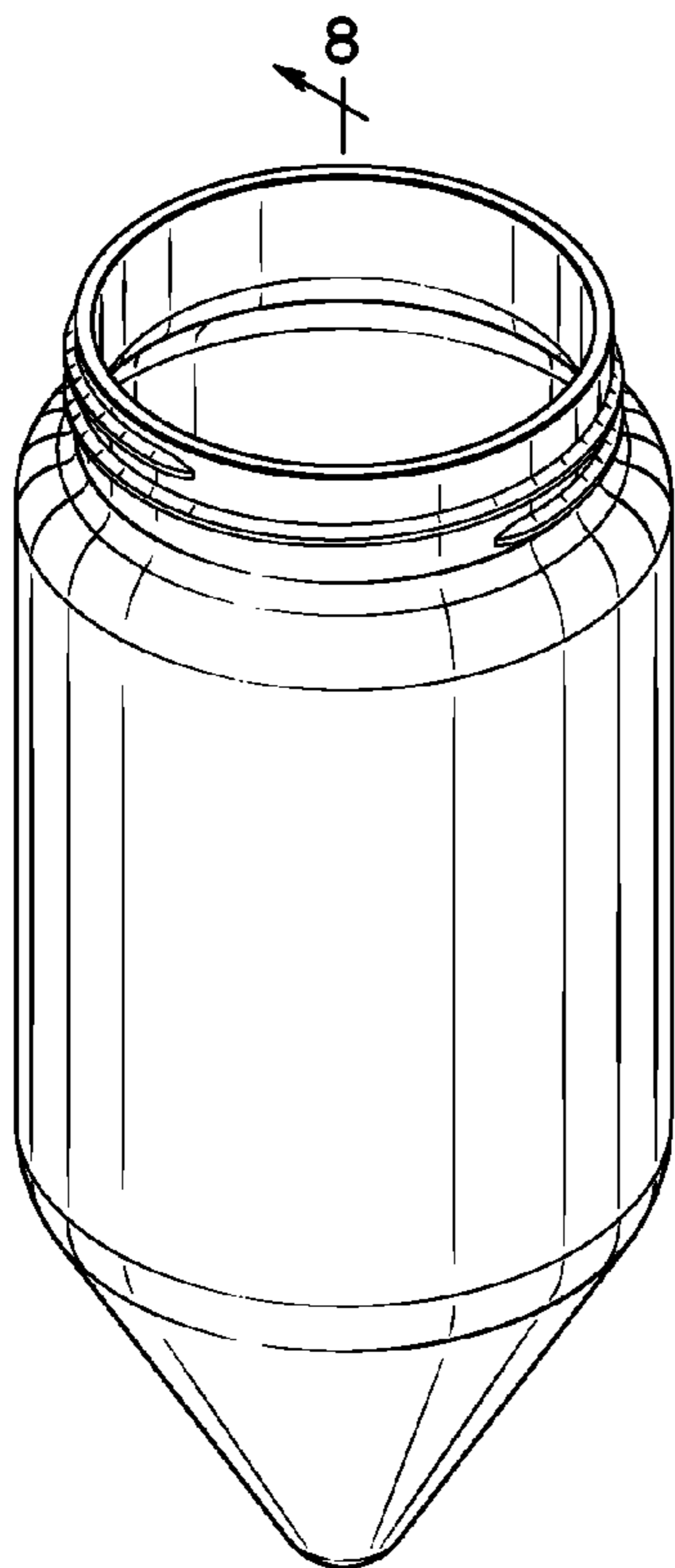

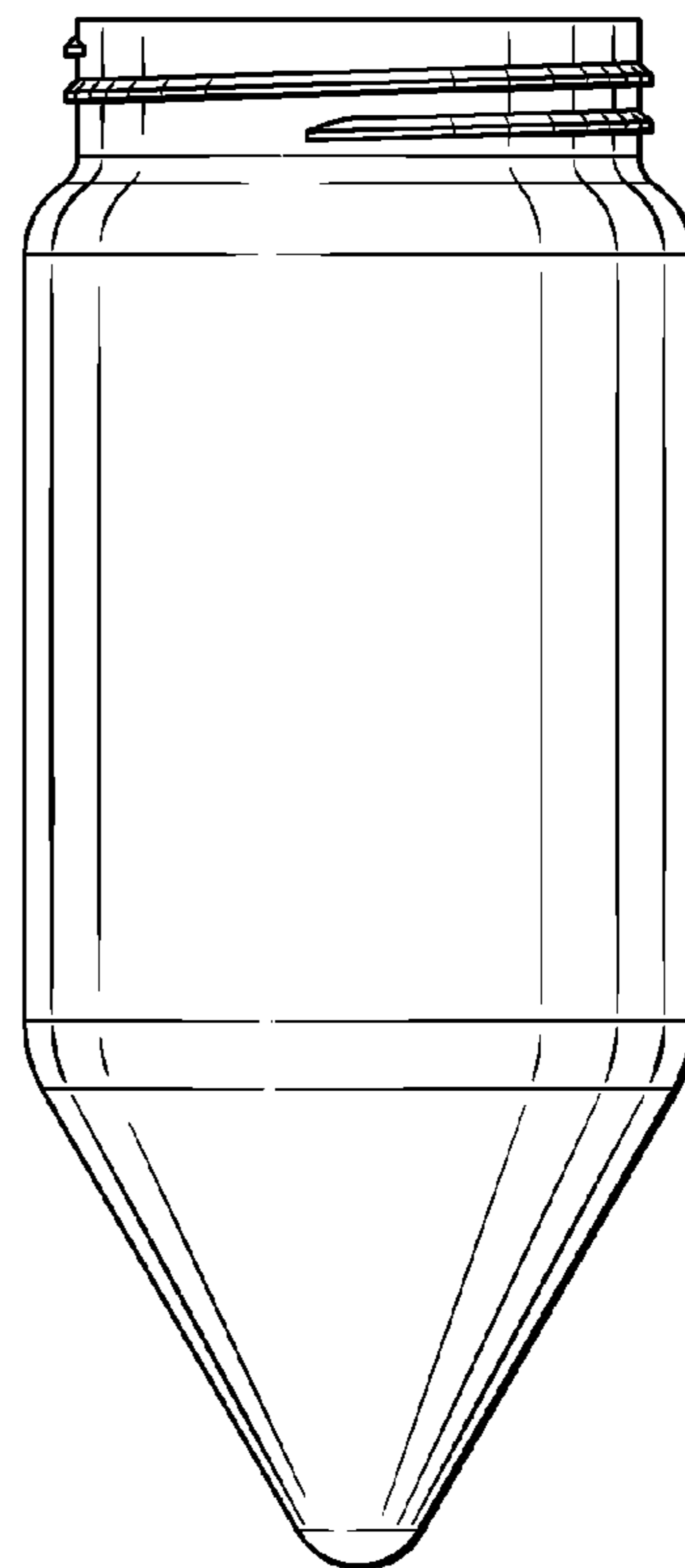

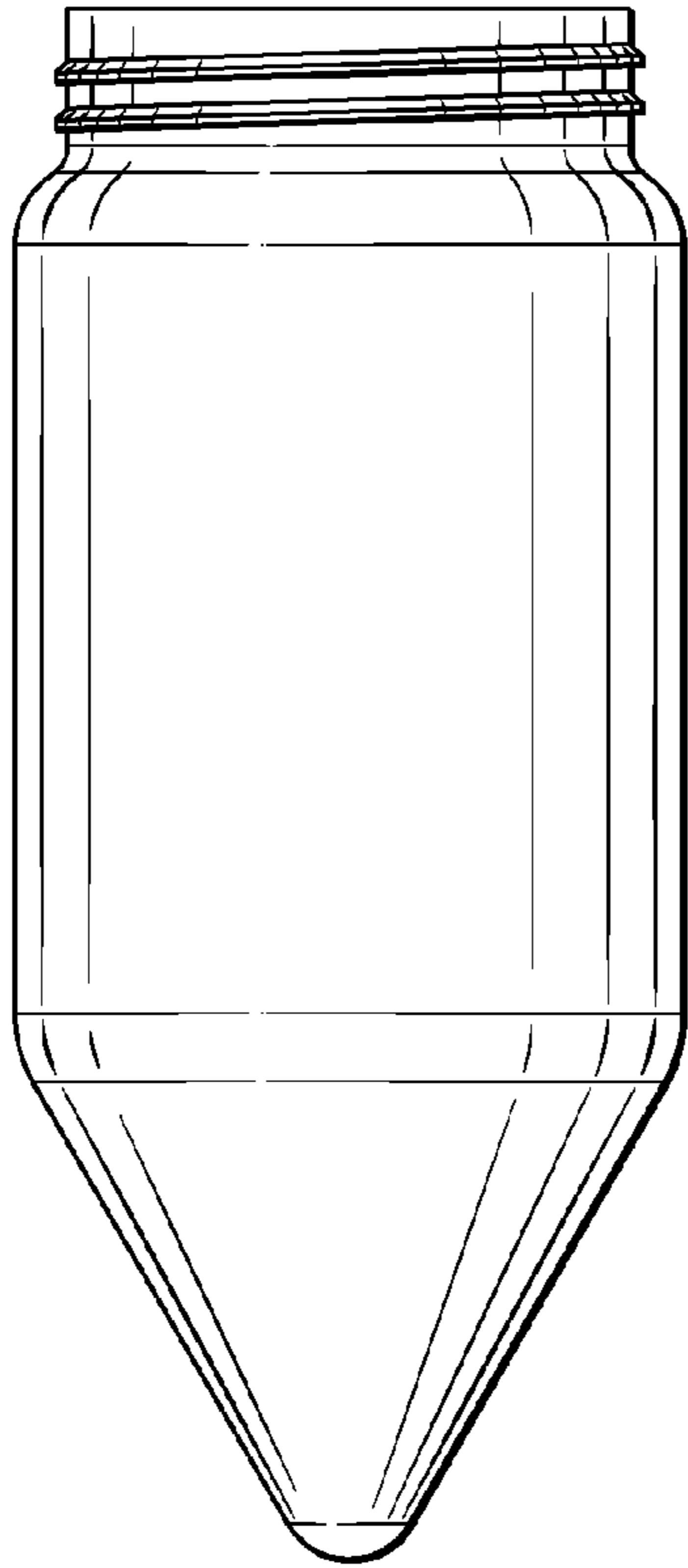

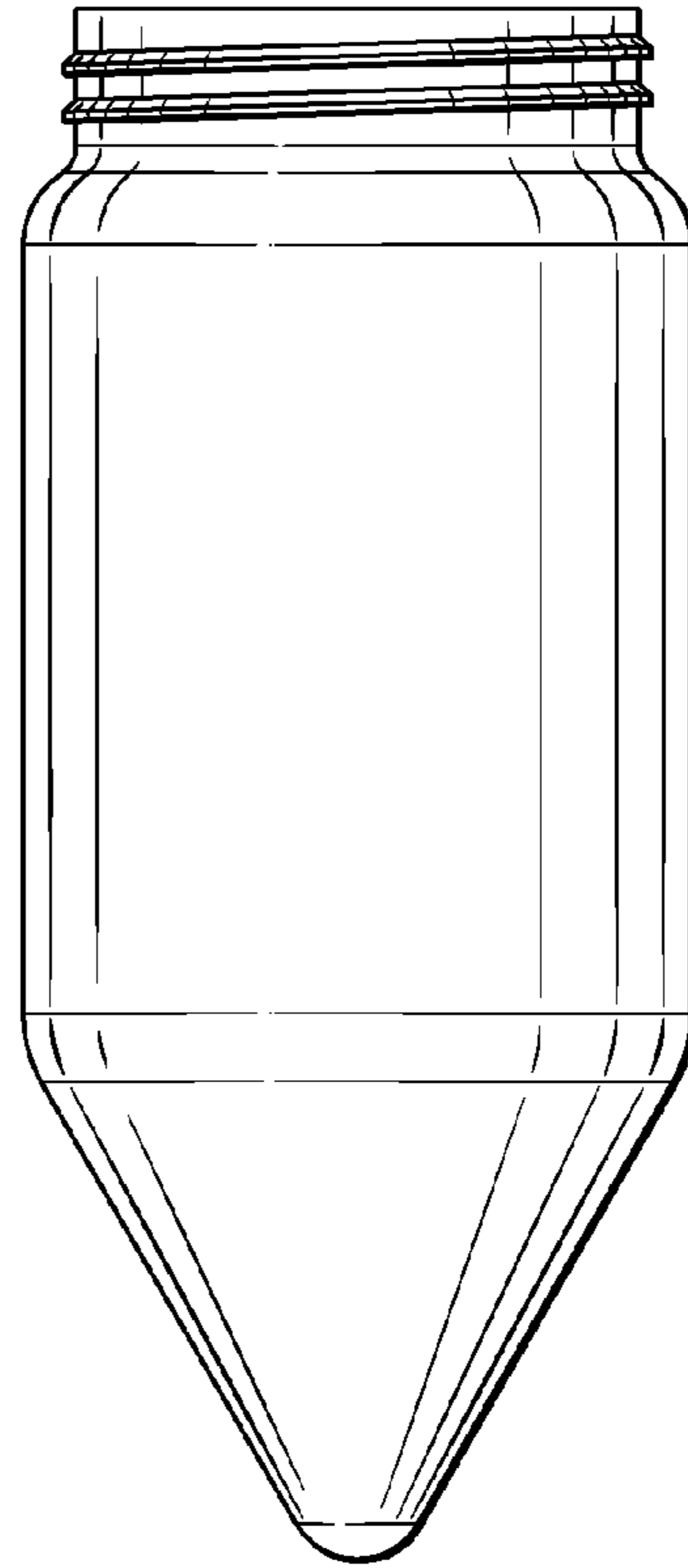

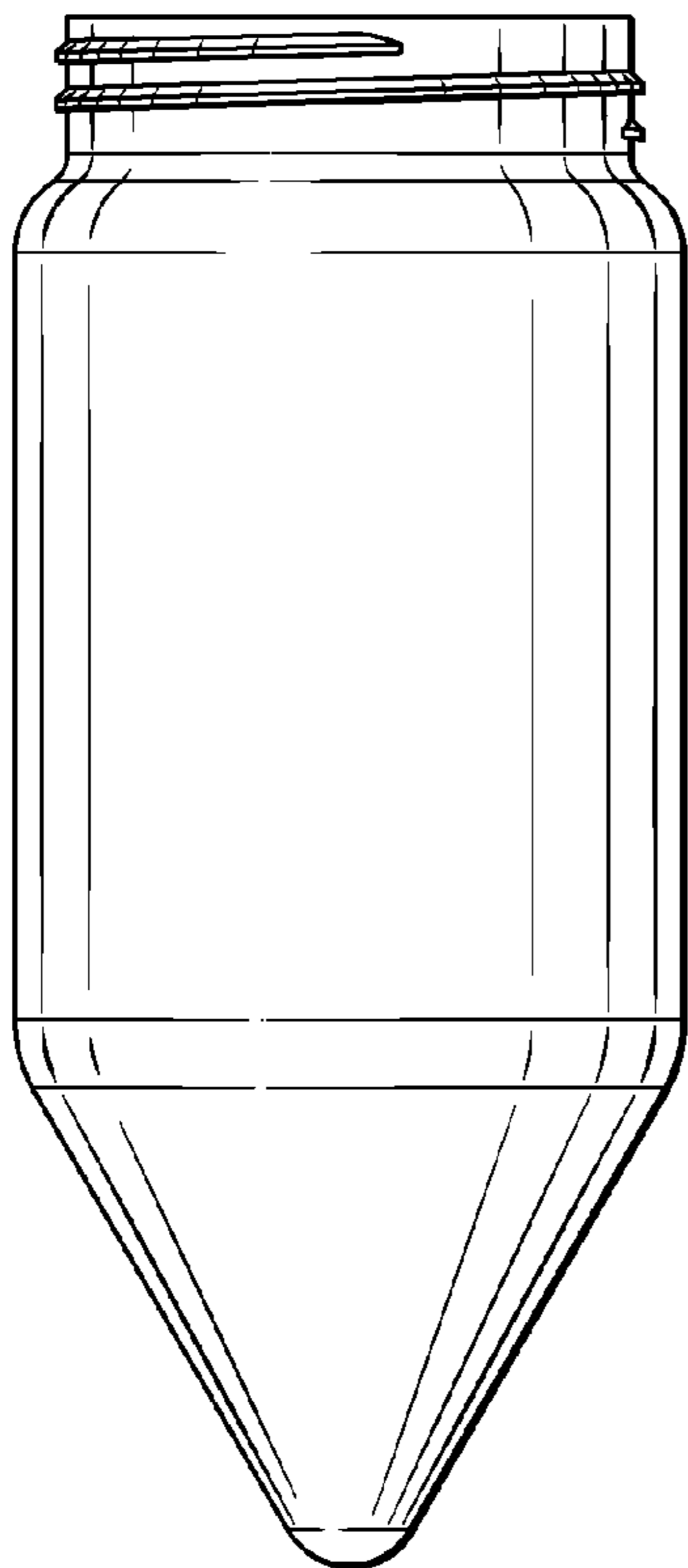

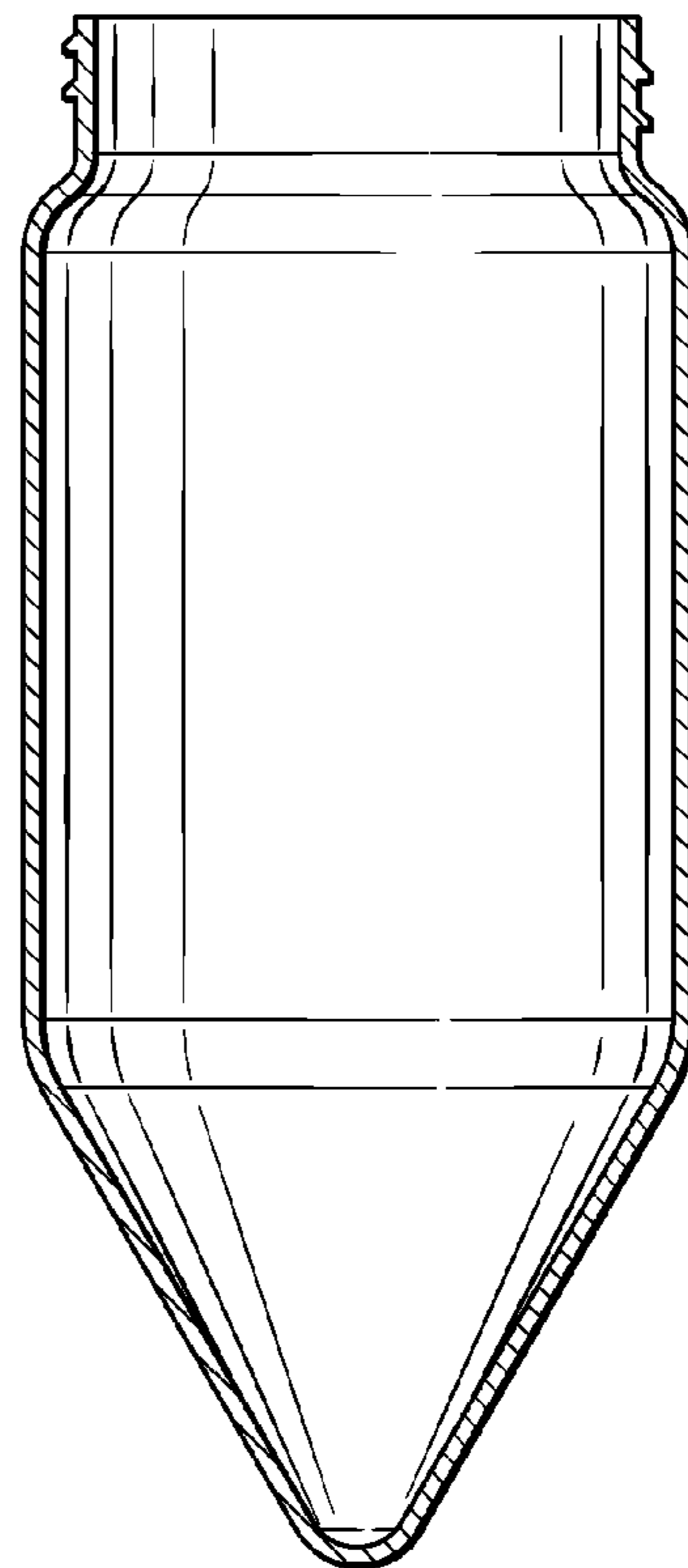

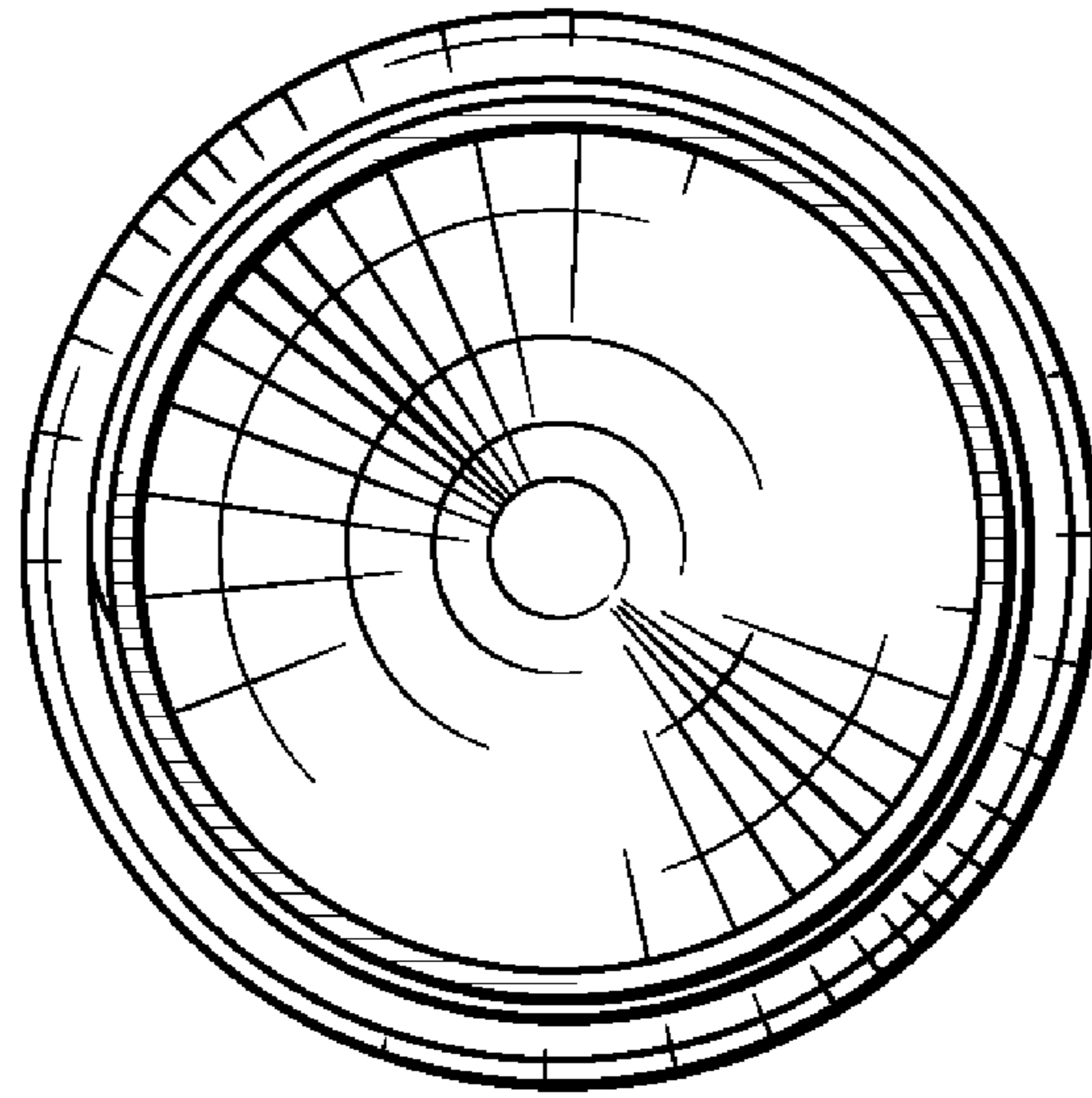

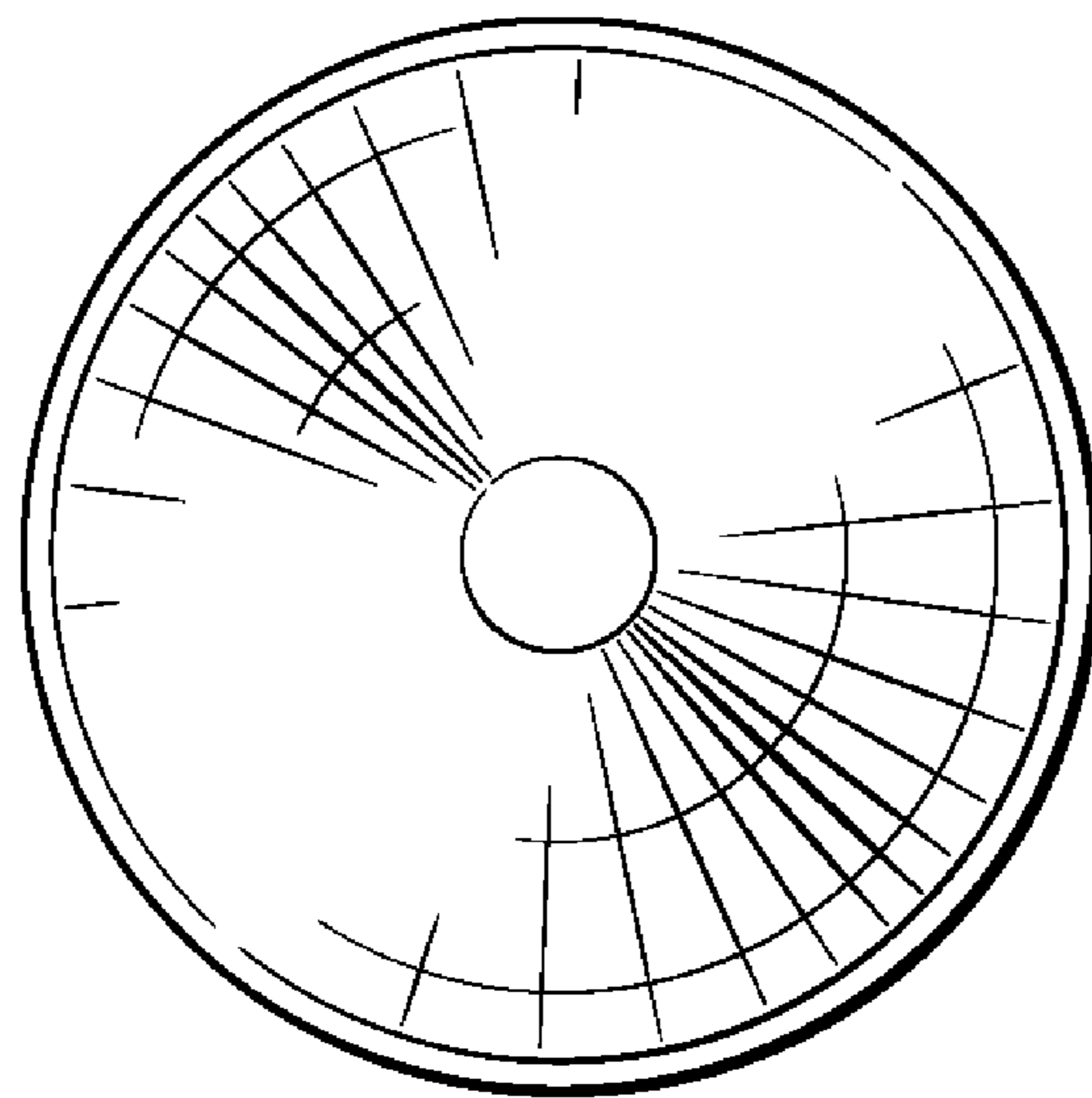
