FIG. 4 is a side planar view of the container of FIG. 1;

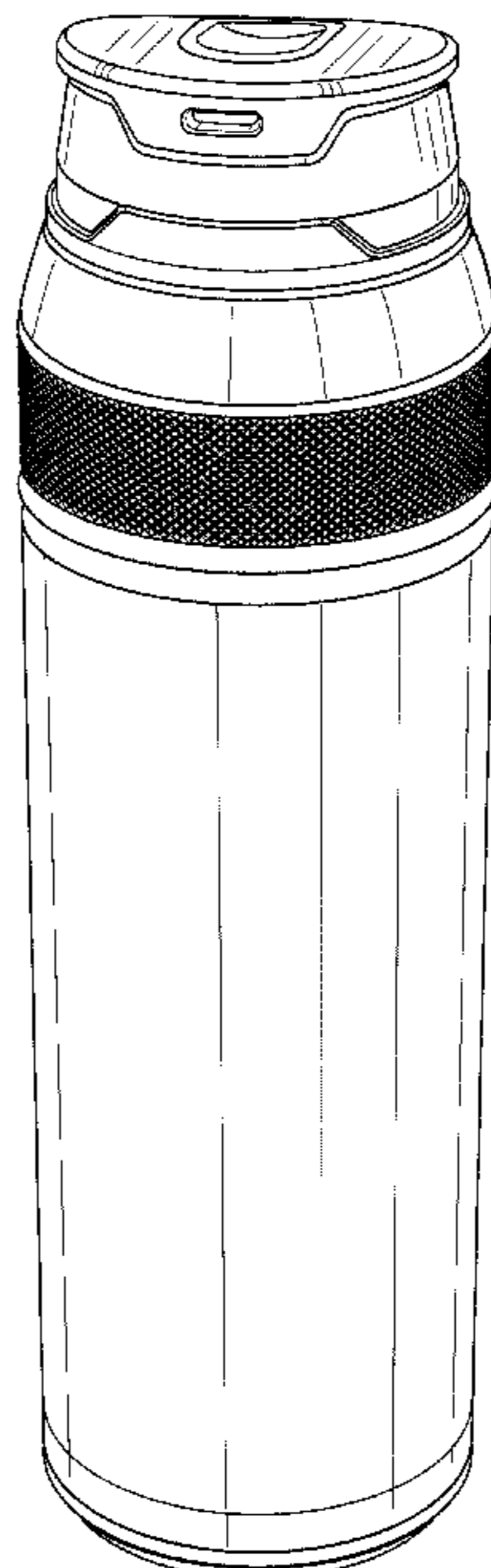
FIG. 5 is another side planar view of the container of FIG. 1, opposite the side view shown in FIG. 4;

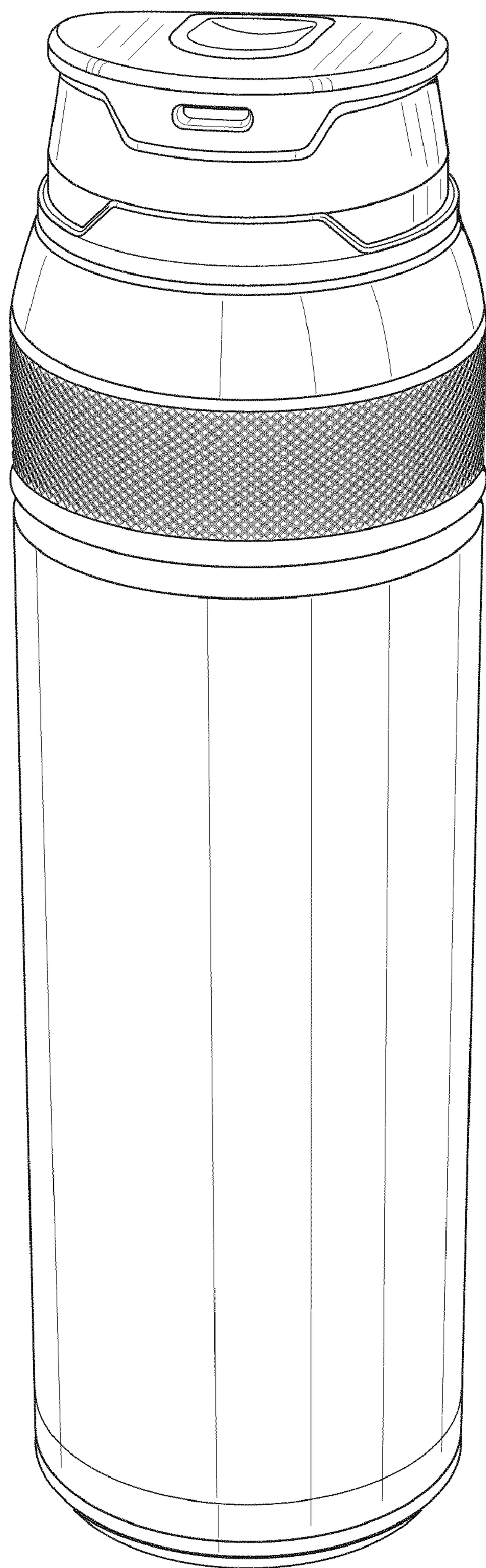

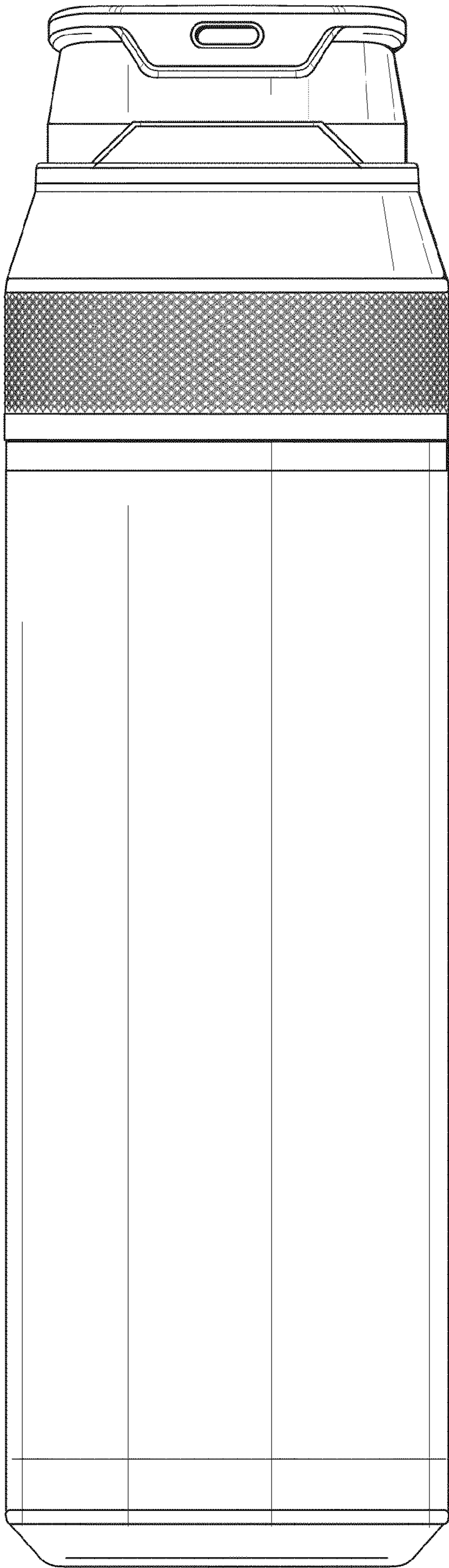

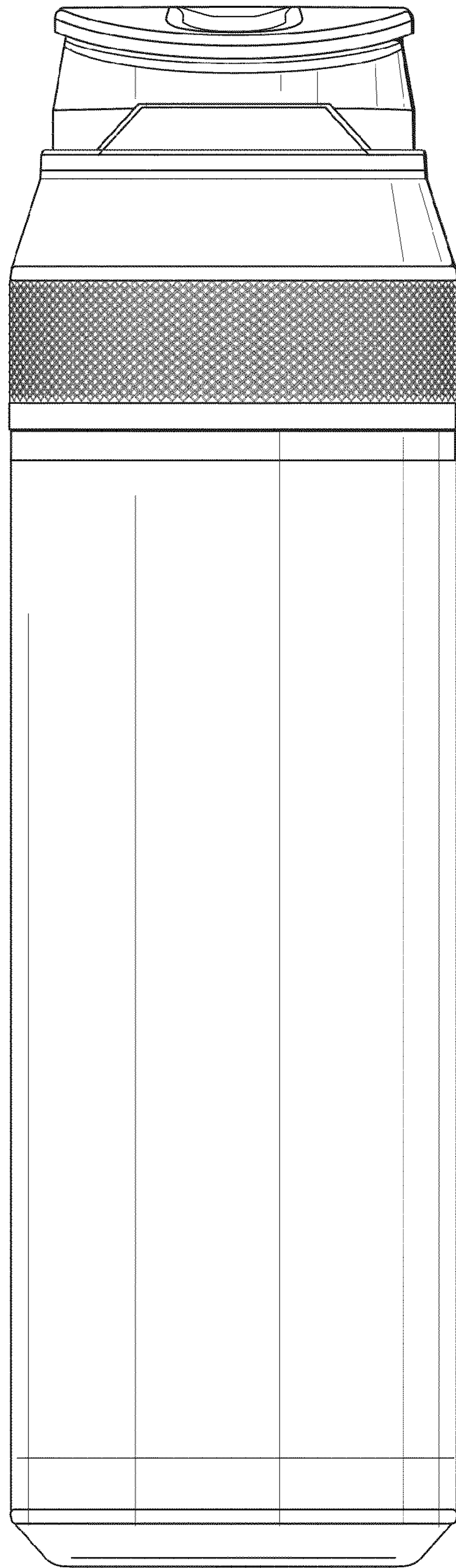

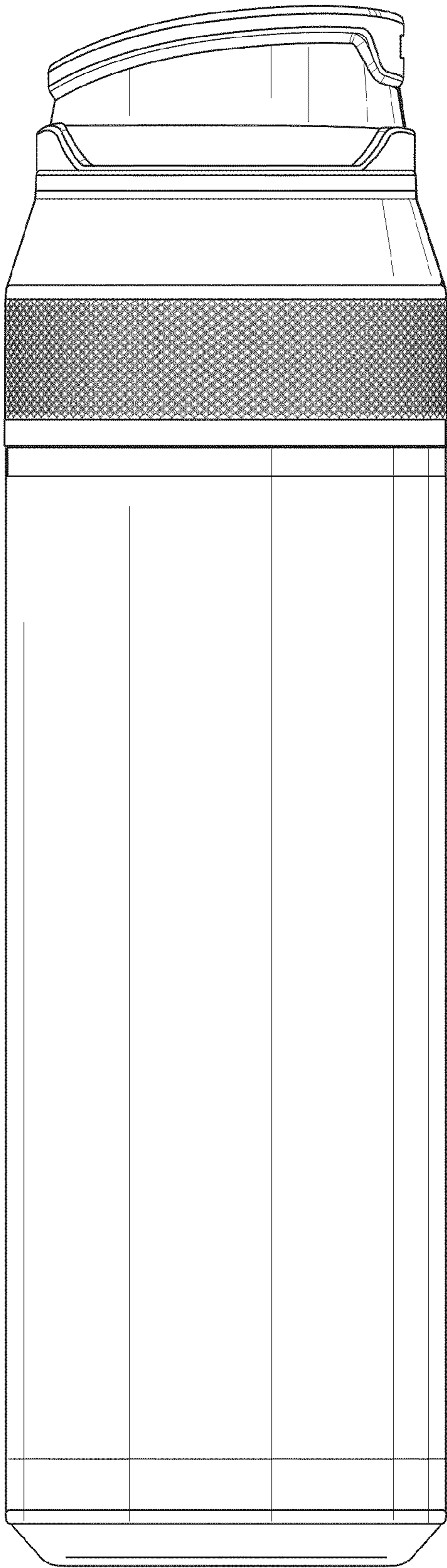

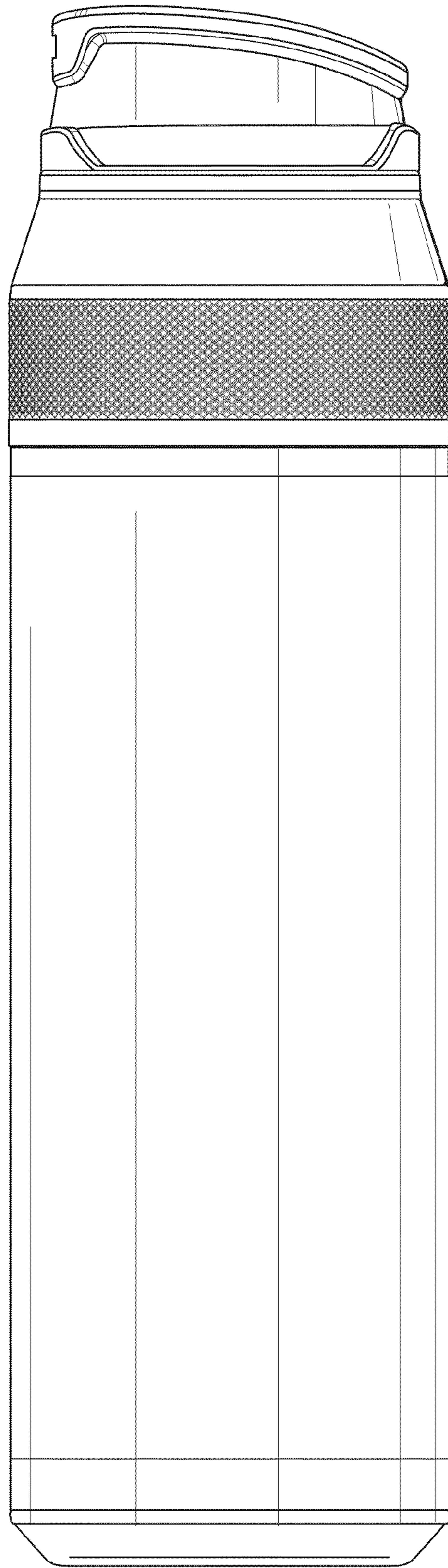

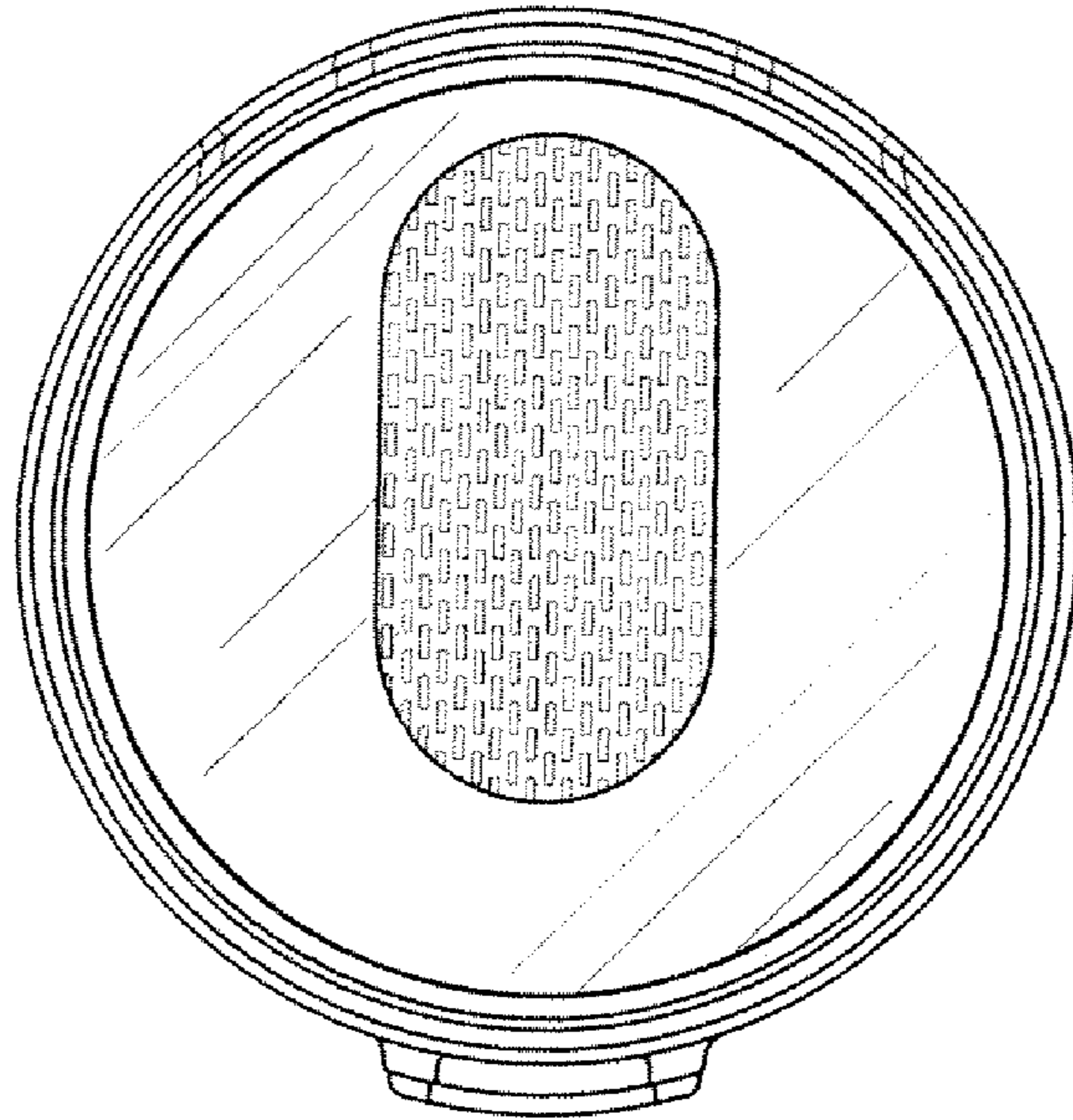

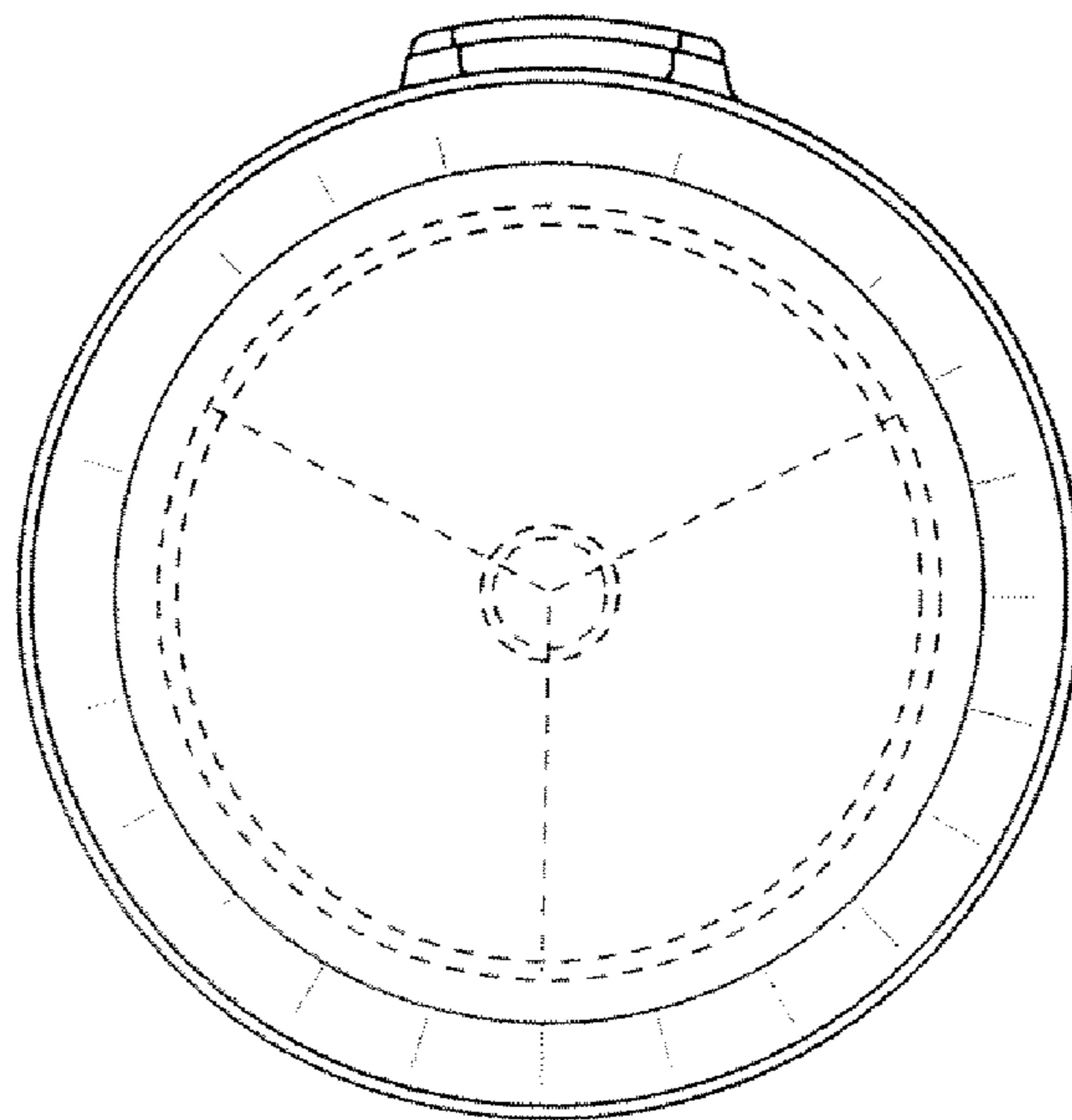

FIG. 4 is a side planar view of the container of FIG. 1;

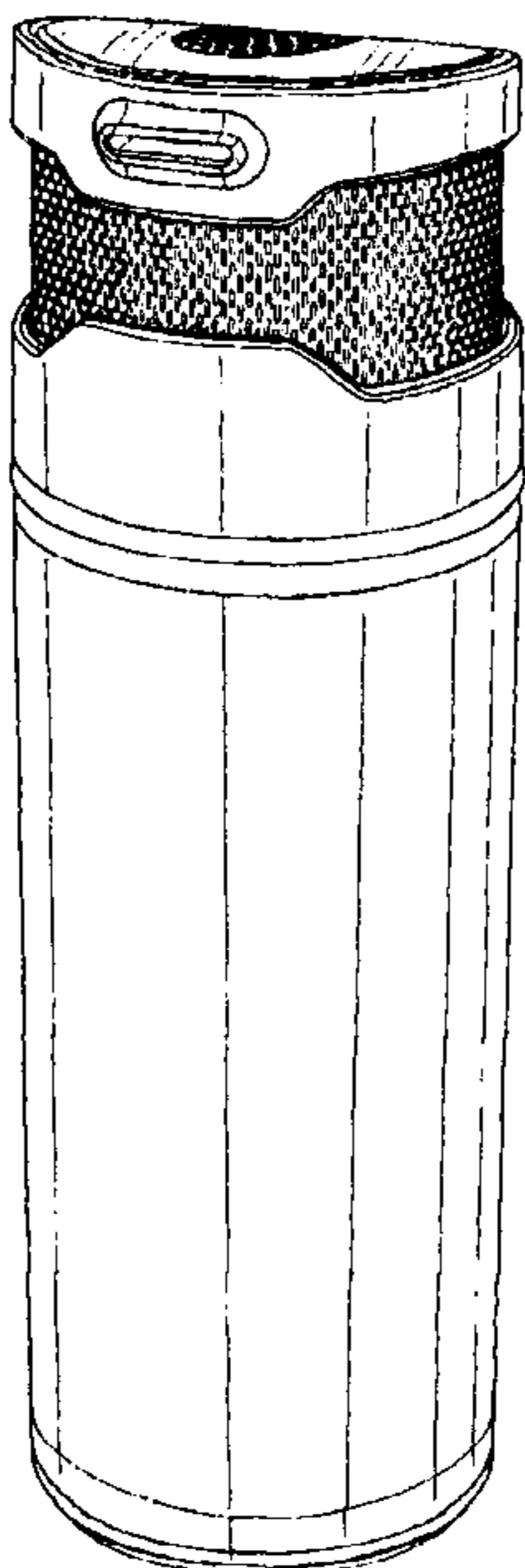
FIG. 5 is another side planar view of the container of FIG. 1, opposite the side view shown in FIG. 4;

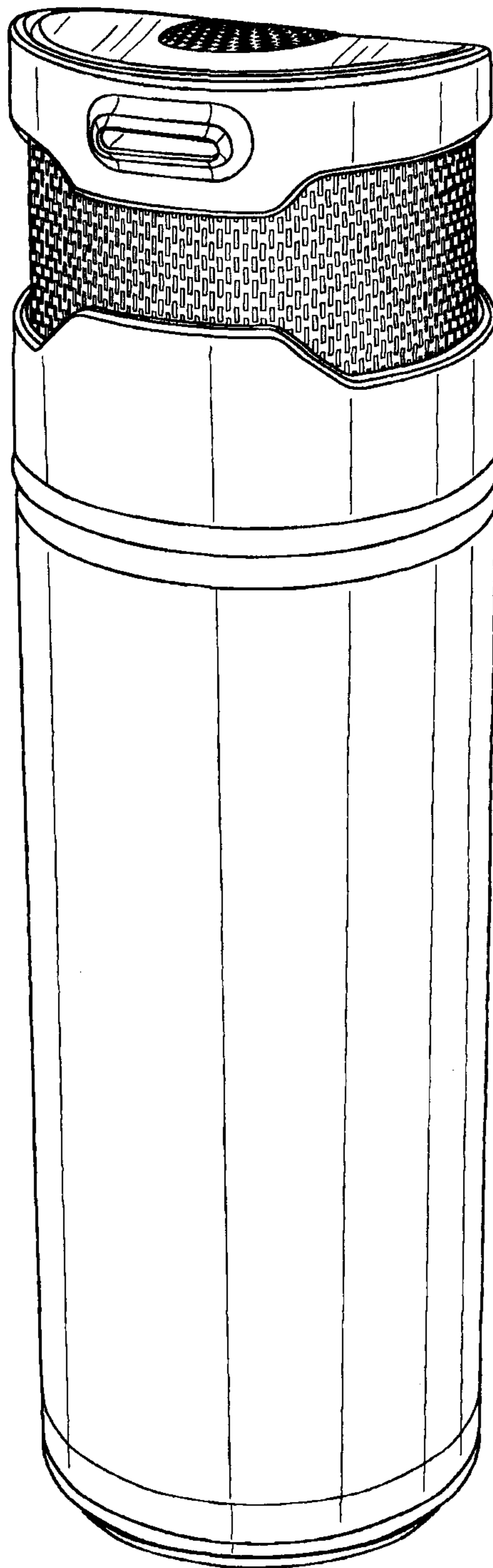

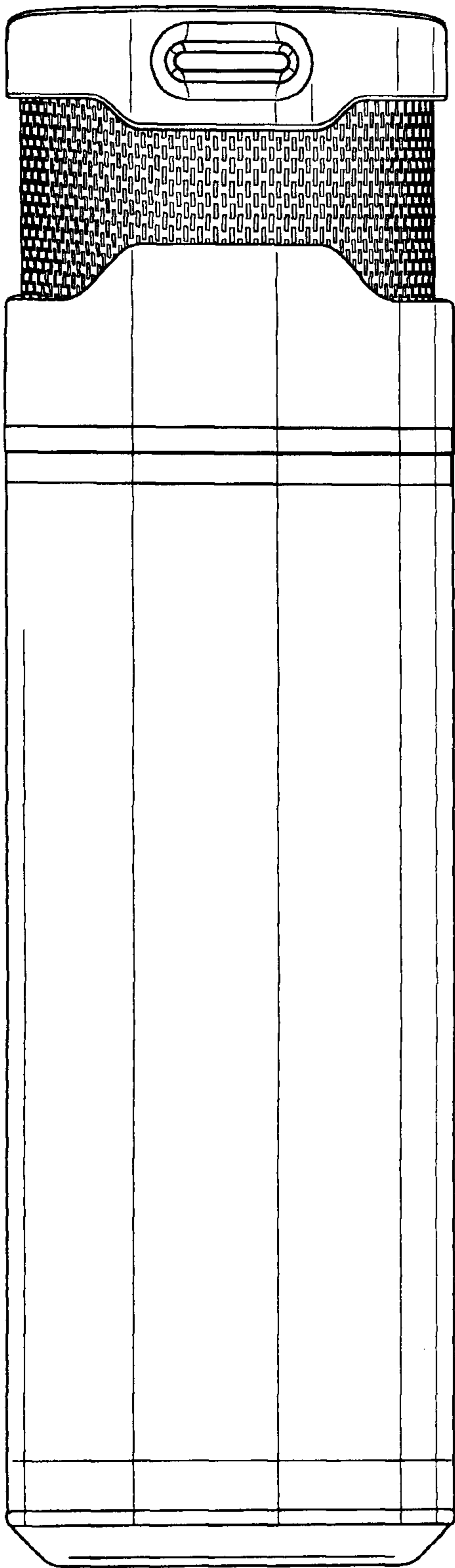

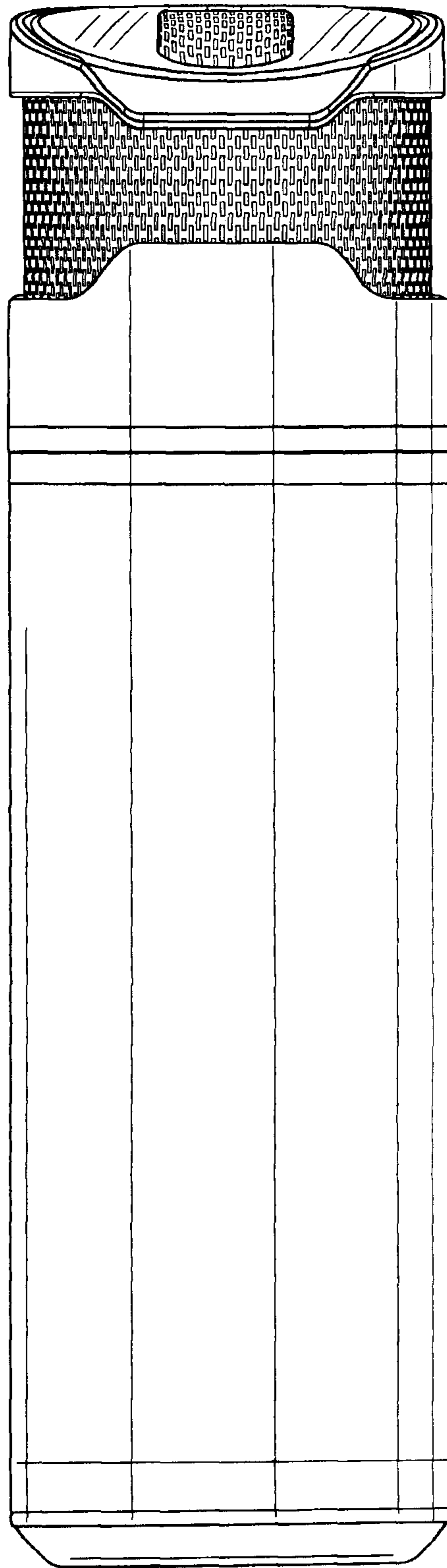

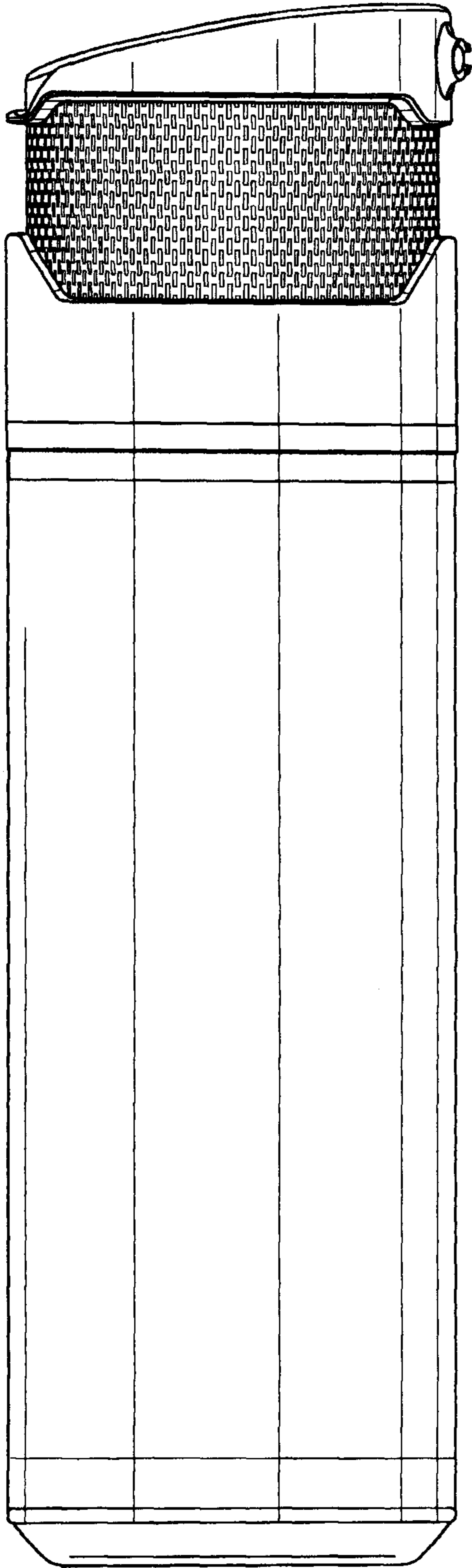

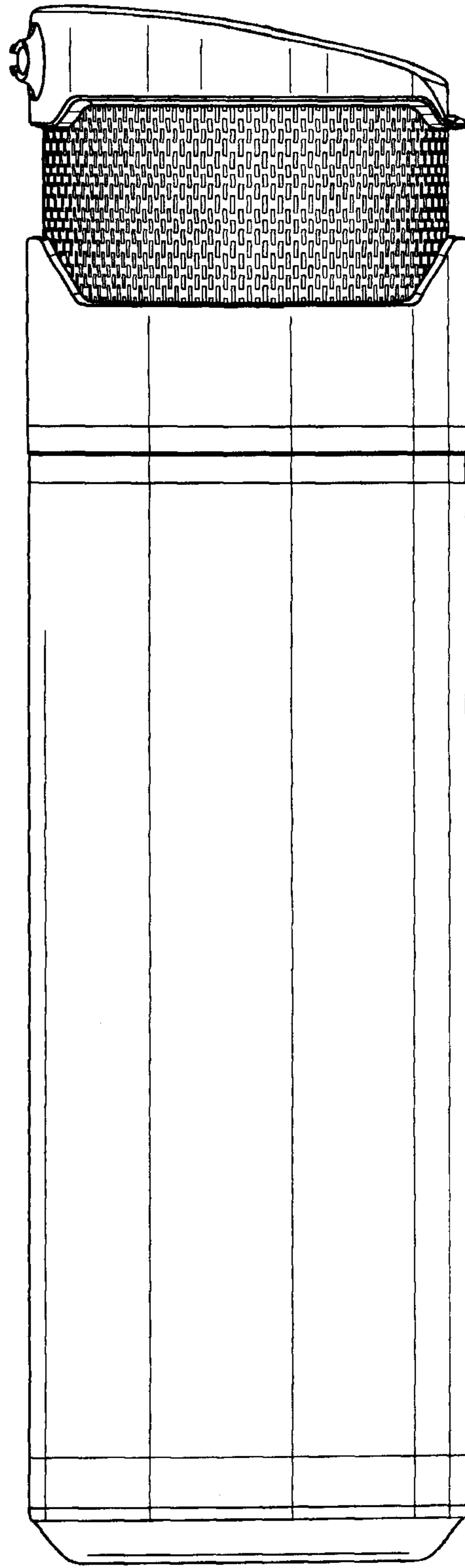
