FIG. 2 shows a left side view of the vehicle shown in FIG. 1;

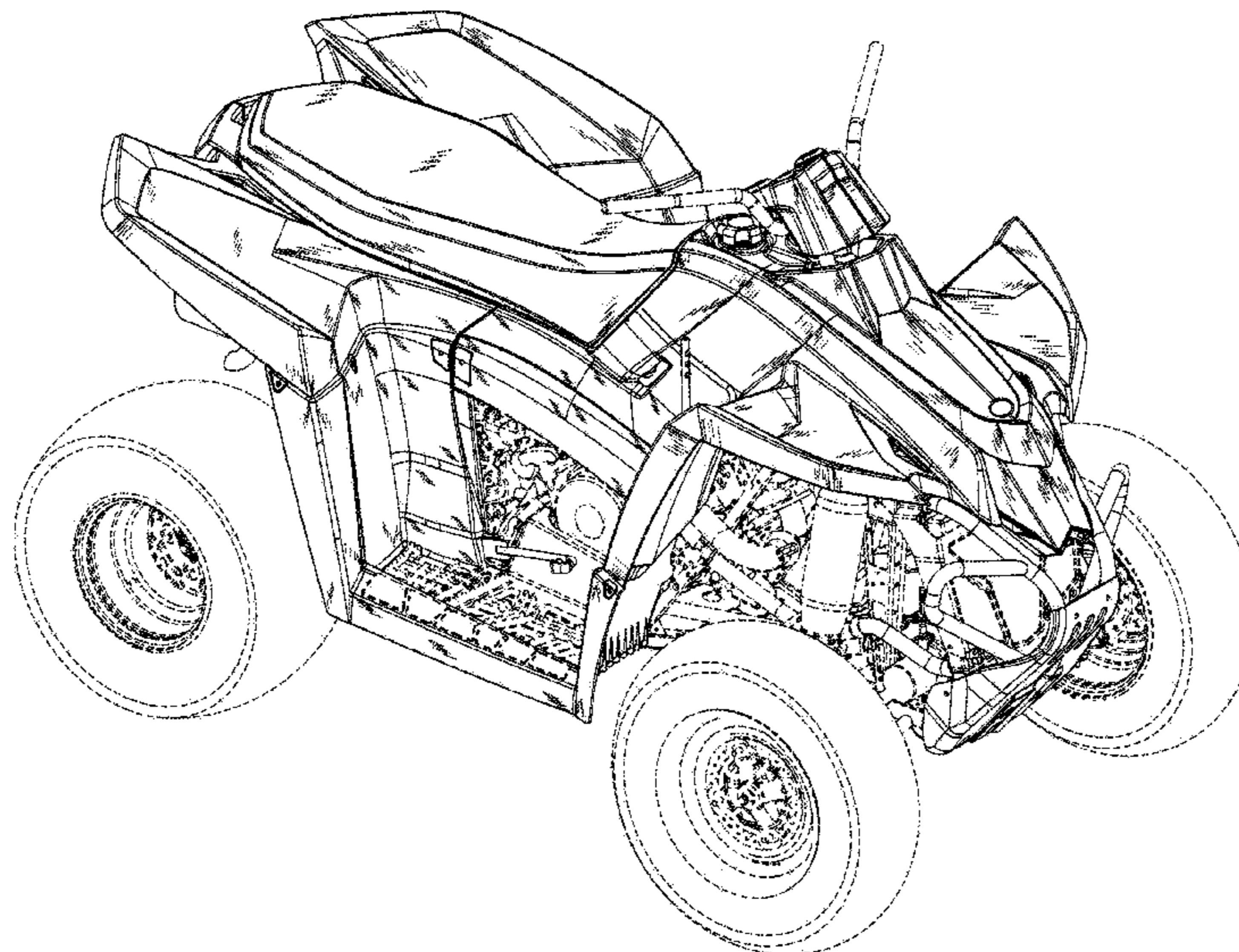
FIG. 3 shows a right side view of the vehicle shown in FIG. 1;

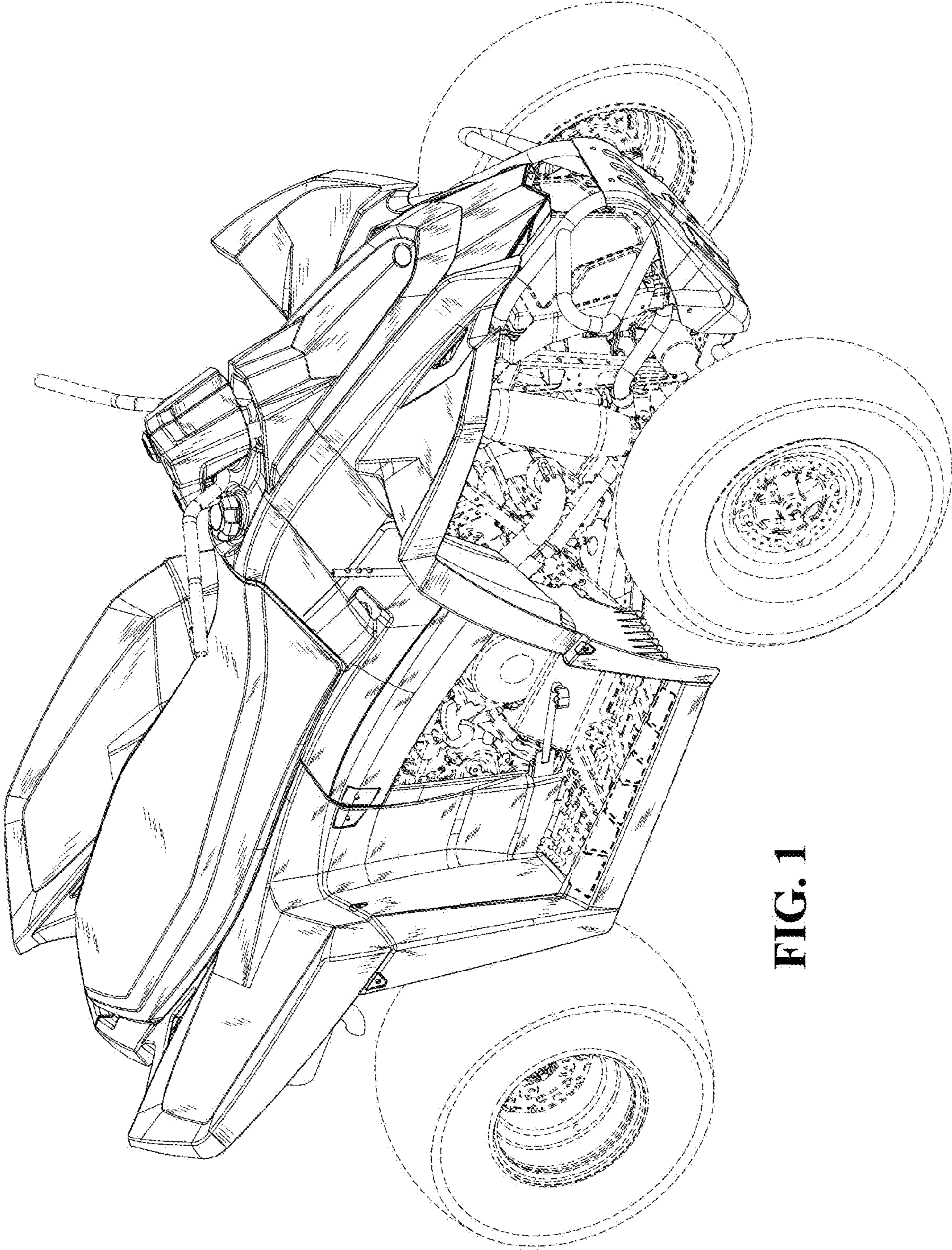

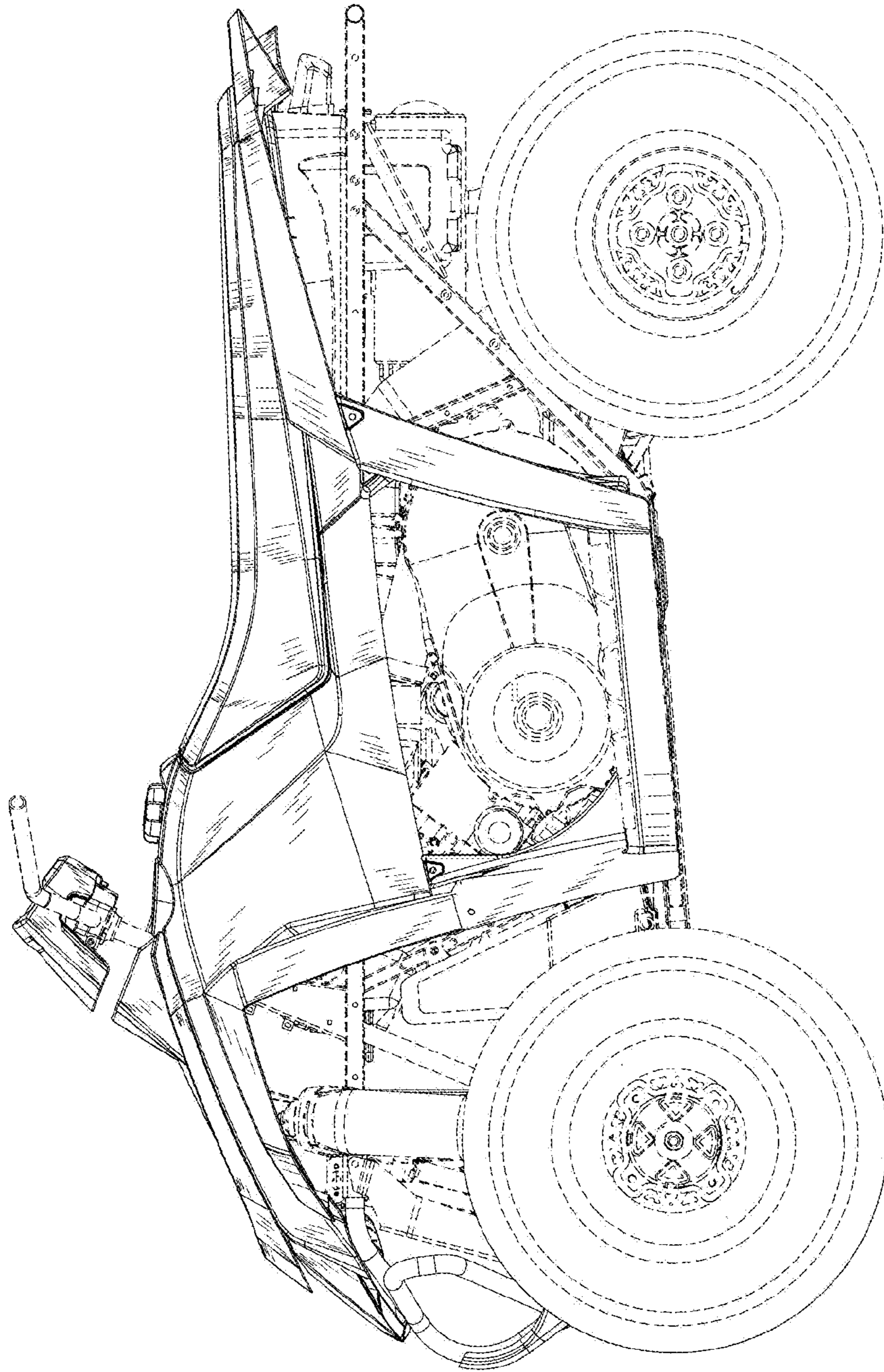

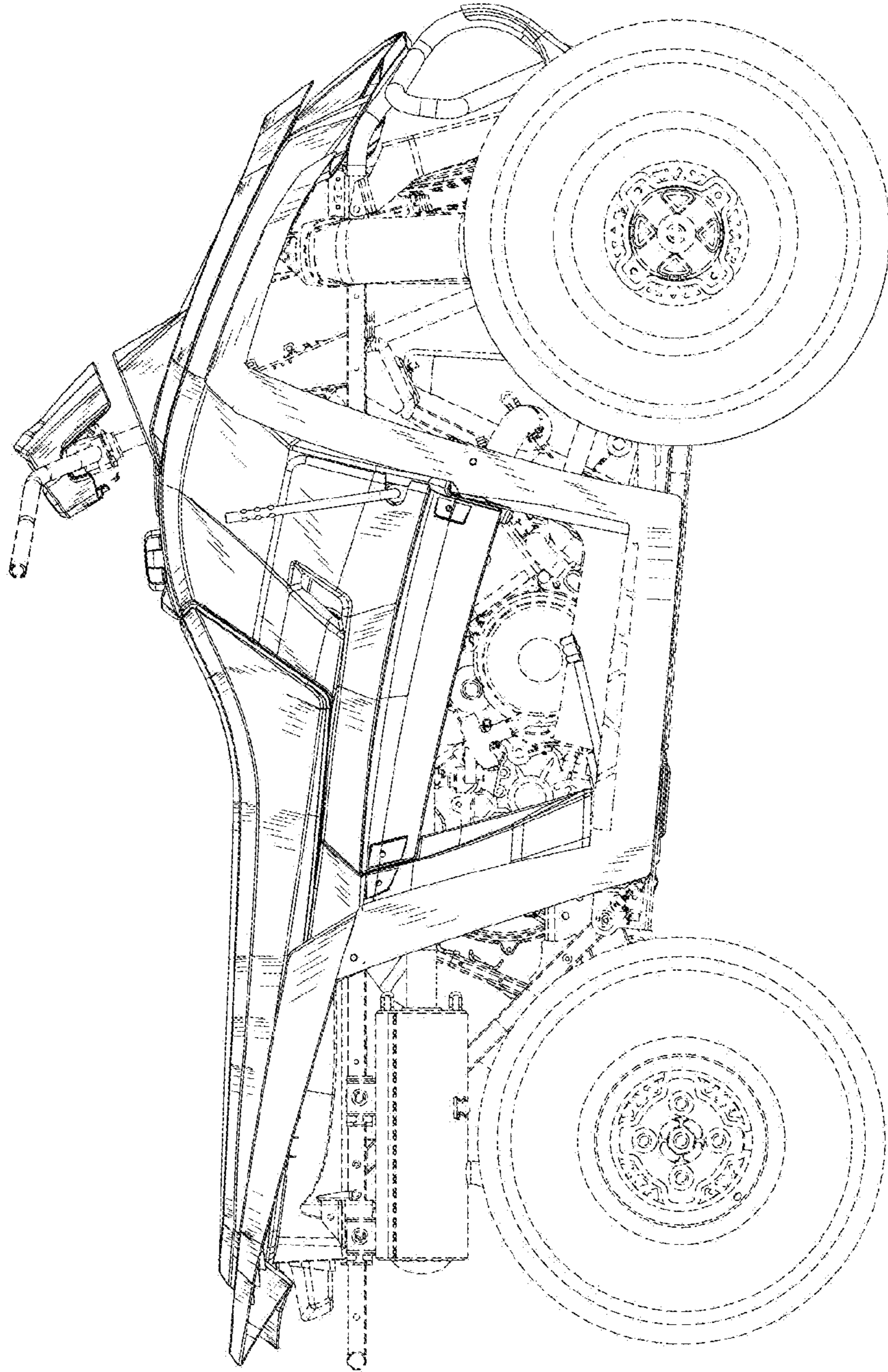

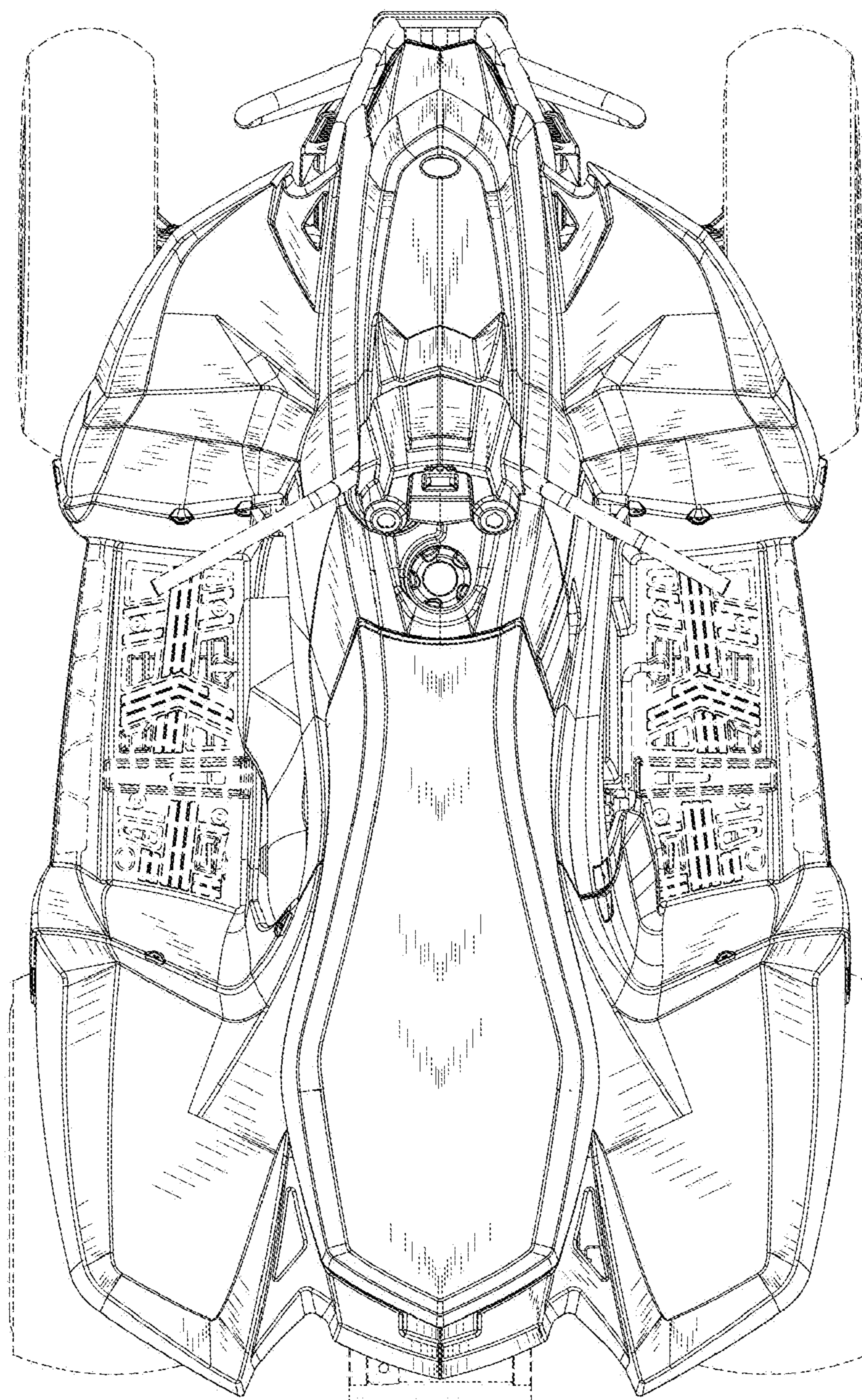

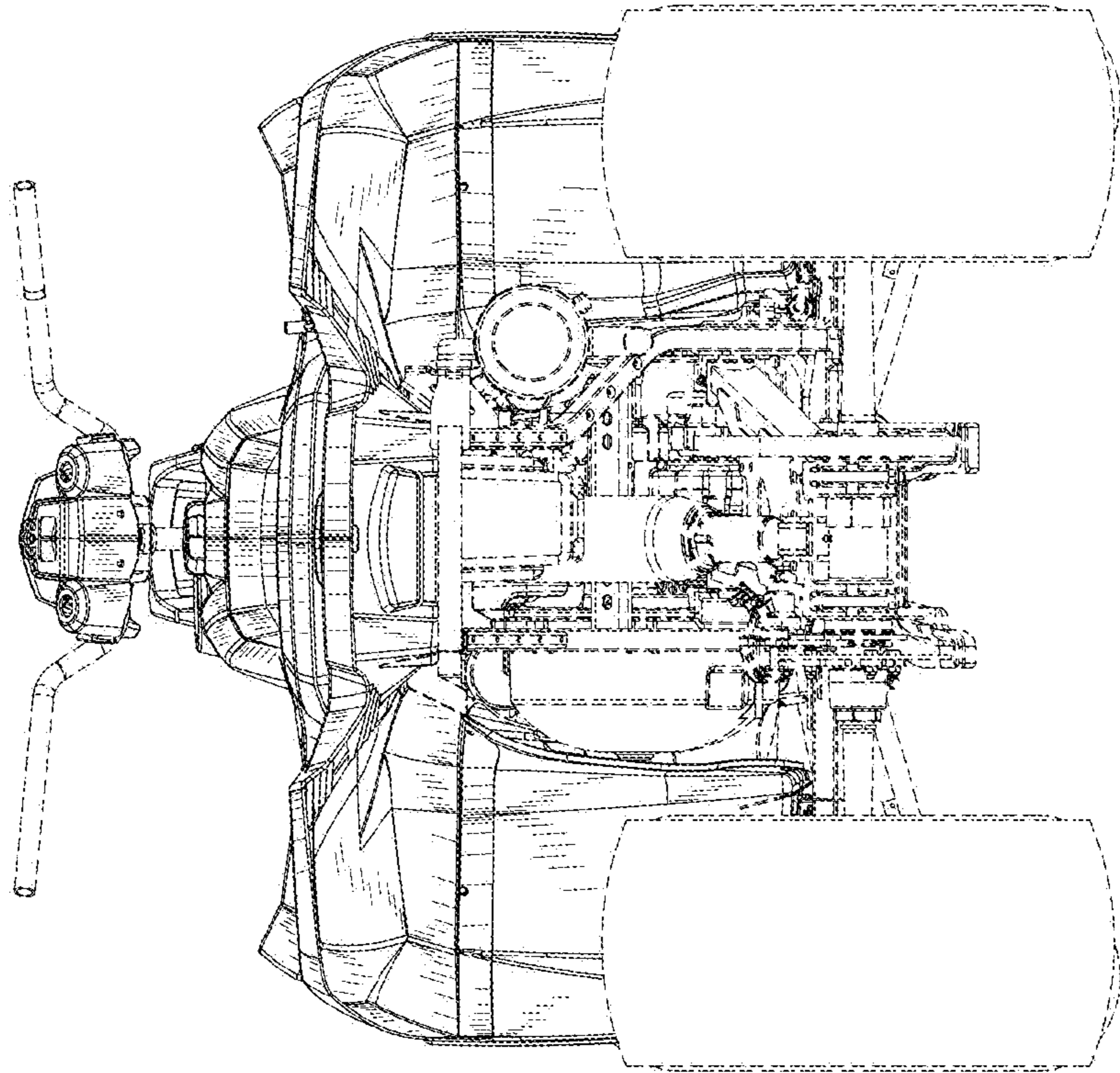

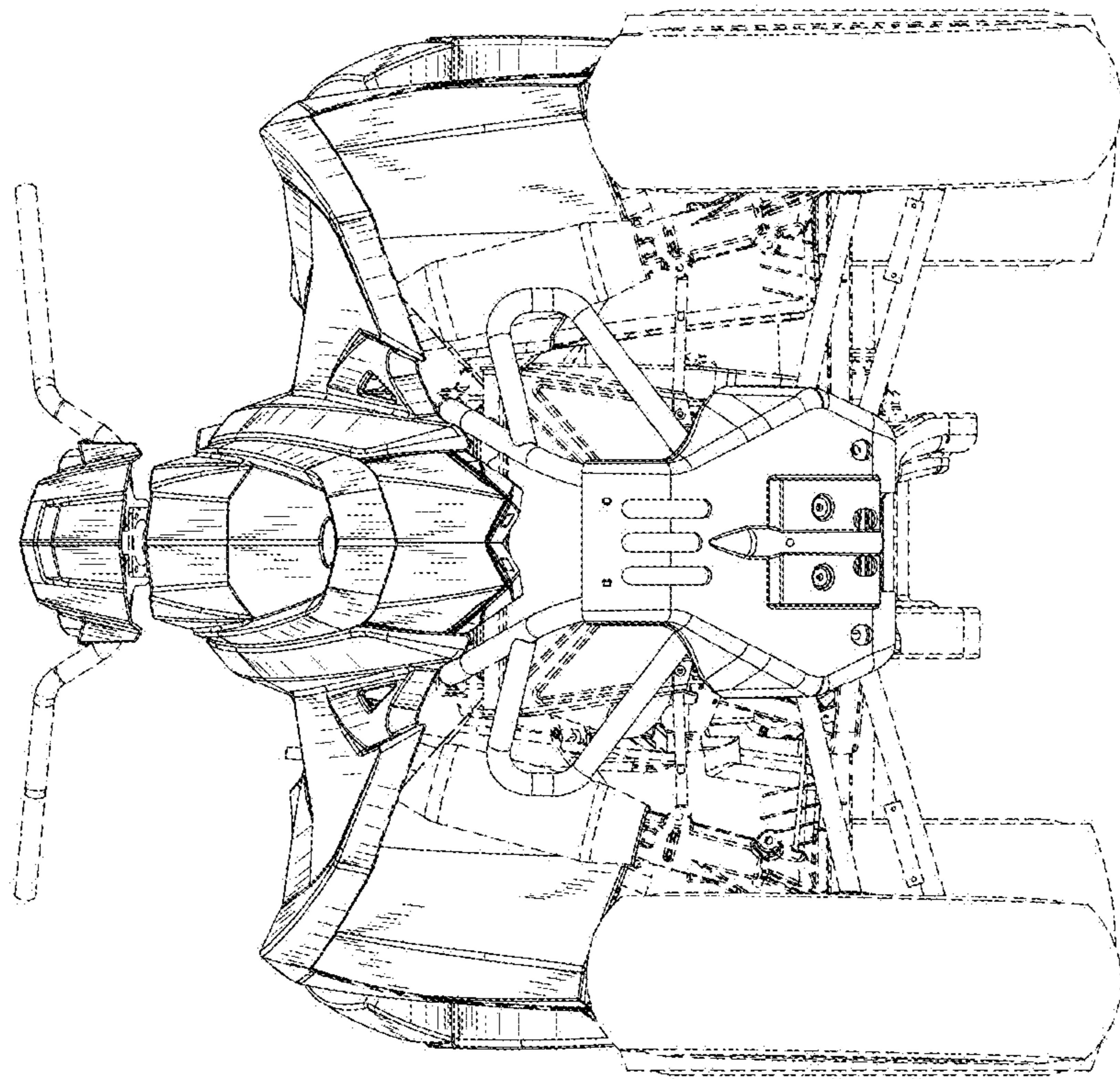
