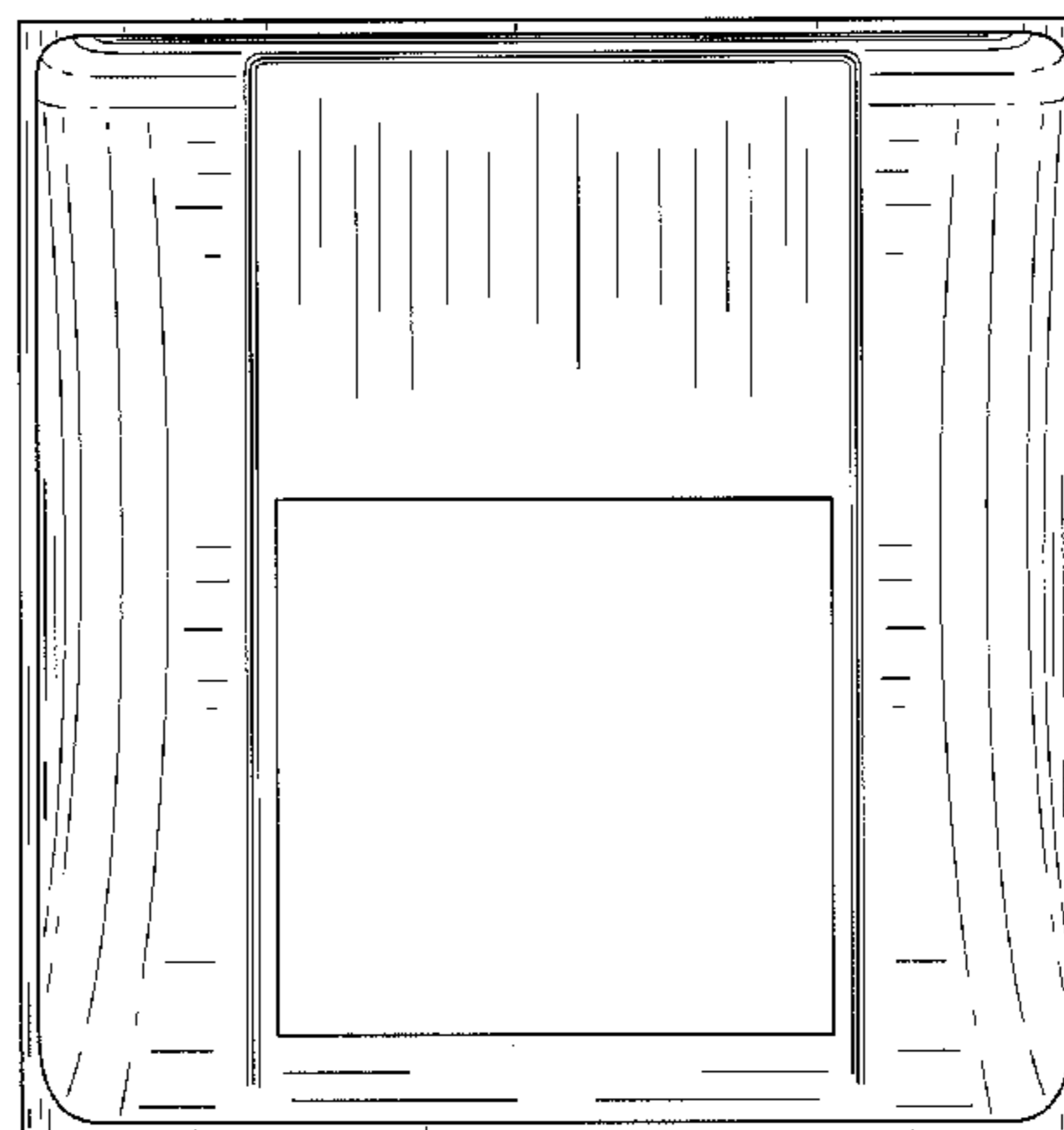
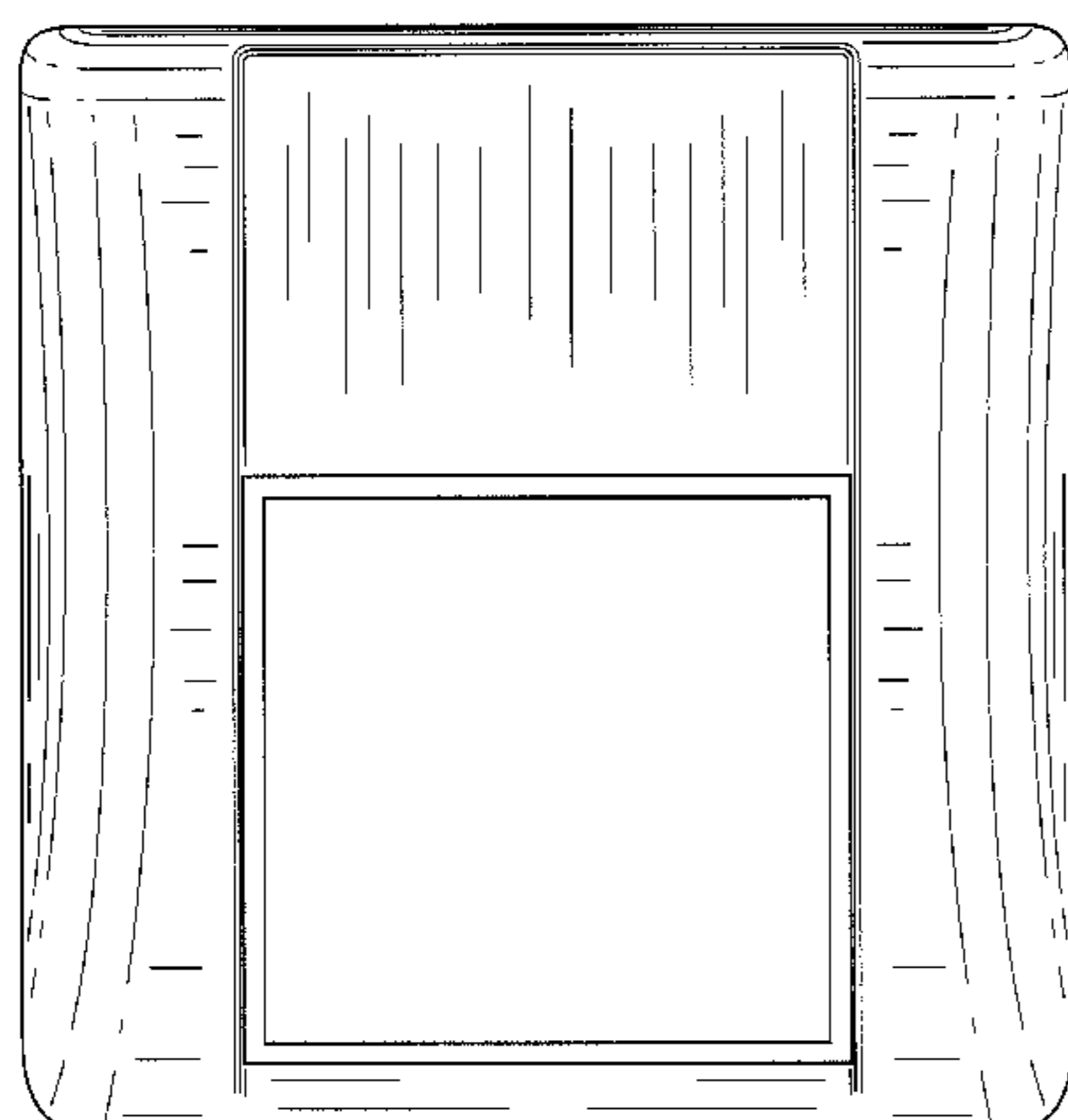
The ornamental design for a roof of bus, as shown and described.

DESCRIPTION

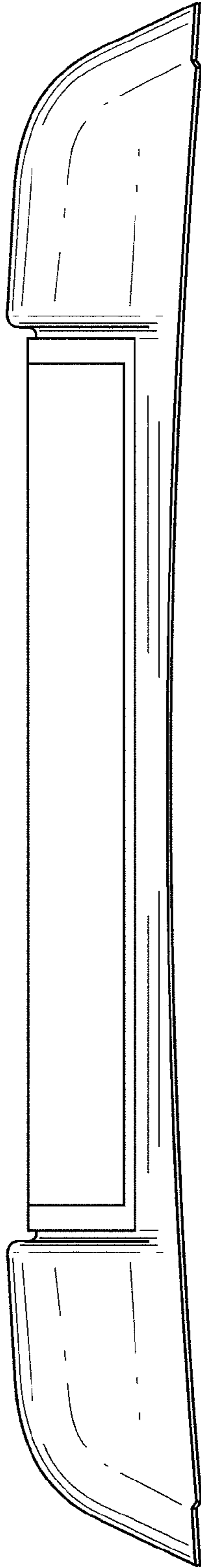

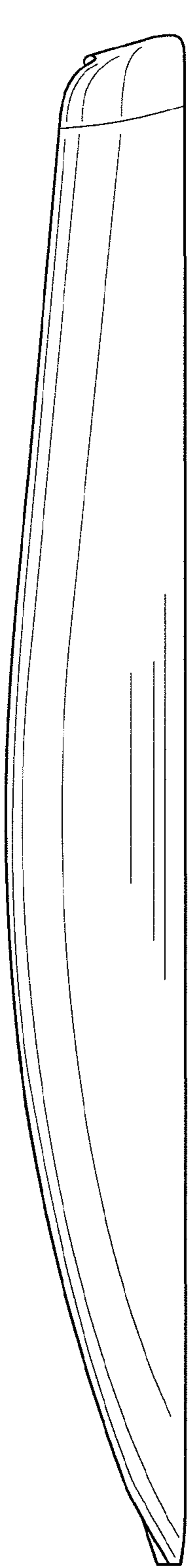

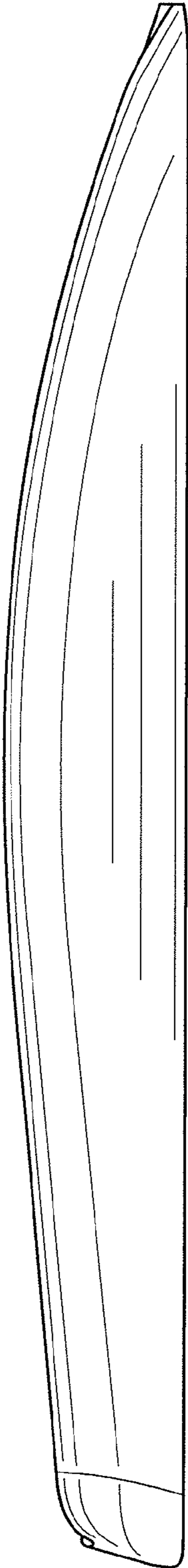

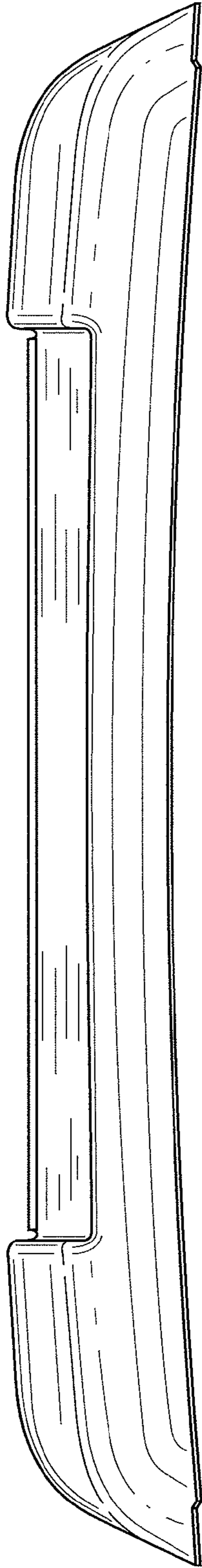
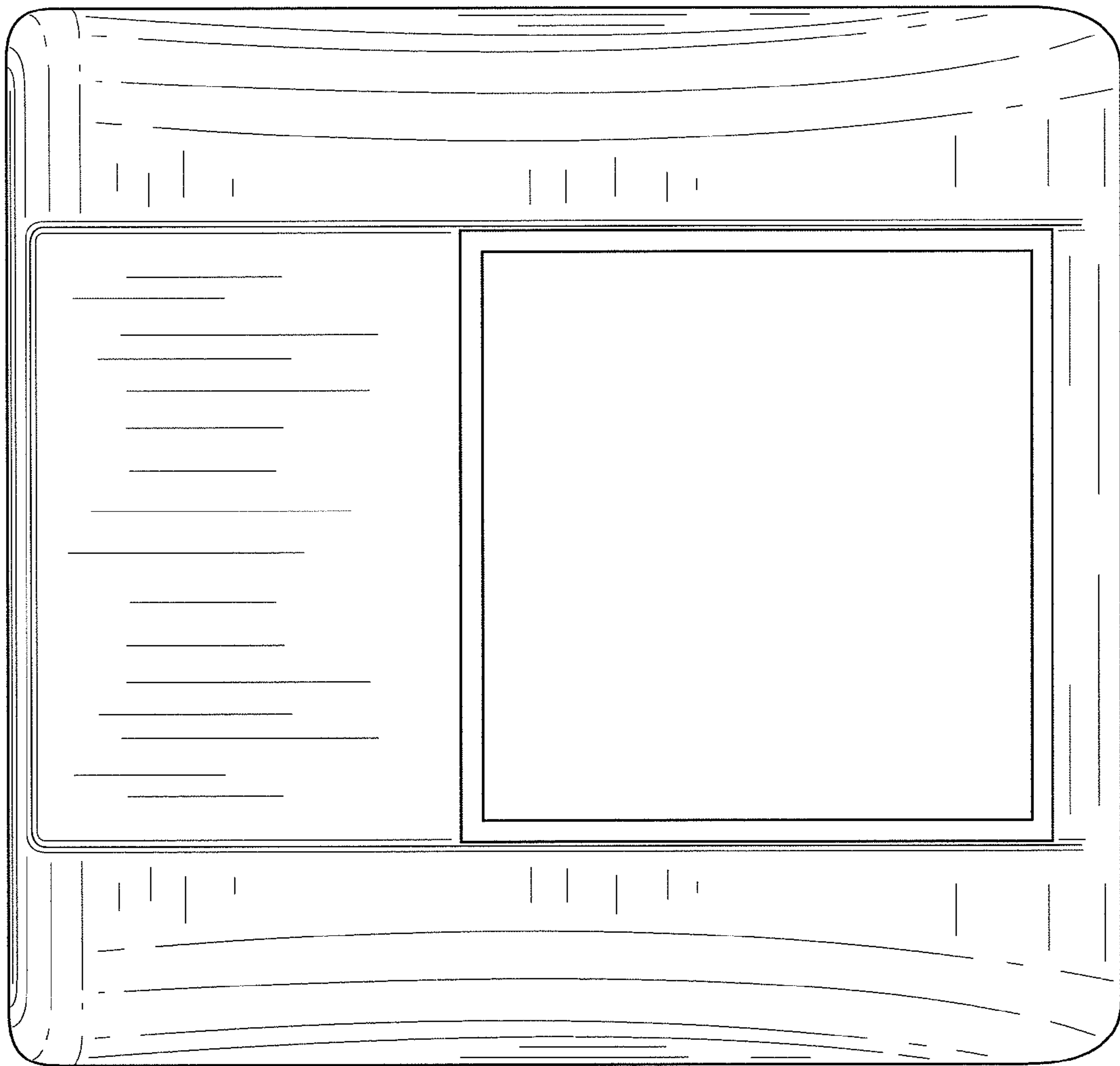

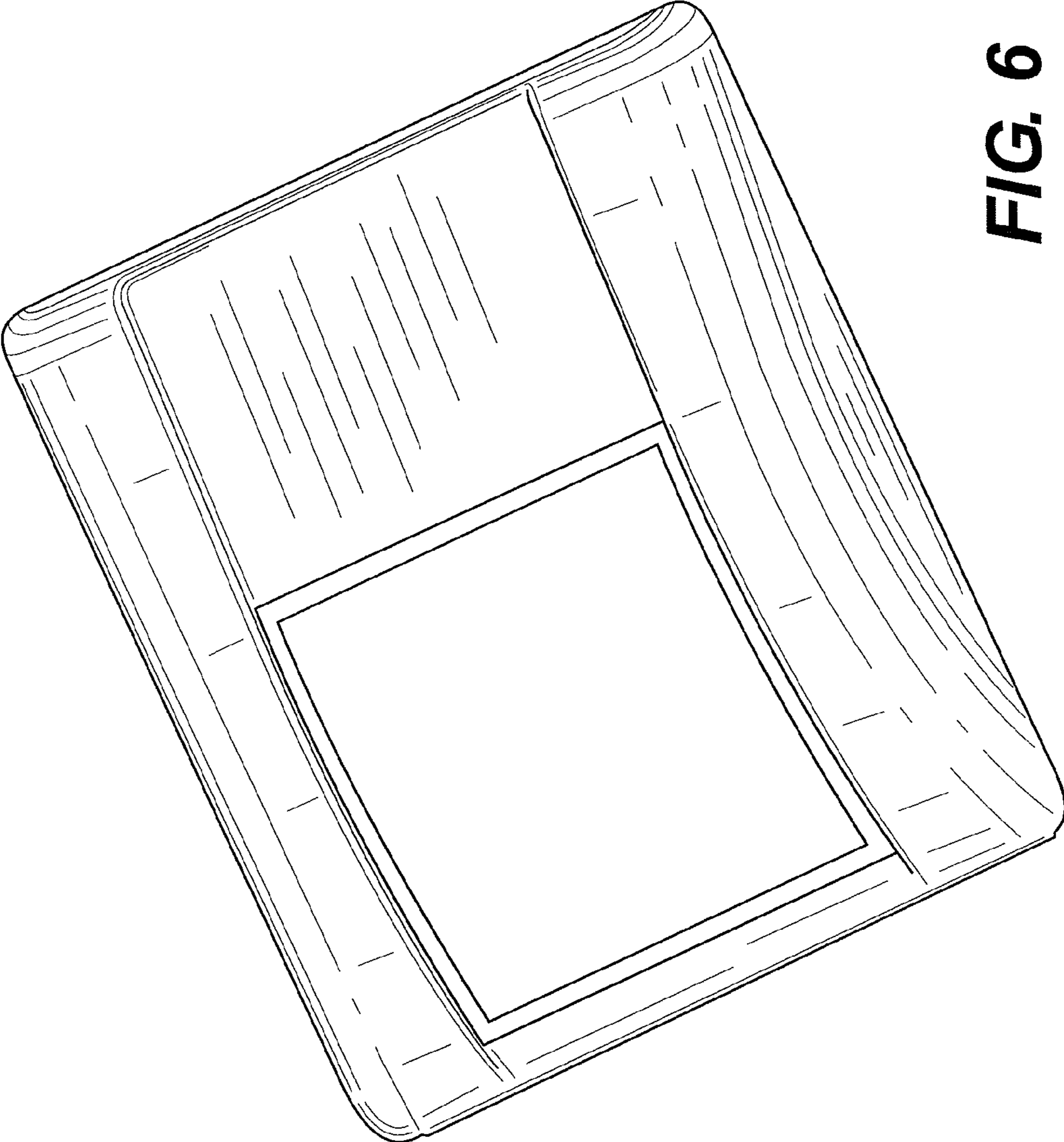

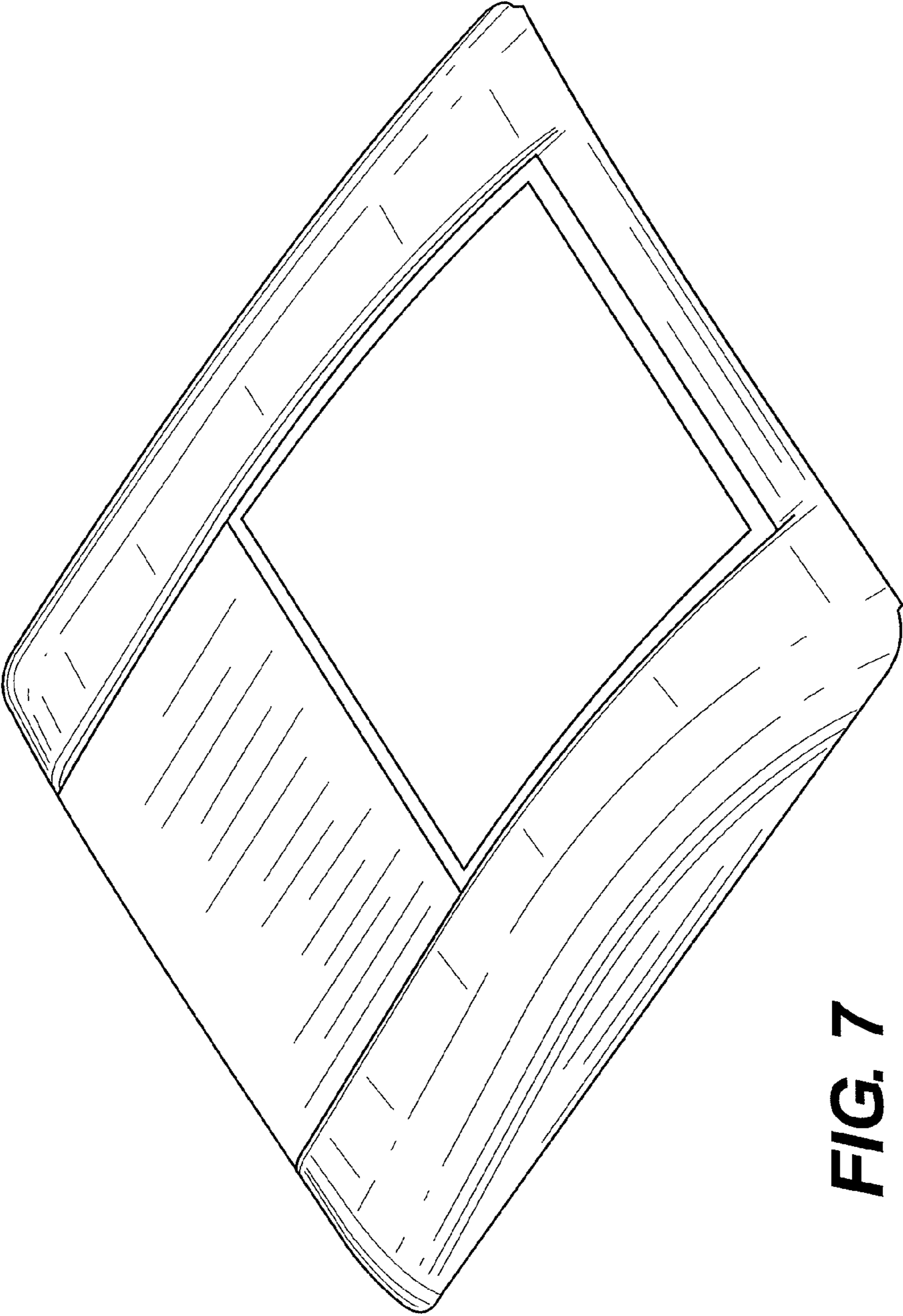

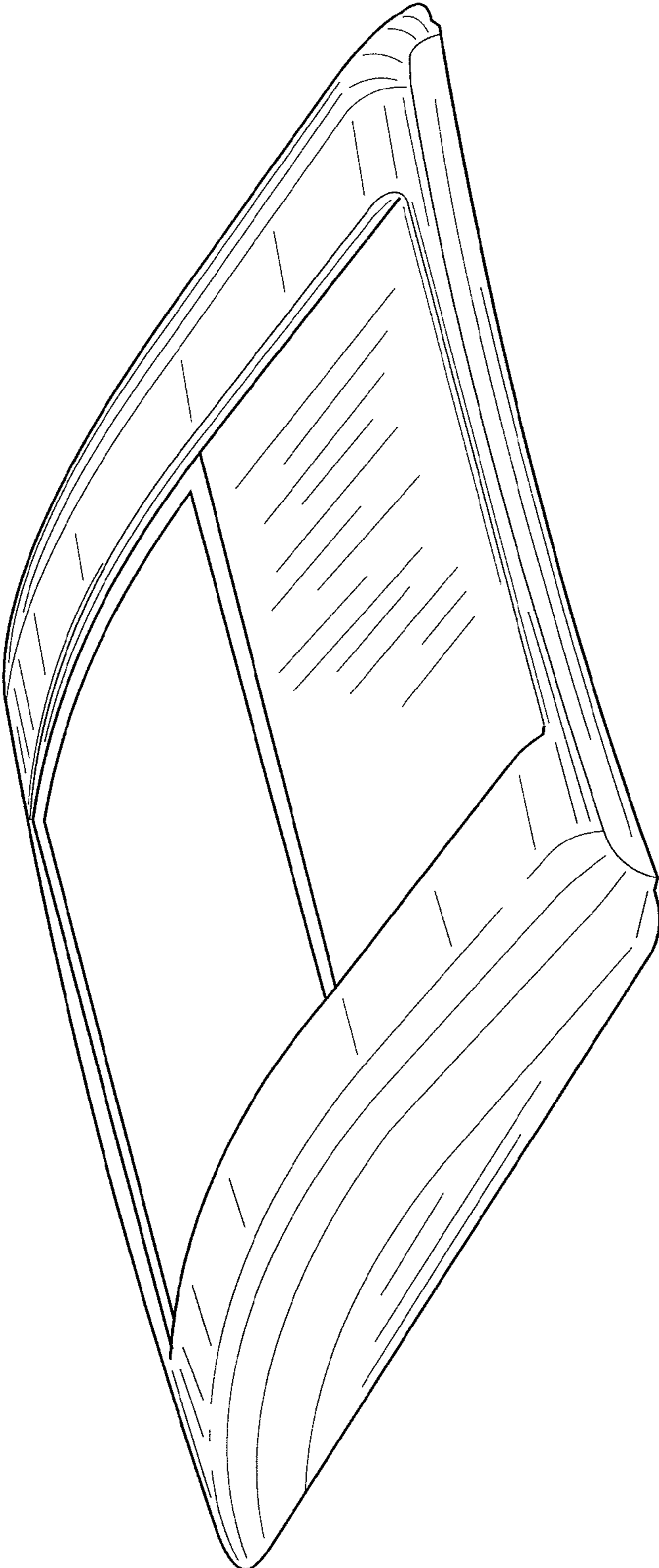

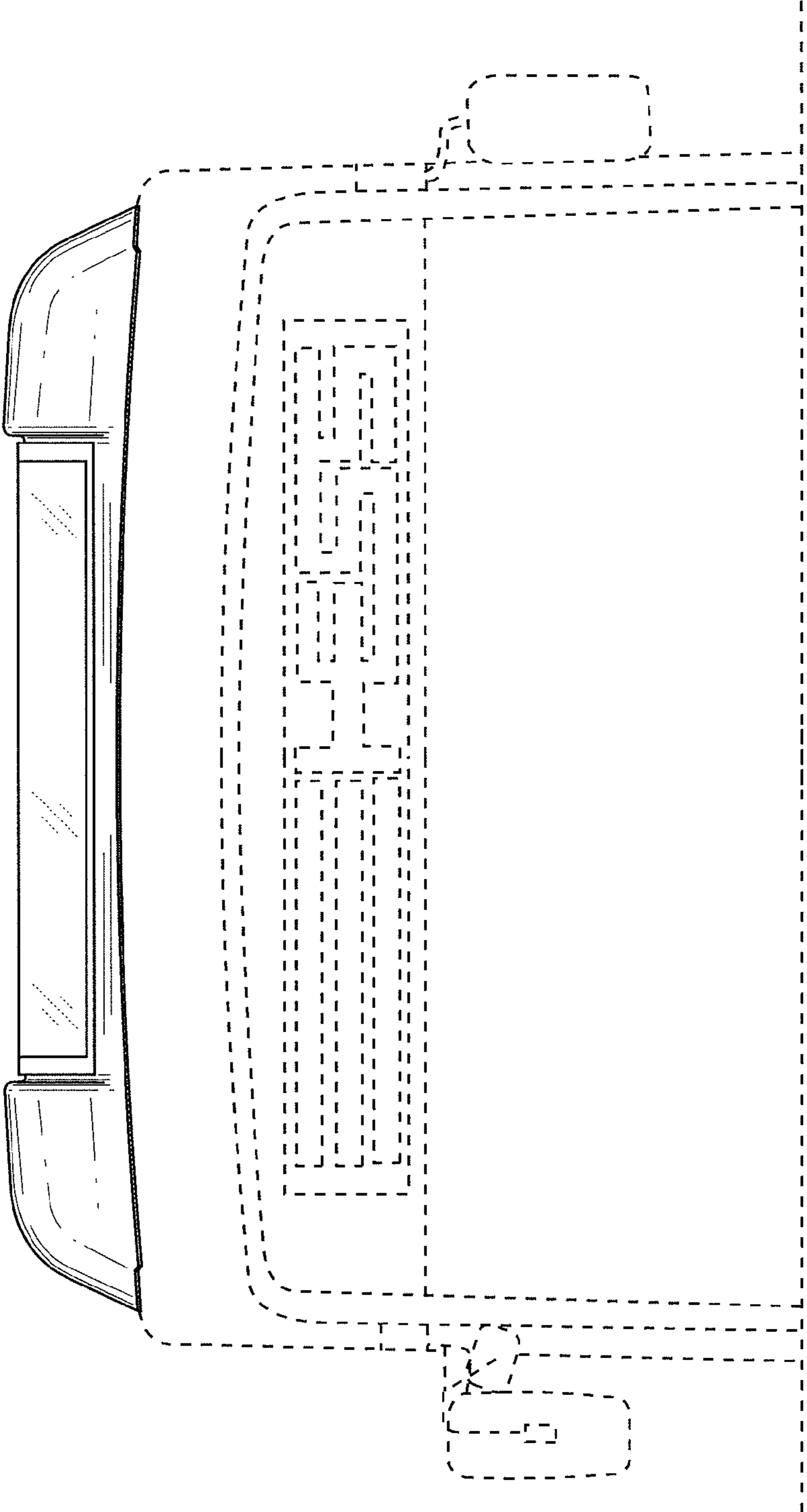

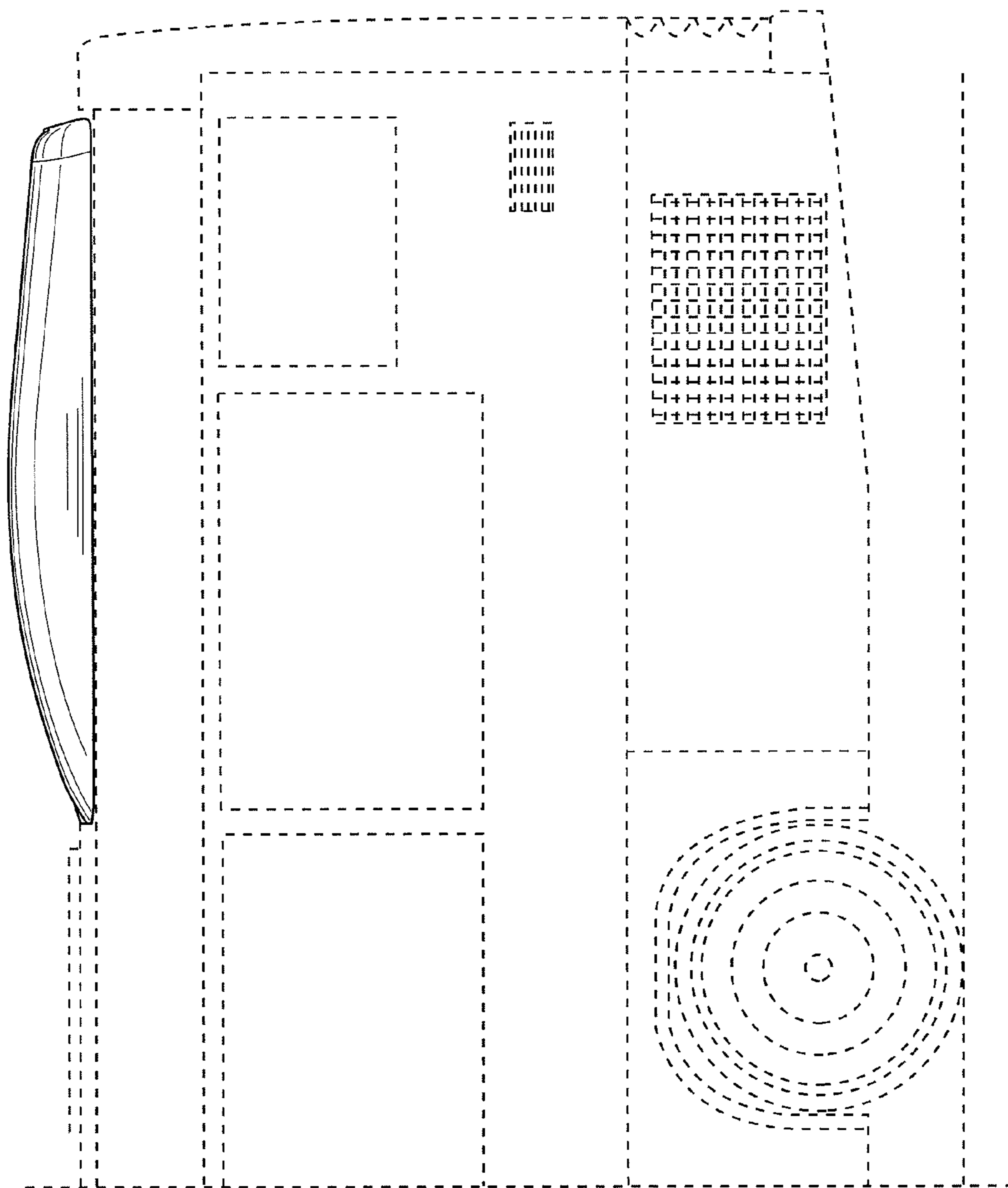

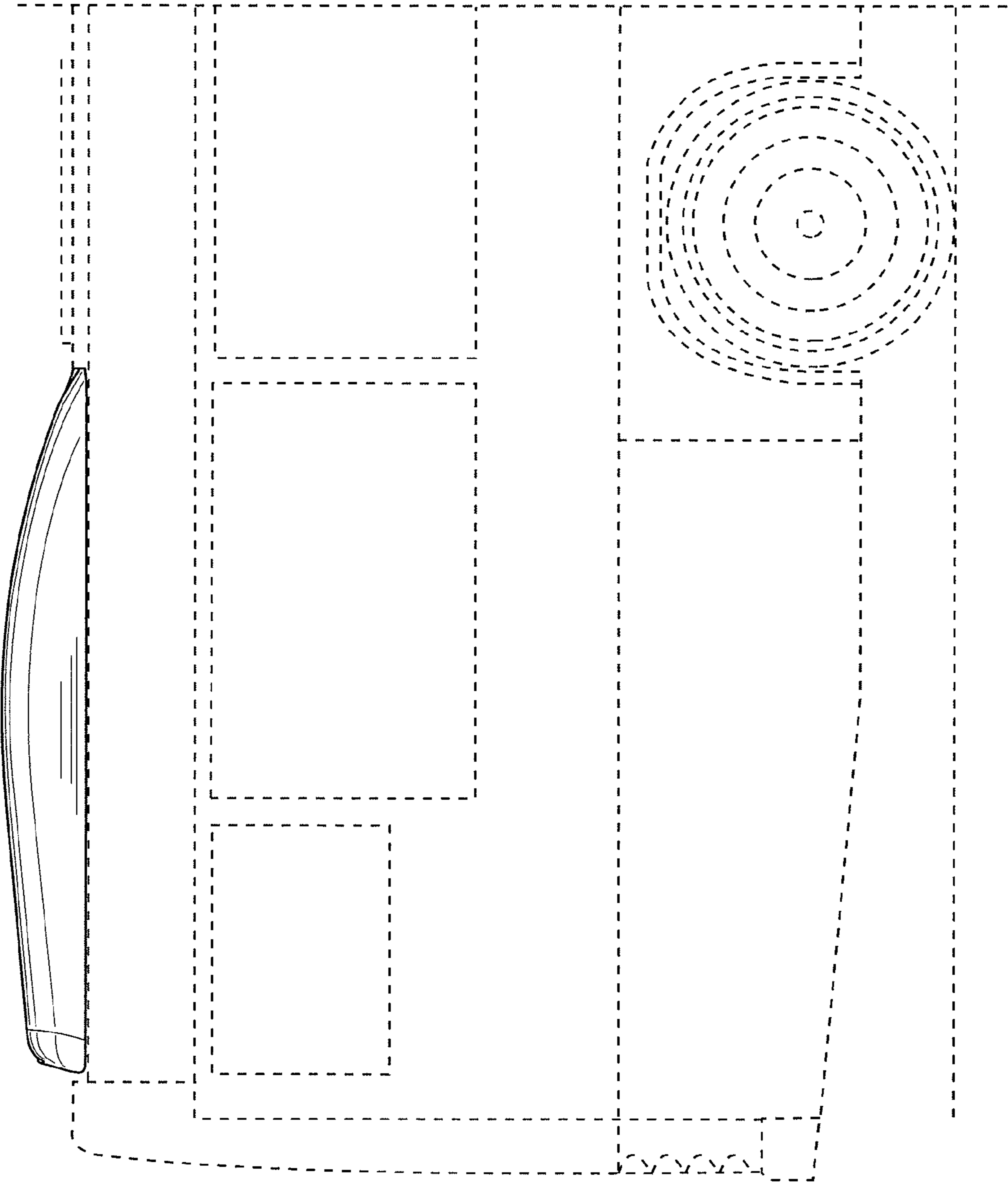

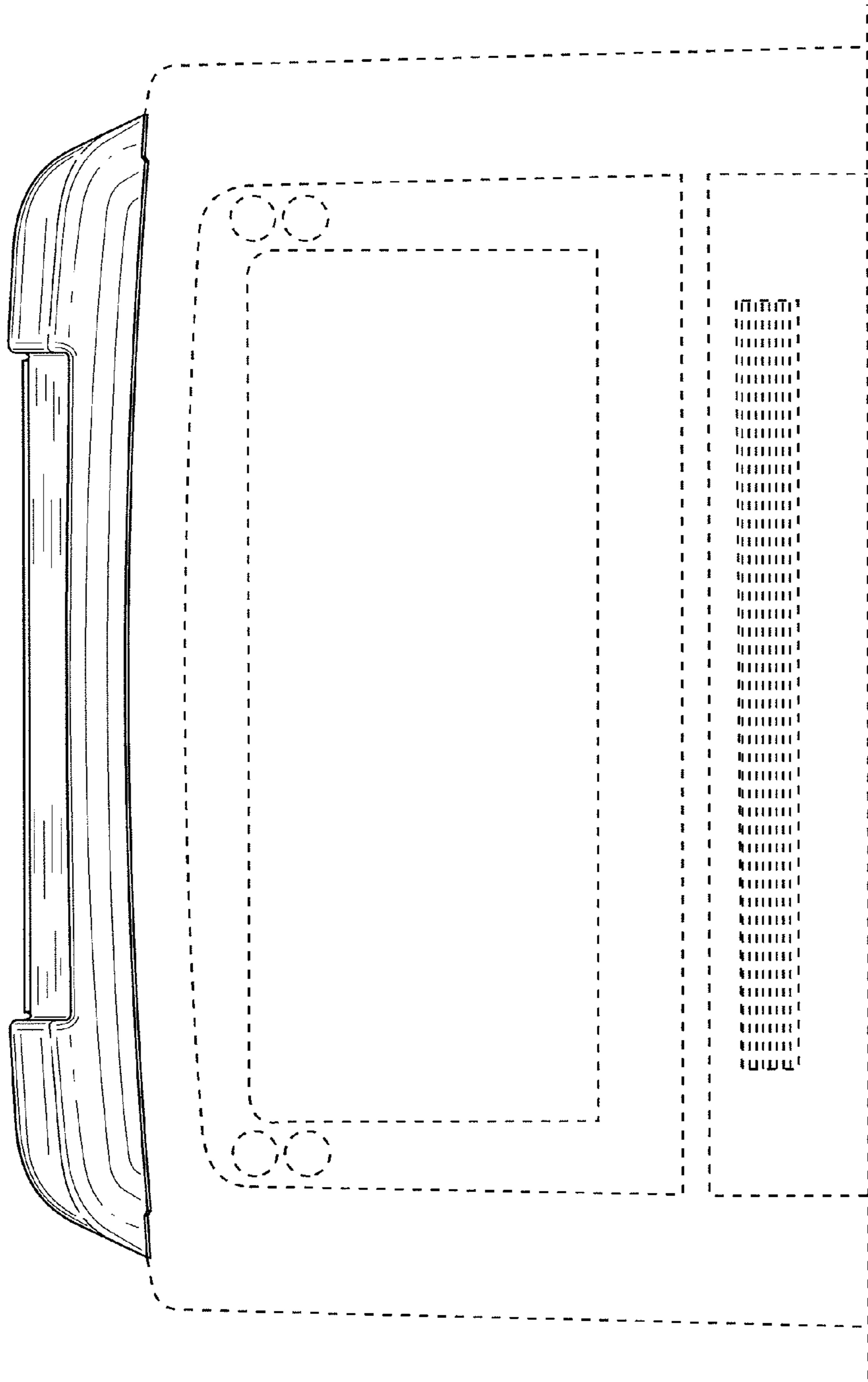
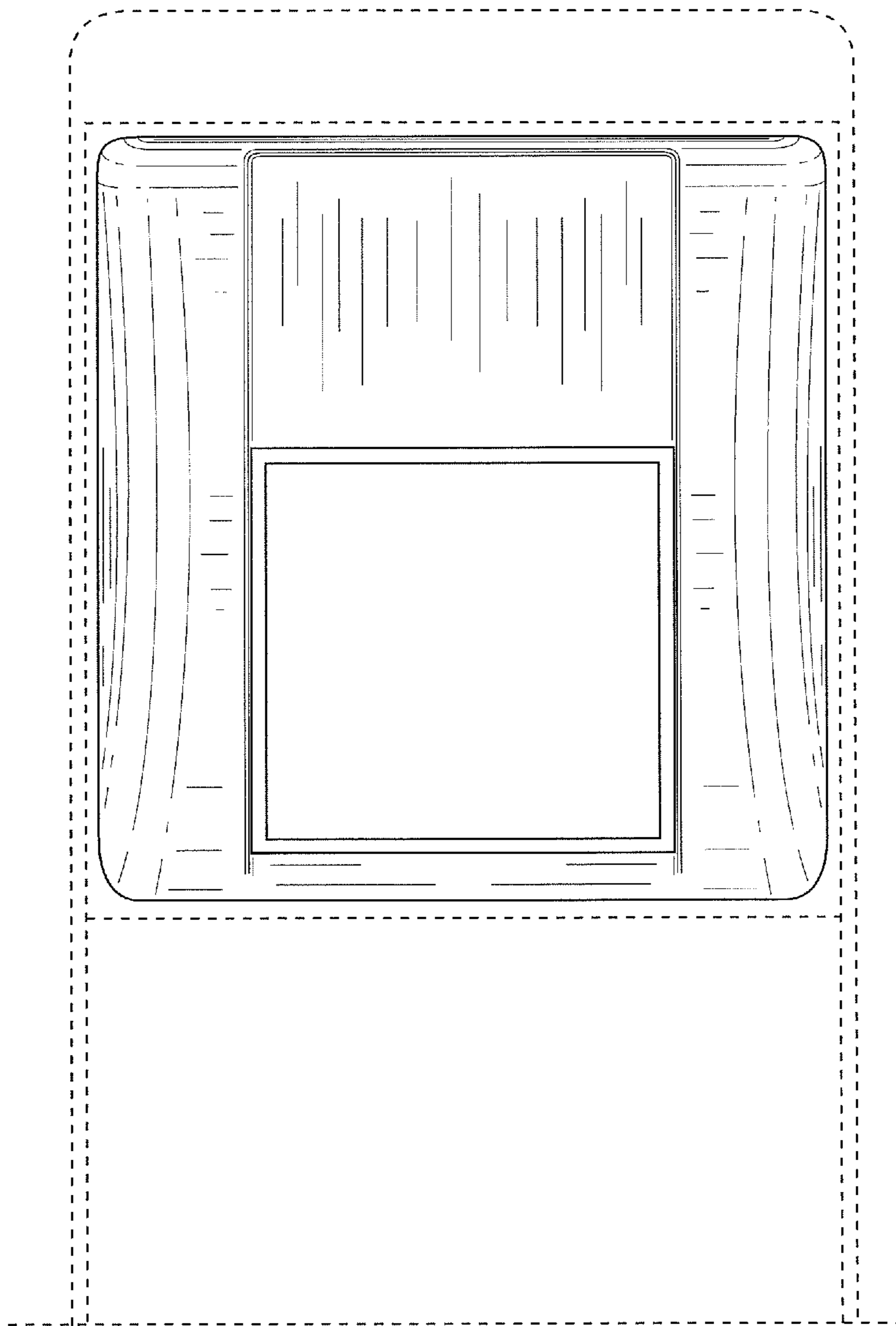

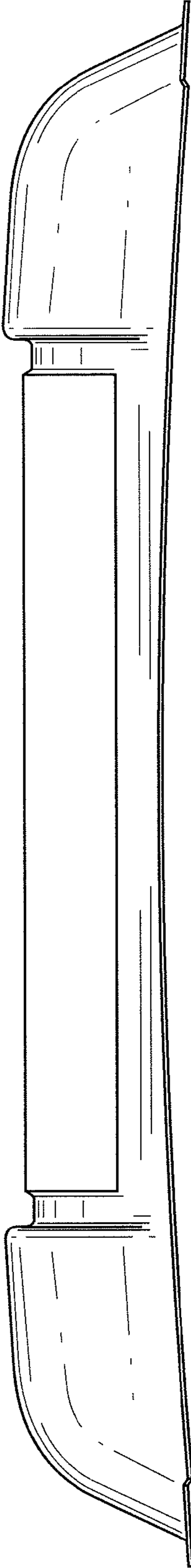

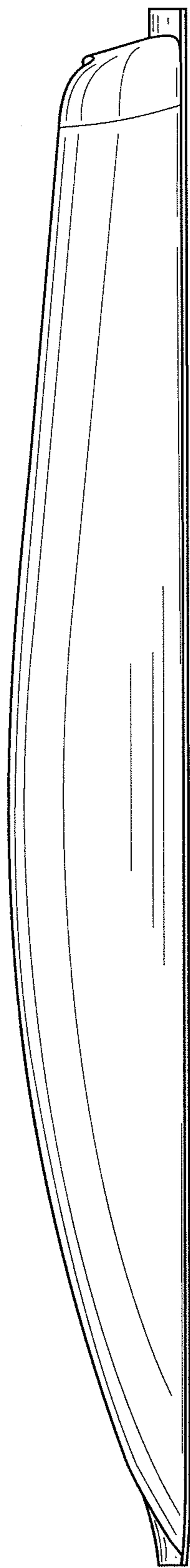

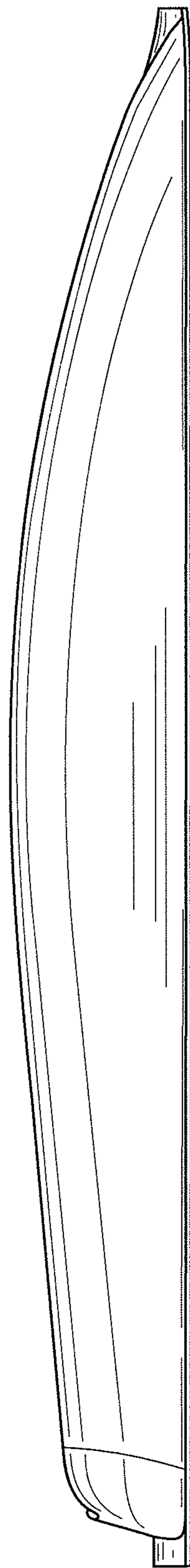

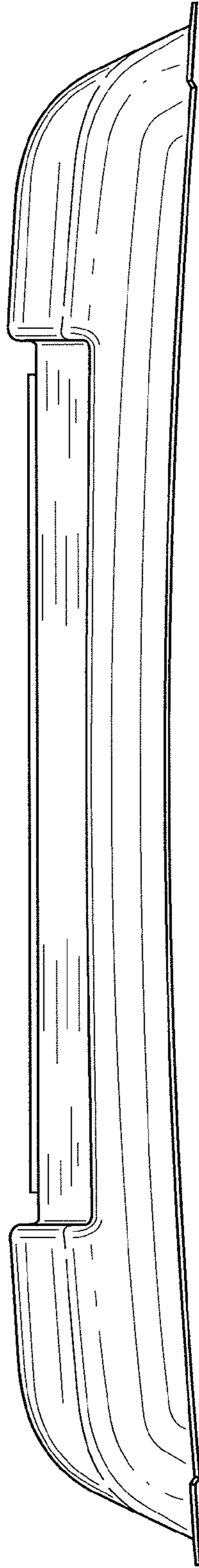
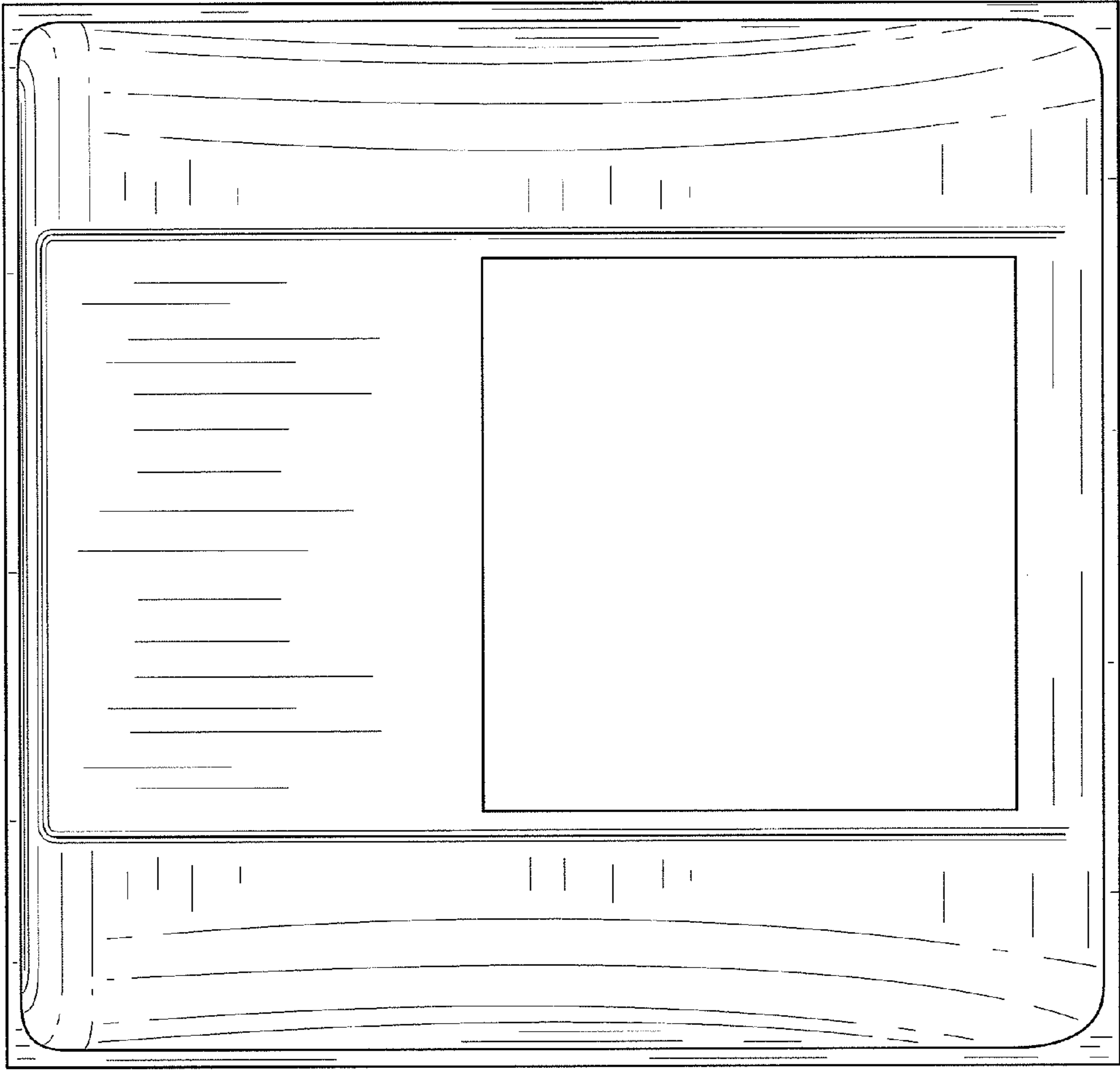

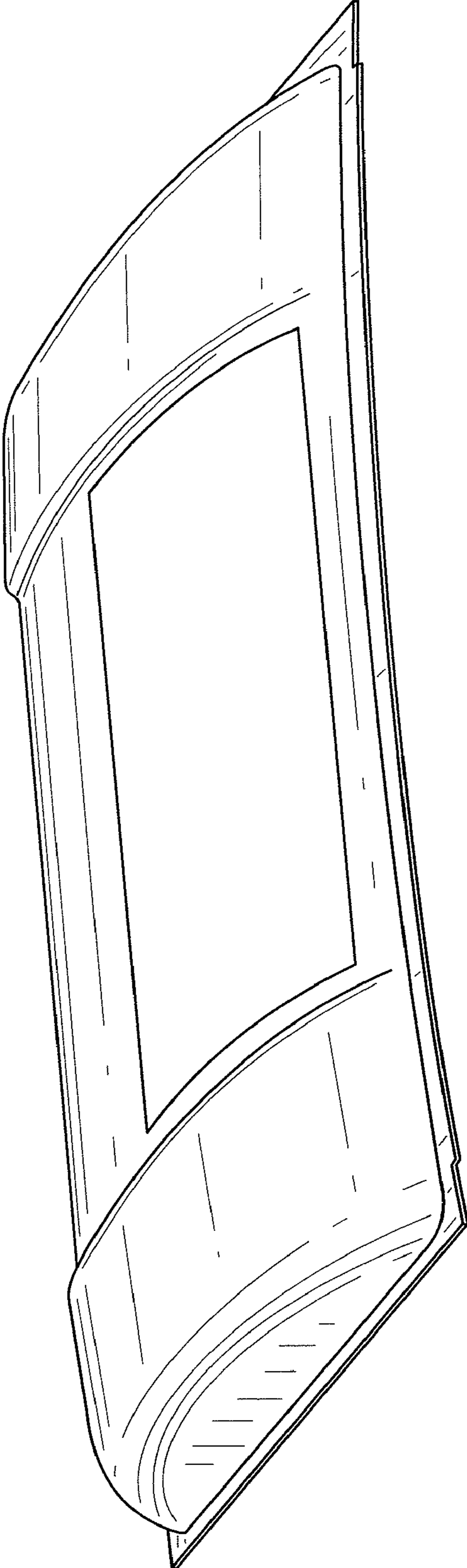
