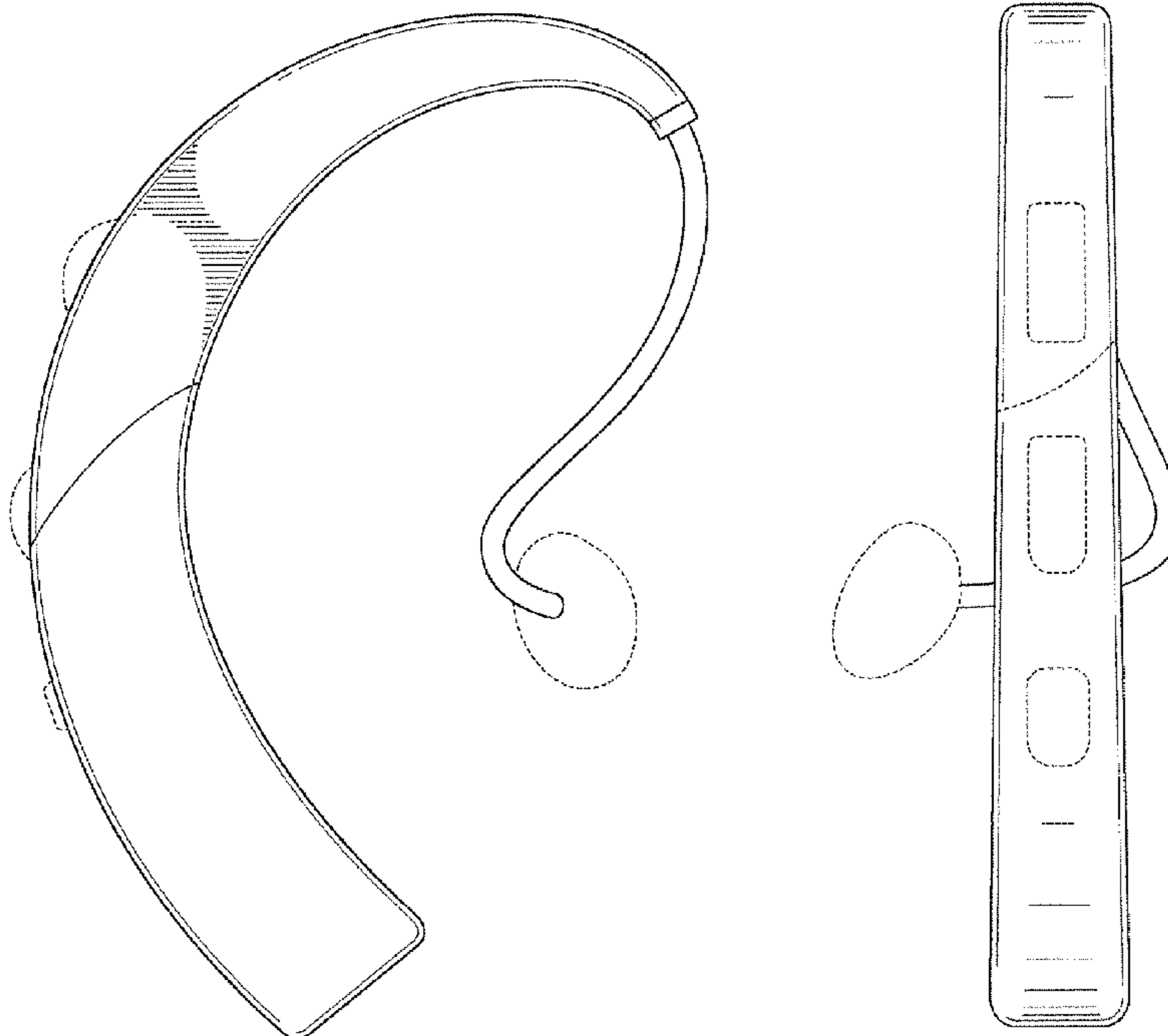
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an outside elevational view of a right portion thereof;
FIG. 2 is an inside elevational view of a right portion thereof;

FIG. 4 is a rear elevational view of a right portion thereof;

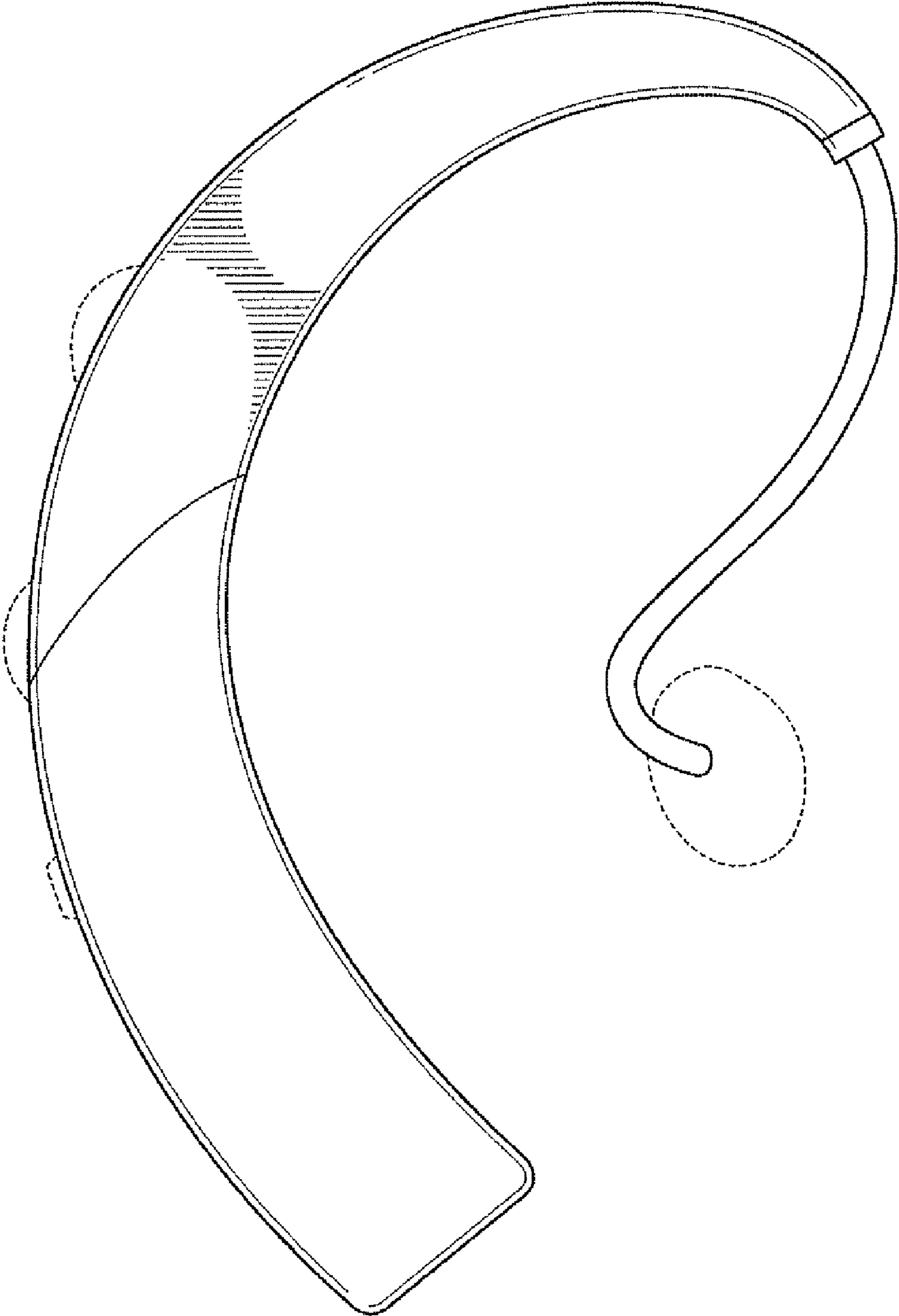

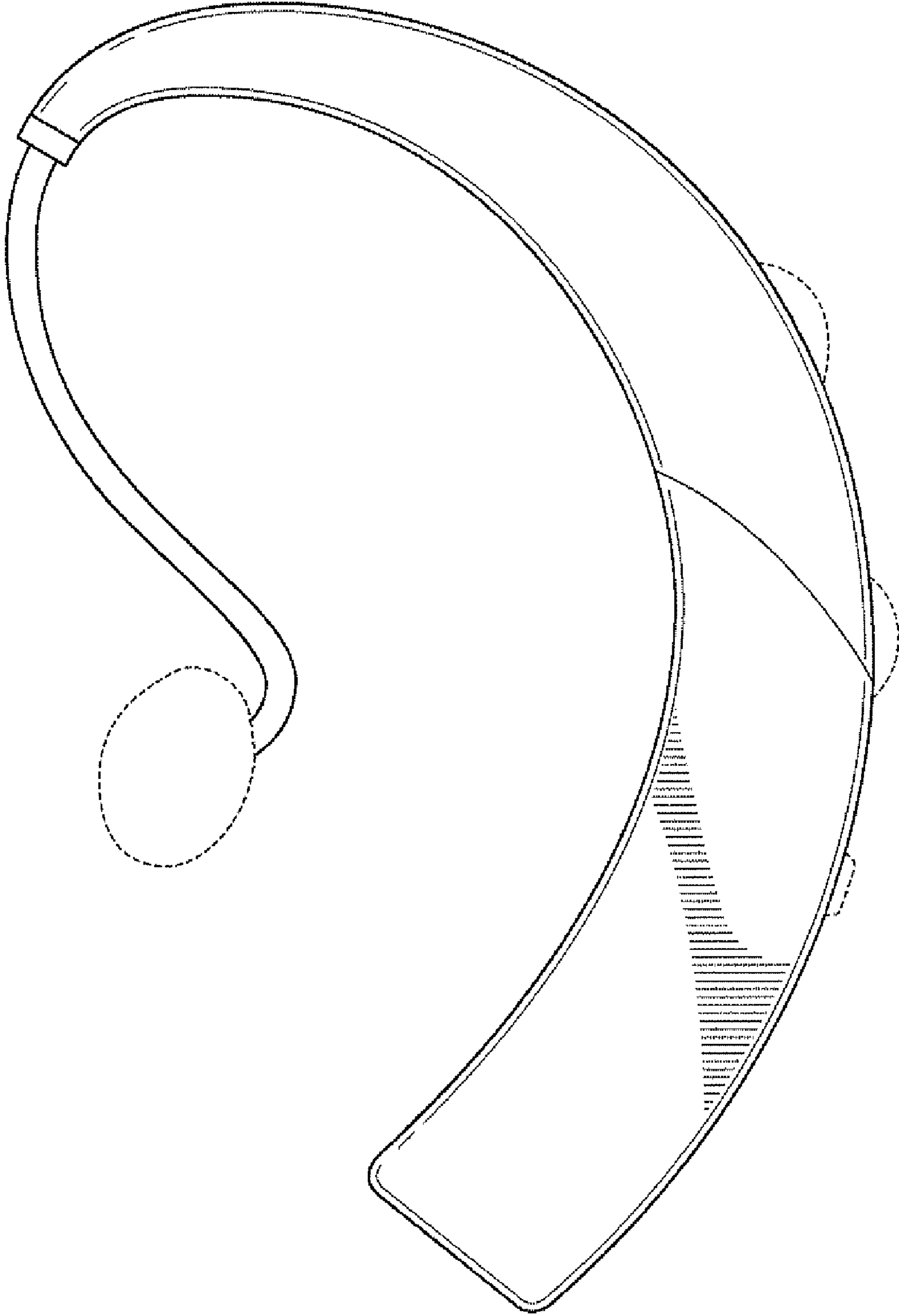

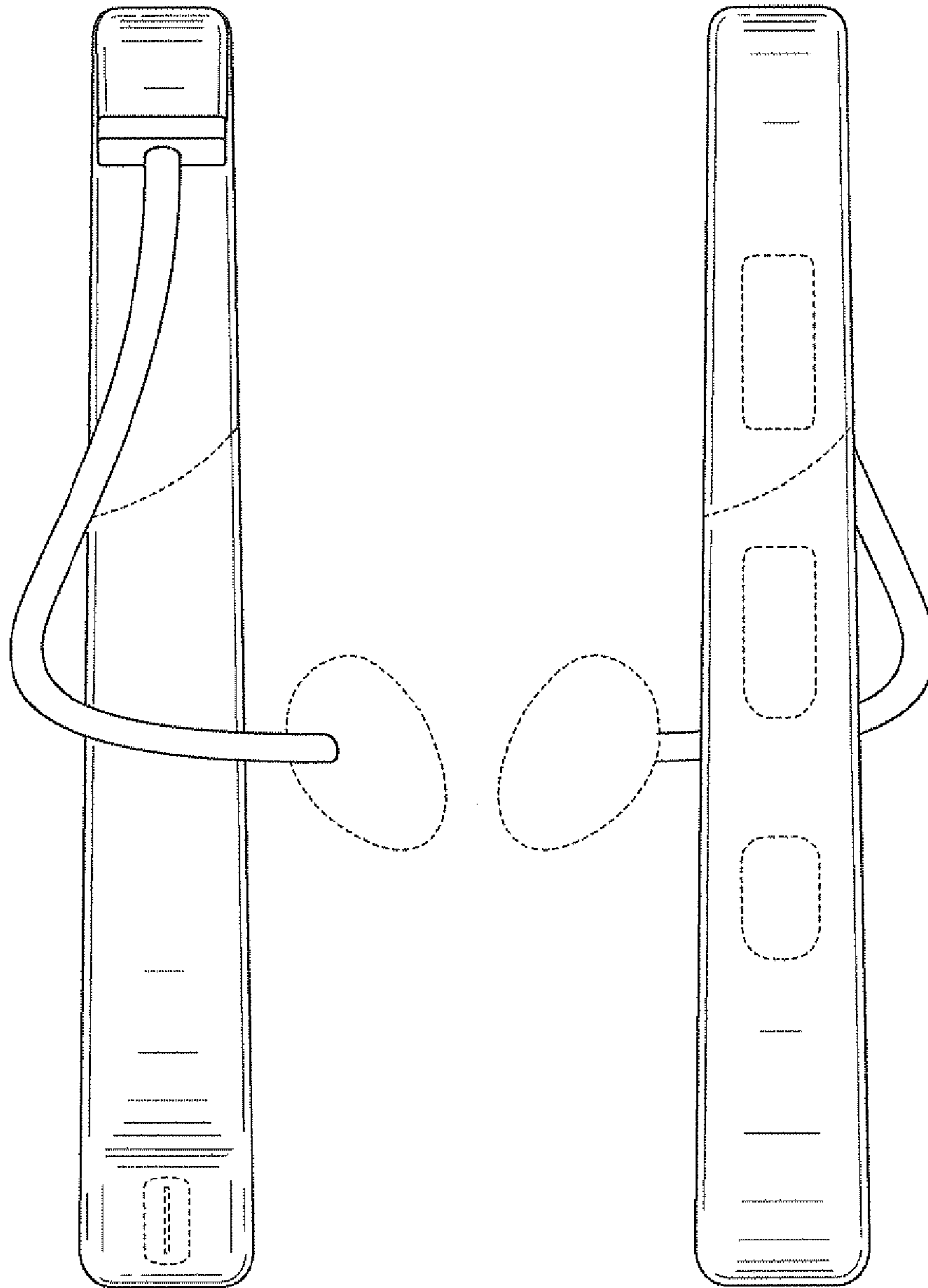

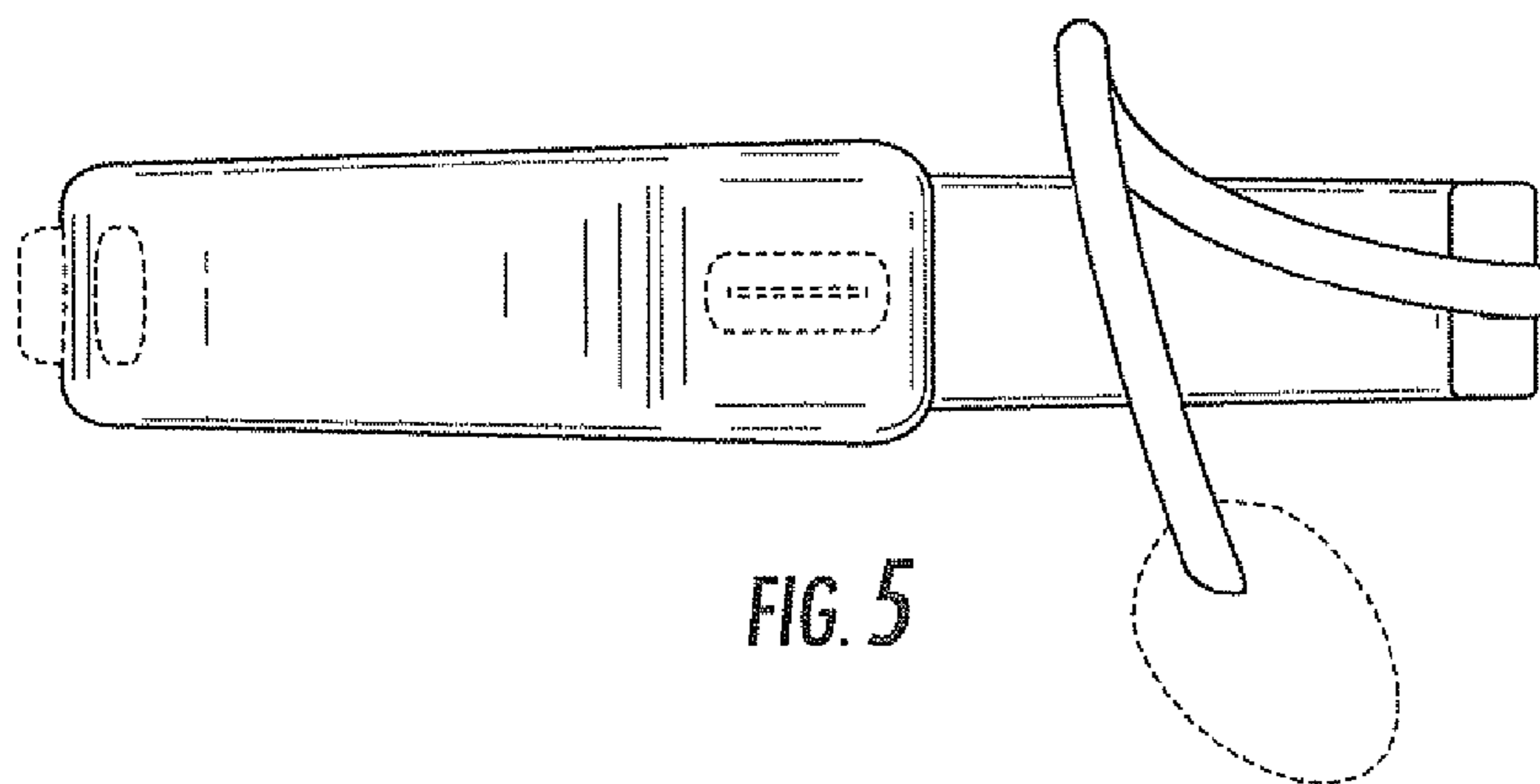

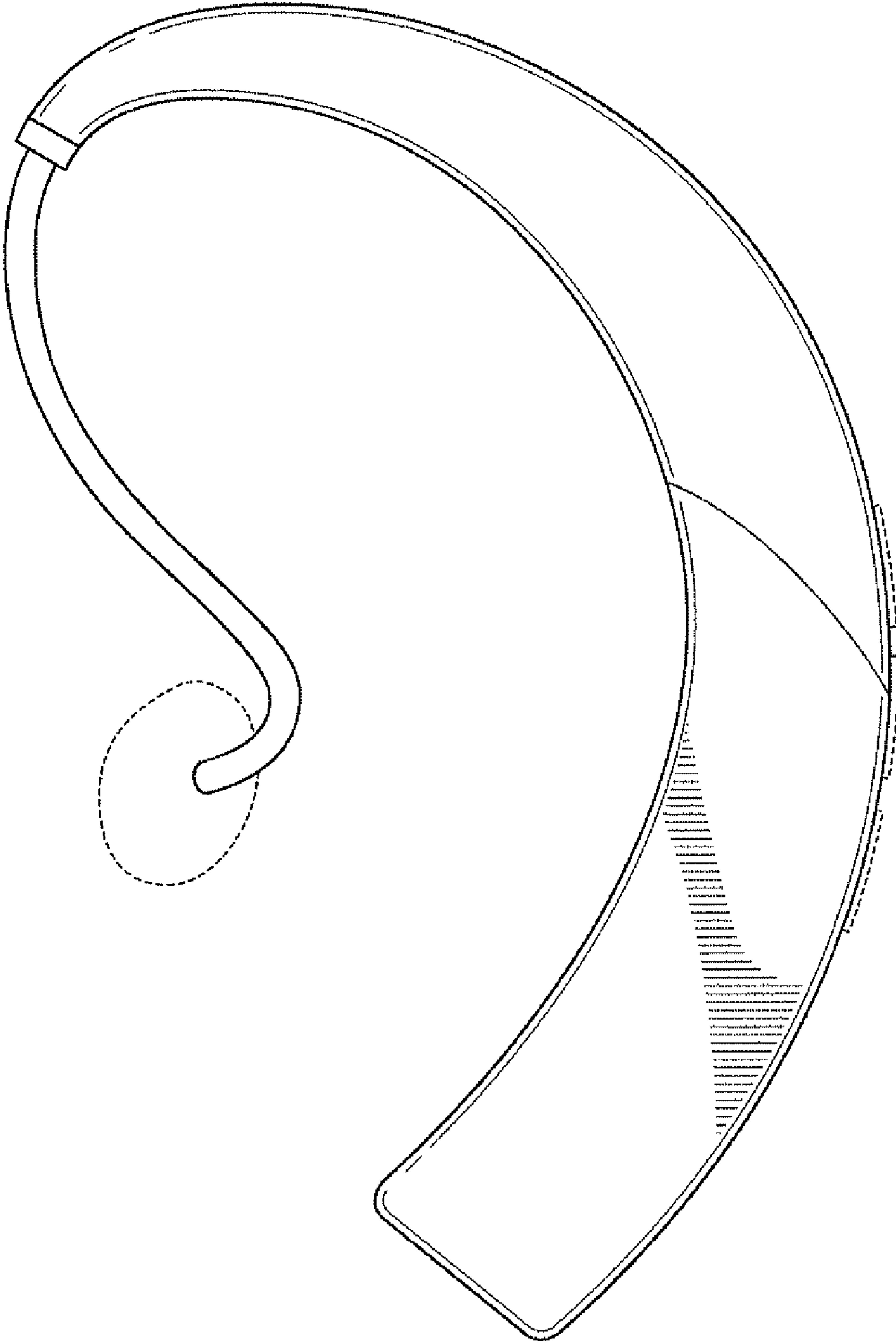

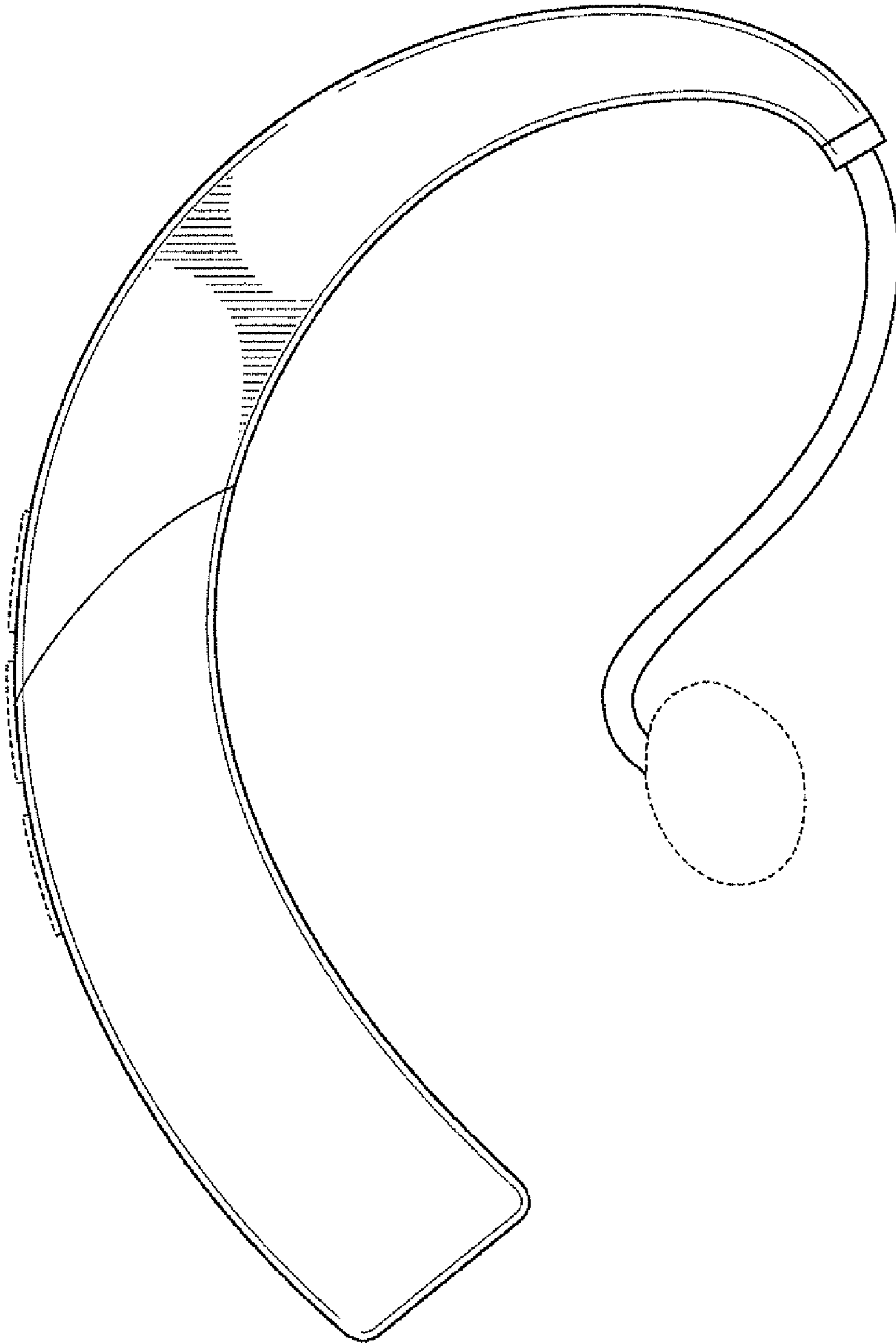

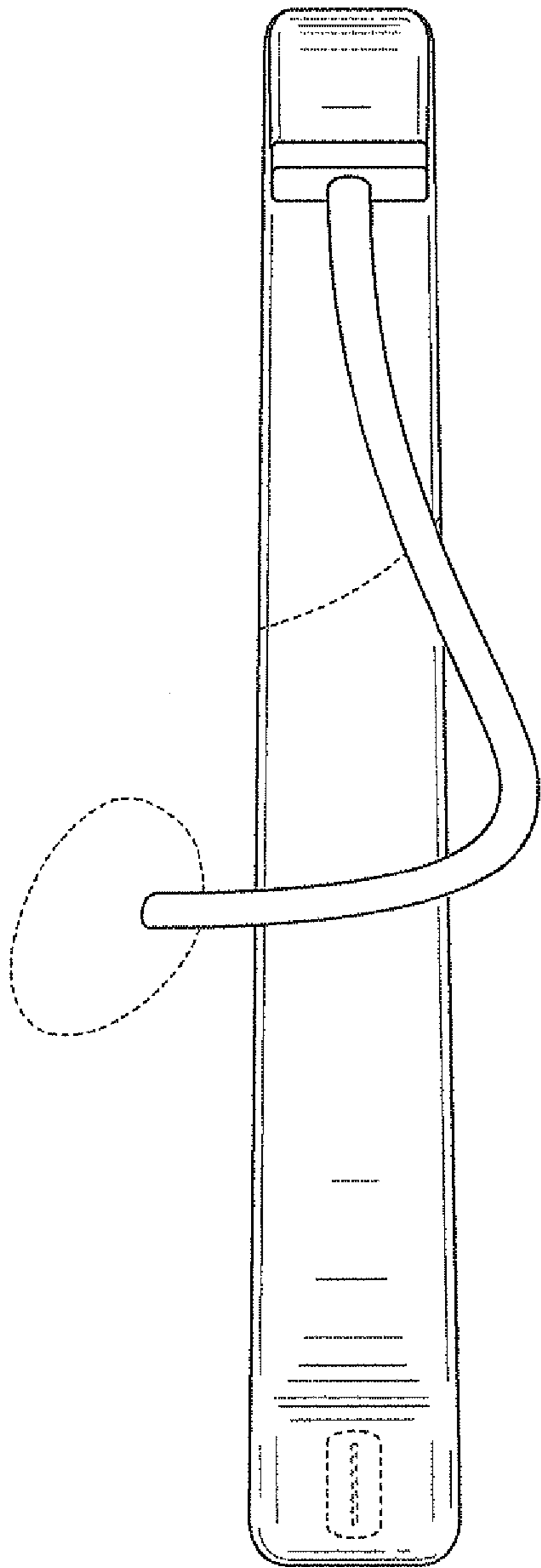

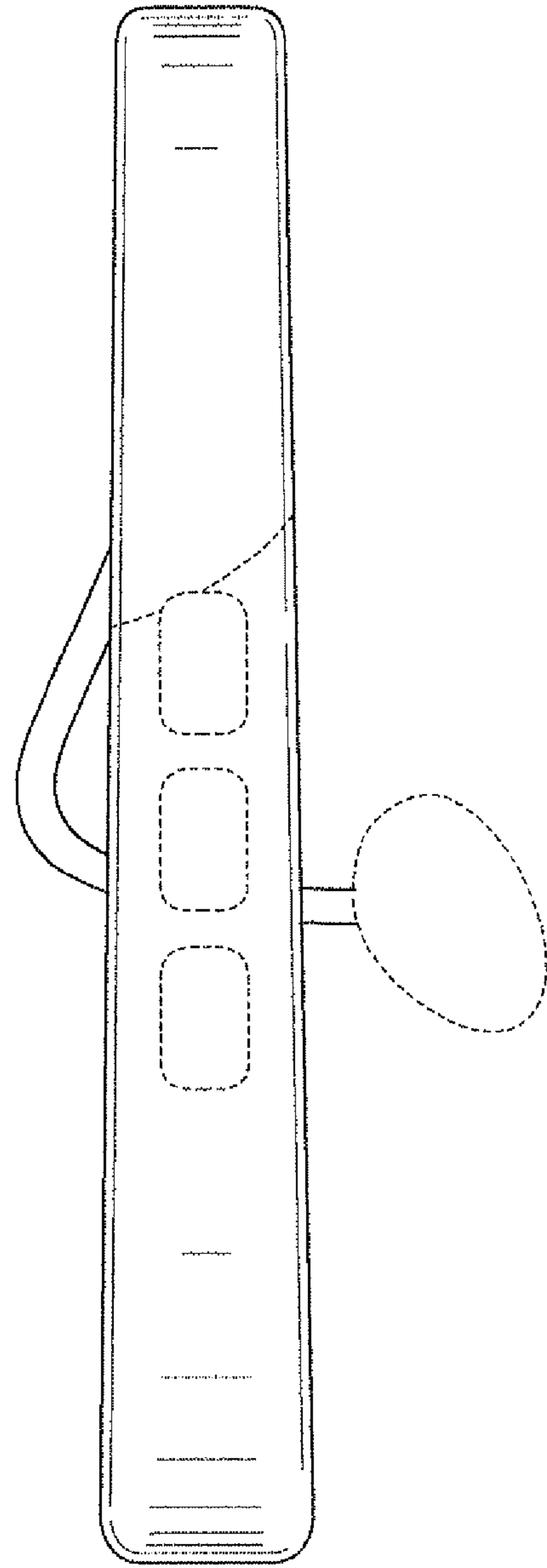

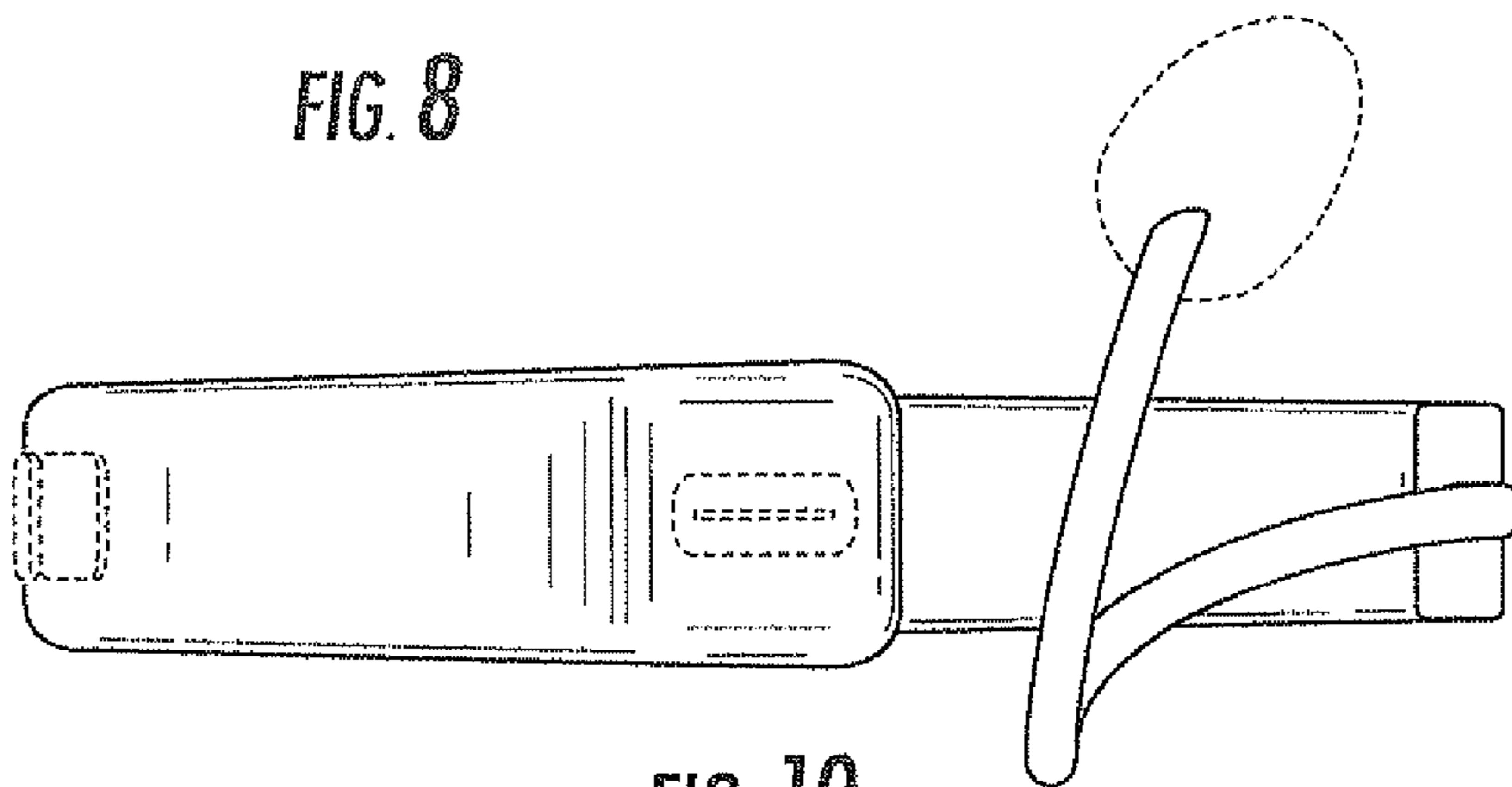
