DESCRIPTION

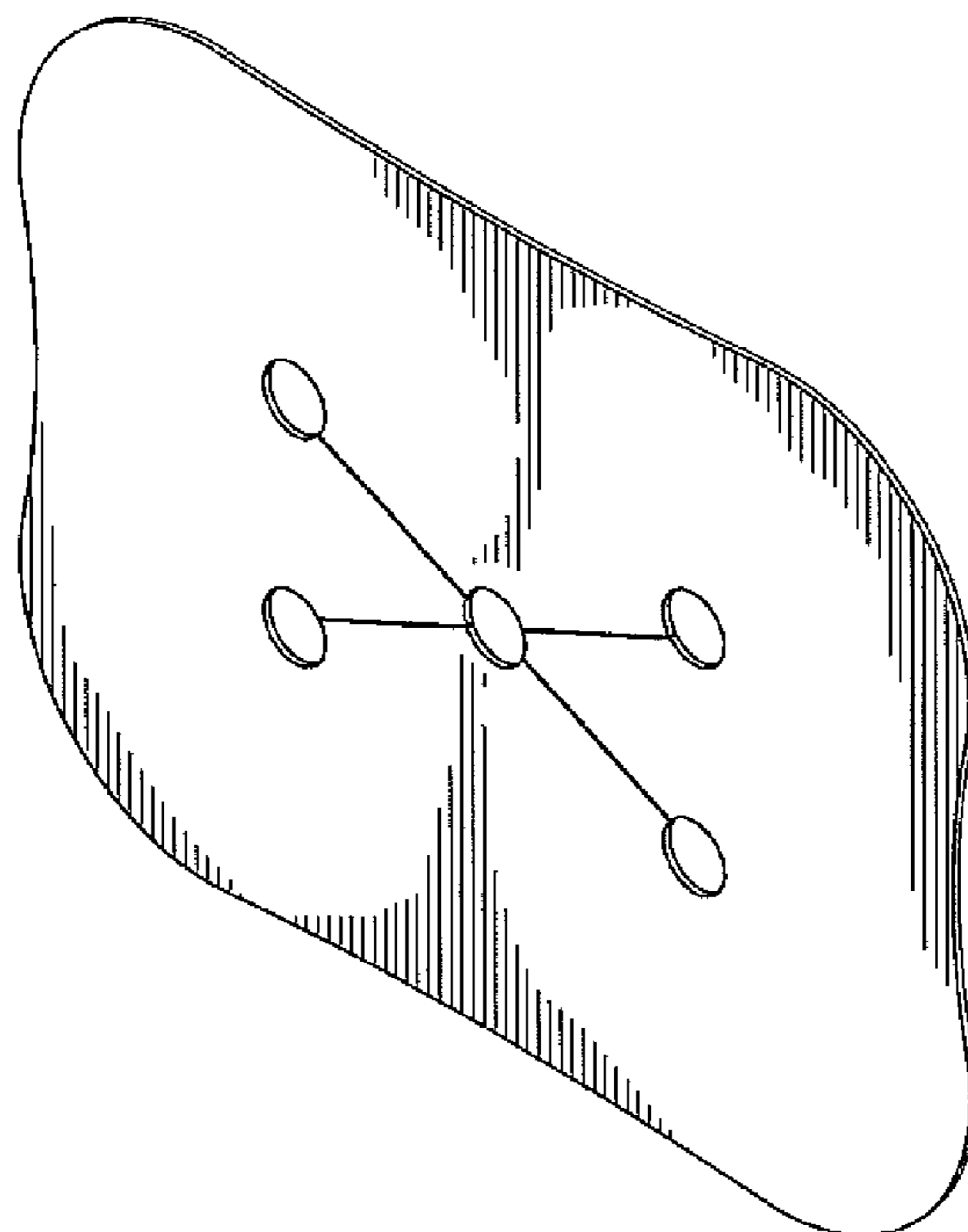
FIG. 1 is a front, perspective view of a shoelace tying apparatus in accordance with the present design;

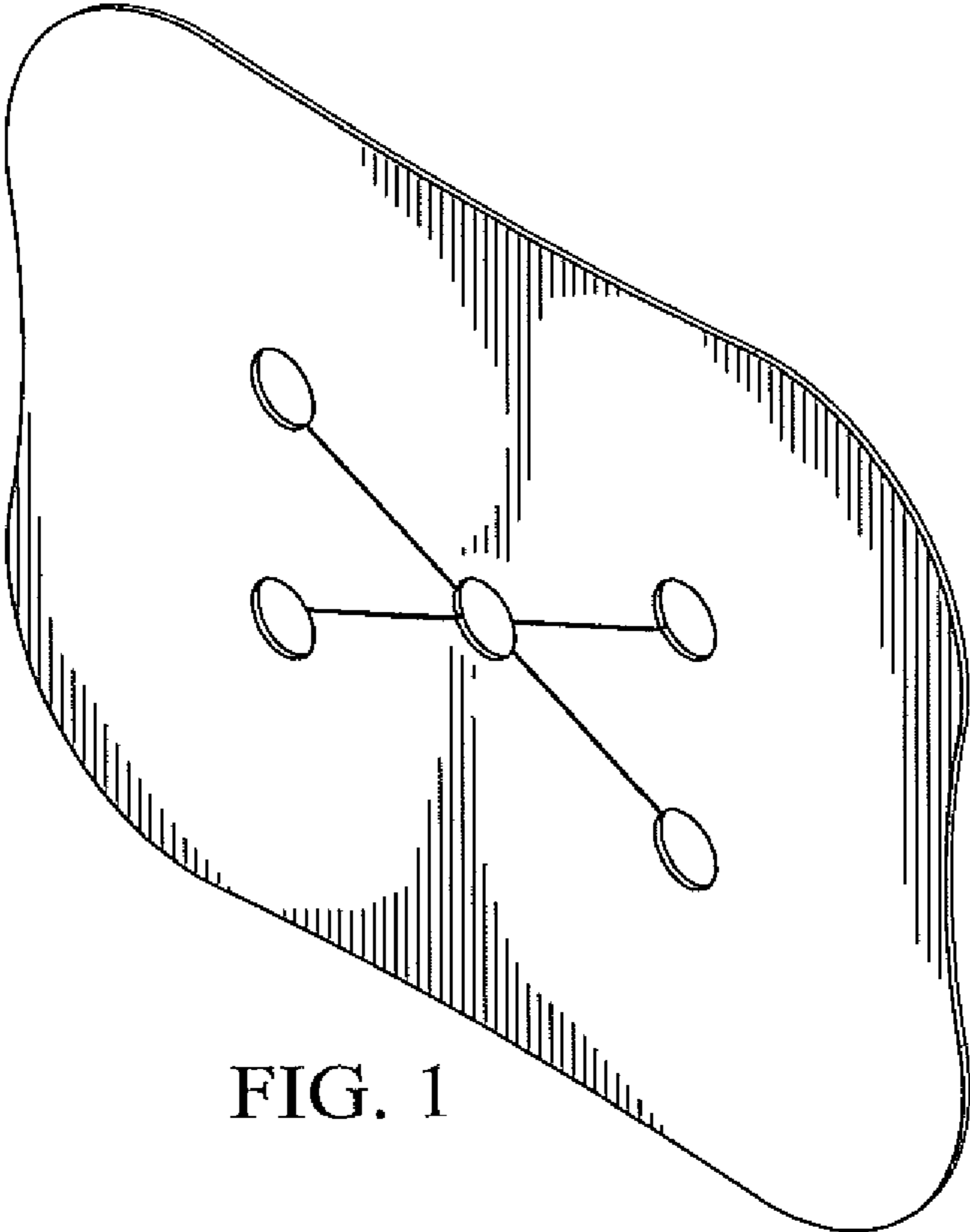

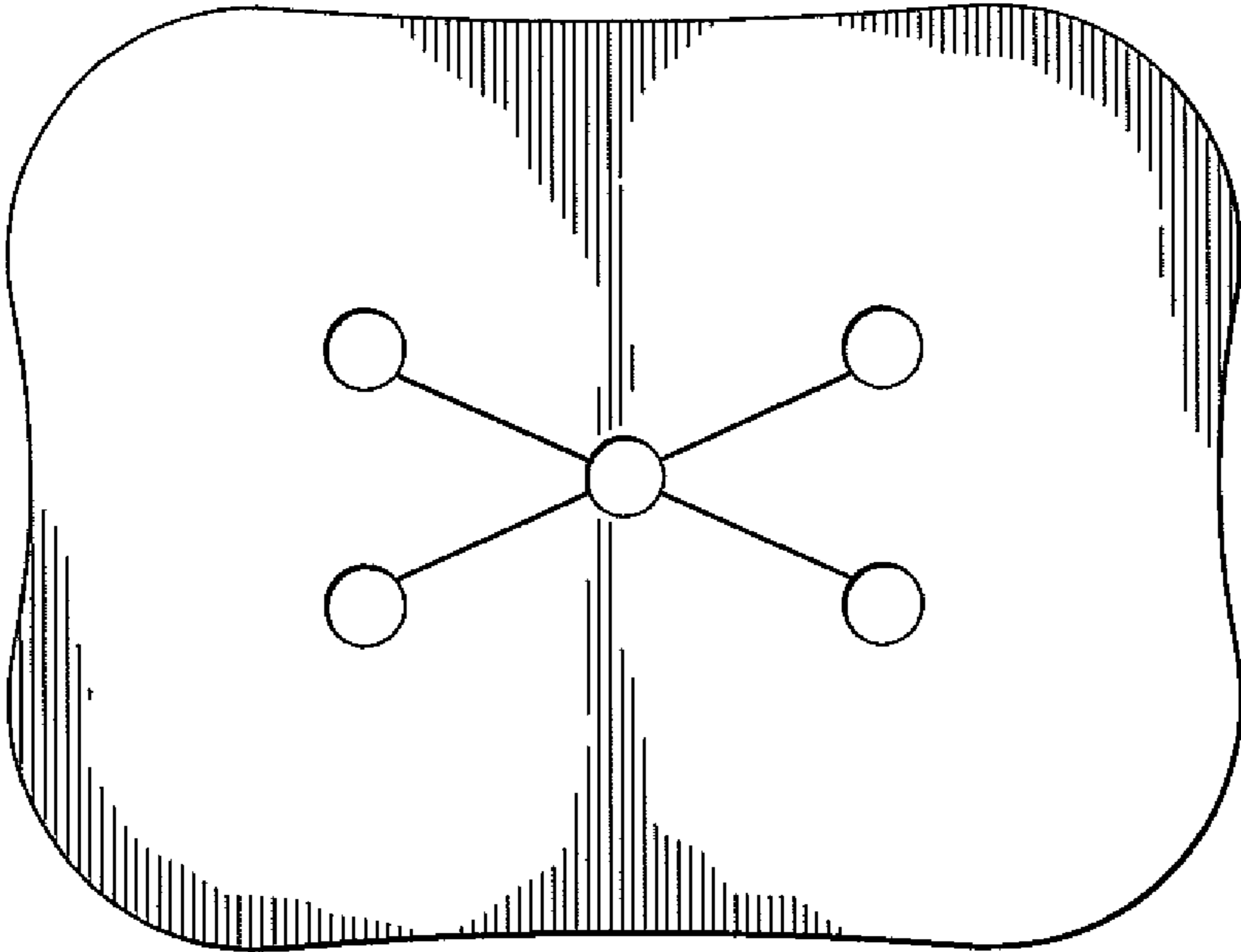

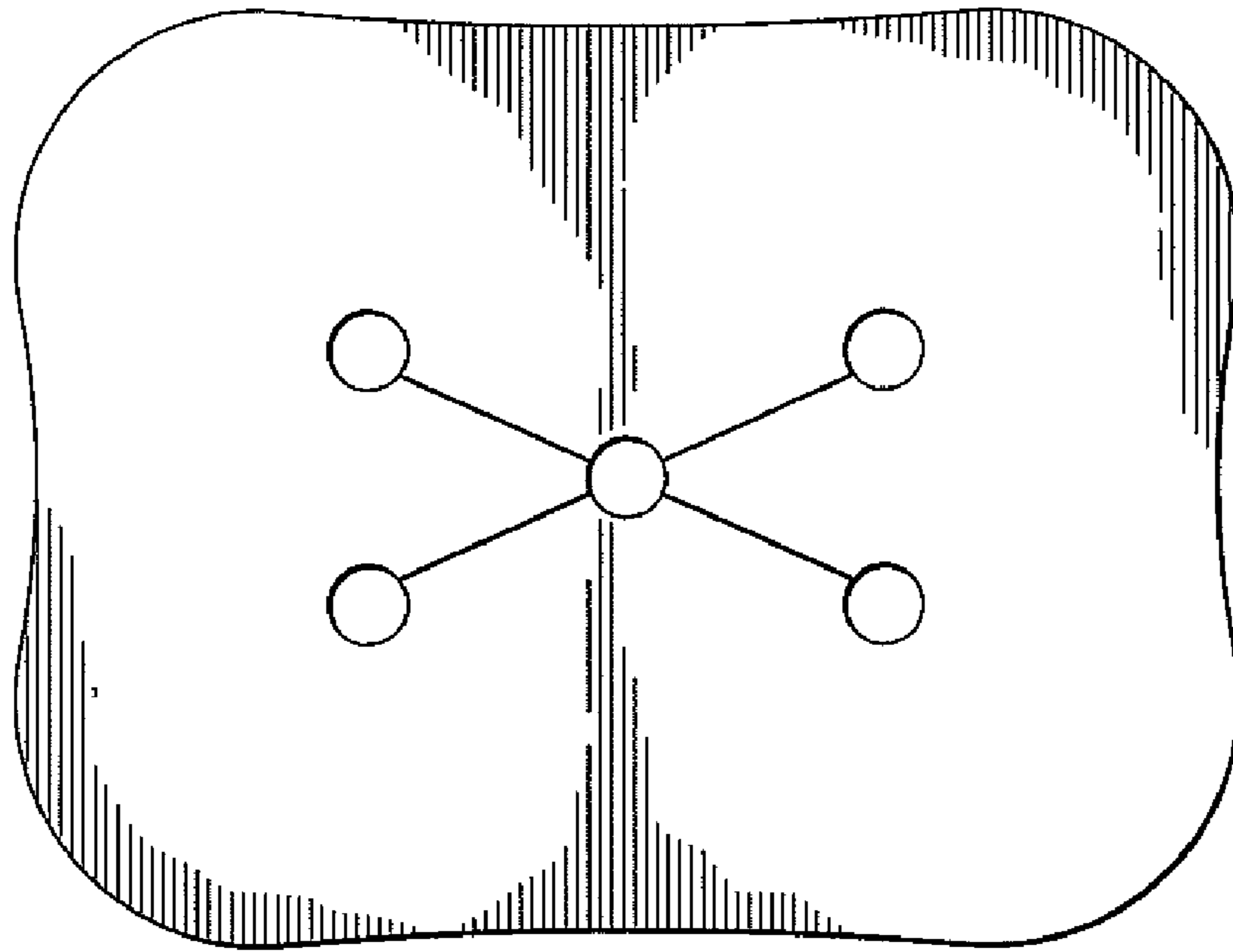
