The ornamental design for a base for an electronic game table, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric front, top, and right side perspective view of the base for an electronic game table.

FIG. 2 is a front view of the base for an electronic game table; and,

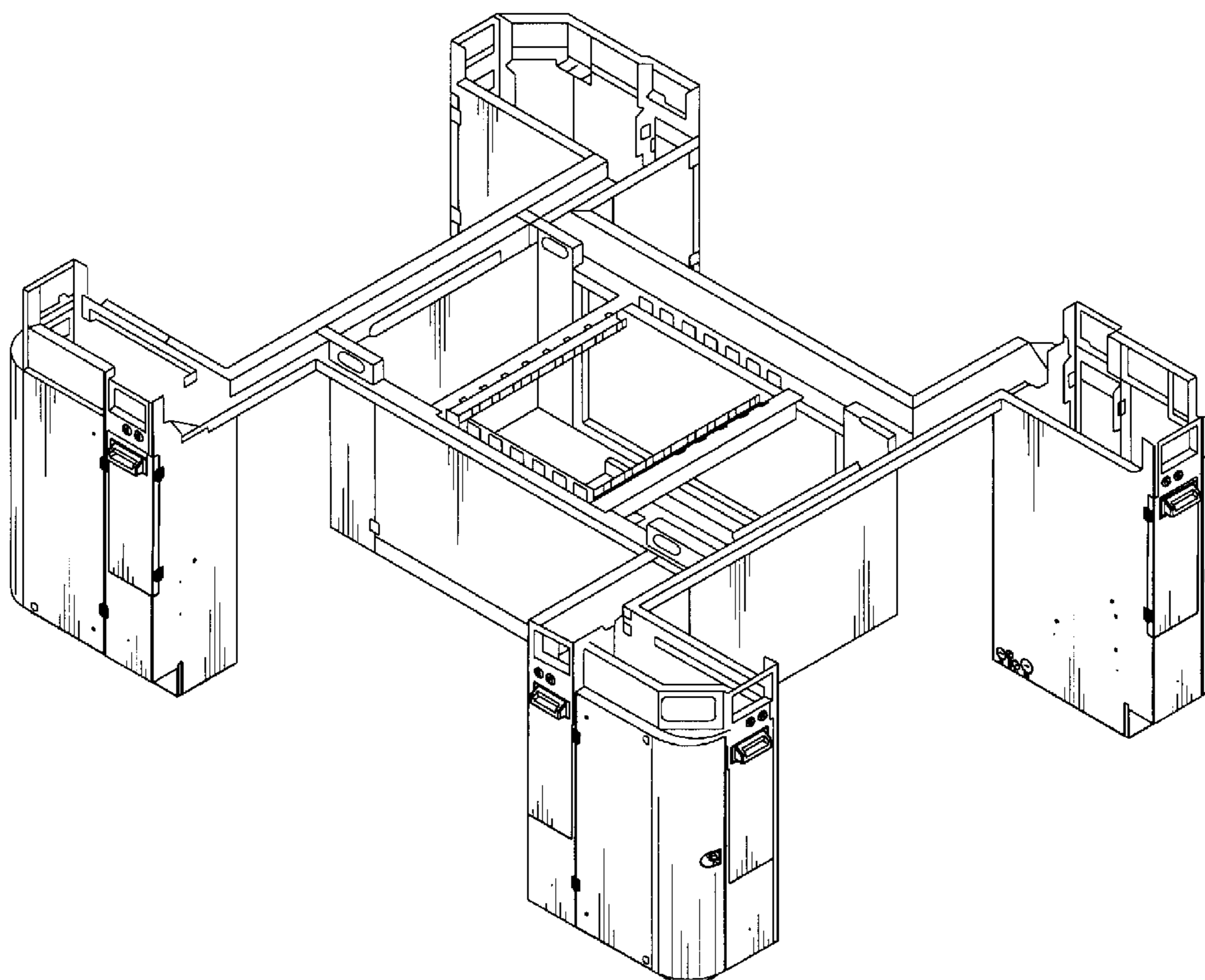
FIG. 3 is a right side view of the base for an electronic game table.

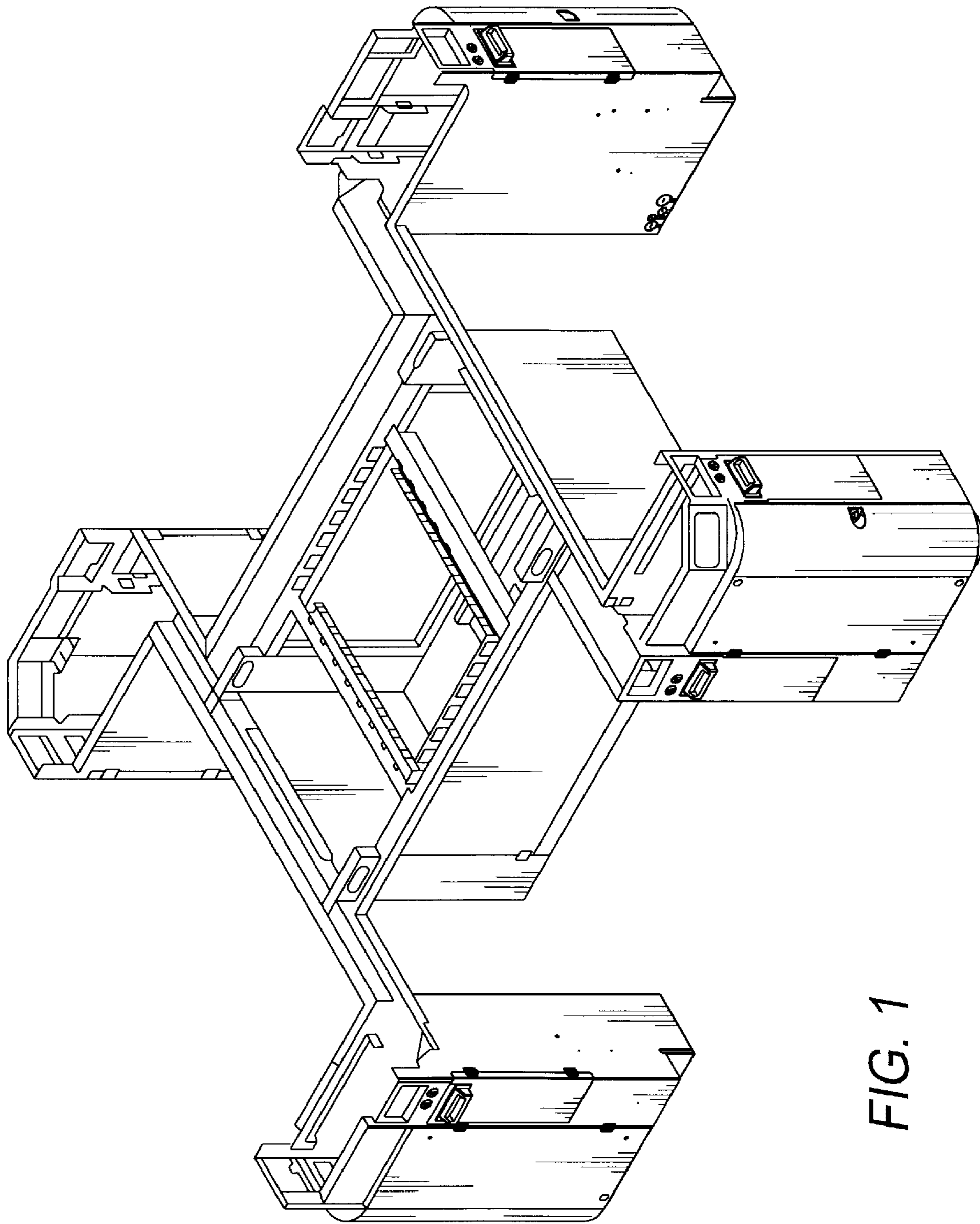

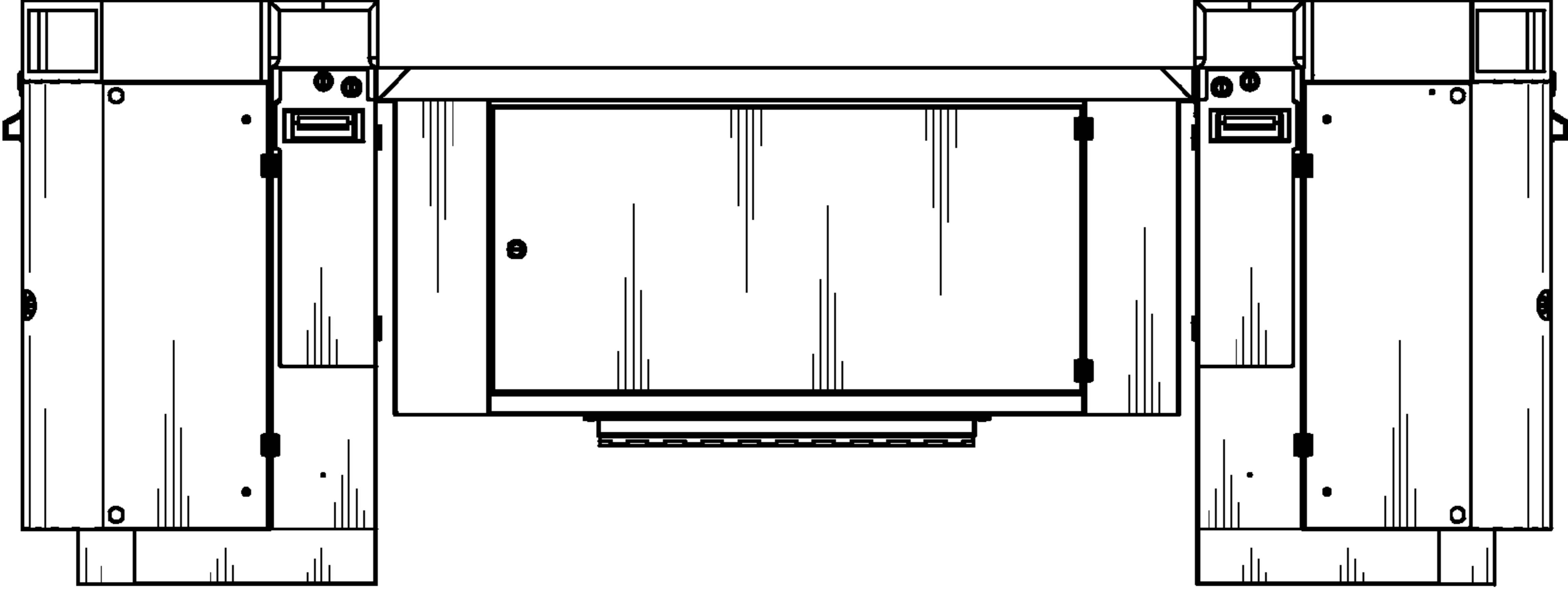

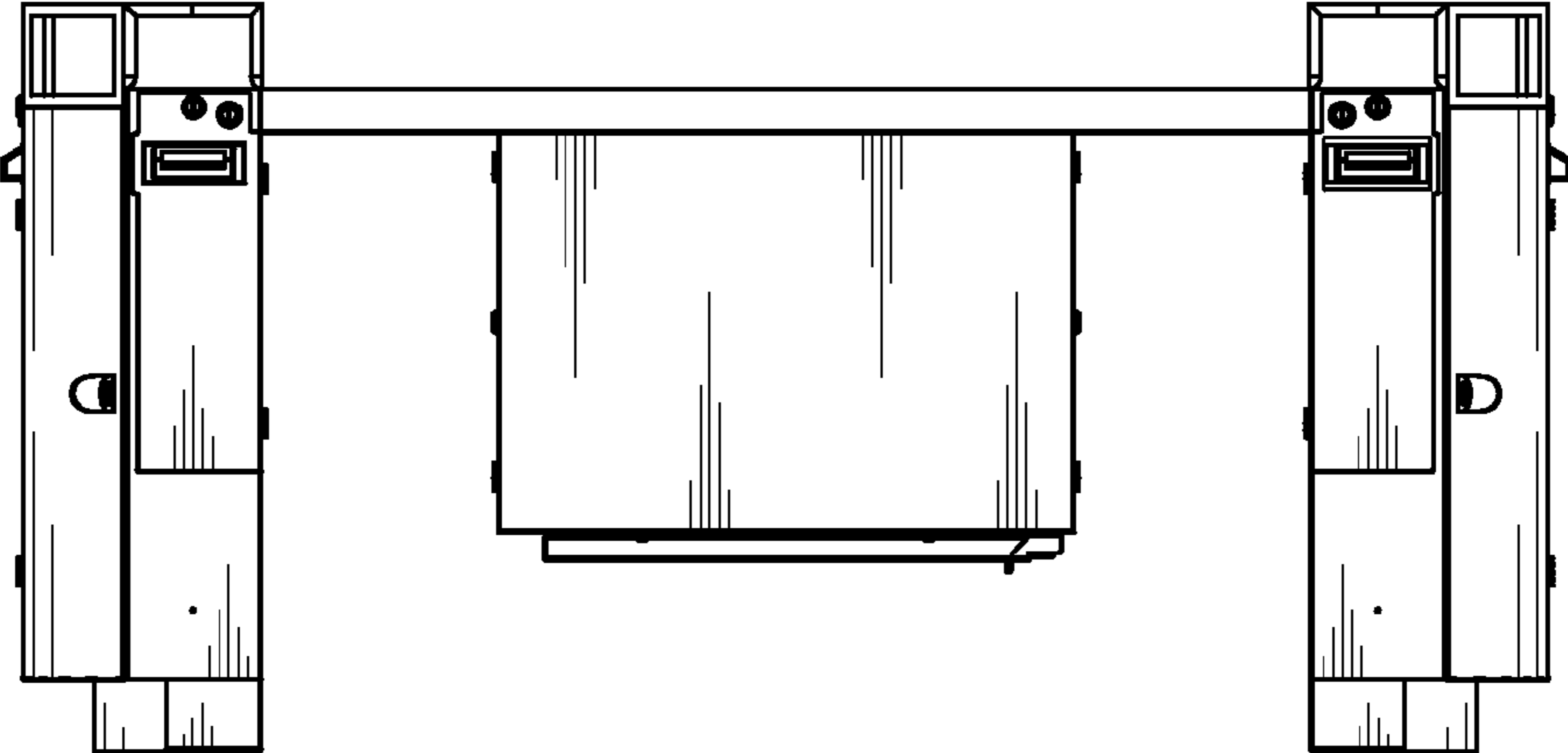
