The ornamental design for a sports net, as shown and described.

DESCRIPTION

FIG. 1 is front perspective view of the sports net showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a left side elevational view thereof, the right side view being a mirror image of the side shown;

FIG. 6 is front perspective view of the sports net showing a second embodiment of our new design;

FIG. 7 is a front elevational view thereof;

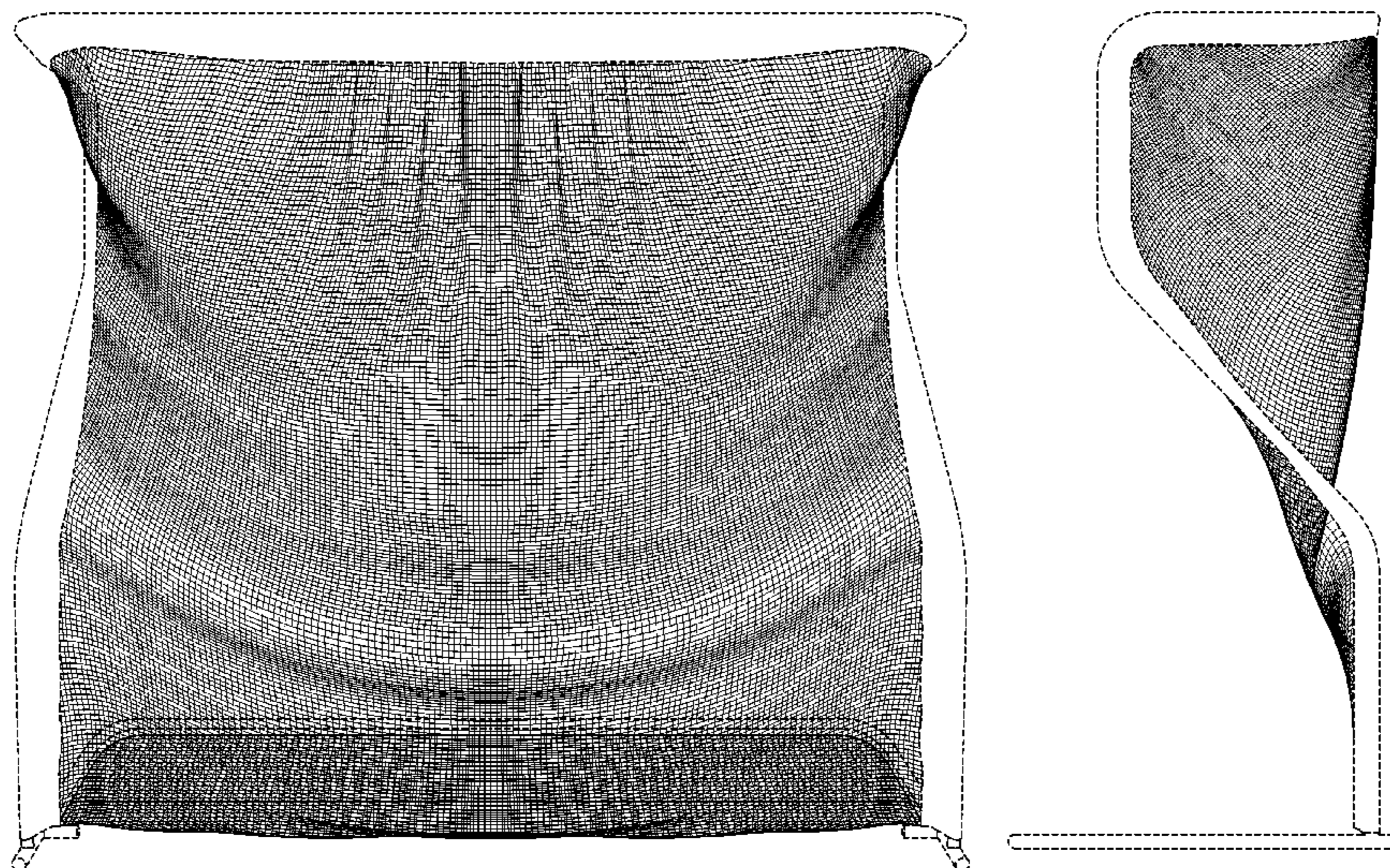
FIG. 8 is a rear elevational view thereof;

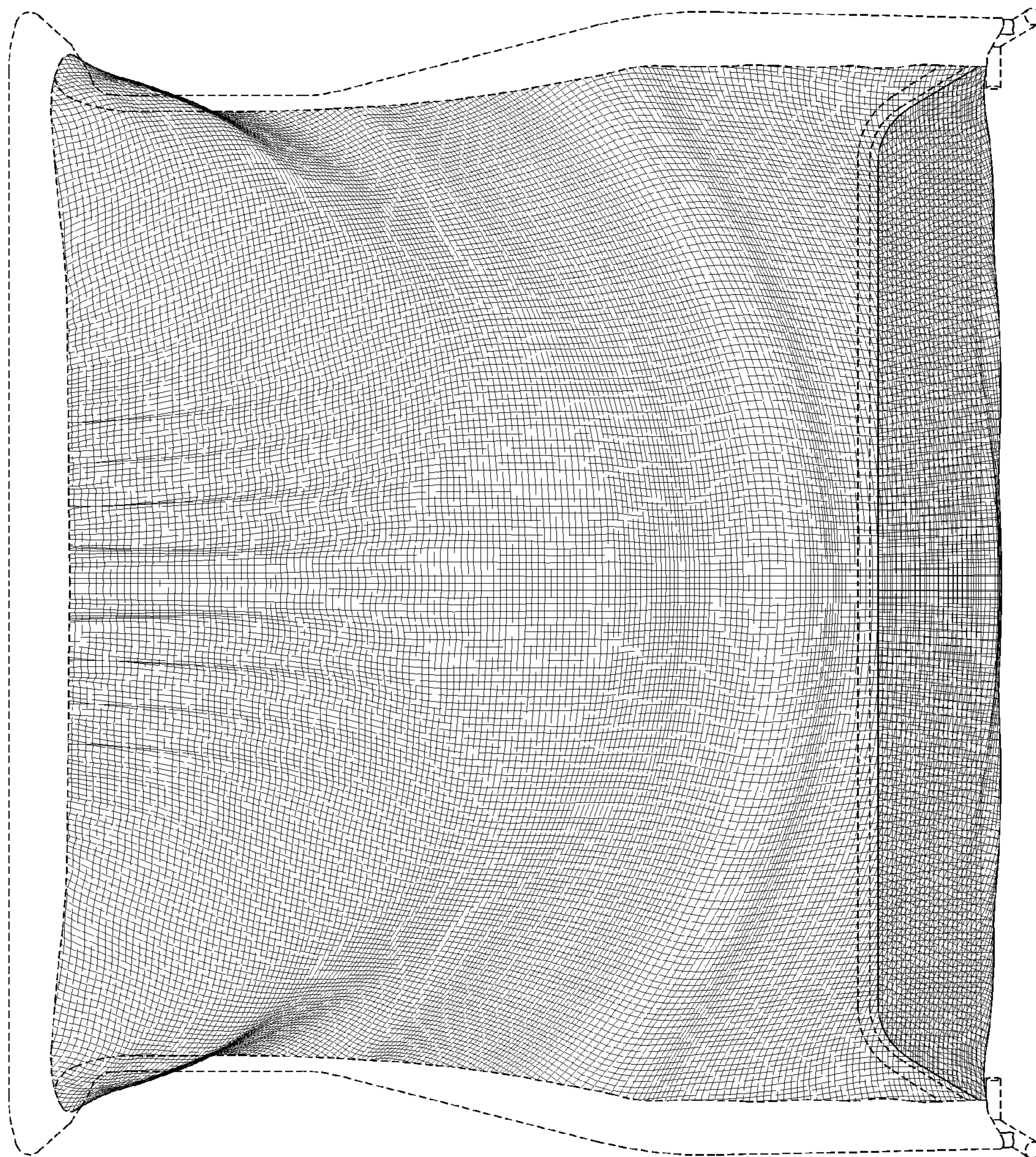

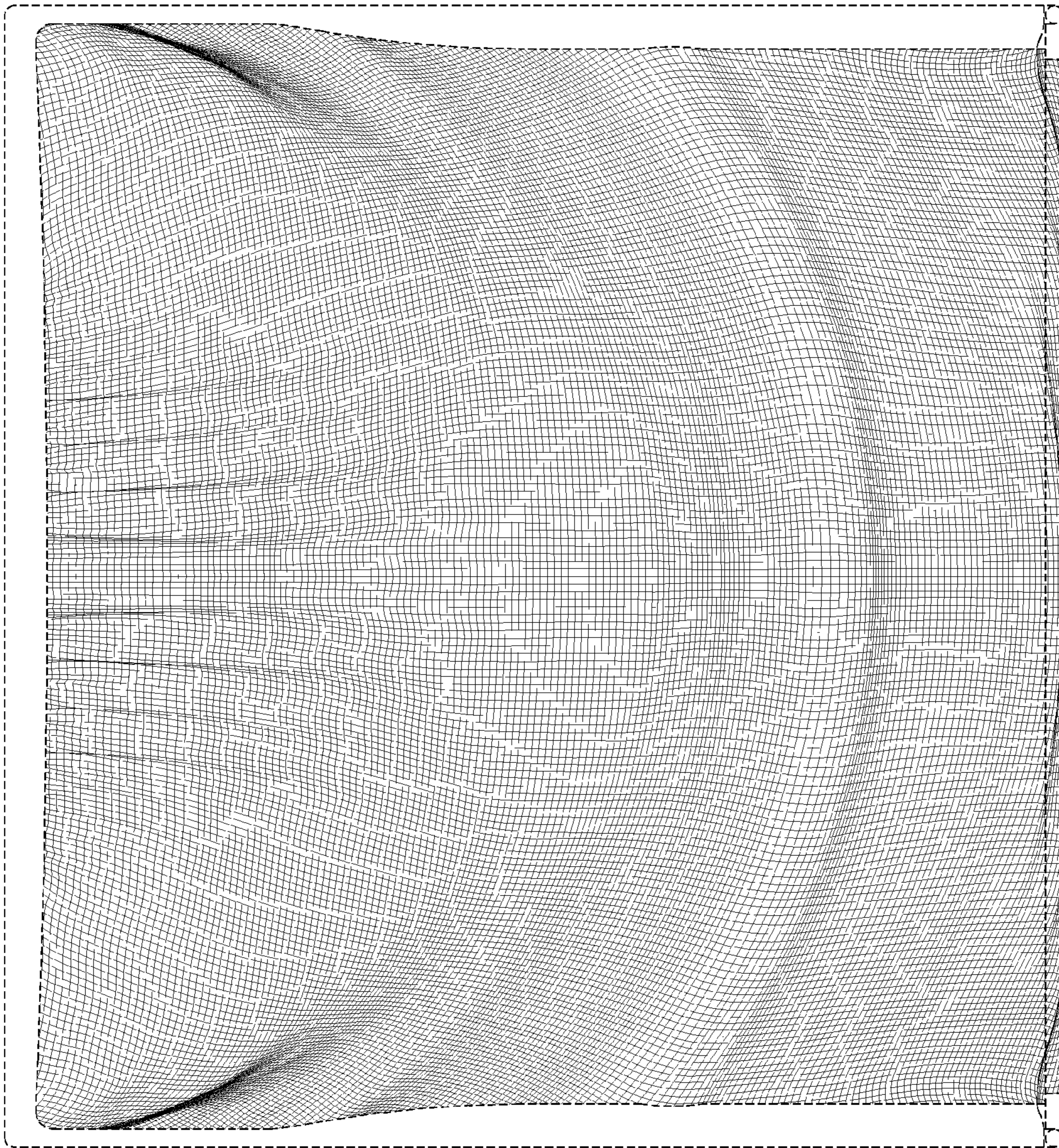

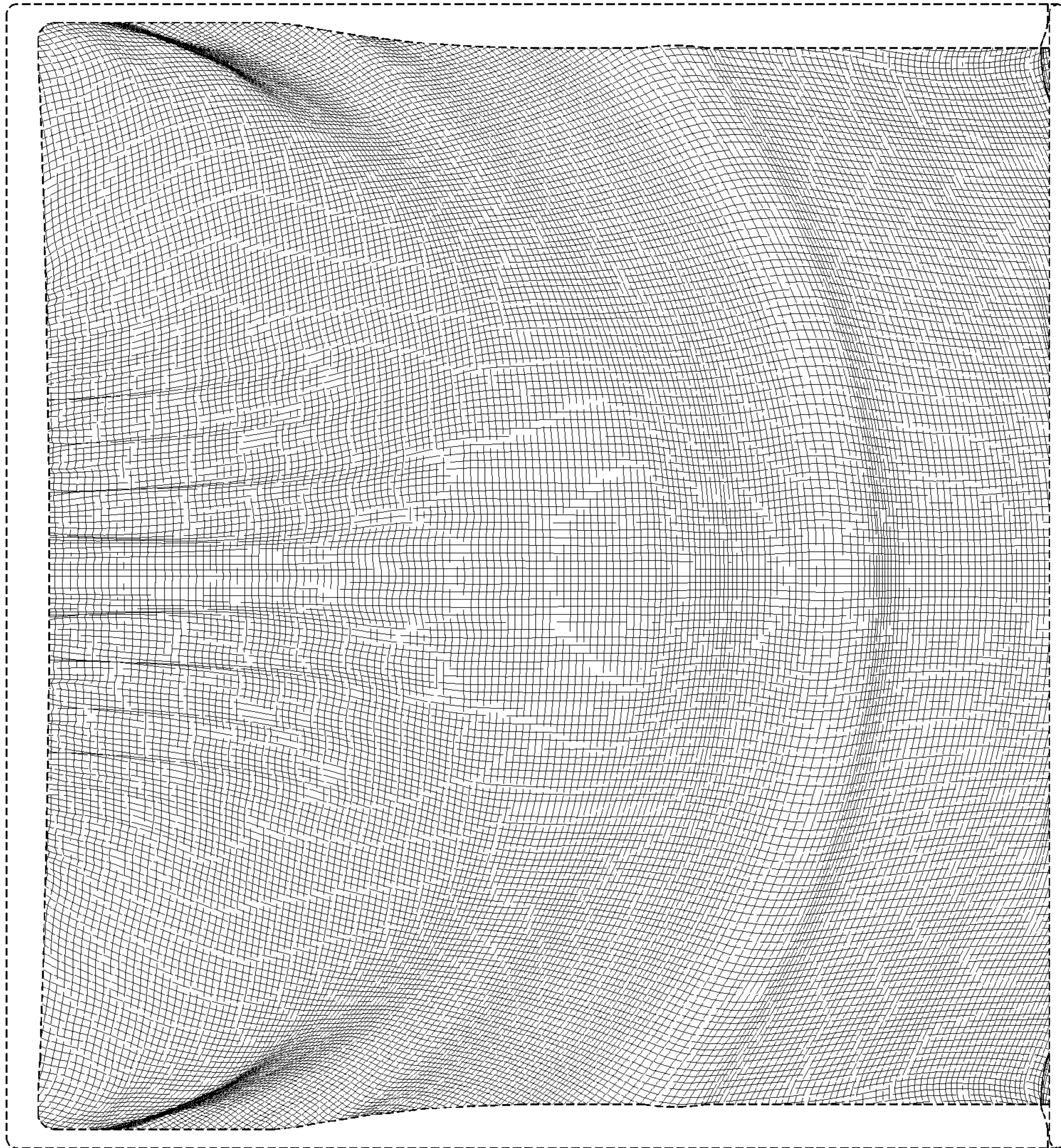

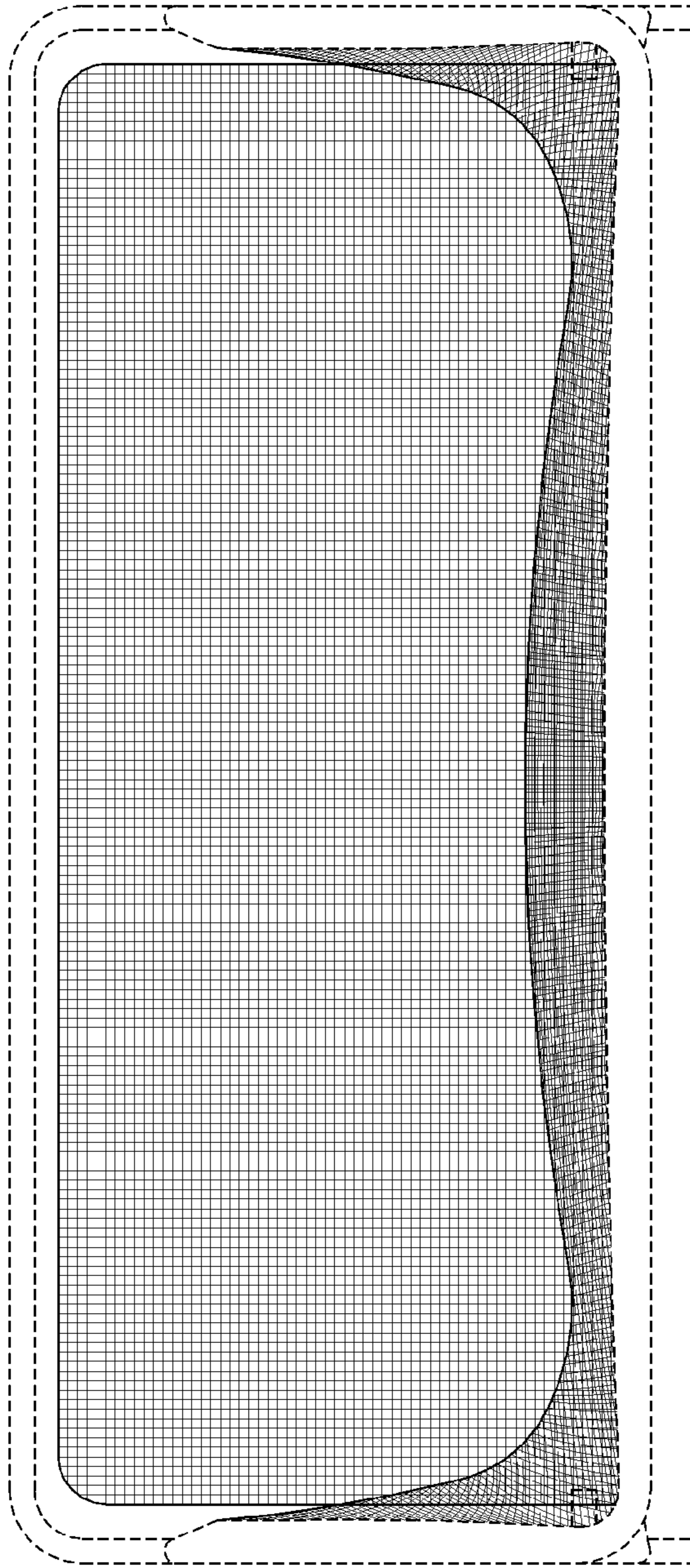
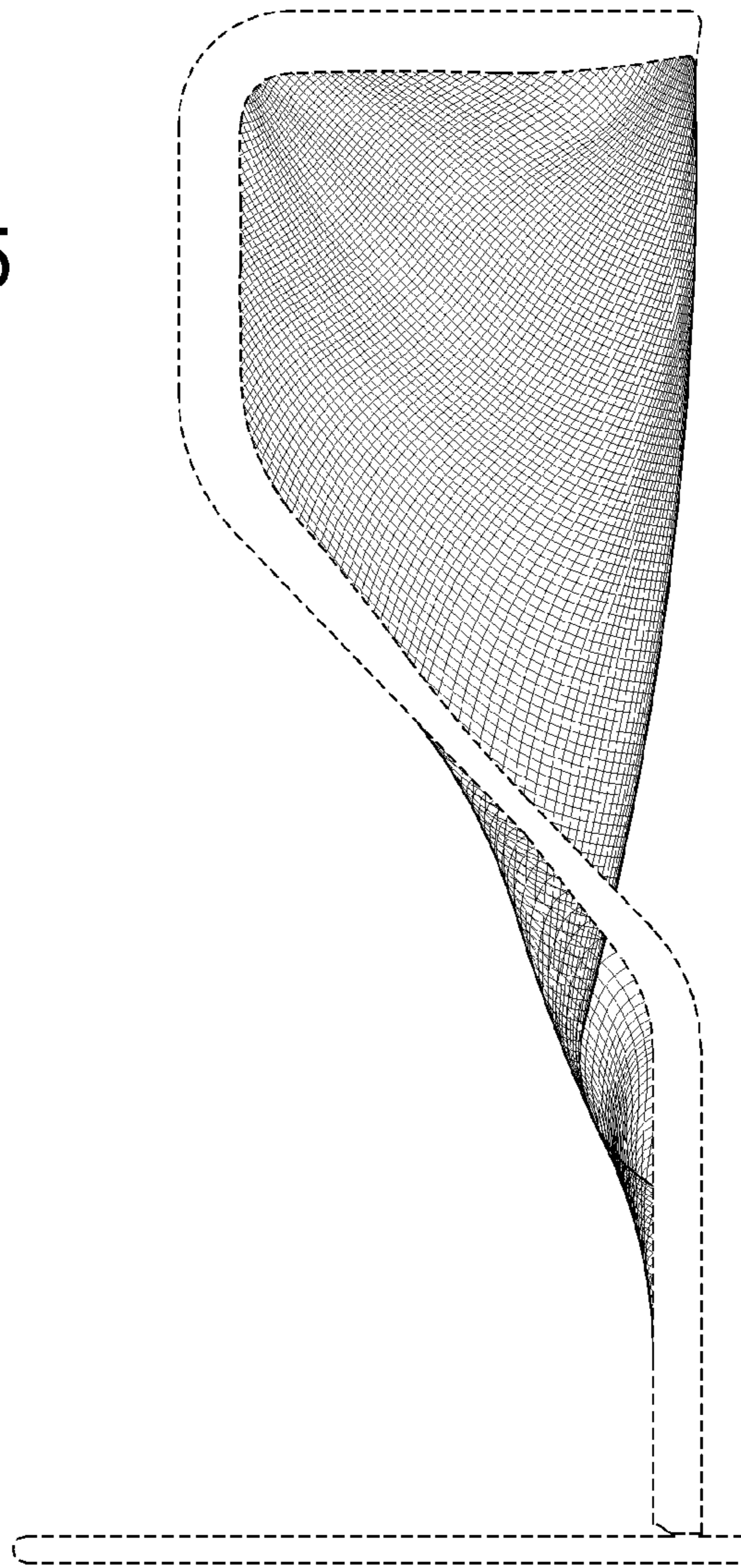

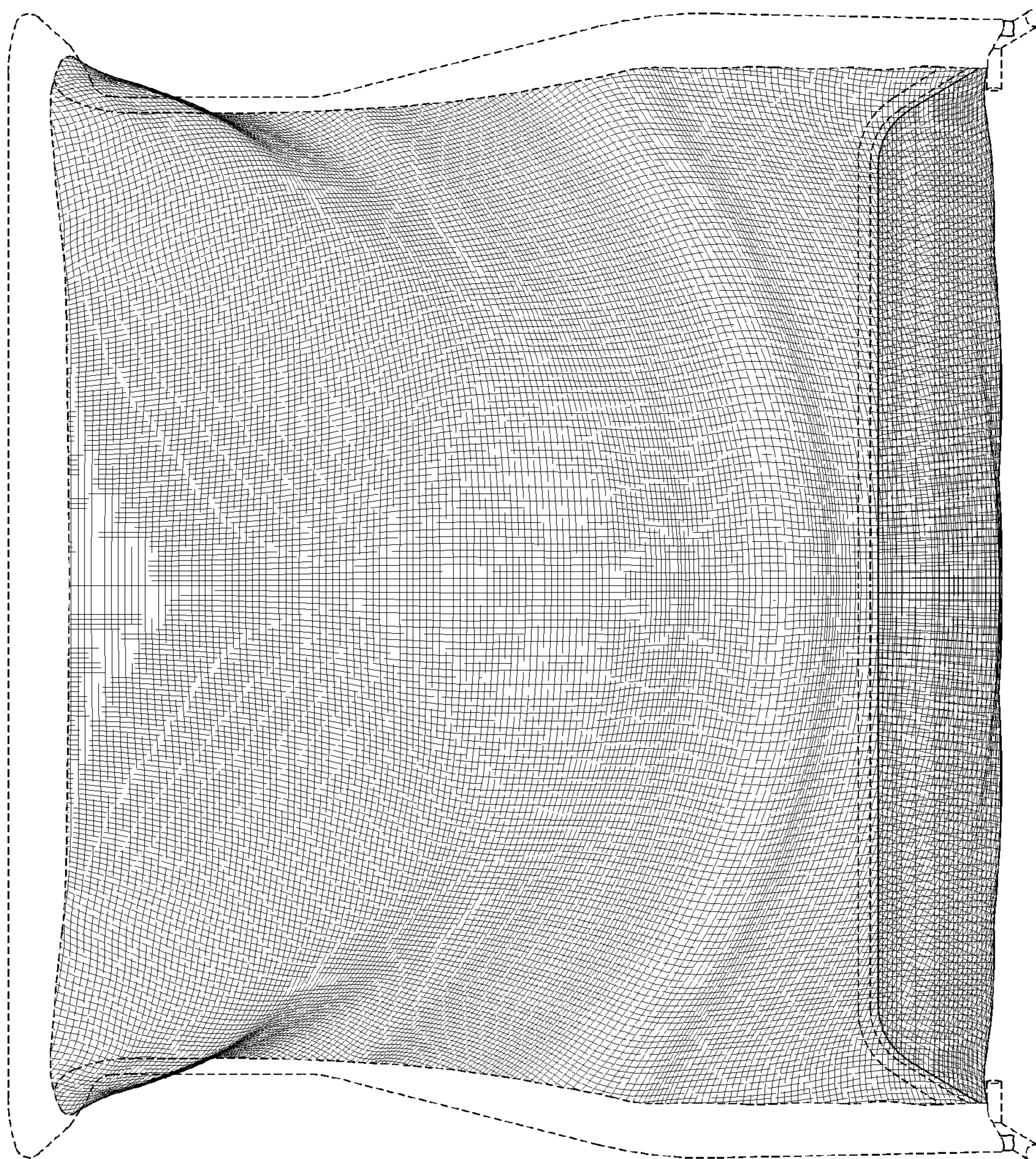

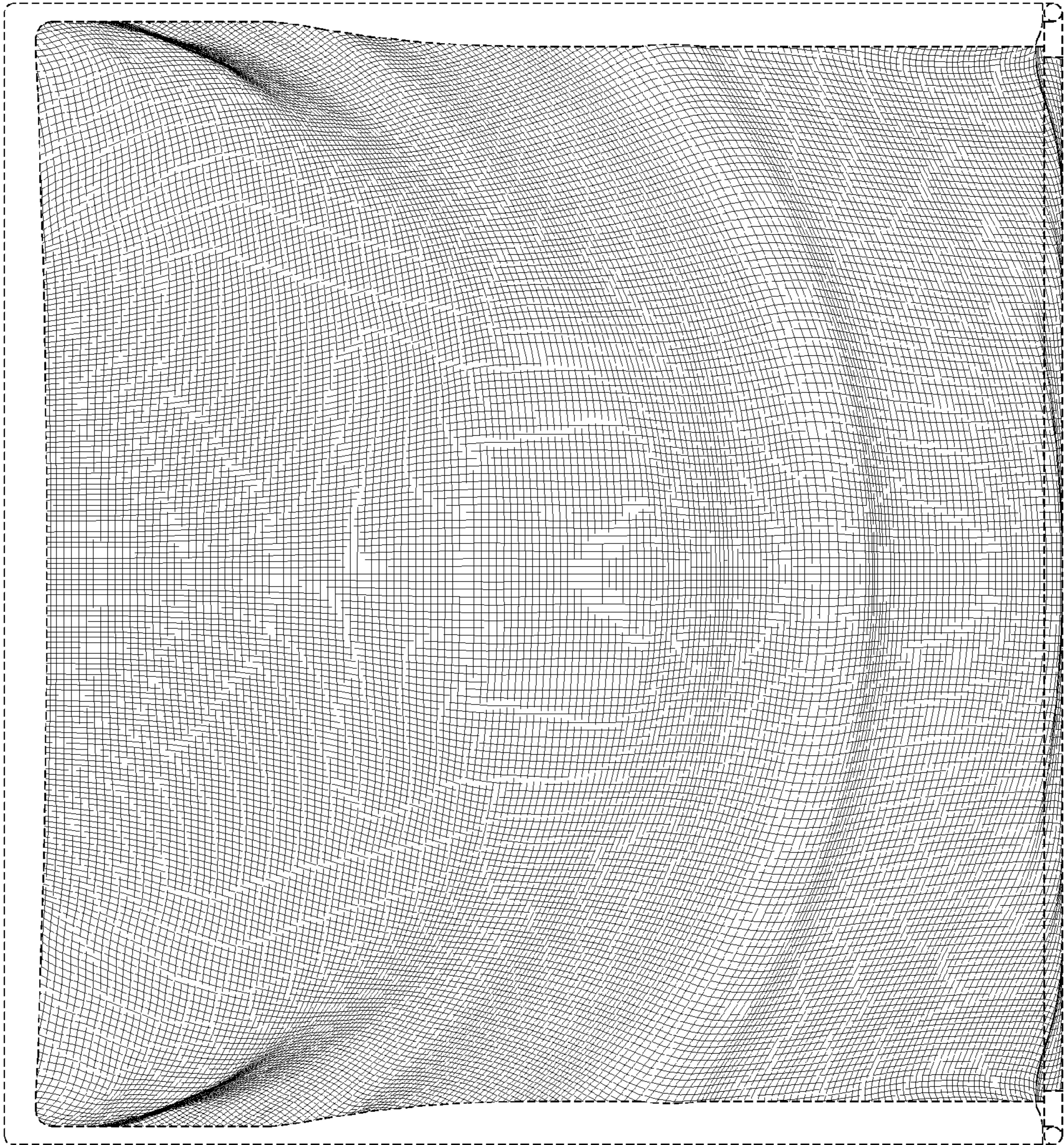

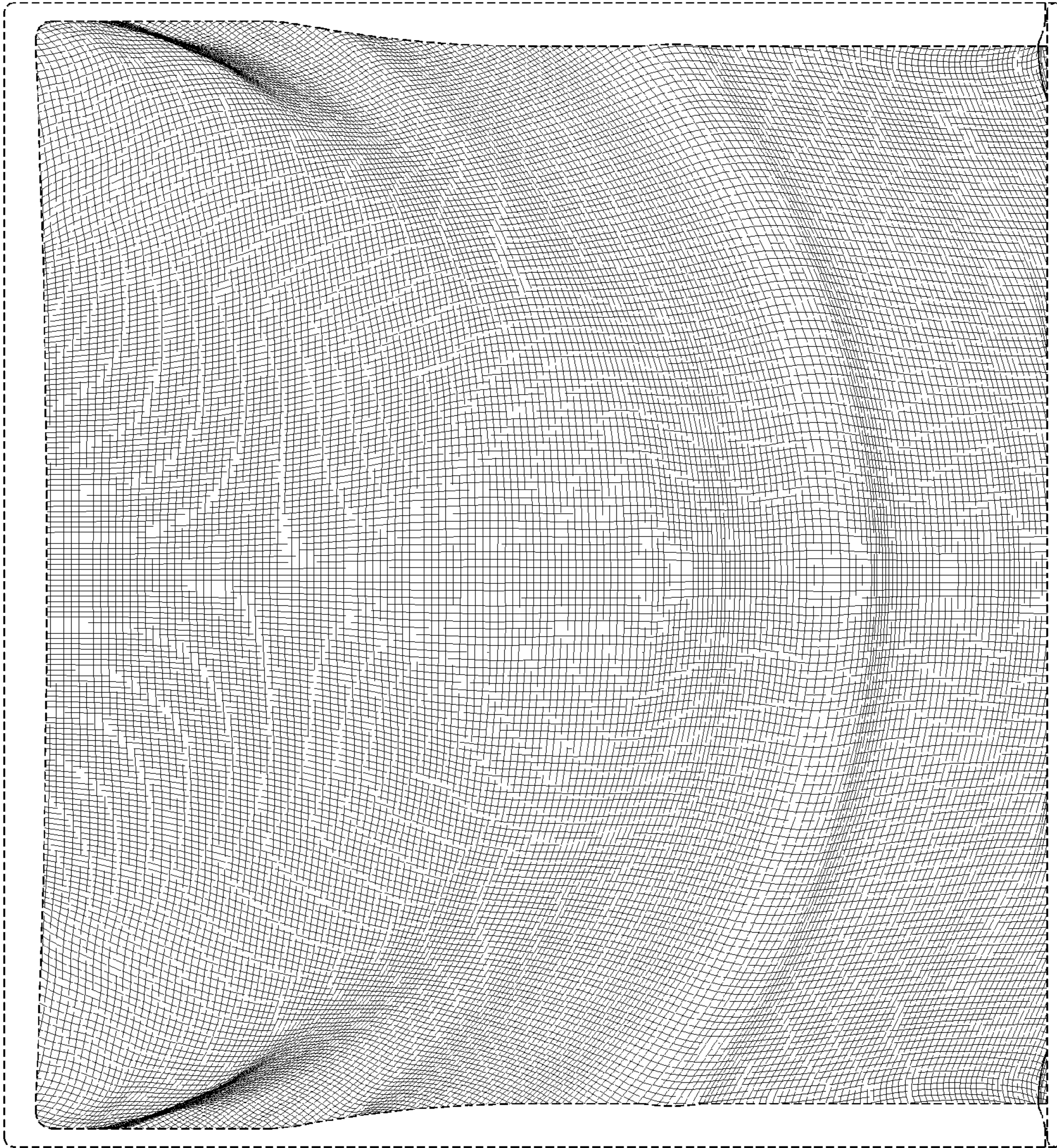

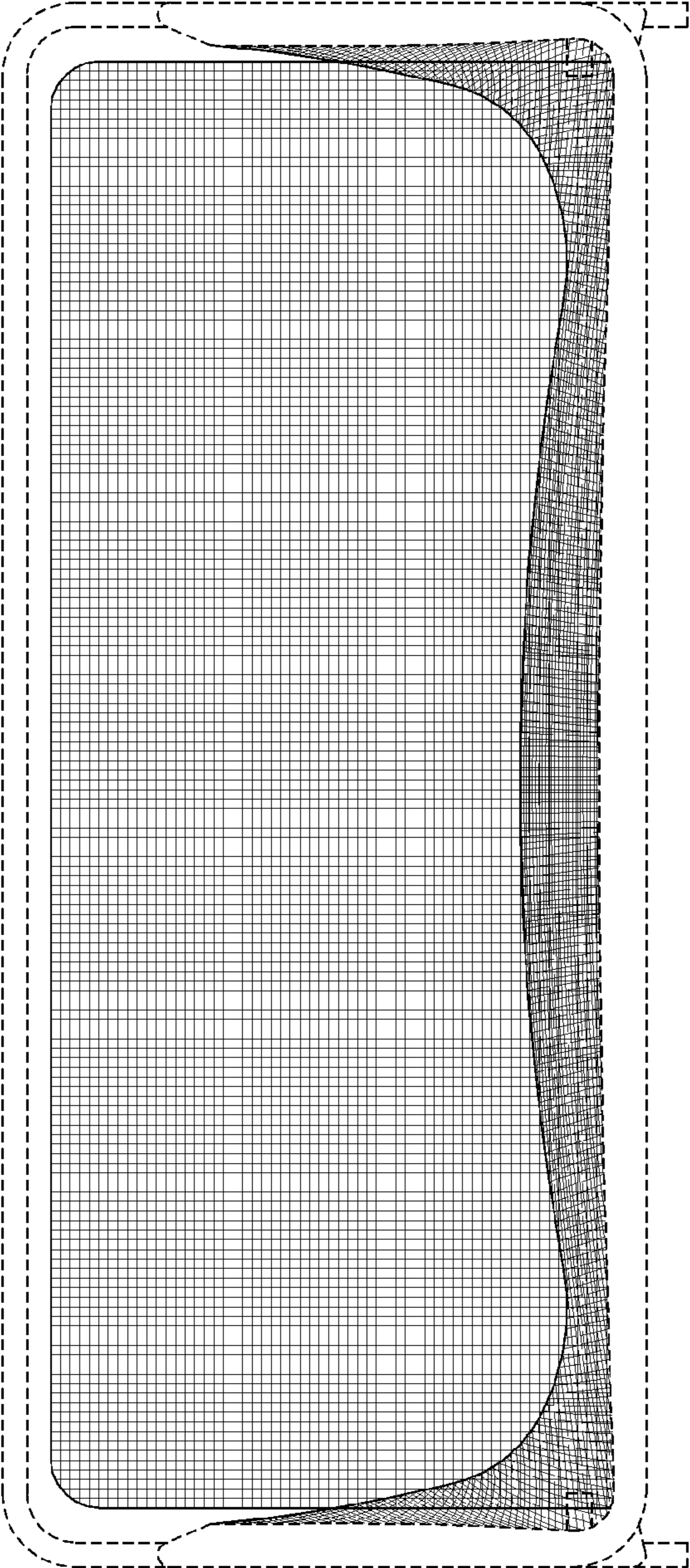
