(57) **CLAIM**

The ornamental design for a set of large artificial pillar candles with live flame for weddings and events, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a set of large artificial pillar candles with live flame for weddings and events;

FIG. 2 is a perspective view comparable to FIG. 1 except showing the set of large artificial pillar candles with live flame for weddings and events in isolation and on an enlarged scale;

FIG. 3 is a front elevational view of the set of large artificial candles shown in an alternate position;

FIG. 4 is an enlarged-scale front elevational view of a representative one of the set, wherein all four pillars are identical except the height;

FIG. 5 is a left side elevational view thereof;

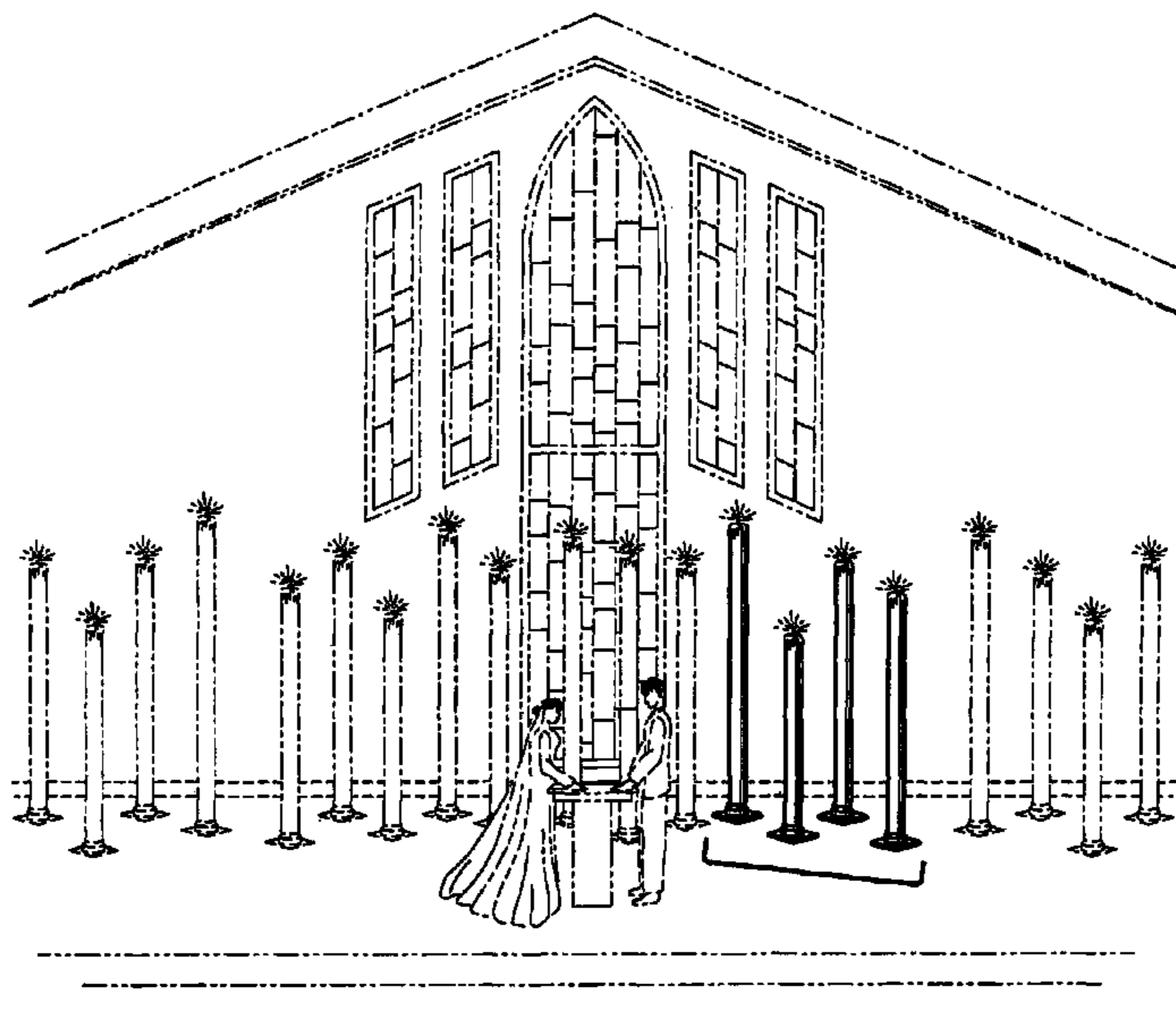
FIG. 6 is a right side elevational view thereof;

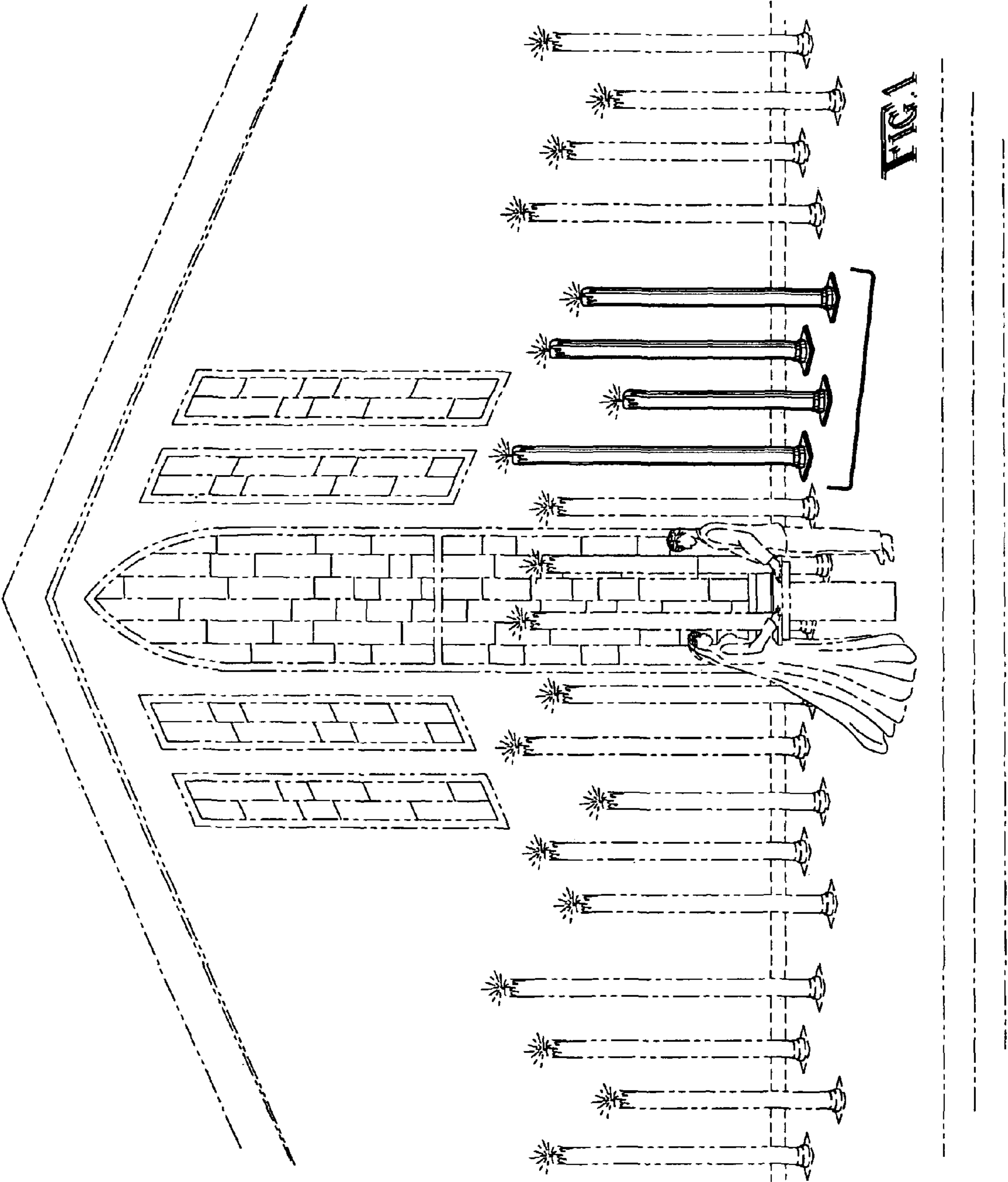
FIG. 7 is rear elevational view thereof; and,

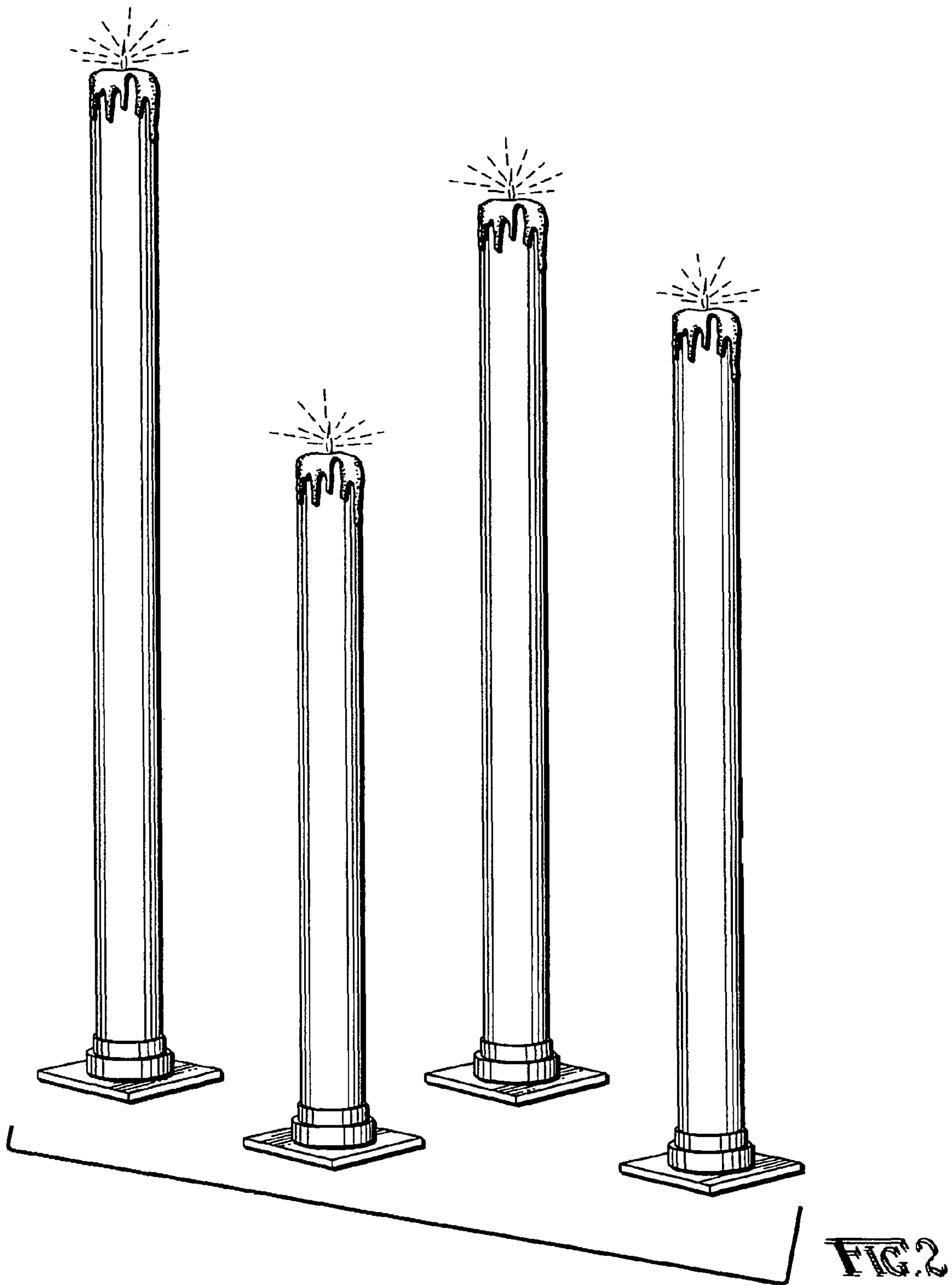
FIG. 8 is a top plan view thereof, wherein the bottom is devoid of surface ornamentation.

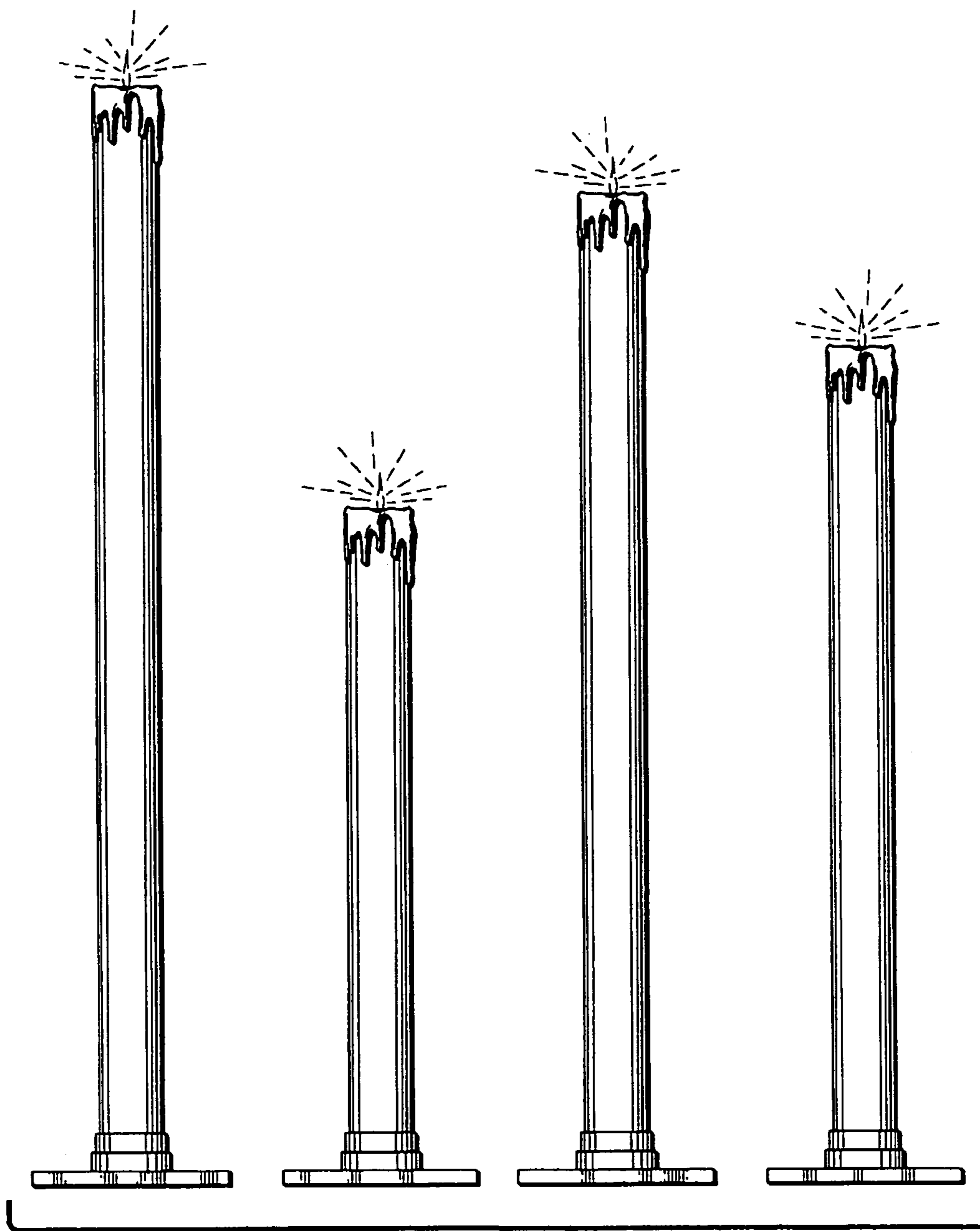
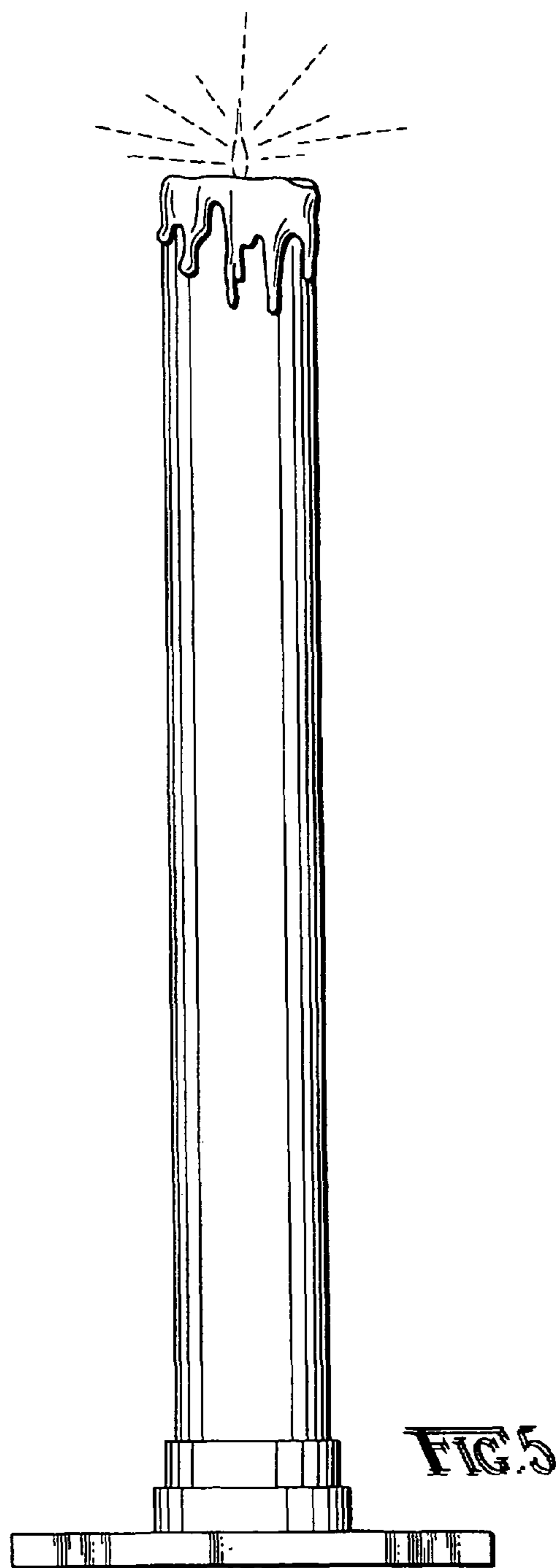
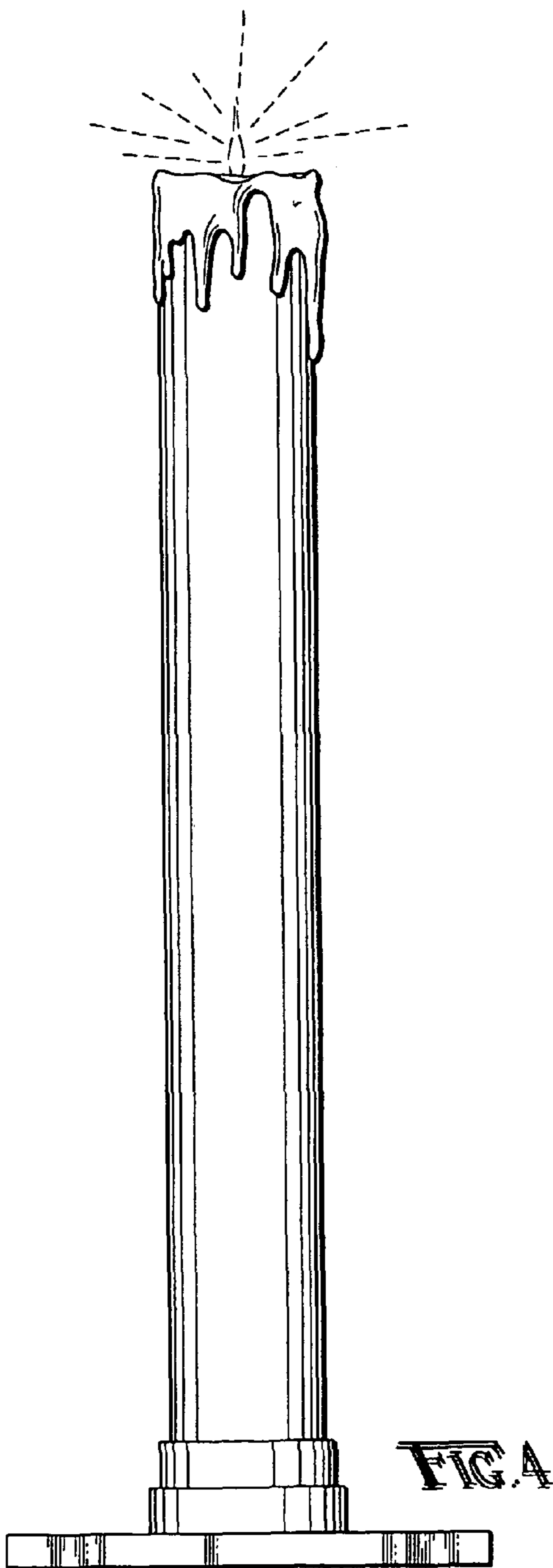
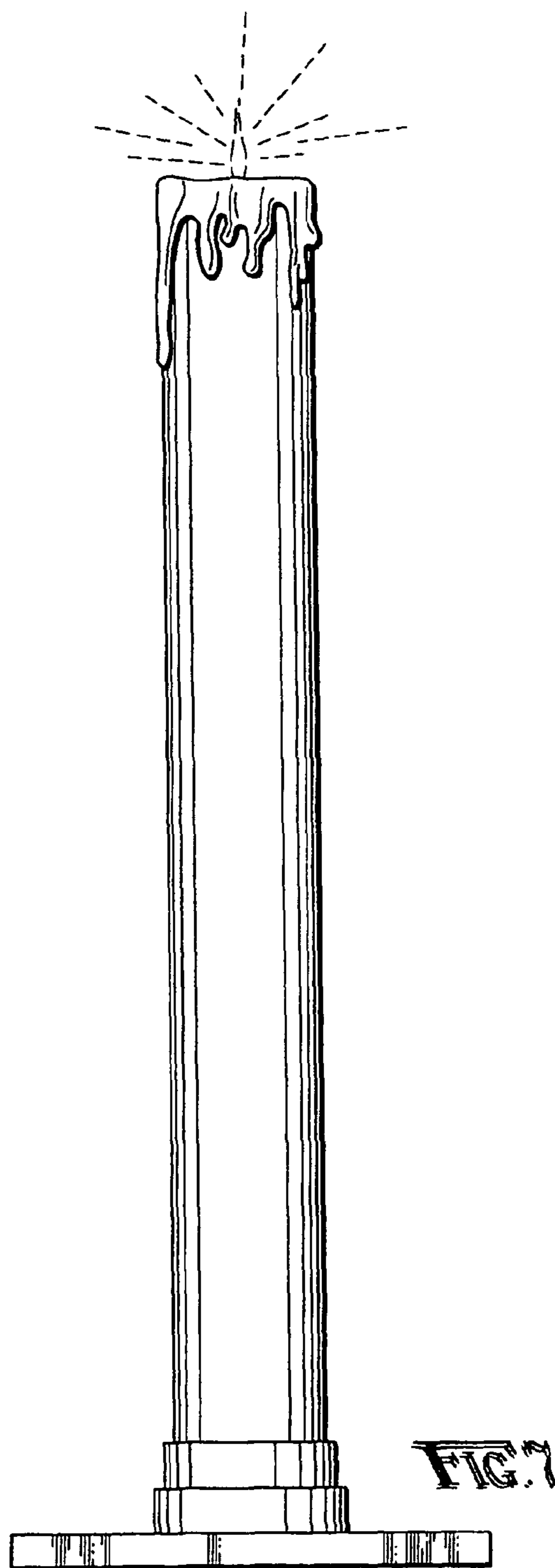
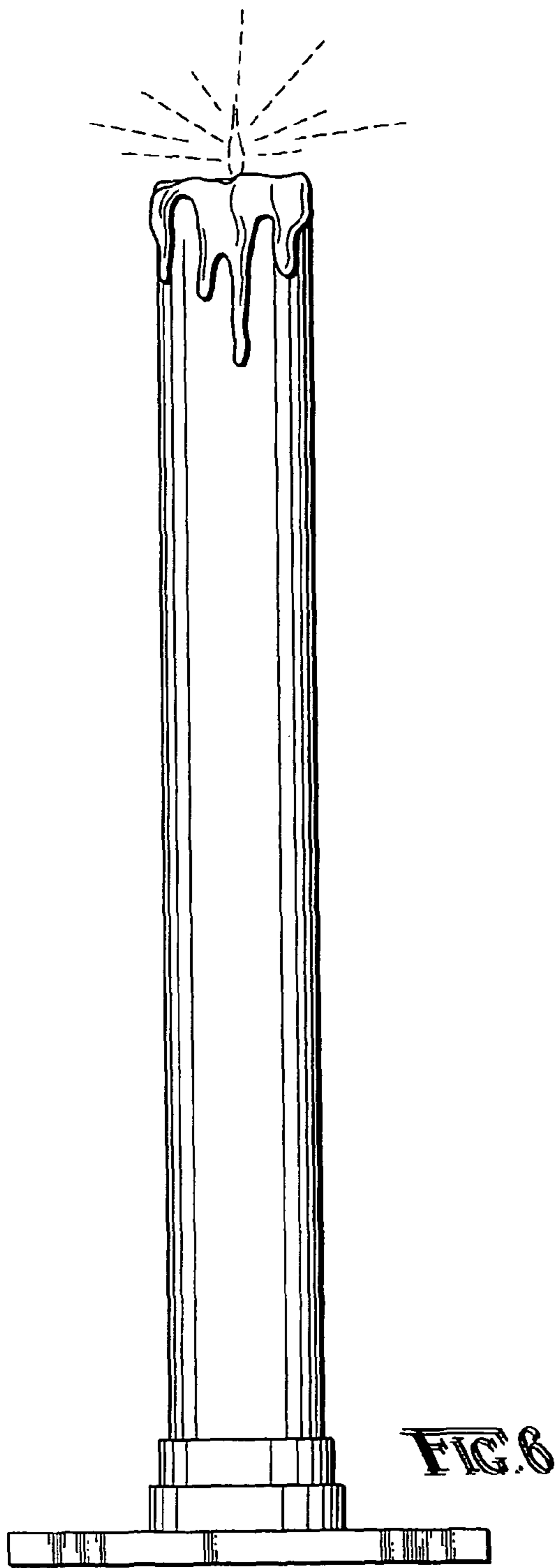

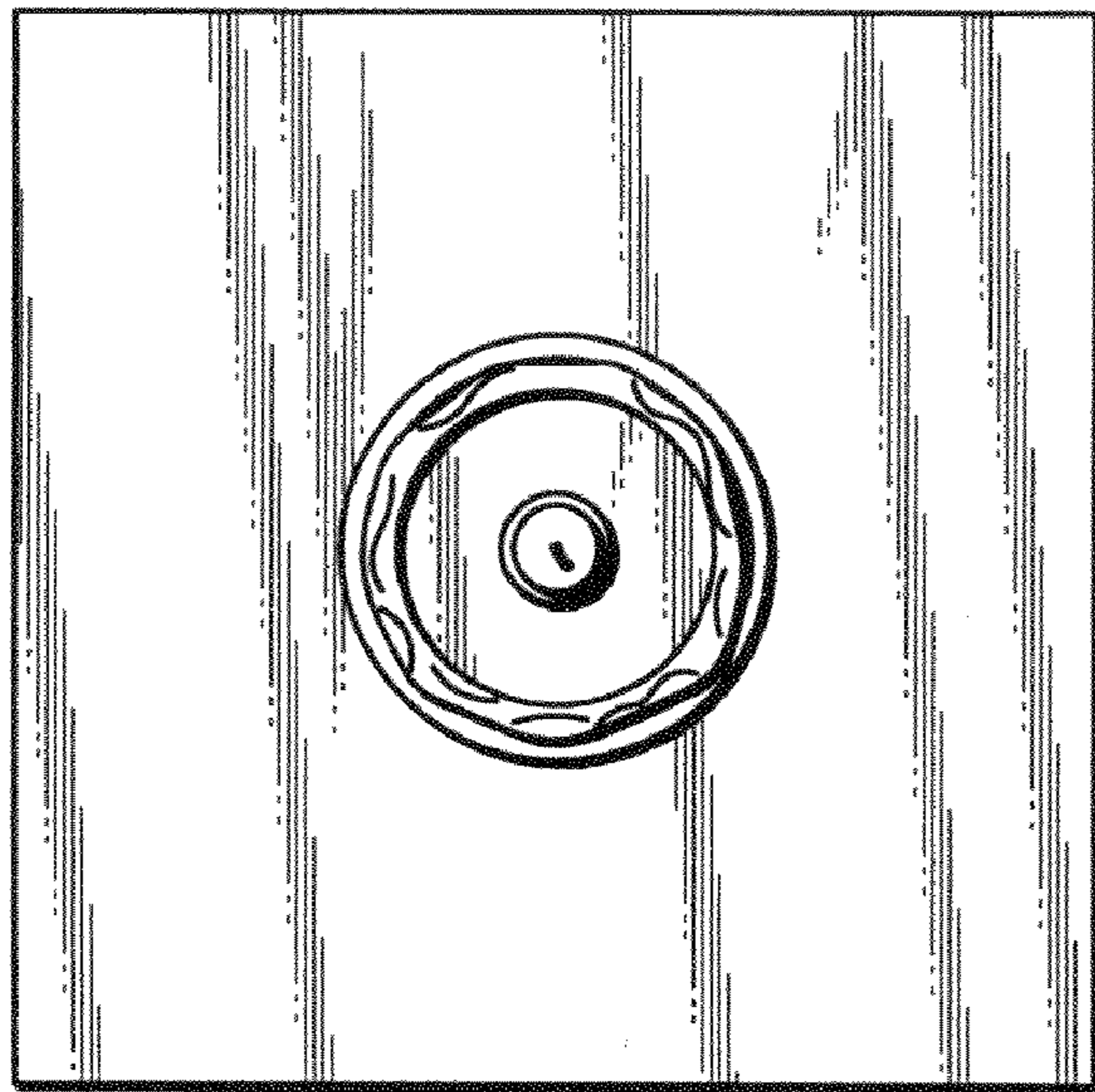
