(57) **CLAIM**

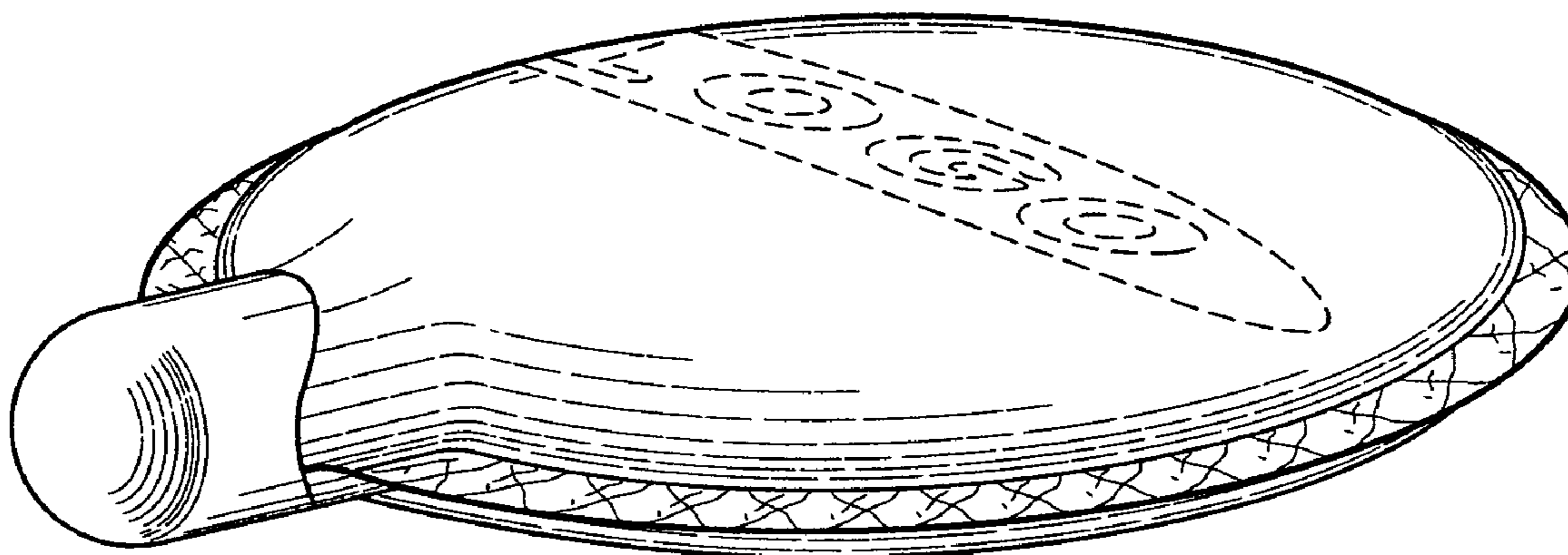
We claim the ornamental design for a light device, as shown and described.

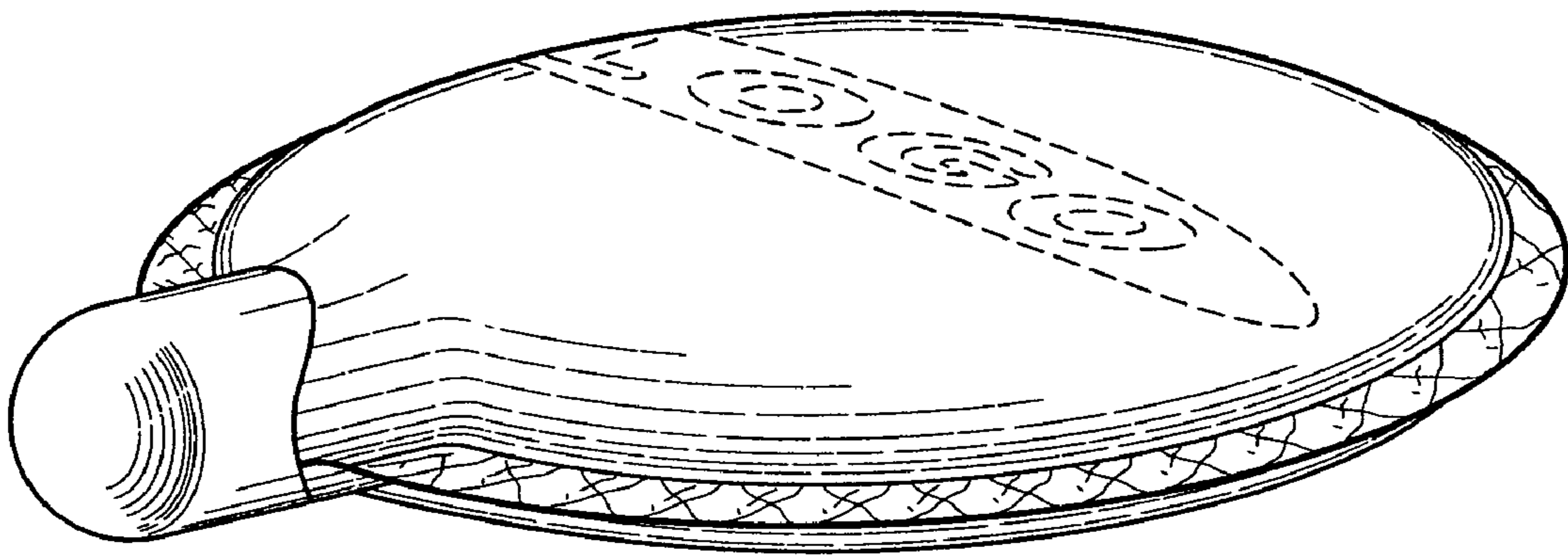

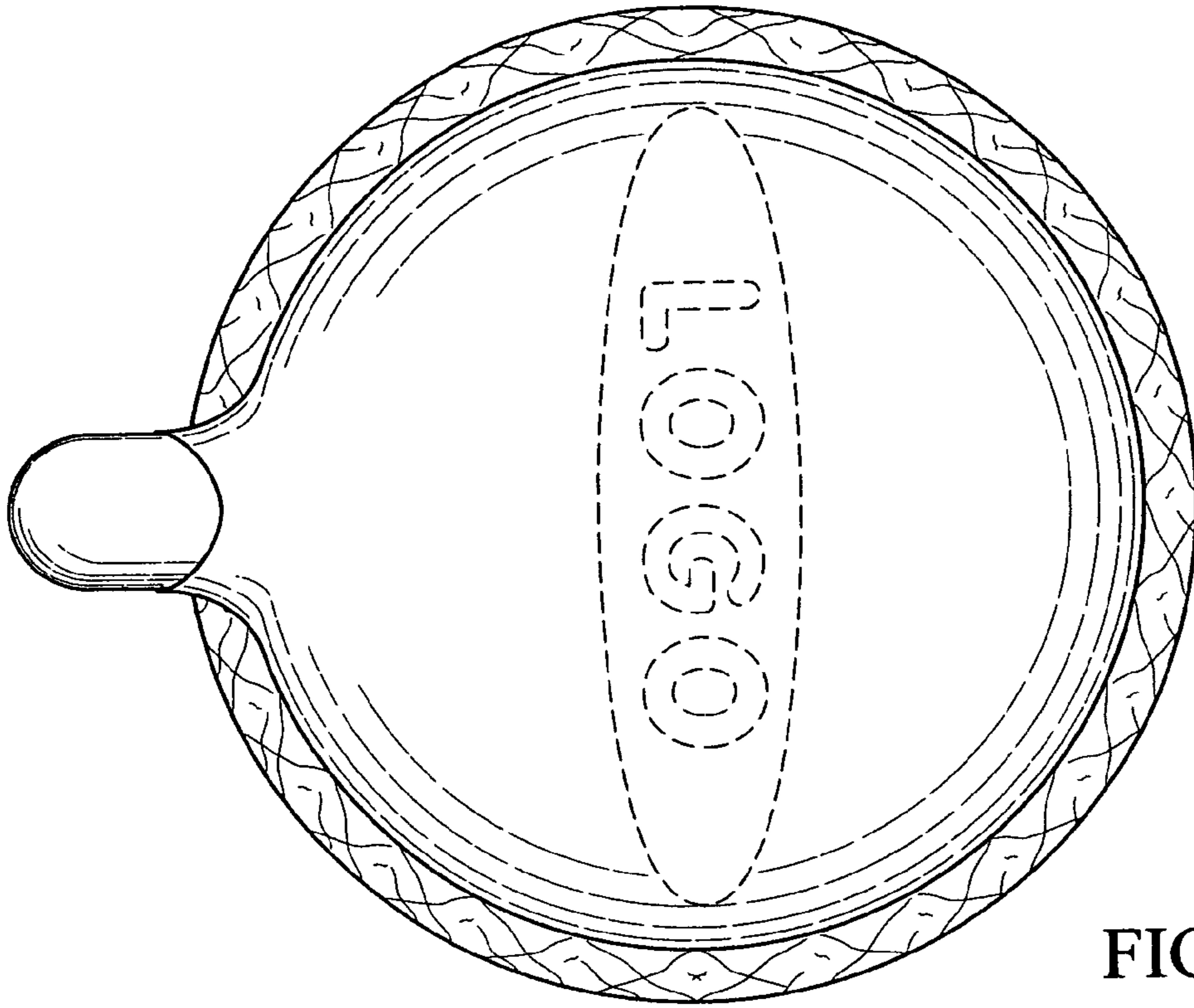

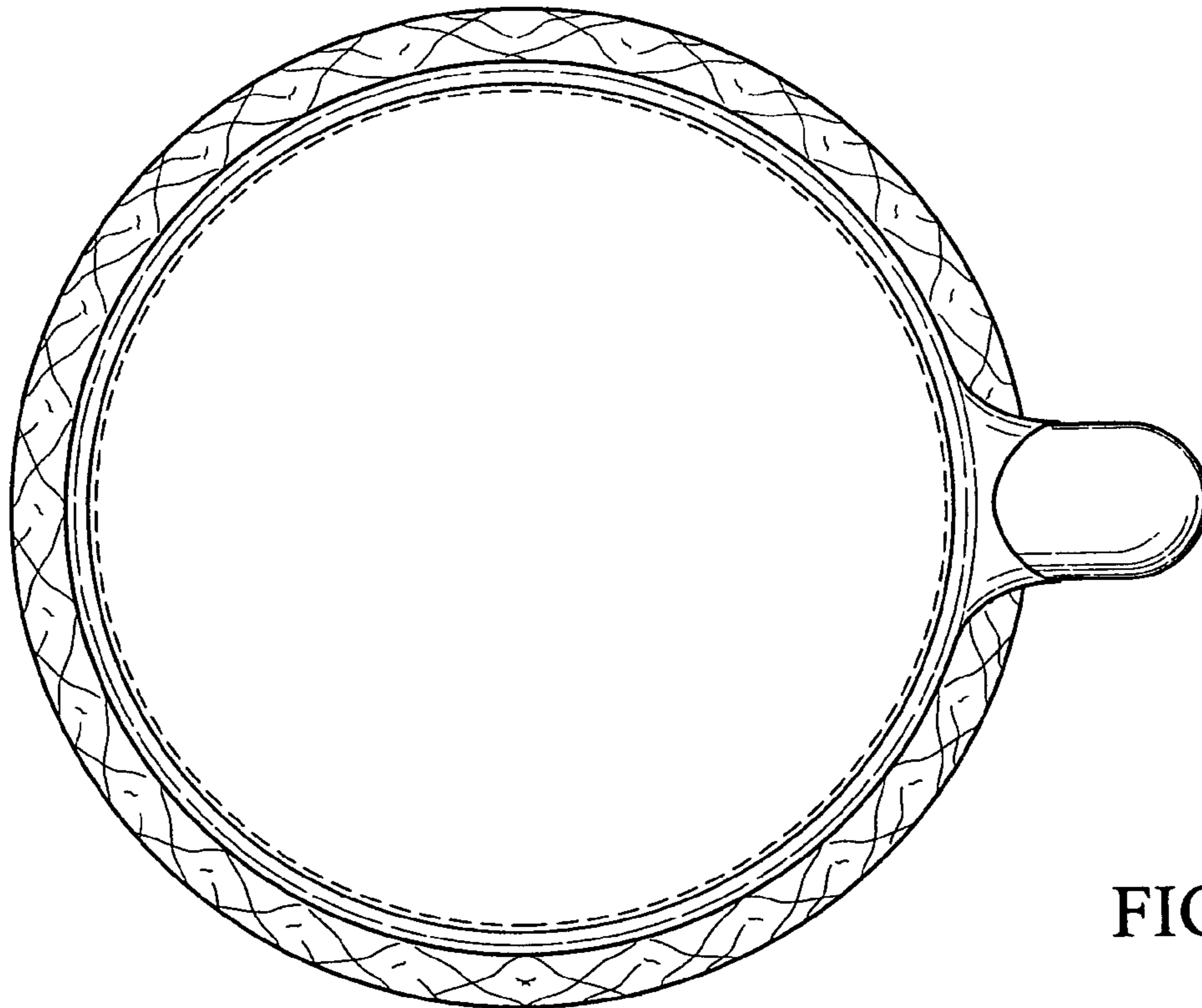

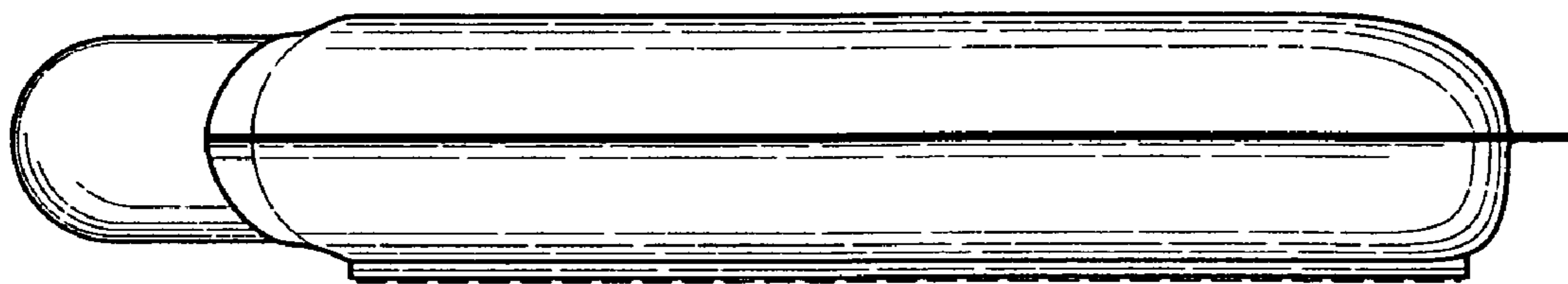

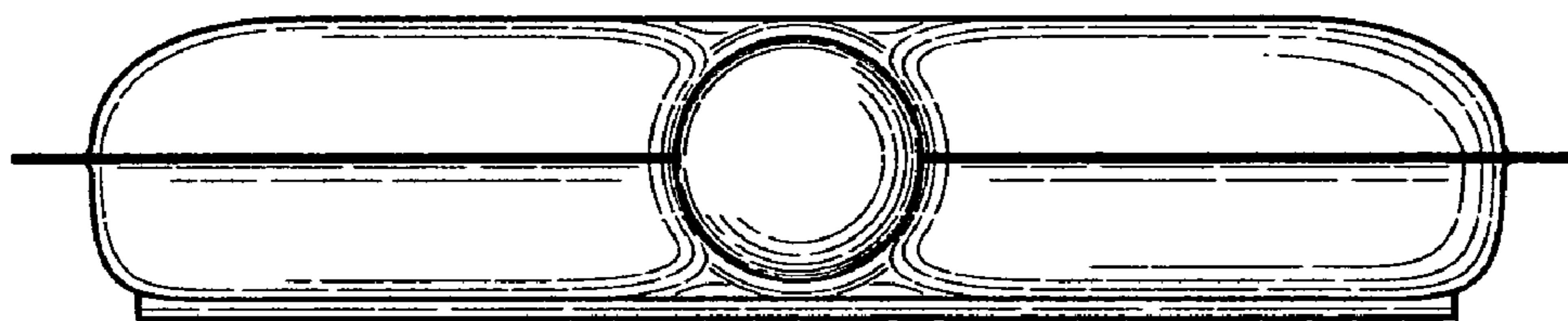

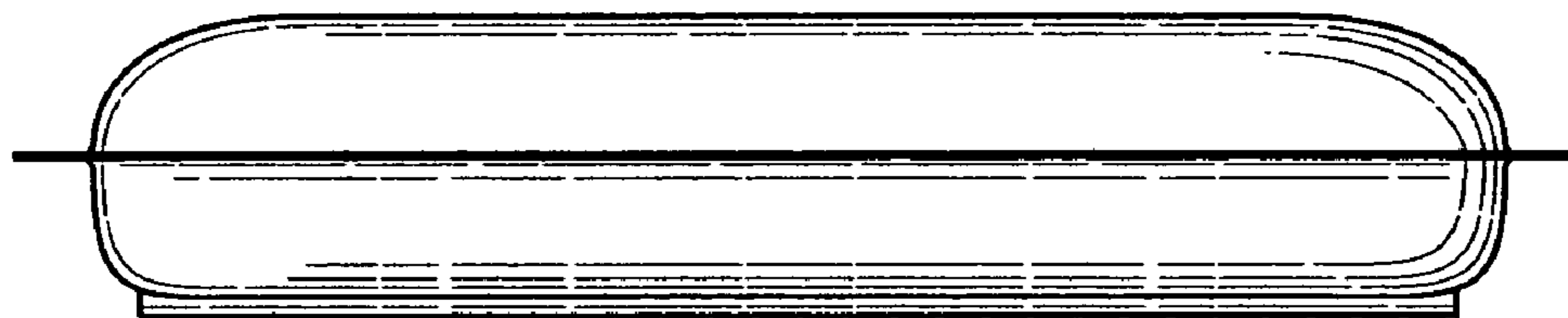
