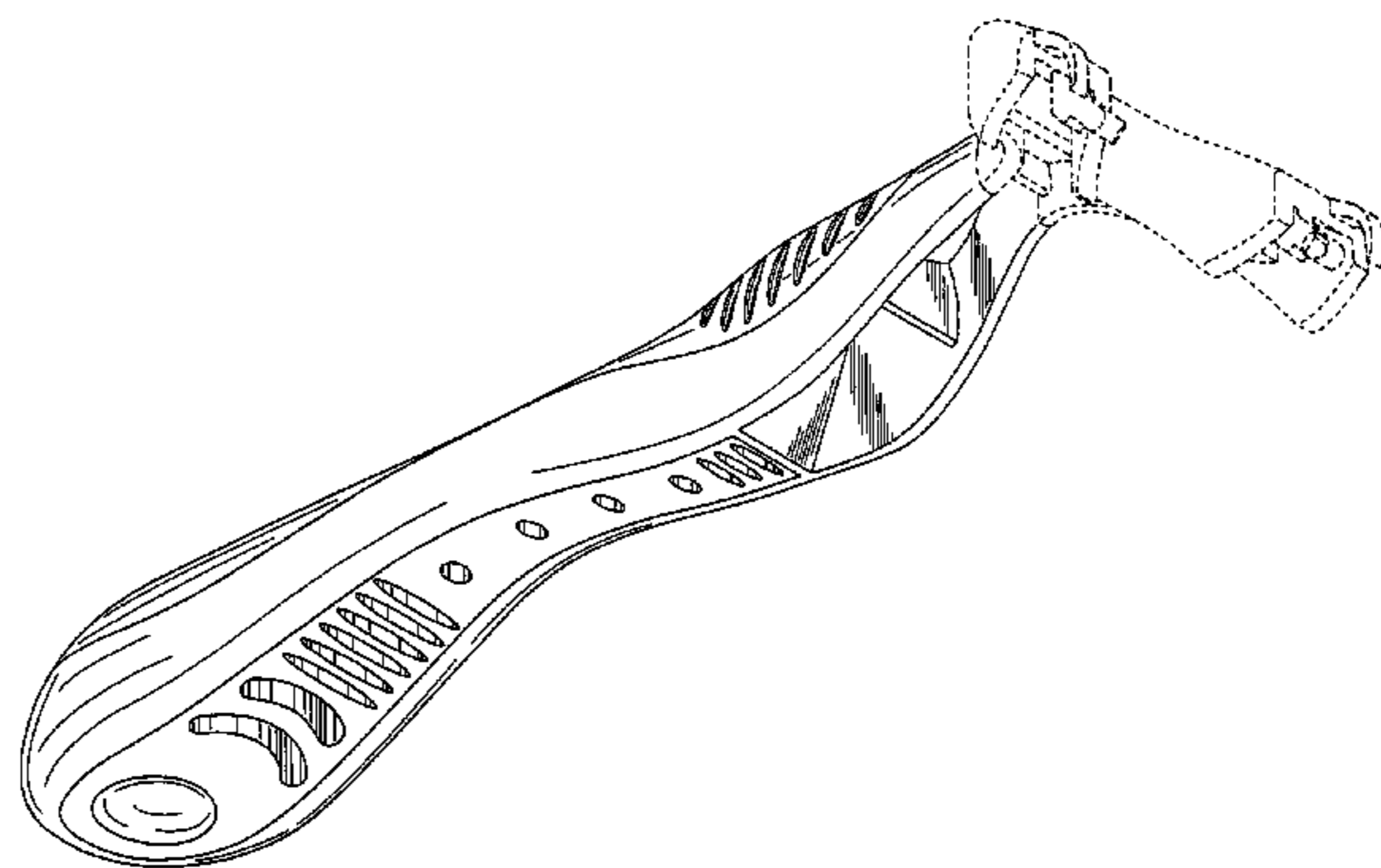
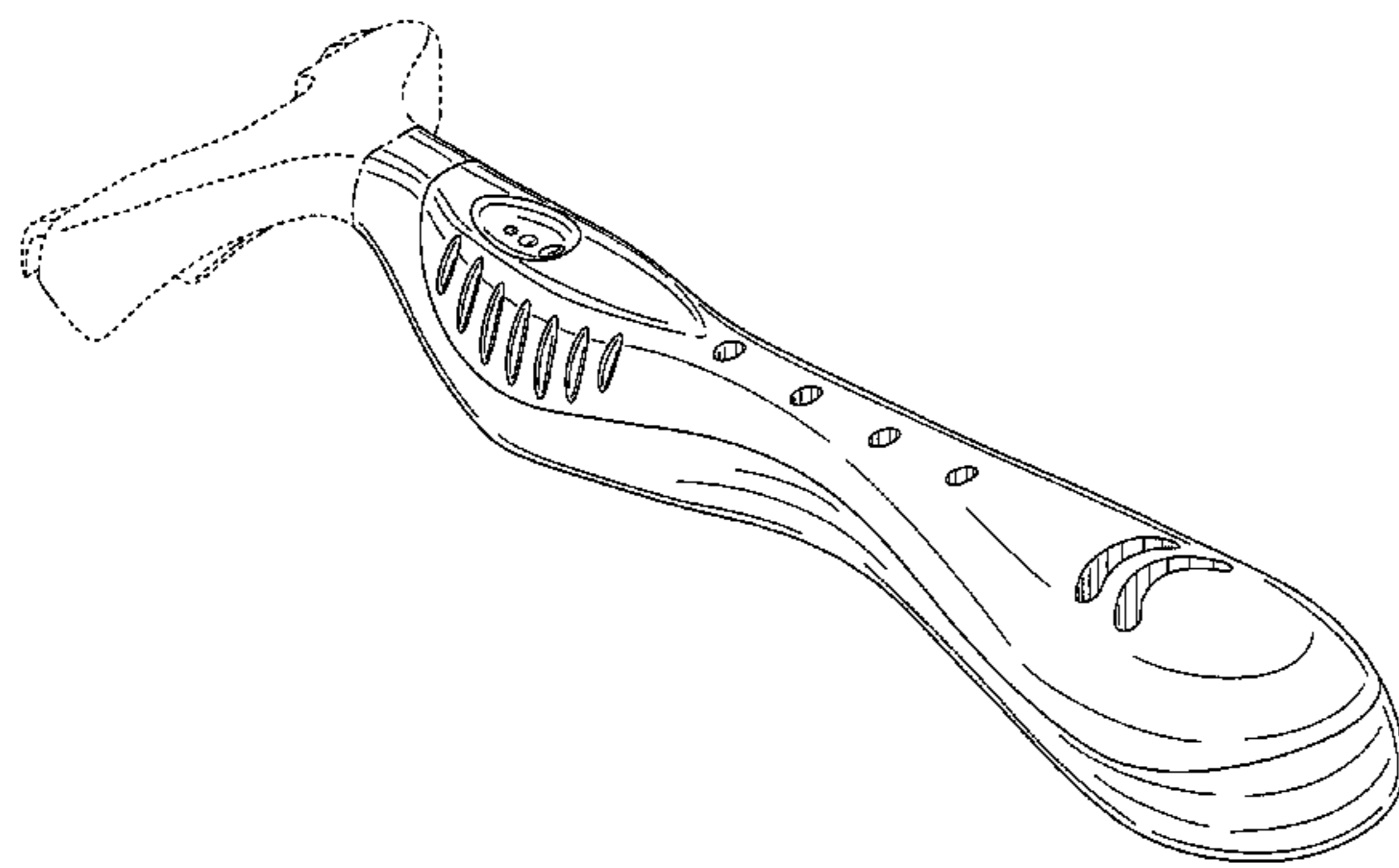
The ornamental design for a safety razor handle, as shown and described.

**DESCRIPTION**

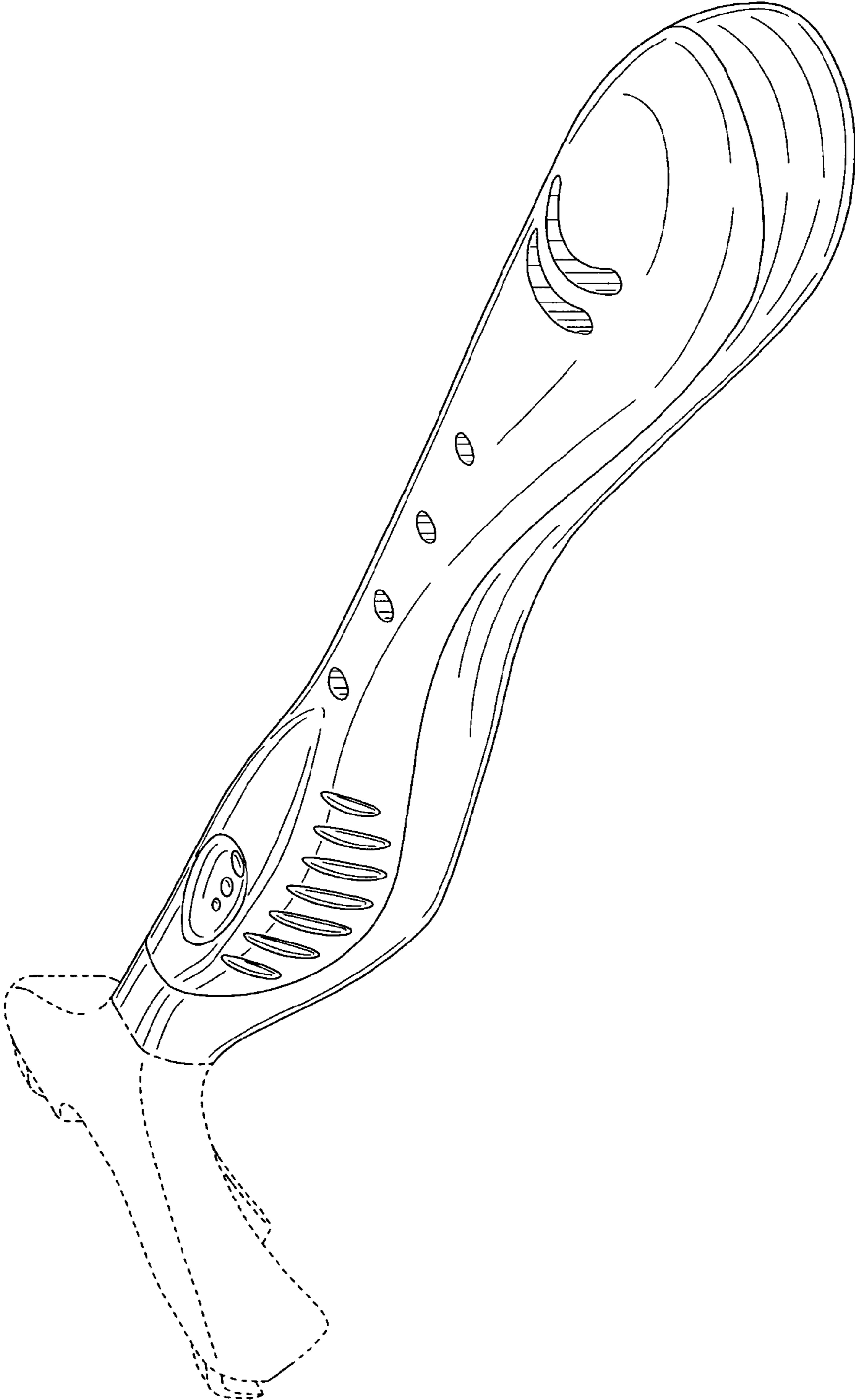
FIG. 1 is a front perspective view of a safety razor handle showing my new design;

The broken lines are shown for illustrative purposes only and form no part of the claimed design. The dot-dashed lines denote the boundary of the claim and form no part of the claimed design.

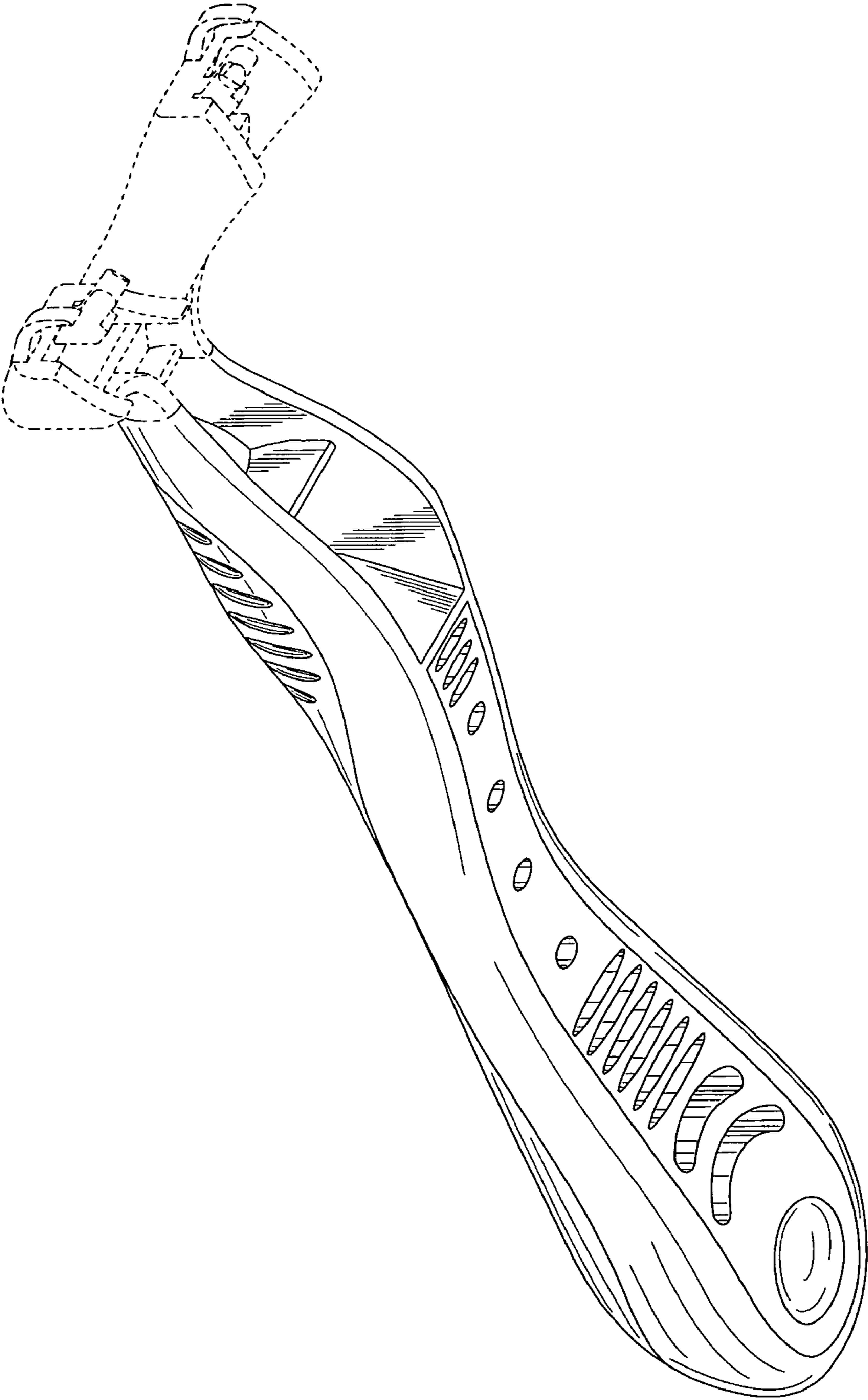

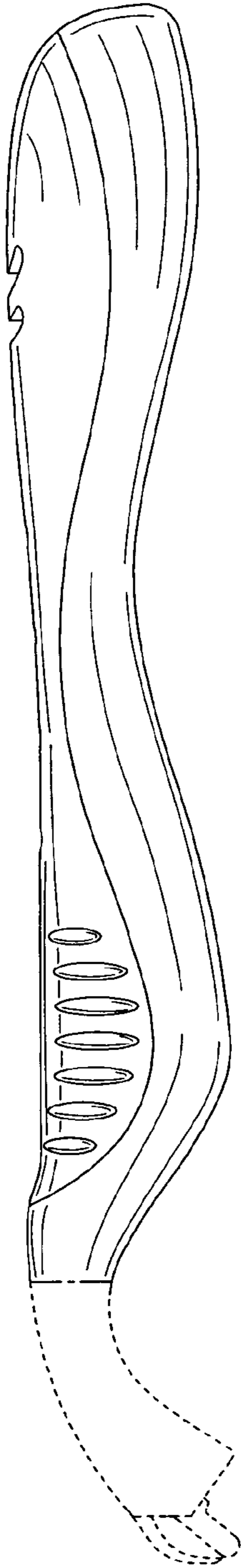

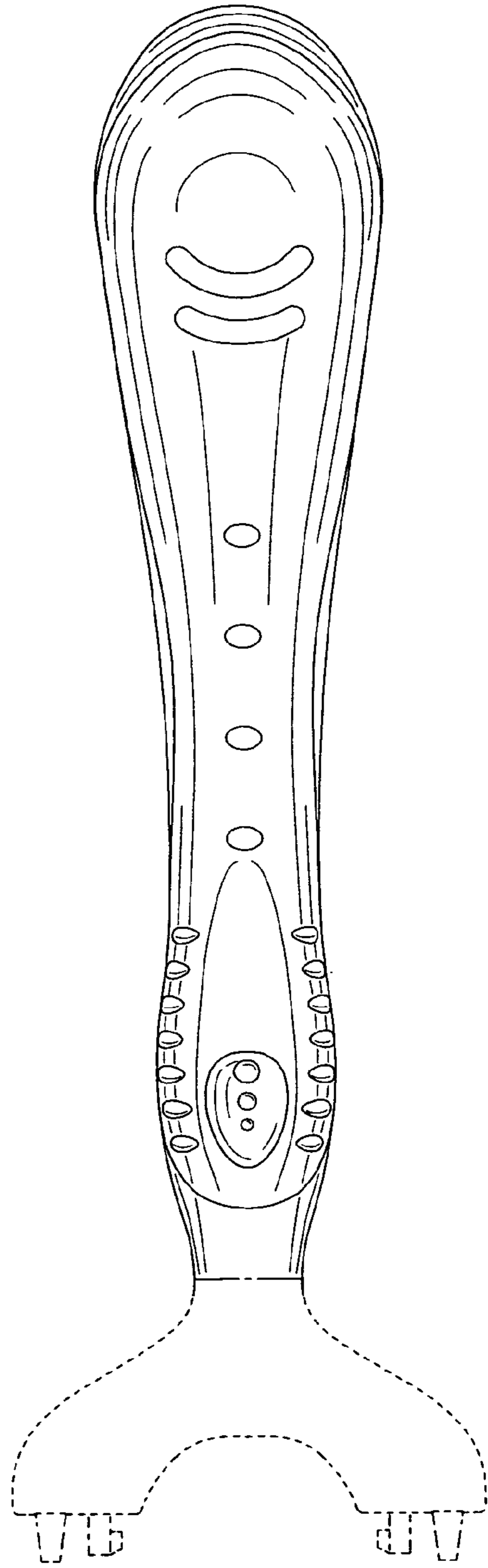

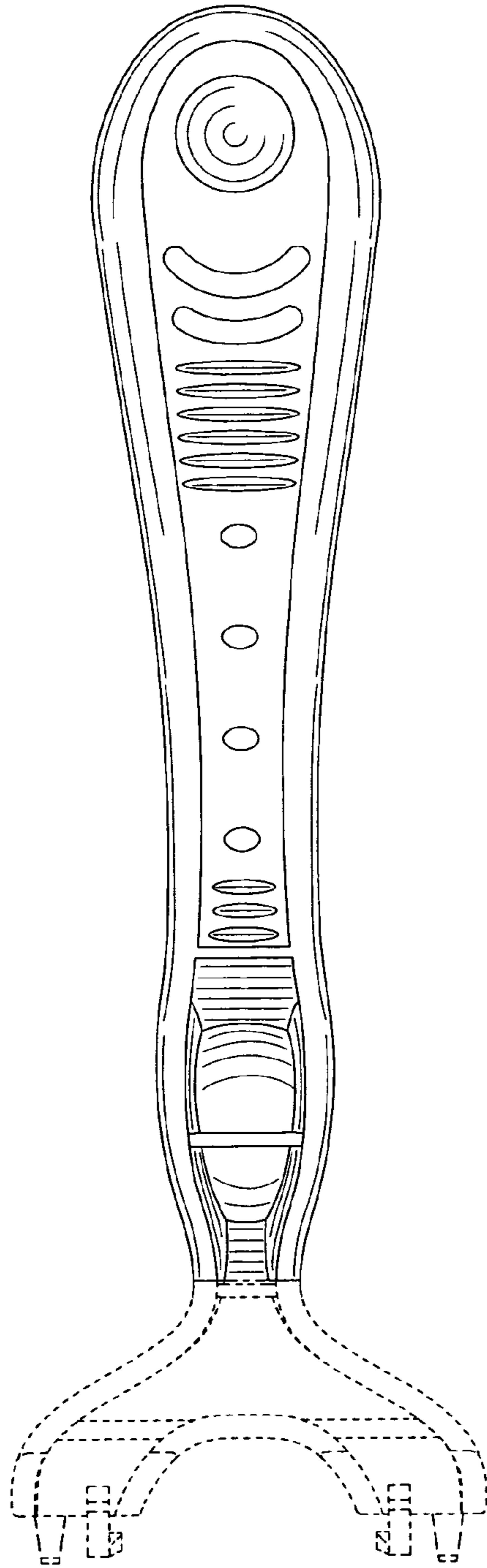

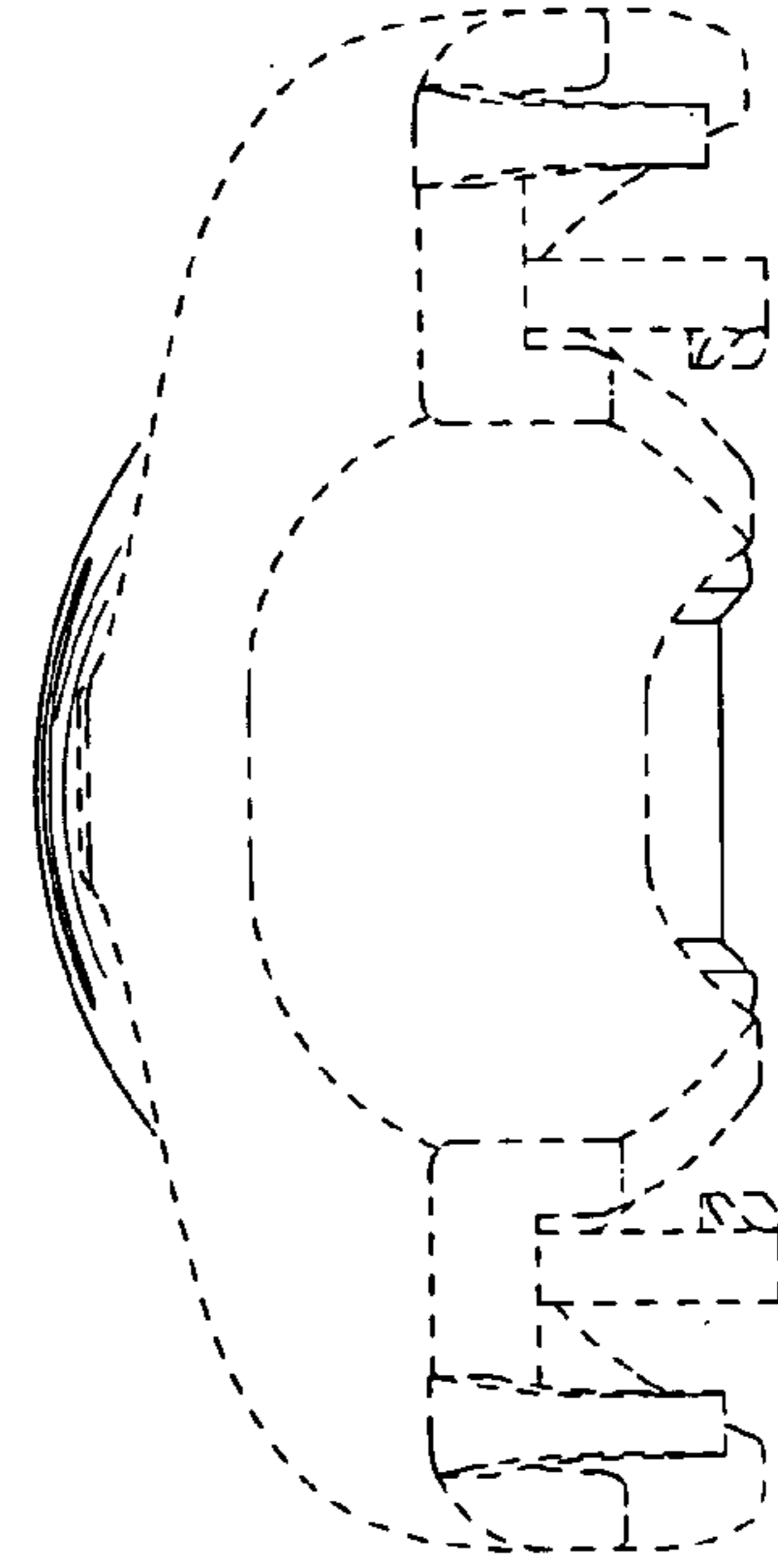
