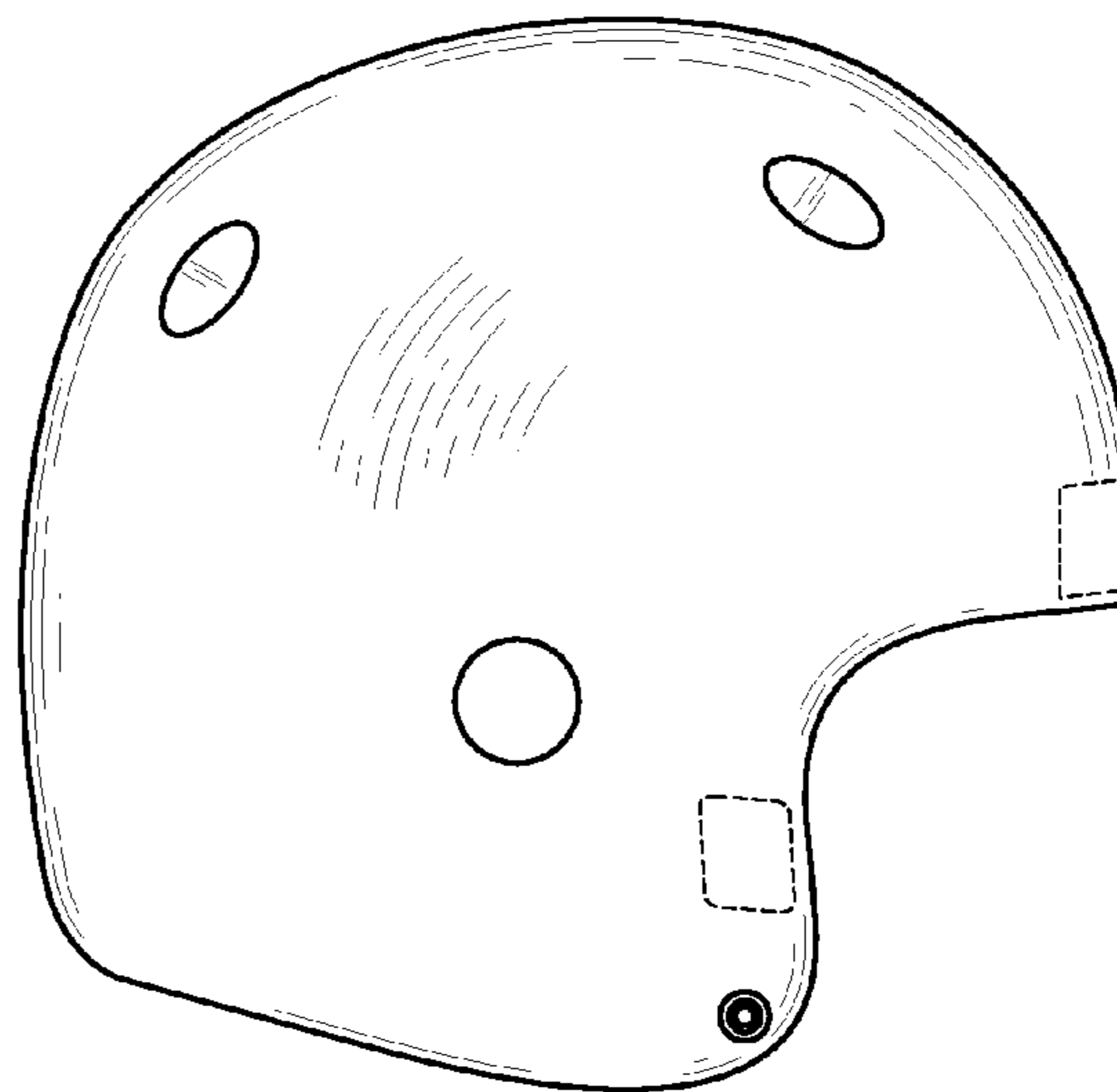
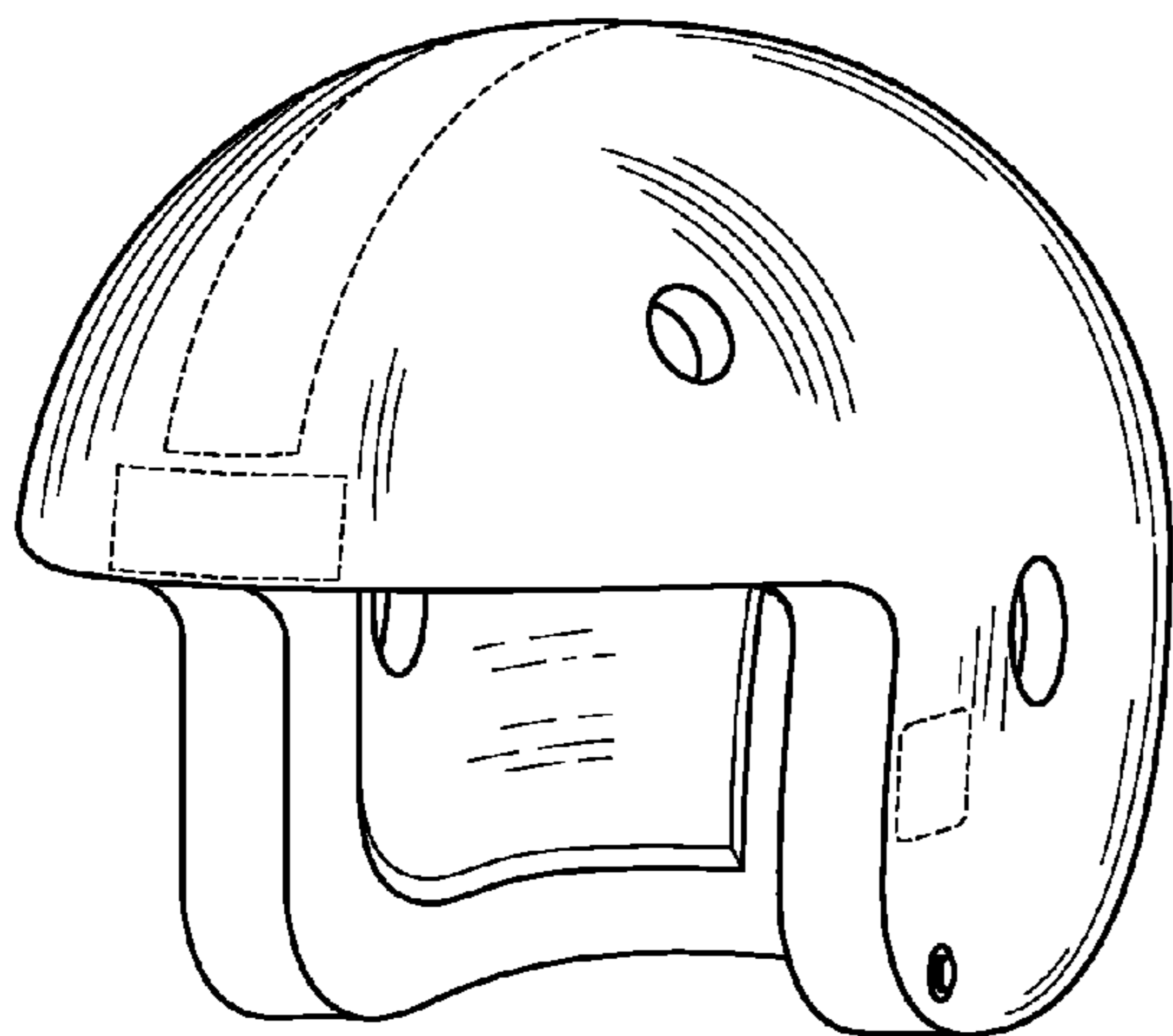

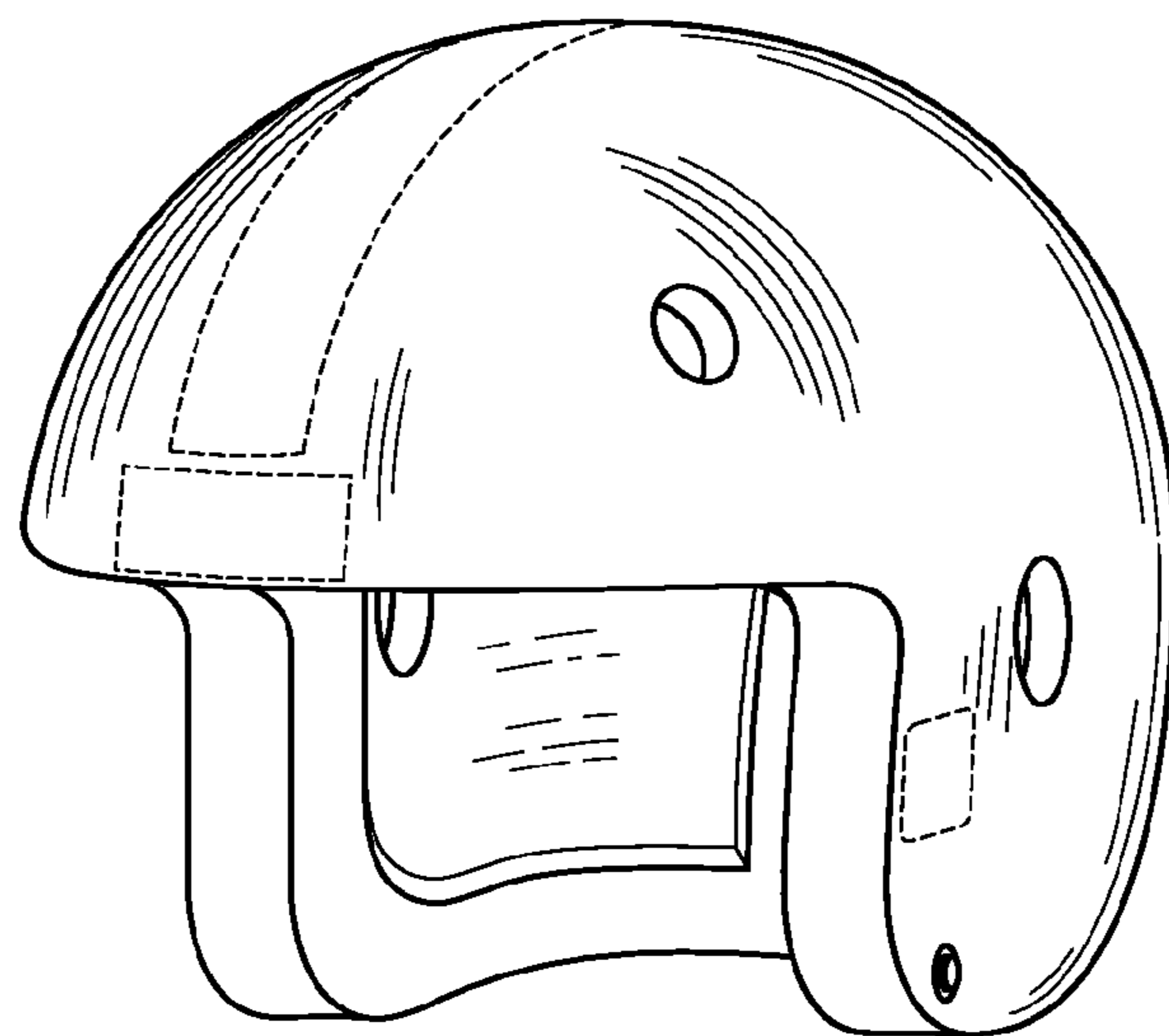
The ornamental design for a head covering, as shown and described:

**DESCRIPTION**

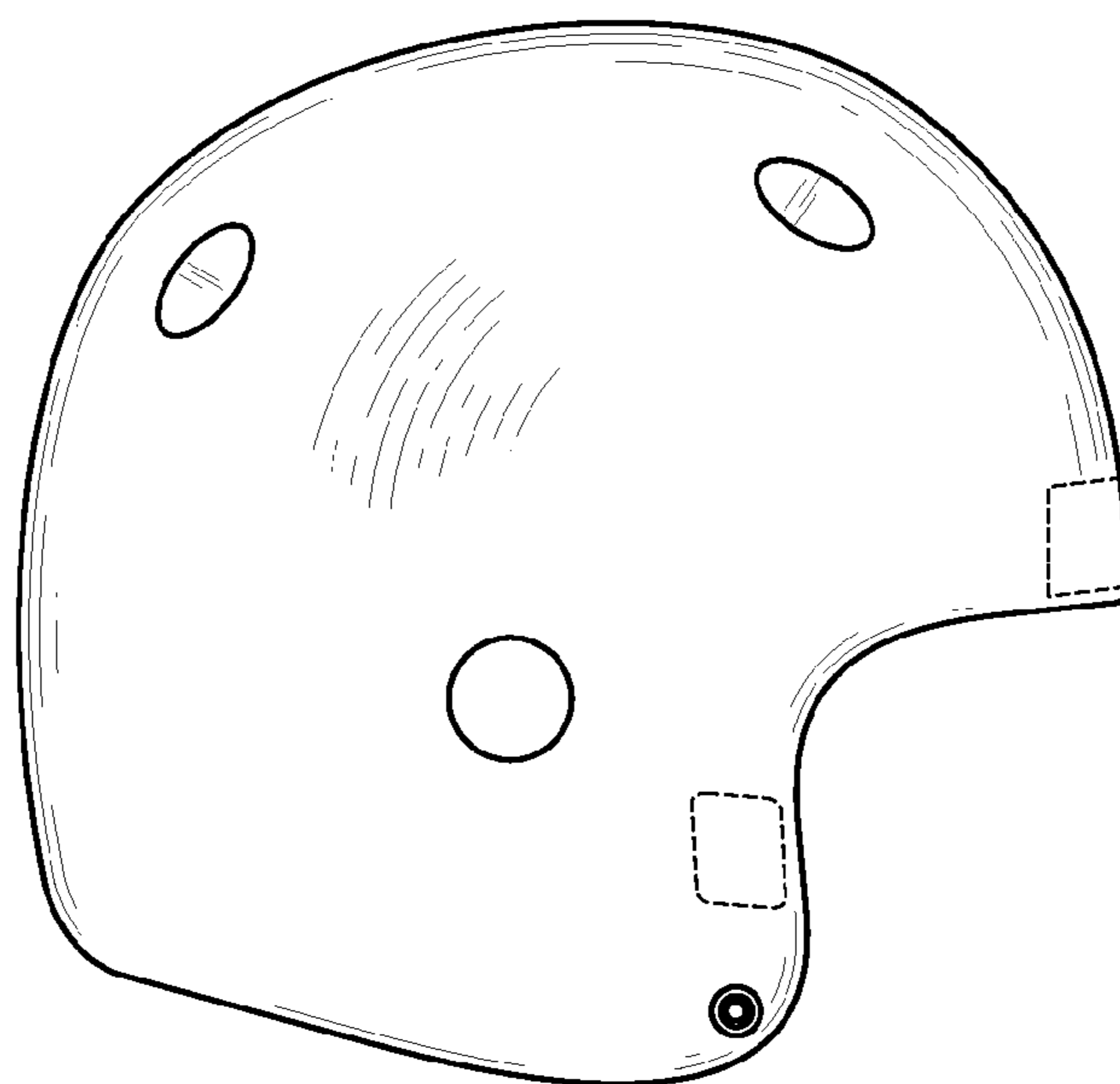
FIG. 1 is a perspective view of a head covering showing my new design;

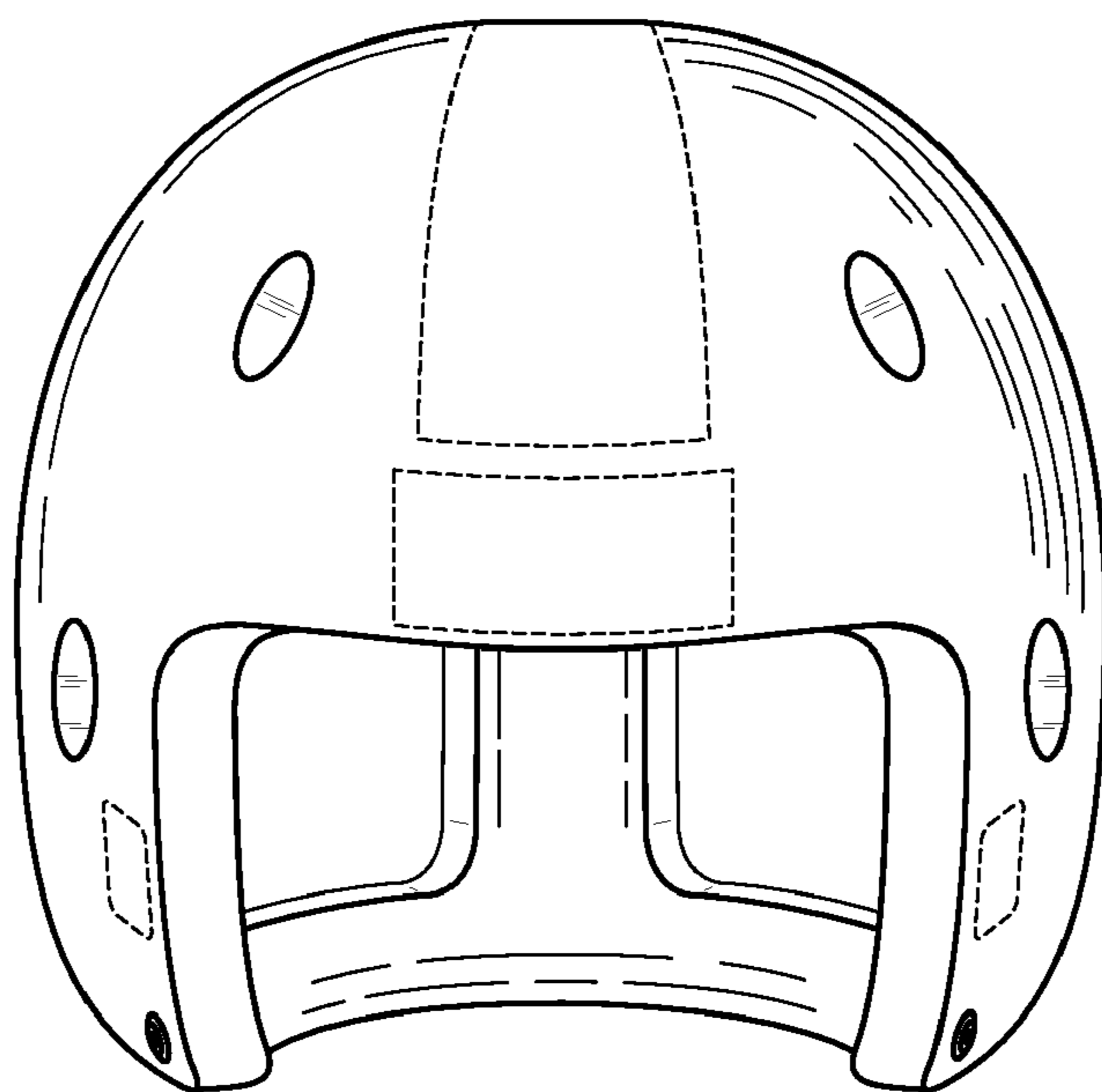




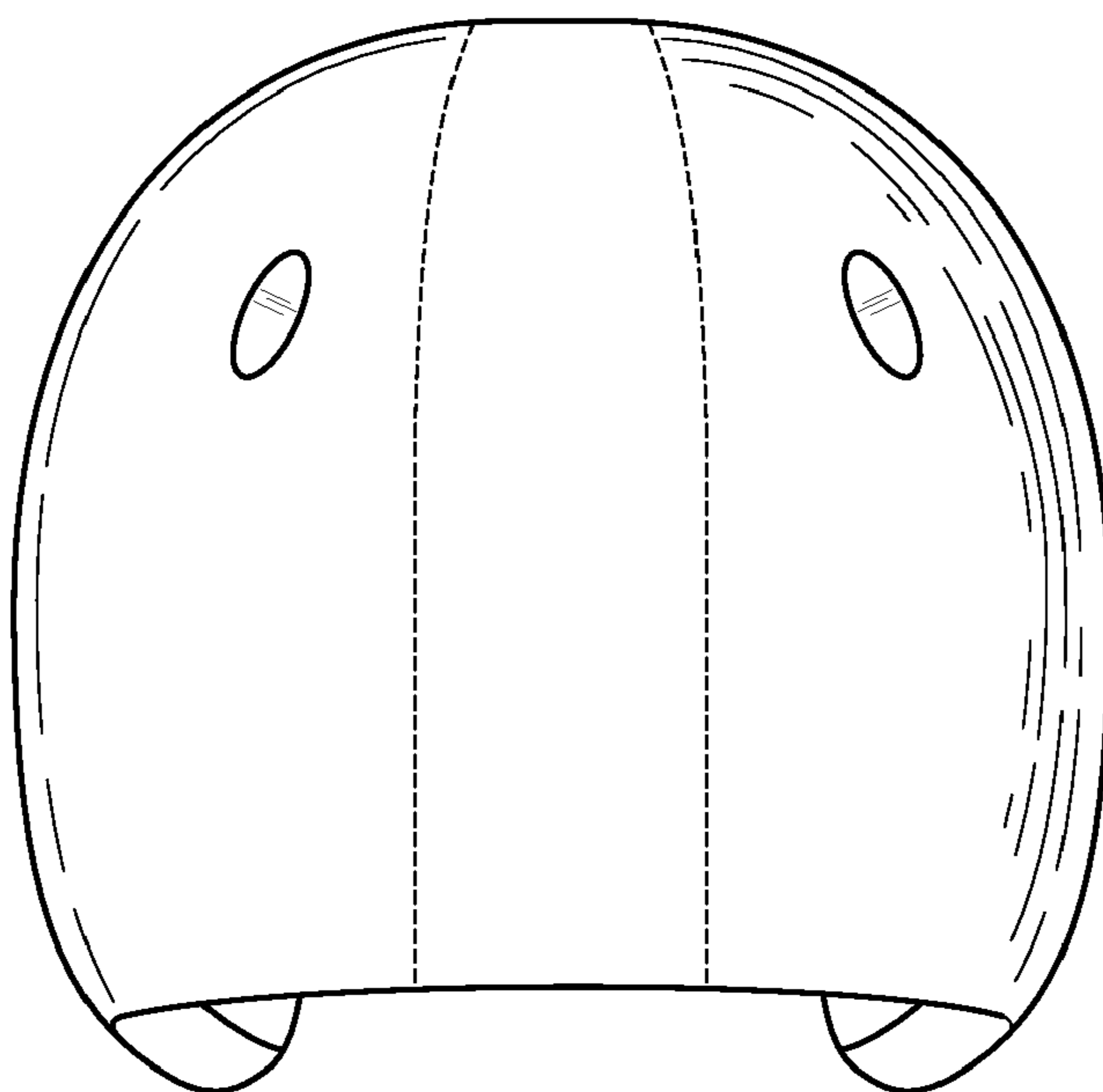

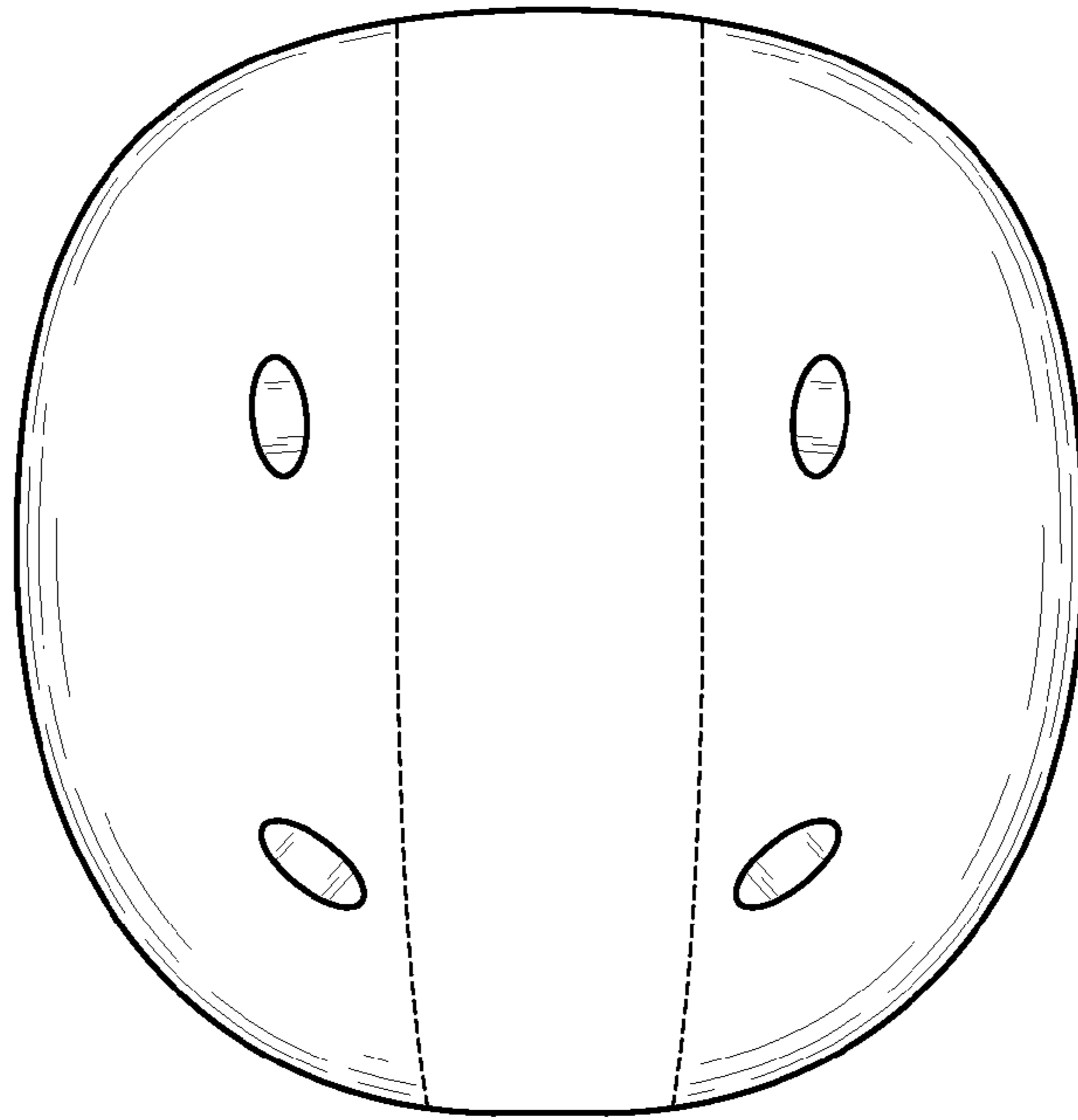

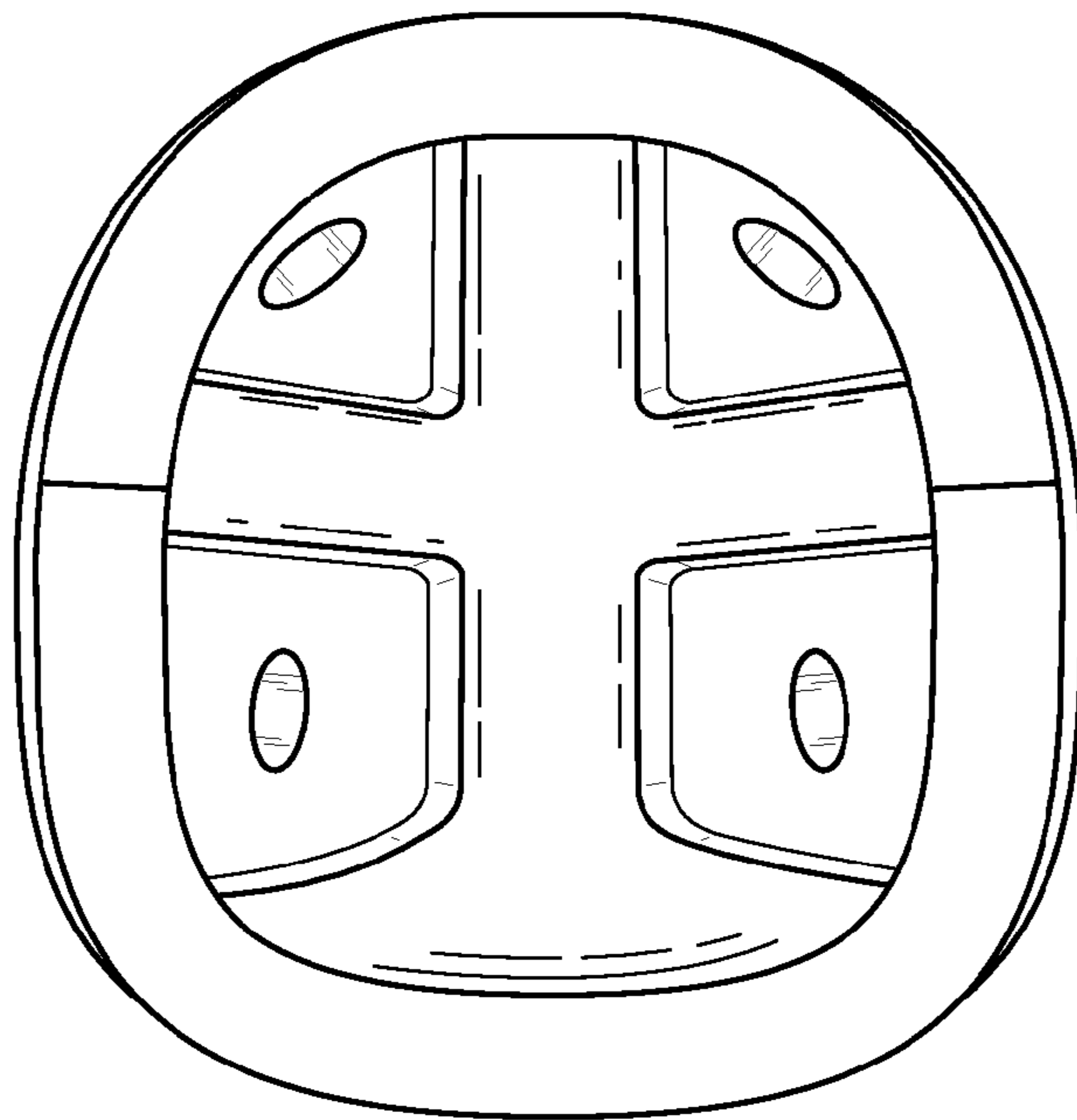
