**DESCRIPTION**

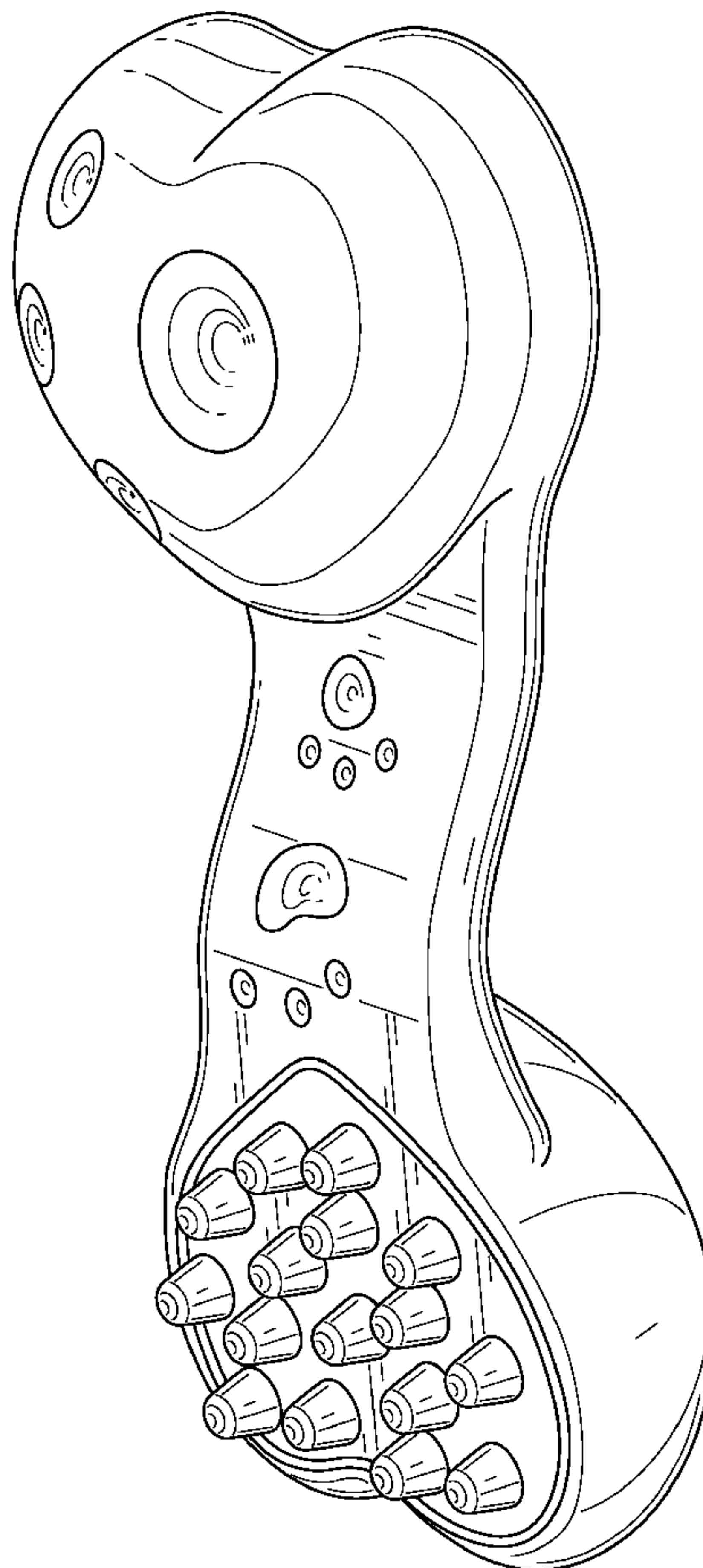
FIG. 1 is a perspective view of a first embodiment of a receiver pet chew of the present invention;

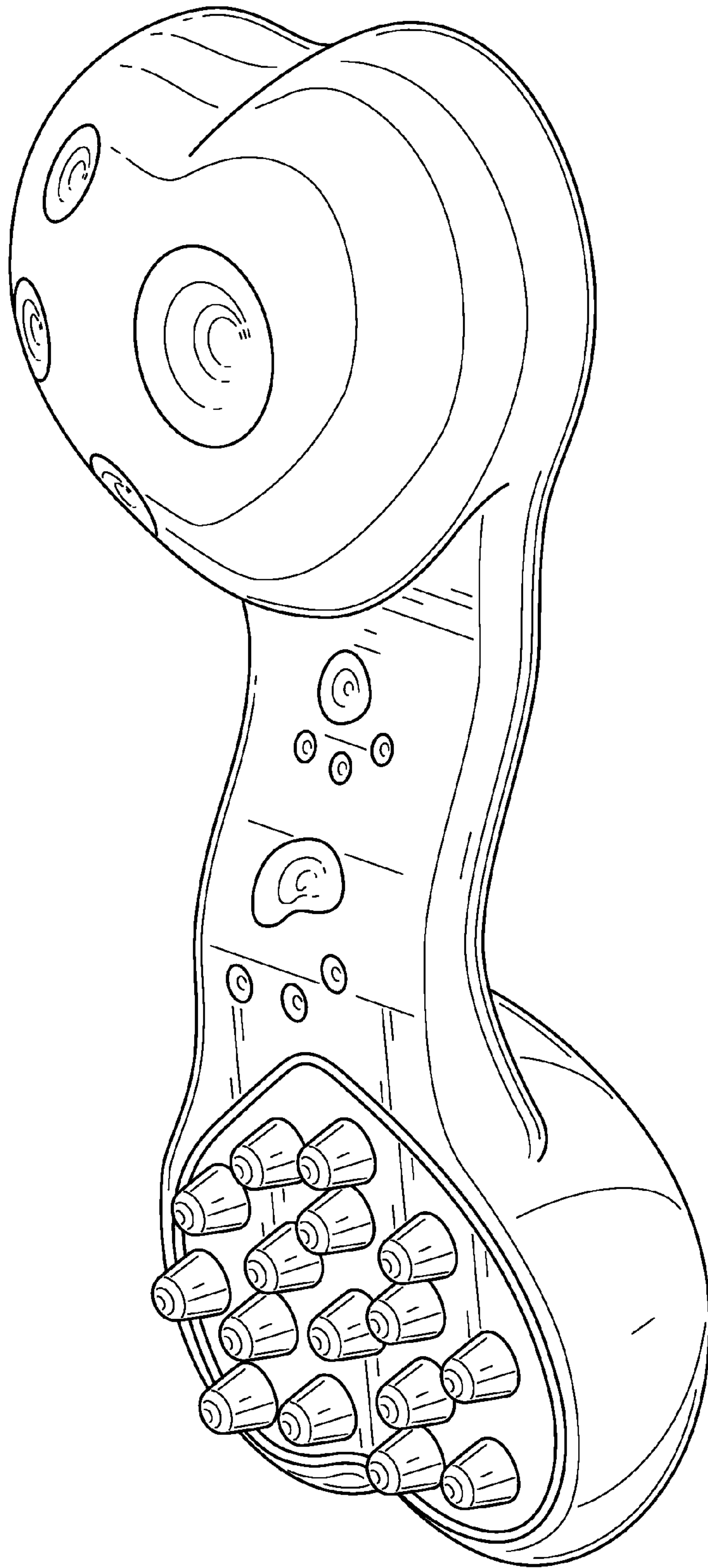

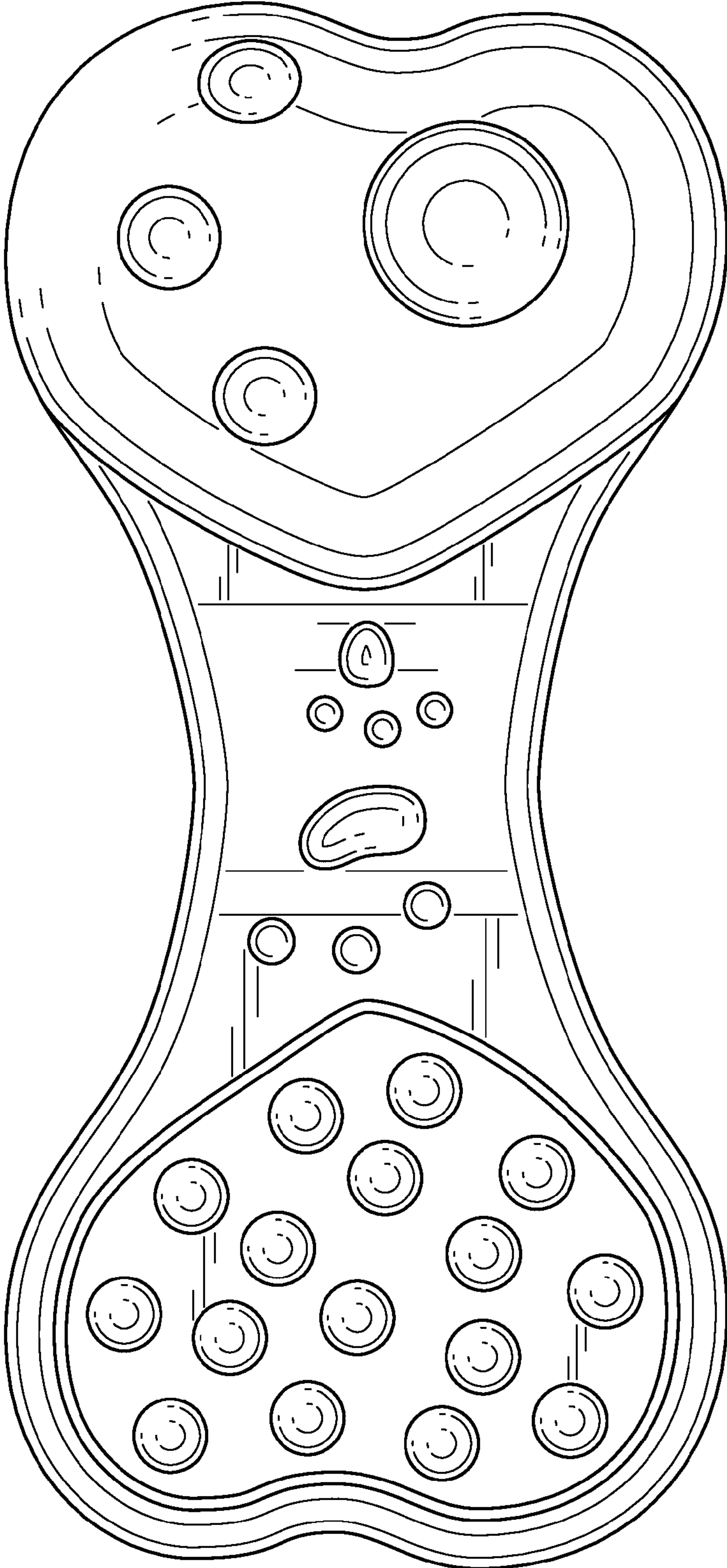

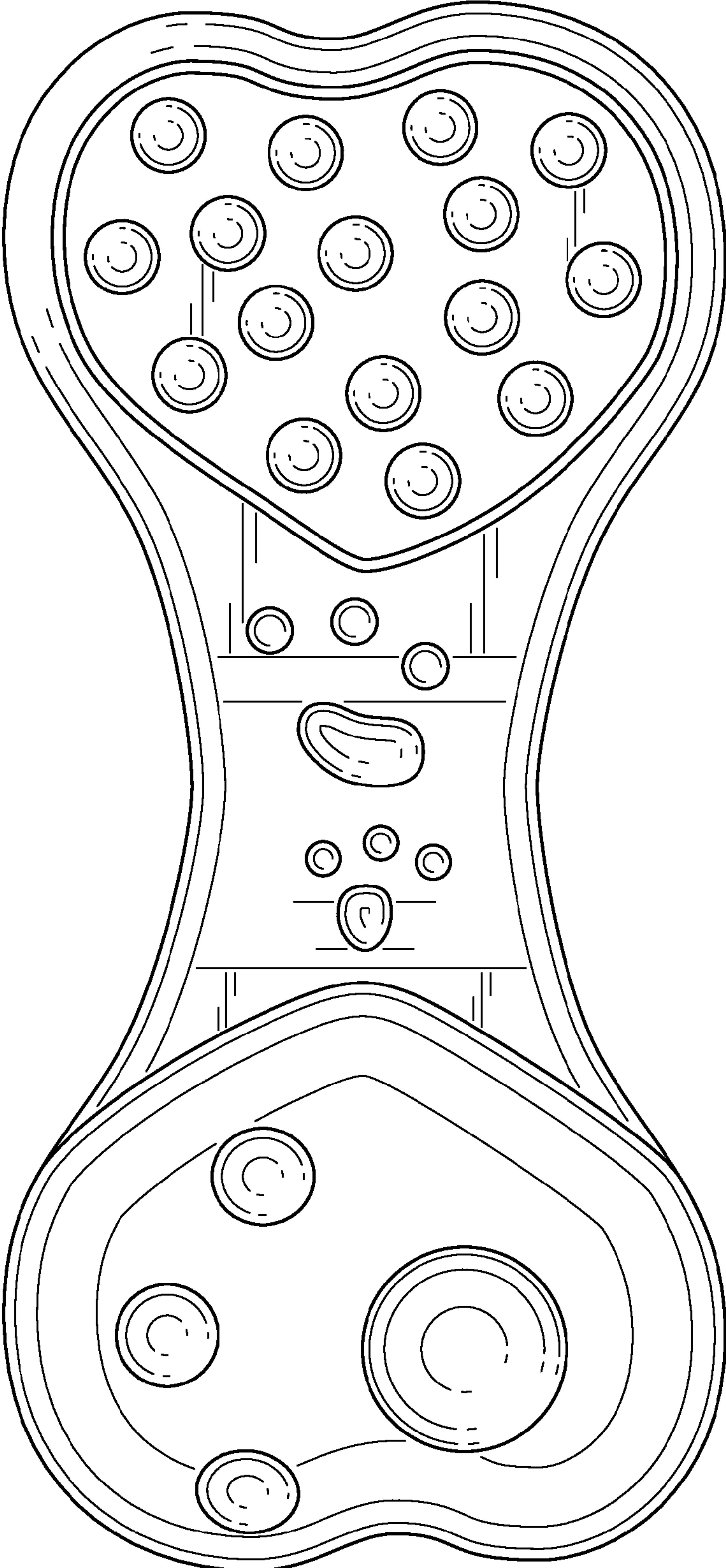

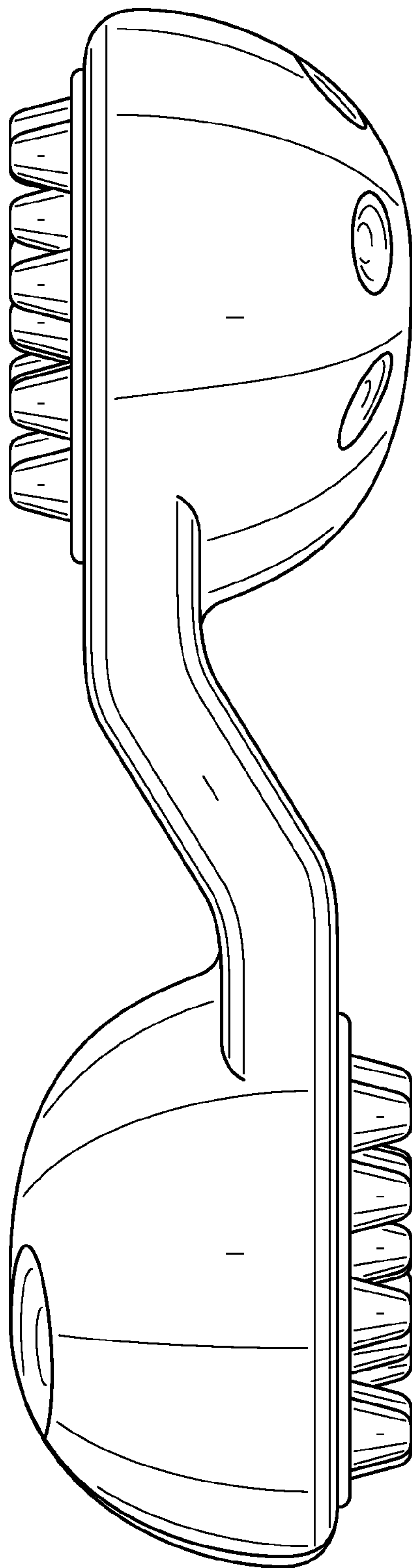

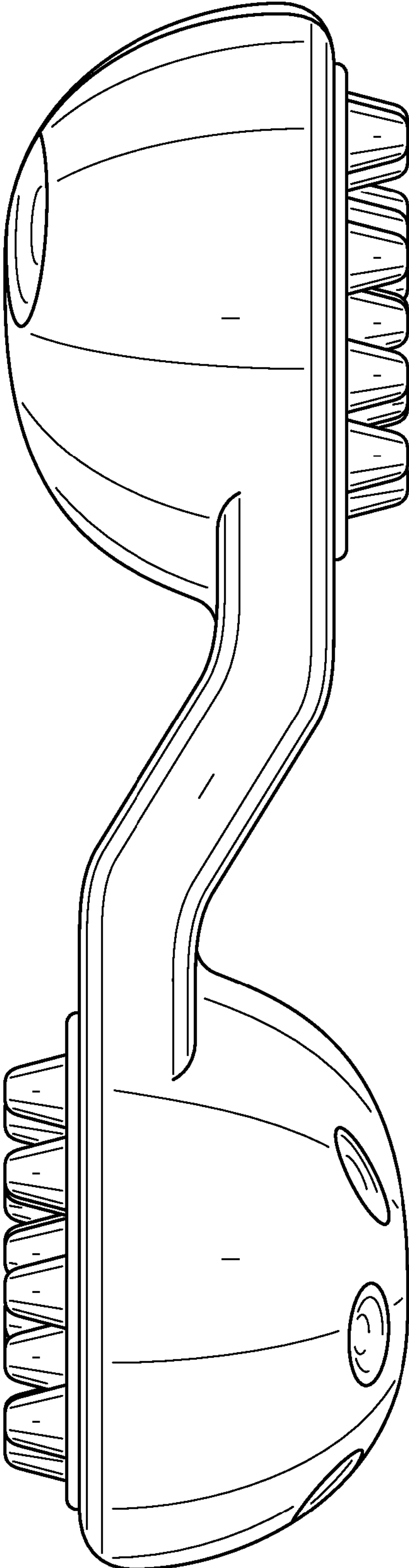

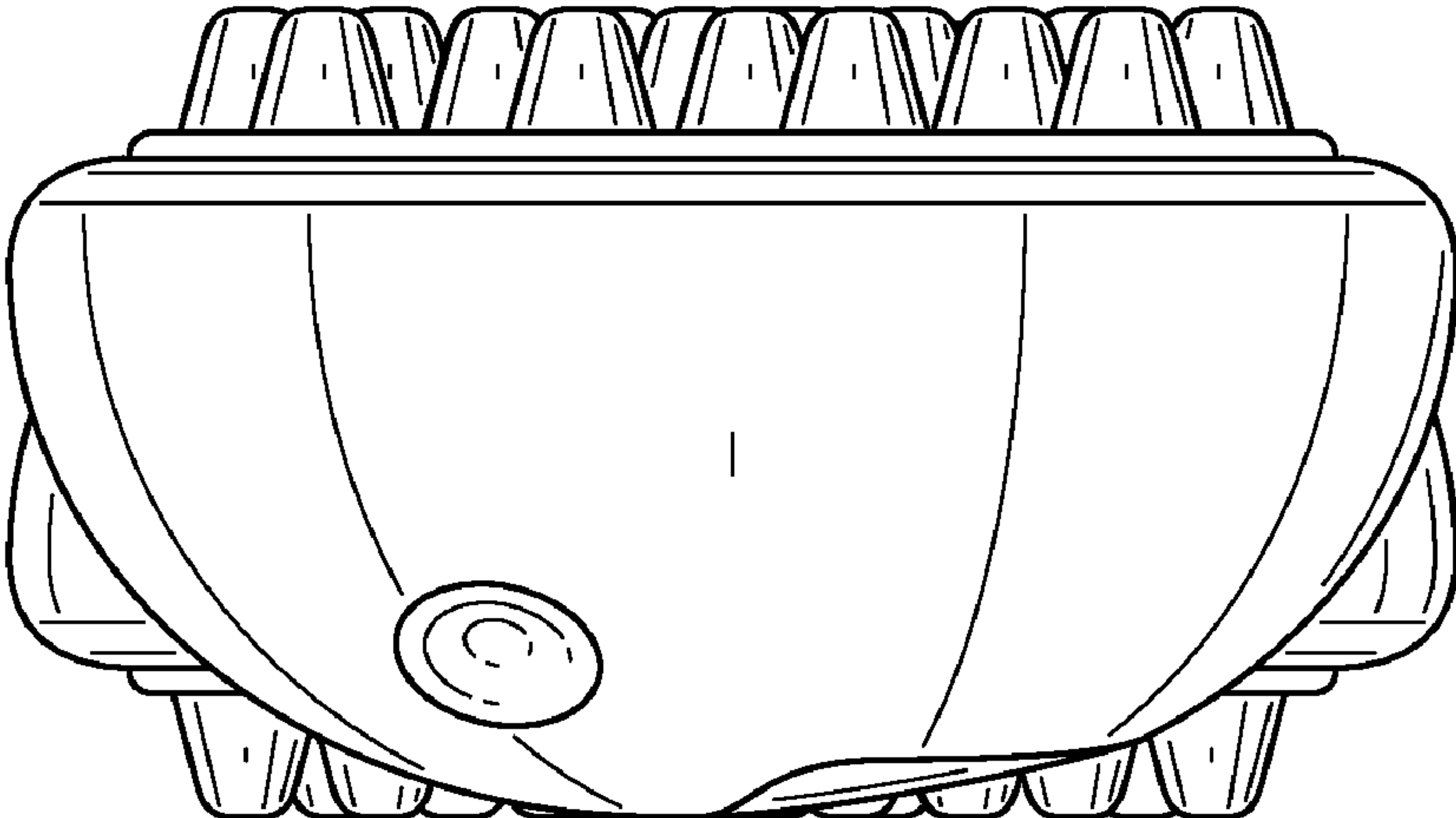

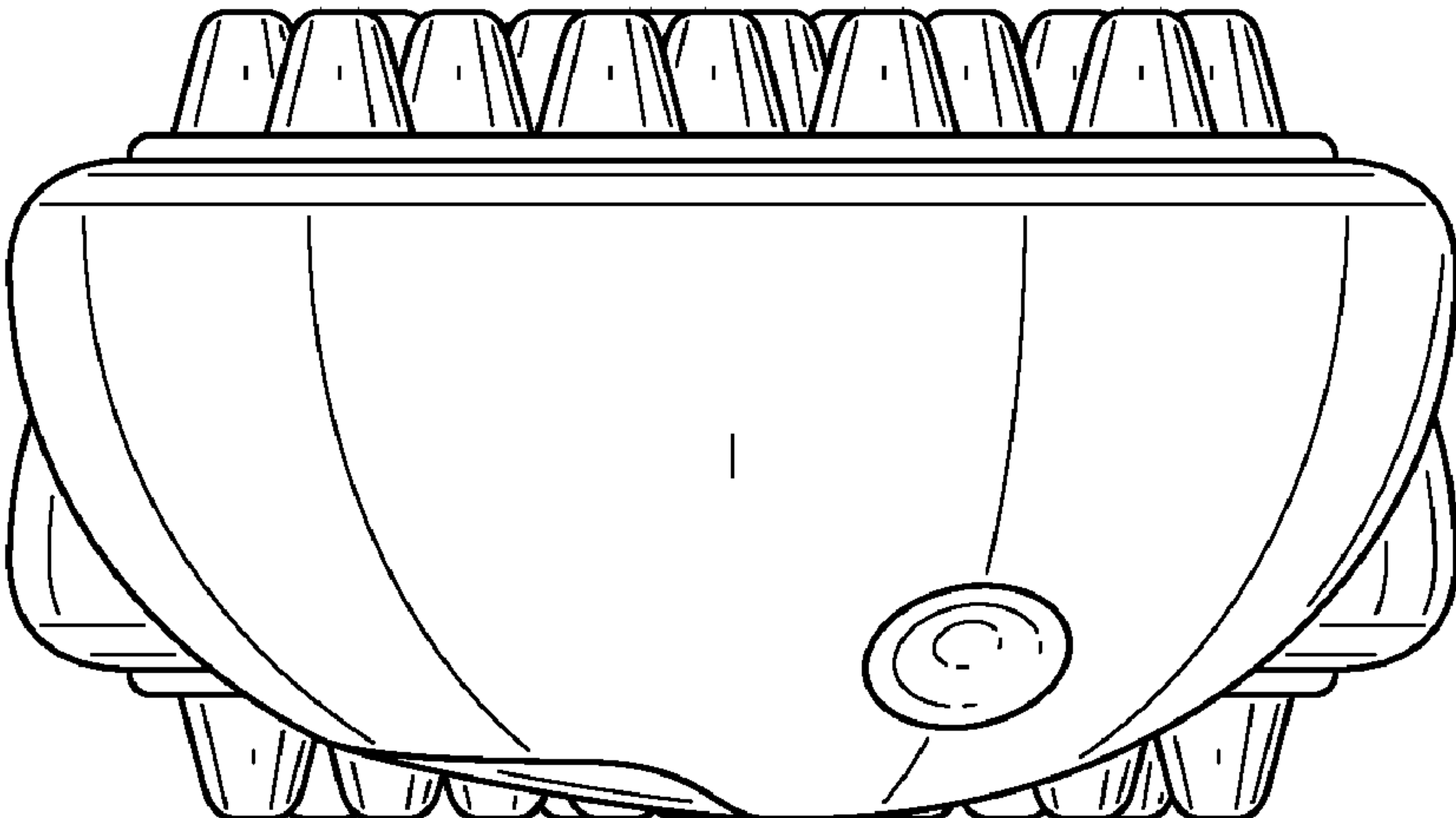
