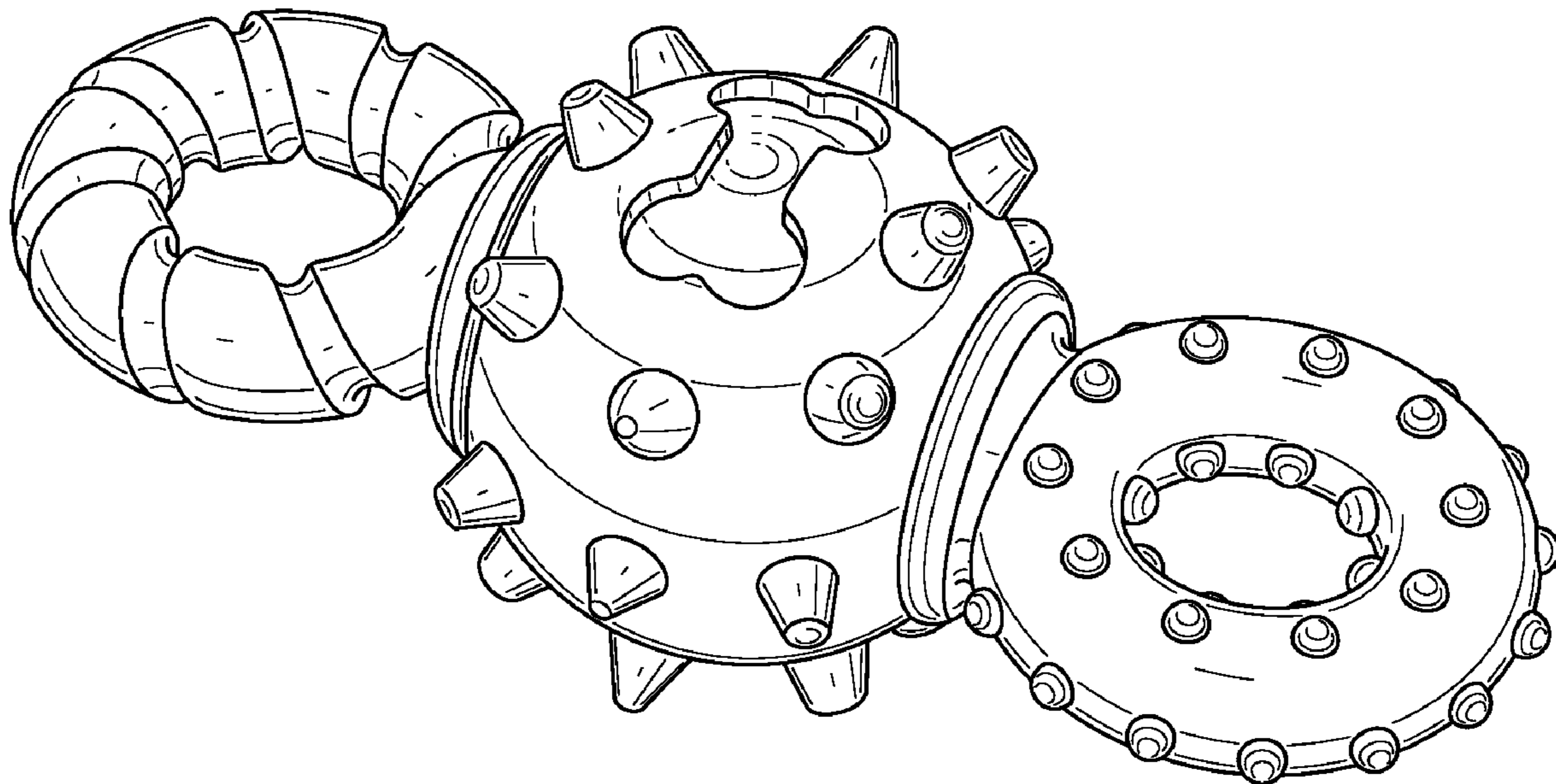
(57) **CLAIM**

The ornamental design for a teething pet chew, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a teething pet chew of the present invention; FIG. 2 is a top view of the teething pet chew of FIG. 1; FIG. 3 is a bottom view of the teething pet chew of FIG. 1; FIG. 4 is a left side view of the teething pet chew of FIG. 1; FIG. 5 is a right side view of the teething pet chew of FIG. 1; FIG. 6 is a front view of the teething pet chew of FIG. 1; and, FIG. 7 is a back view of the teething pet chew of FIG. 1.

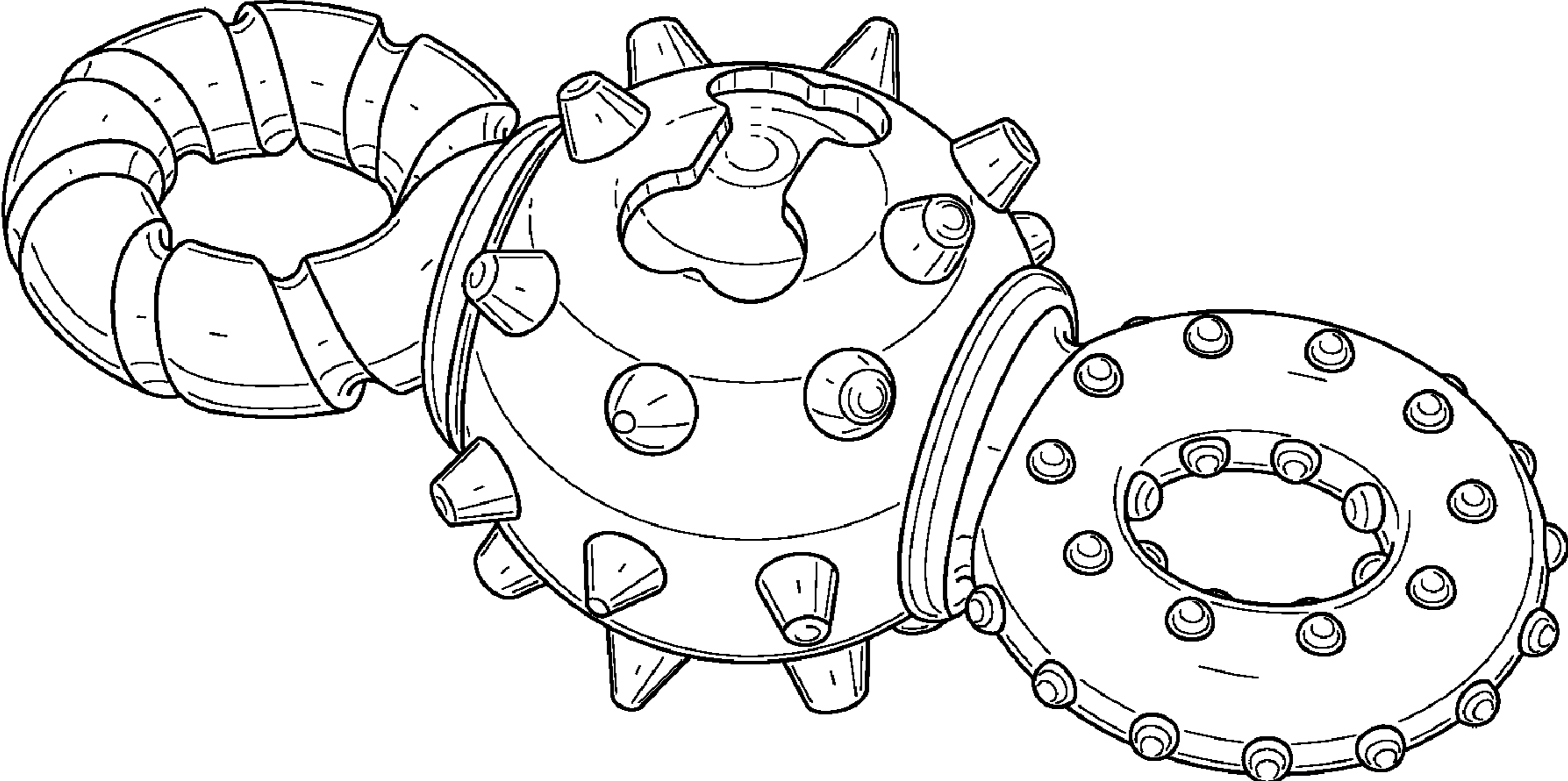

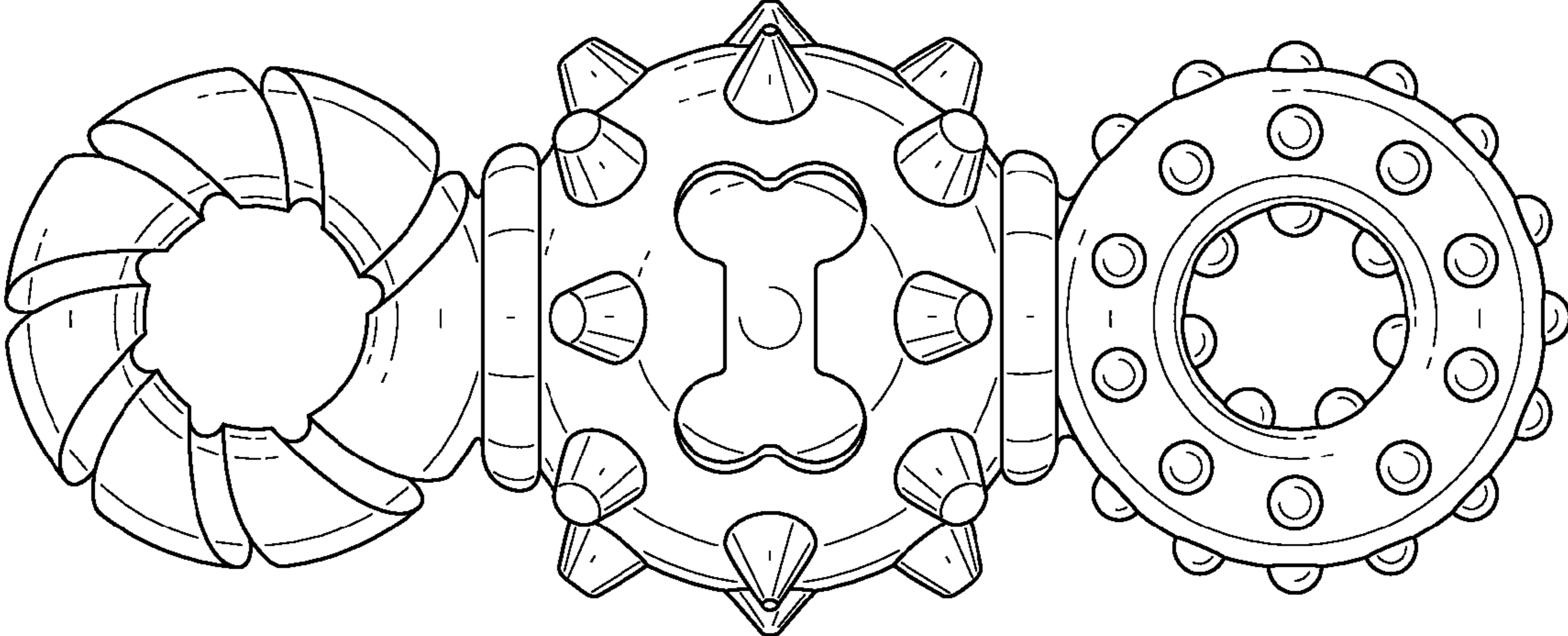

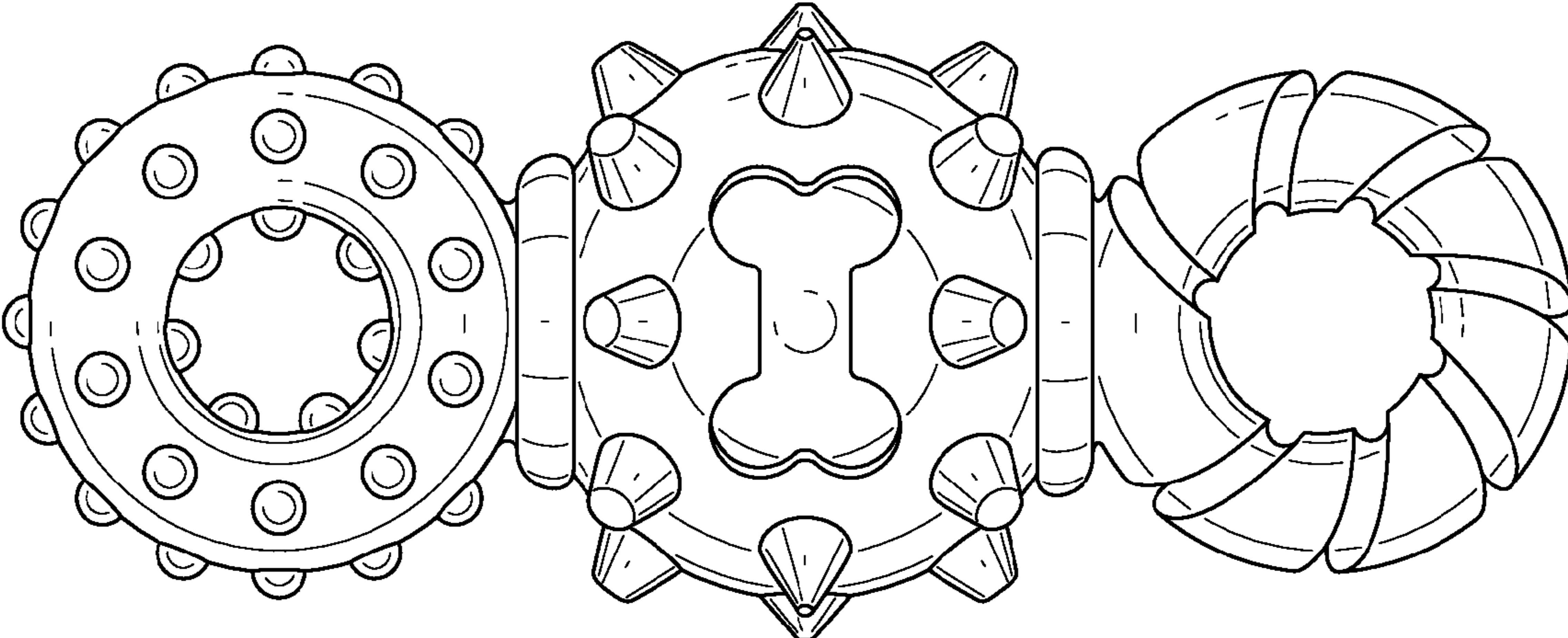

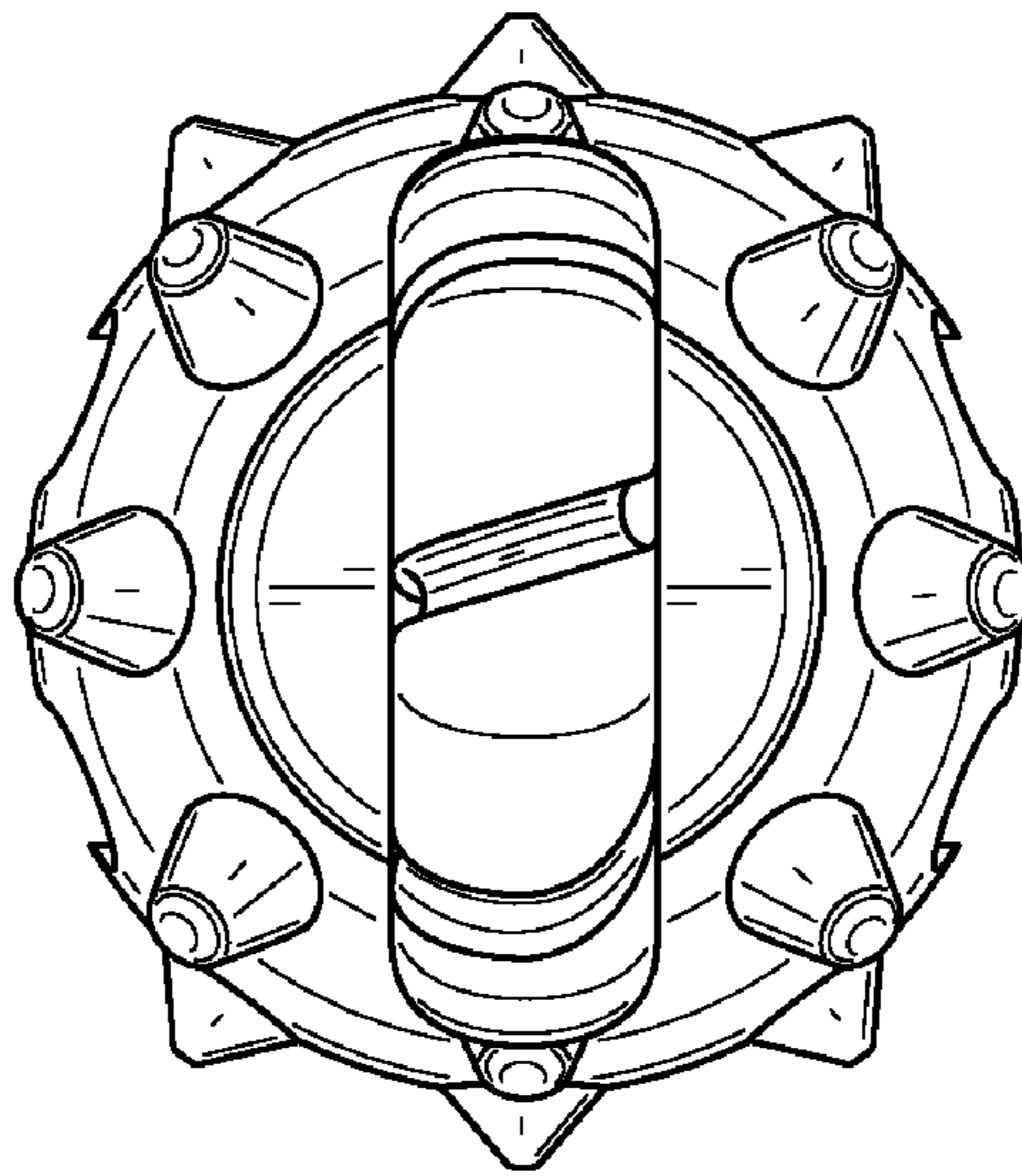

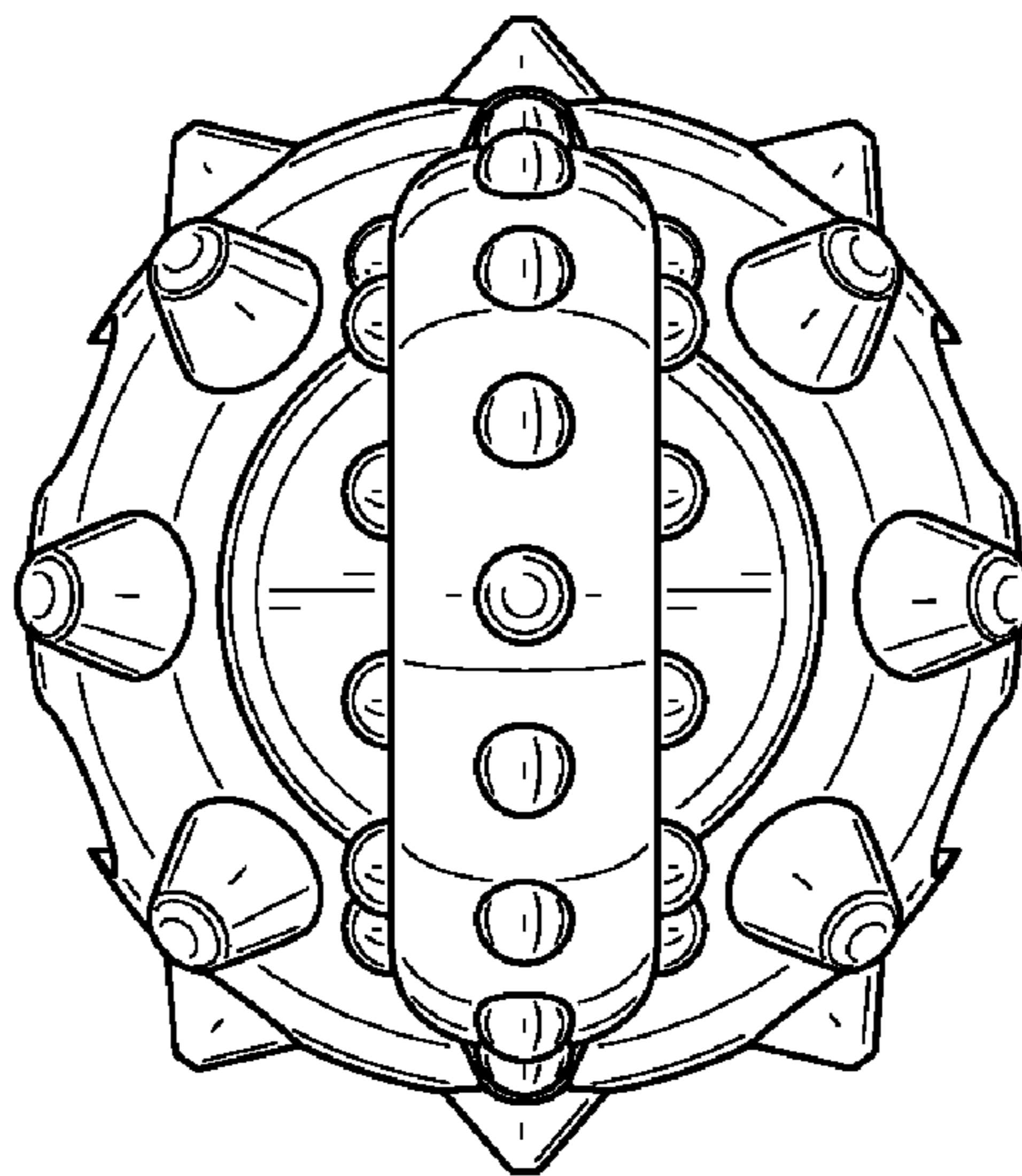

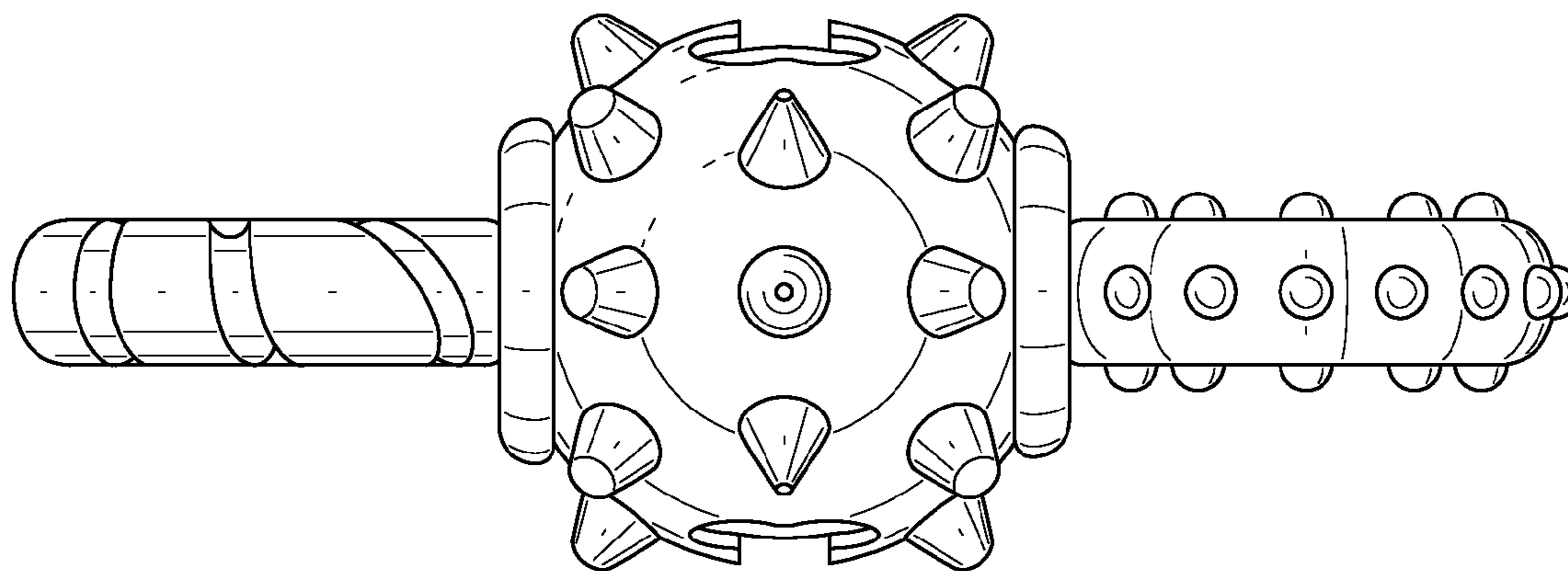

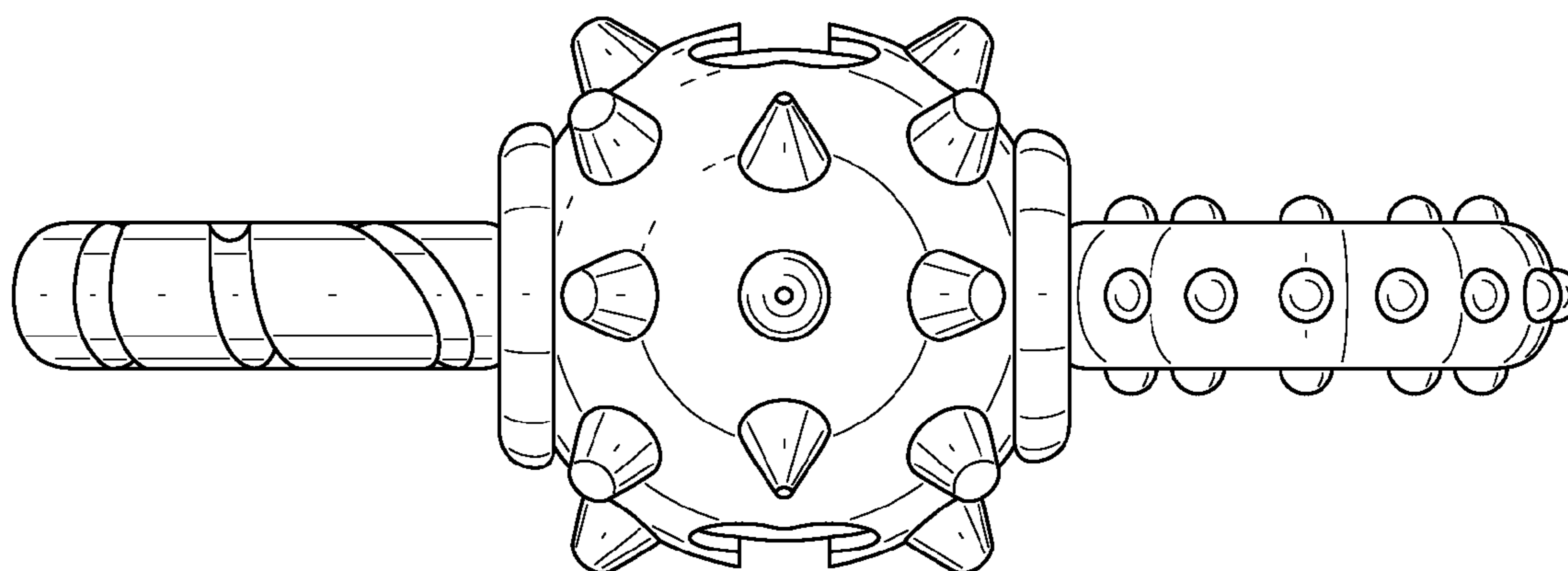
