FIG. 1 shows a side view of a spectacle case in an unfolded configuration;

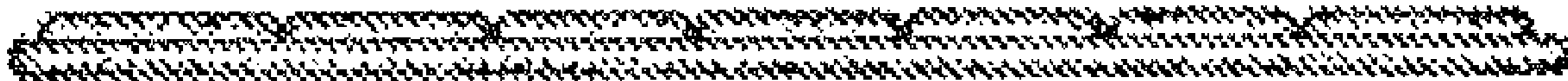
FIG. 2 shows another side view of the spectacle case of FIG. 1;

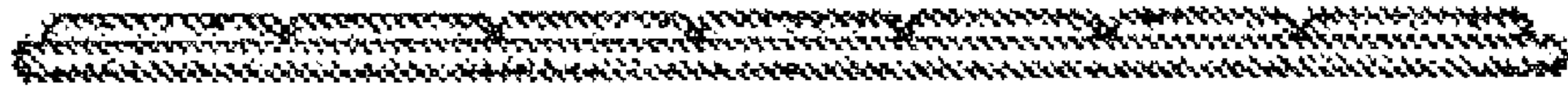

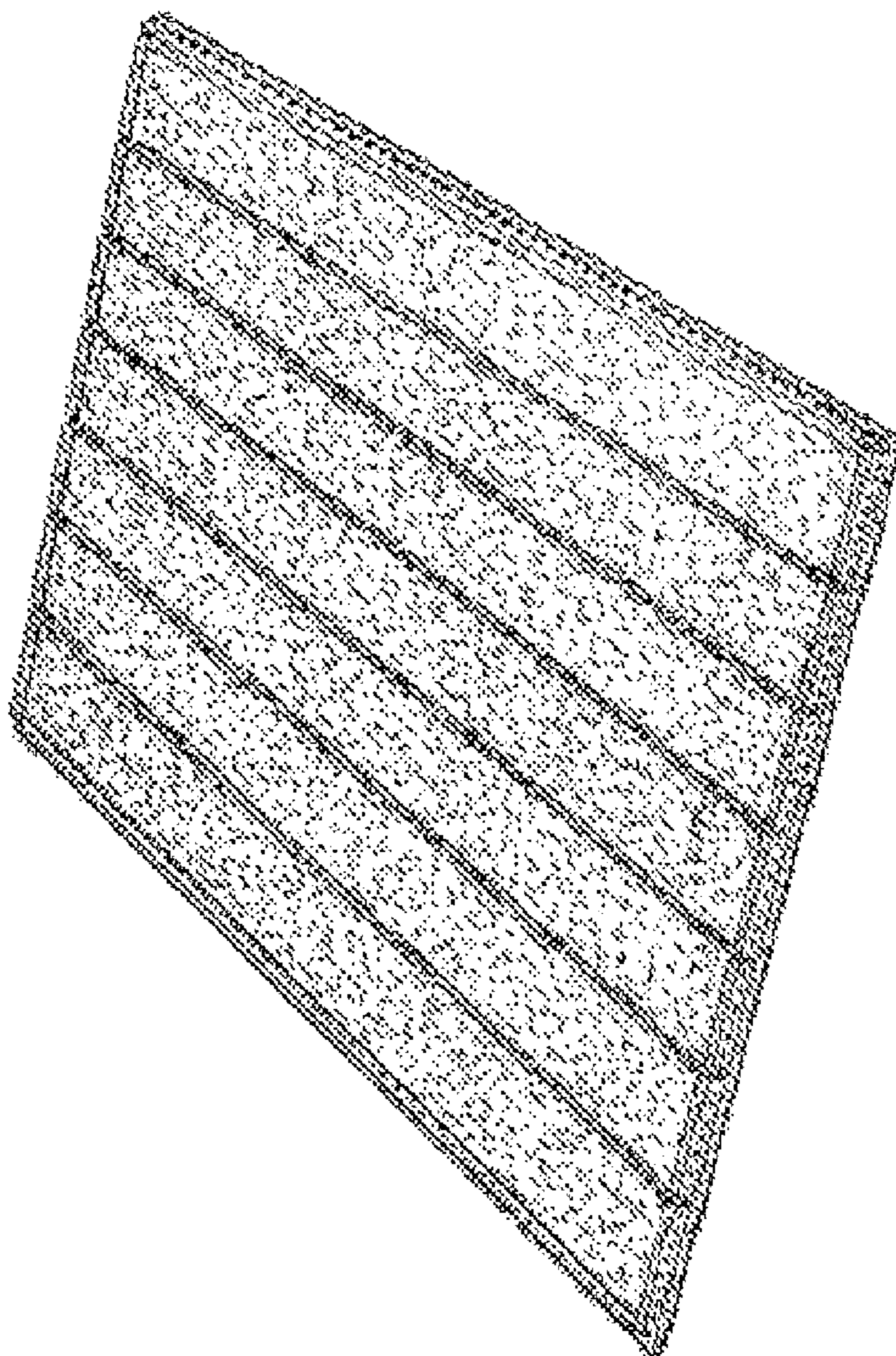

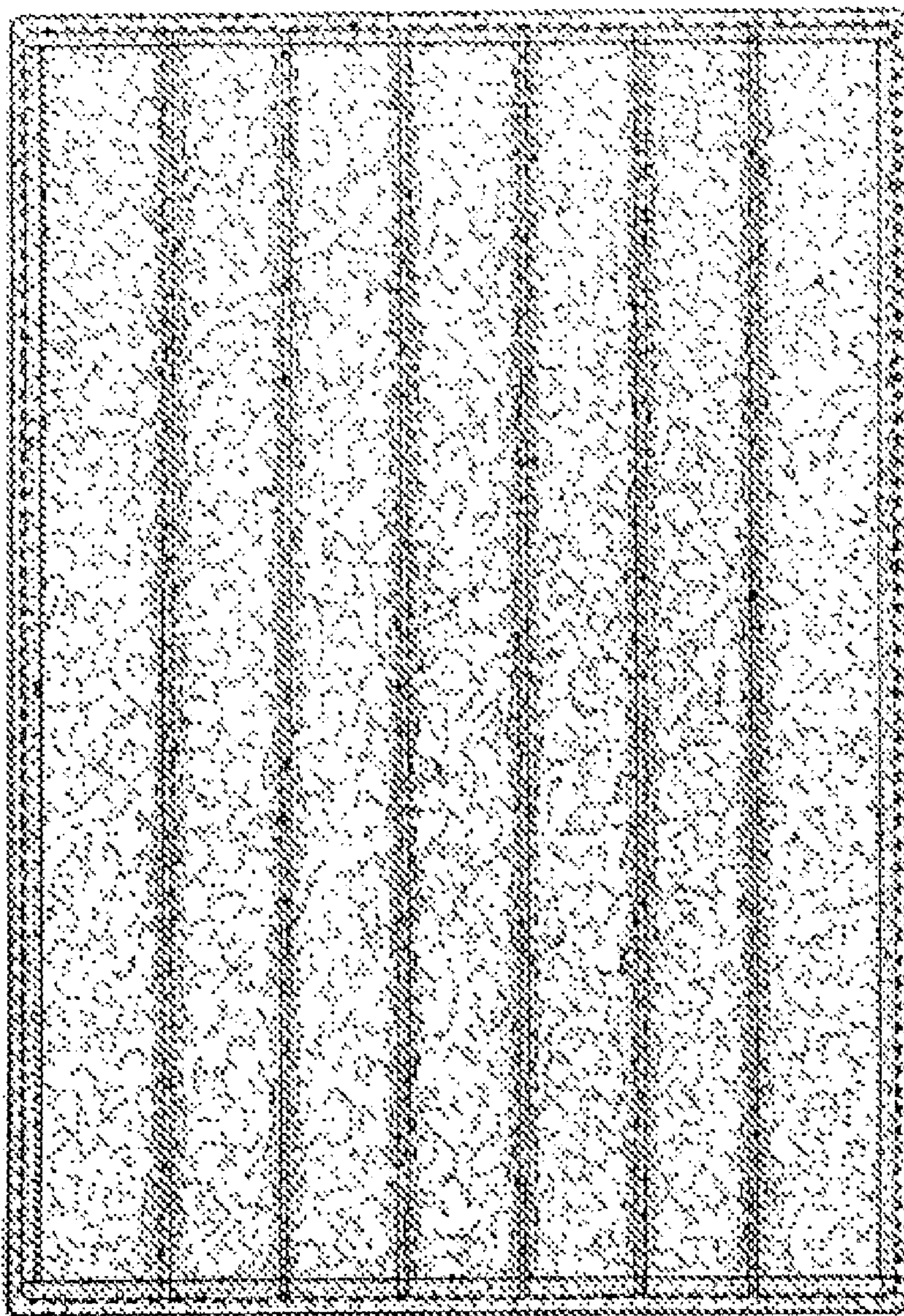

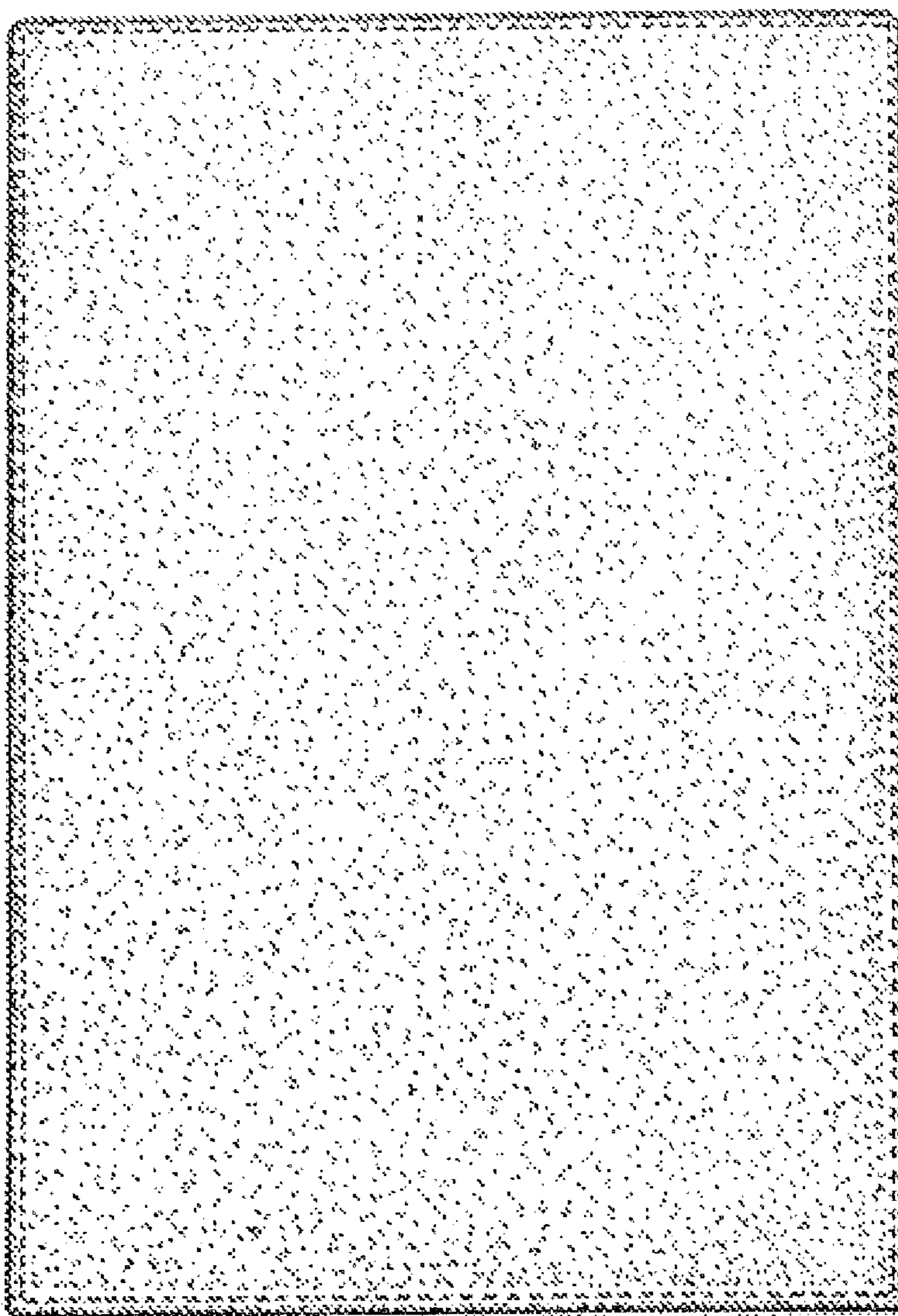
