The ornamental design for an electric tooth brush, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of an electric tooth brush showing my new design;

FIG. 2 is a right side elevation view thereof;

FIG. 3 is a front elevation view thereof;

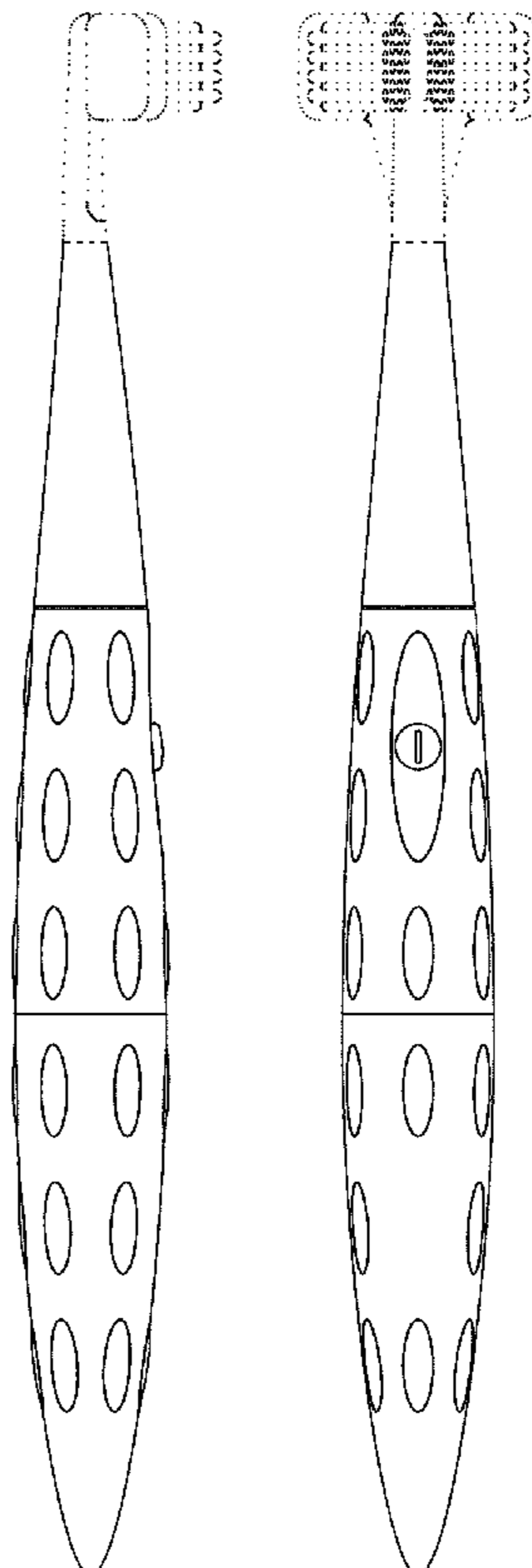
FIG. 4 is a left side elevation view thereof;

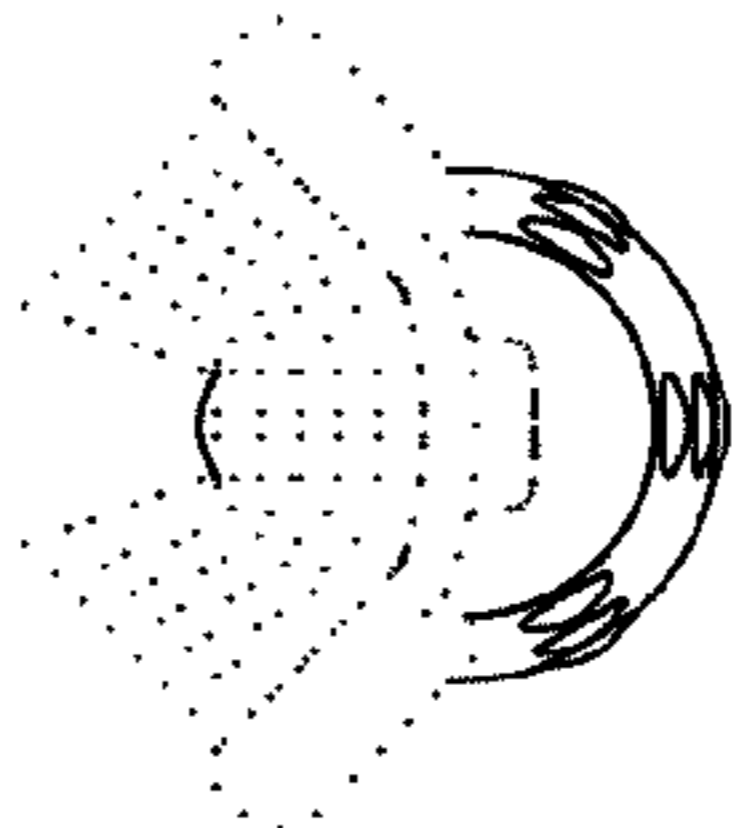

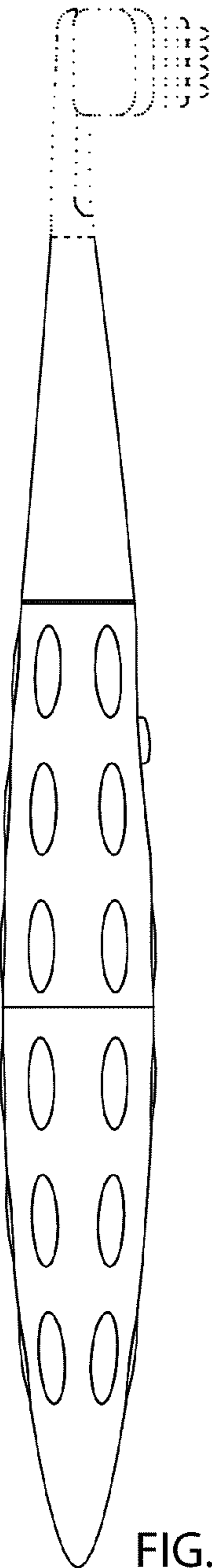

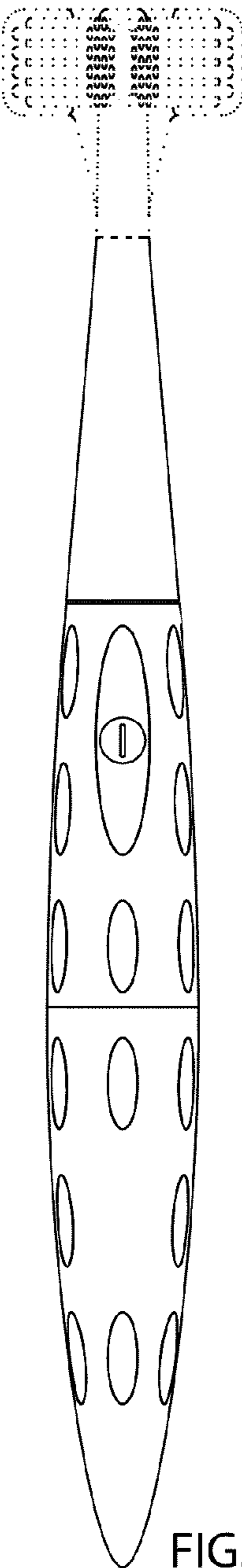

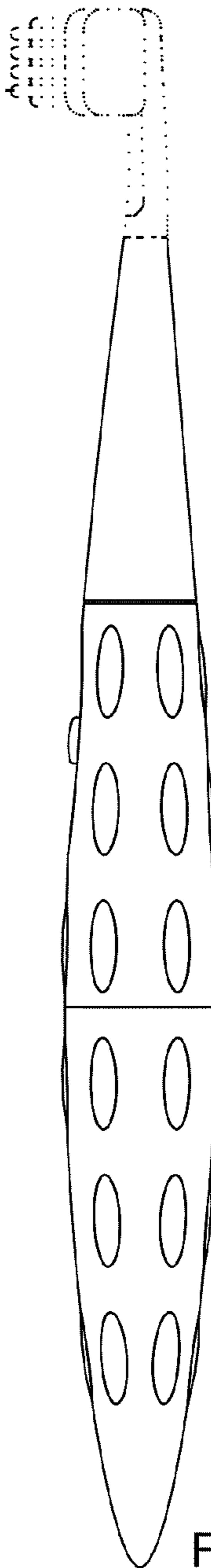

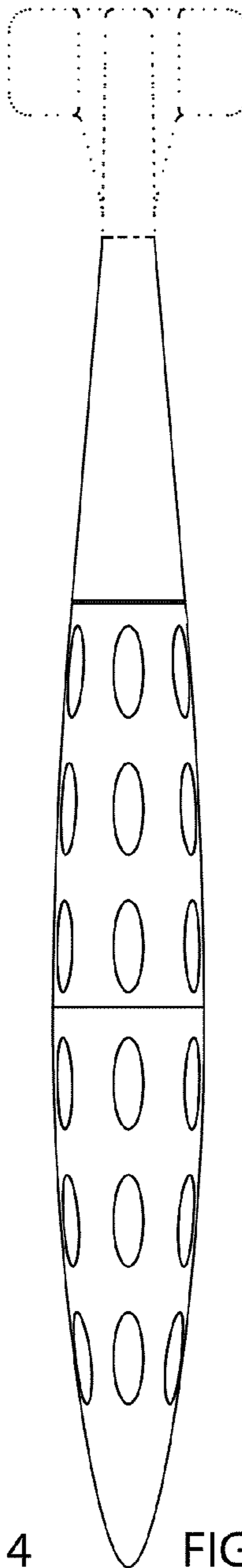

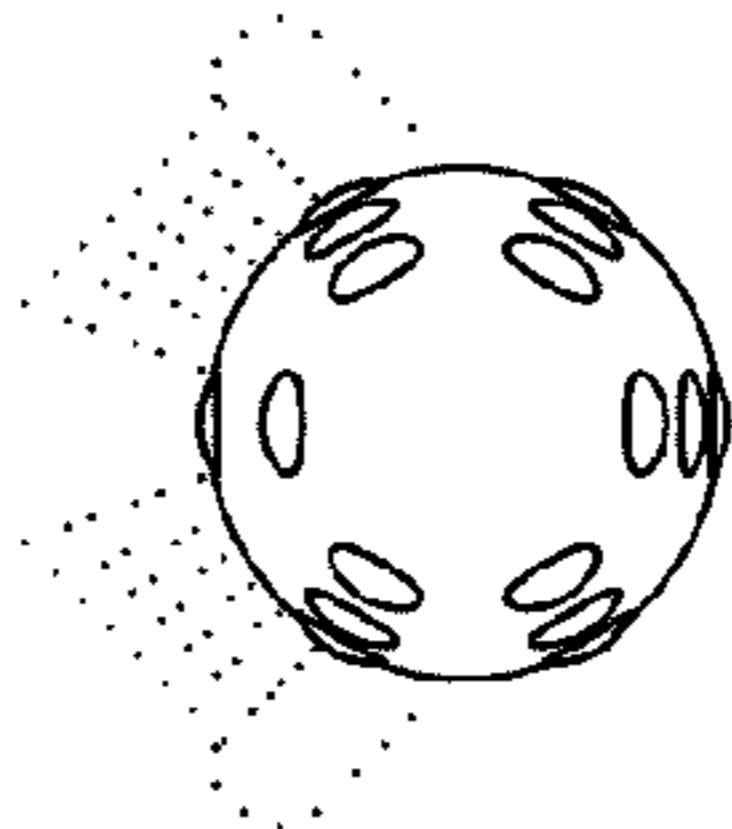
