(57) **CLAIM**

We claim the ornamental design for a console table, as shown and described.

**DESCRIPTION**

FIG. 1 is a front corner perspective view of a console table of the invention. The view from the adjacent front corner being a mirror image thereof.

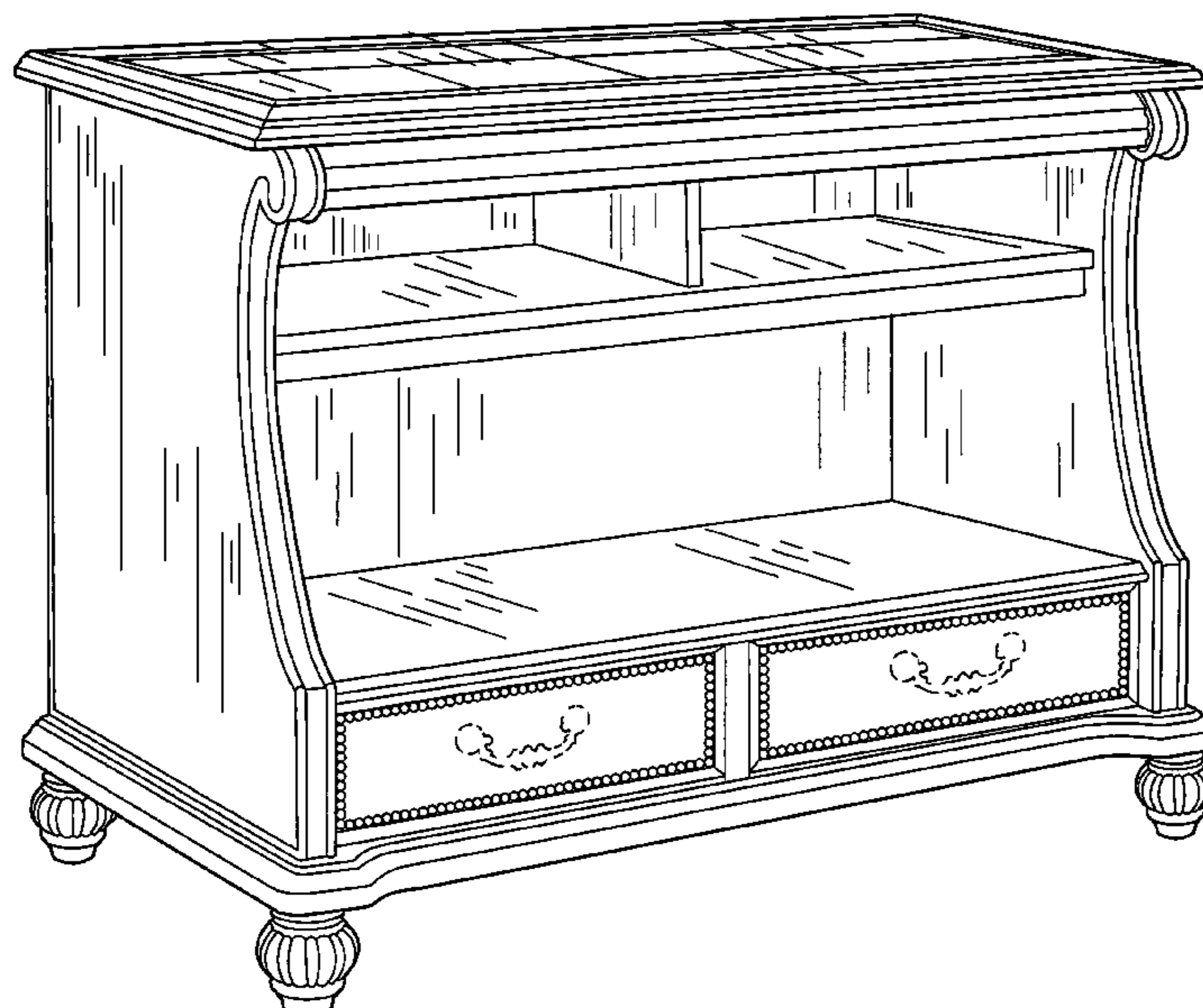
FIG. 2 is a front elevational view of a console table of the invention.

FIG. 3 is a side elevational view of a console table of the invention. The view from the opposite side being a mirror image thereof; and,

FIG. 4 is a top plan view of a console table of the invention. The backside of the console table is not shown and forms no part of the claimed invention.

The portions of the figures shown in dashed lines are for illustrative purposes only and form no part of the claimed invention.

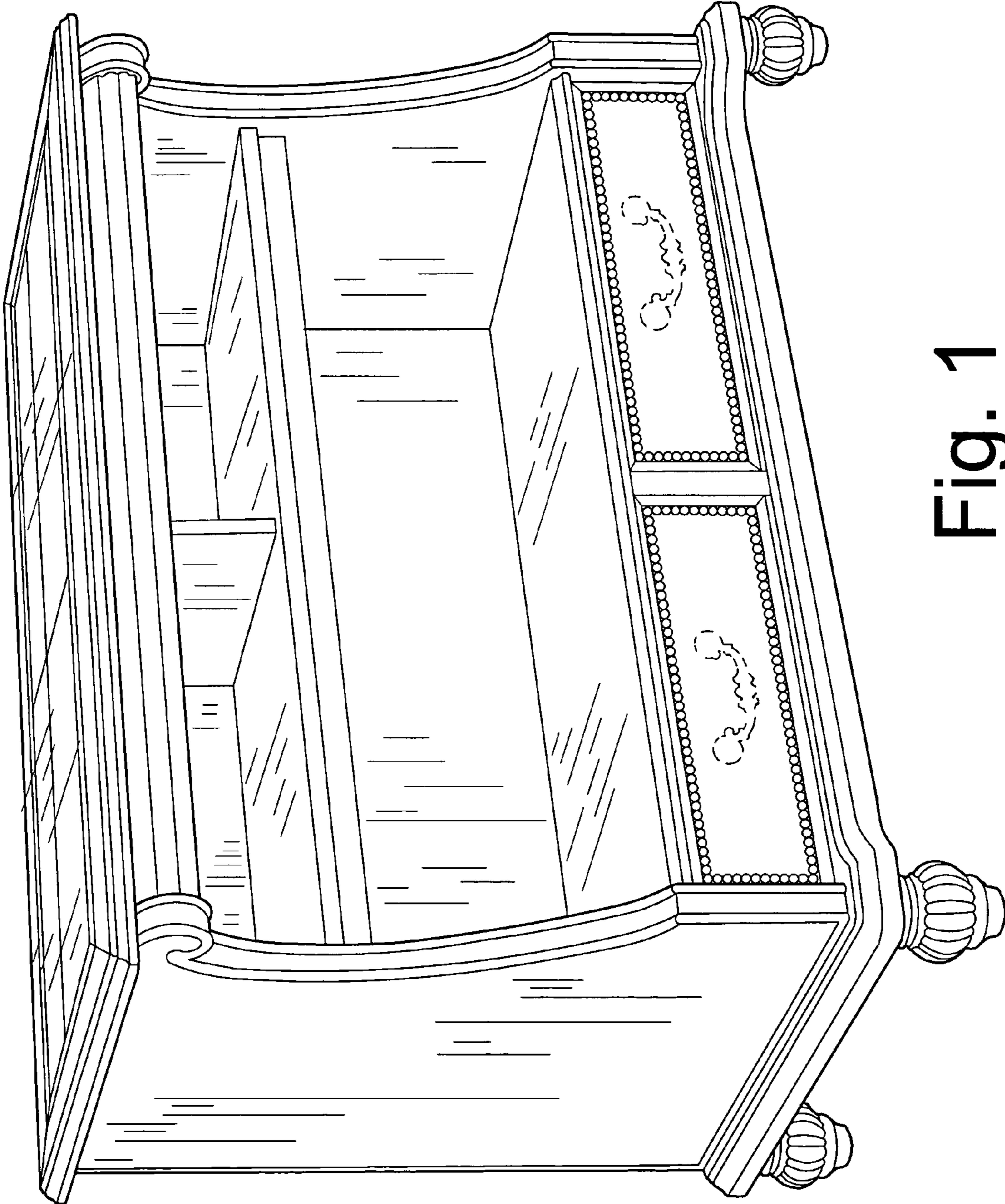

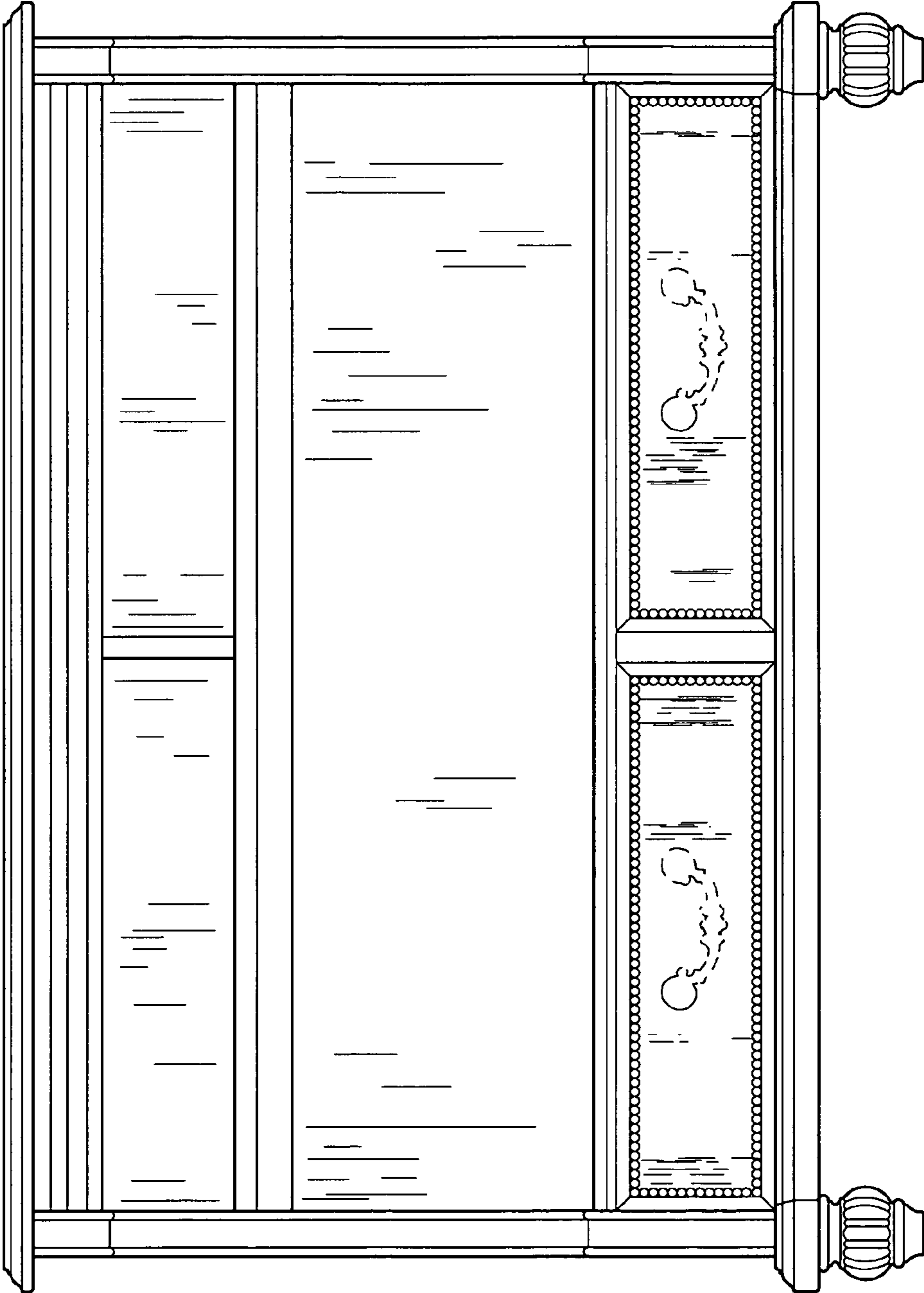

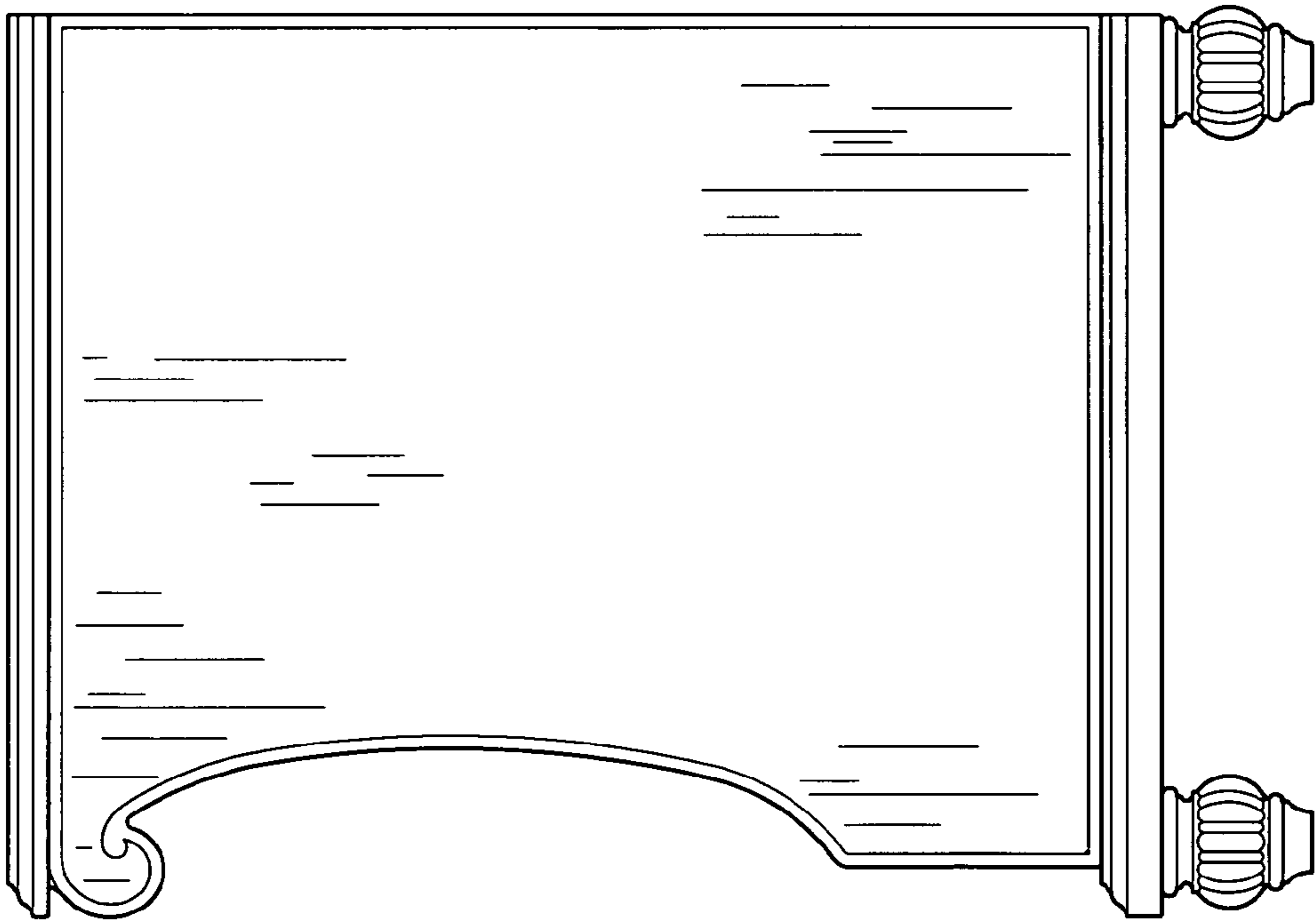

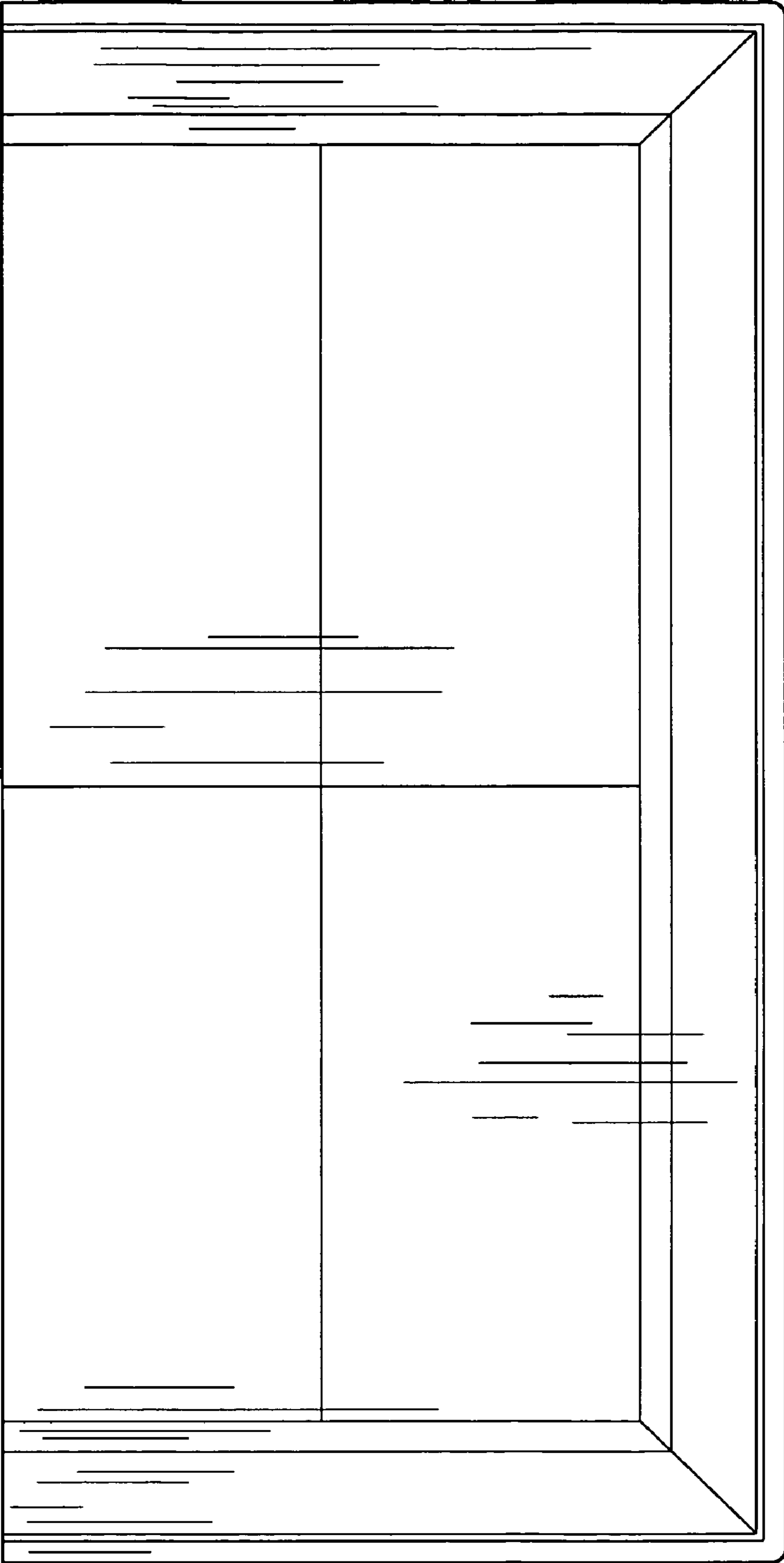
