(57) **CLAIM**

The ornamental design for a pillow, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pillow according to an embodiment of the present design.

FIG. 2 is a front elevation view of the pillow of FIG. 1.

FIG. 3 is a rear elevation view of the pillow of FIG. 1.

FIG. 4 is a right side elevation view of the pillow of FIG. 1 as seen from the left side of FIG. 2.

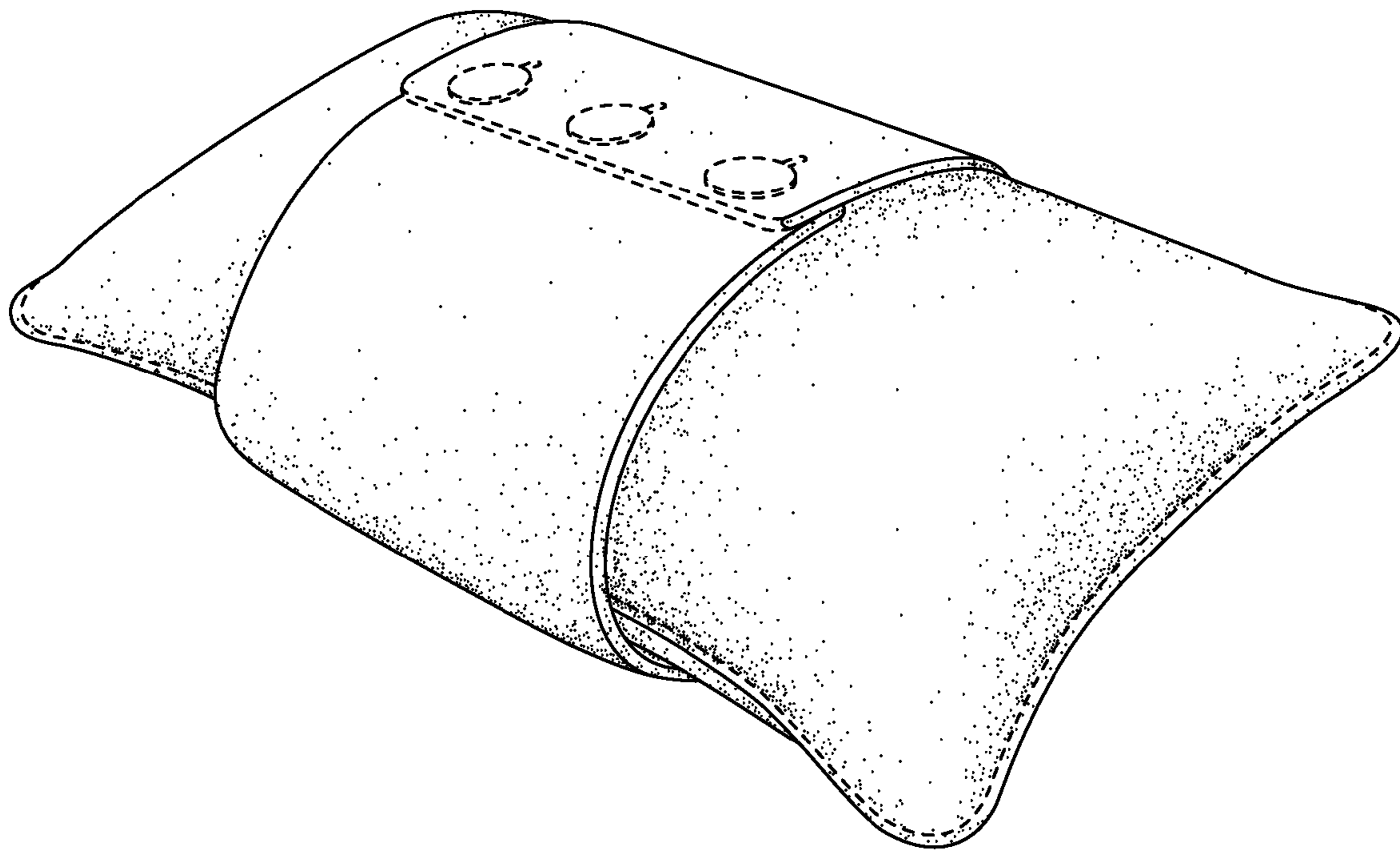
FIG. 5 is a left side elevation view of the pillow of FIG. 1 as seen from the right side of FIG. 2.

FIG. 6 is a top plan view of the pillow of FIG. 1; and,

FIG. 7 is a bottom plan view of the pillow of FIG. 1.

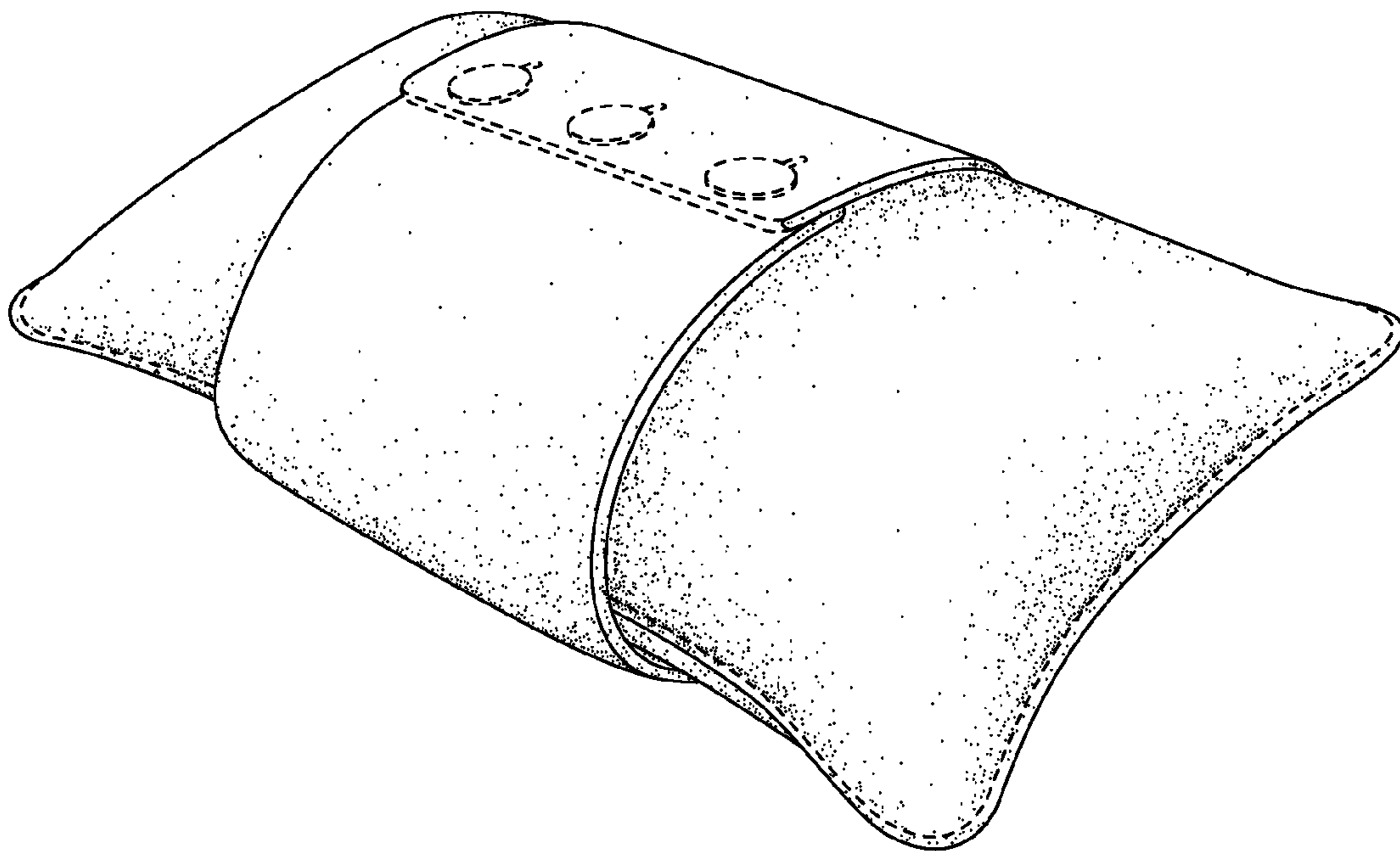

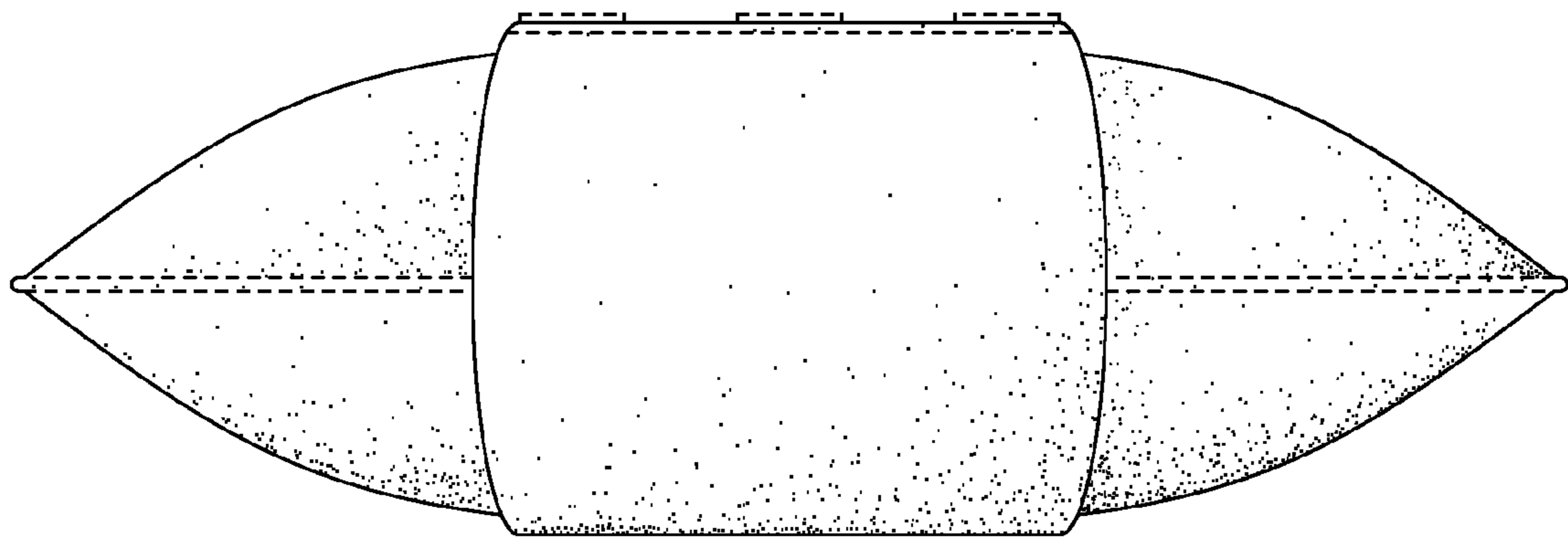

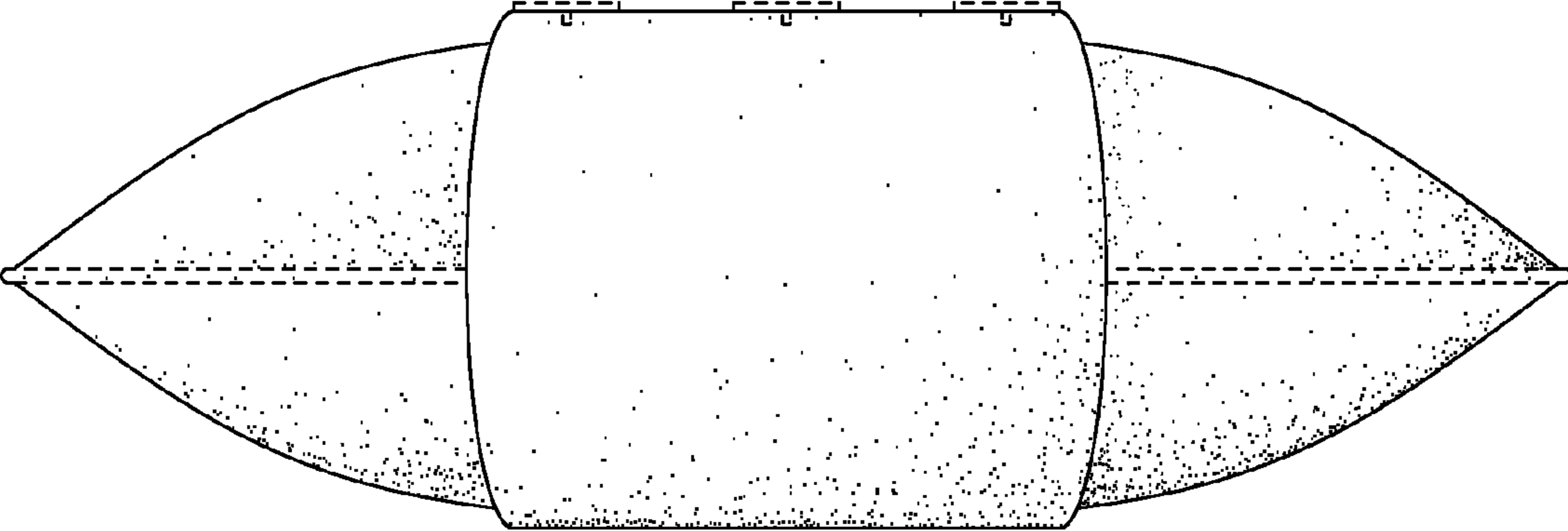

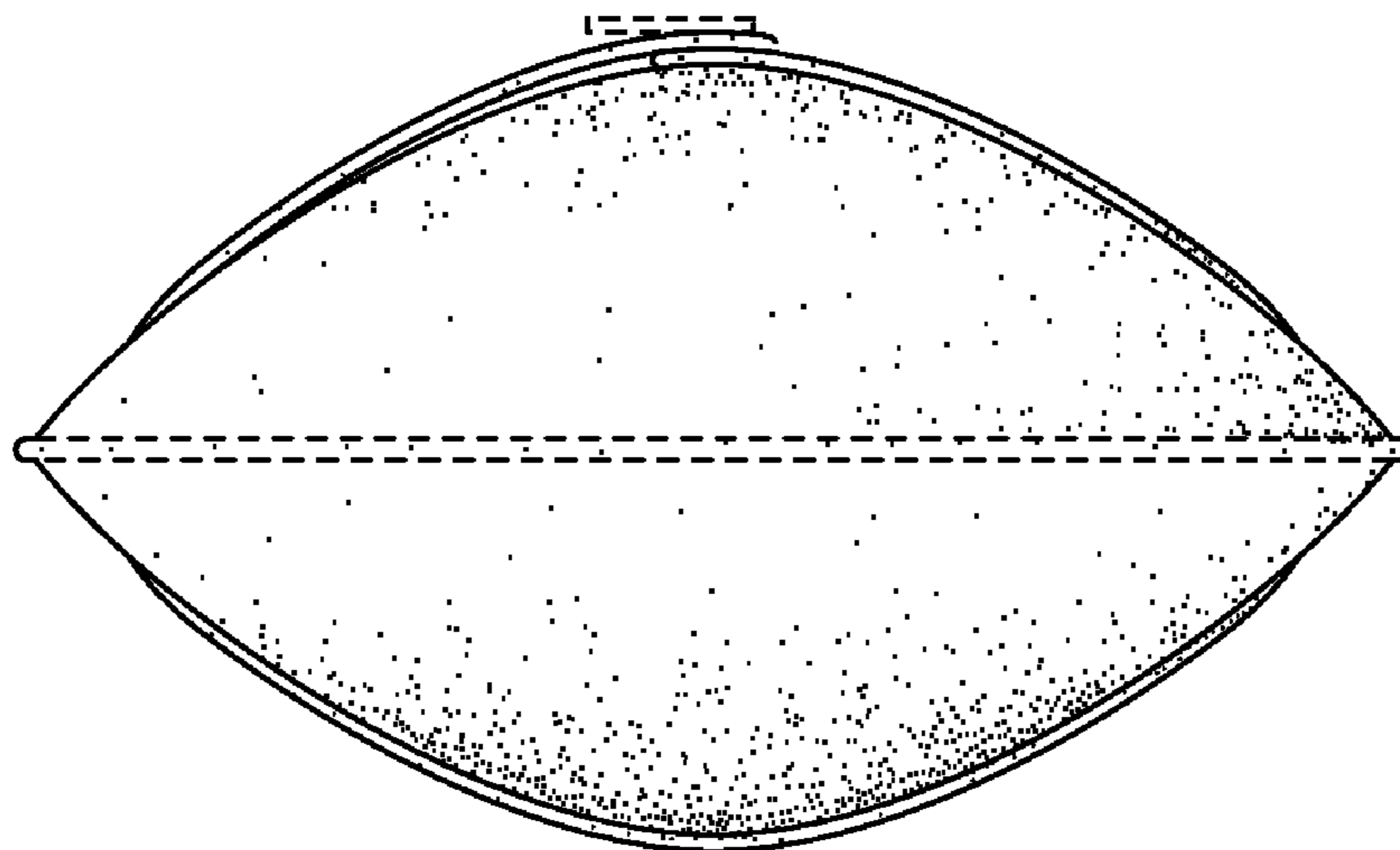

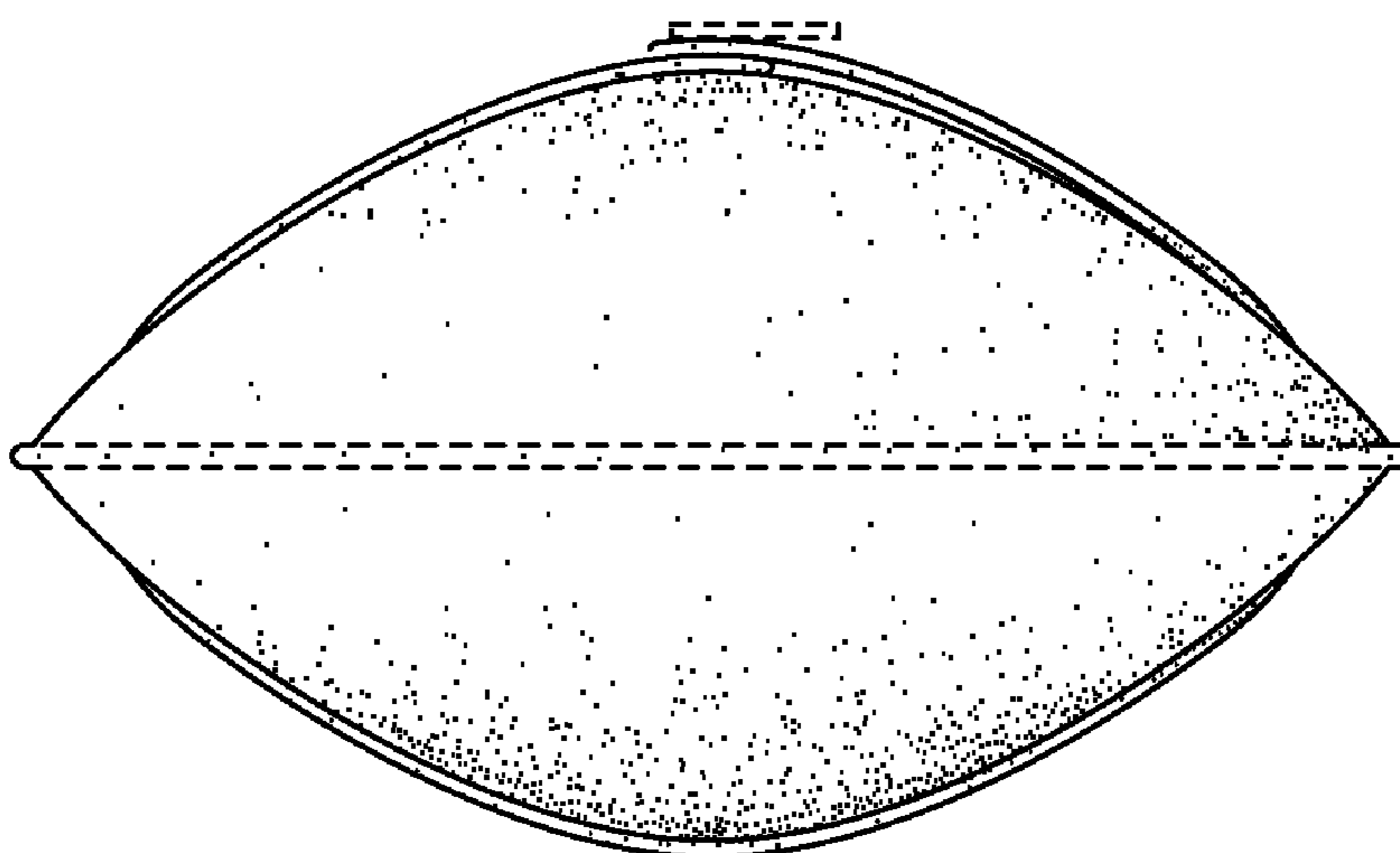

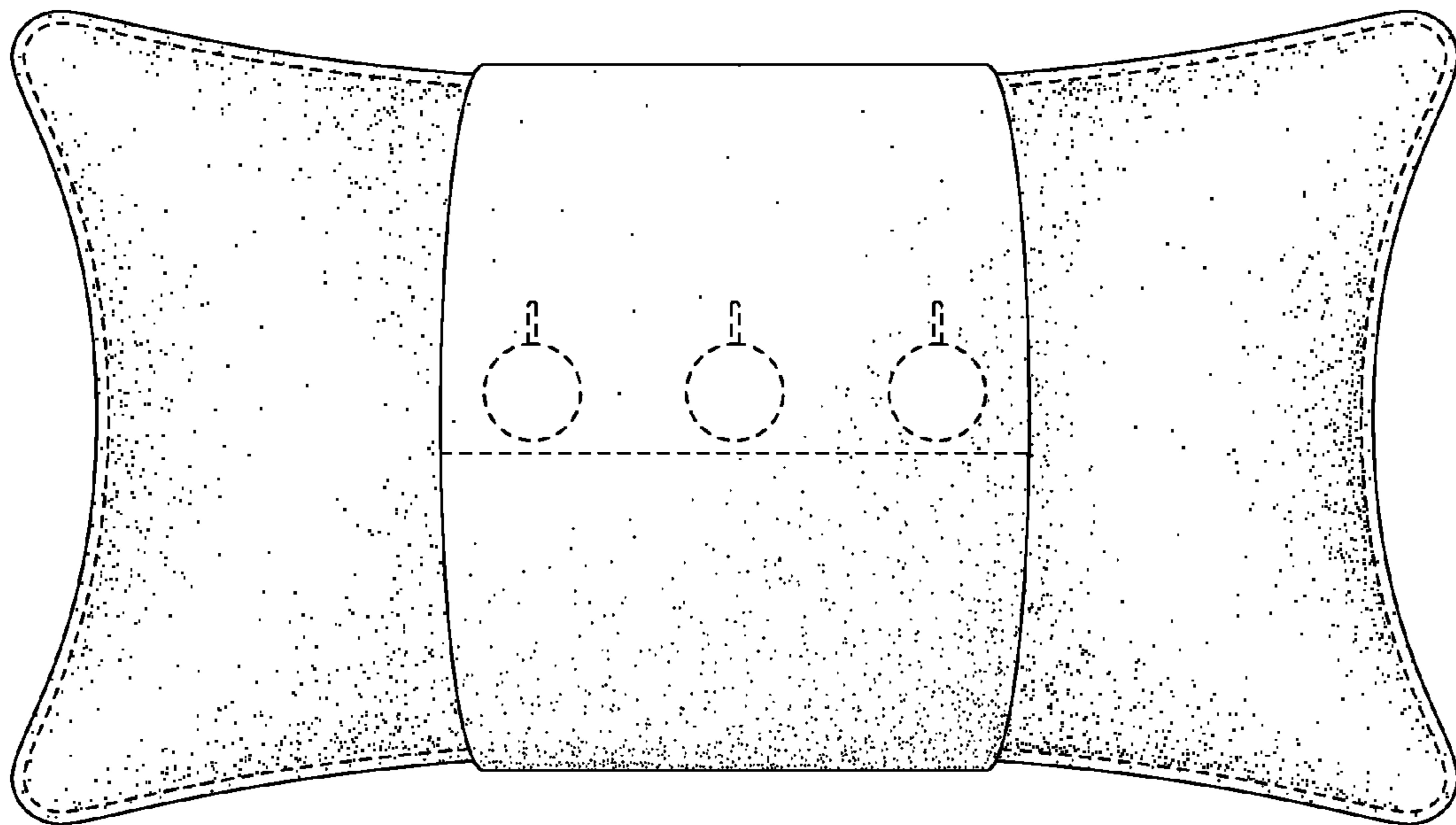

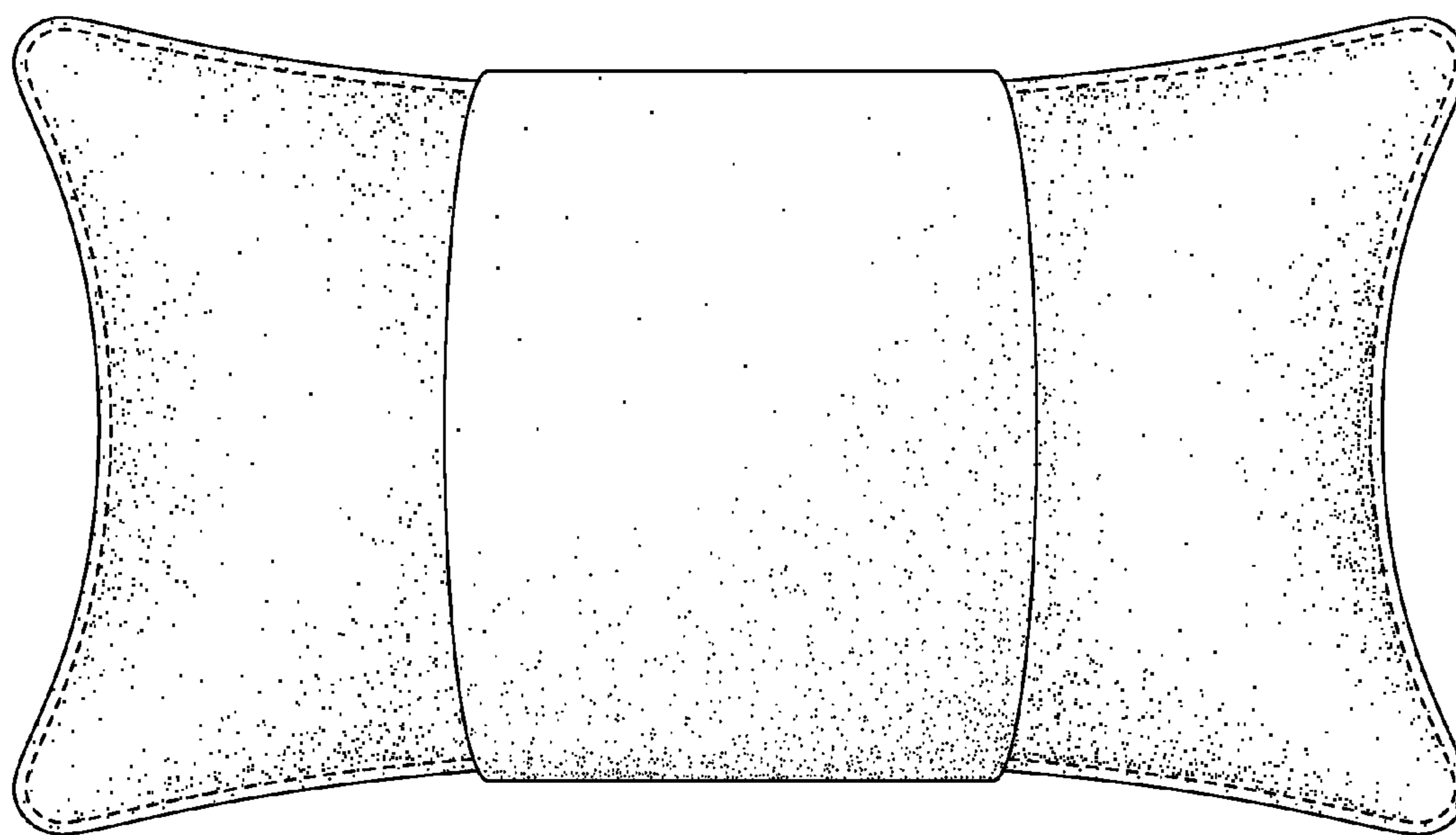
