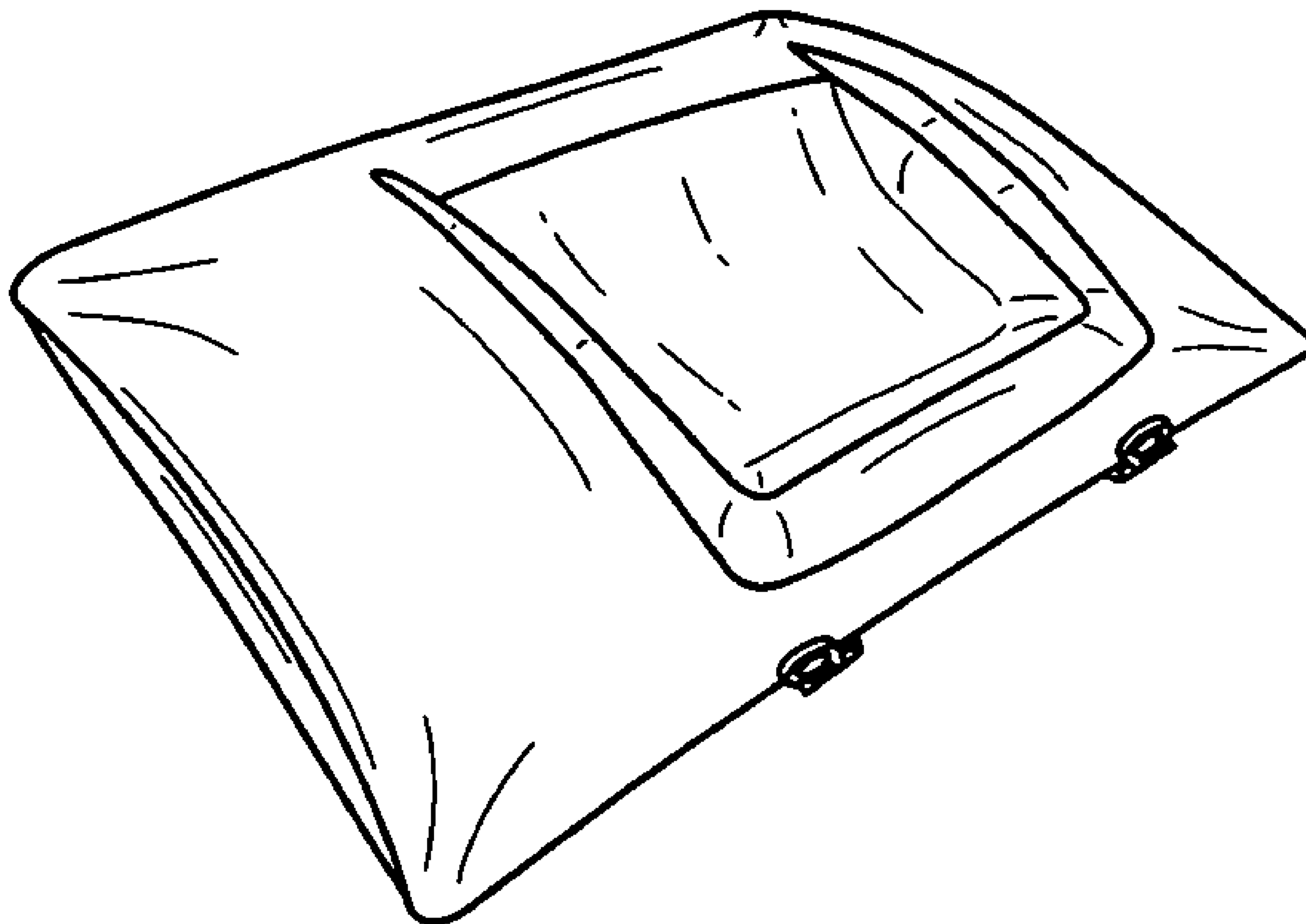
(57) **CLAIM**

The ornamental design for a support pillow, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a support pillow showing my new design supporting a tablet personal computer;
FIG. 2 is perspective view of the support pillow;
FIG. 3 is a front elevational view thereof
FIG. 4 is a back elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a right side elevational view thereof, the left side being a mirror image.
The tablet personal computer shown in broken lines in FIG. 1 does not form part of the claimed design.

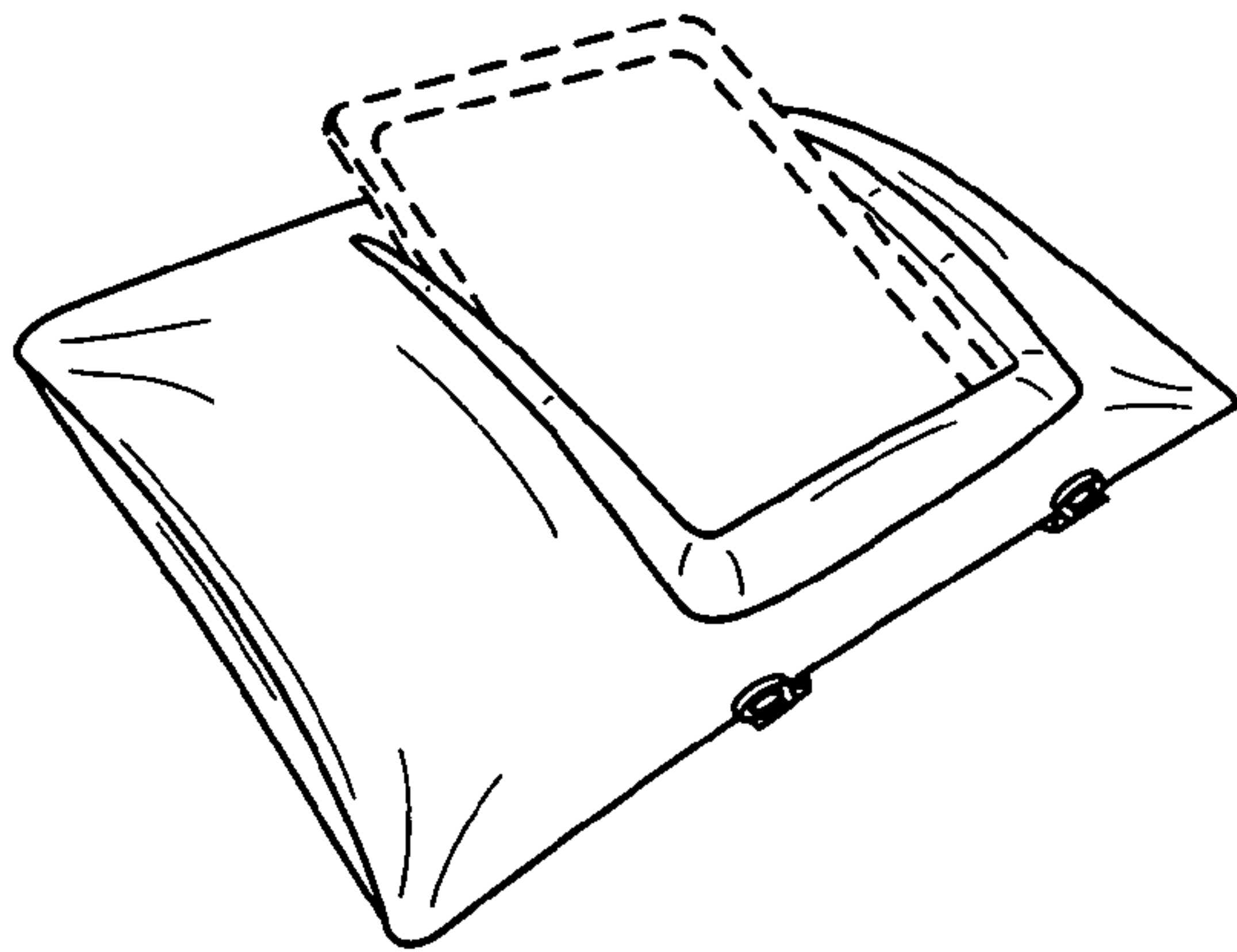

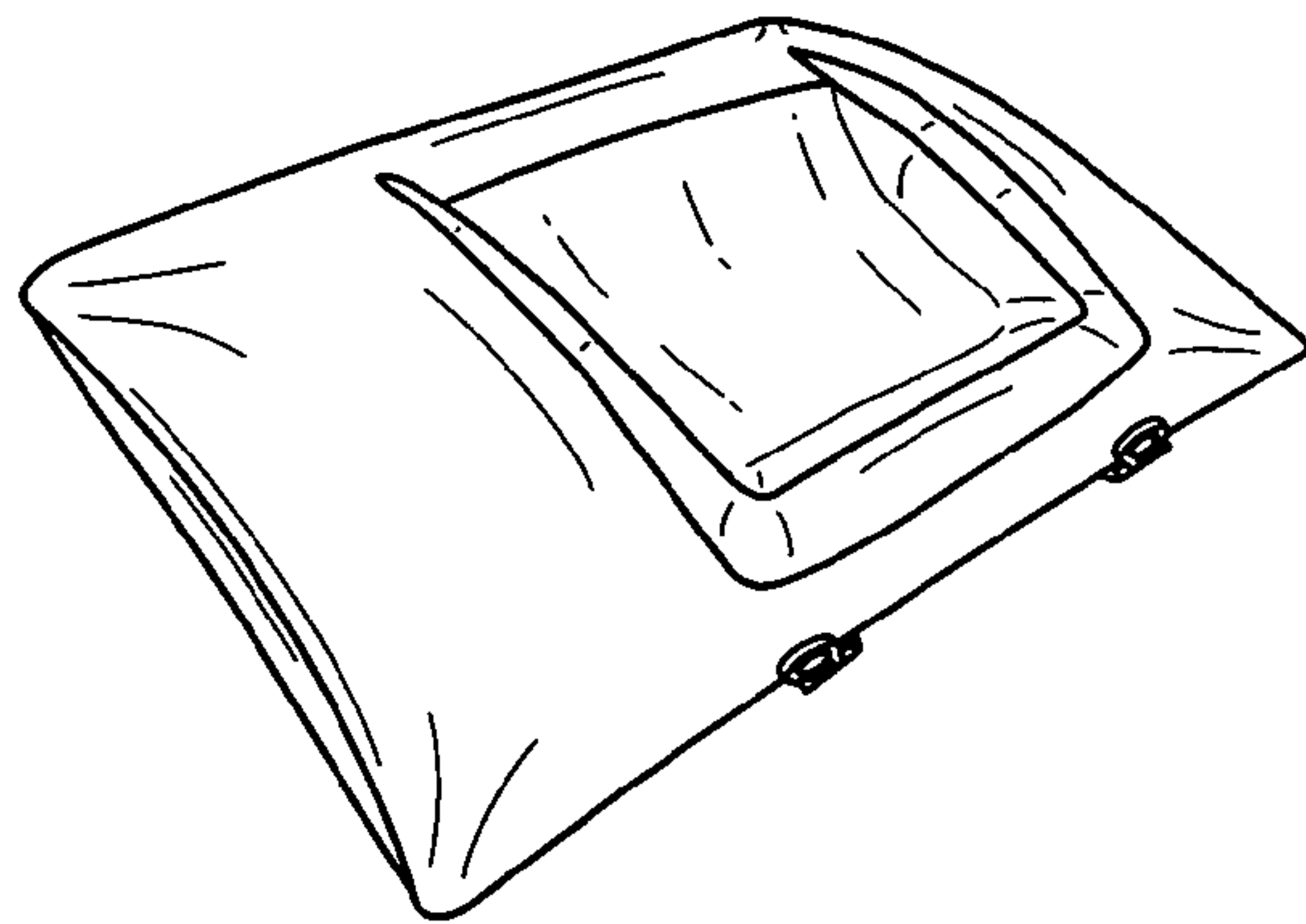

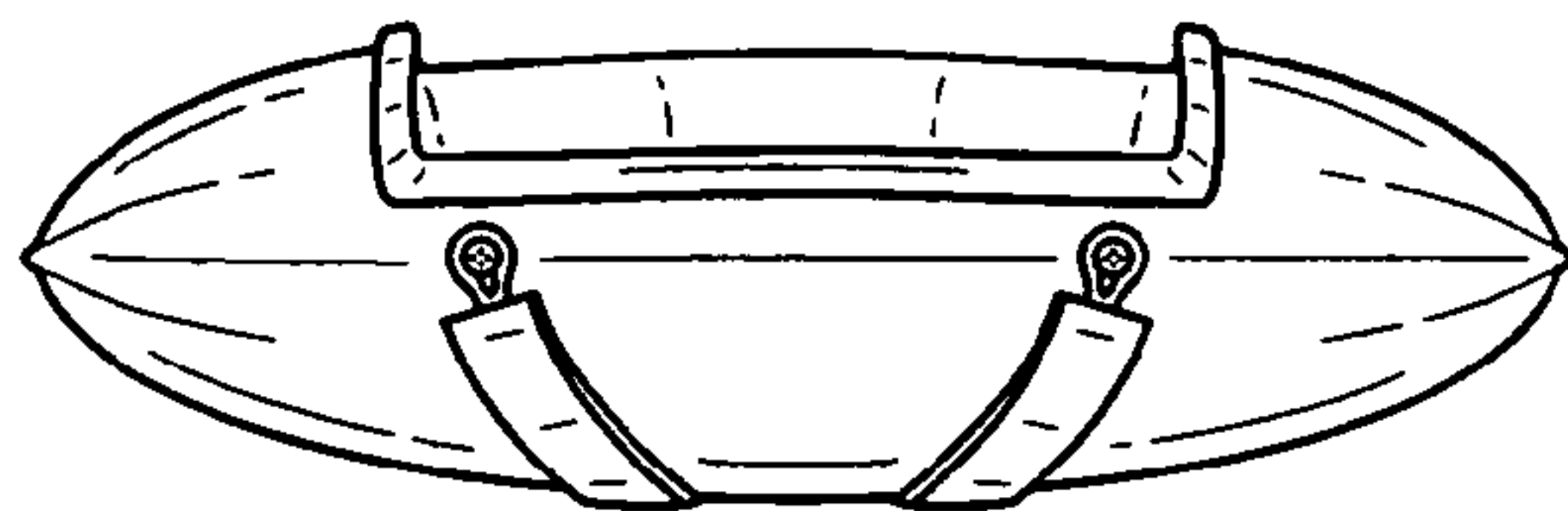

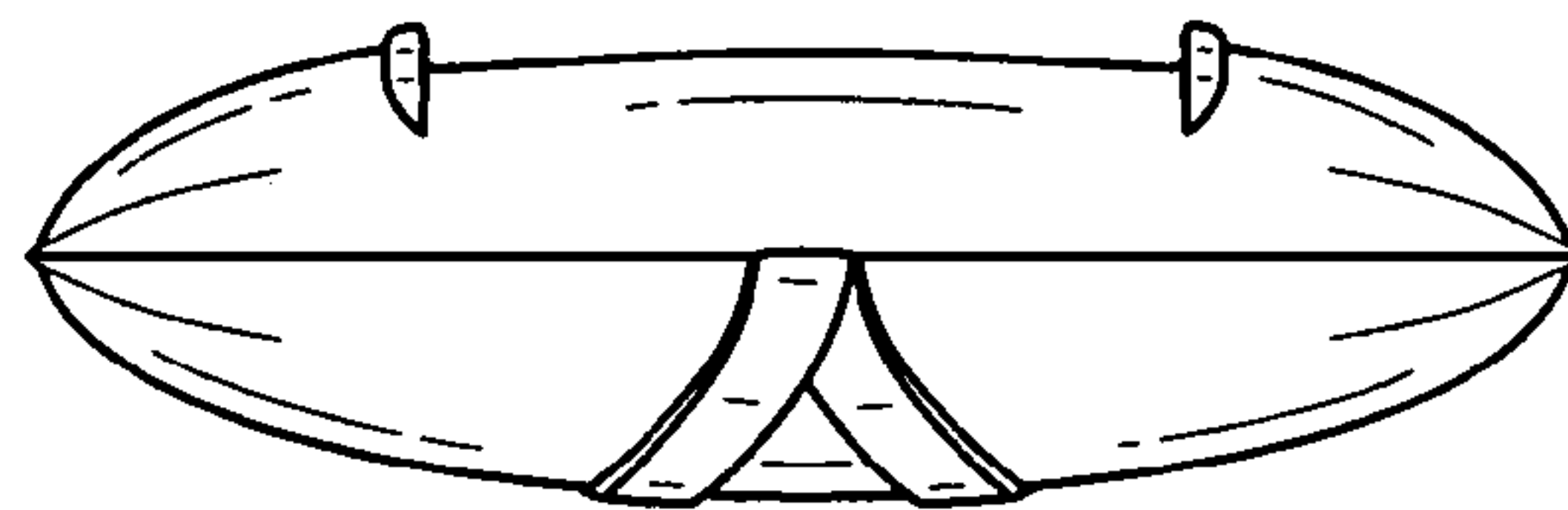

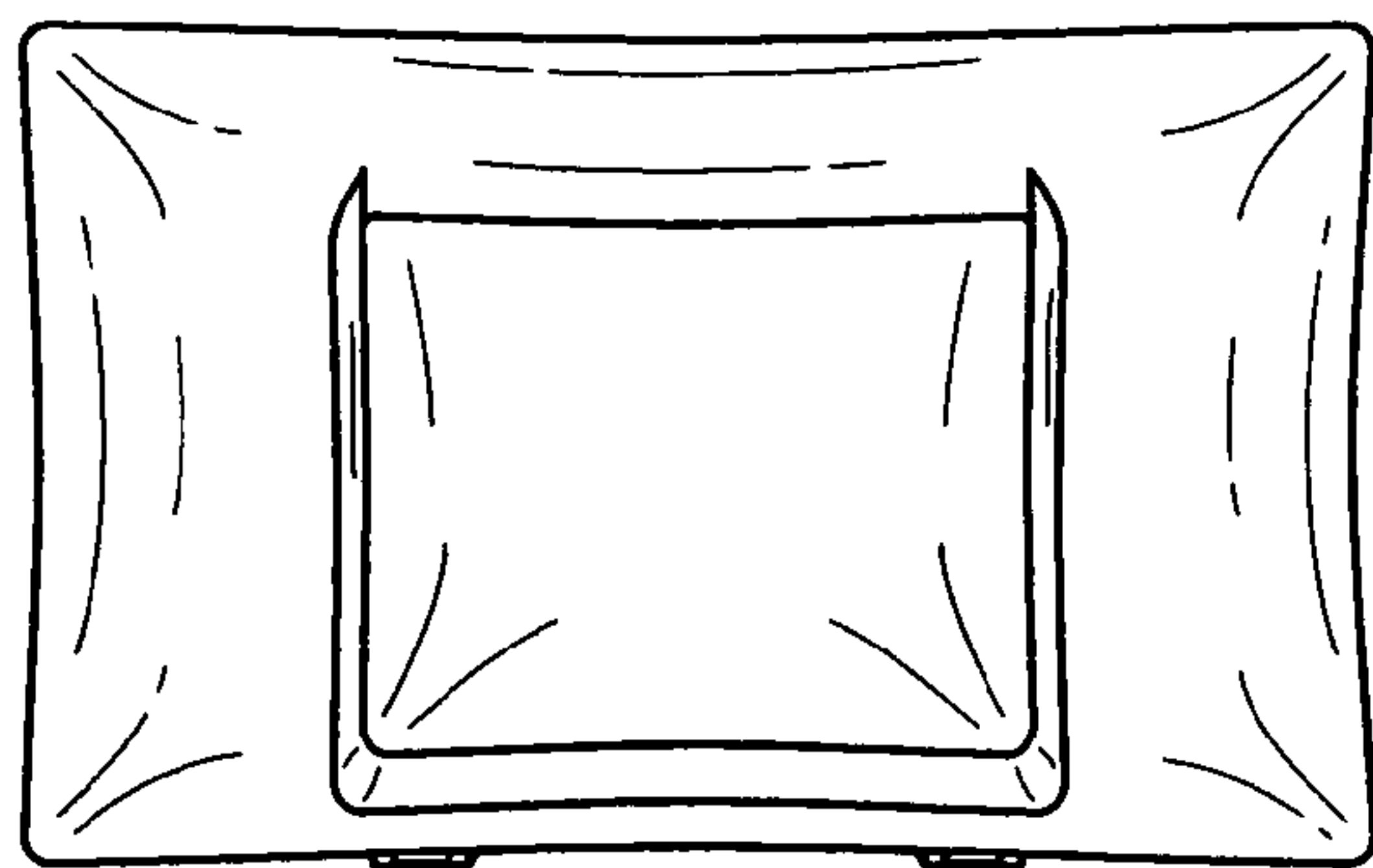

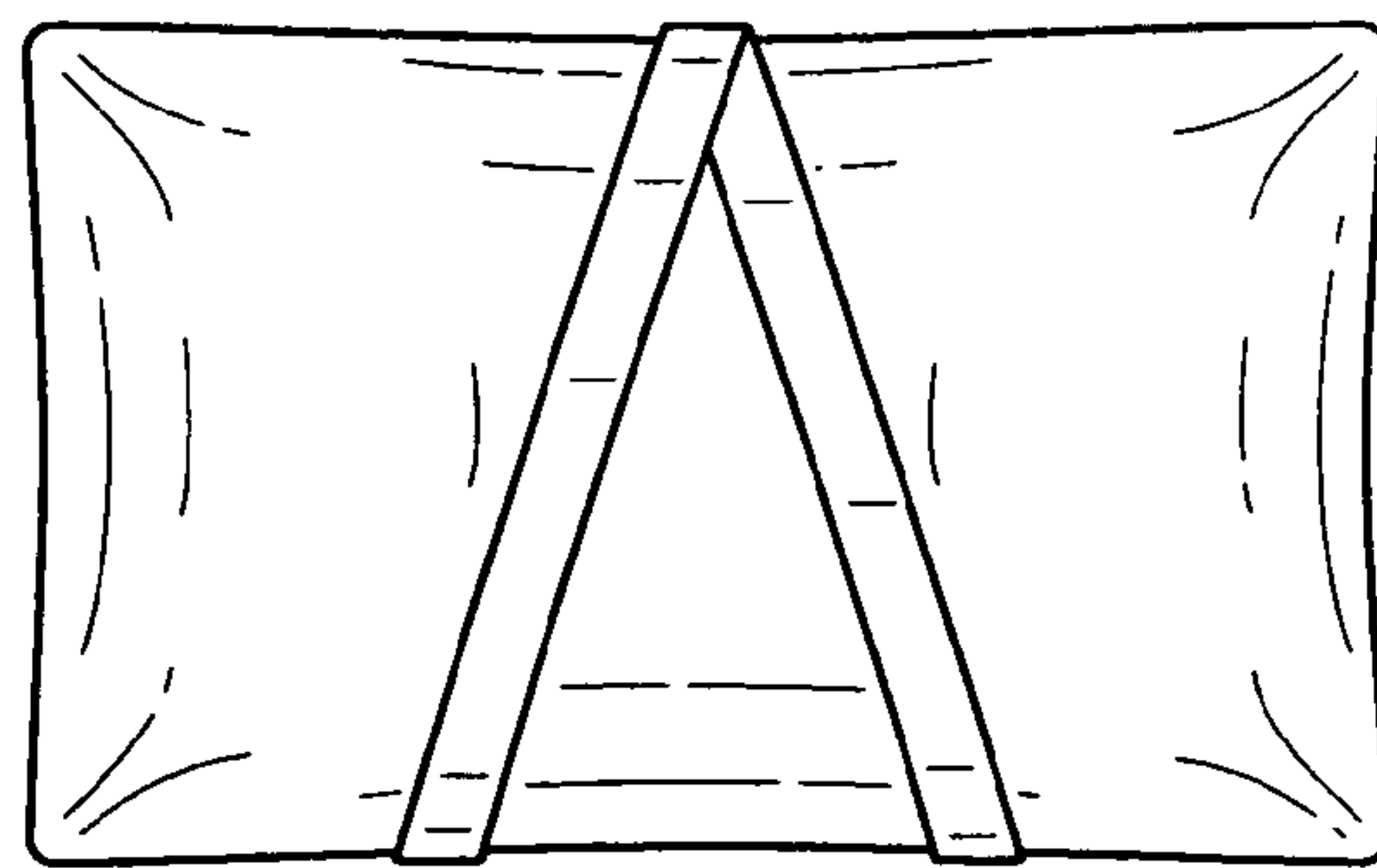

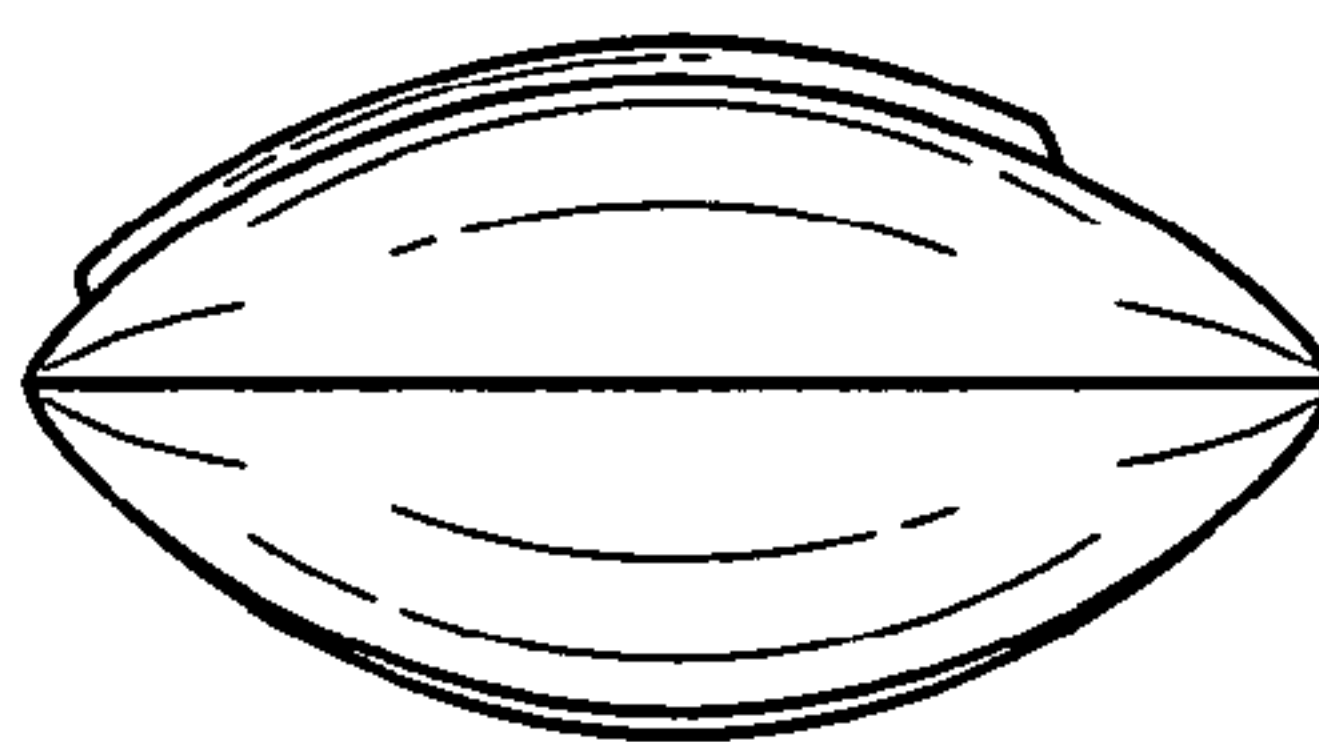
