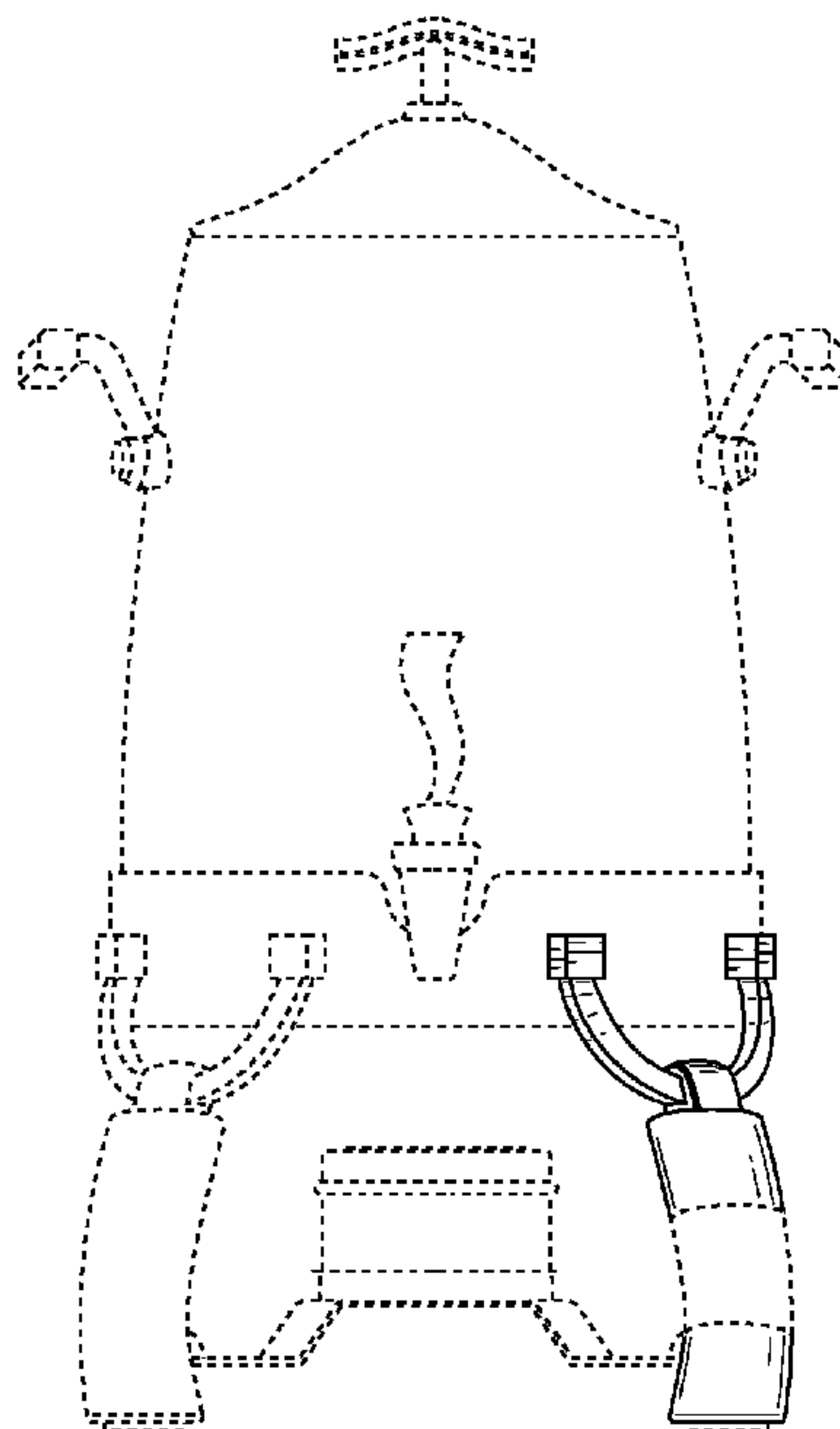
(57) **CLAIM**

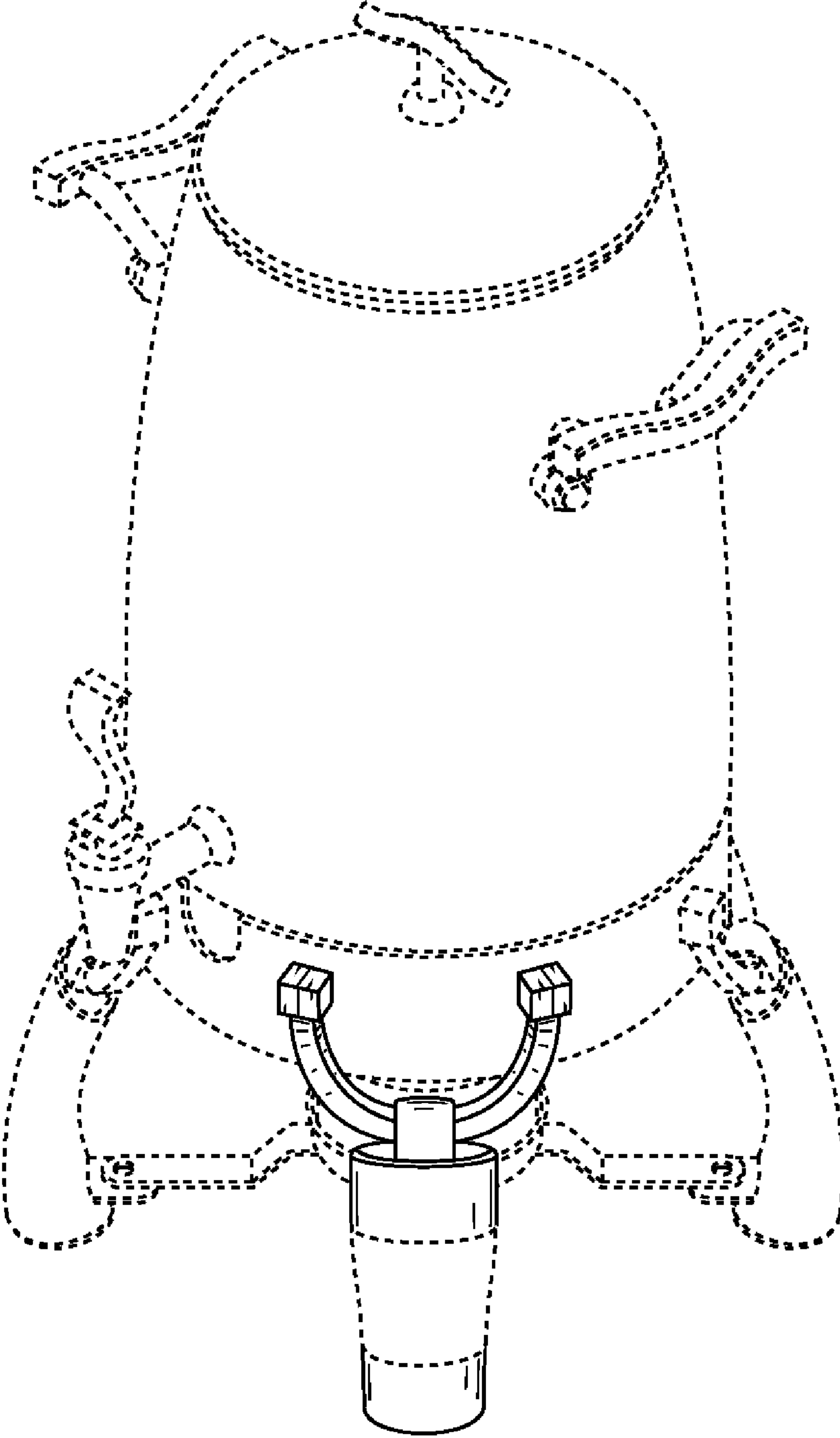
We claim the ornamental design for a support for food service equipment, as shown and described.

**DESCRIPTION**

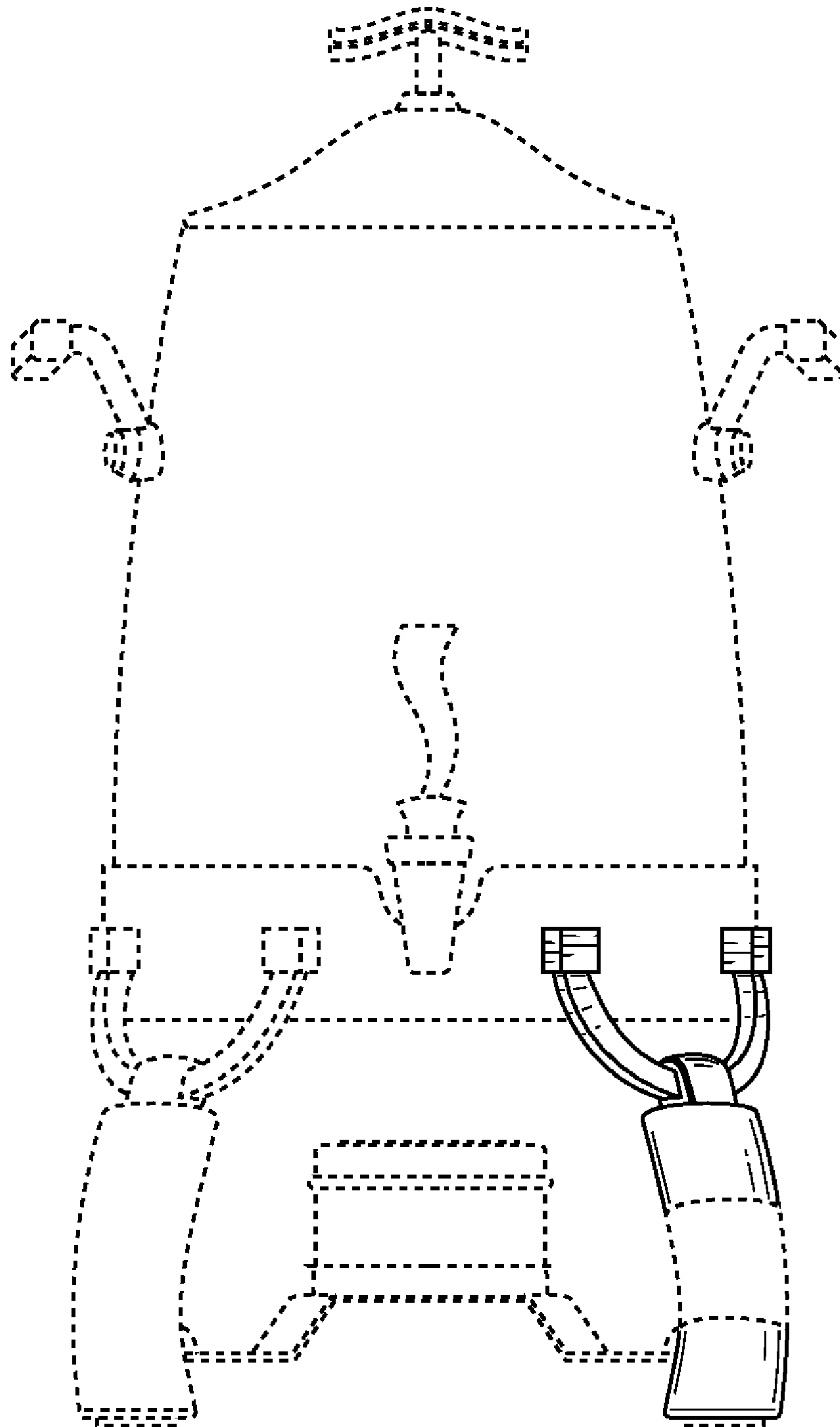

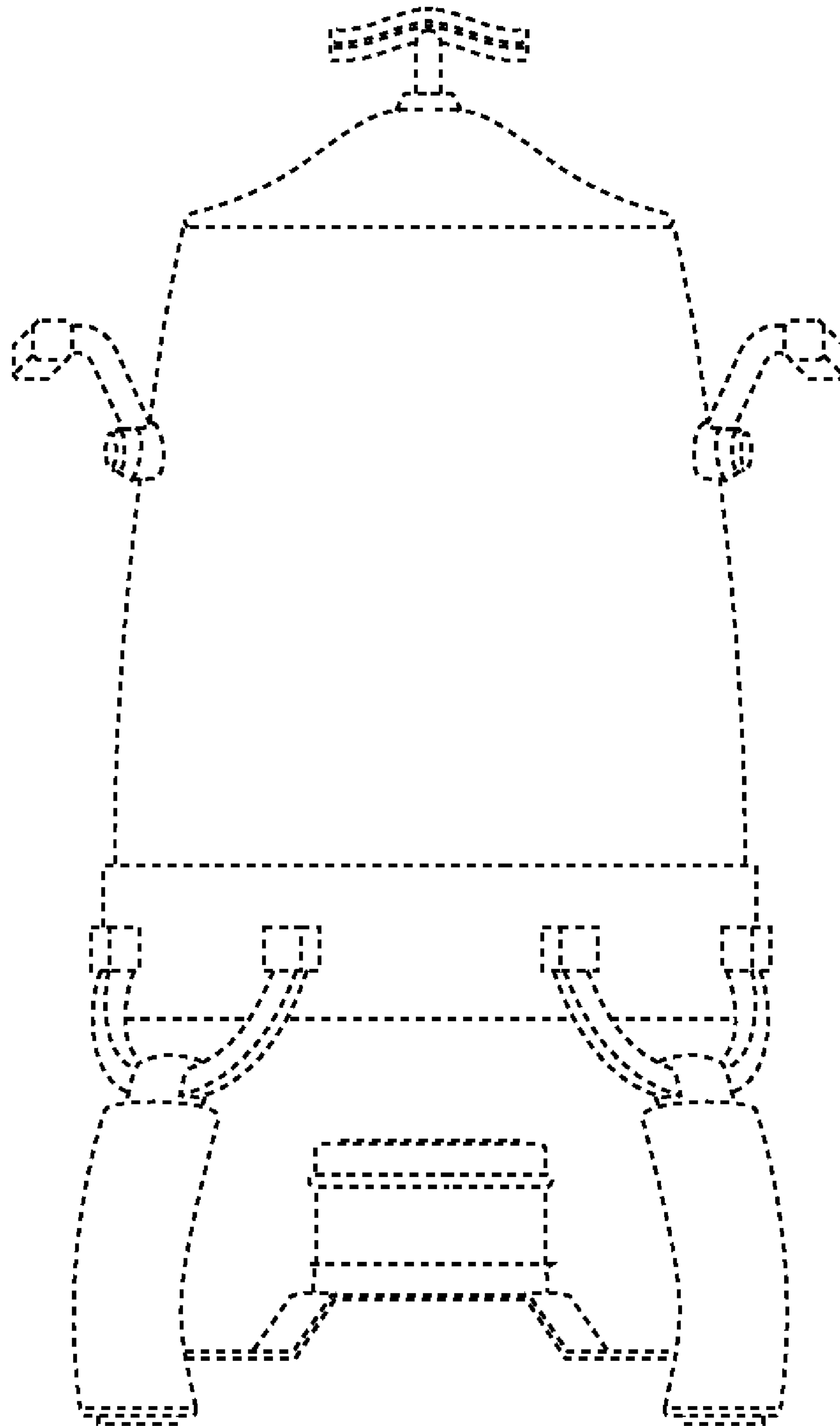




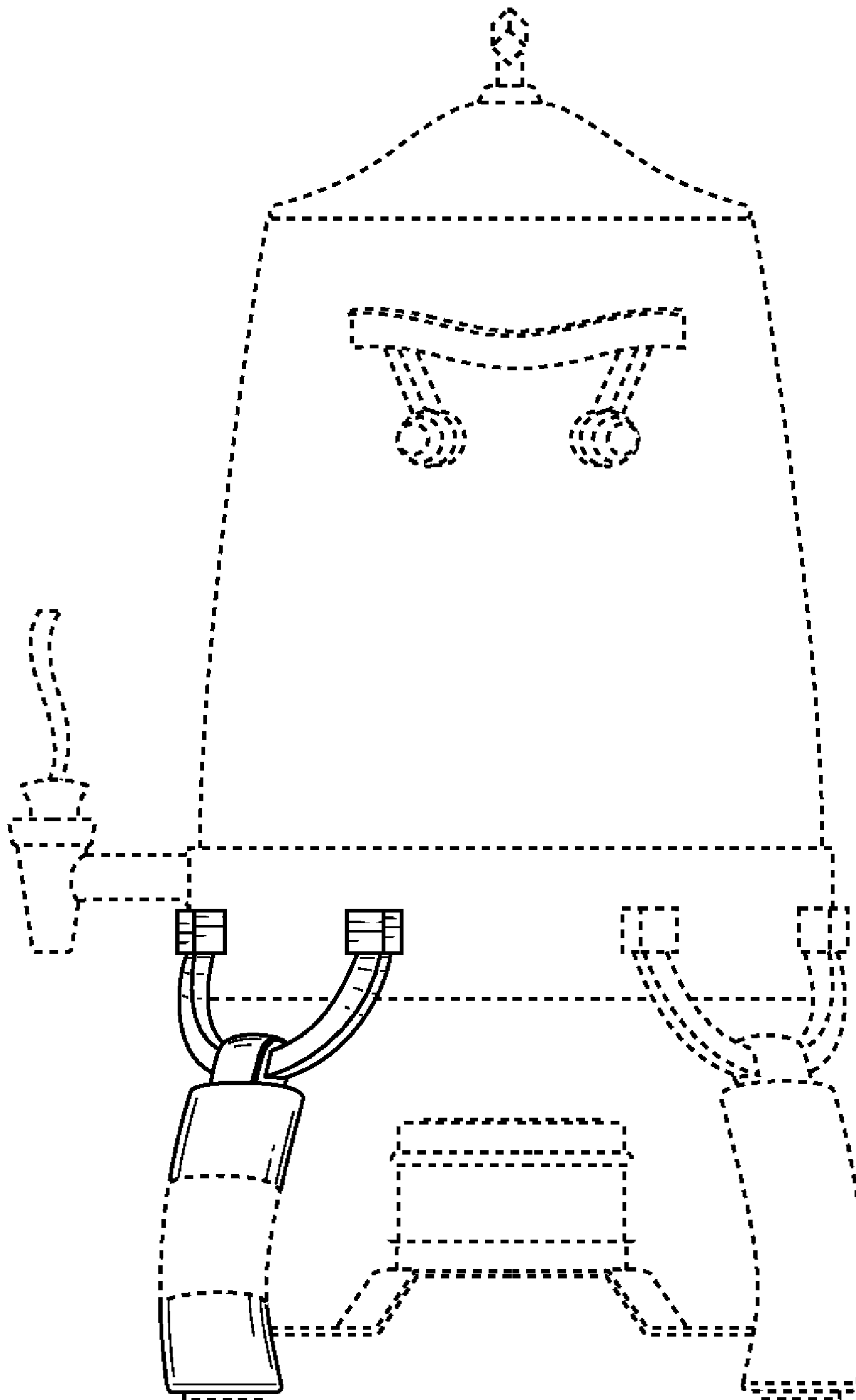

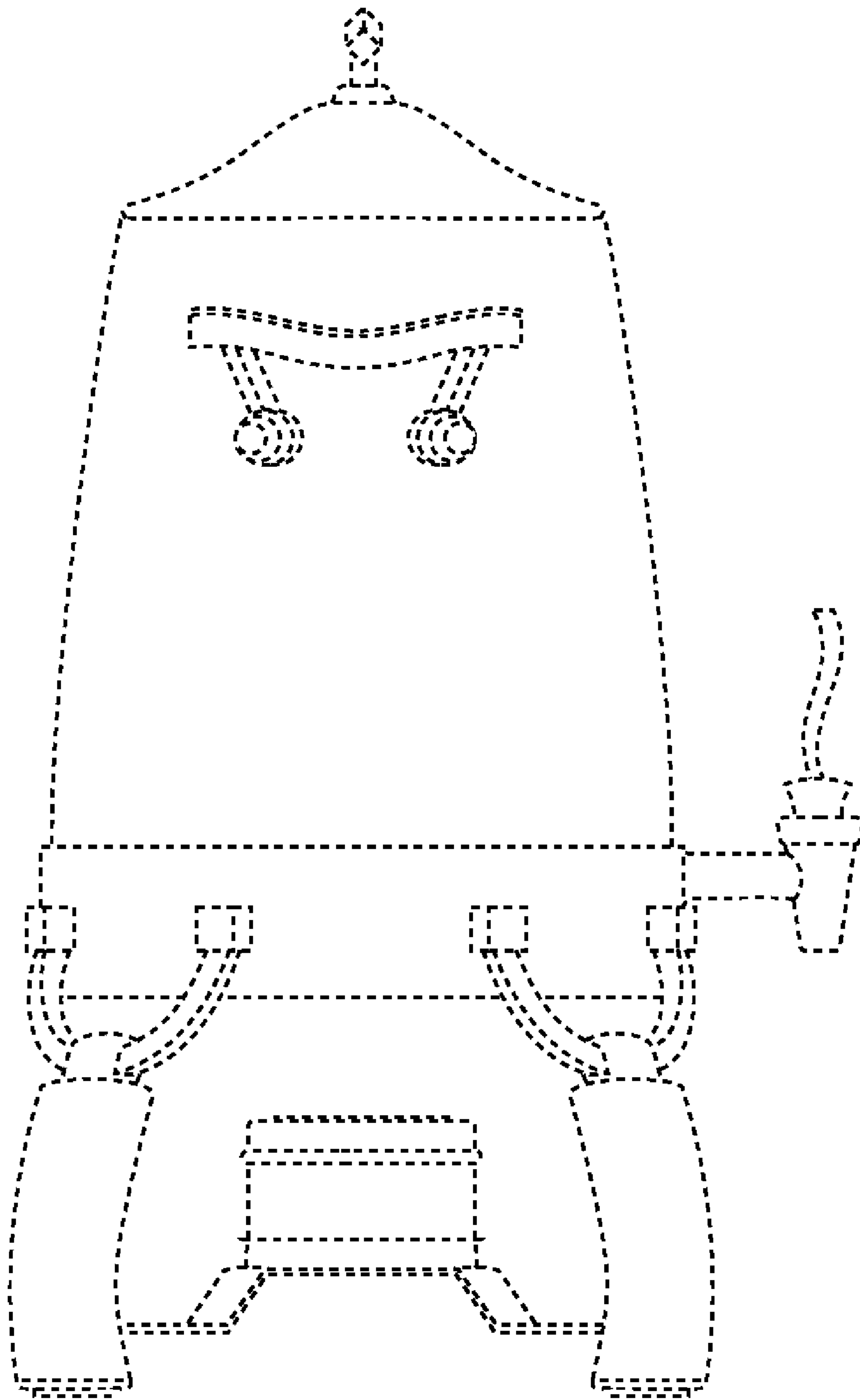

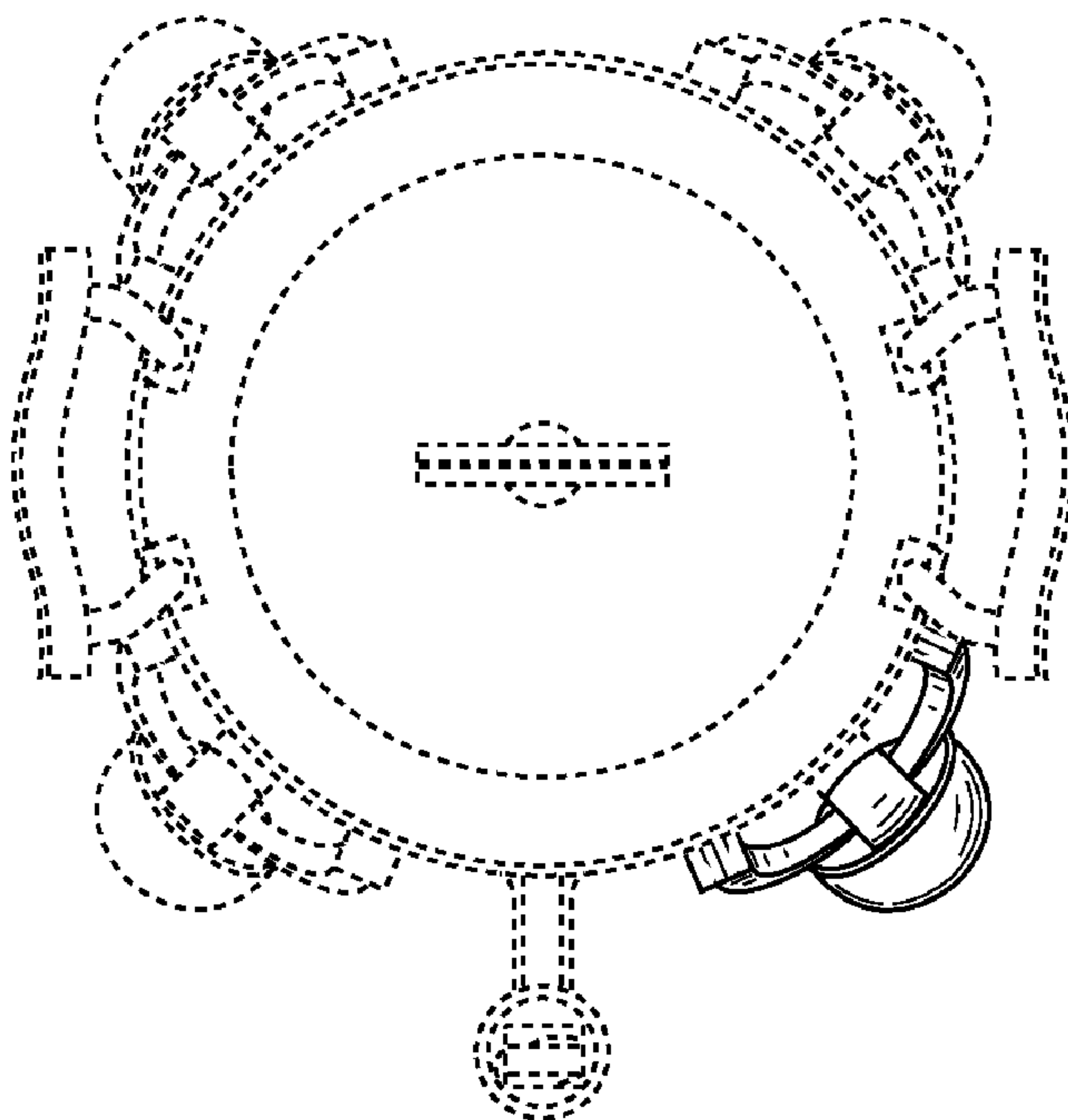

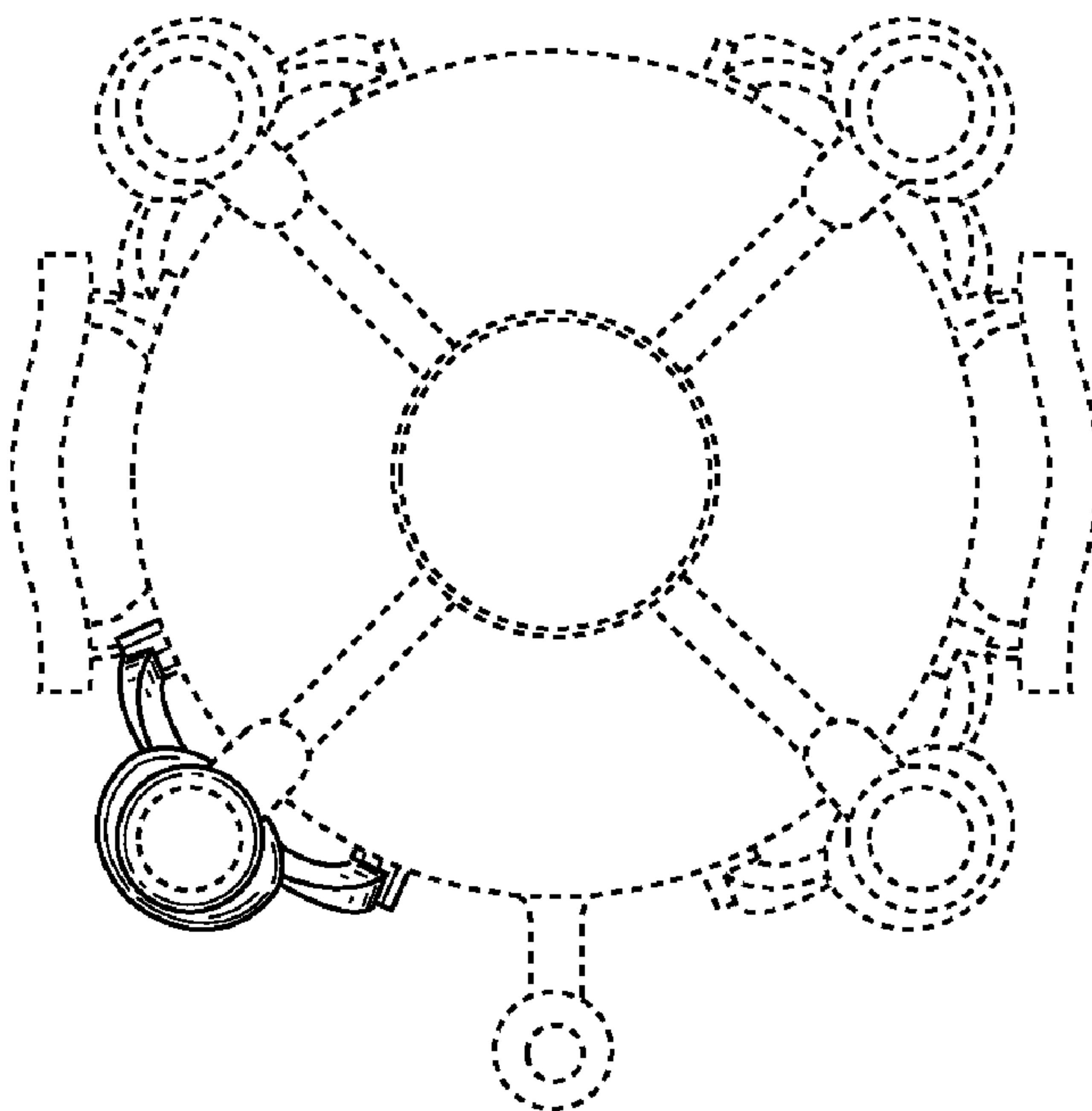
