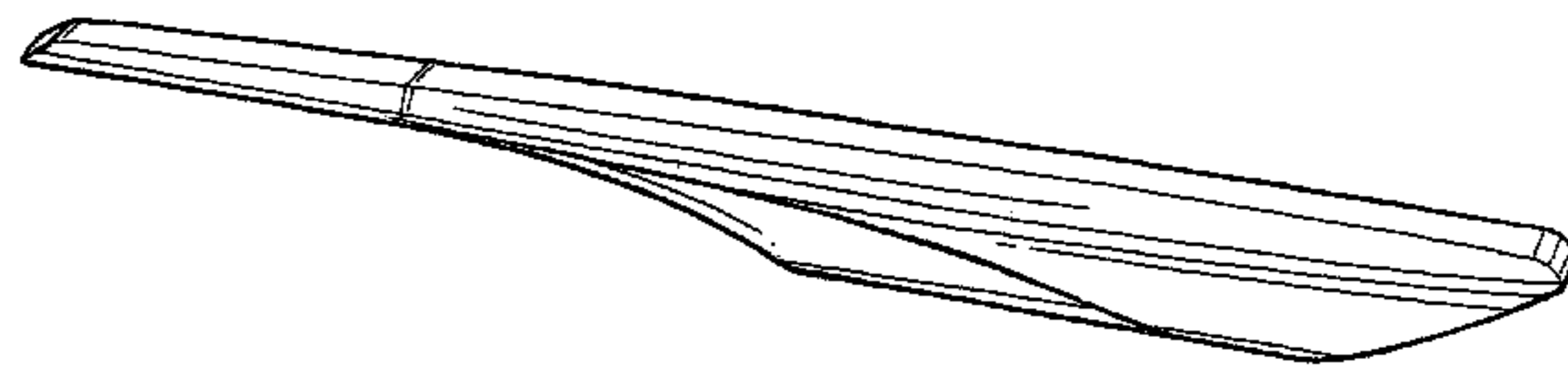
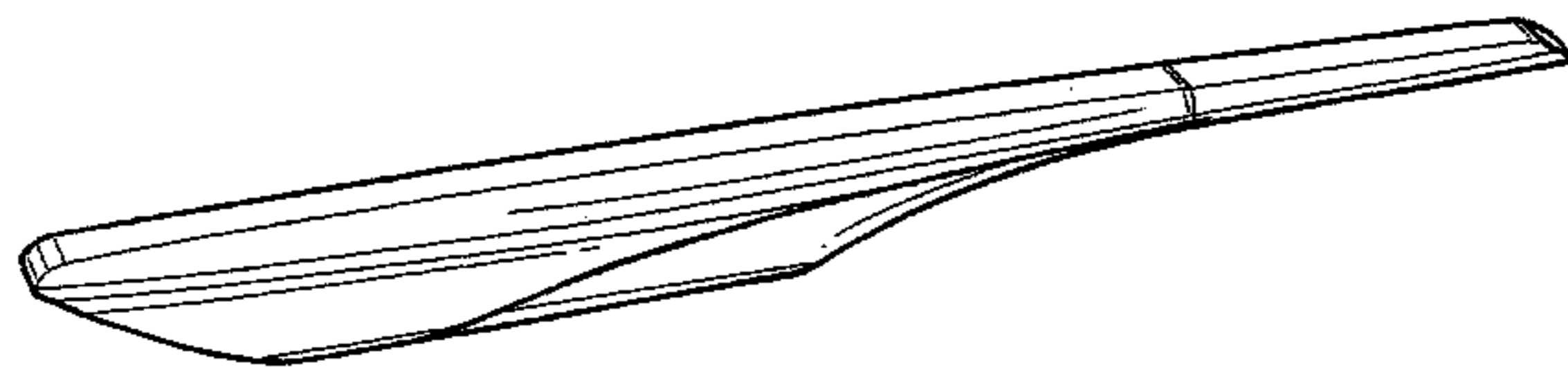
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a left, elevated perspective view of a decorative element for a vehicle according to my design;

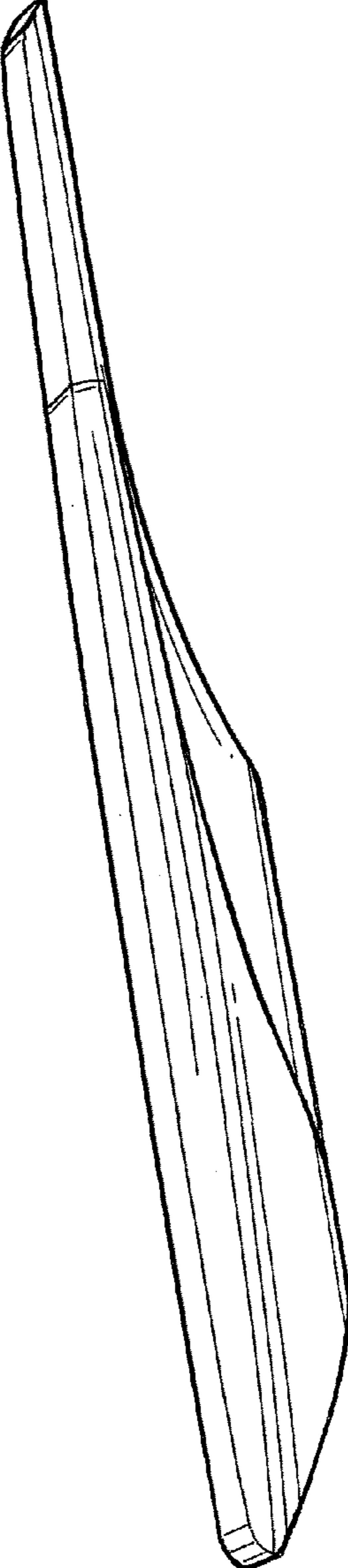

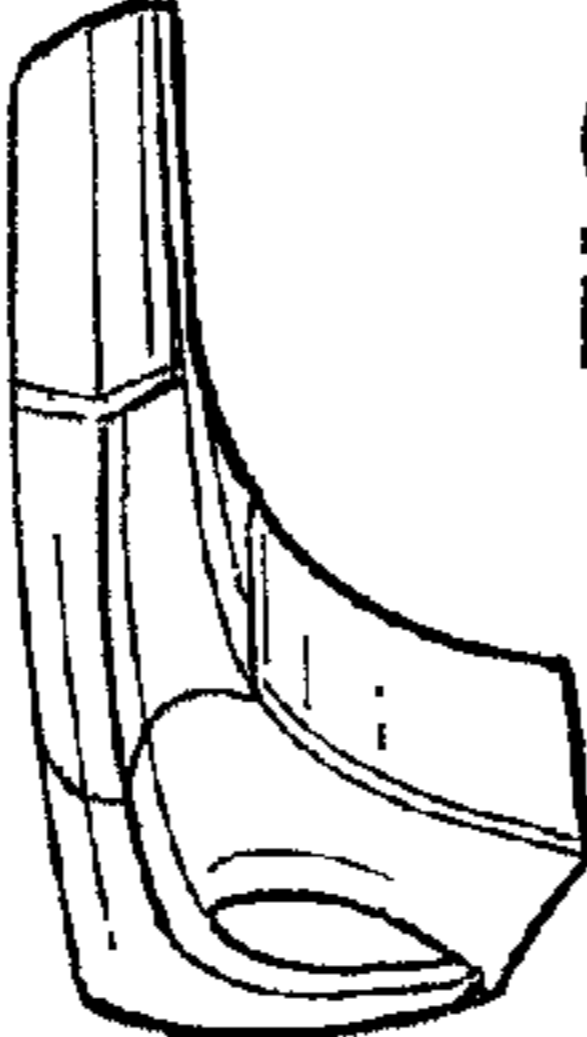

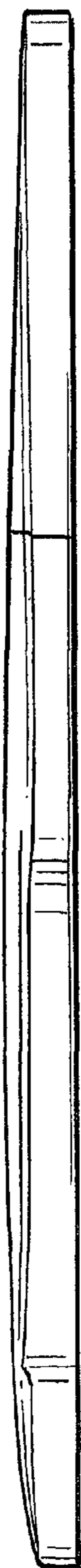

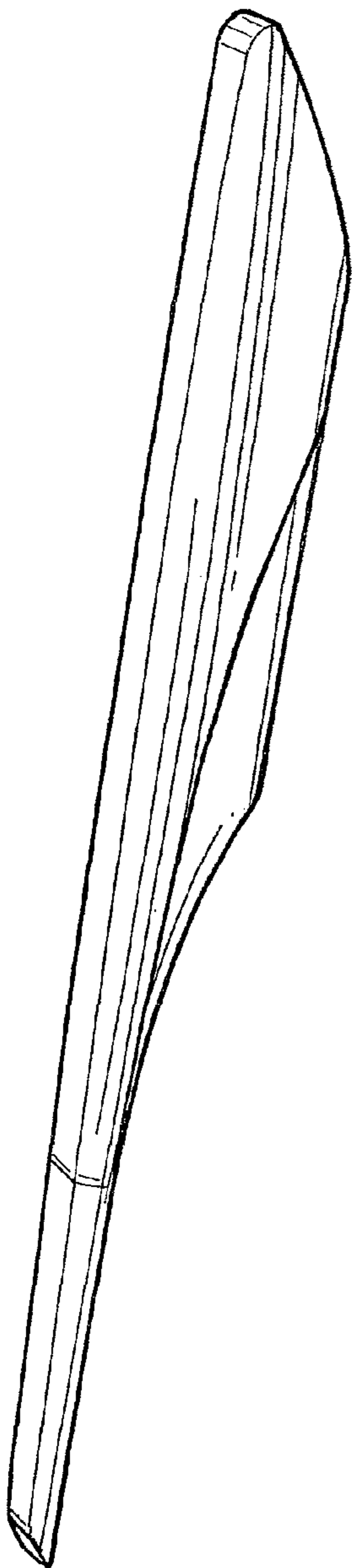

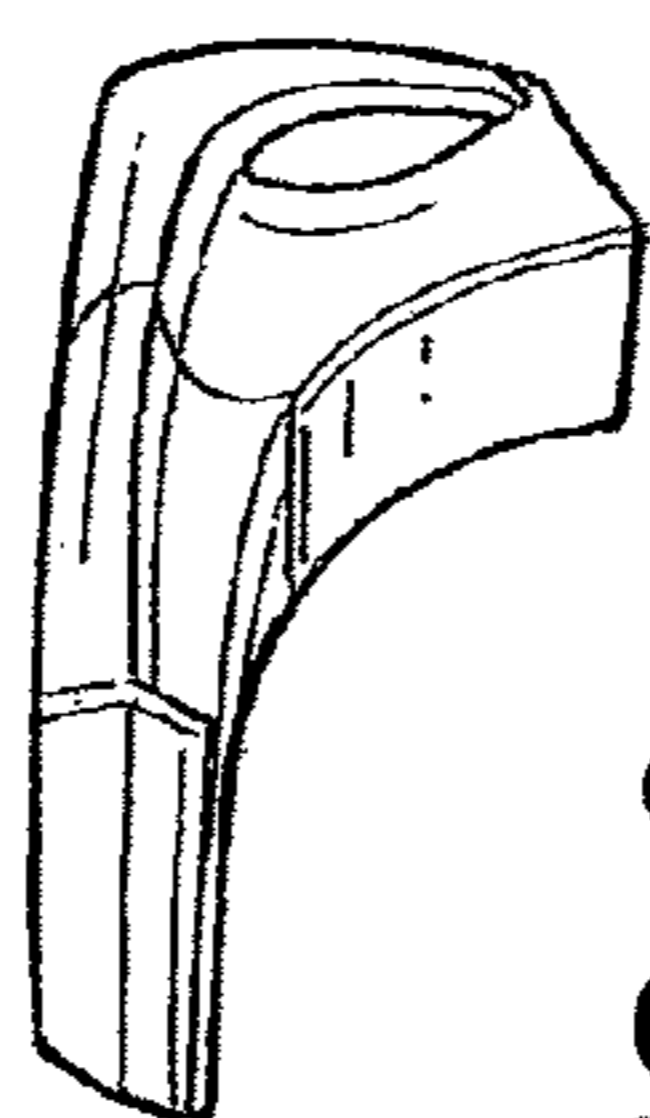

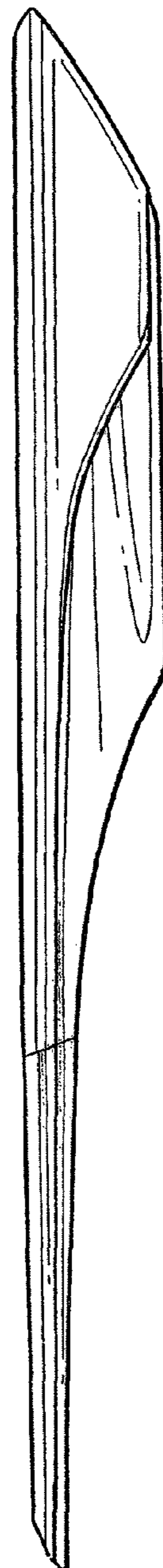

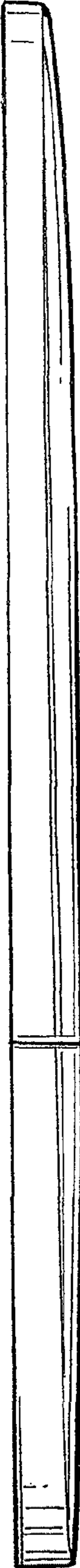
