FIG. 3 is a top elevated view of the integrated guitar case and amplifier;

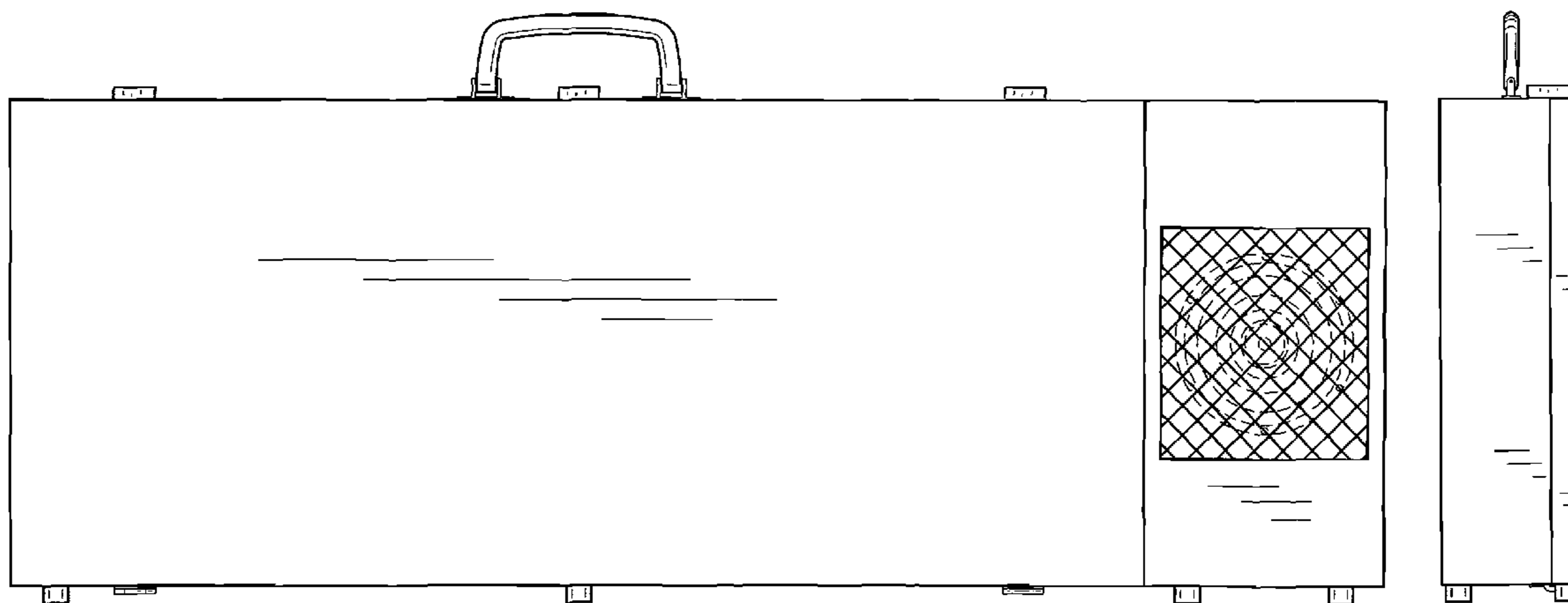
FIG. 4 is a bottom plan view of the integrated guitar case and amplifier;

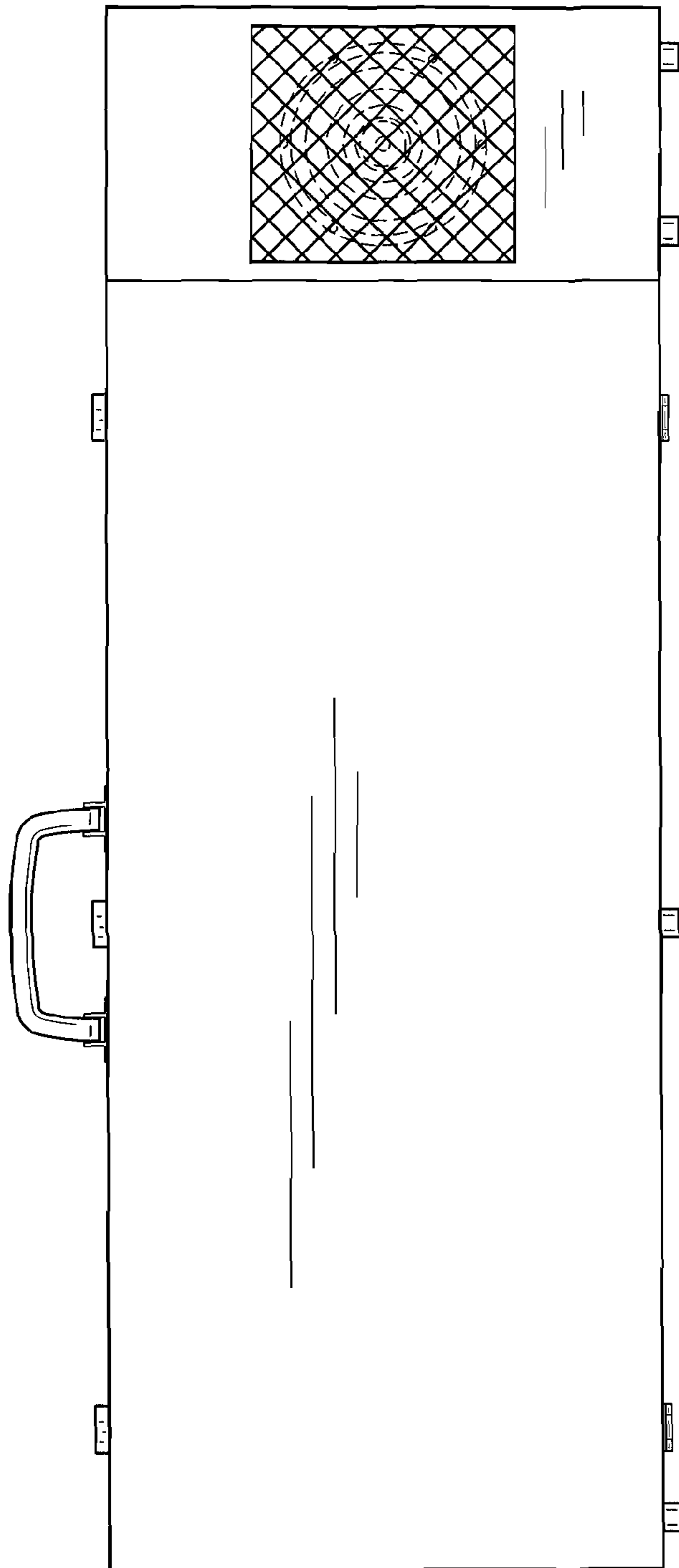

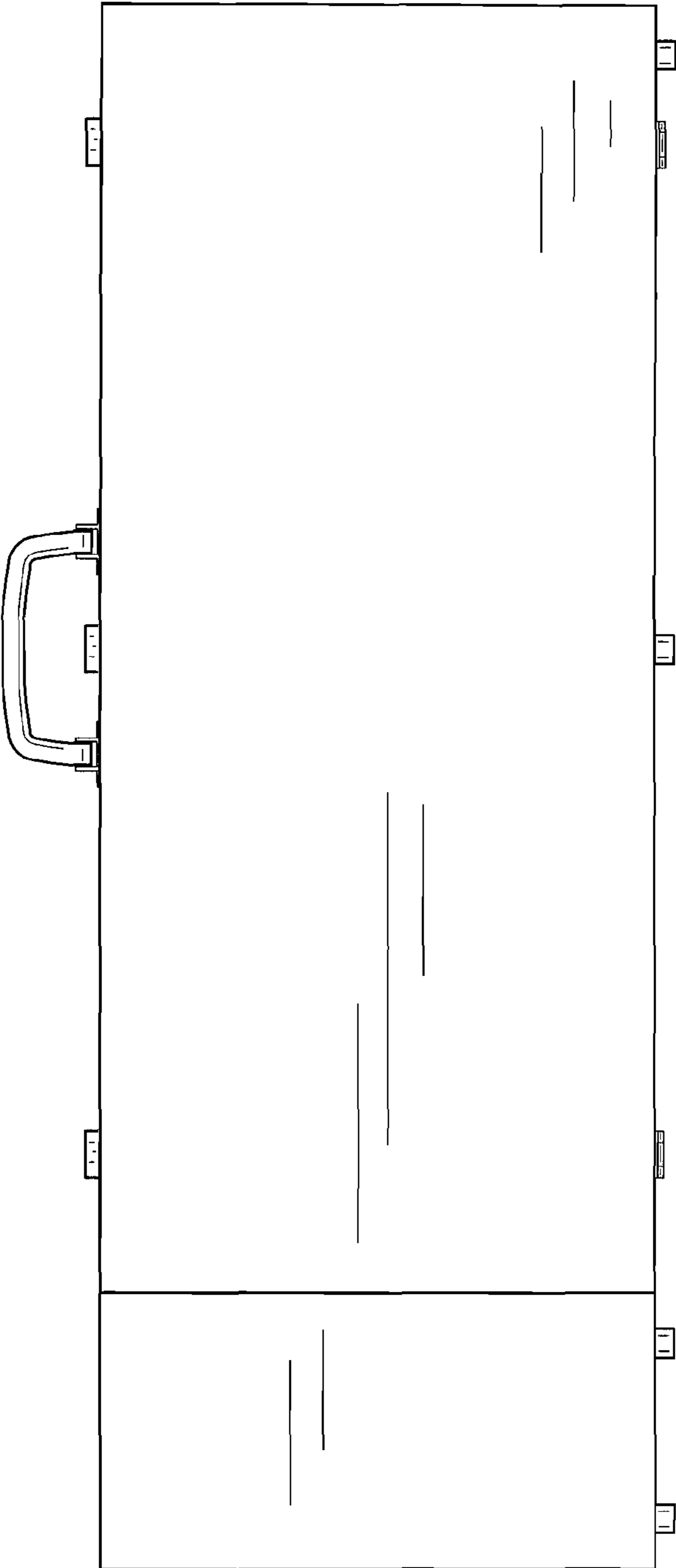

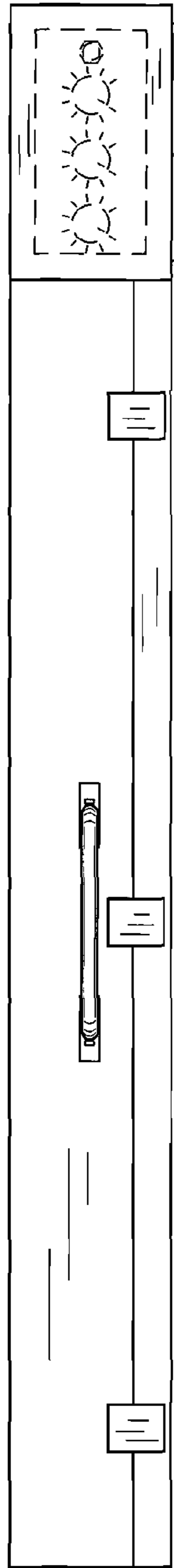

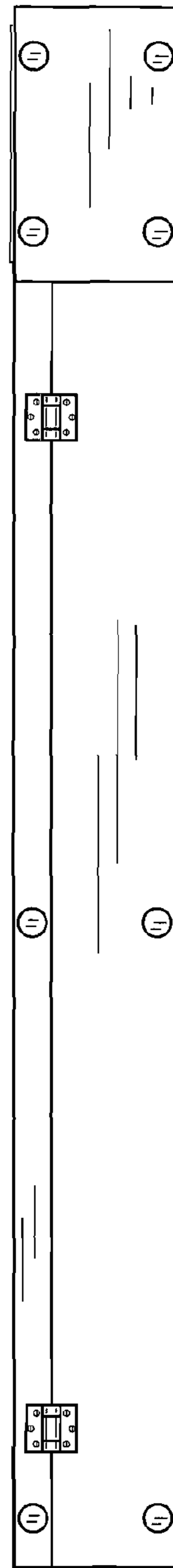

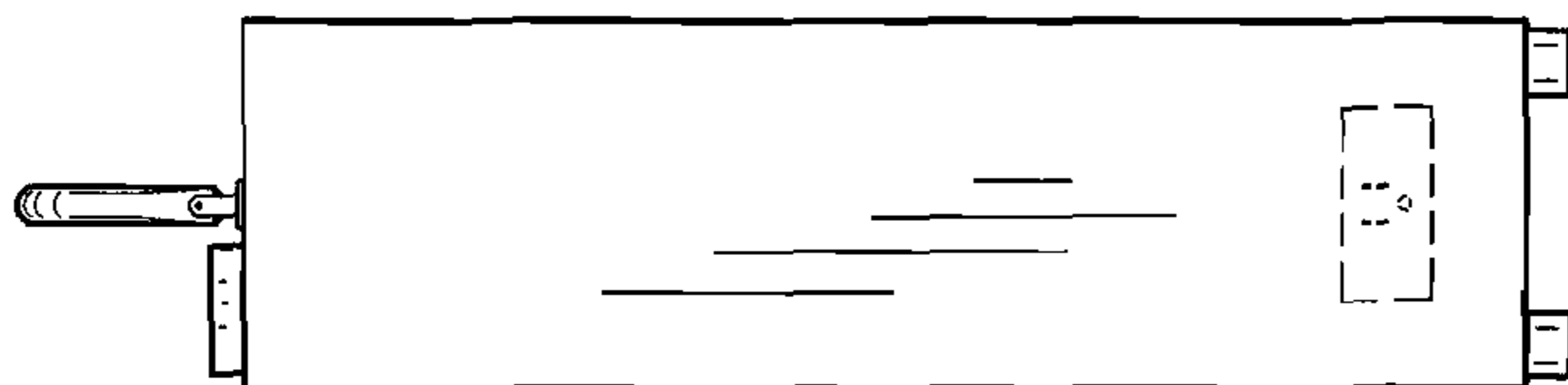
