FIG. 4.is a left side elevational view thereof;

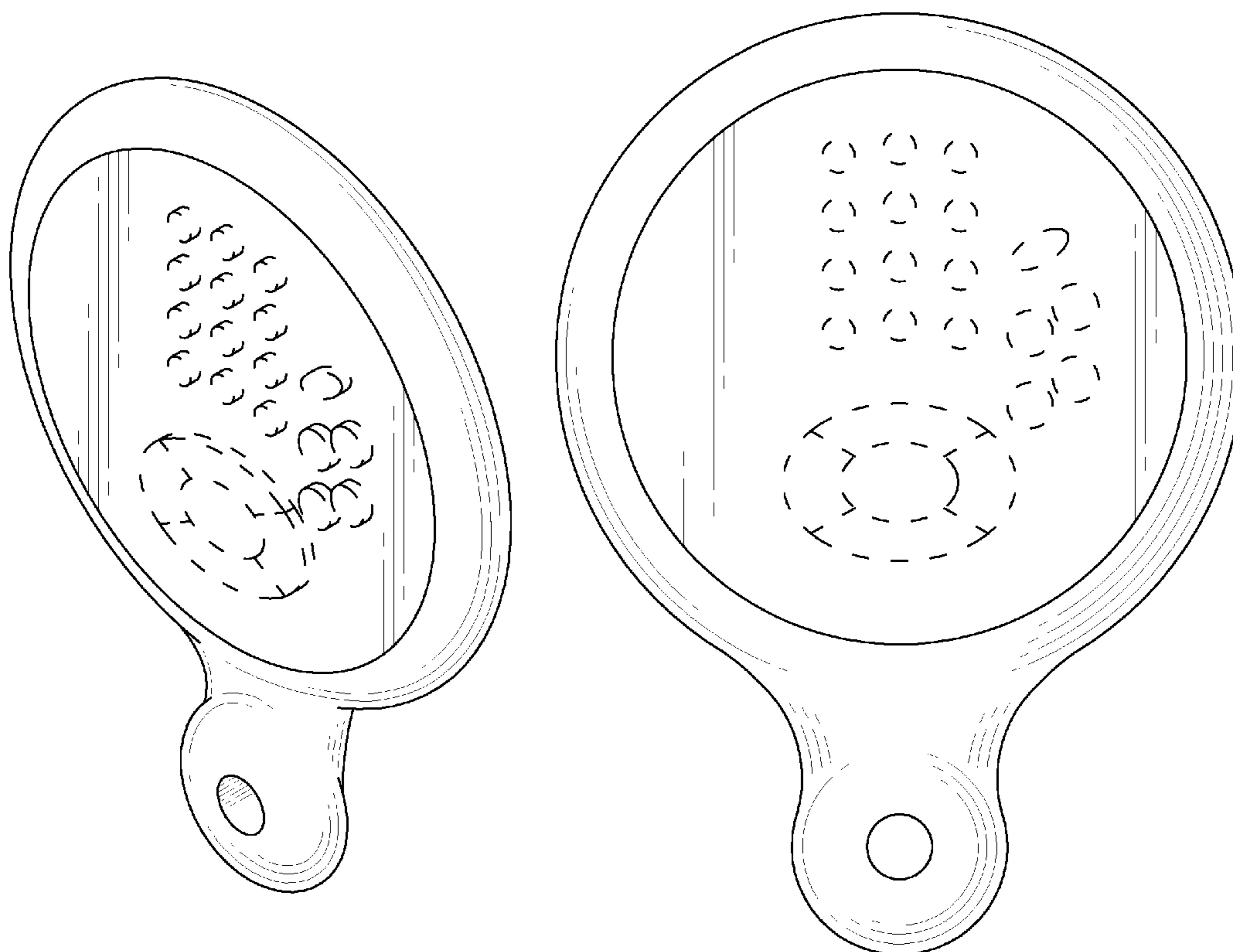
FIG. 5.is a right side elevational view thereof;

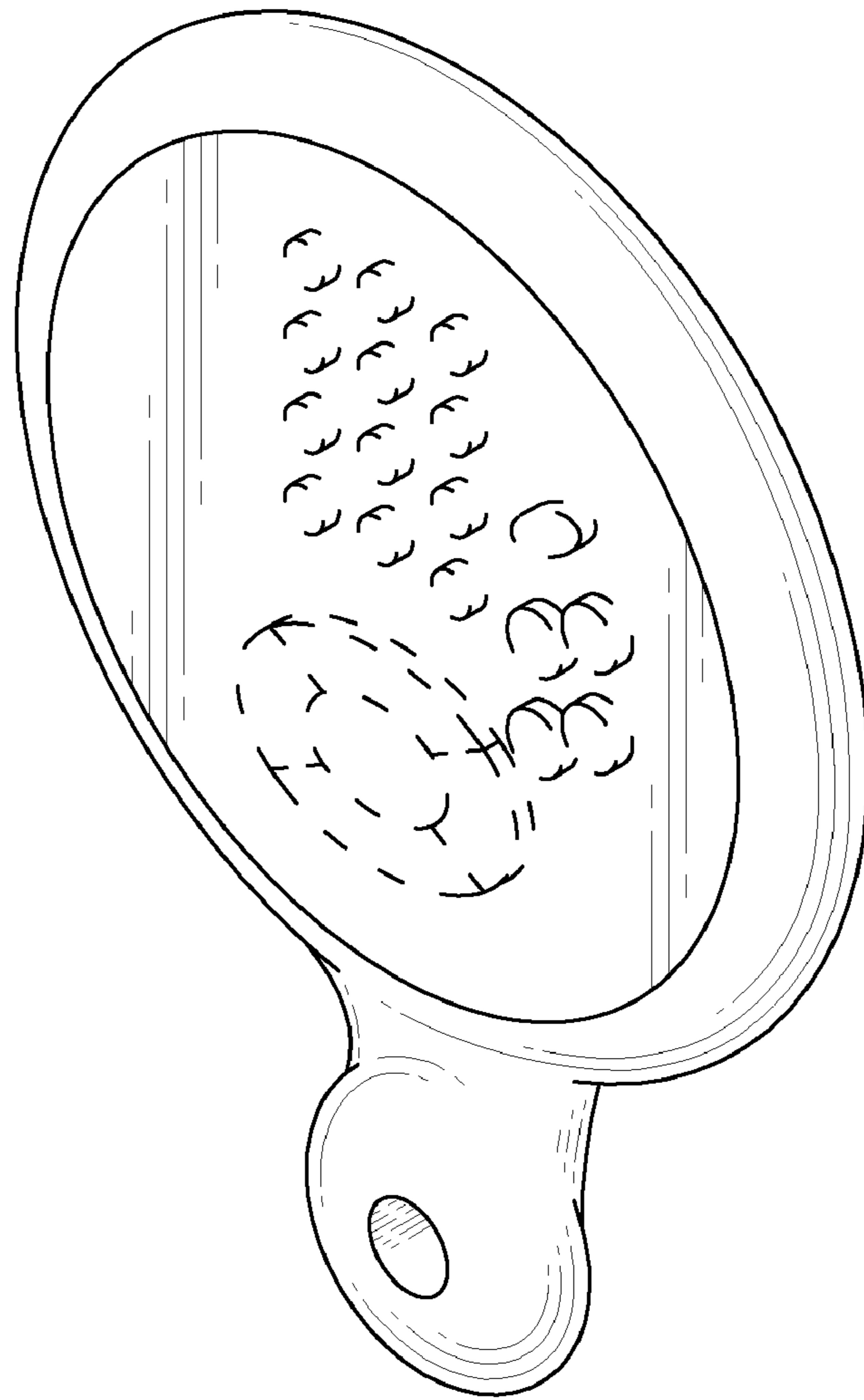

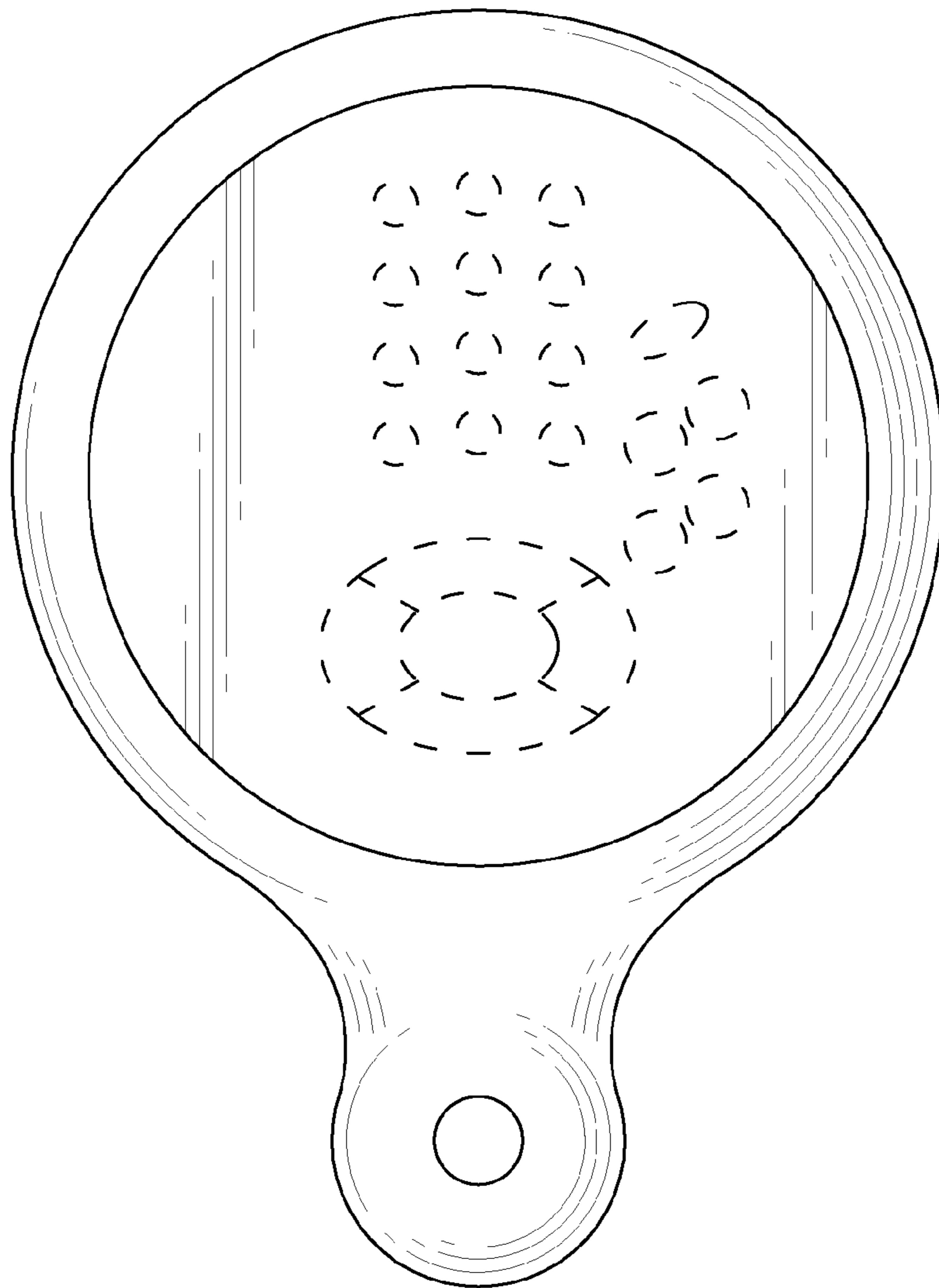

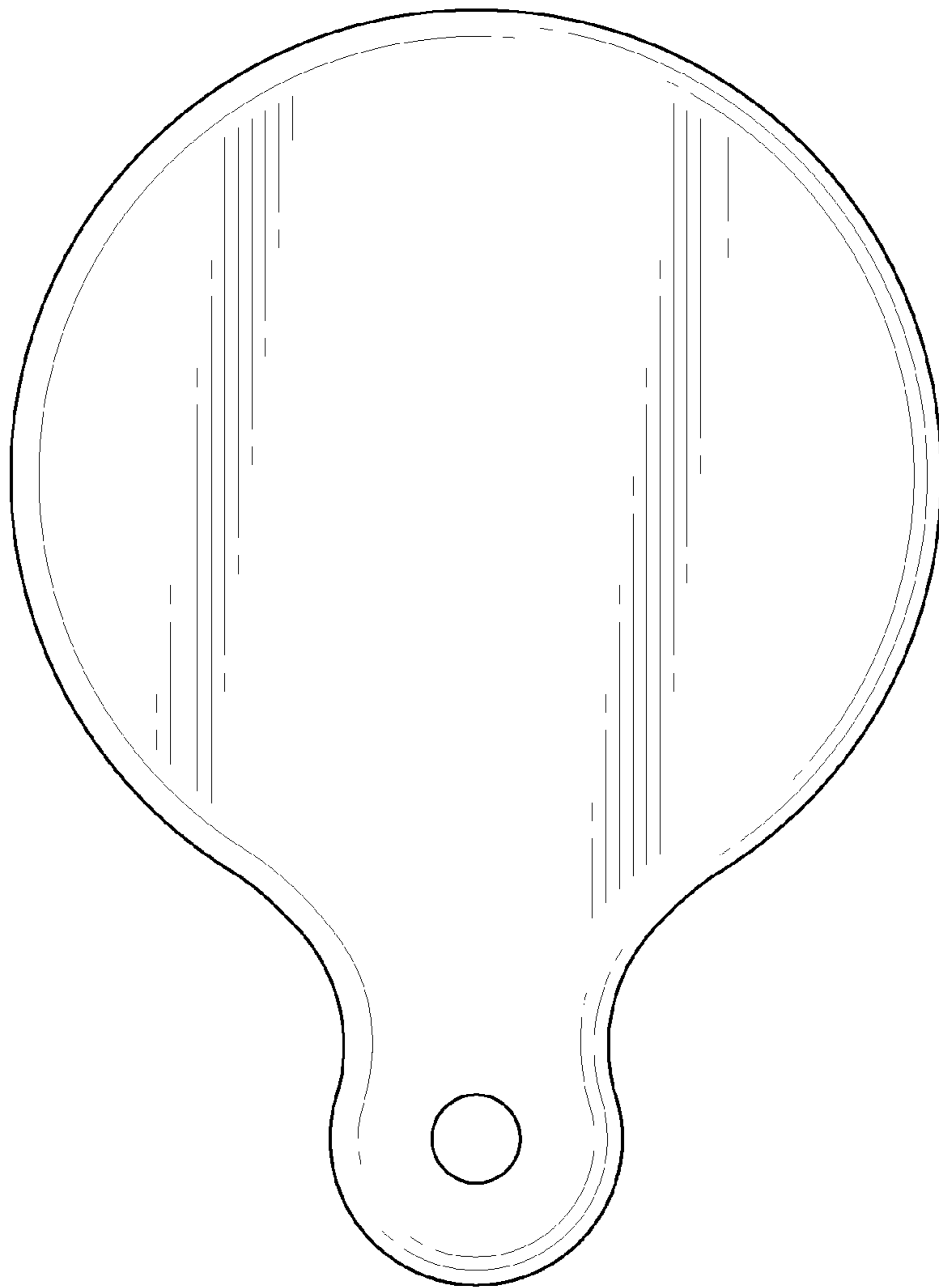

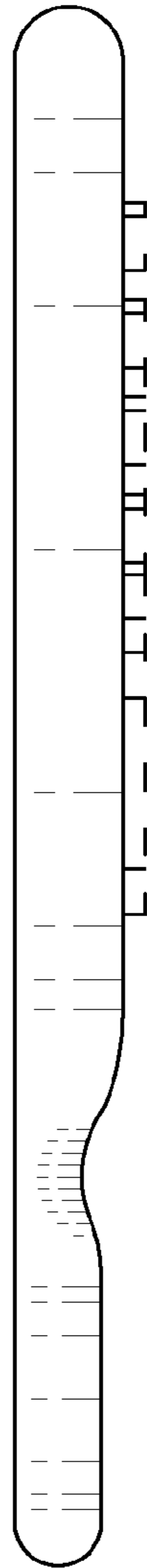

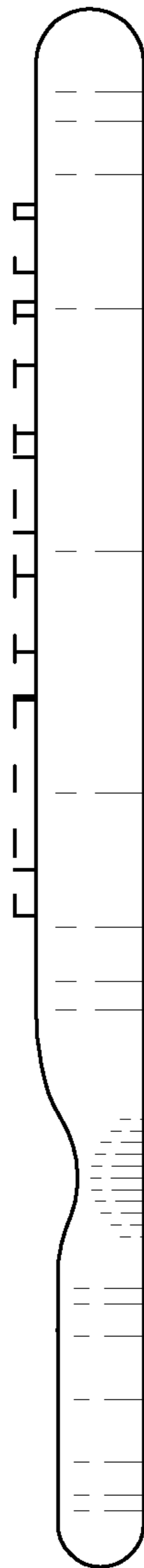

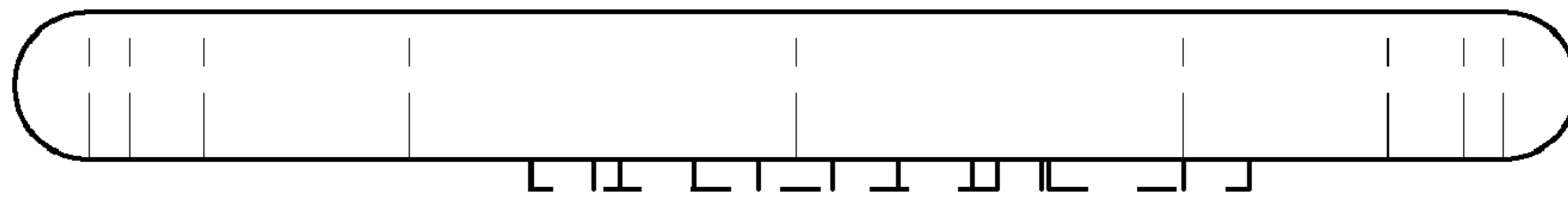

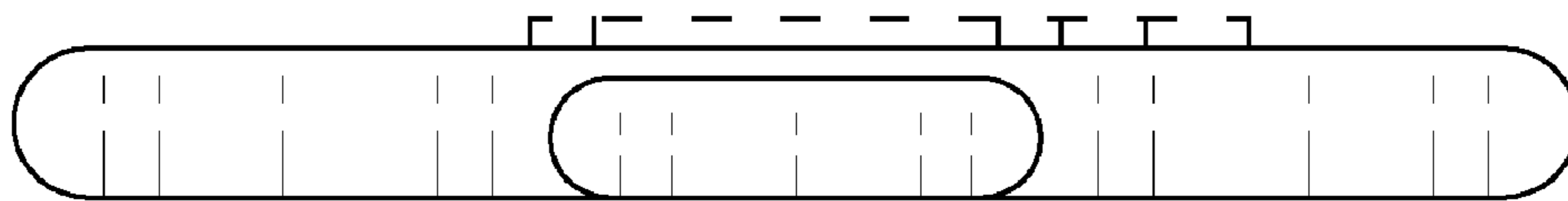
