FIG. 4 is a front elevational view of the card reader;

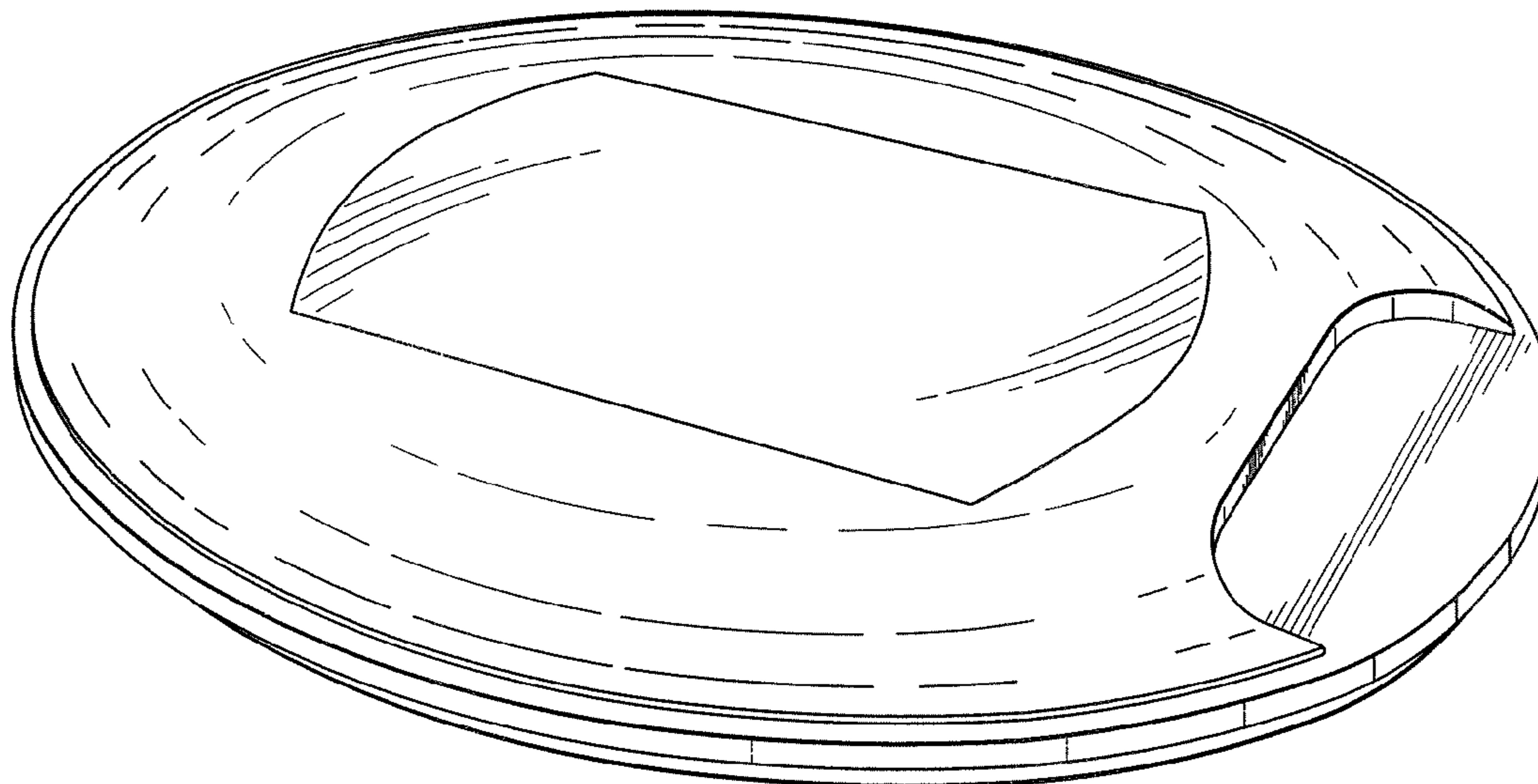
FIG. 5 is a rear elevational view of the card reader;

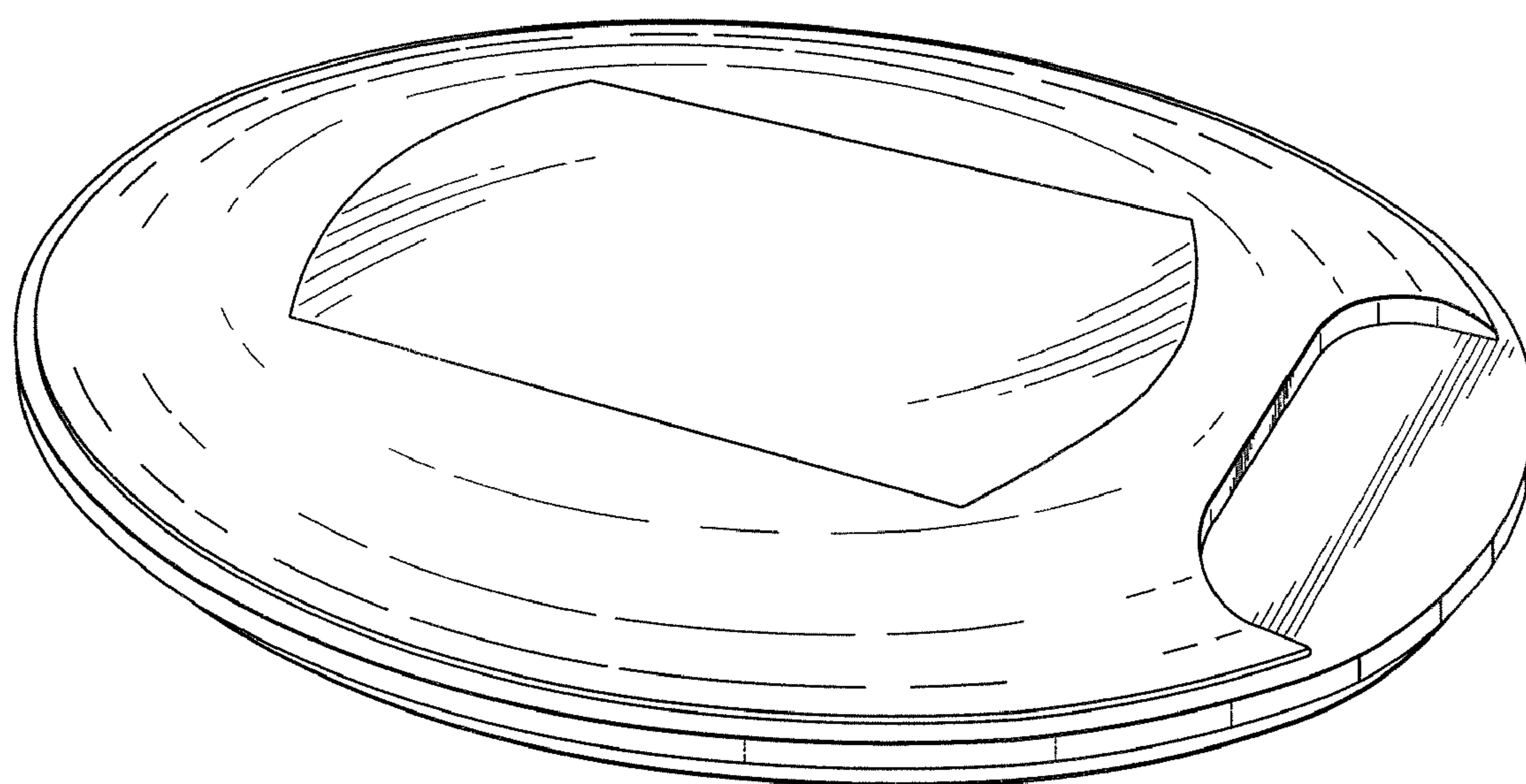

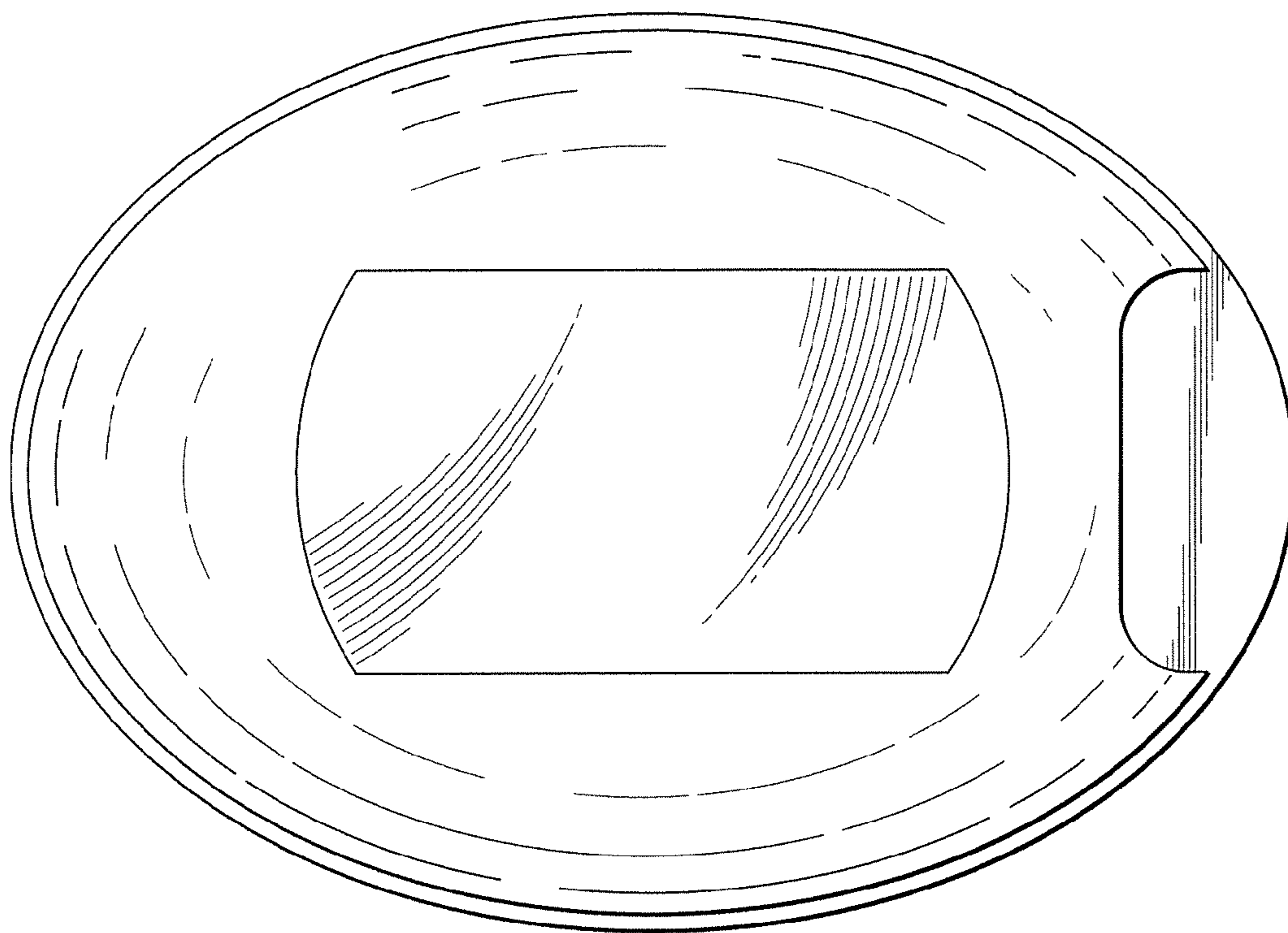

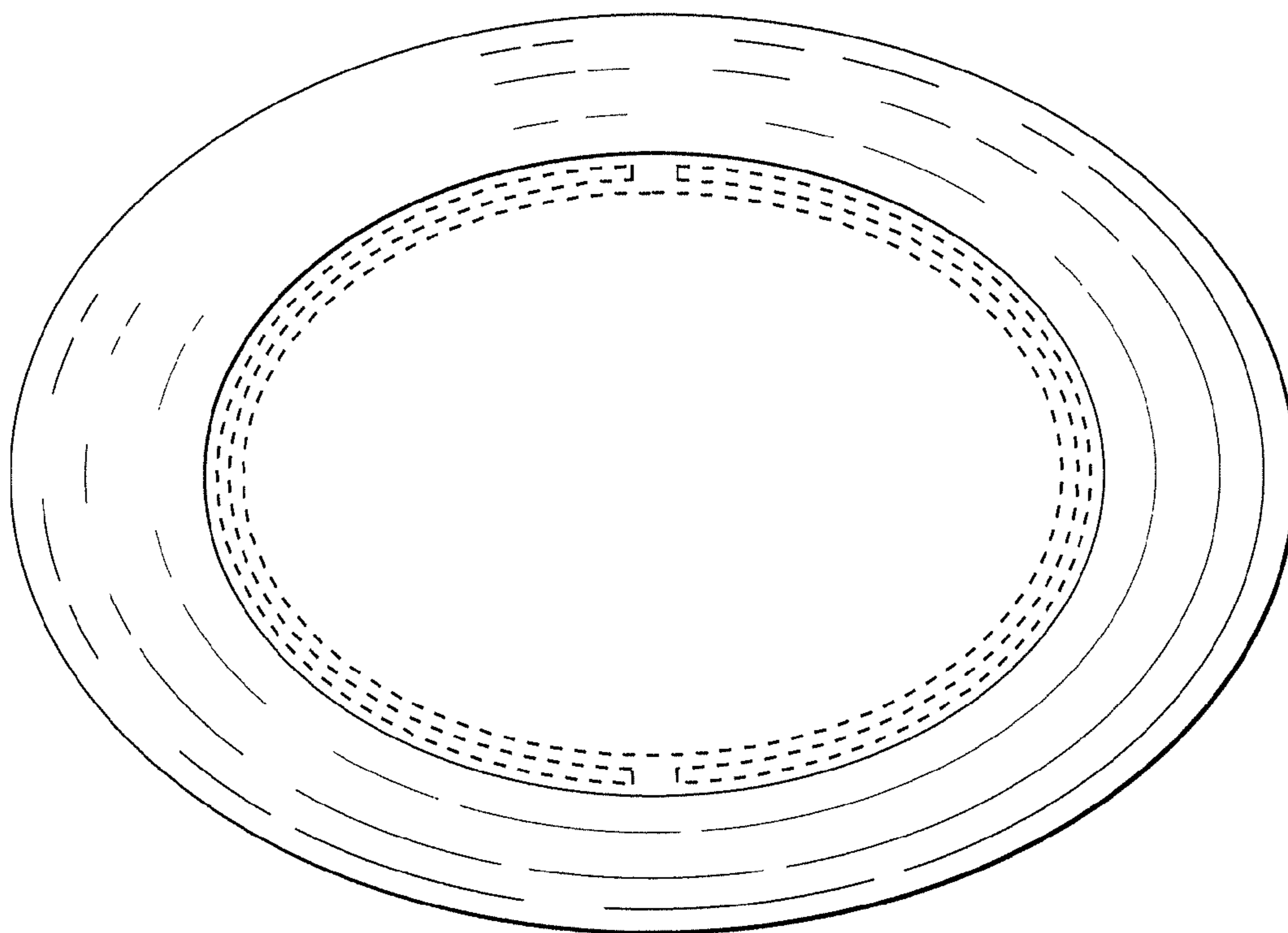

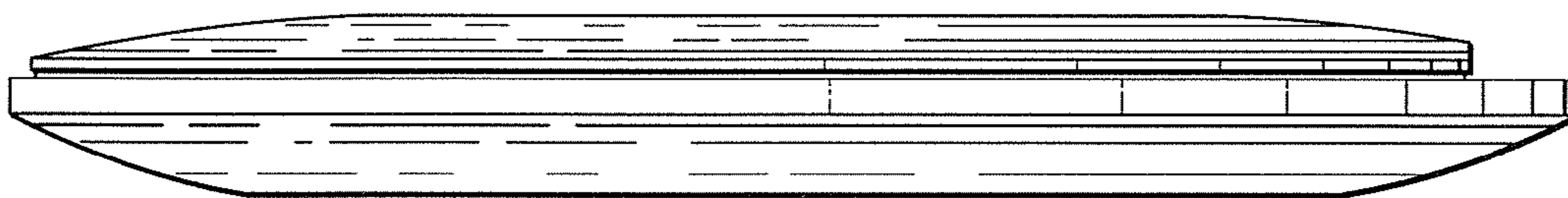

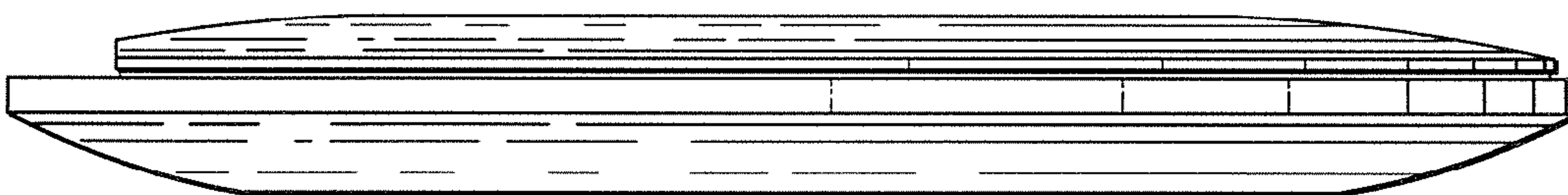

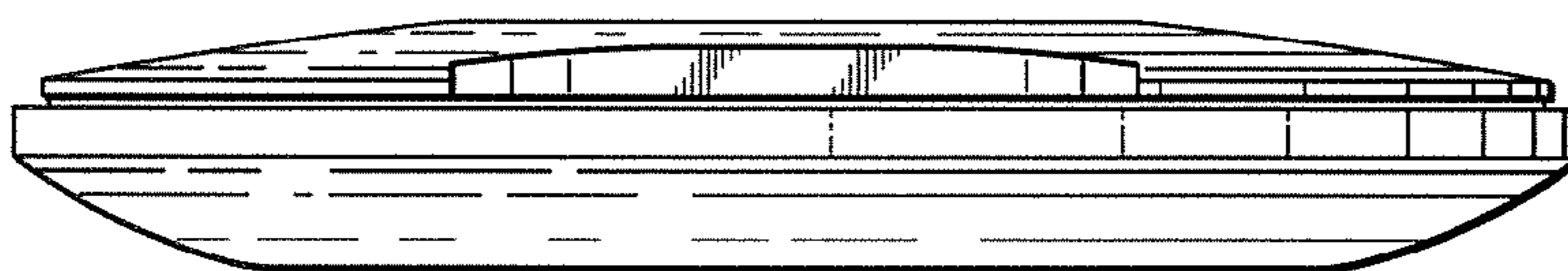

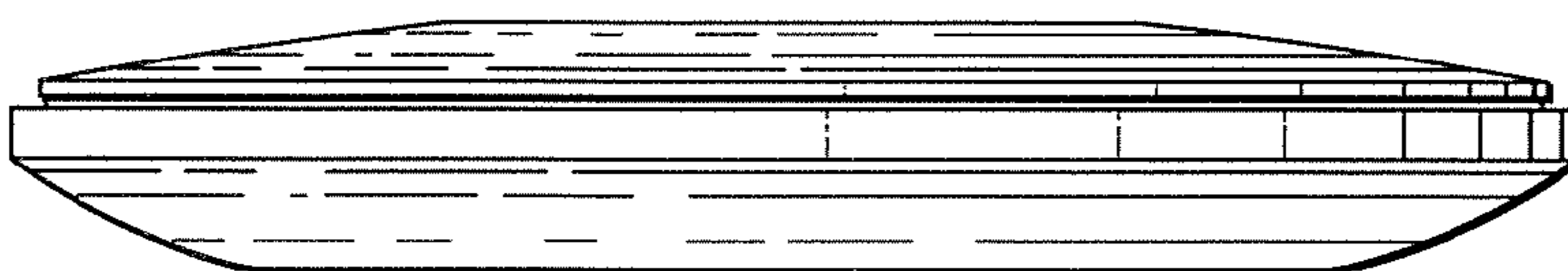
