(57) **CLAIM**

The ornamental designs for a water sports board, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an embodiment of a water sports board according to the present designs;

FIG. 2 is a bottom perspective view of the embodiment of FIG. 1;

FIG. 3 is a top-plan view of the embodiment of FIG. 1;

FIG. 4 is a bottom-plan view of the embodiment of FIG. 1;

FIG. 5 is a right-side elevational view of the embodiment of FIG. 1;

FIG. 6 is a front elevational view of the embodiment of FIG. 1;

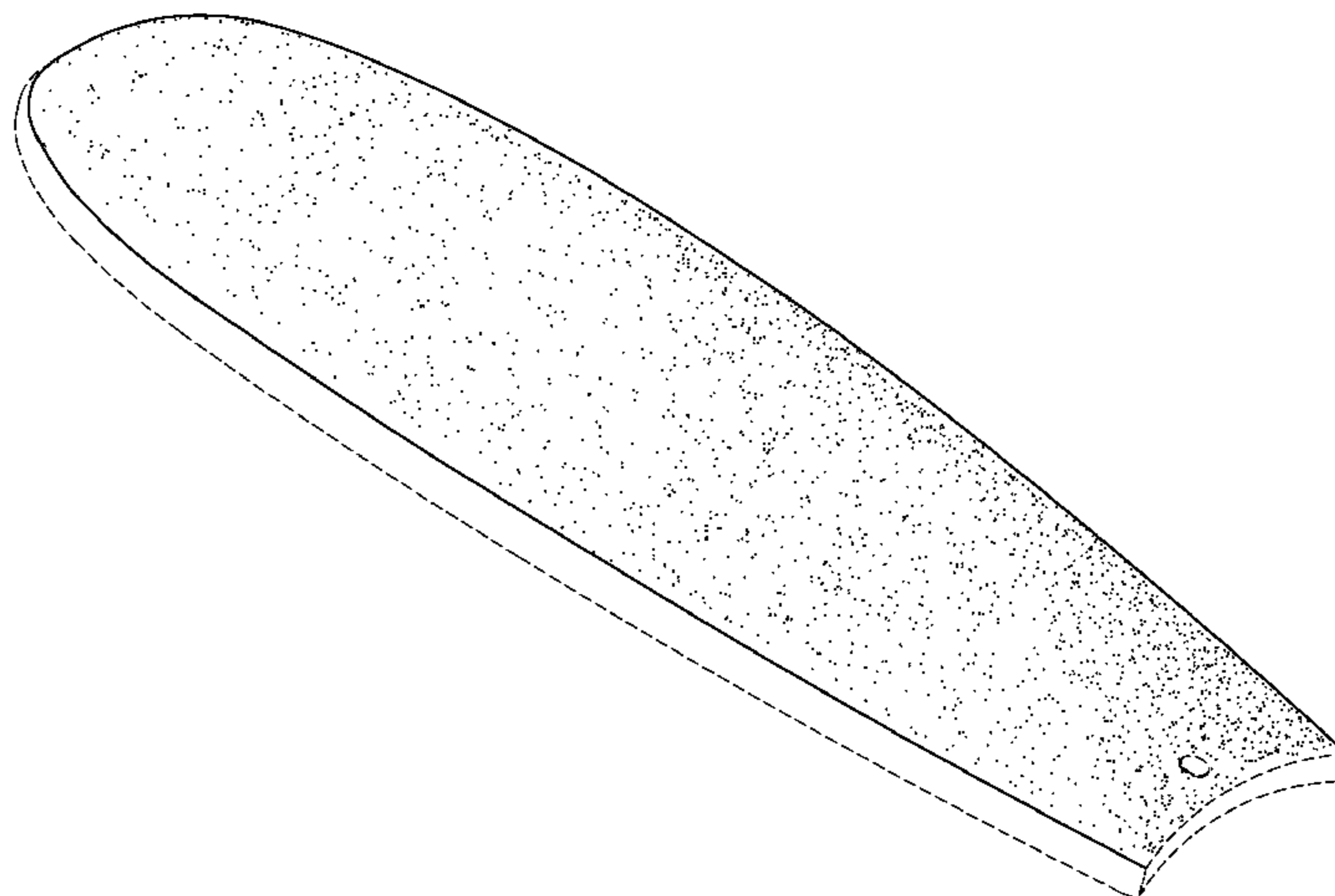
FIG. 7 is a rear elevational view of the embodiment of FIG. 1;

FIG. 8 is a cross-sectional view of FIG. 3 taken through line 8—8 of the embodiment of FIG. 1; and,

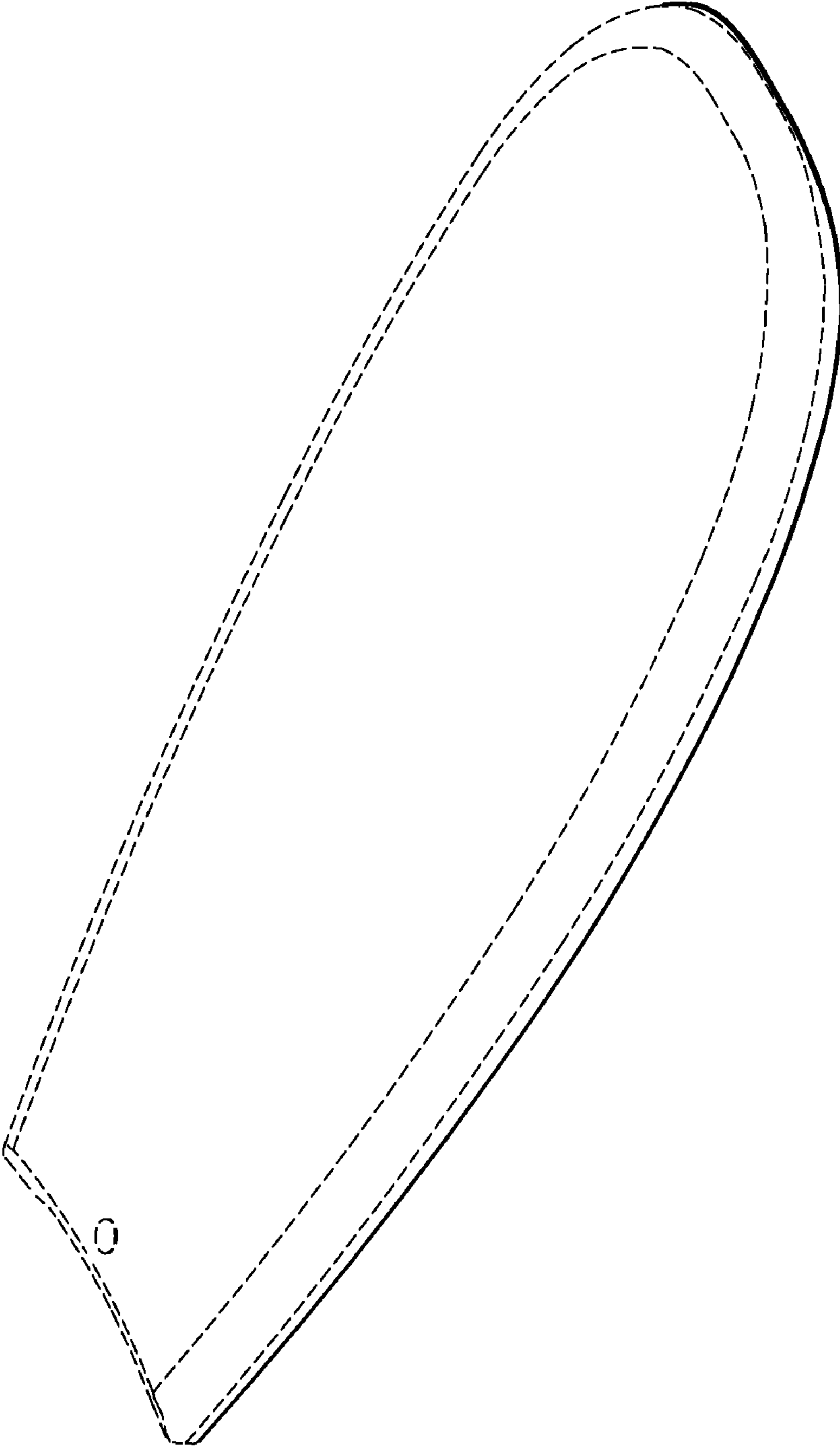

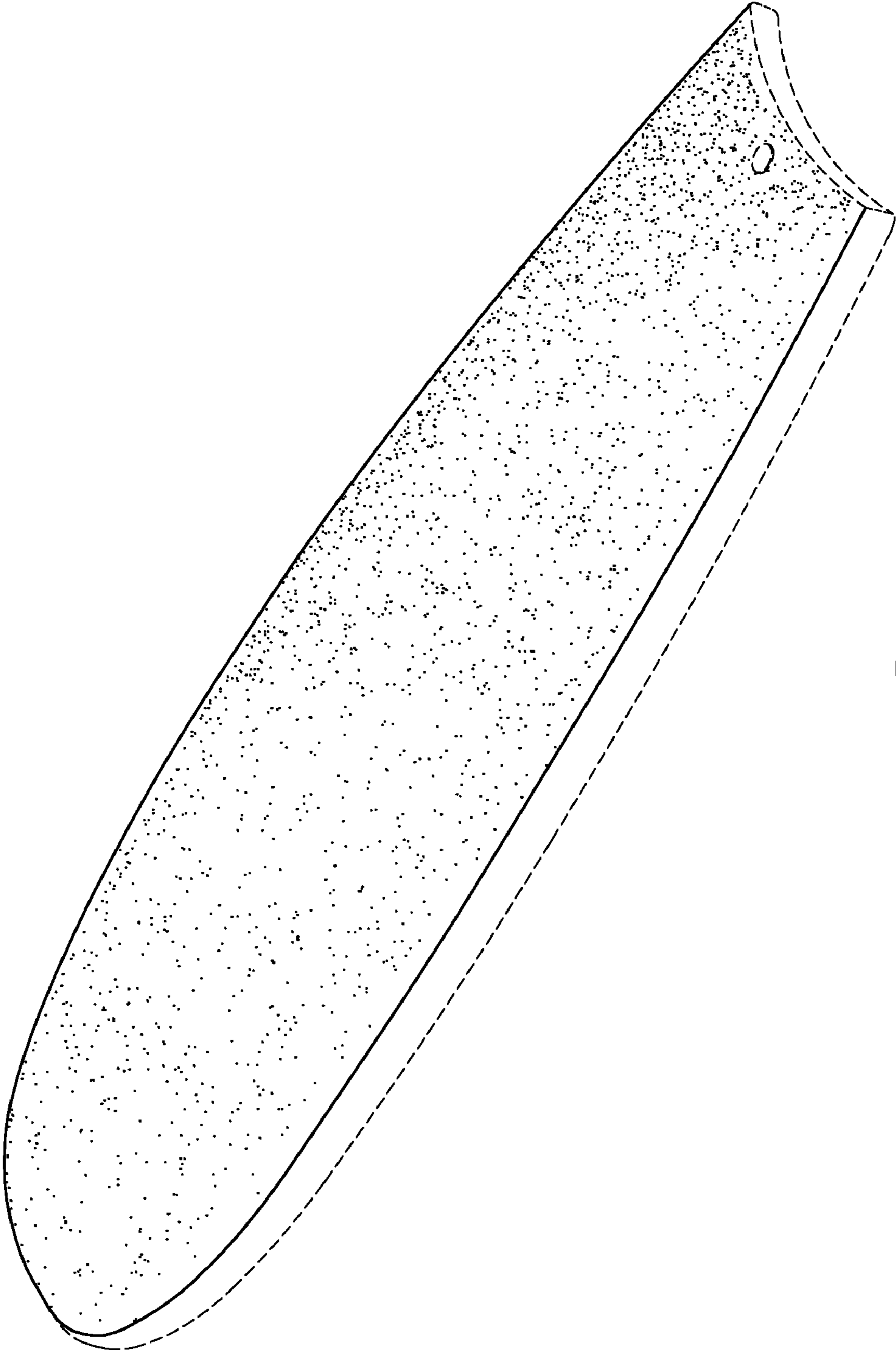

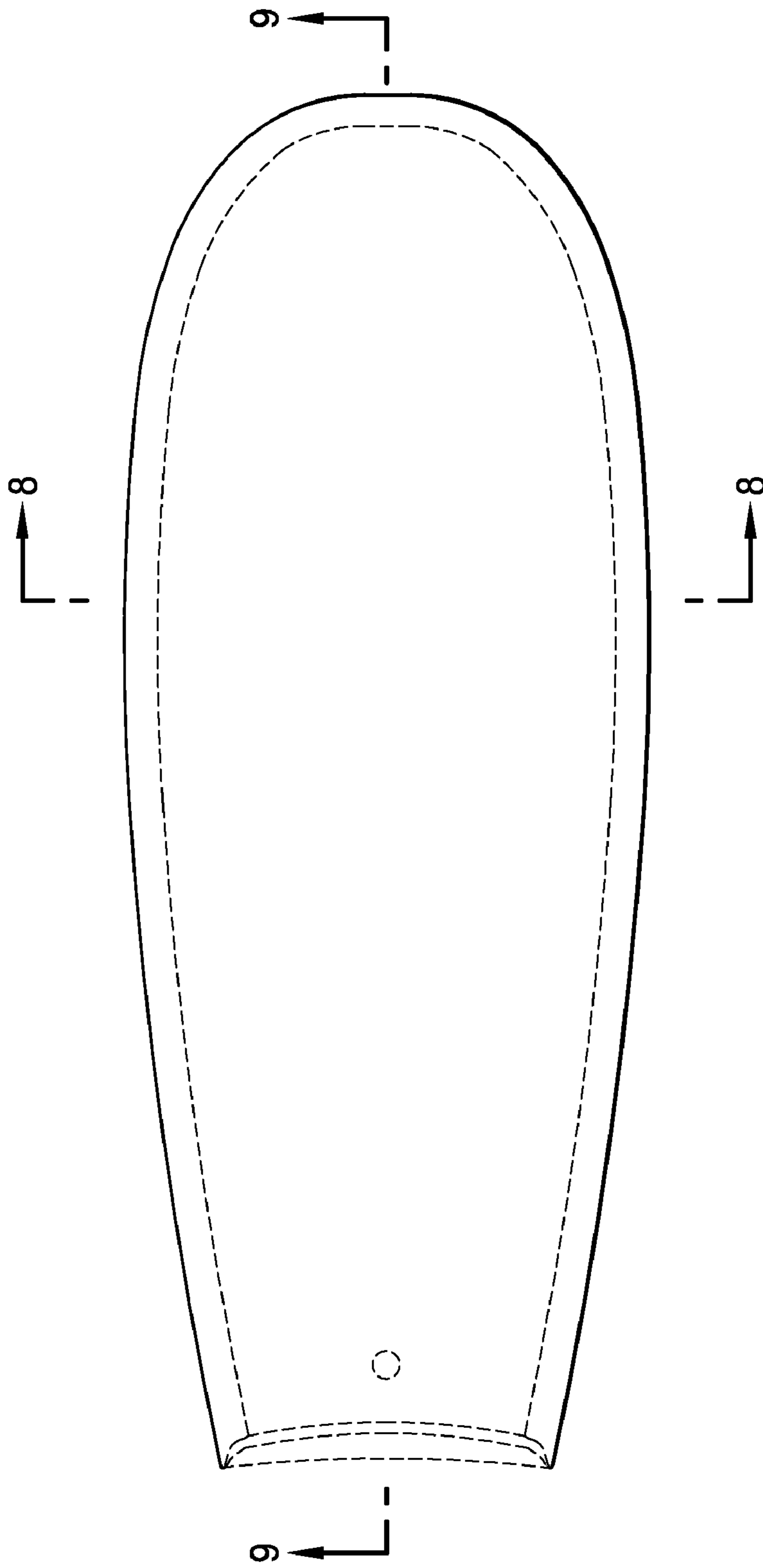

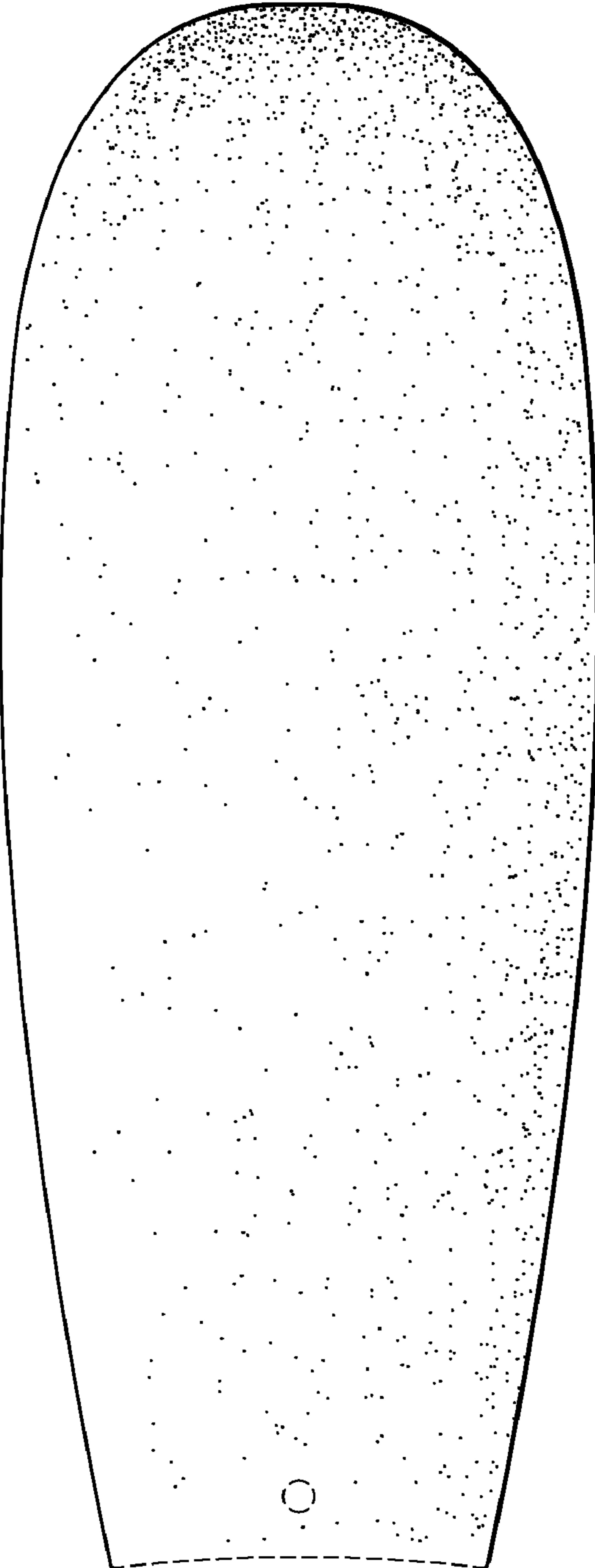

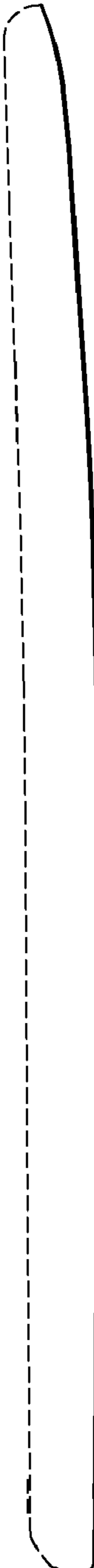

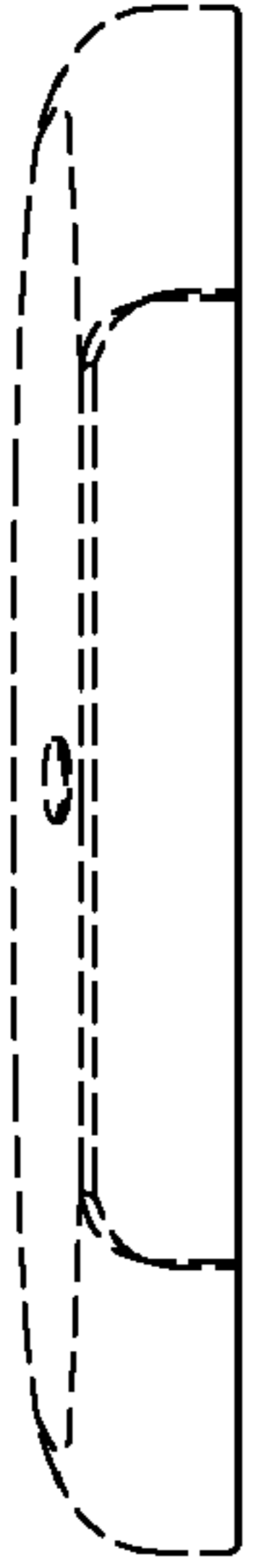

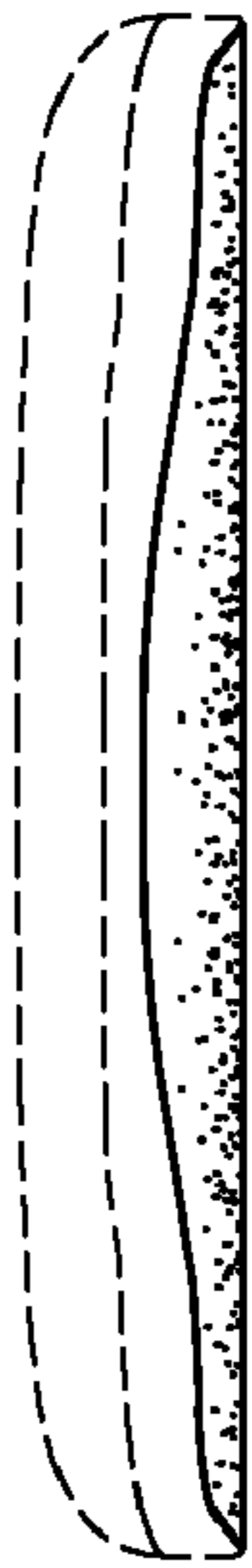

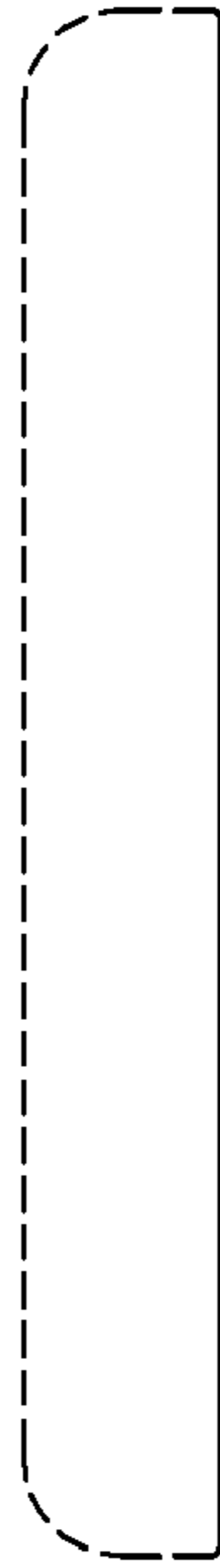

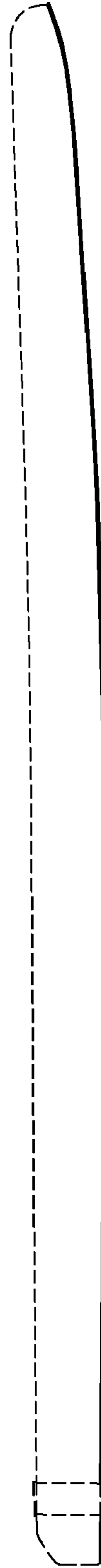
