The ornamental design for a protective head guard cap insert,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a protective head guard cap insert showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side view thereof (the right side view being a mirror image of the left side view);  
FIG. 5 is a top view thereof; and,  
FIG. 6 is a bottom view thereof.

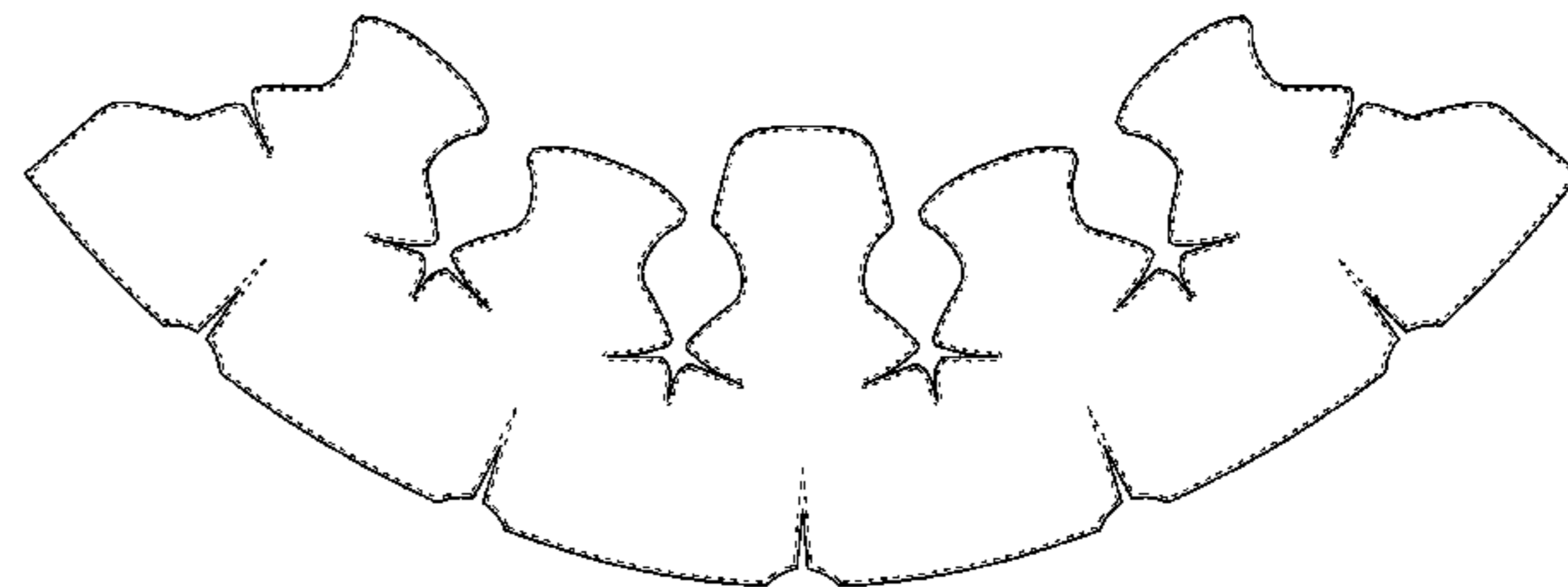
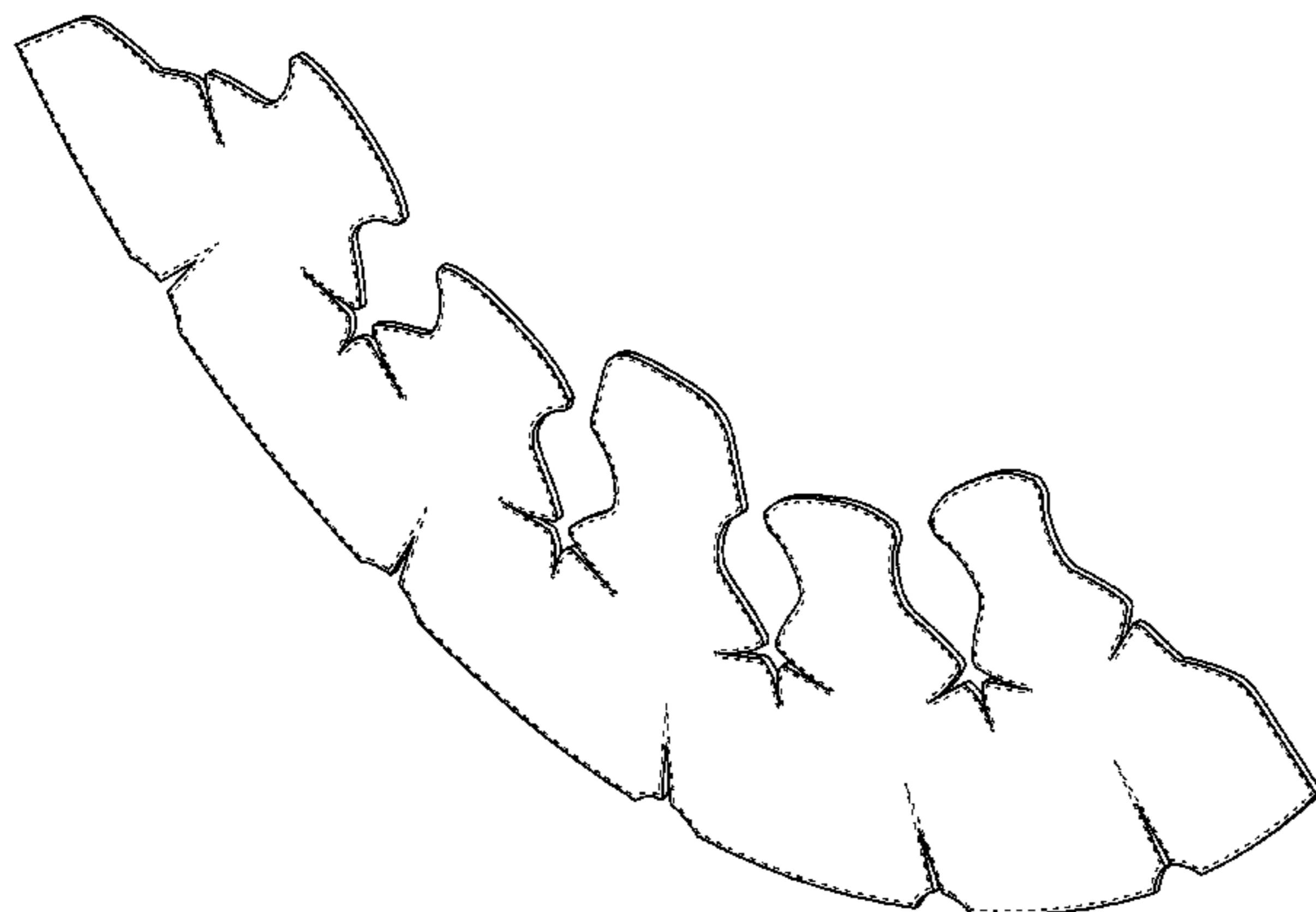

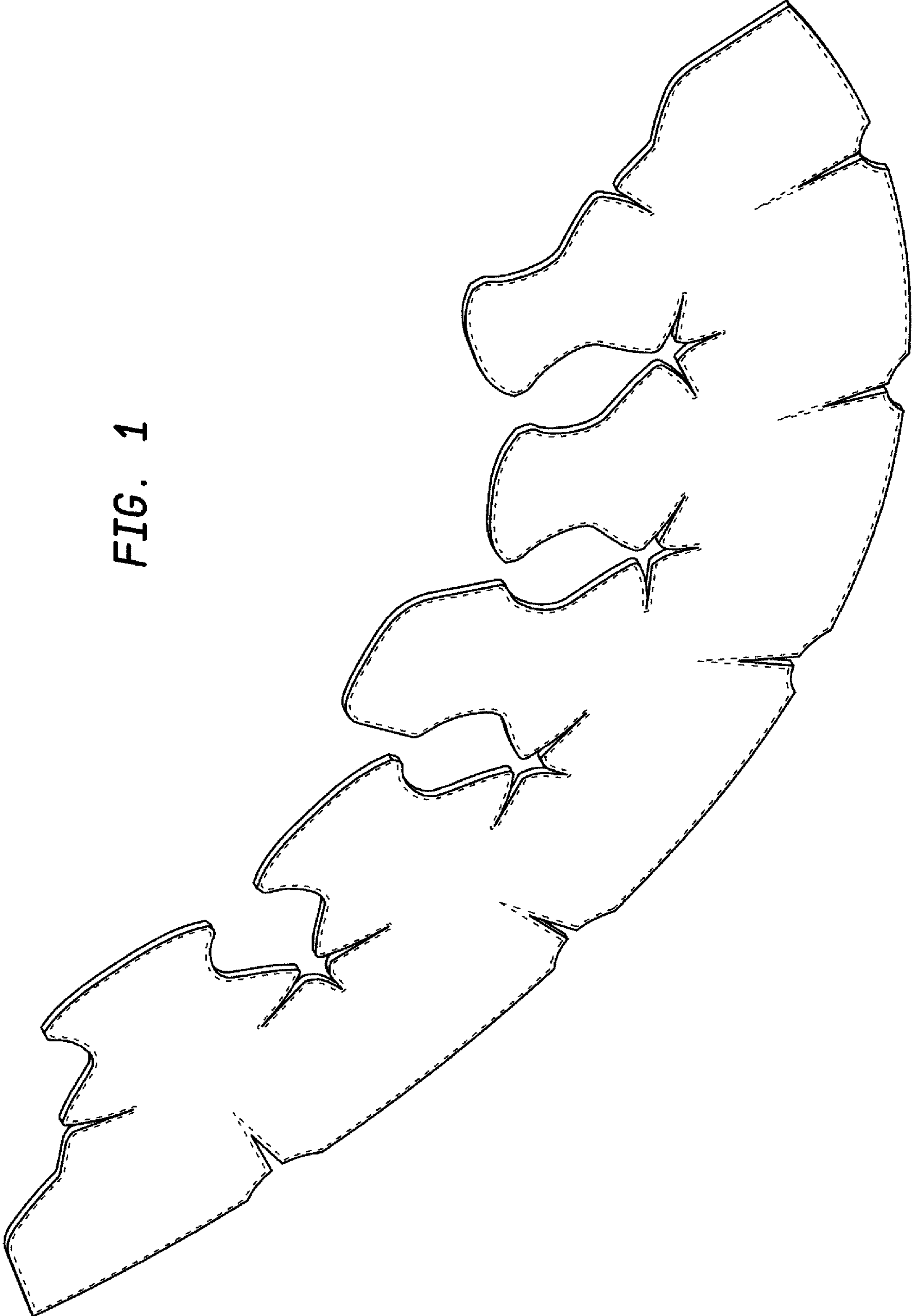

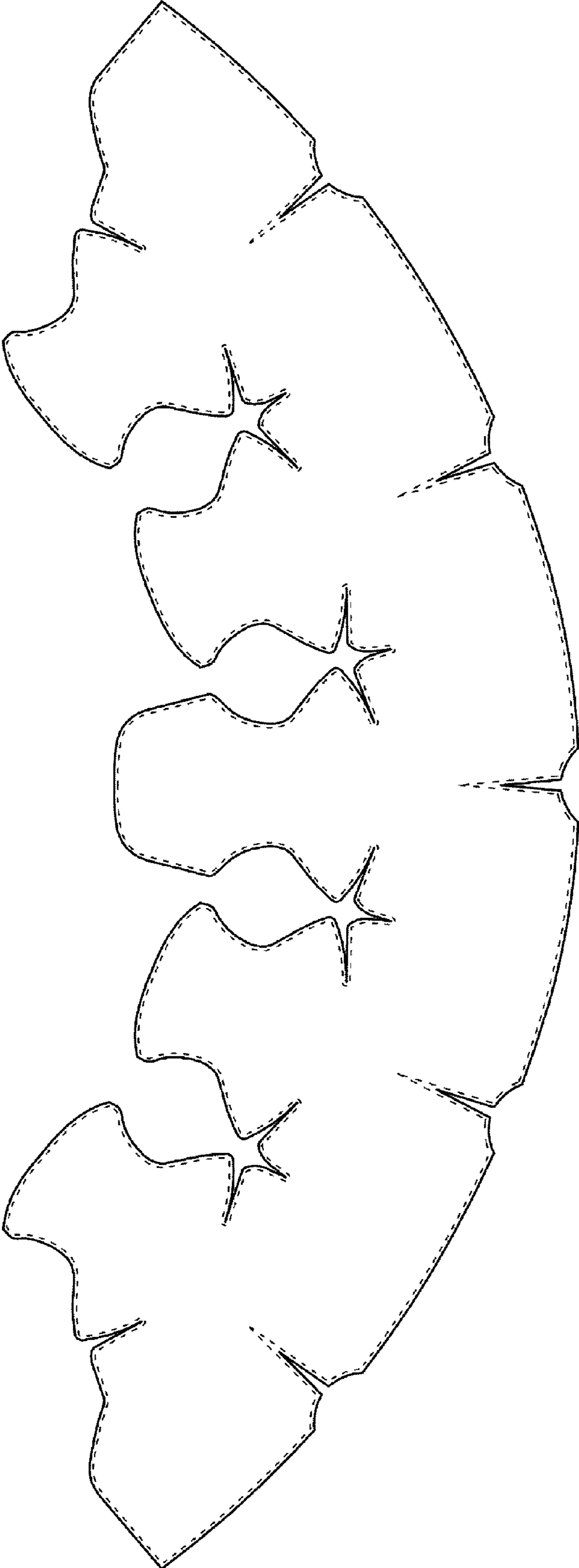

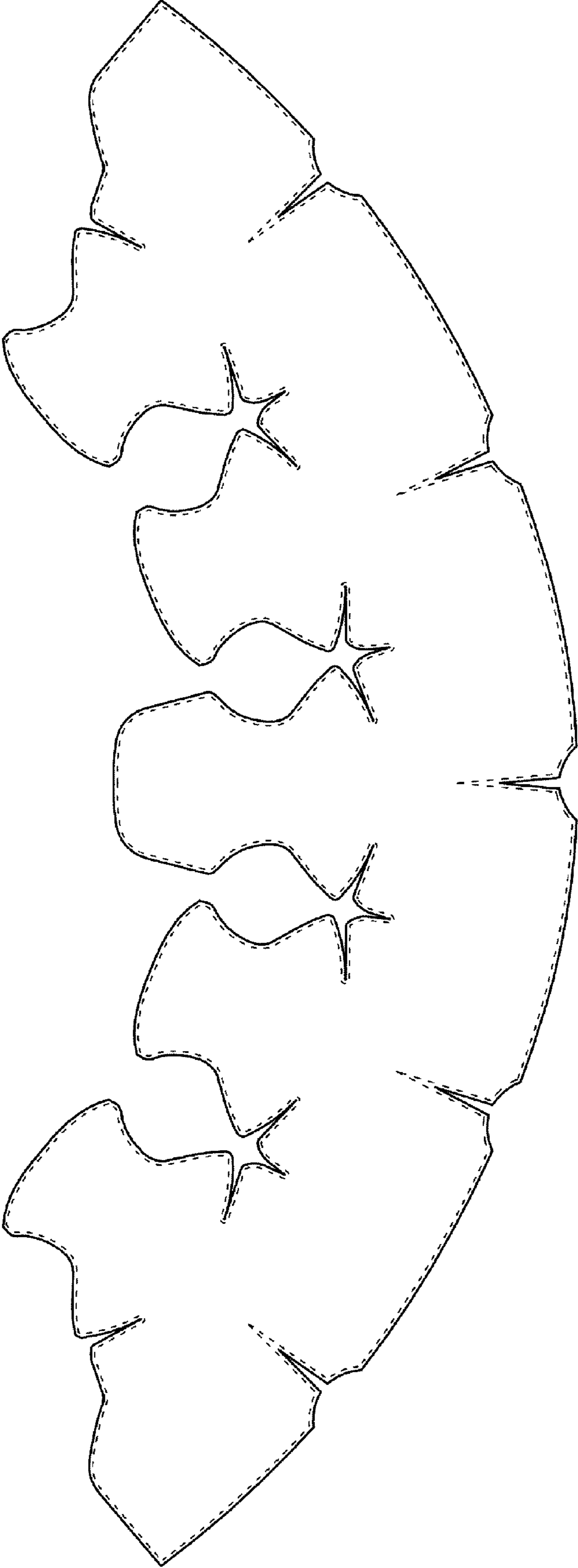

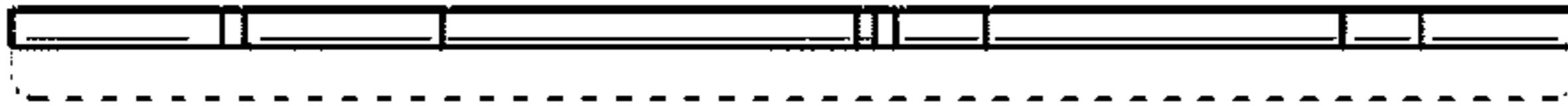
