DESCRIPTION

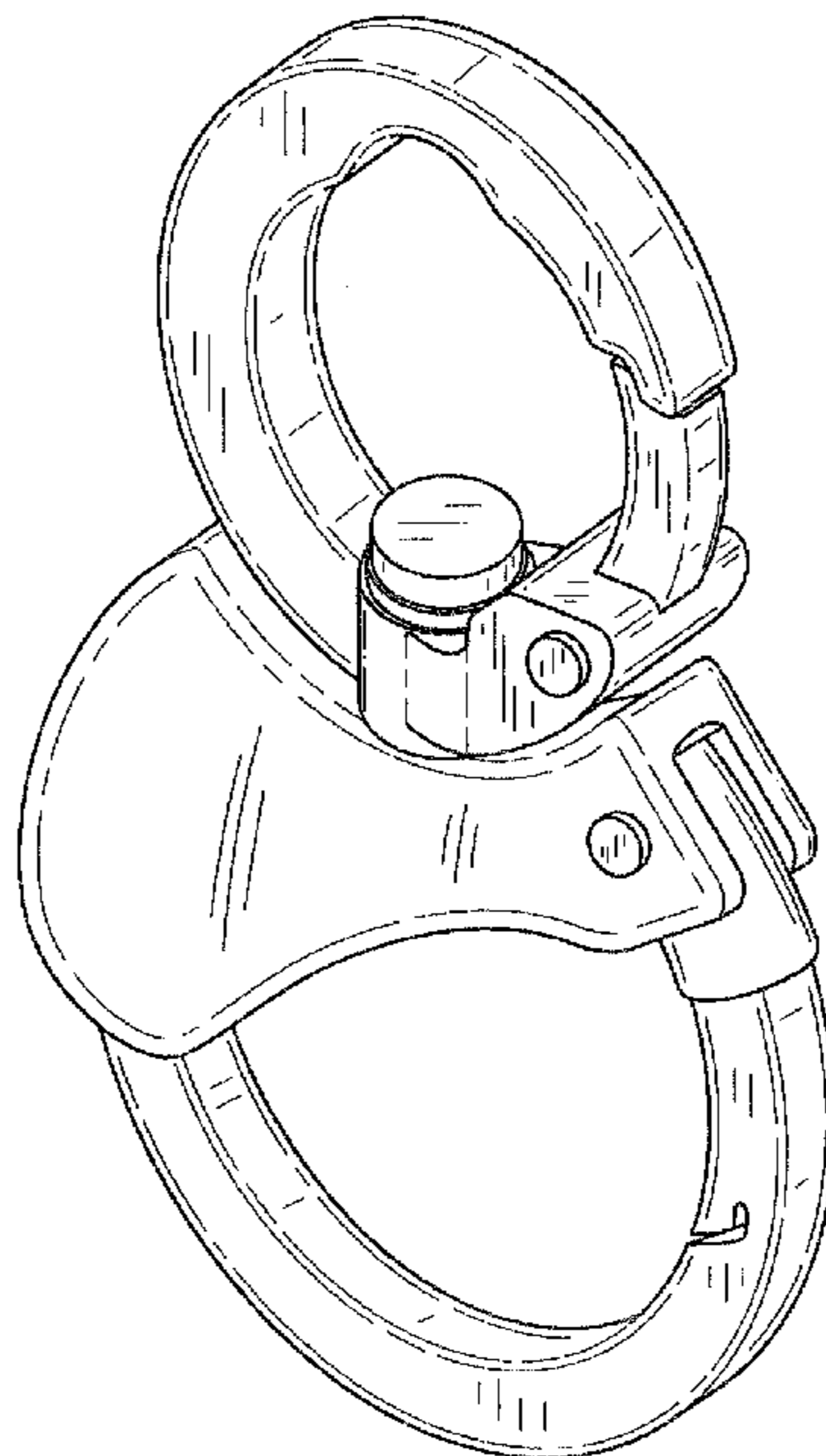
FIG. 1 is a perspective view of a quick change animal tag.

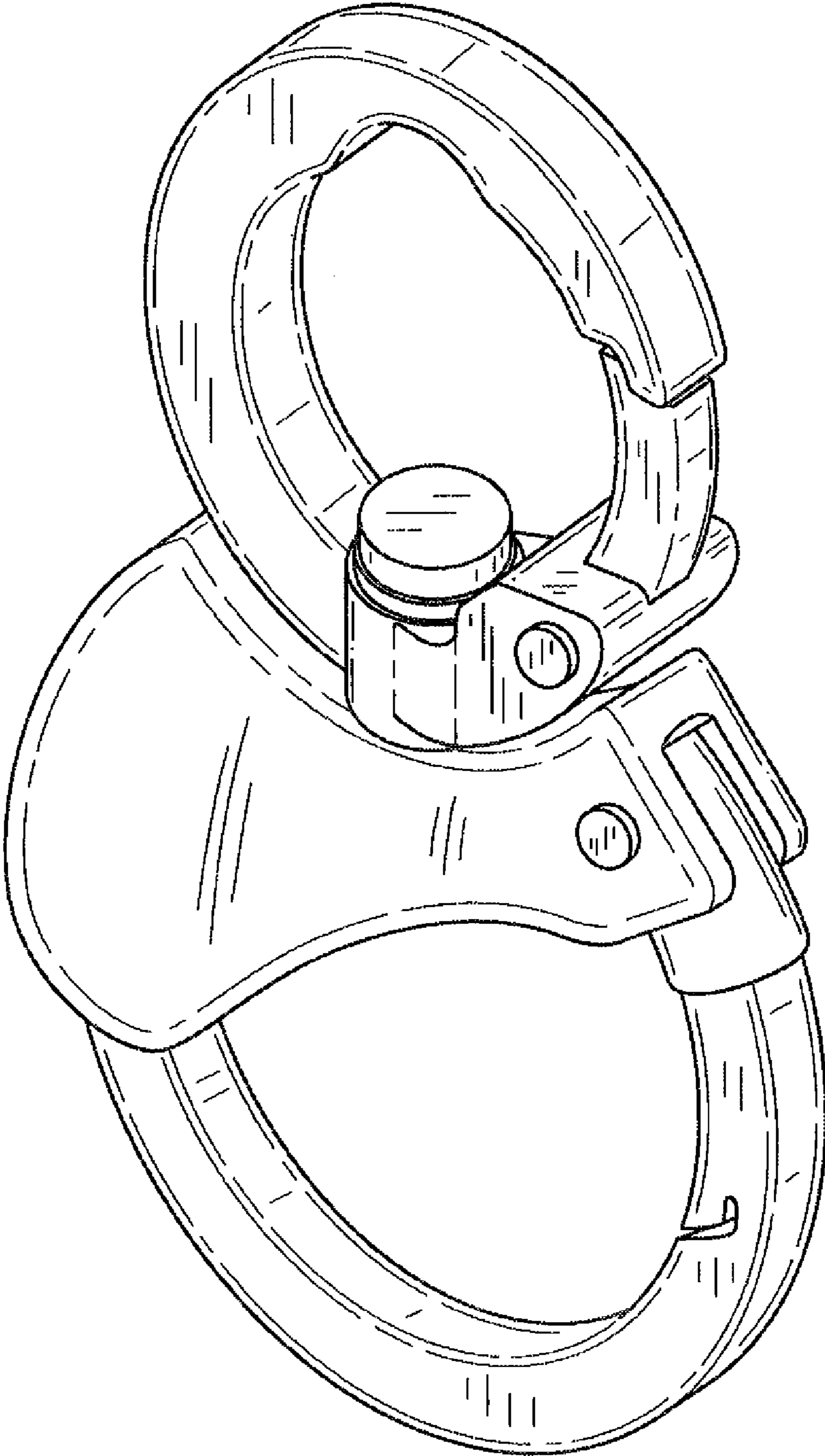

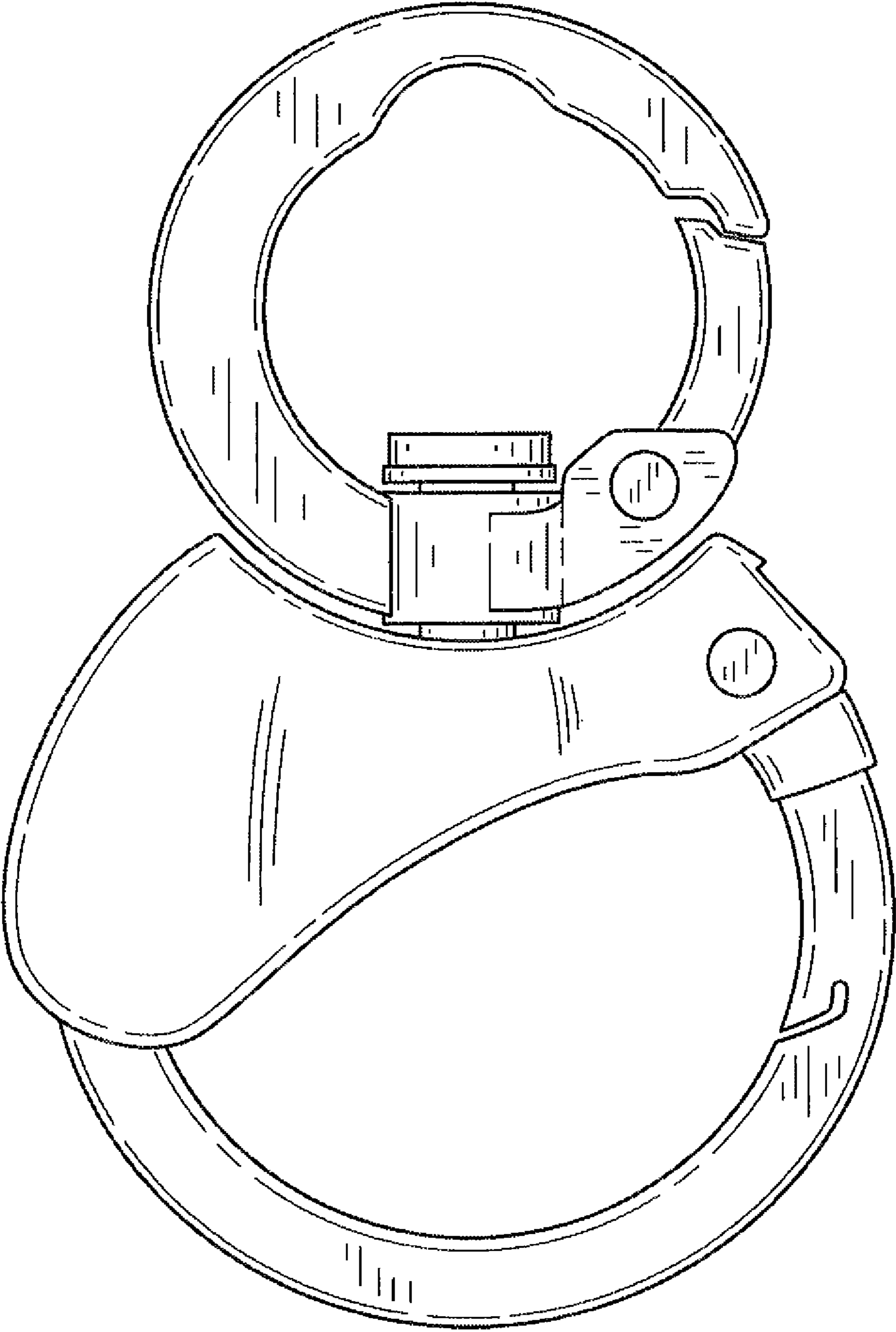

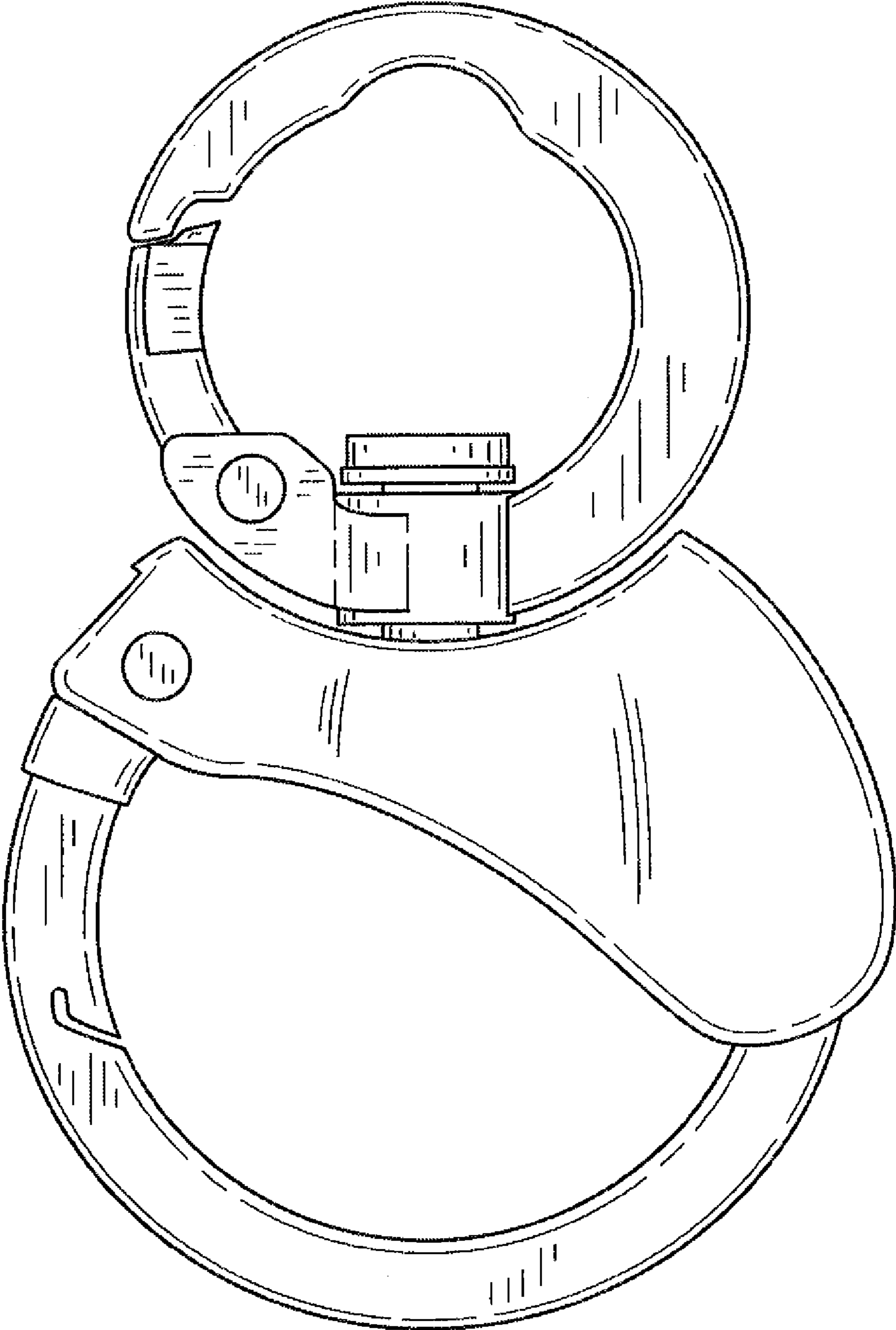

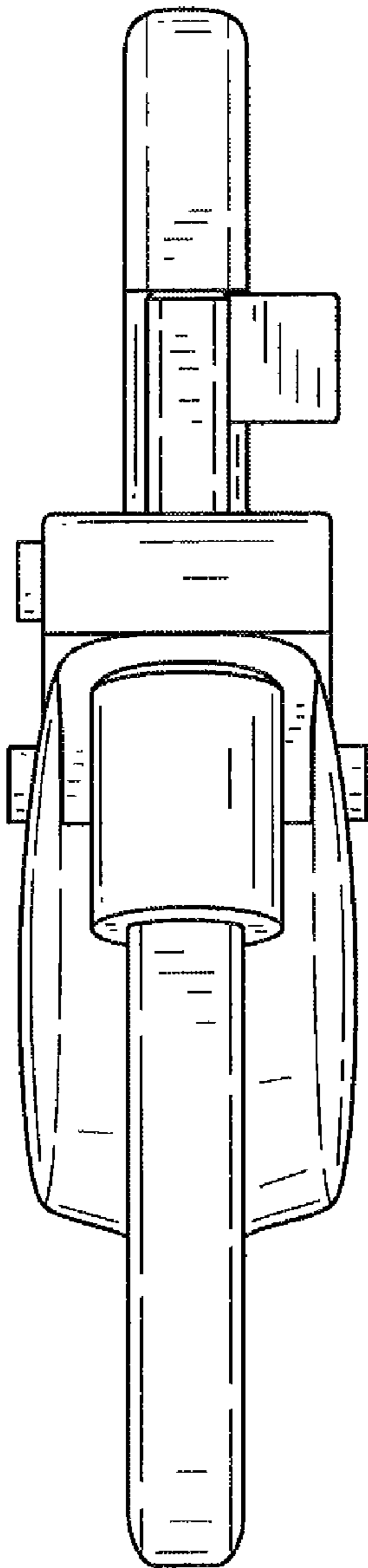

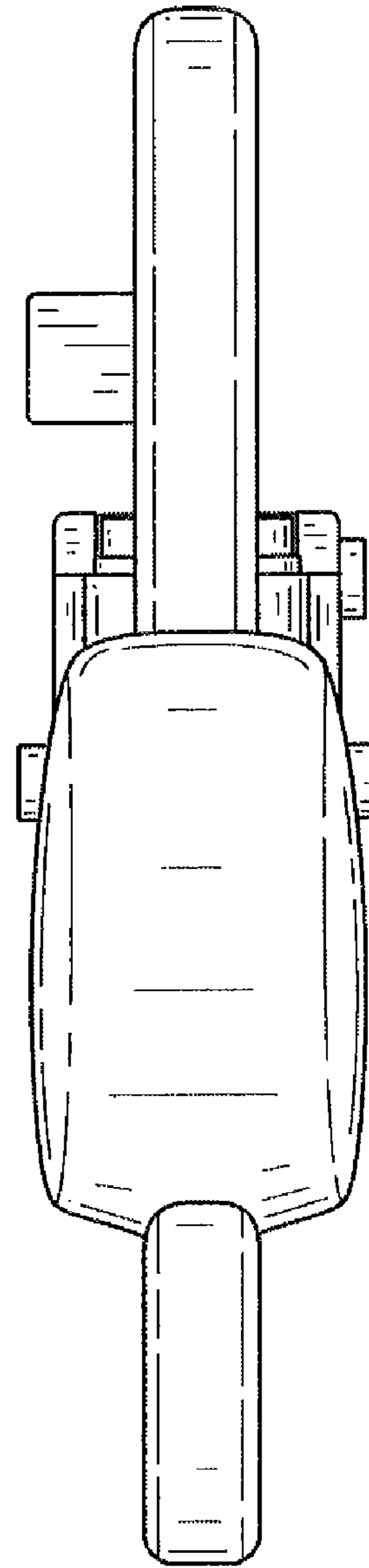

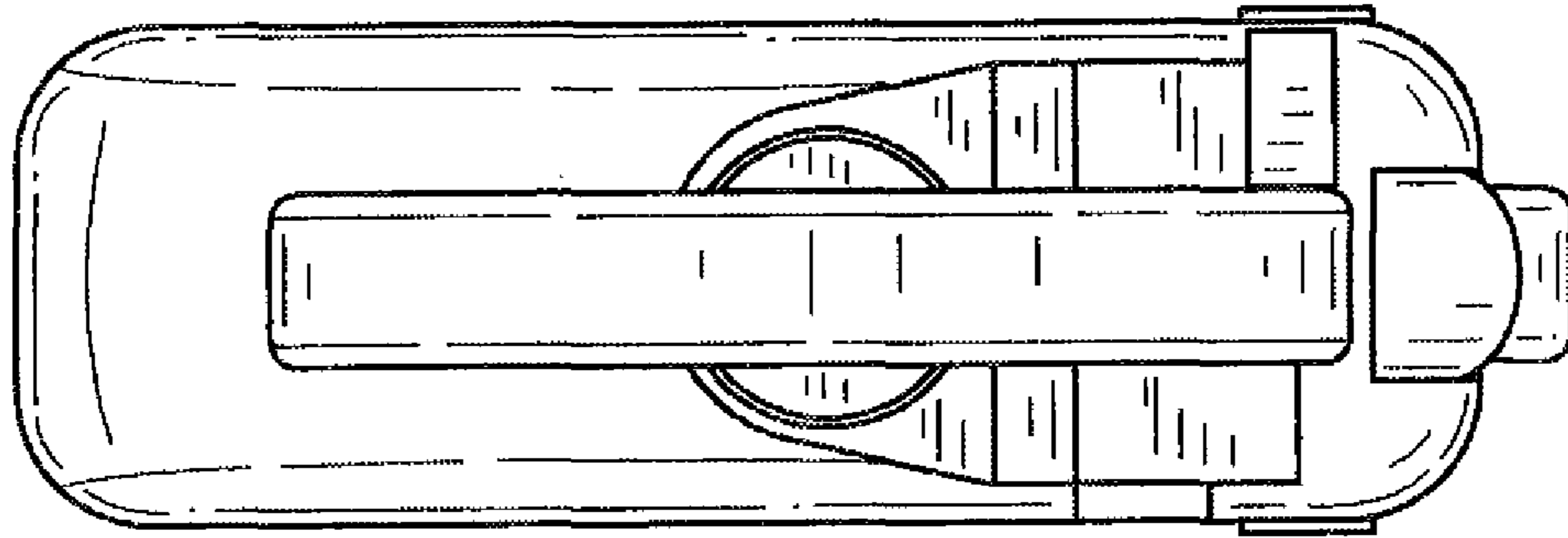

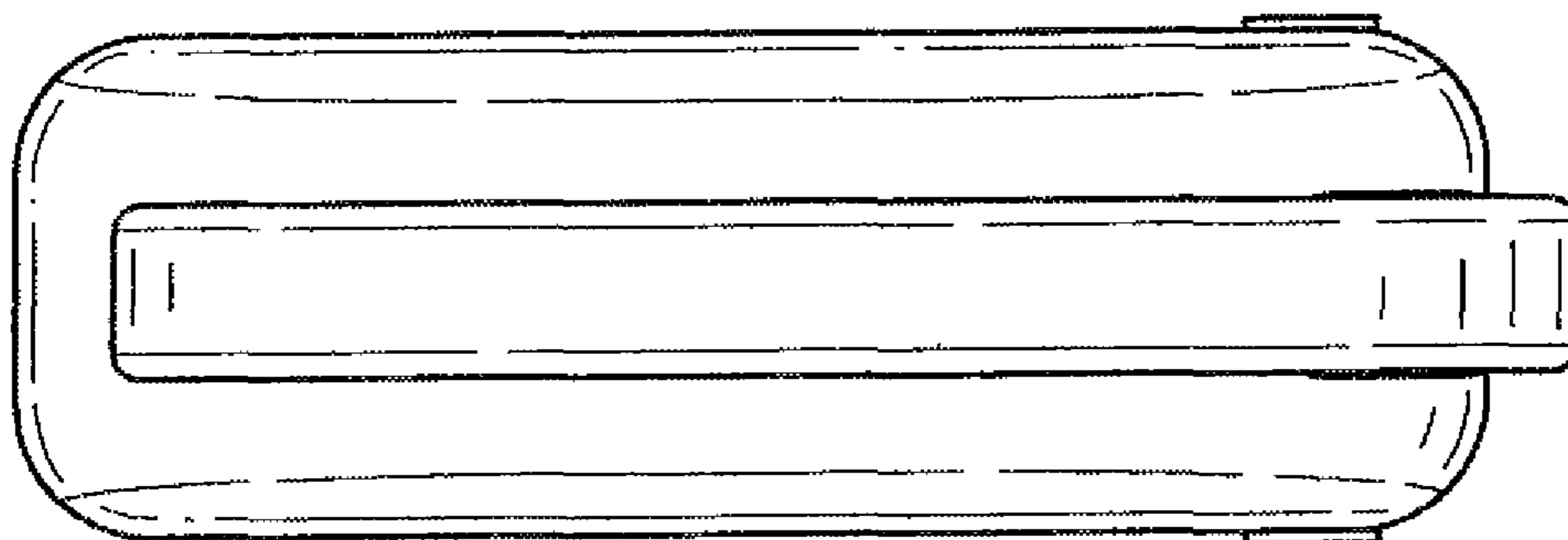
