(57) **CLAIM**

The ornamental design for a full frontal pocket jacket, as shown and described.

DESCRIPTION

FIG. 1 is a frontal view of a full frontal pocket jacket showing my design, depicting the zipper located for right handed users.

FIG. 2 is another view thereof, depicting the zipper located for left handed users.

FIG. 3 is rear view thereof.

FIG. 4 is a right side view thereof.

FIG. 5 is a left side view thereof.

FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof.

The long dashed lines shown a hanger, a hood, the draw strings, and the circle in the drawings are included for the purpose of illustrating environmental structure and form no part of the claimed design. The short dashed lines in the drawings represent stitching.

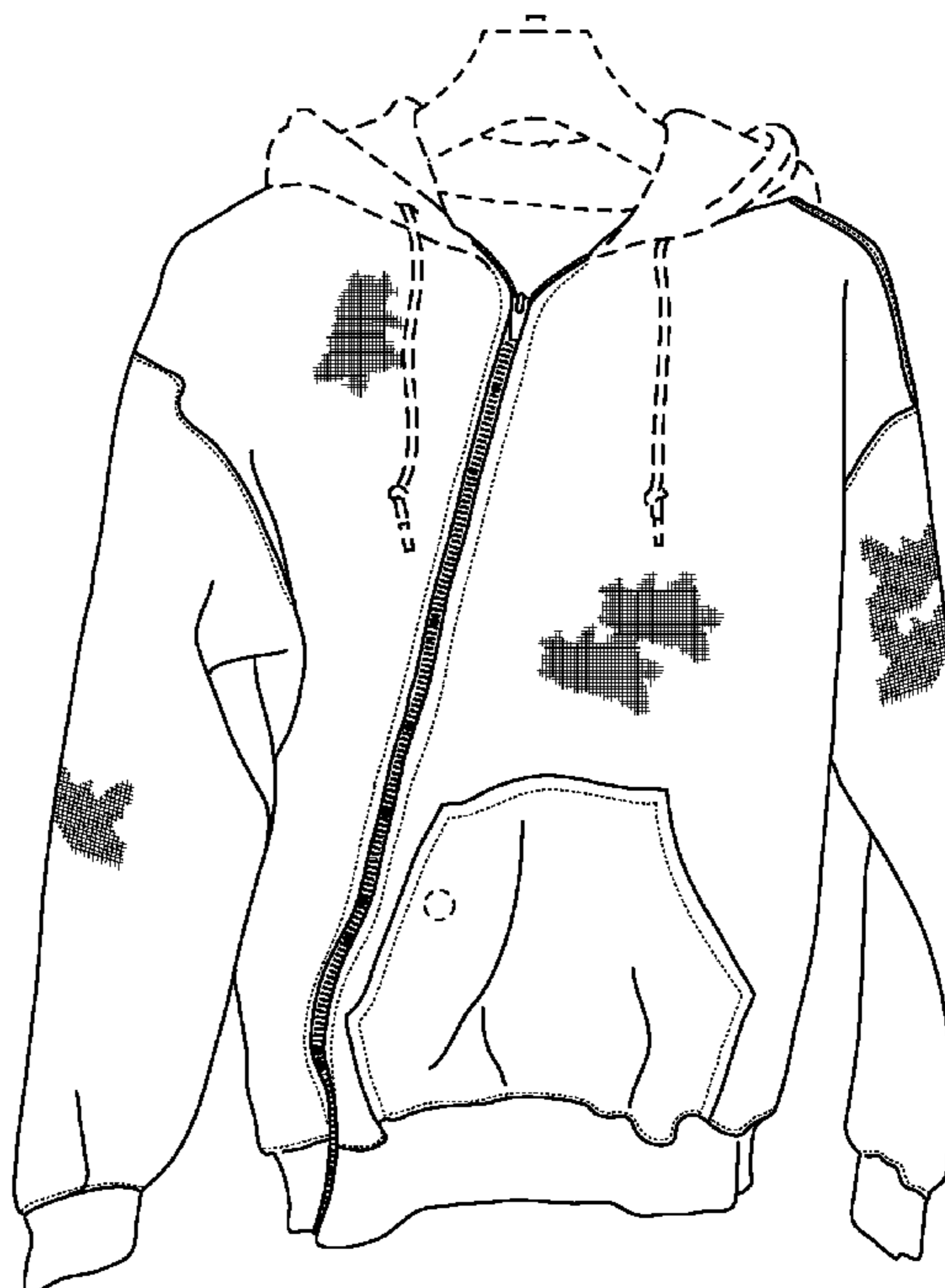
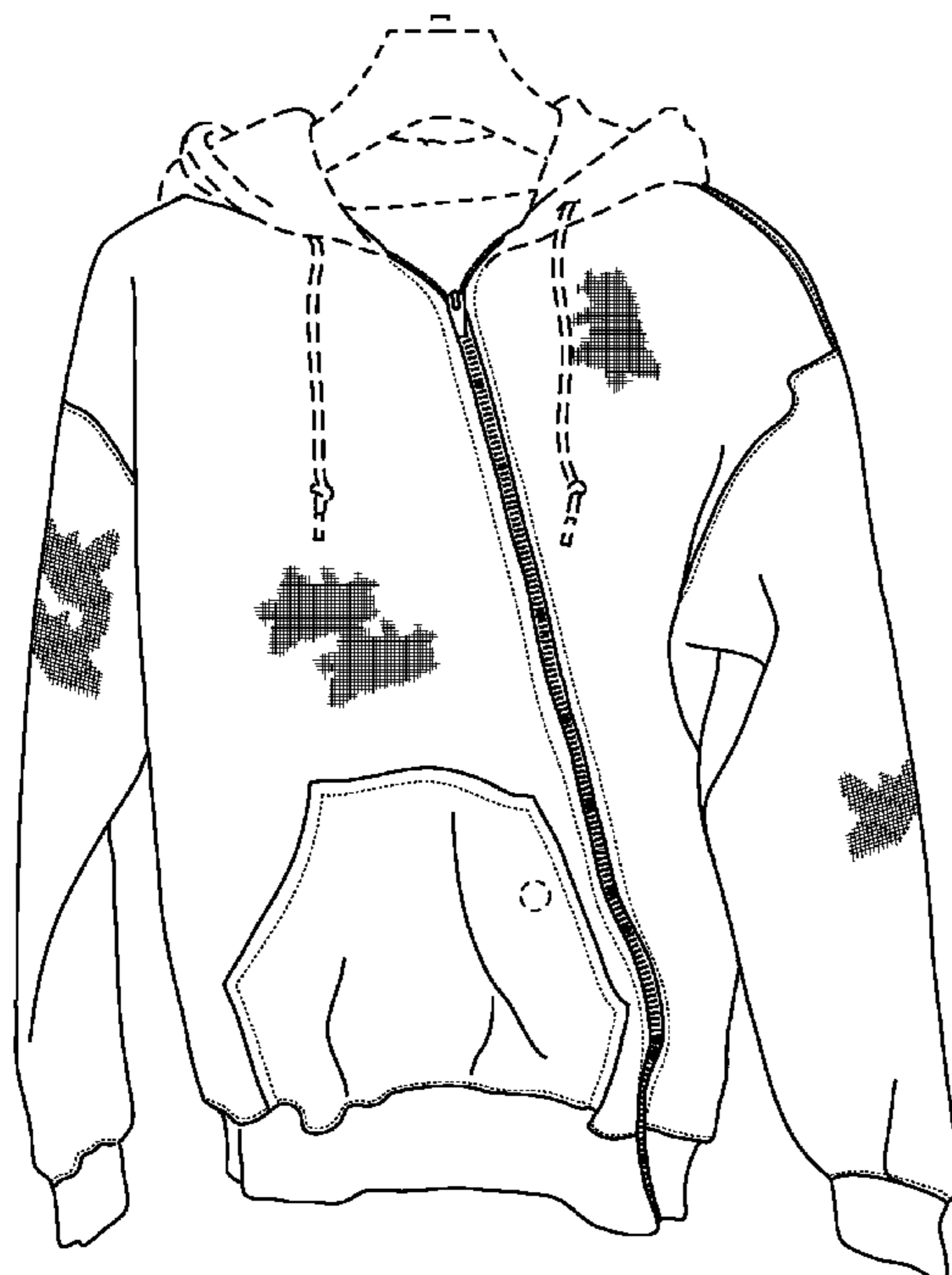

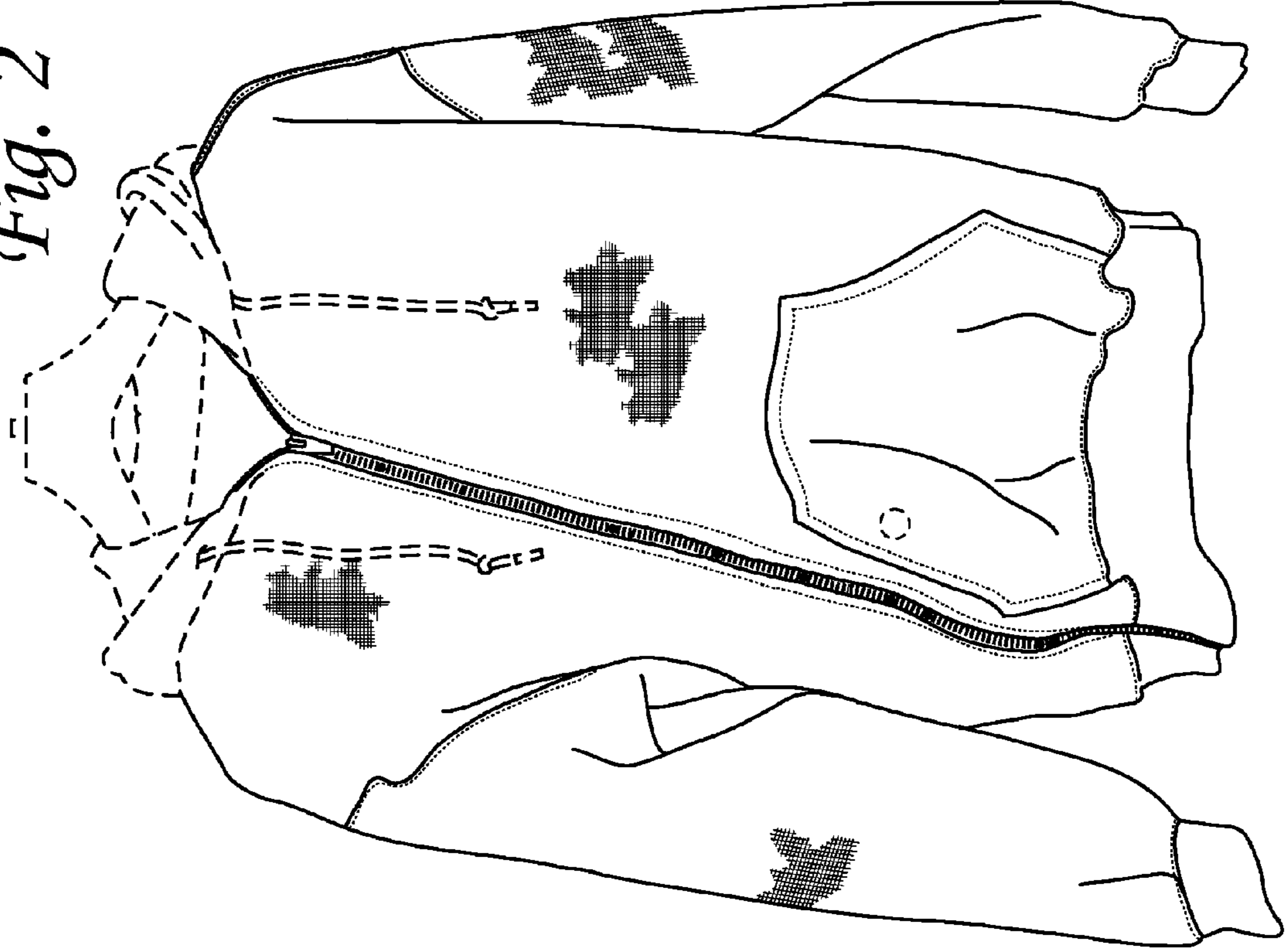

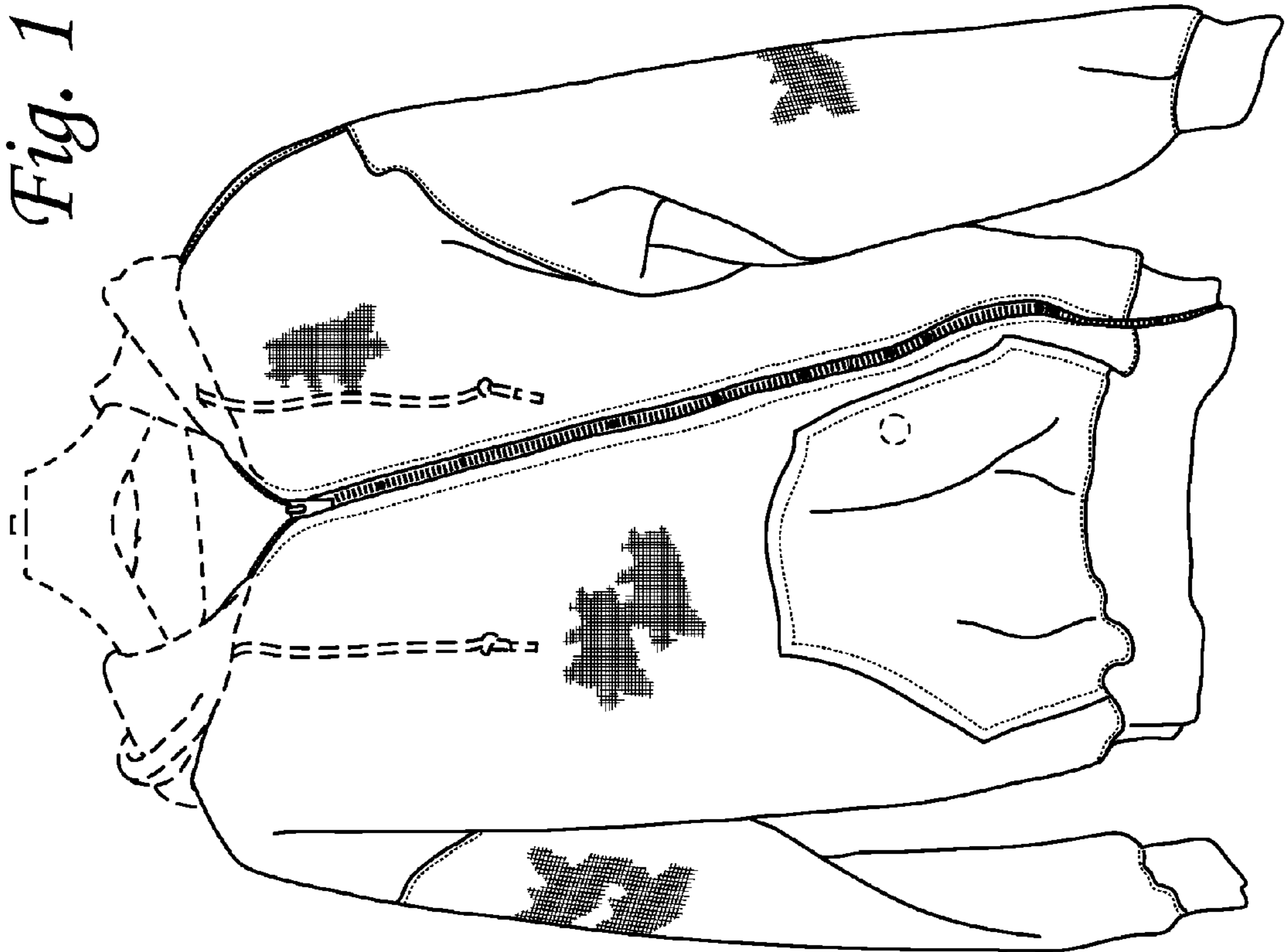

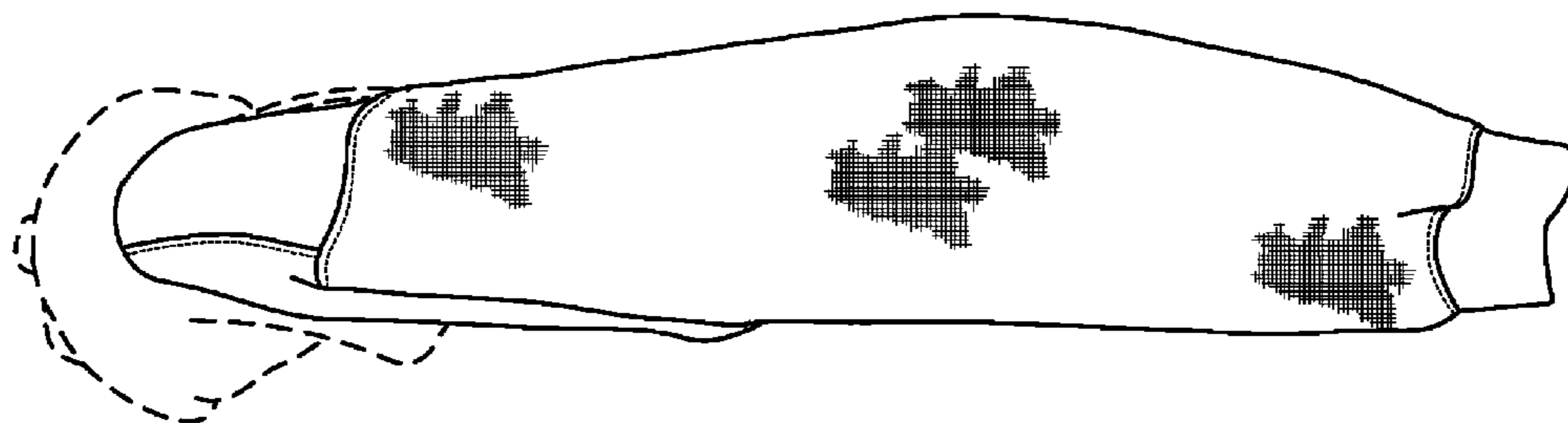
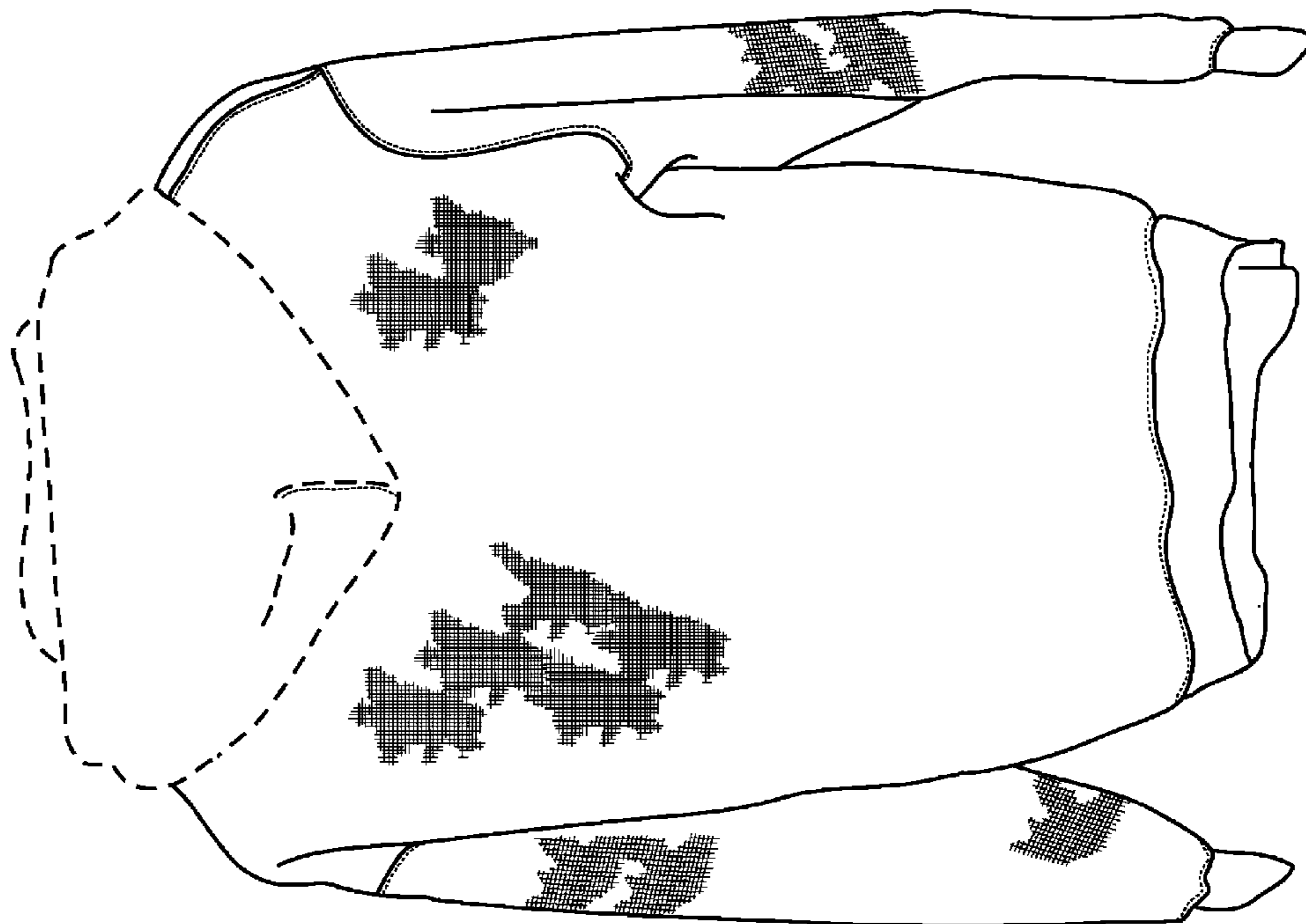

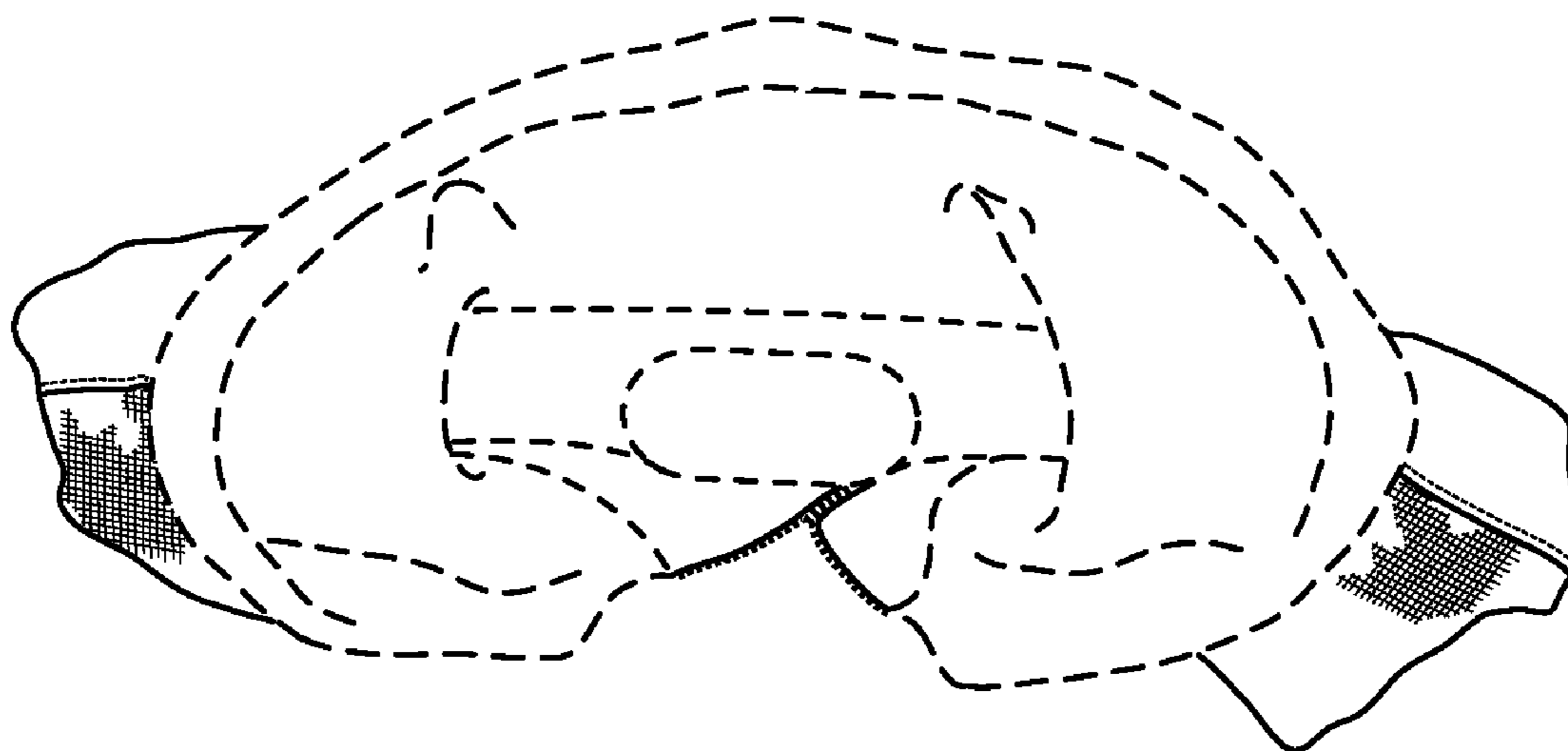

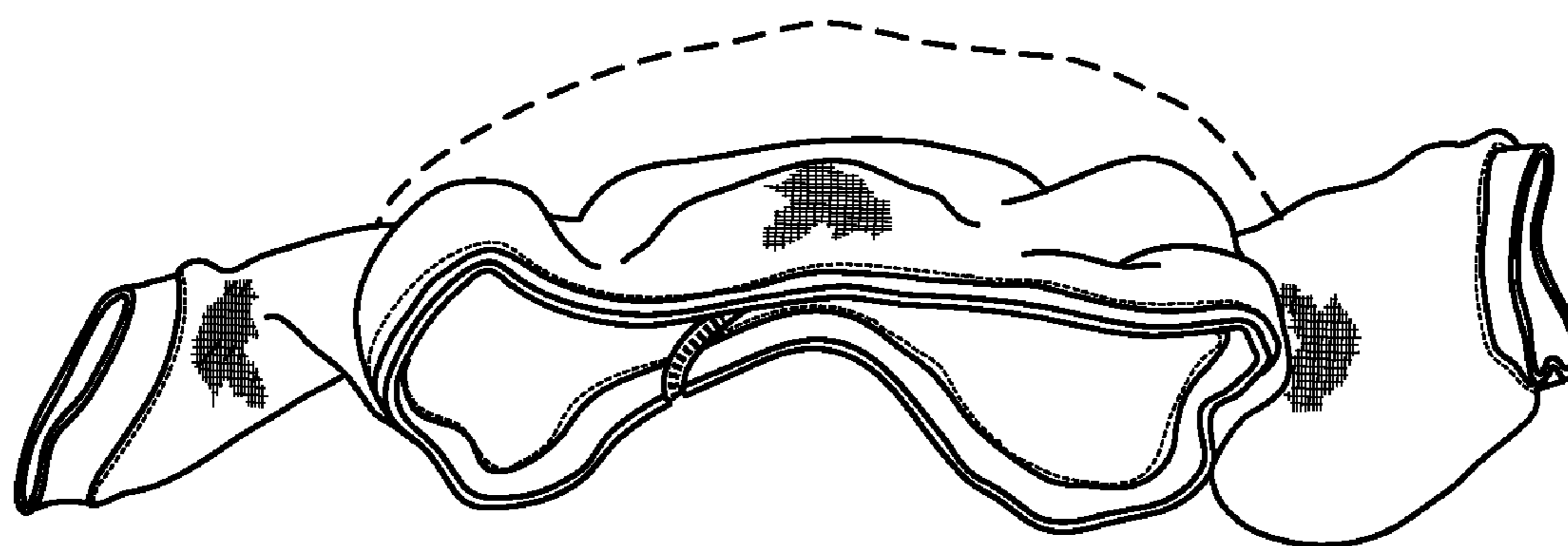
