(57) **CLAIM**

The ornamental design for a storage handle of a hairstyling tool, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a storage handle of a hairstyling tool according to the present invention and shown in a closed position, the rear view being a mirror image thereof.

FIG. 2 is a left side view of the storage handle of FIG. 1, the right side view being a mirror image thereof.

FIG. 3 is a top view of the storage handle of FIG. 1.

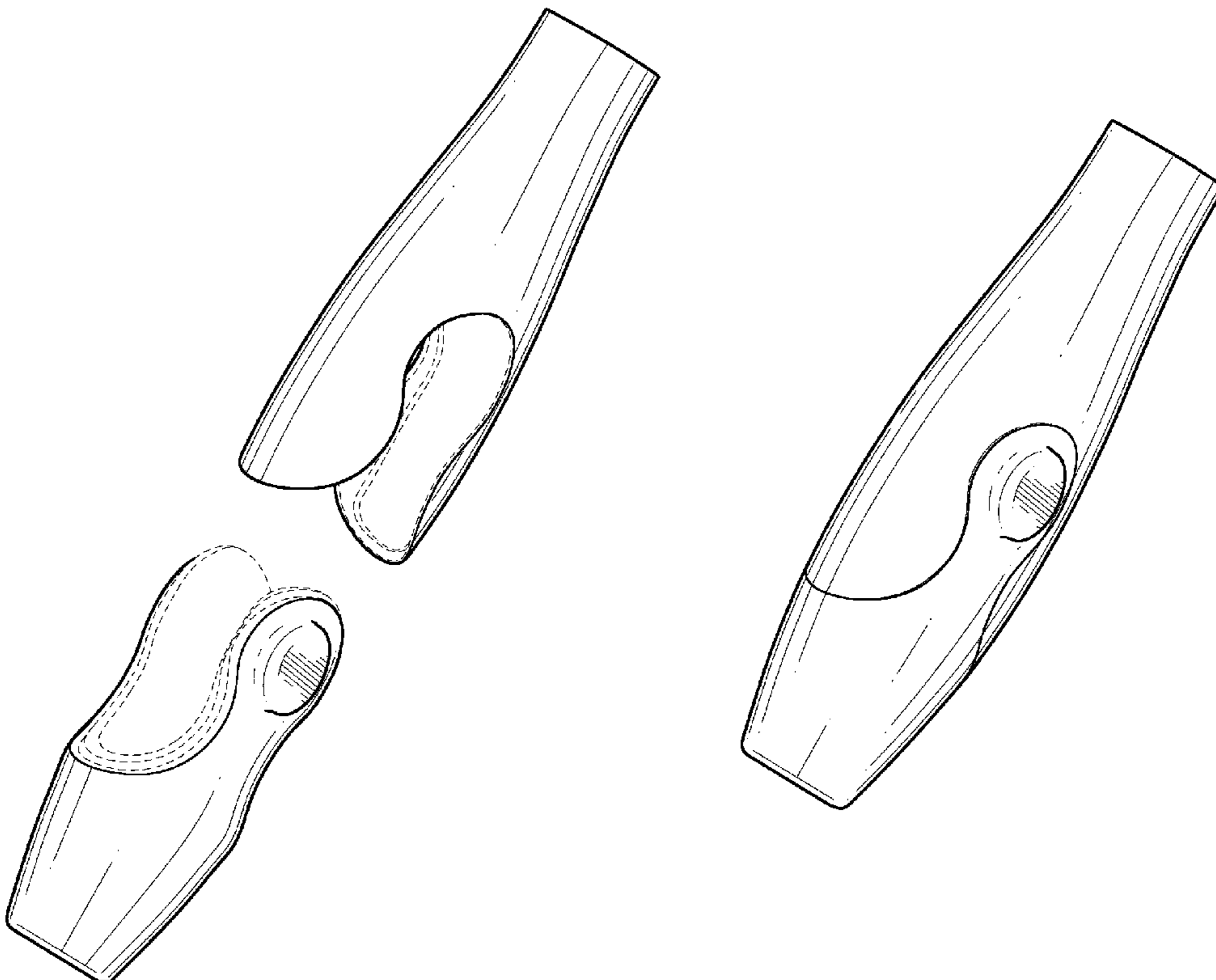
FIG. 4 is a bottom view of the storage handle of FIG. 1.

FIG. 5 is a perspective view of the storage handle of FIG. 1 shown in an open position; and,

FIG. 6 is a perspective view of the storage handle of FIG. 1 shown in the closed position.

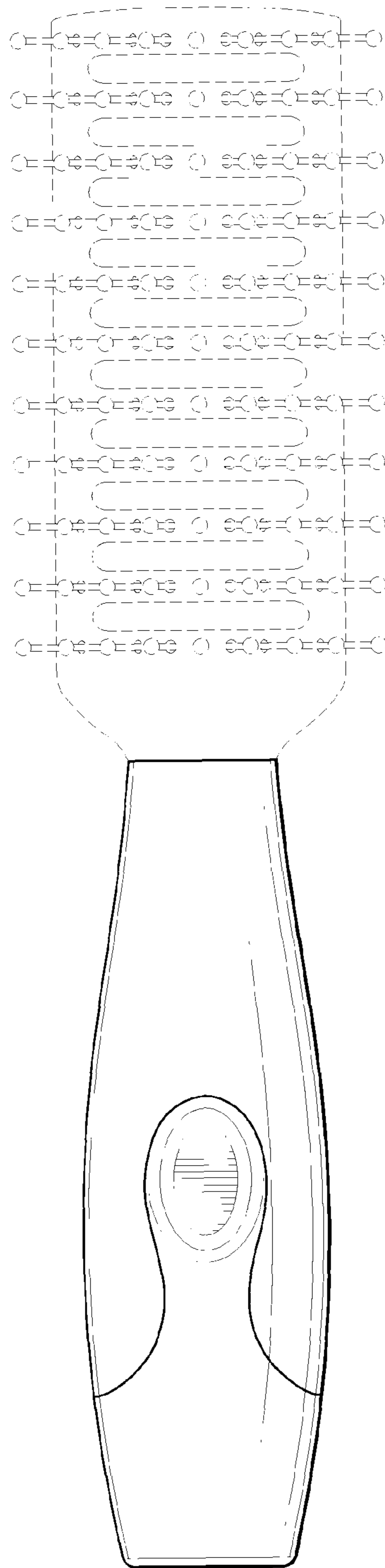

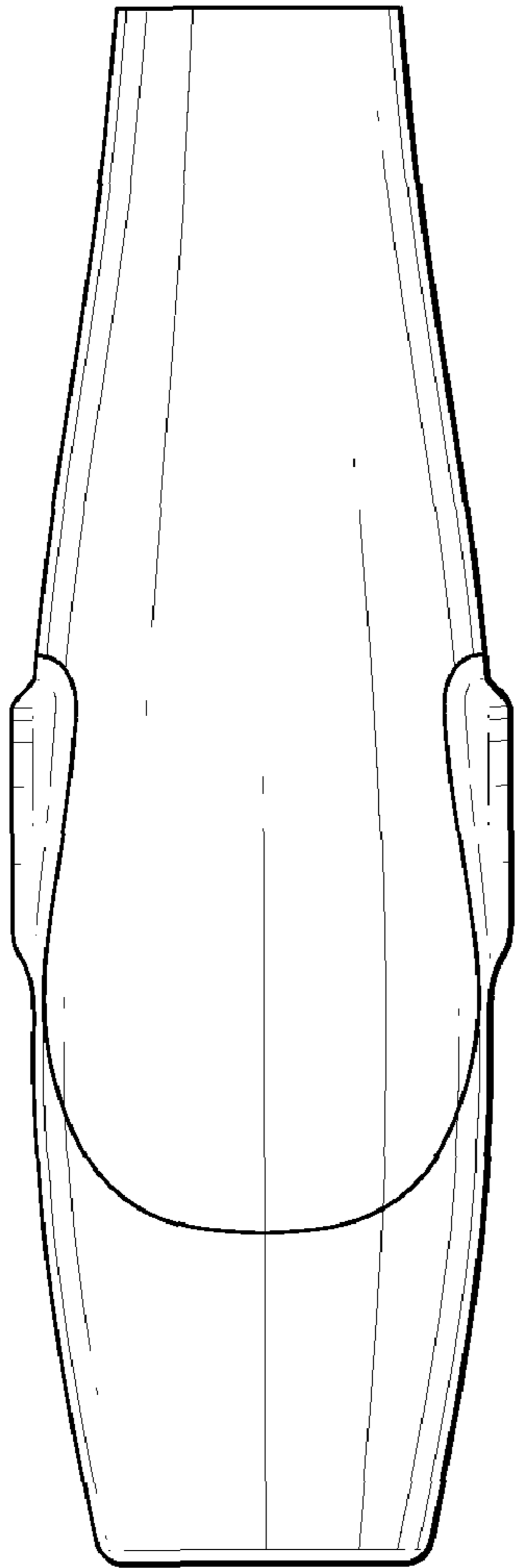

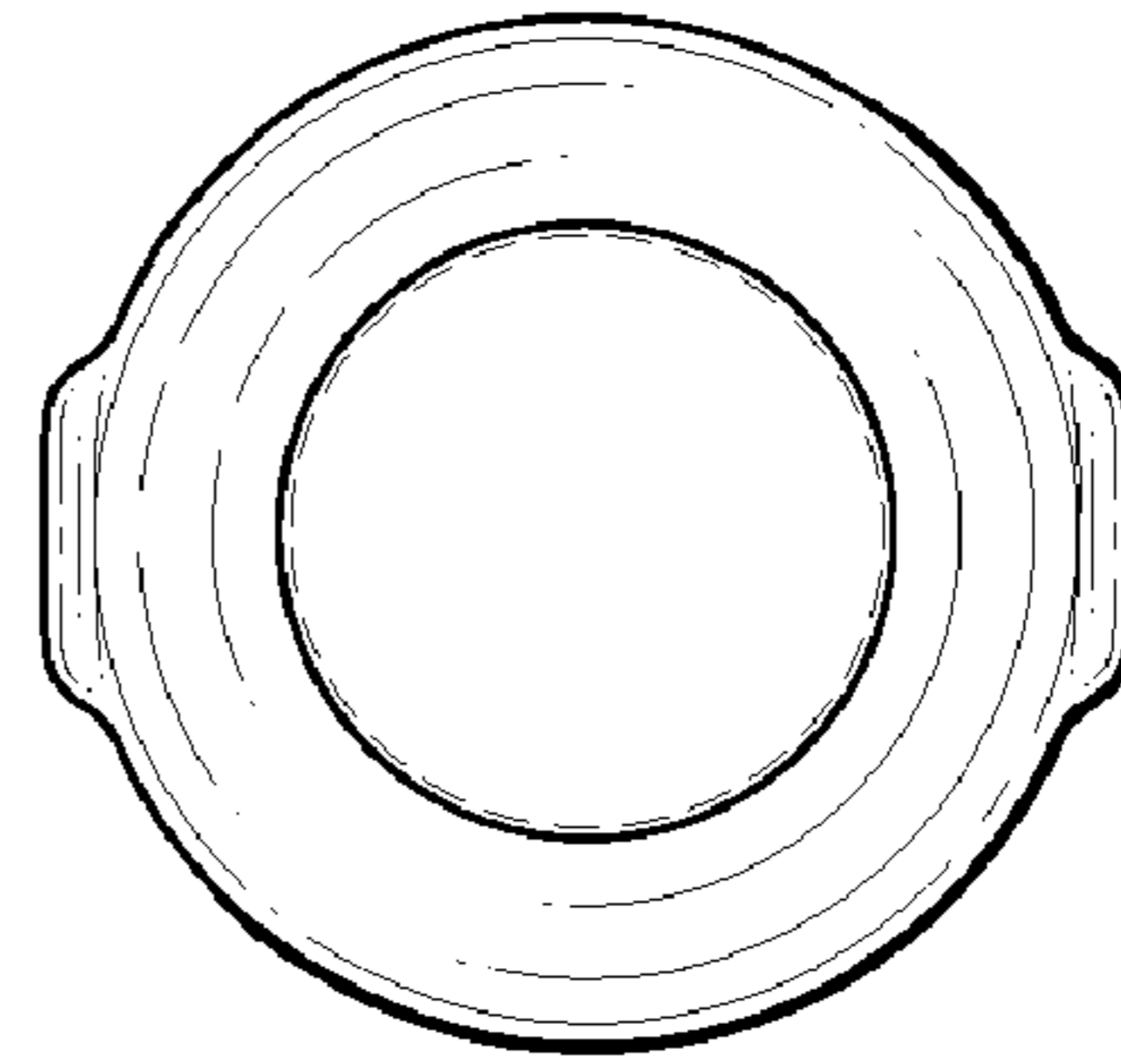

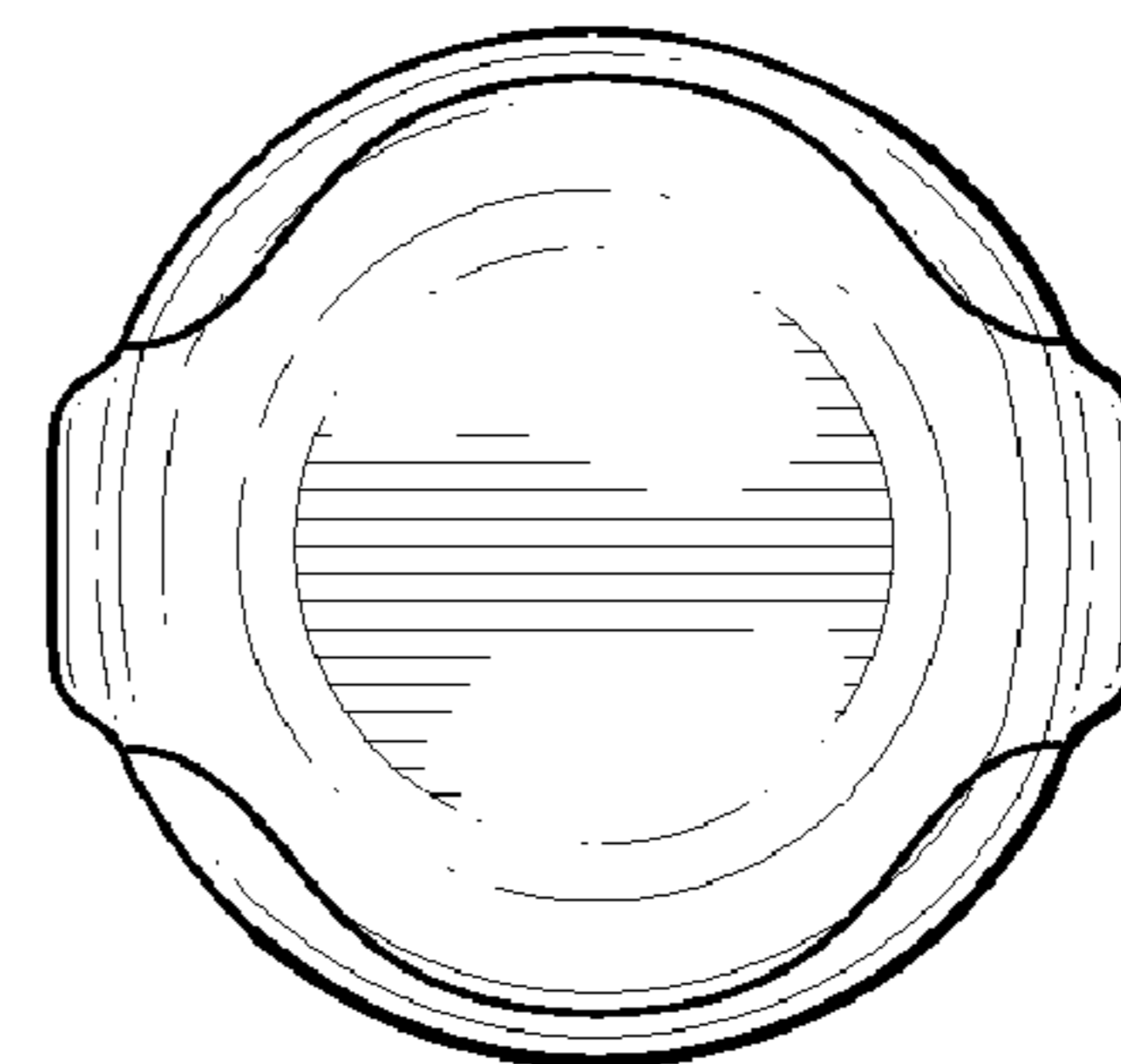

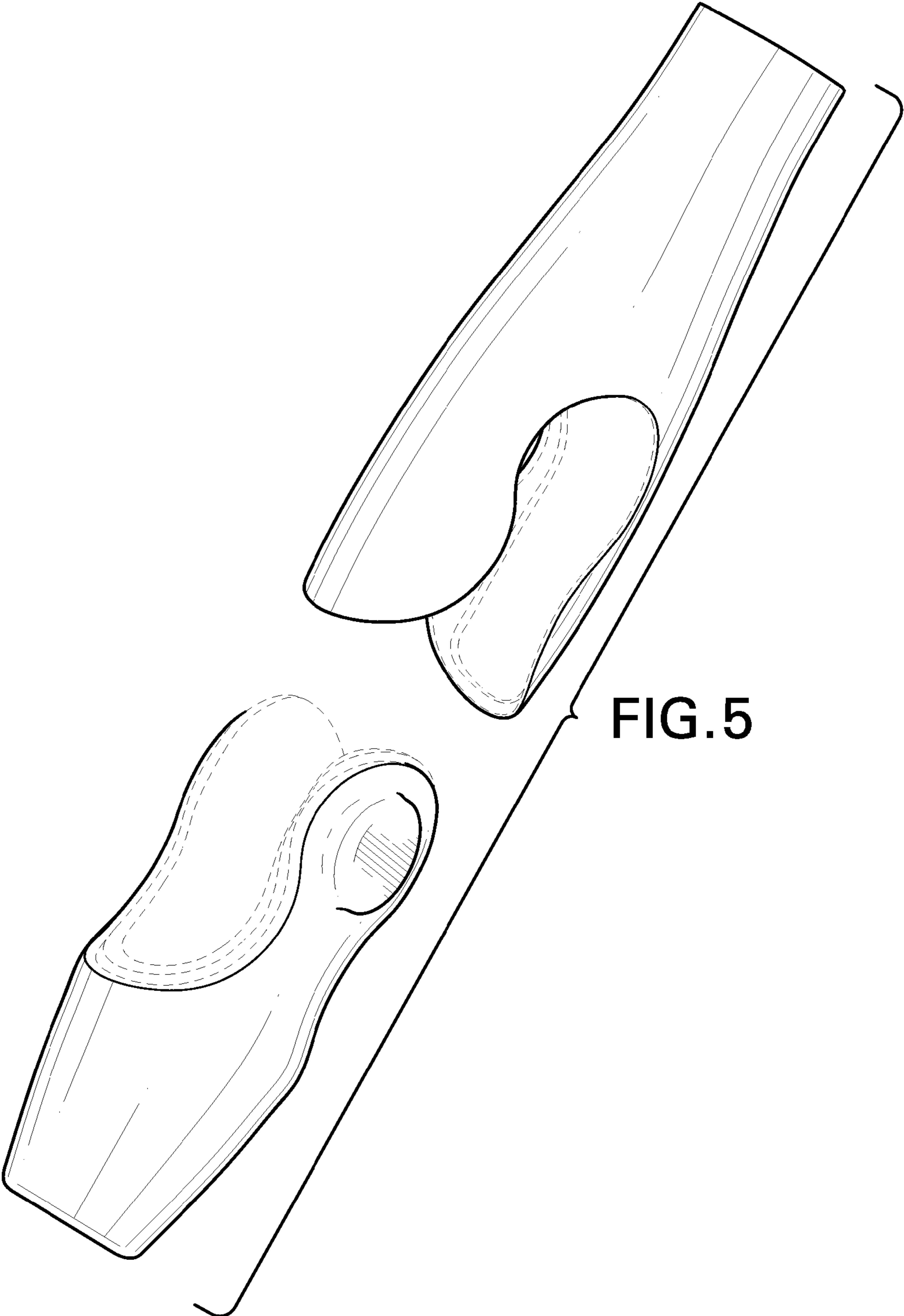

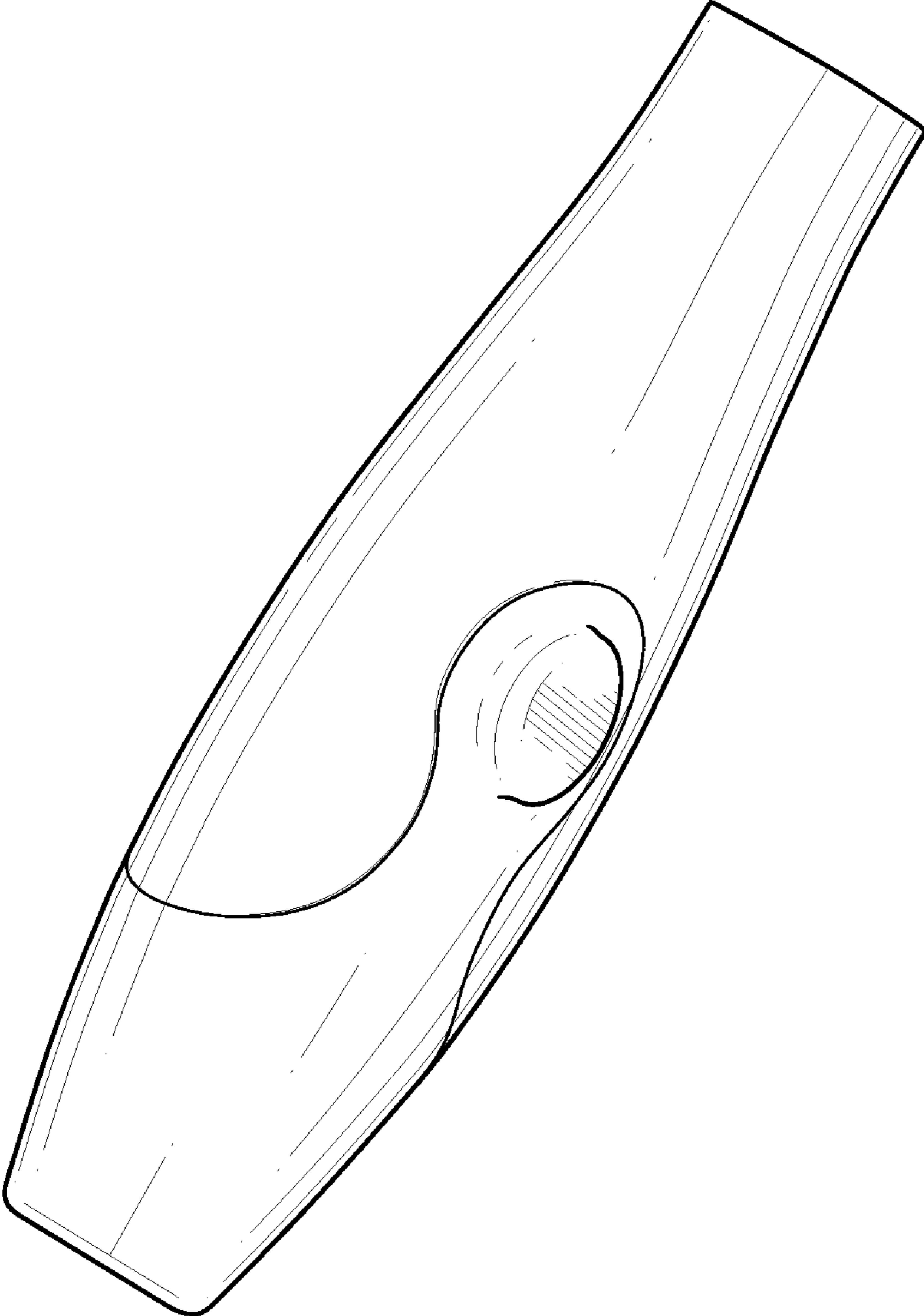
